FIG. 3 is a rear perspective view thereof;

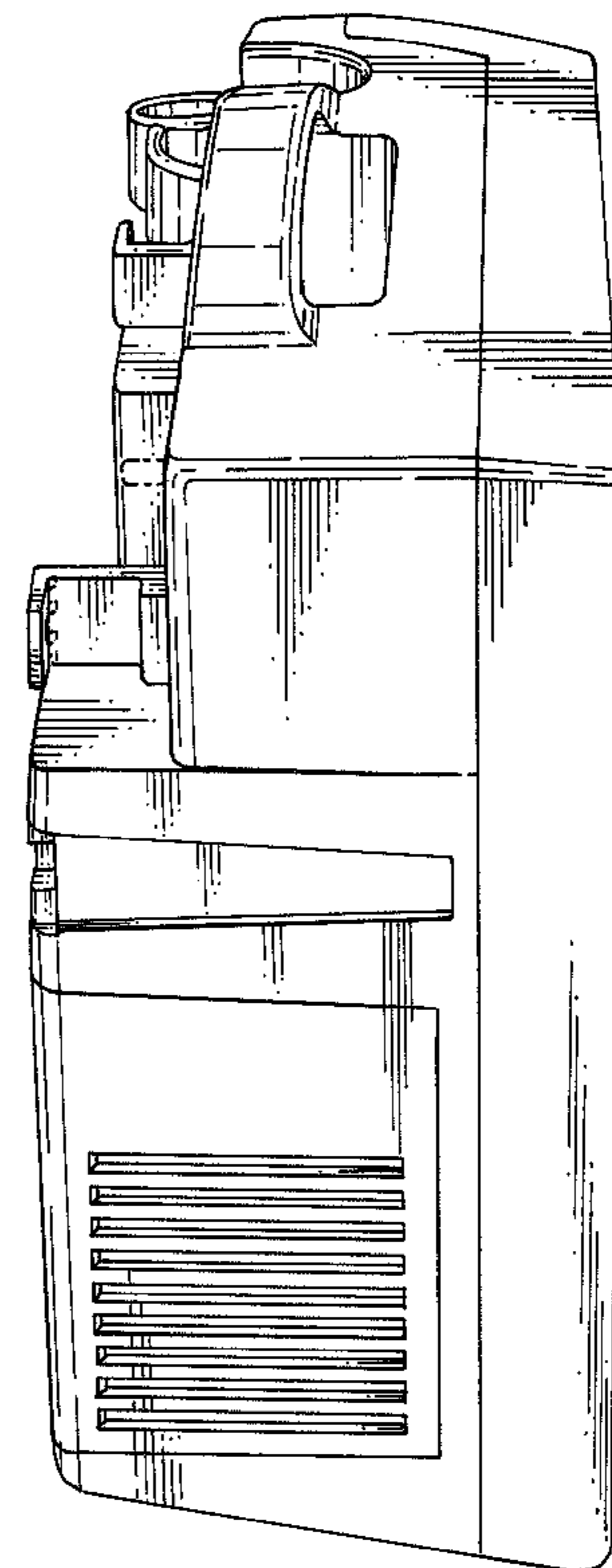
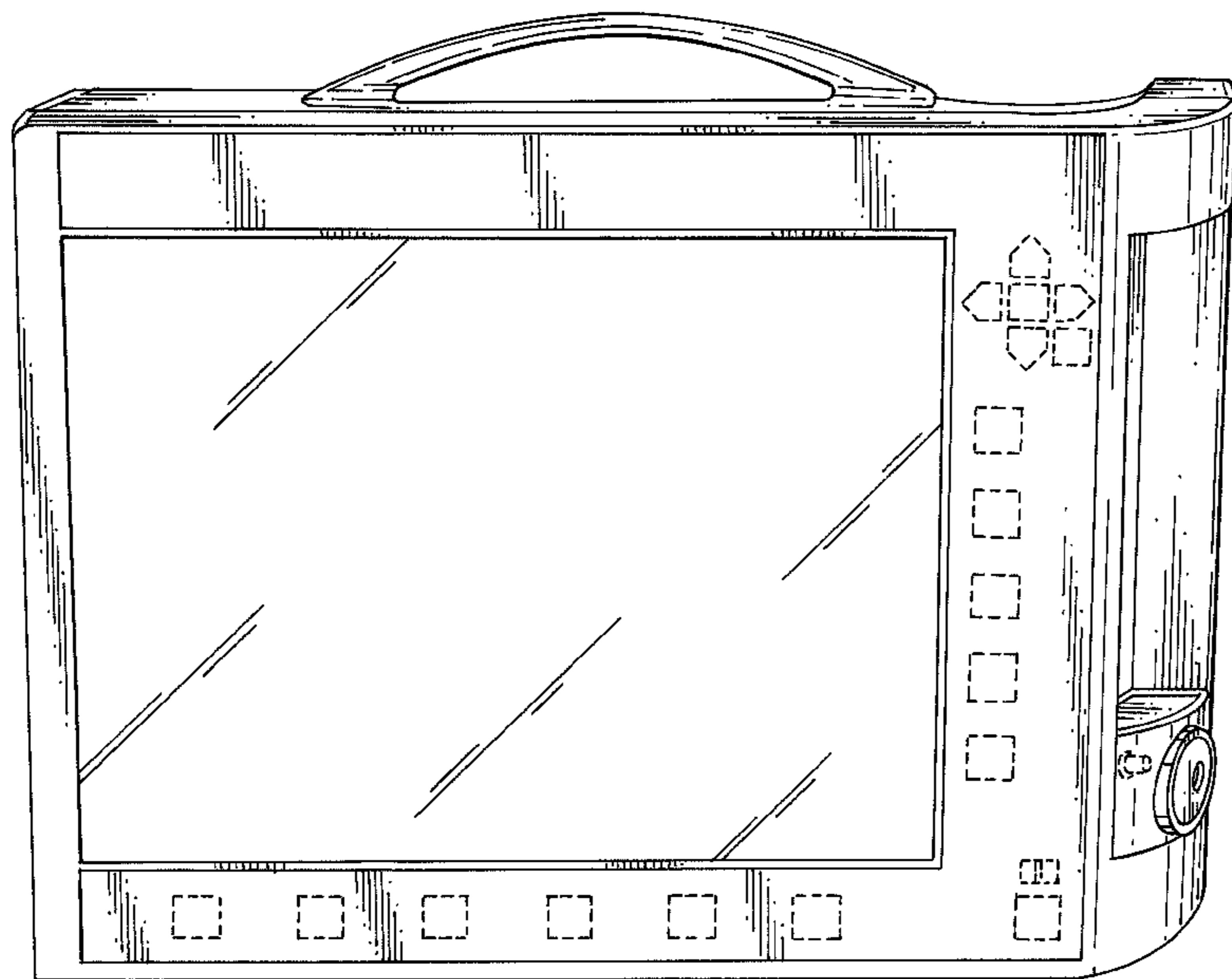
FIG. 4 is a top perspective view thereof;

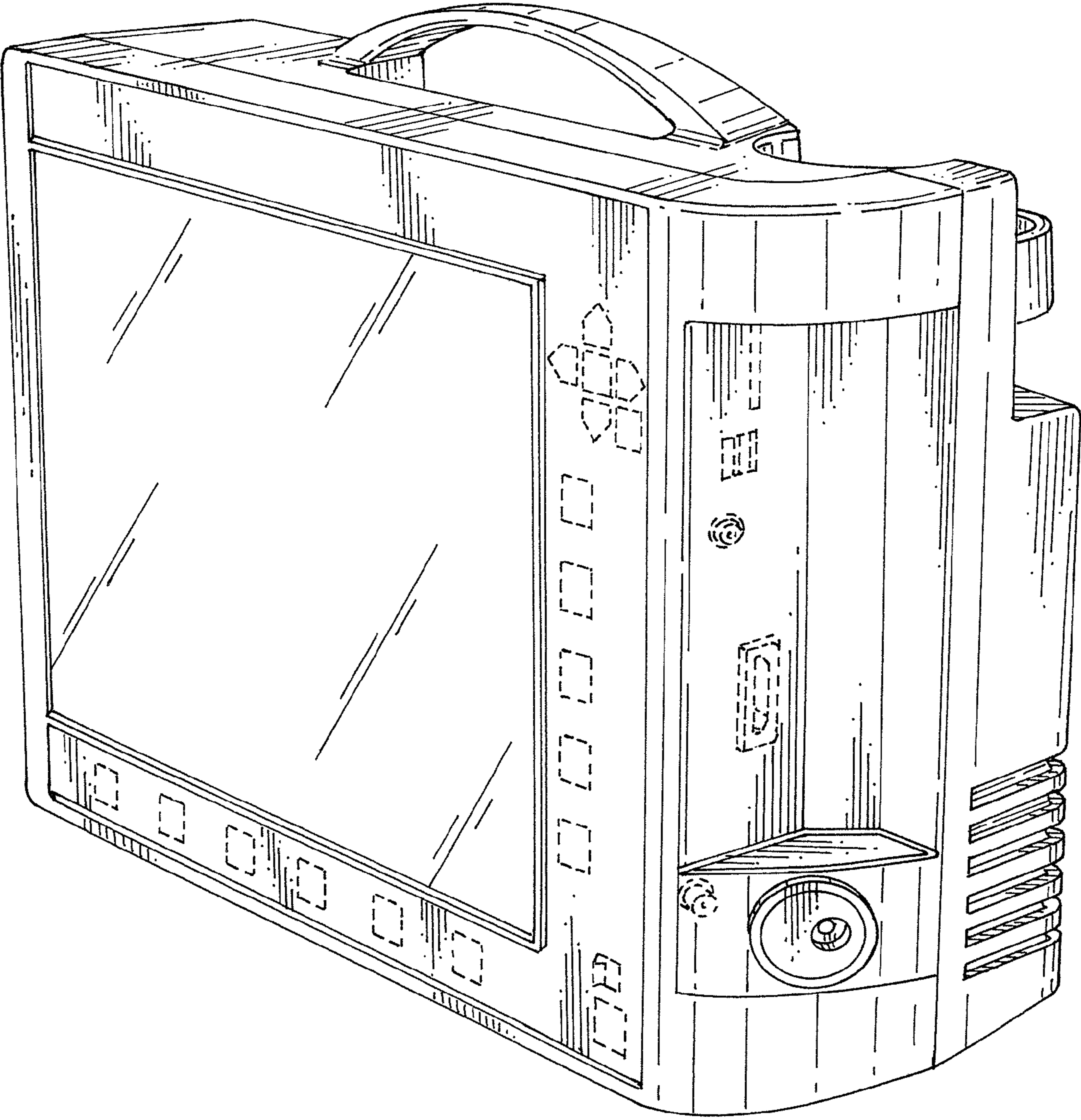
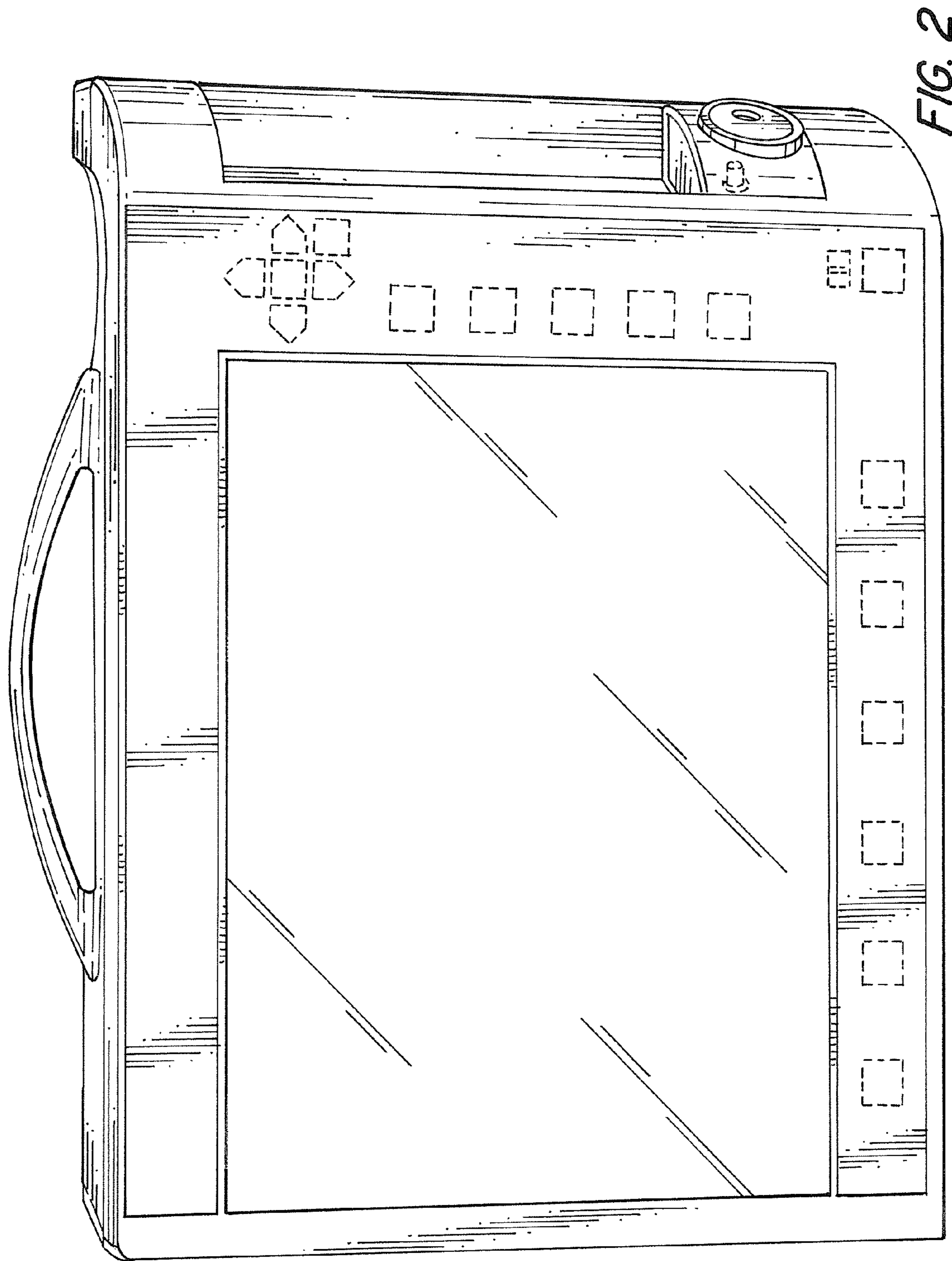

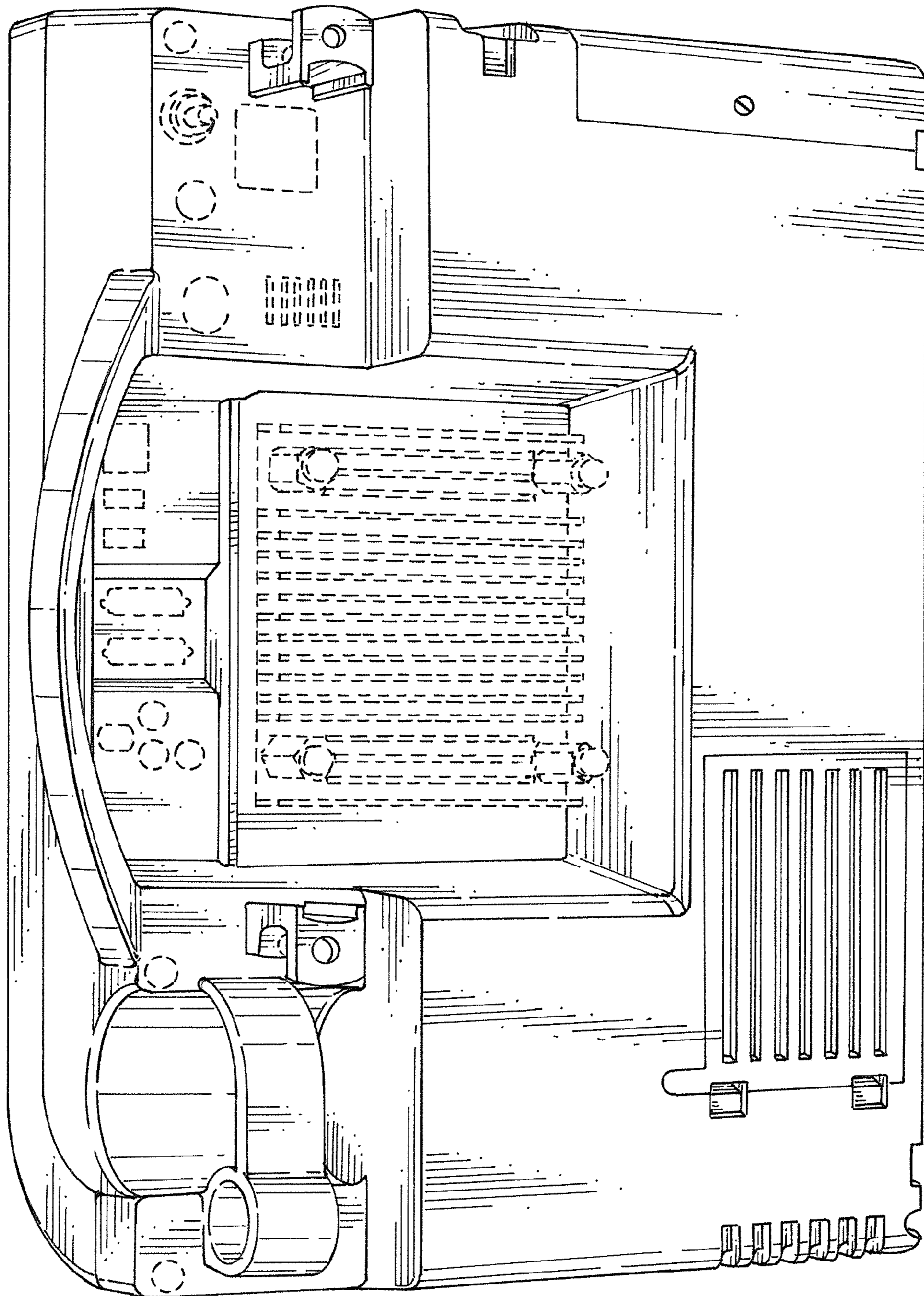

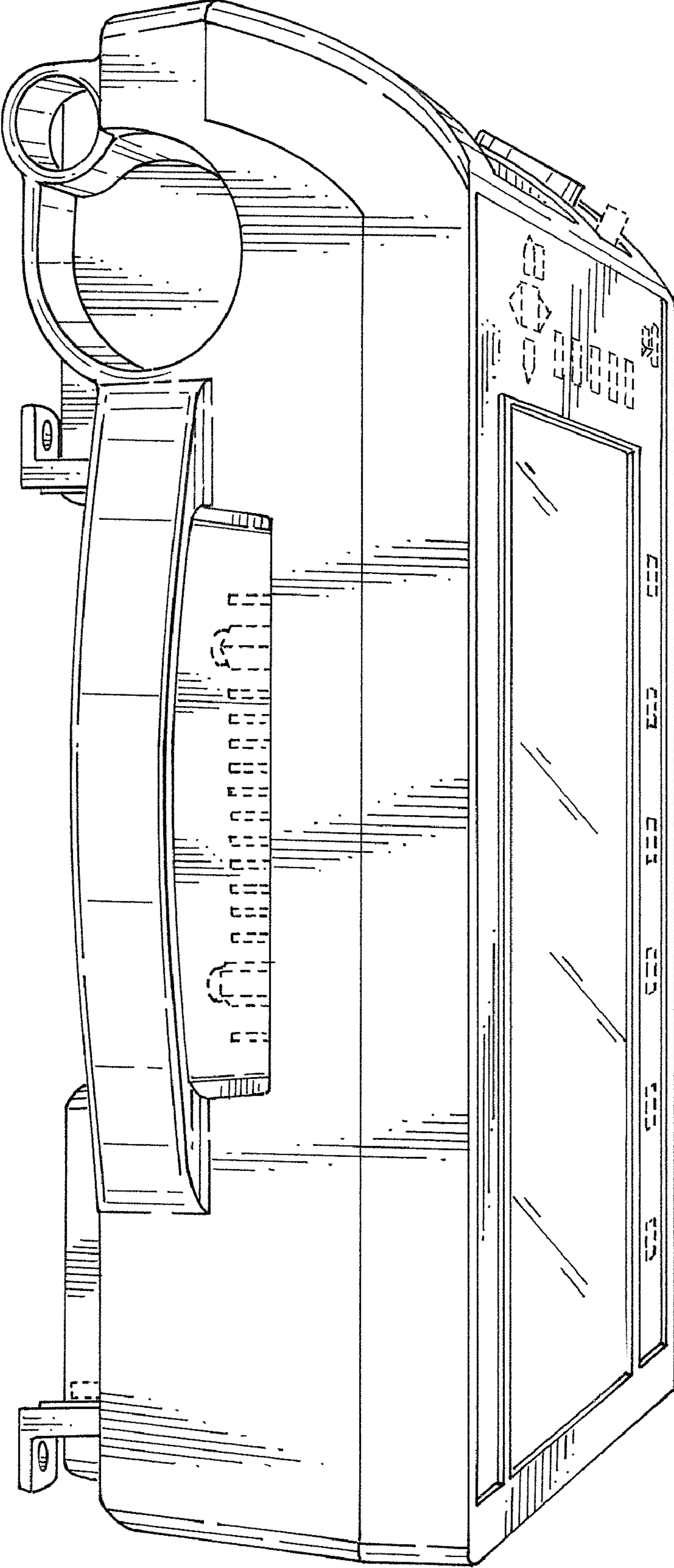

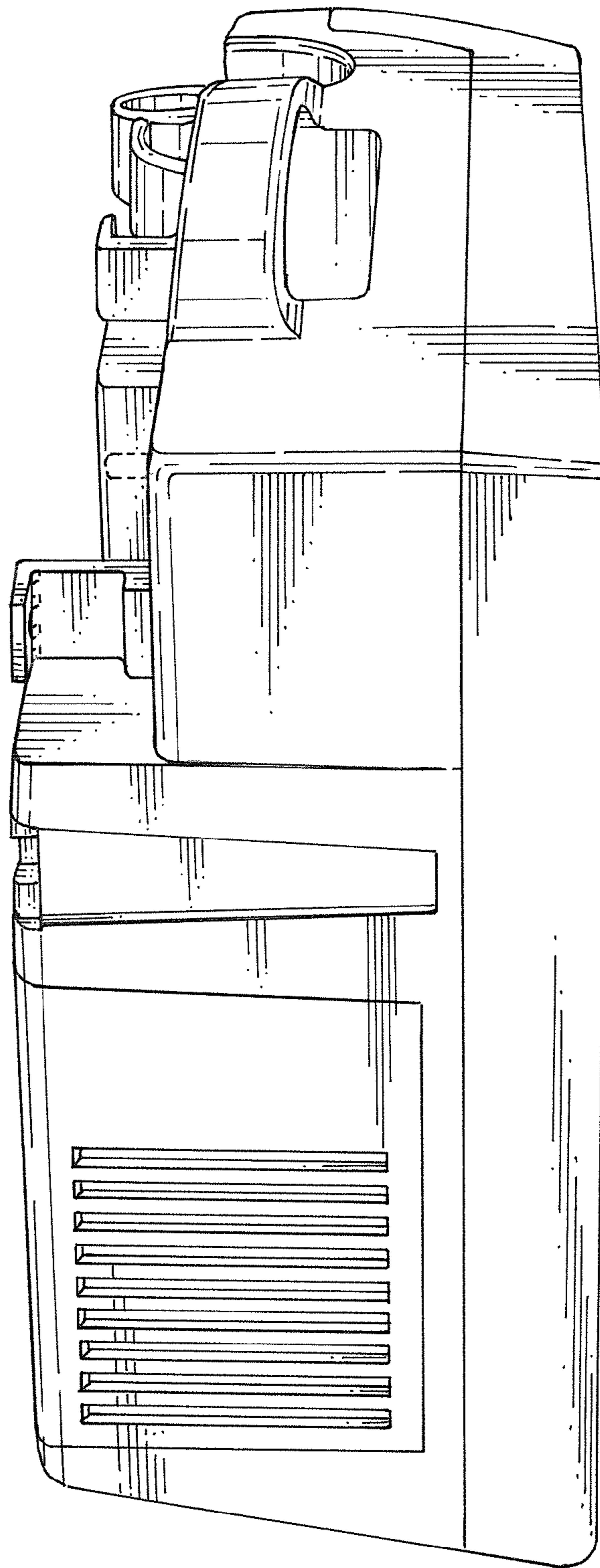

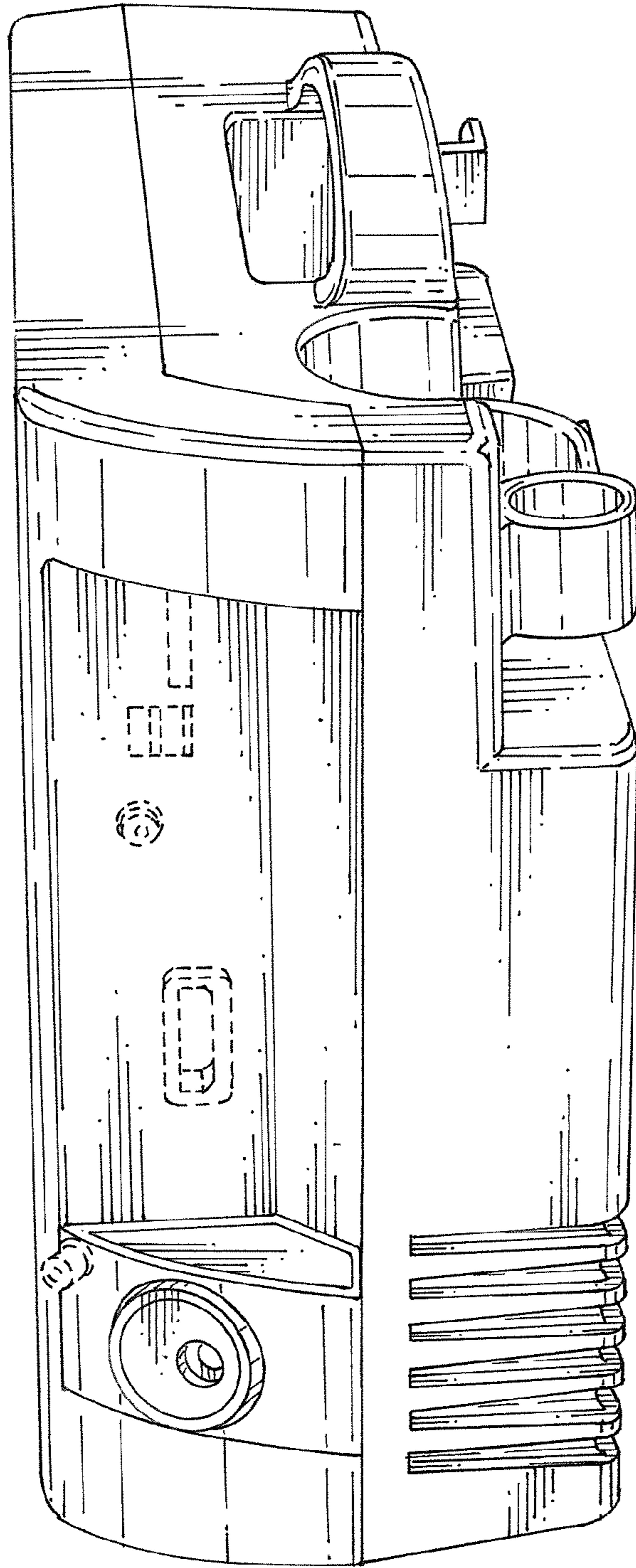
