(57) **CLAIM**

The ornamental design for a “dressing cuff,” shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the top, back and left side of the dressing cuff;

FIG. 2 is a perspective view of the dressing cuff in use;

FIG. 3 is a top plan view of the dressing cuff;

FIG. 4 is a bottom plan view of the dressing cuff;

FIG. 5 is a back elevational view of the dressing cuff;

FIG. 6 is a front elevational view of the dressing cuff;

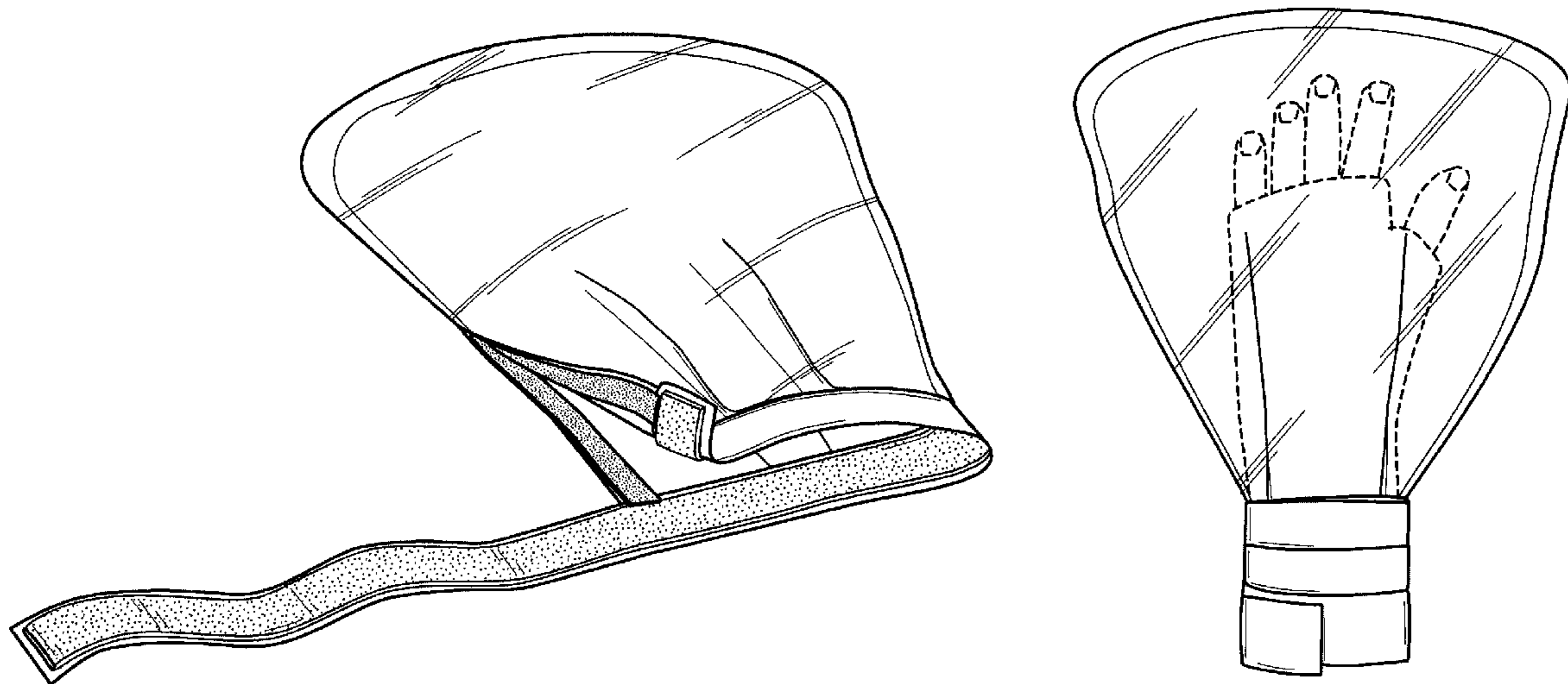
FIG. 7 is a left side elevational view of the dressing cuff;

FIG. 8 is a right side elevational view of the dressing cuff; and,

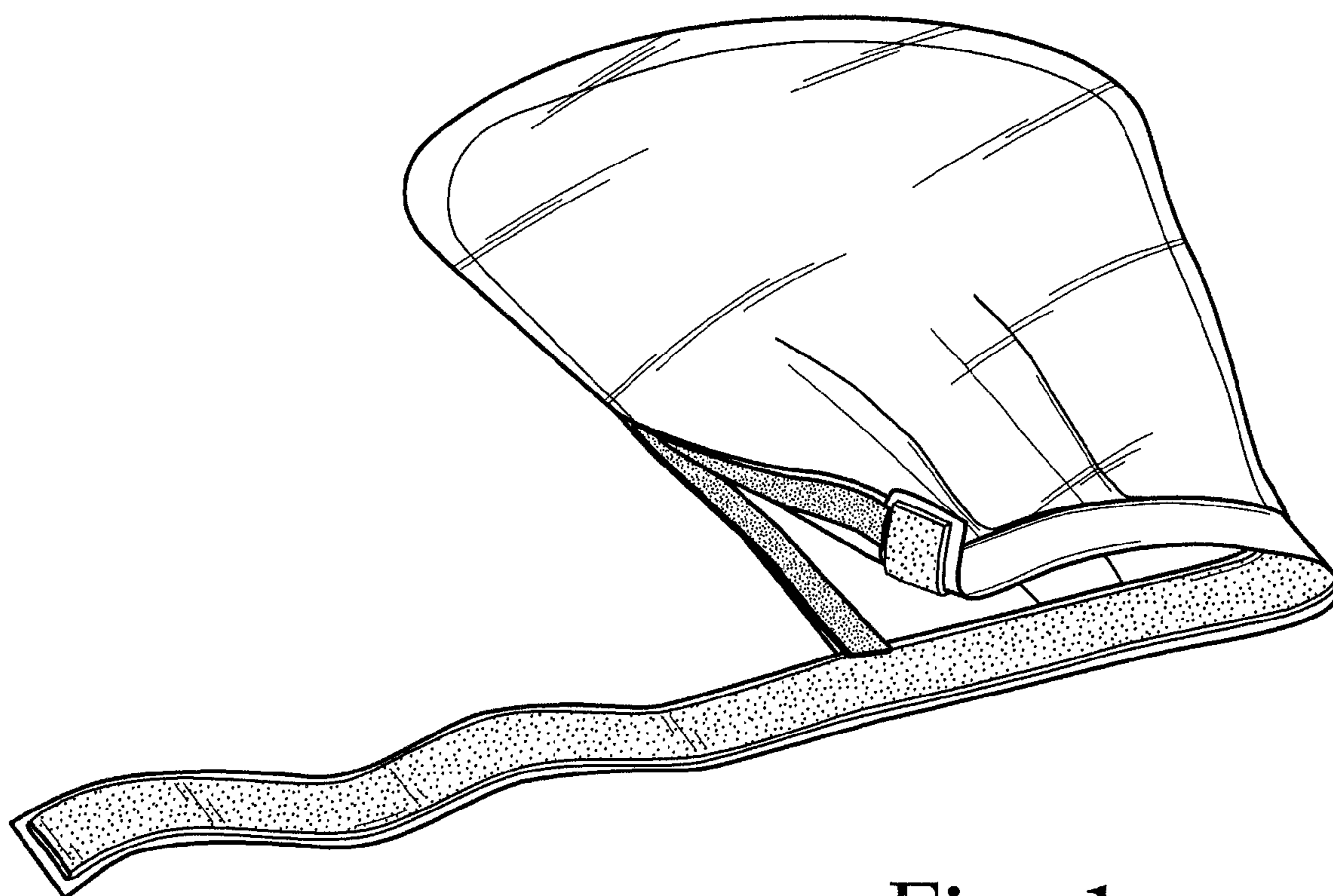

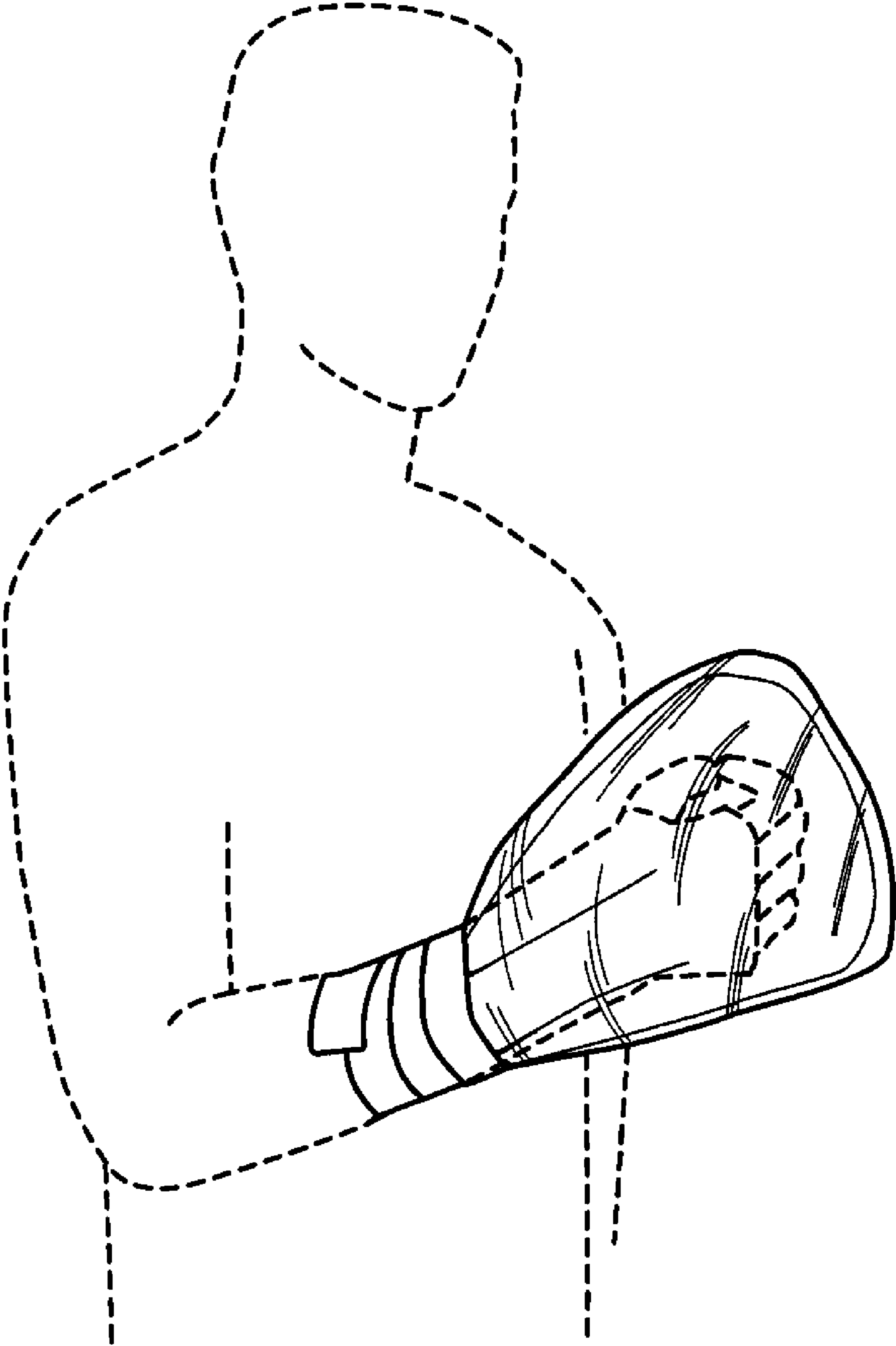

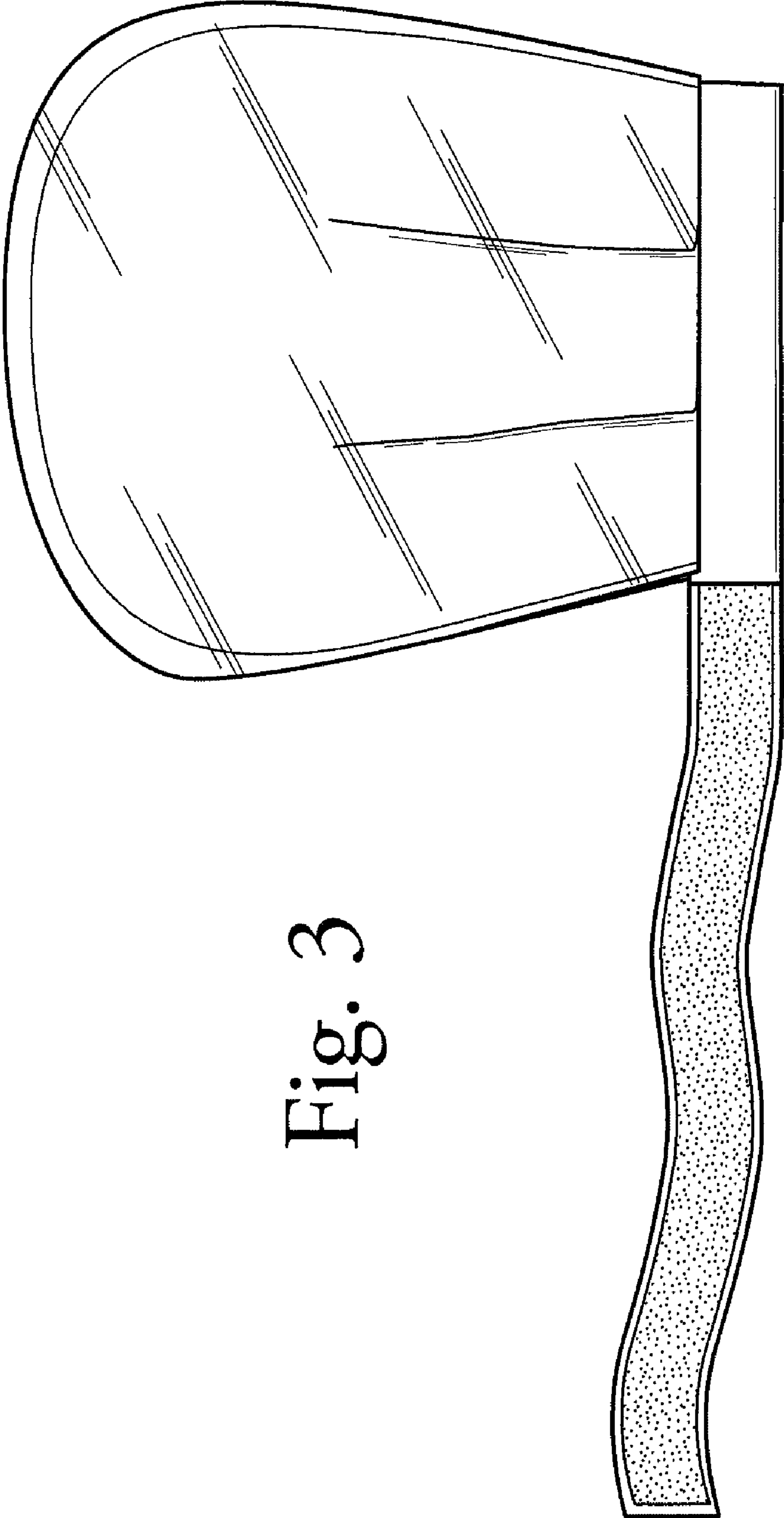

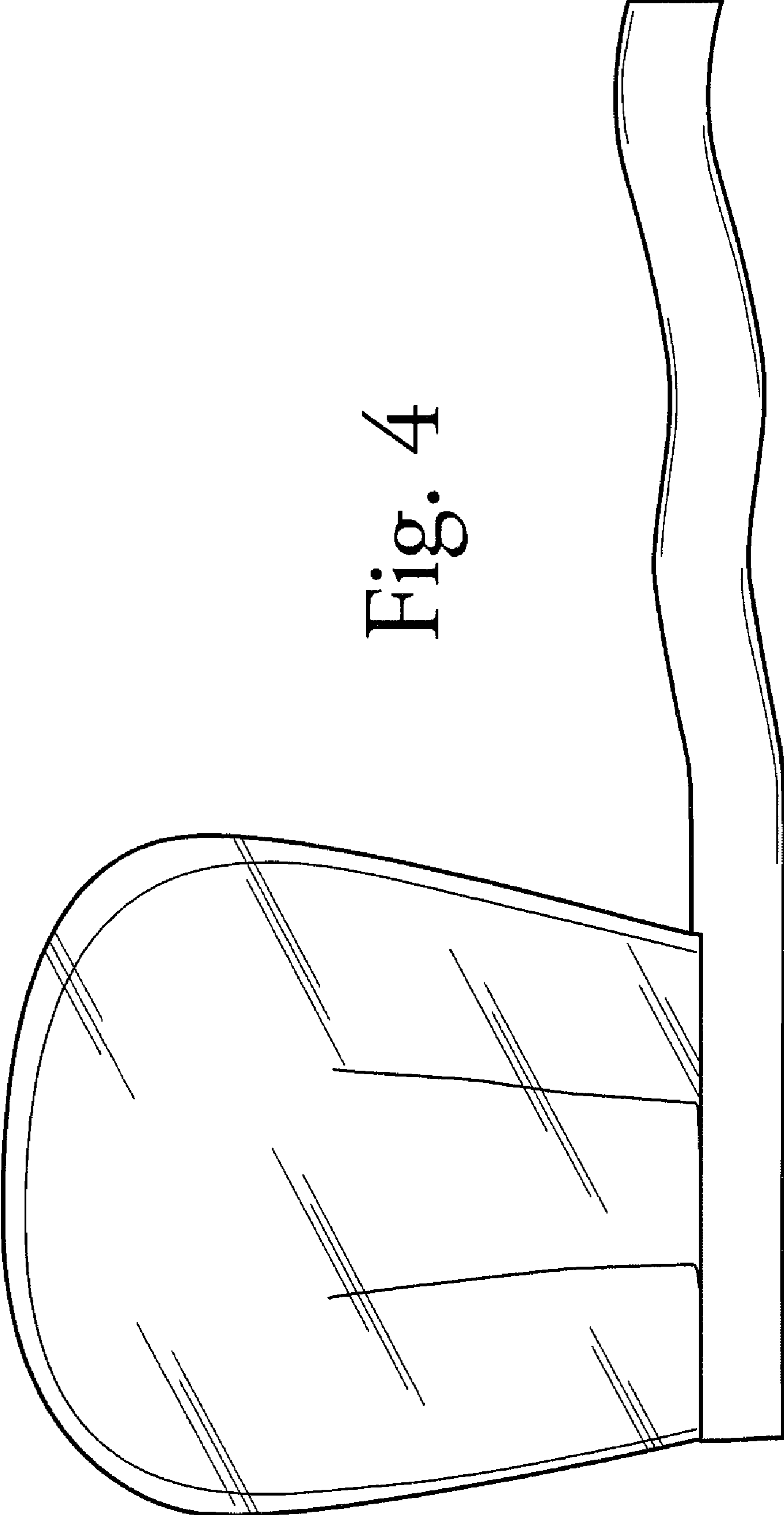

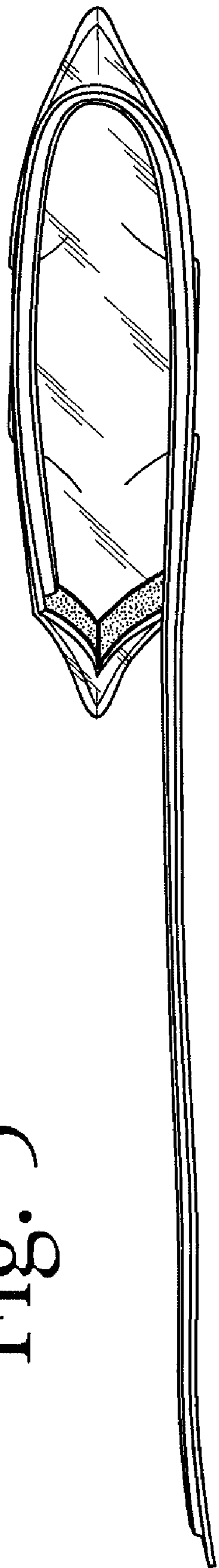
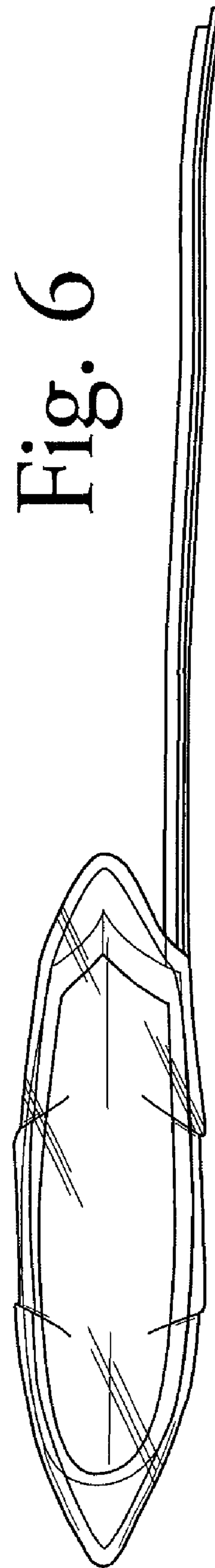

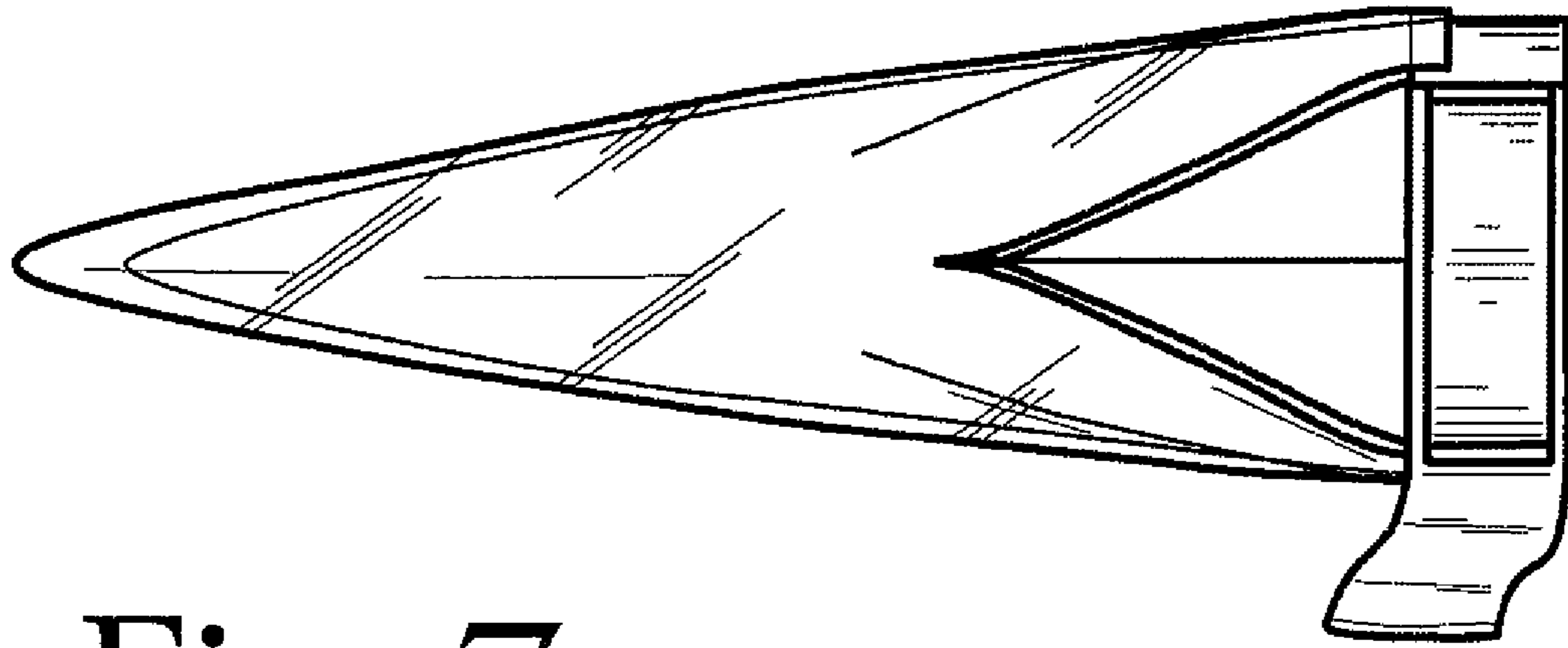

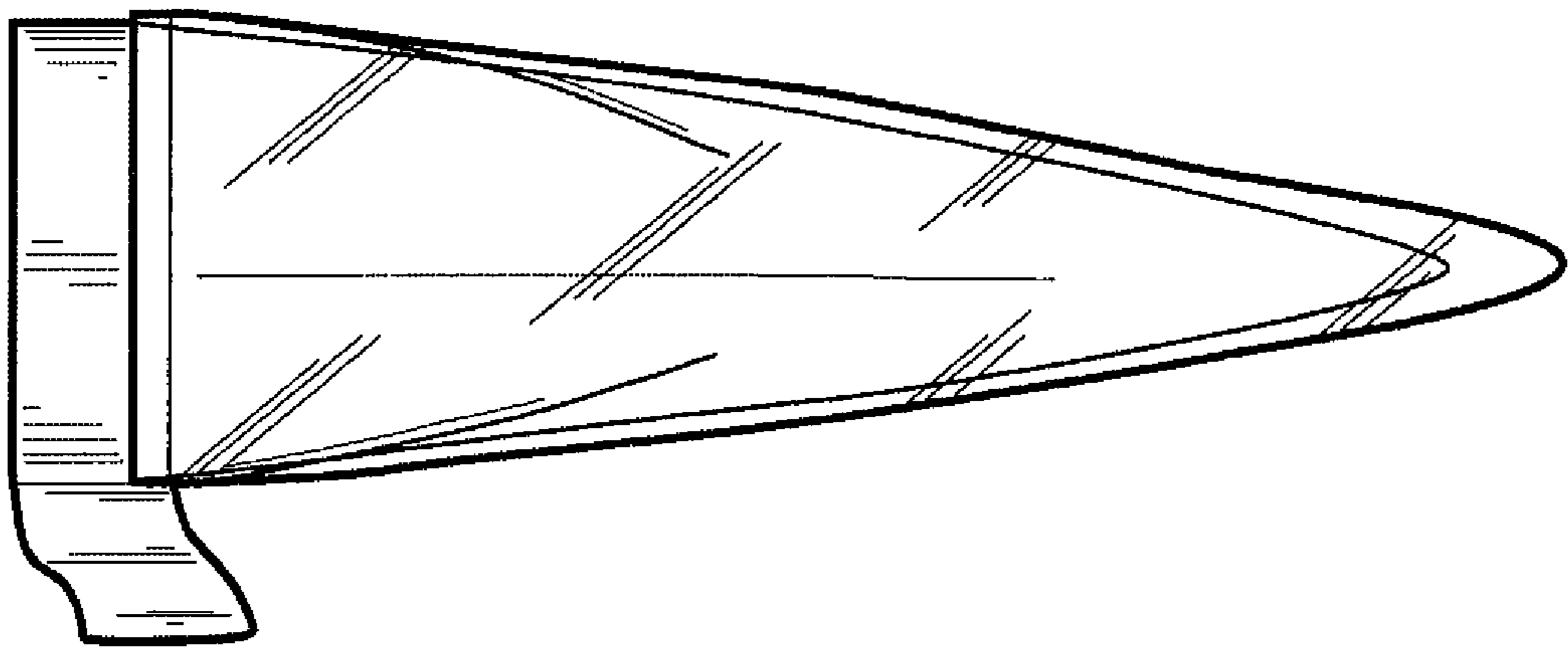

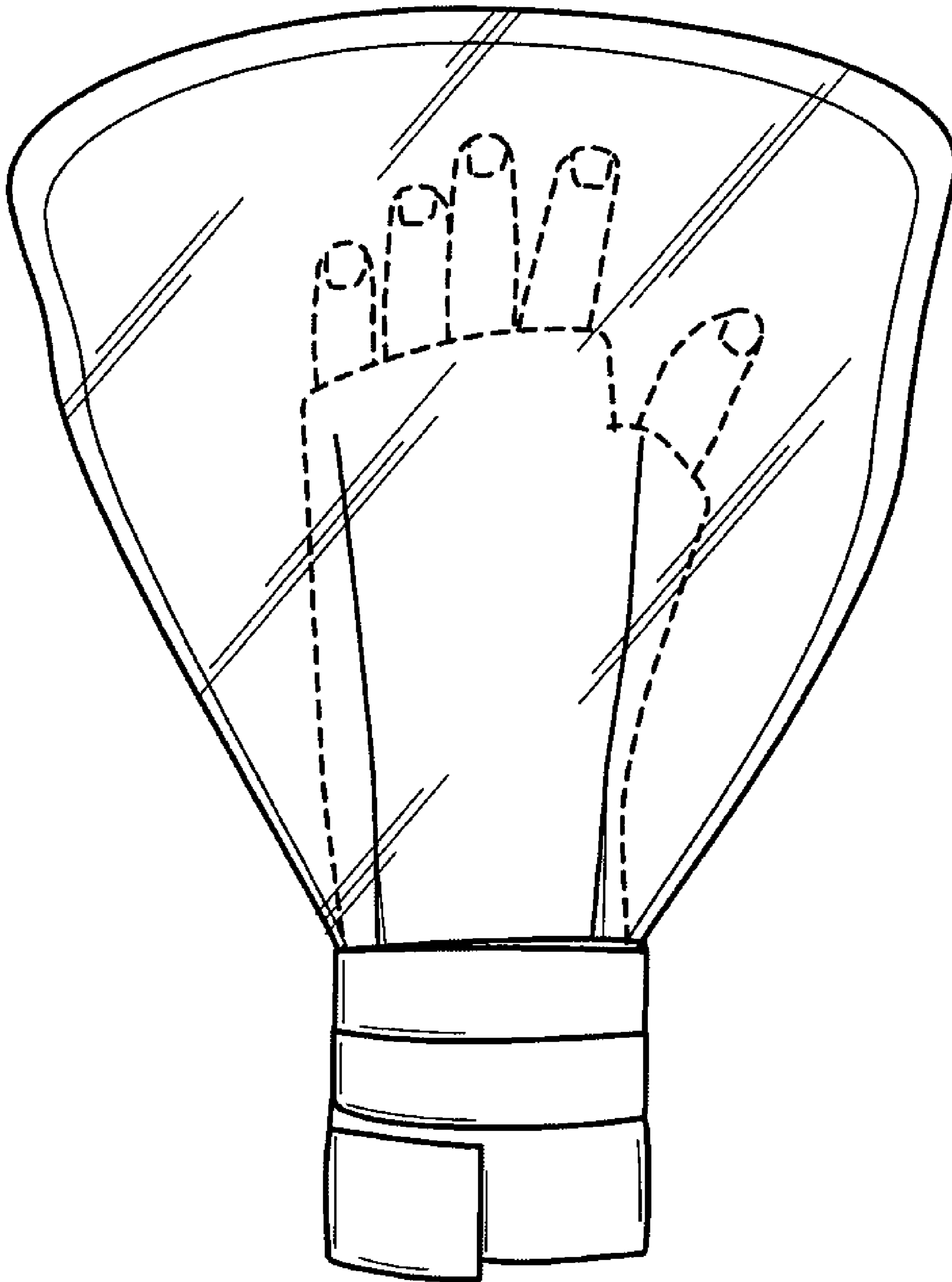
