DESCRIPTION

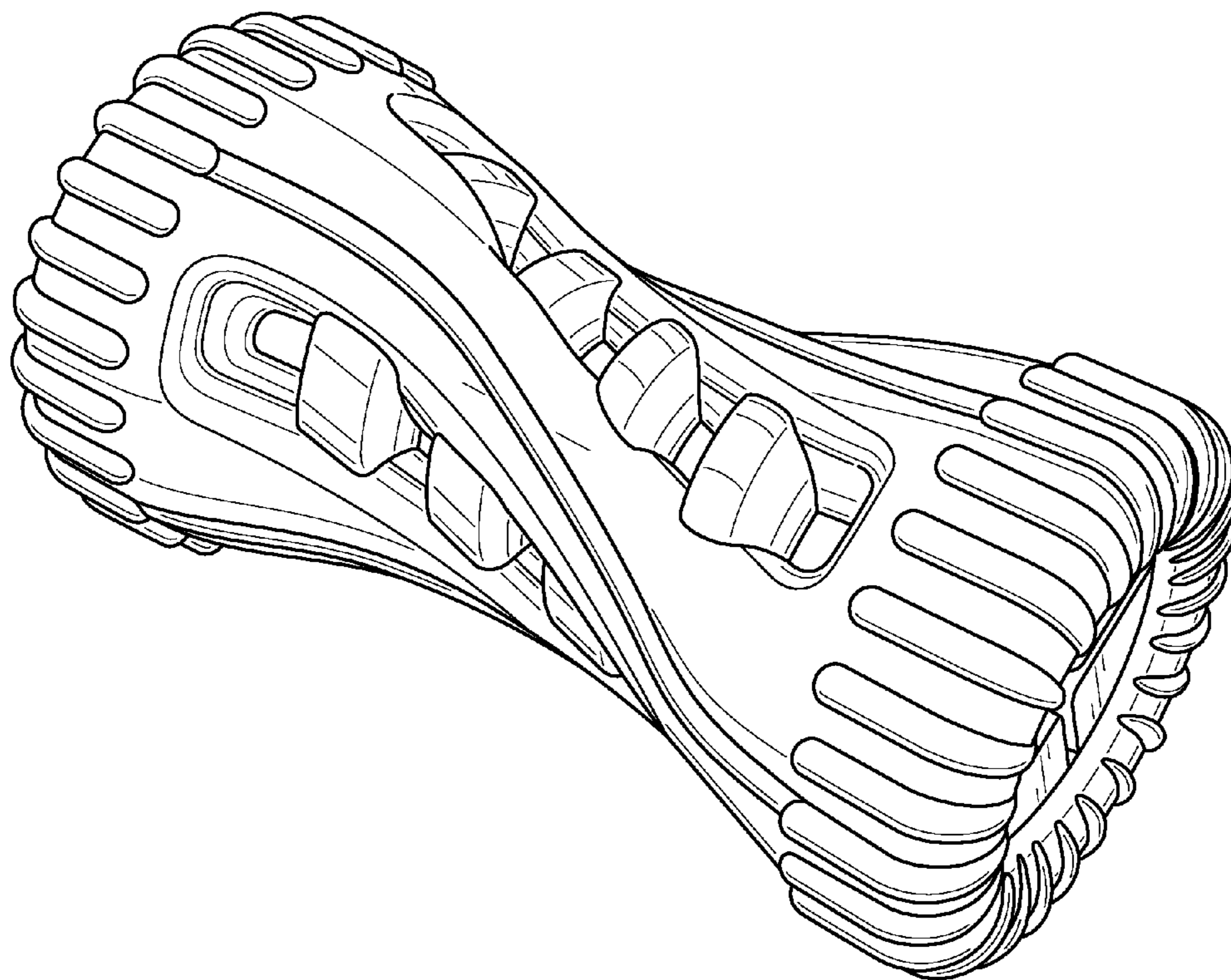
FIG. 1 is a perspective view of a first embodiment of a twisting barrel pet chew of the present invention;

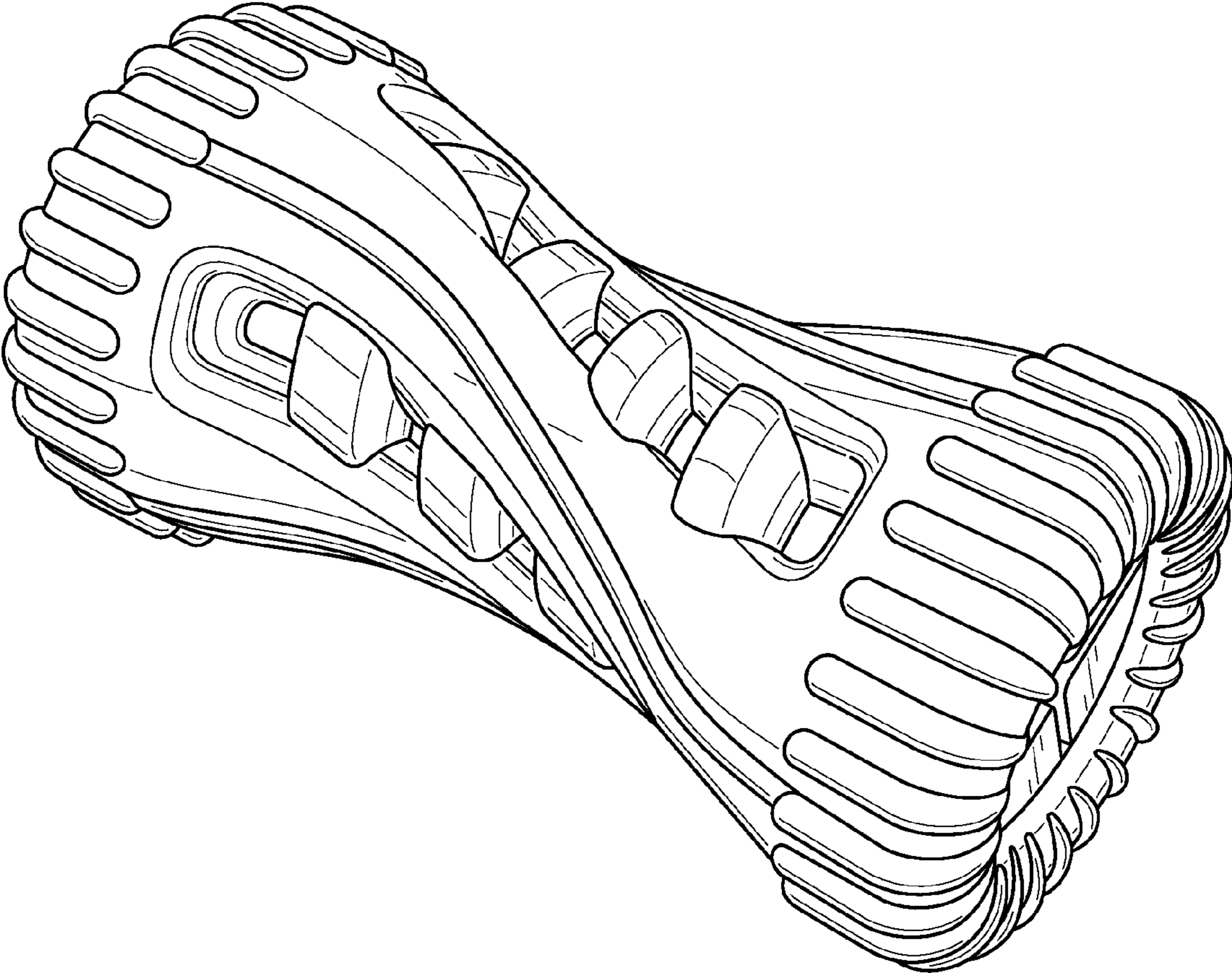

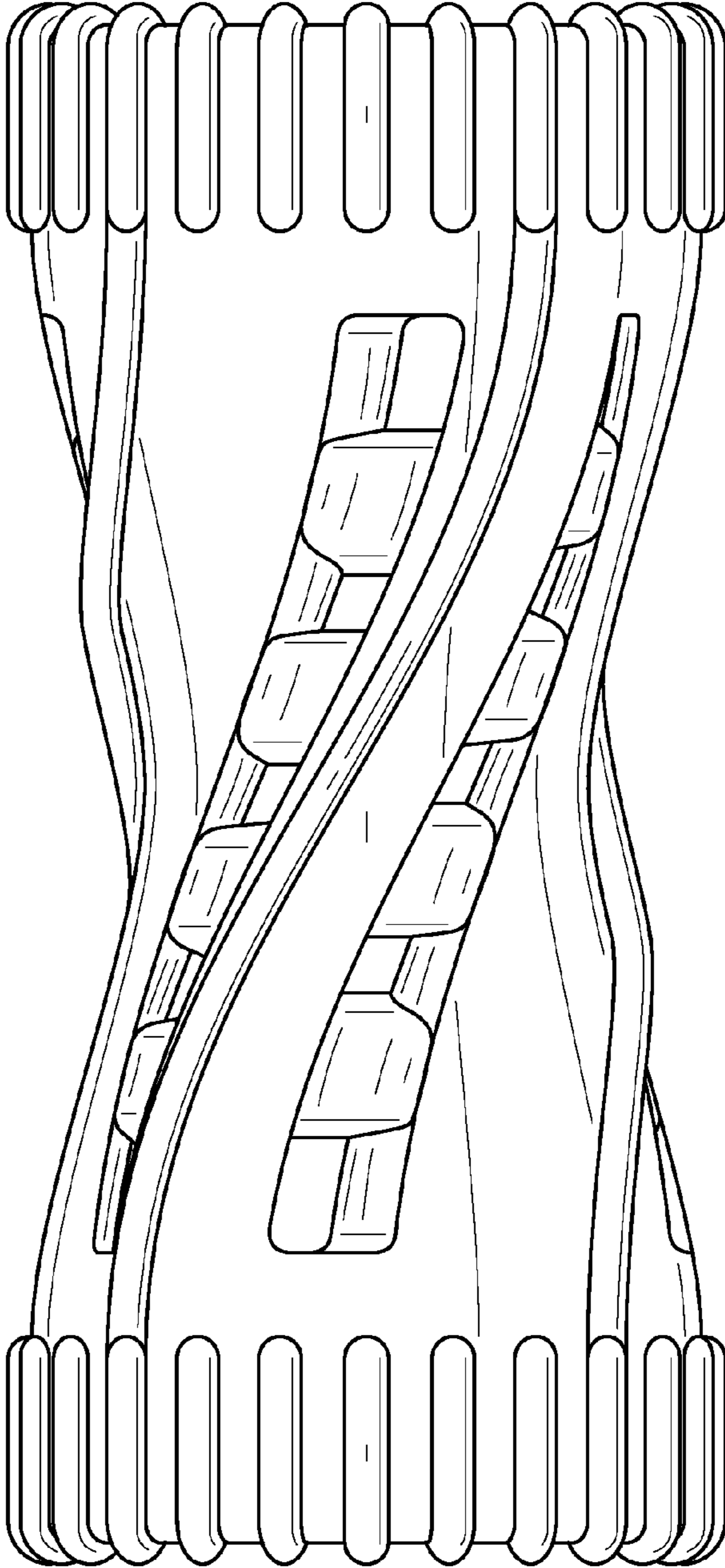

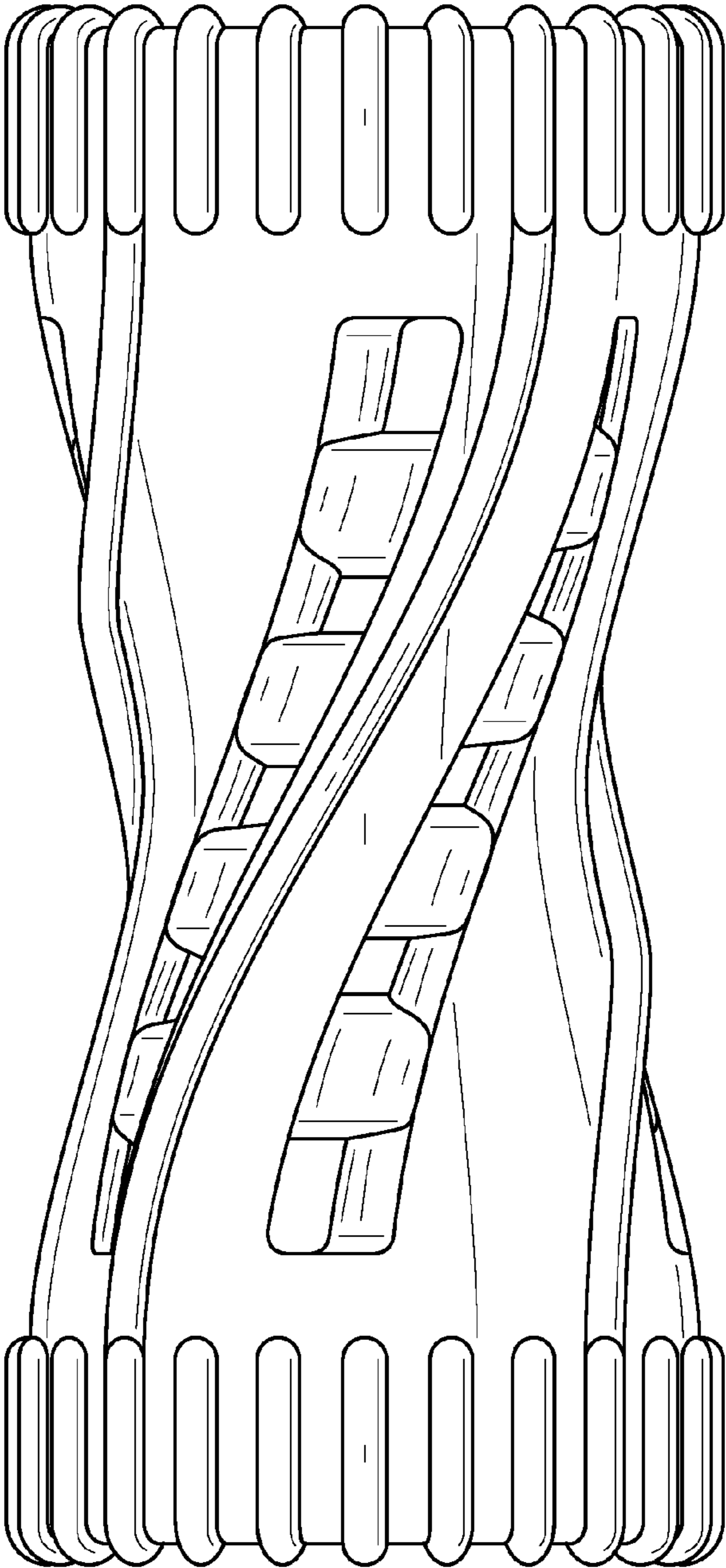

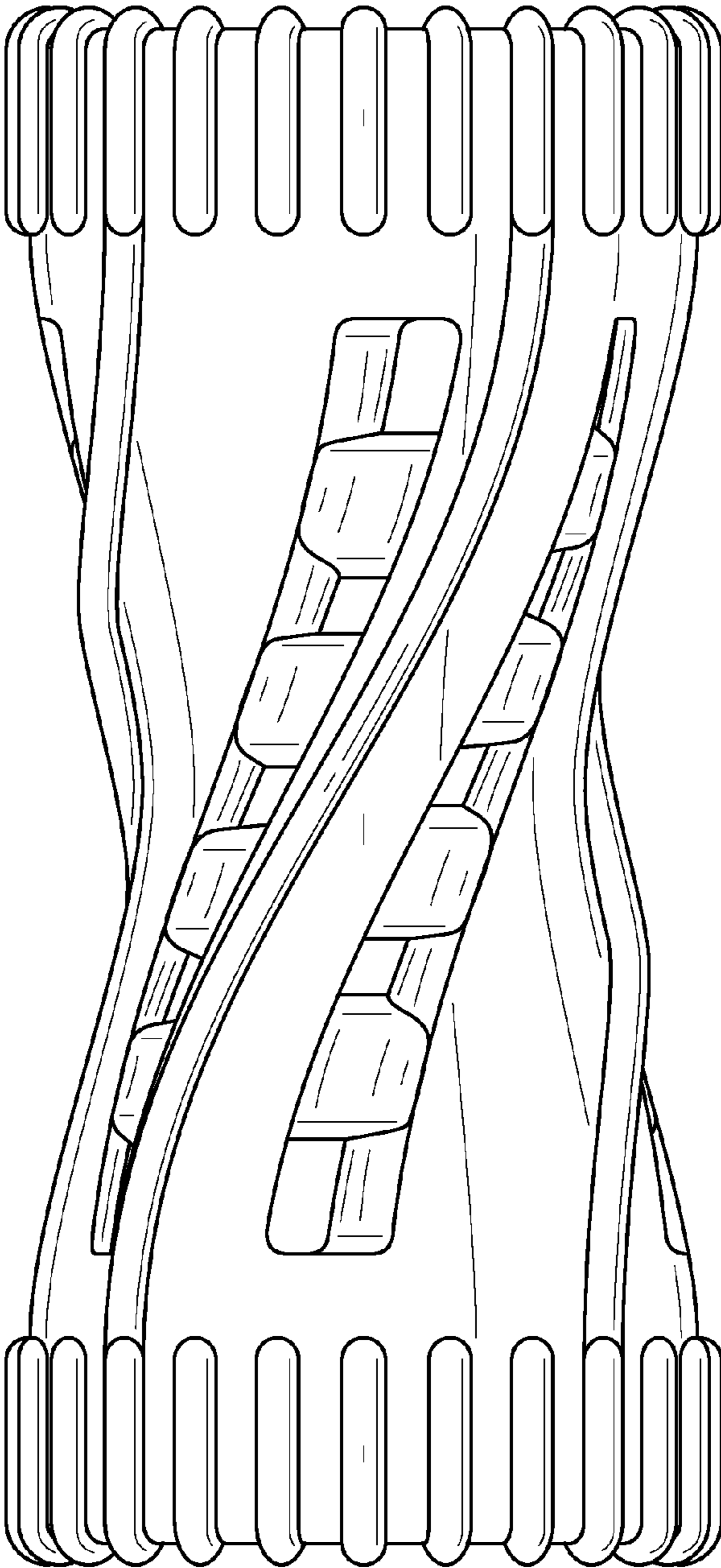

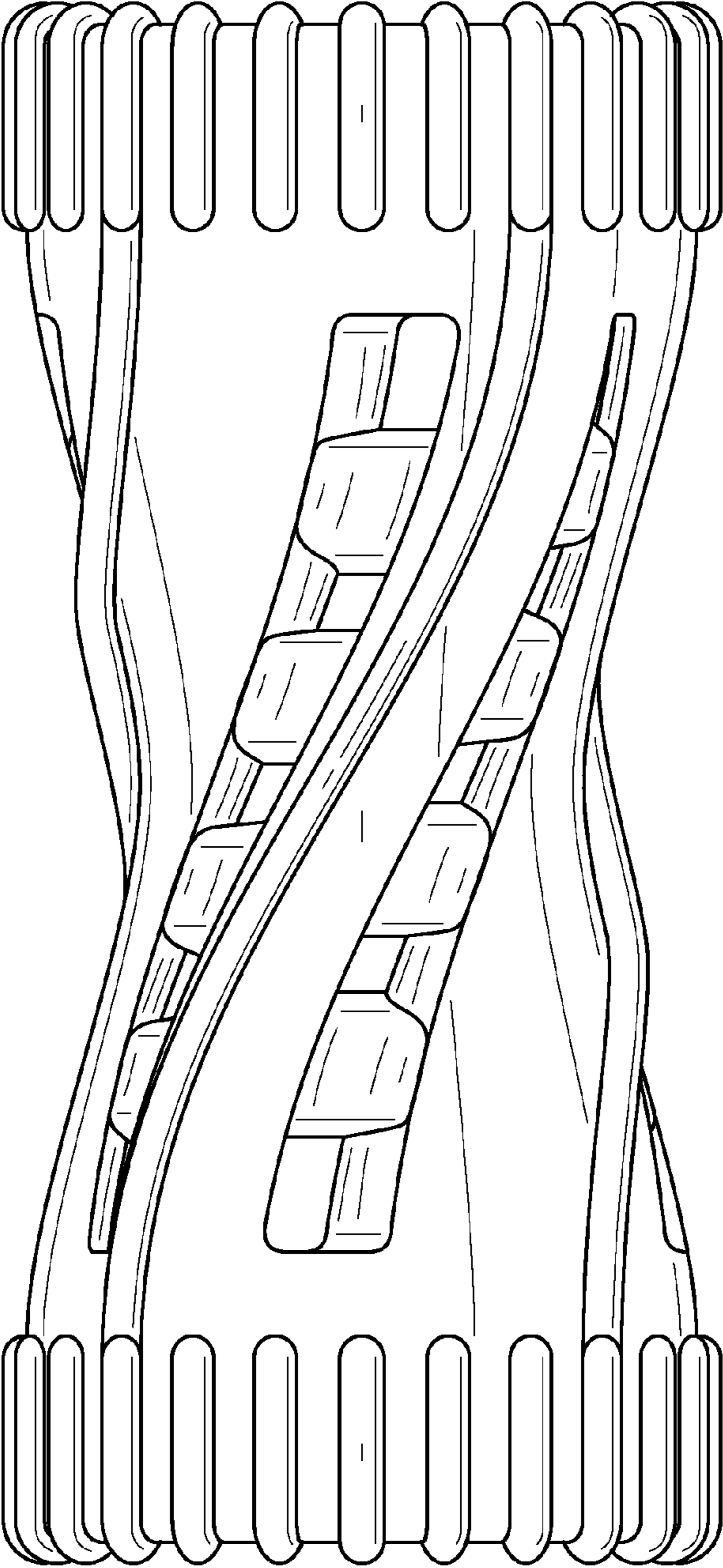

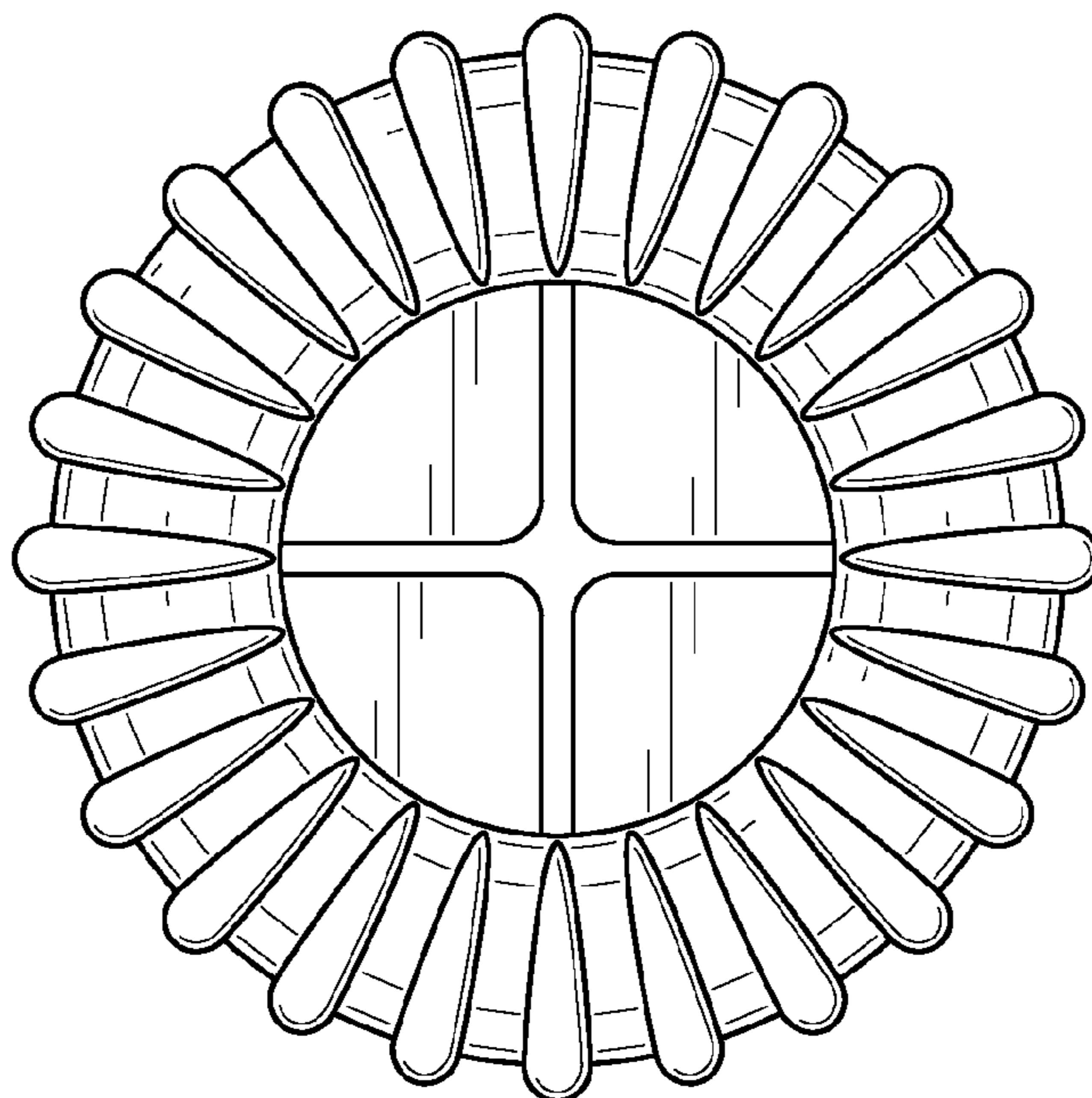

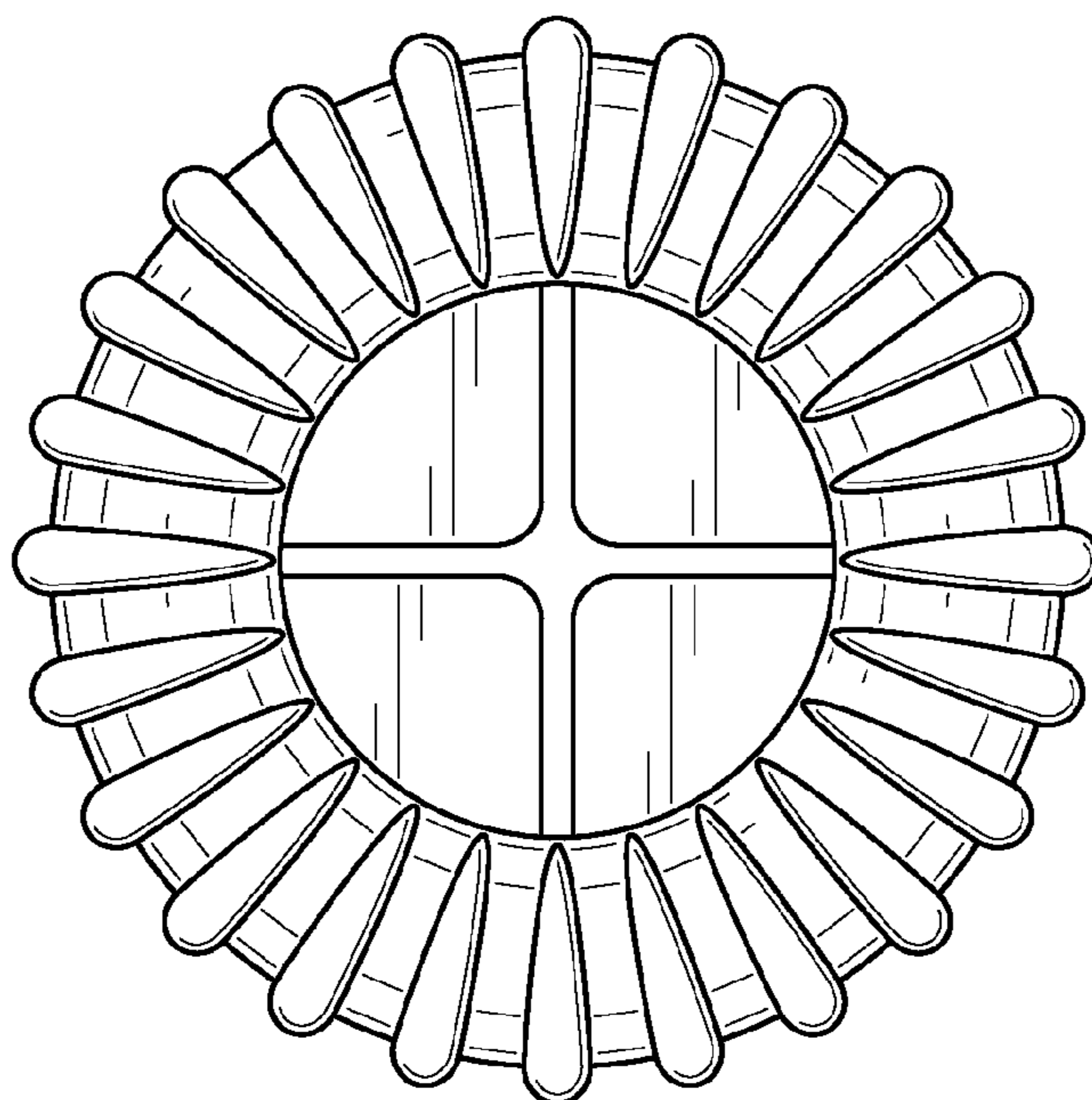
