(57) **CLAIM**

The ornamental design for a conveyor chain link, as shown
and described.

DESCRIPTION

FIG. 1 is a top plan view of a conveyor chain link embodying
our new design;

FIG. 2 is a front elevation view thereof;

FIG. 3 is a rear elevation view thereof;

FIG. 4 is a left side elevation view thereof with the right side
thereof being a mirror image of the left side shown;

FIG. 5 is a top plan view of a conveyor chain link embodying
a second embodiment of the design;

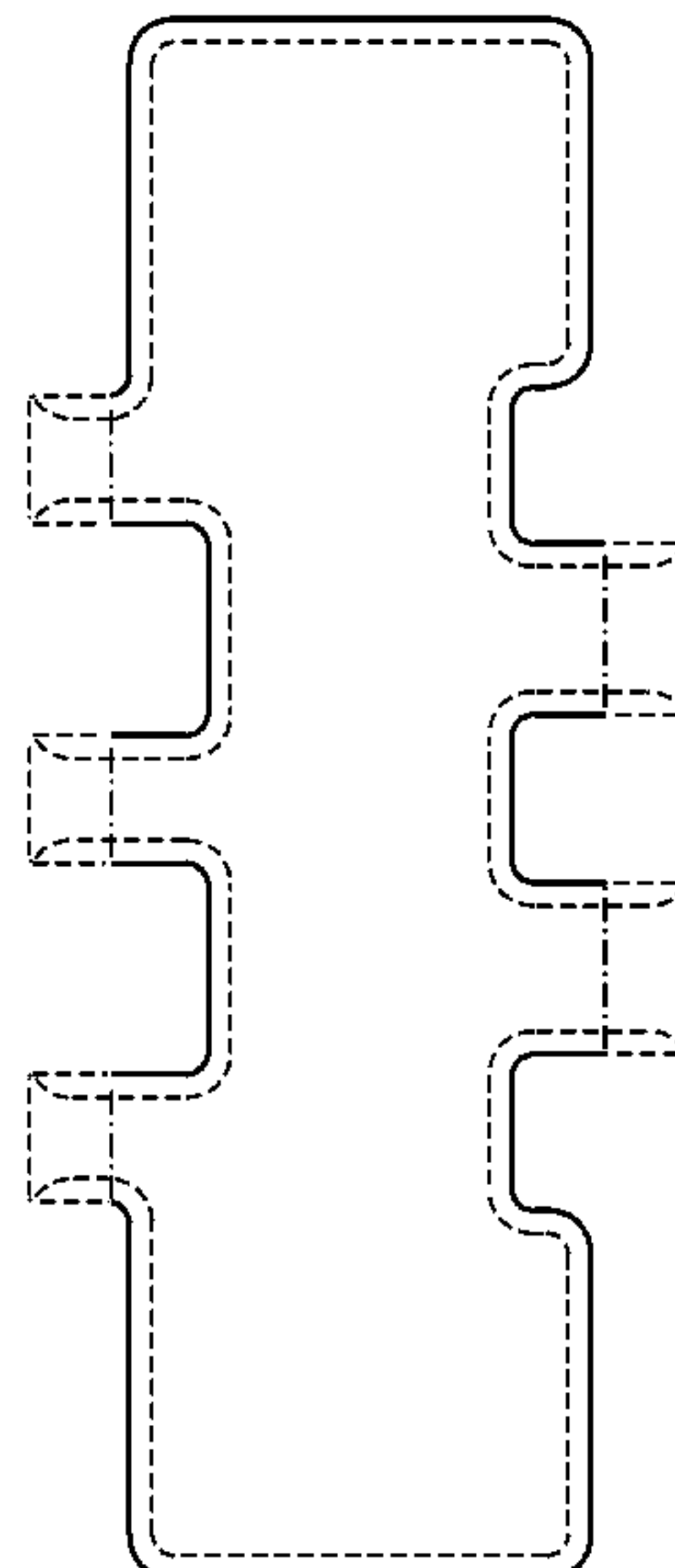
FIG. 6 is a front elevation view thereof;

FIG. 7 is a rear elevation view thereof; and,

FIG. 8 is a left side elevation view thereof with the right side
thereof being a mirror image of the left side shown.

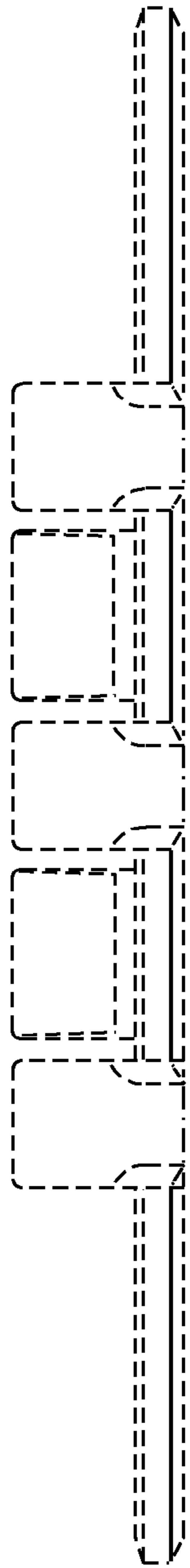

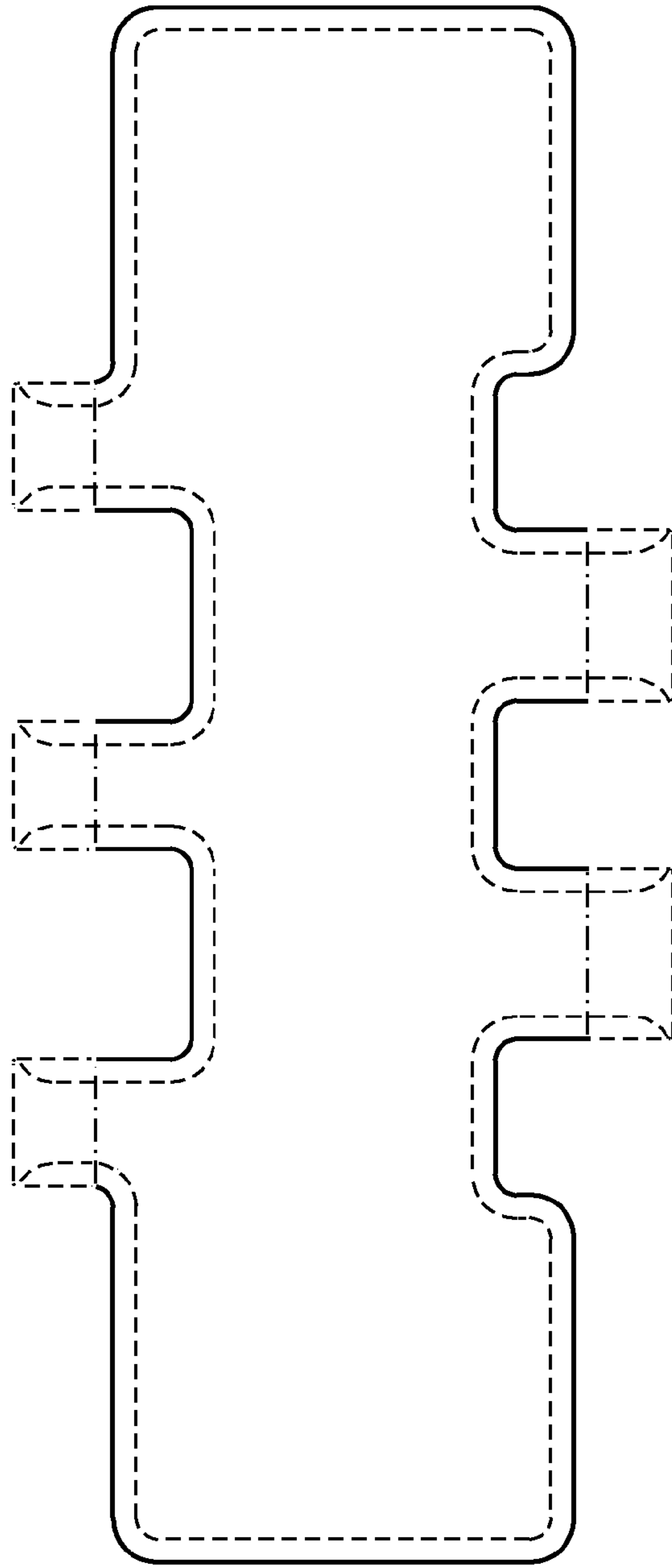

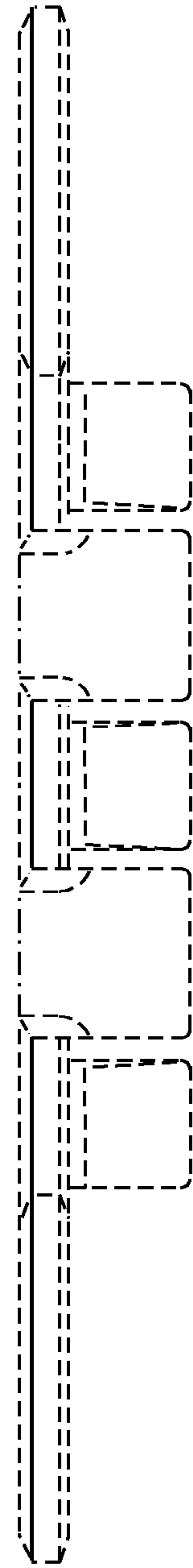

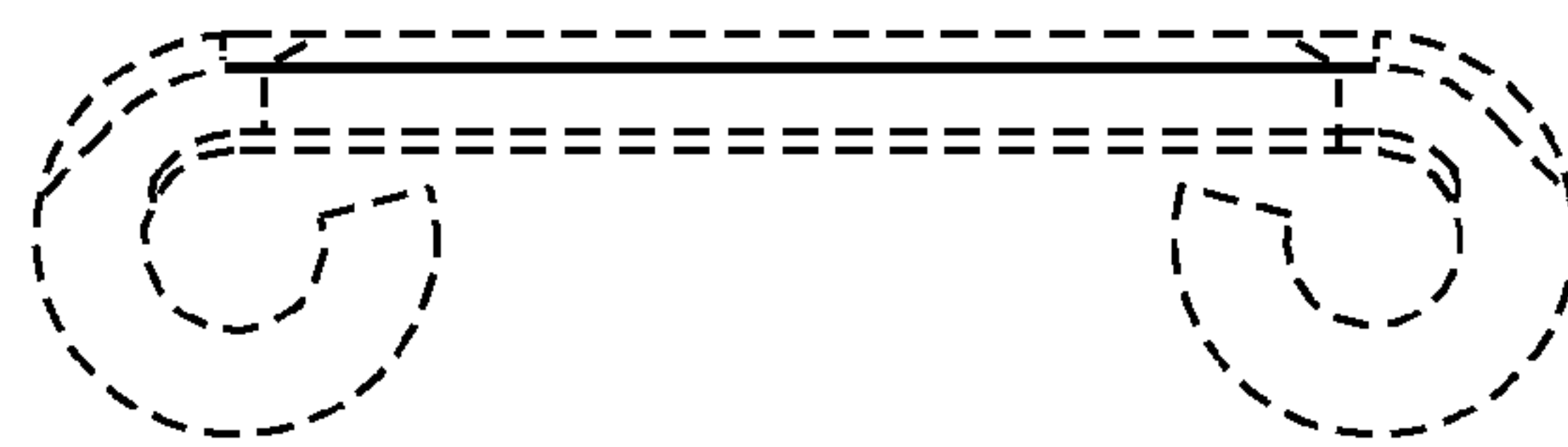

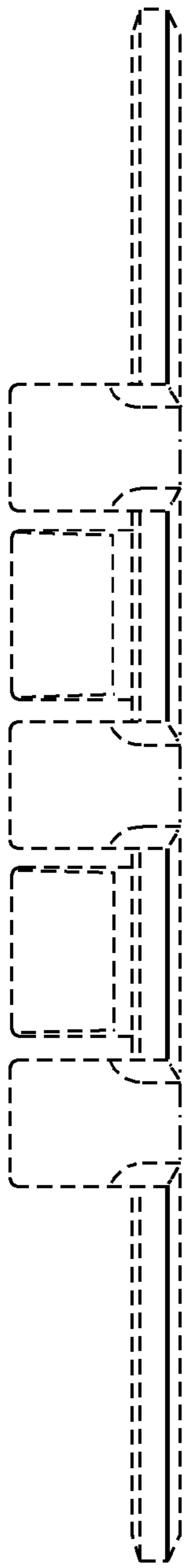

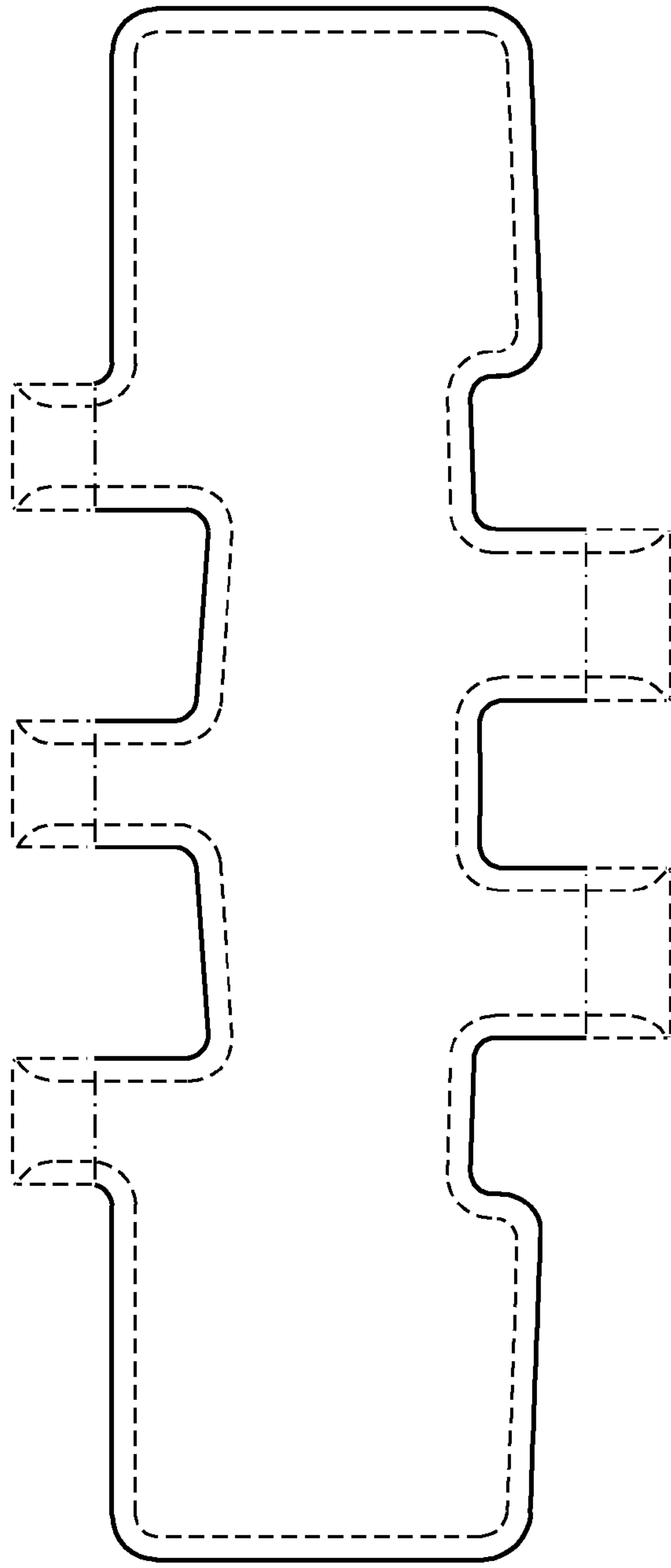

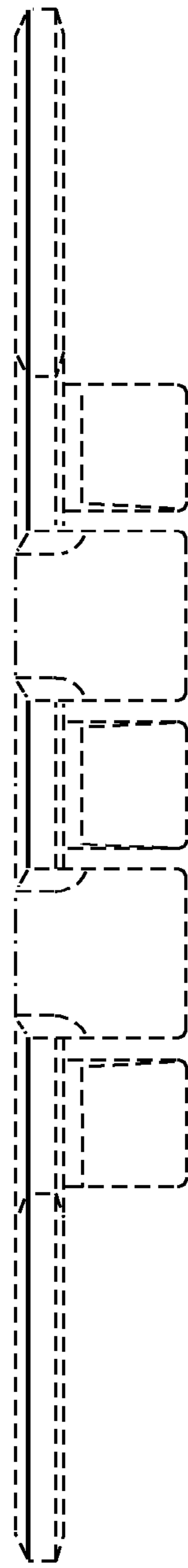

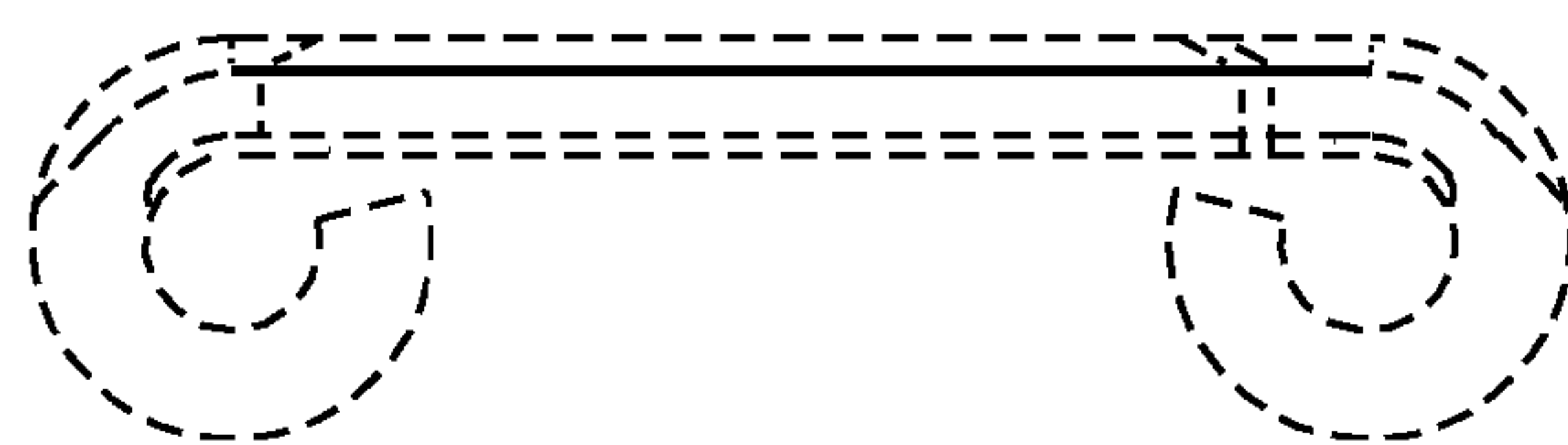
