(57) **CLAIM**

The ornamental design for a T-shirt, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevational view of a T-shirt showing our new design;

FIG. 2 is a left side view thereof;

FIG. 3 is a rear elevational view thereof; and,

FIG. 4 is a right side view thereof.

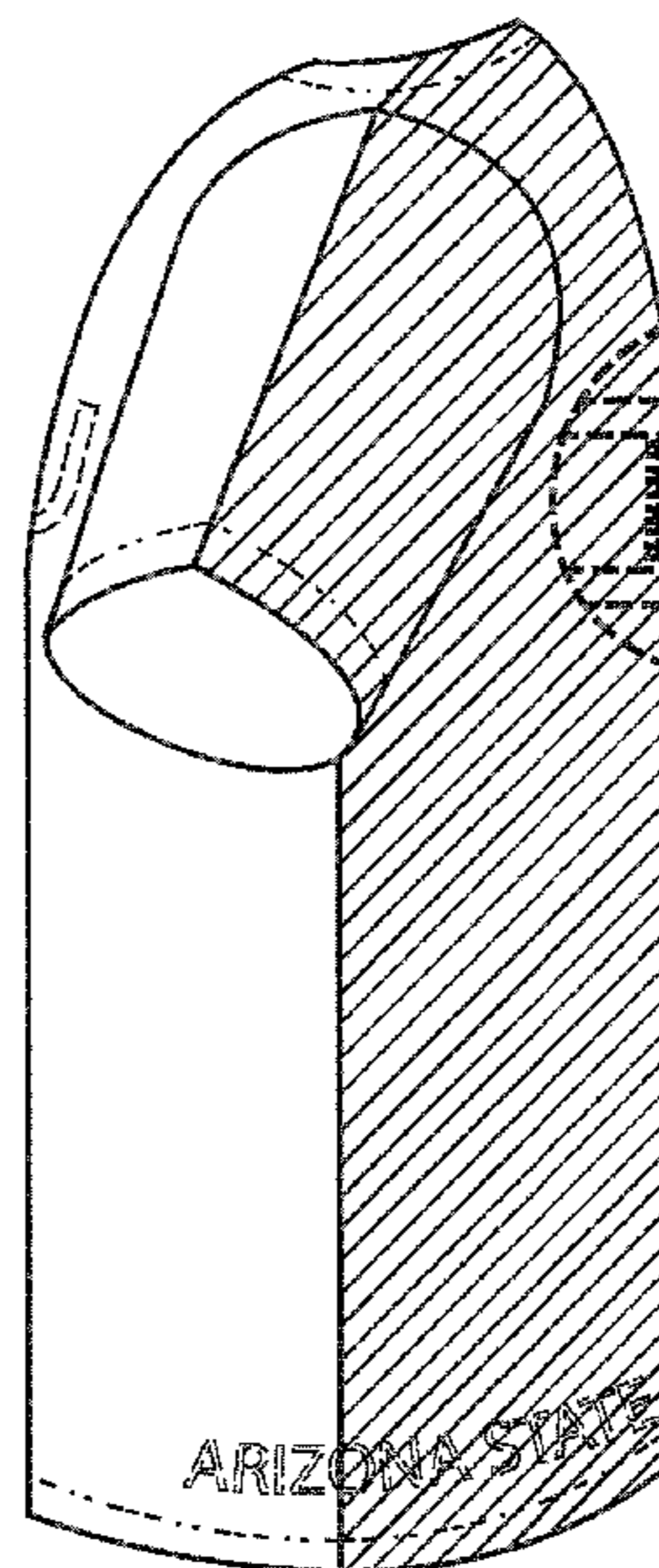
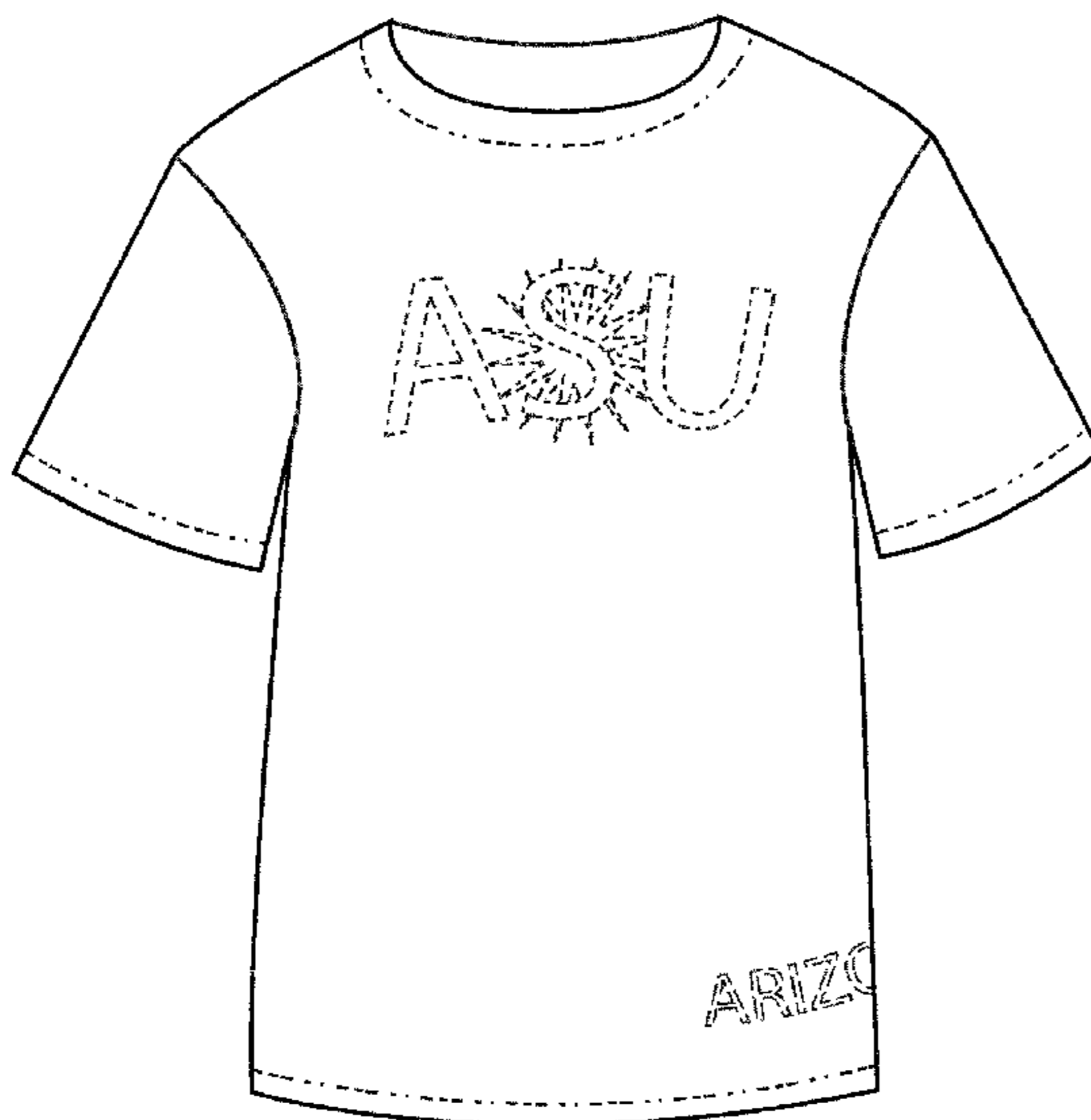
The even dash lines showing the football is included for the purpose of illustrating environmental structure and form no part of the claimed design.

The dash-dash-dash-dot-dot lines showing the stitching in the collar and hemlines of the T-shirt are included for the purpose of illustrating environmental structure and form no part of the claimed design.

The broken lines shown in the drawings as forming the words "ASU" and "ARIZONA STATE" represent unclaimed portions of the design and form no part of the claimed design.

The diagonal lines are included for the purpose of showing surface shading and are meant to indicate contrasting color, contrasting materials, and/or contrasting surface treatment.

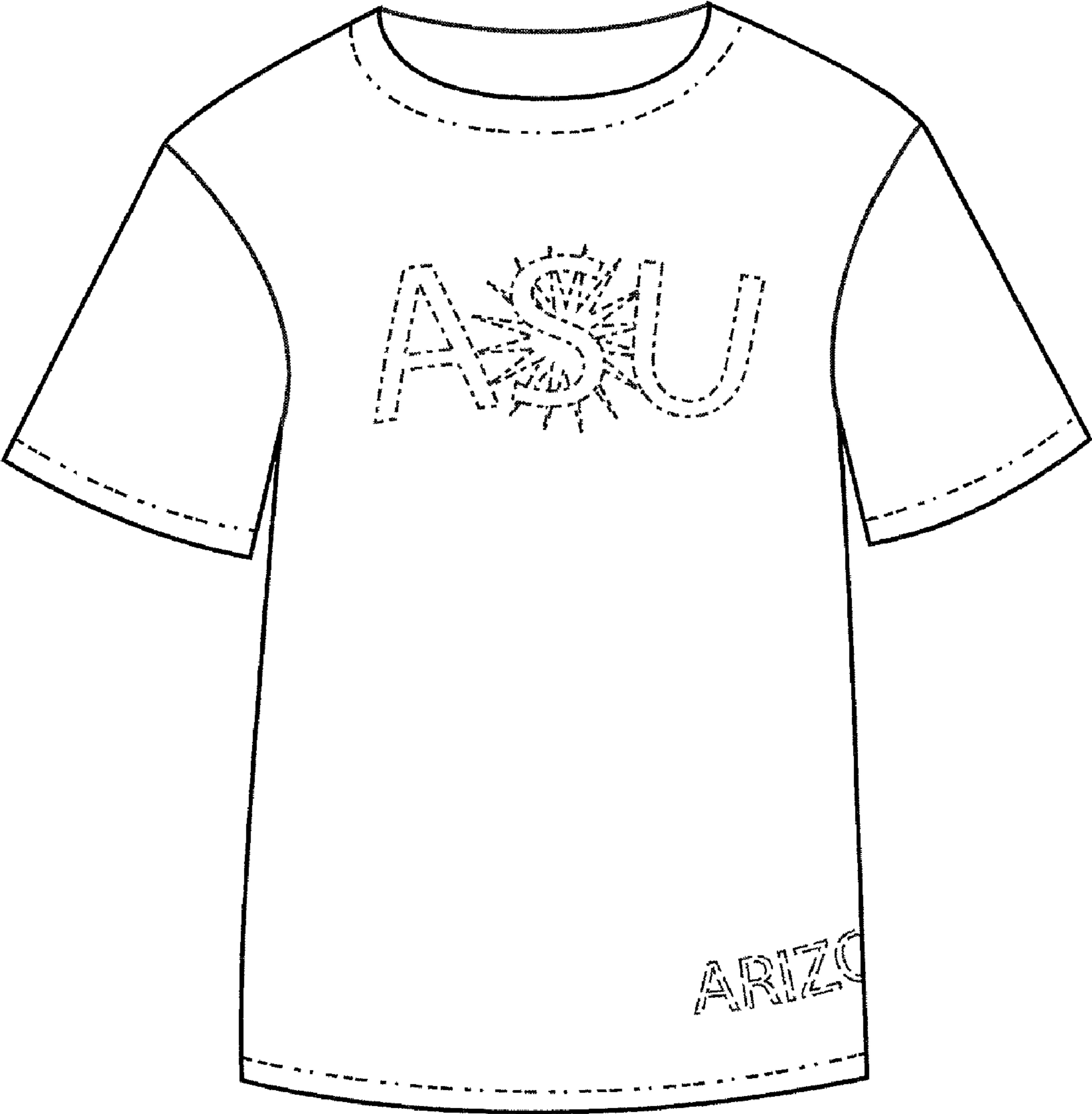

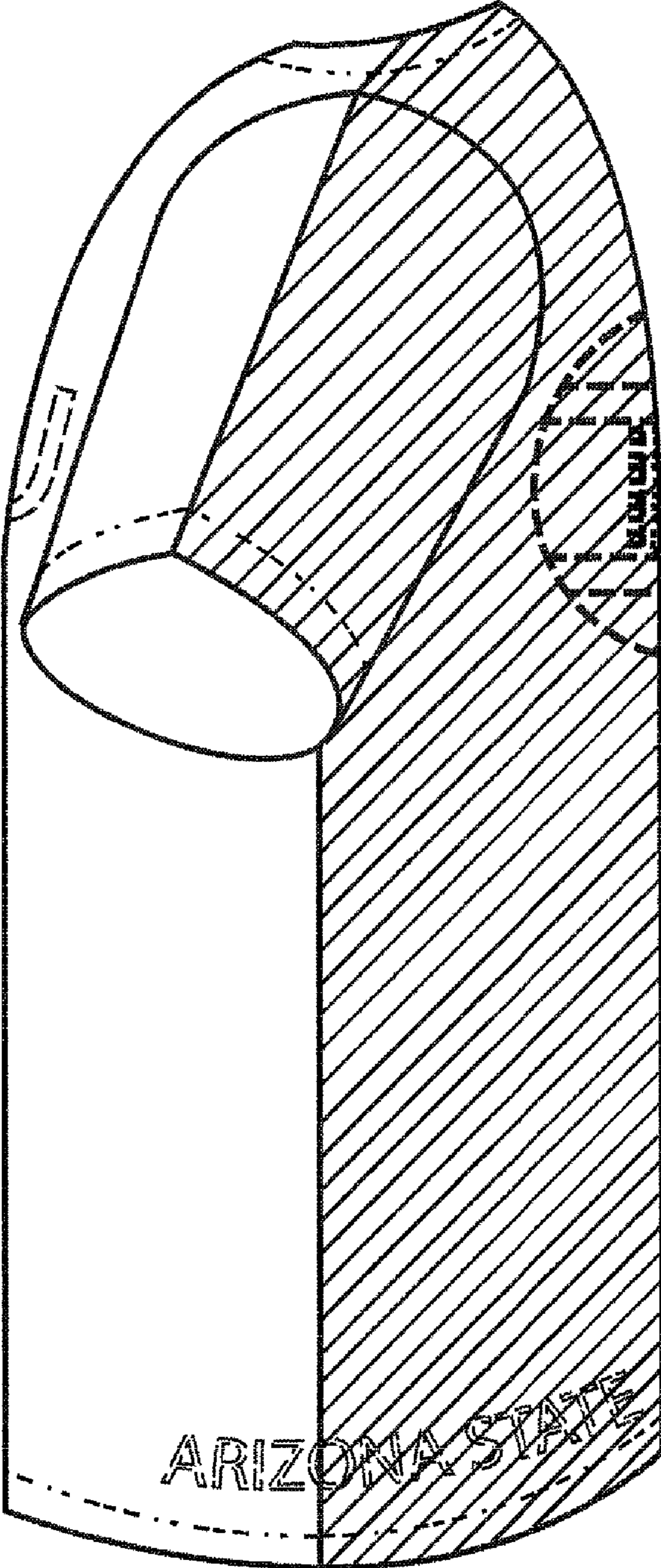

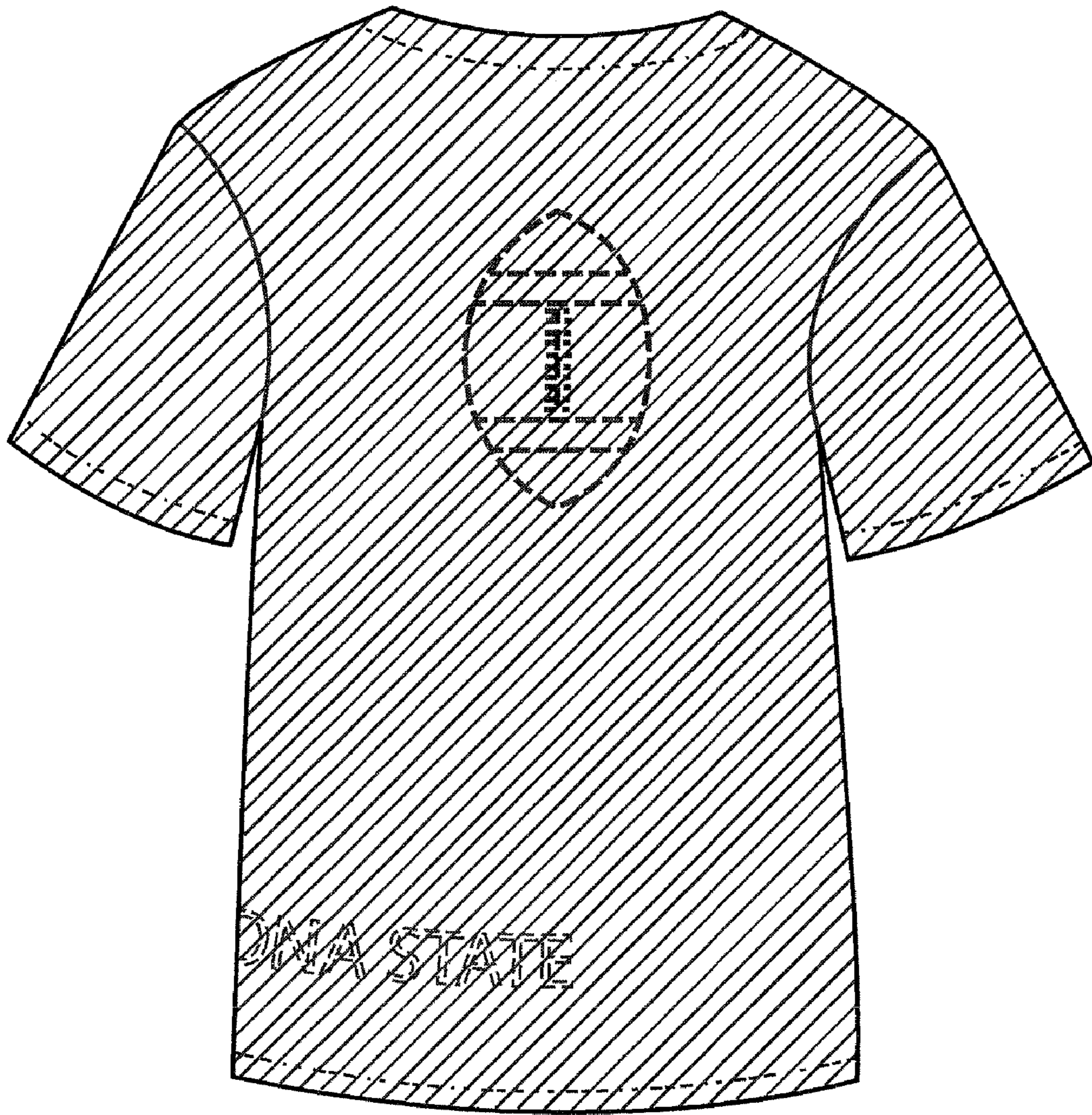

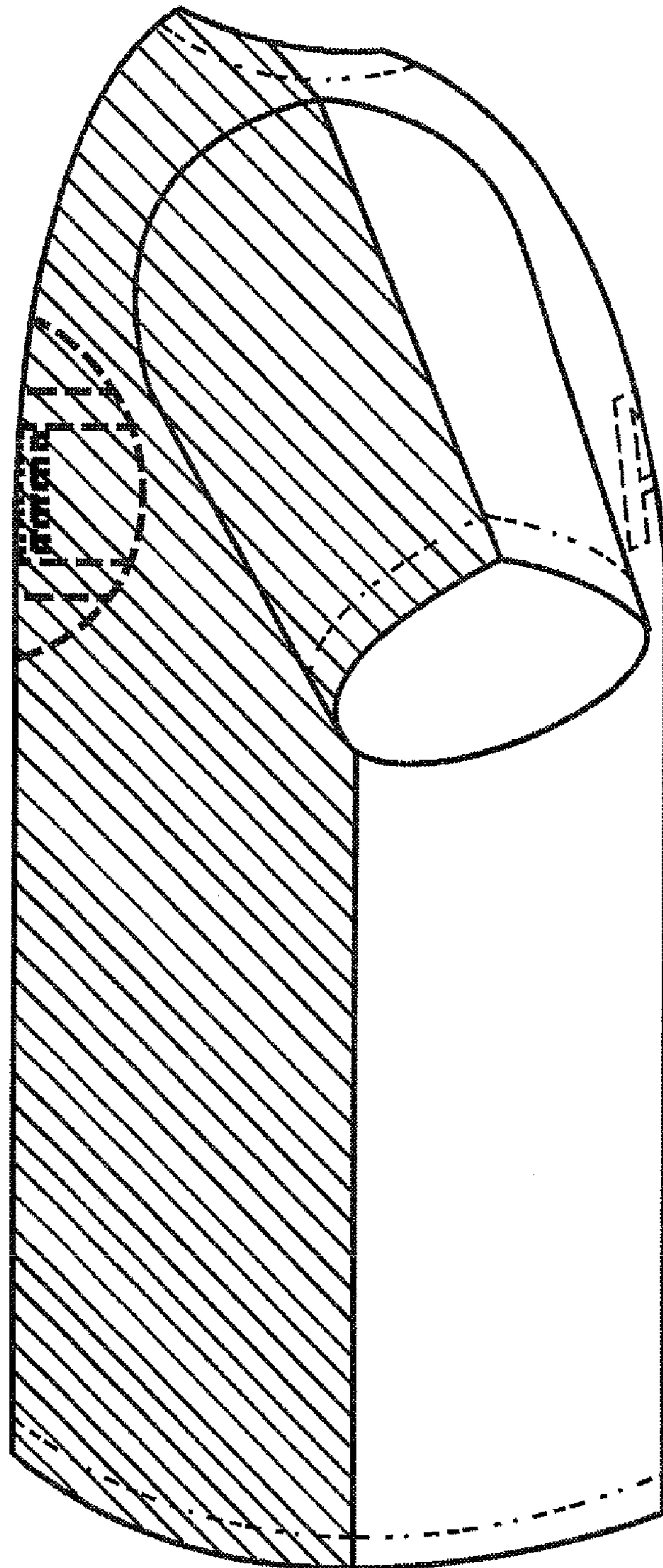
