(57) **CLAIM**

I claim an ornamental design for shorts, as shown and described.

DESCRIPTION

FIG. 1 is a front view of shorts showing our new design;

FIG. 2 is a rear view thereof;

FIG. 3 is a top view thereof;

FIG. 4 is a left side view thereof;

FIG. 5 is a bottom view thereof; and,

FIG. 6 is a right side view thereof.

In FIGS. 1-6, the elongated darker dashed lines represent stitching; the plaid pattern represents a stretchable material; and, the short lighter dashed lines represent the portions of the design which form no part of the claim.

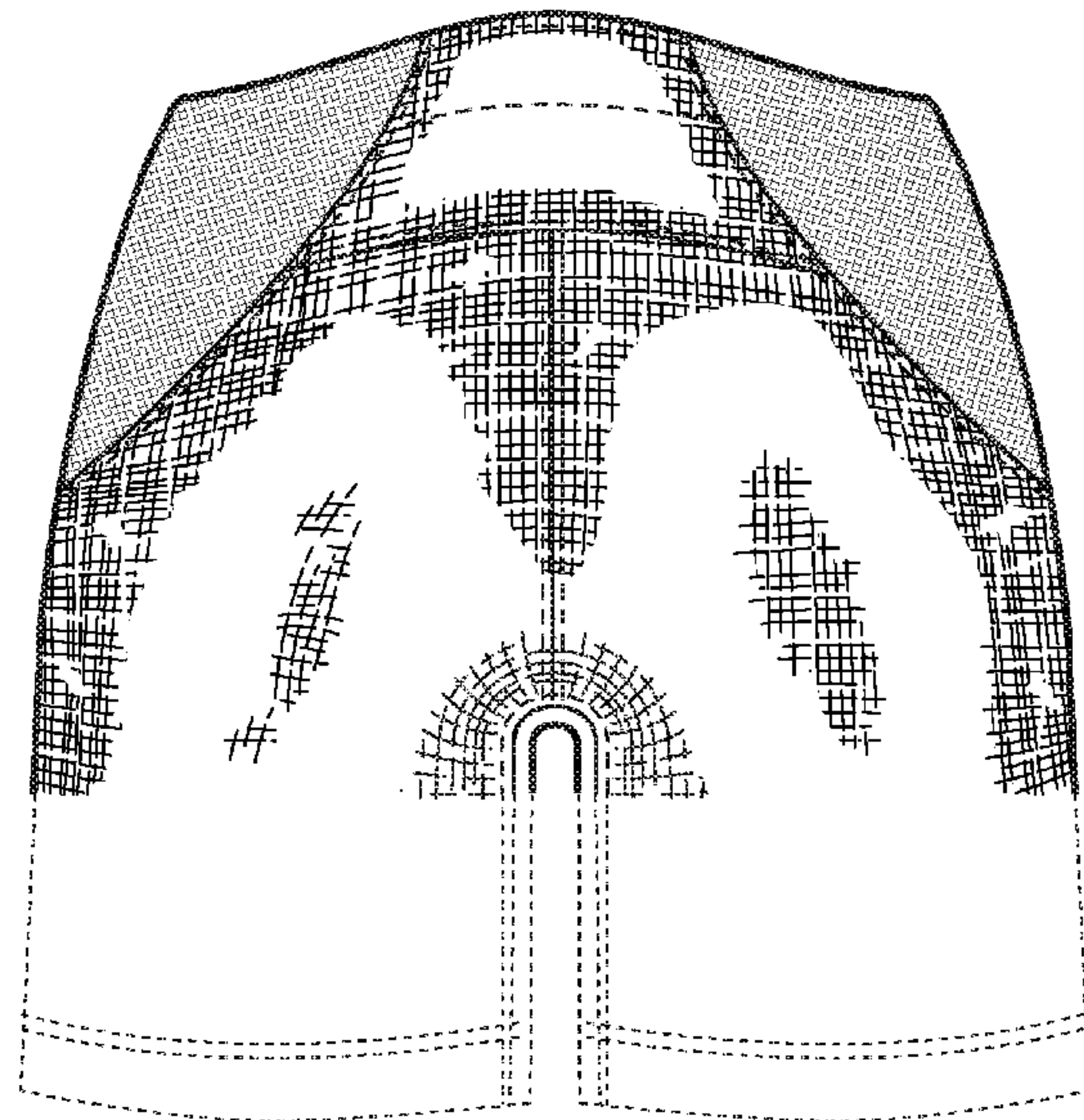
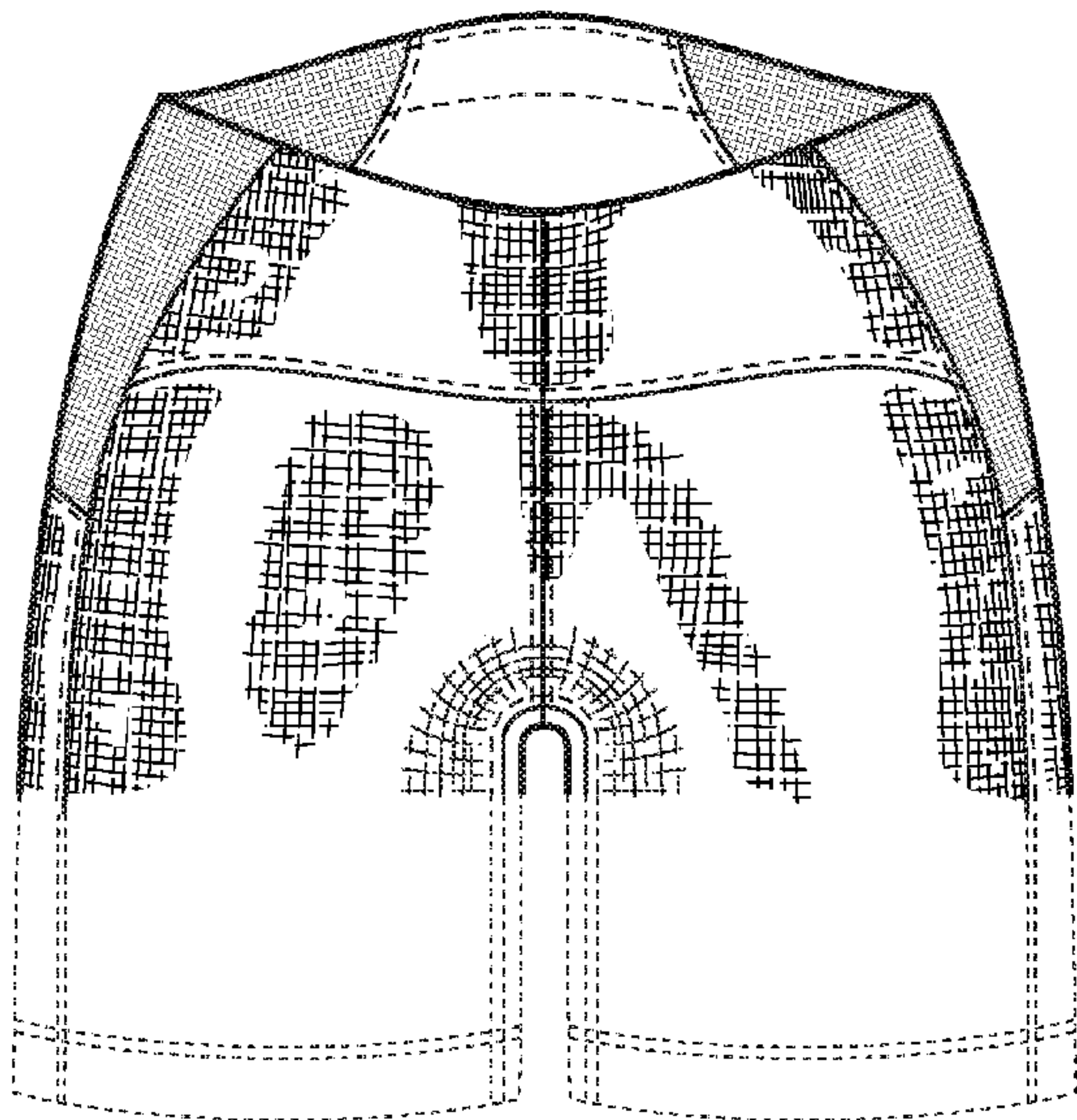

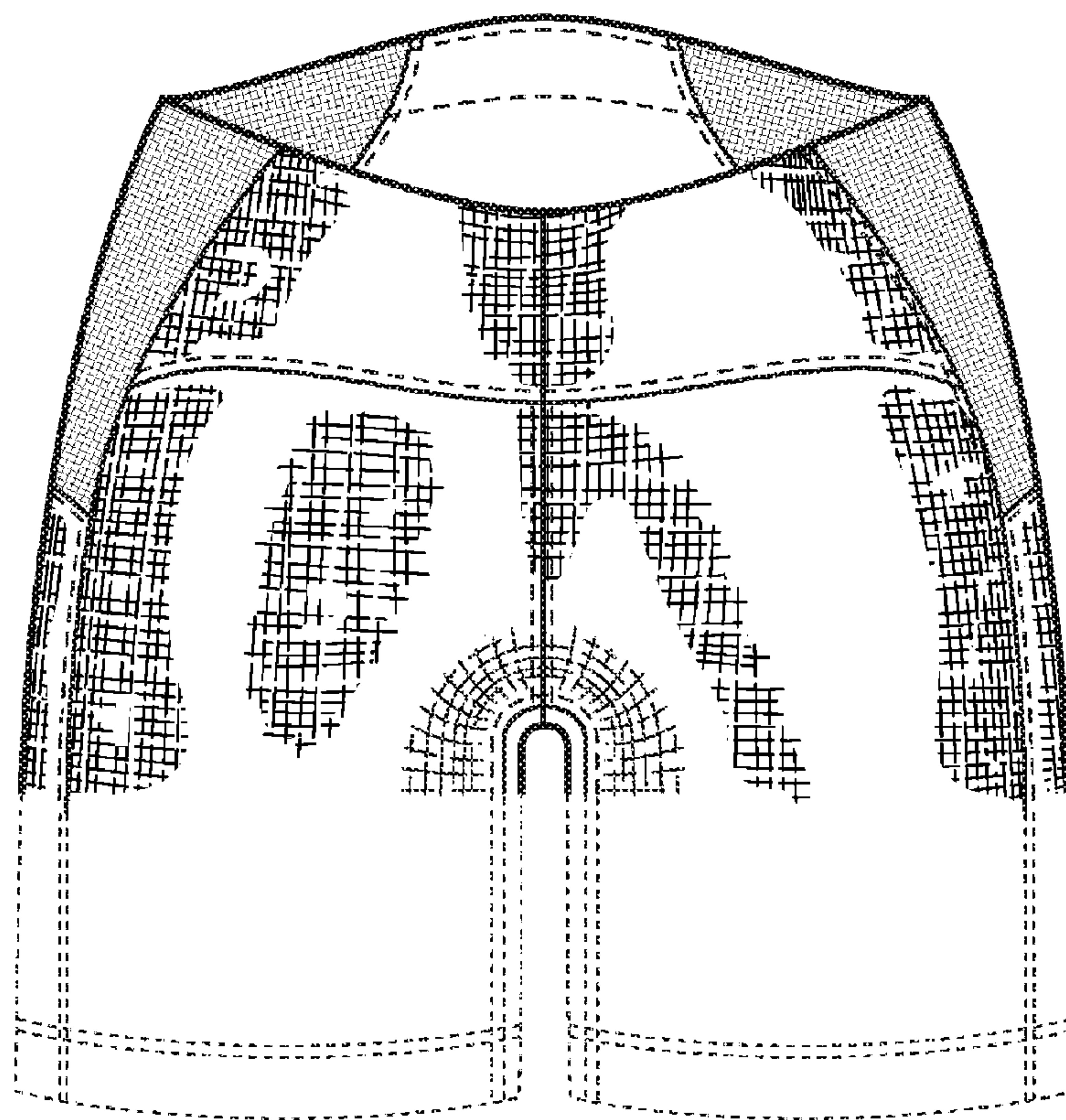
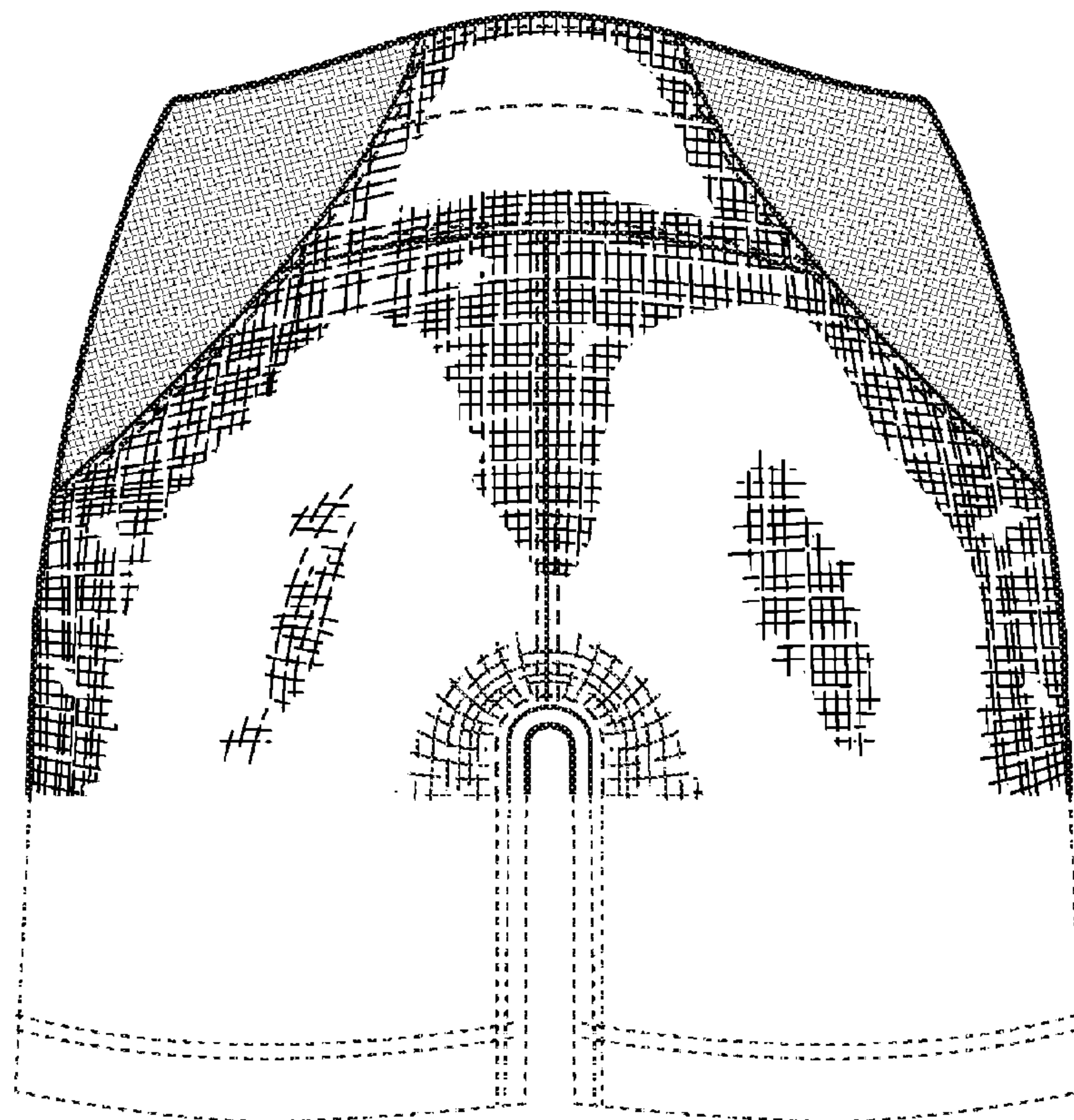

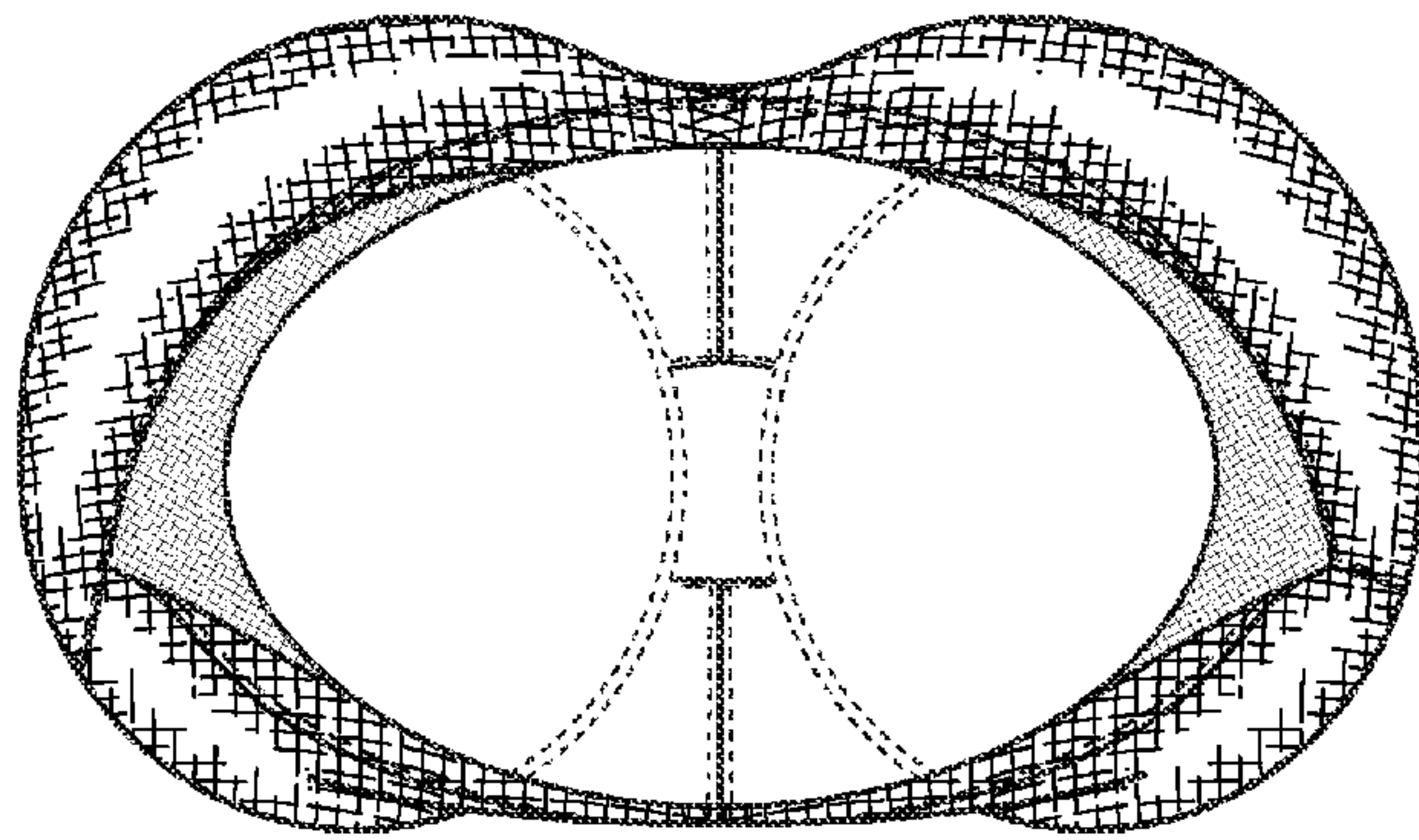

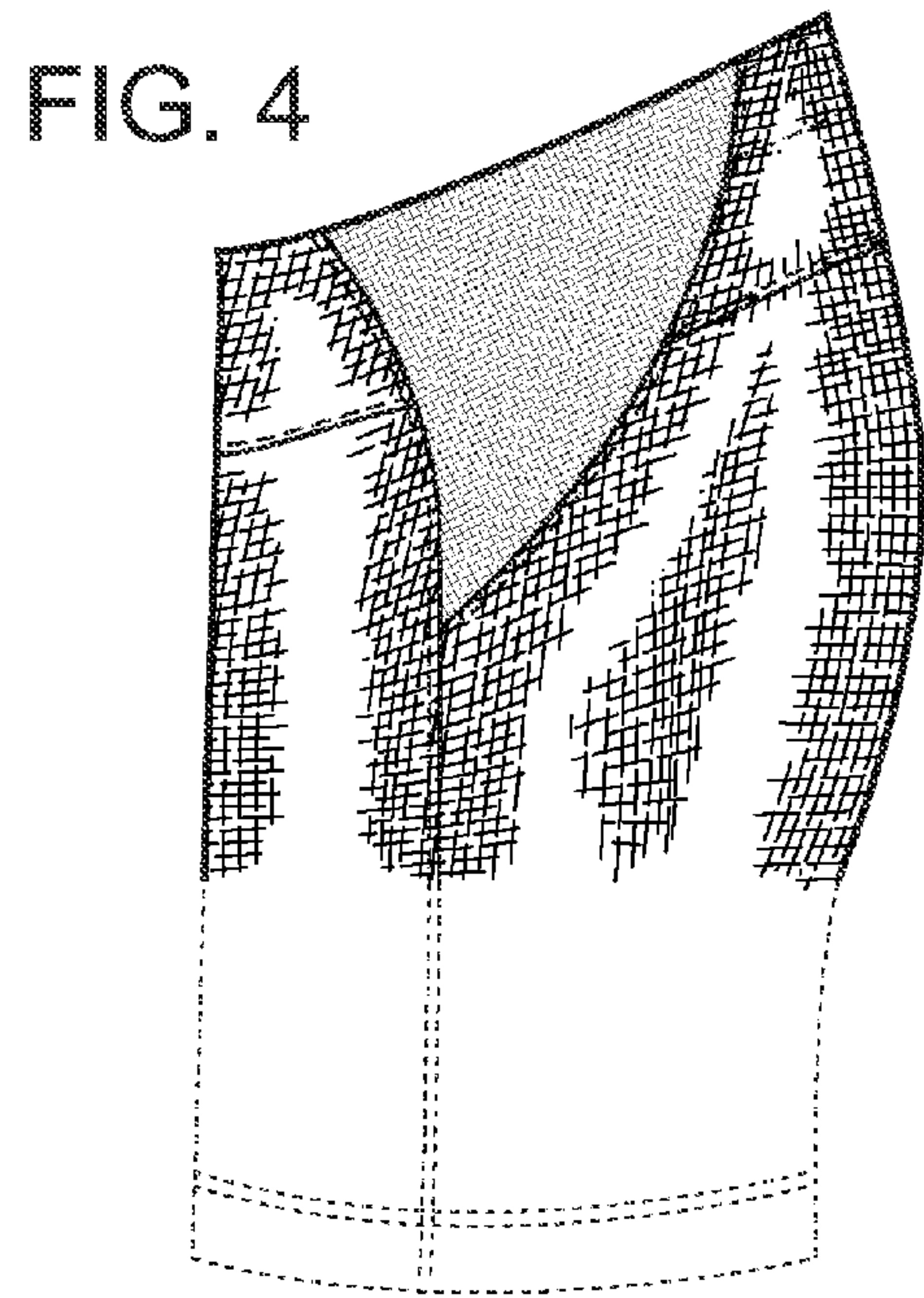

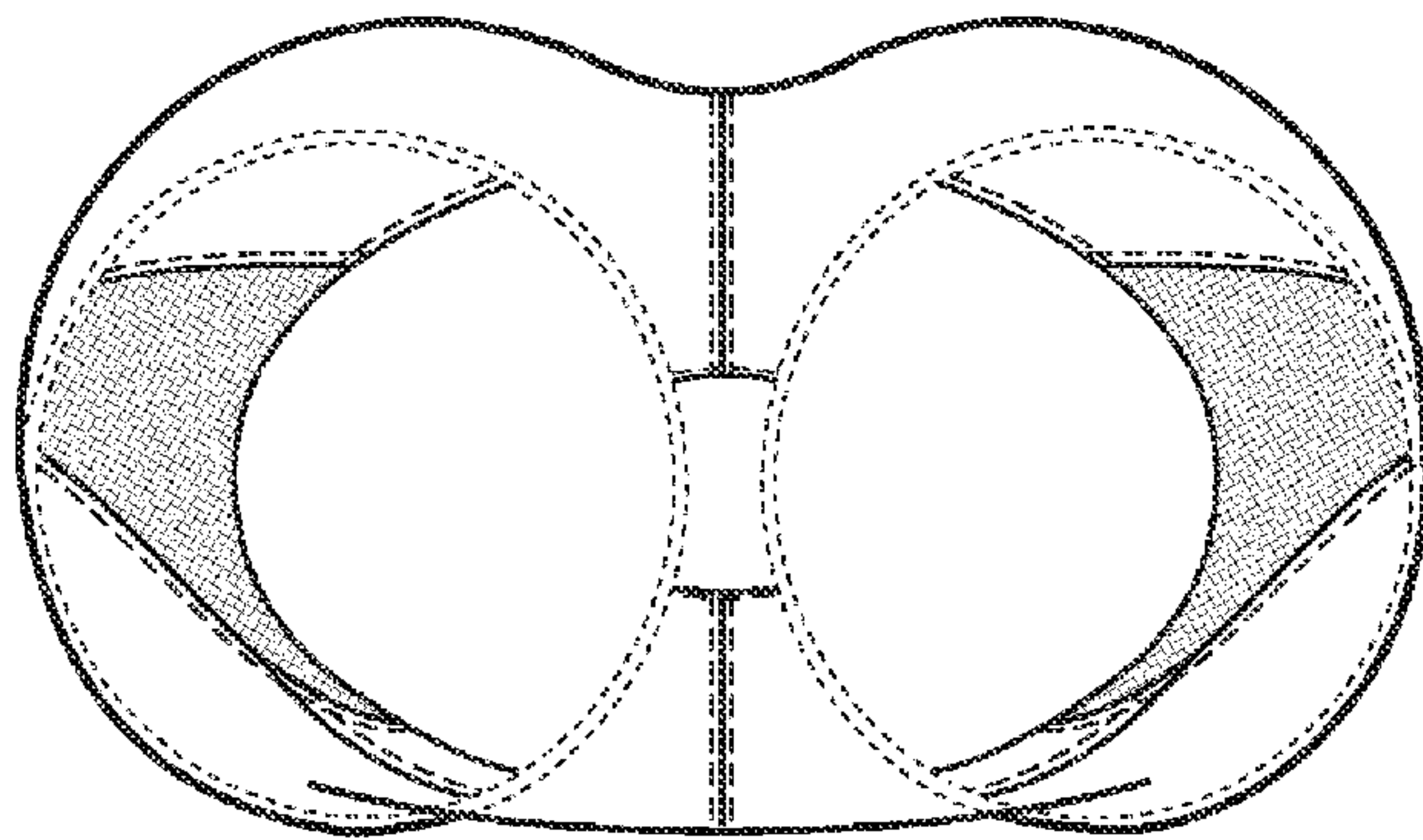

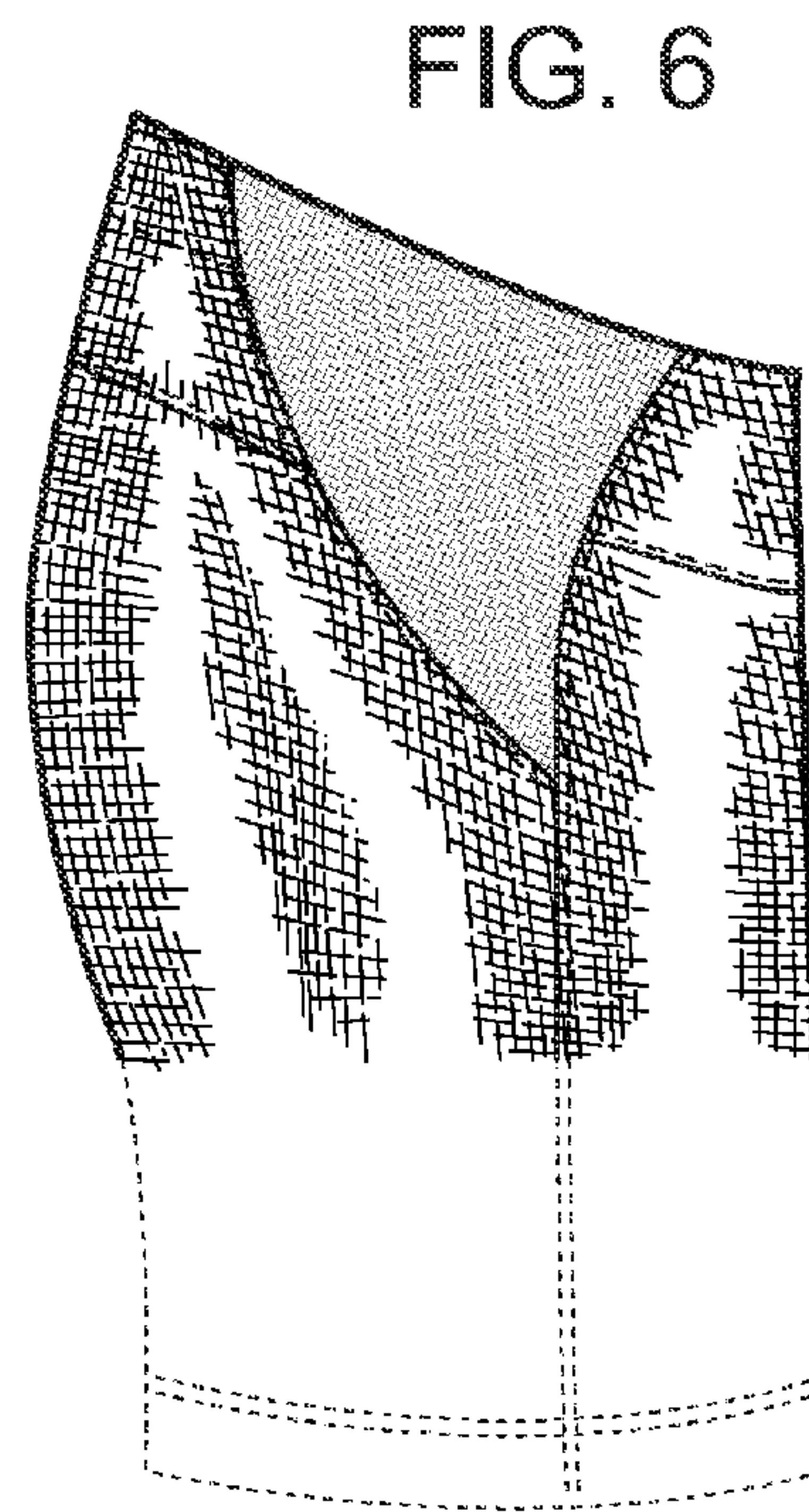
