(57) **CLAIM**

I claim an ornamental design for pants, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of pants showing my new design; the flap folded down;

FIG. 2 is a rear view of the pants illustrated in FIG. 1 with the flap folded down;

FIG. 3 is a front view of the pants illustrated in FIG. 1 with the flap folded down;

FIG. 4 is a right side view of the pants illustrated in FIG. 1 with the flap folded down;

FIG. 5 is a left side view of the pants illustrated in FIG. 1 with the flap folded down;

FIG. 6 is a front perspective view of the pants illustrated in FIG. 1, showing the flap folded up;

FIG. 7 is a rear view of the pants illustrated in FIG. 6 with the flap folded up;

FIG. 8 is a front view of the pants illustrated in FIG. 6 with the flap folded up;

FIG. 9 is a right side view of the pants illustrated in FIG. 6 with the flap folded up;

FIG. 10 is a left side view of the pants illustrated in FIG. 6 with the flap folded up;

FIG. 11 is a top view of the pants illustrated in FIG. 1 with the flap folded down;

FIG. 12 is a bottom view of the pants illustrated in FIG. 1 with the flap folded down;

FIG. 13 is a top view of the pants illustrated in FIG. 6 with the flap folded up; and,

FIG. 14 is a bottom view of the pants illustrated if FIG. 6 with the flap folded up.

The broken lines in FIGS. 1-14 represent the portions of the pants, which form no part of the claimed design.

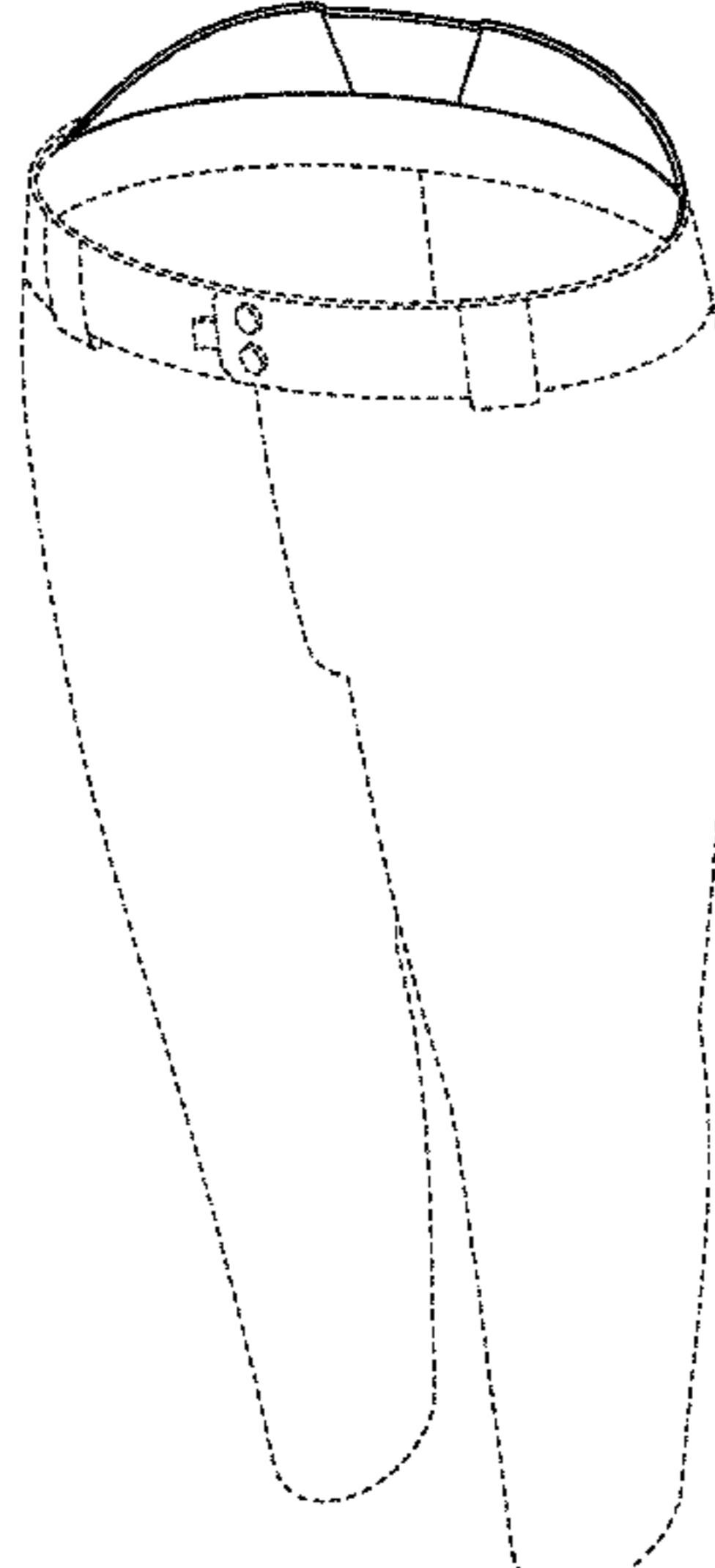
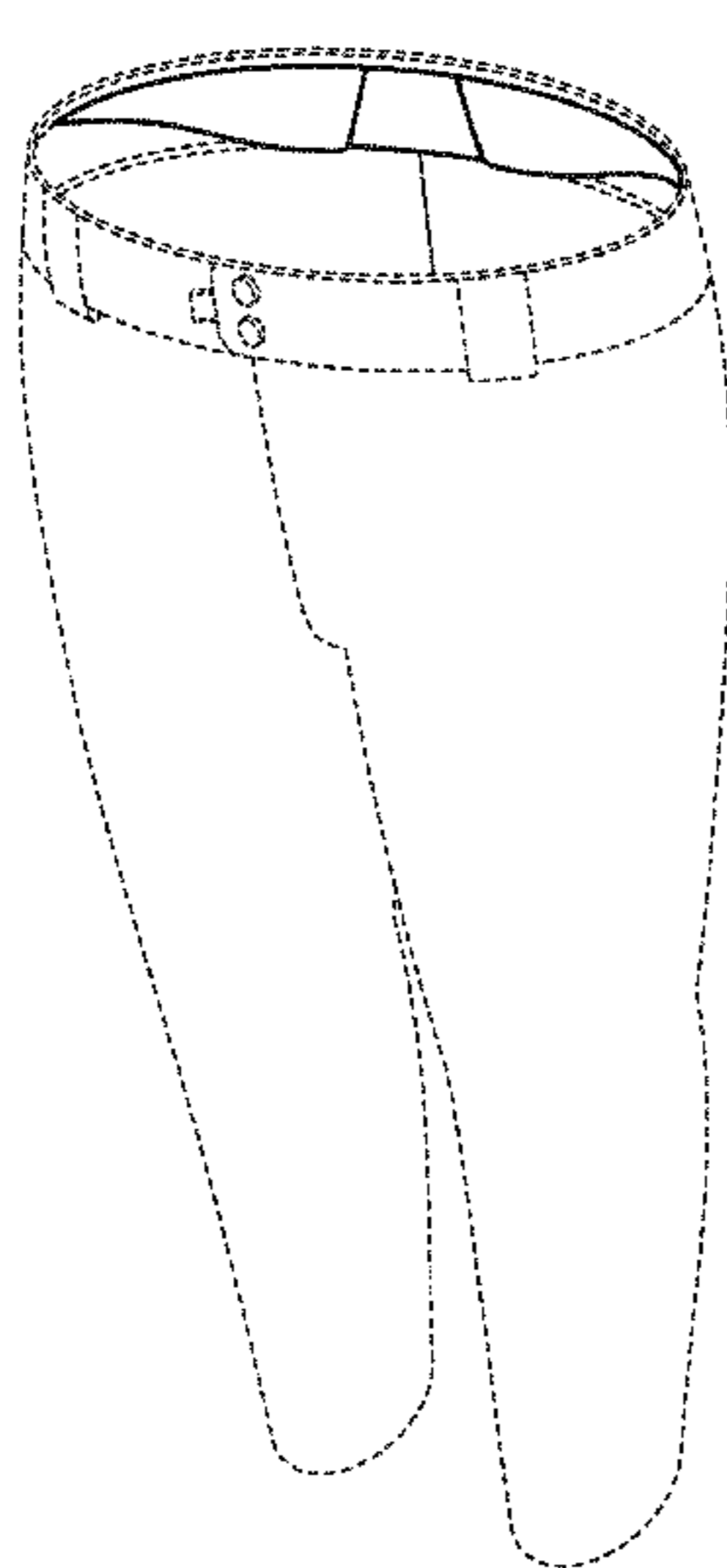
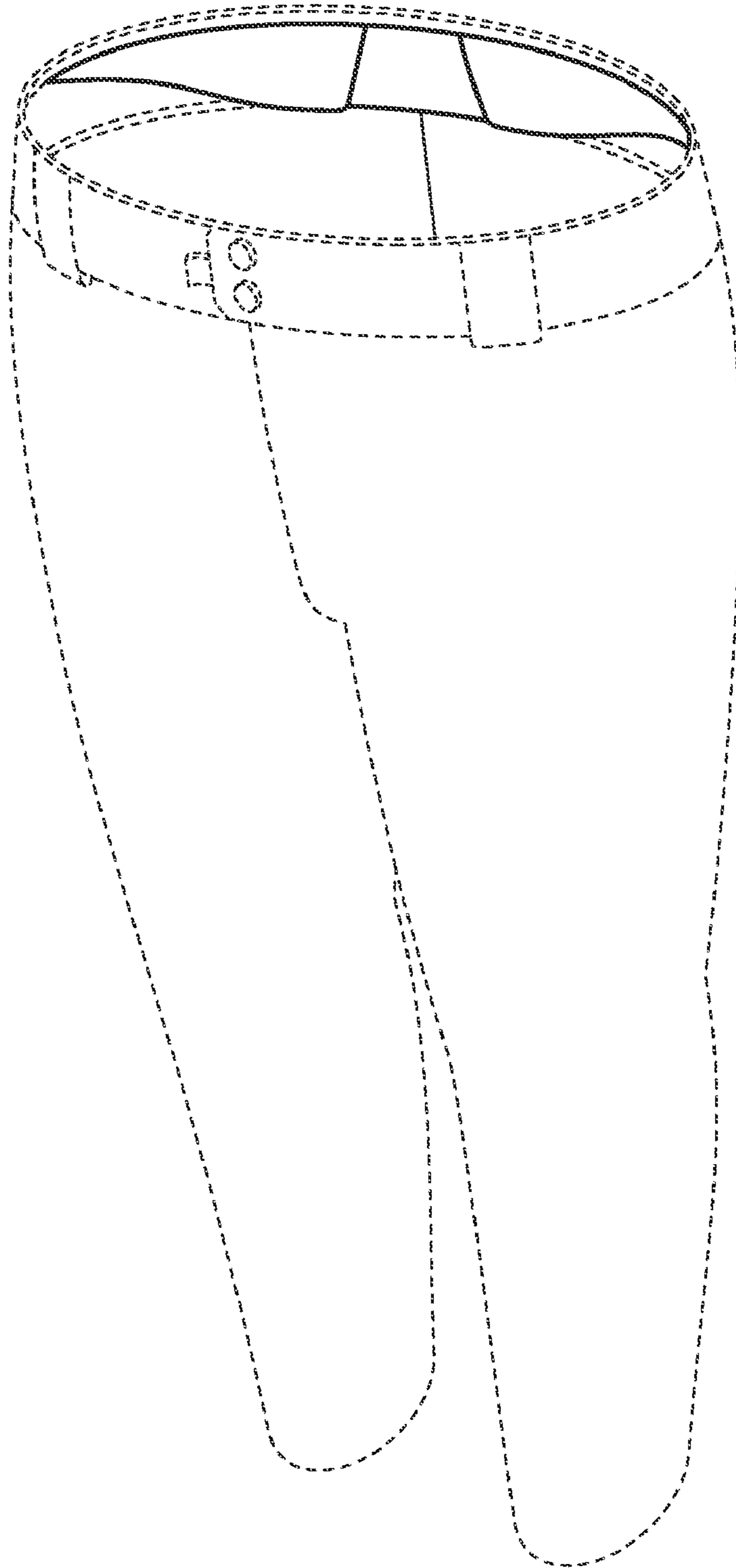

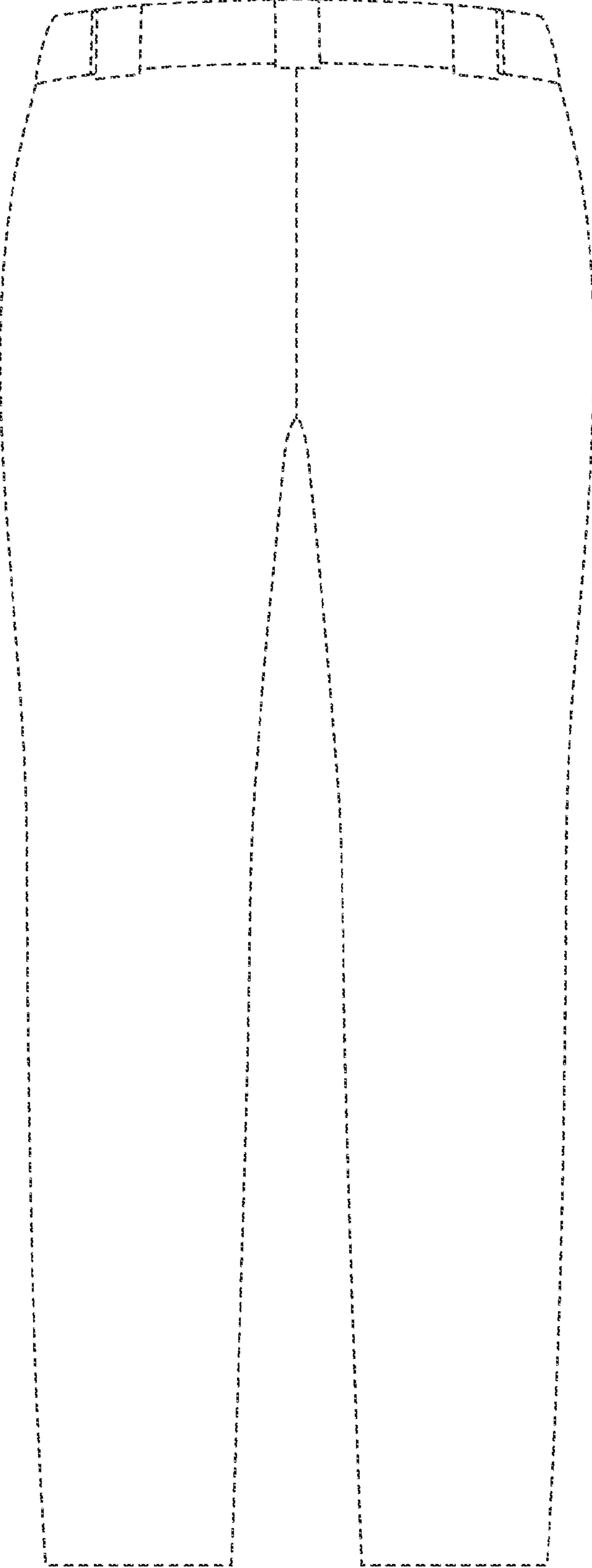

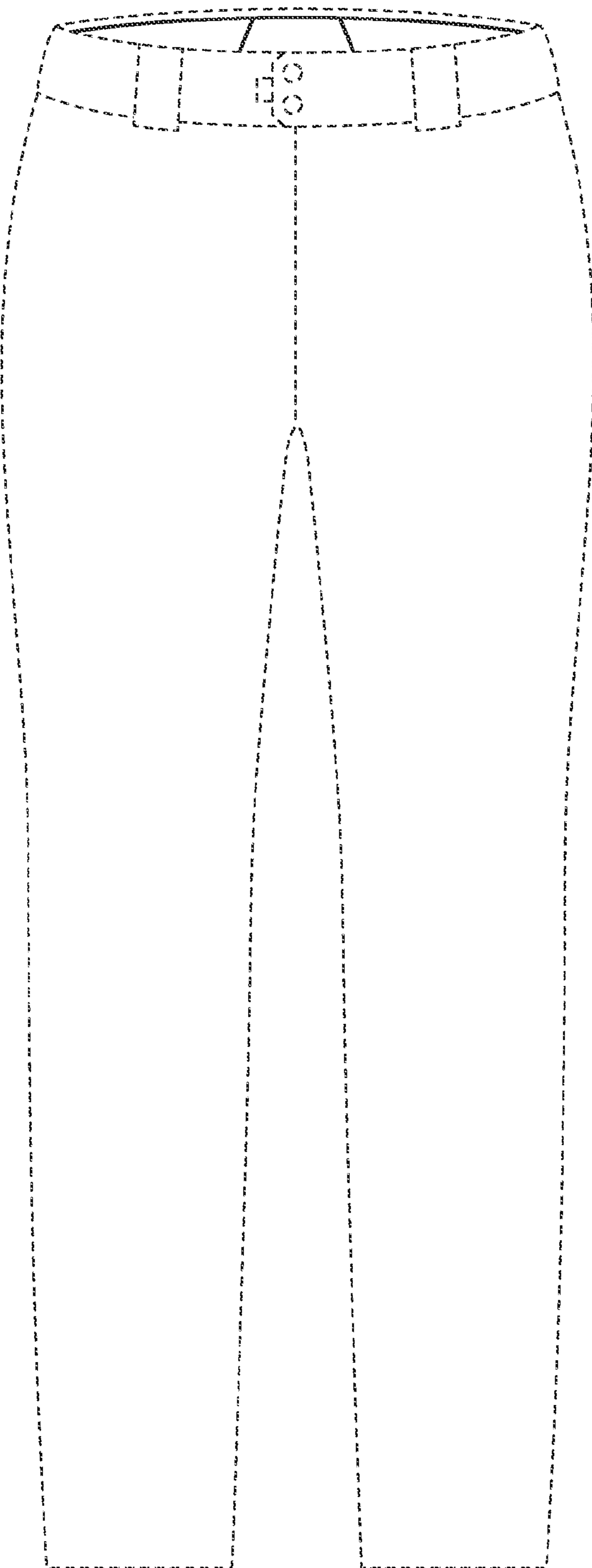

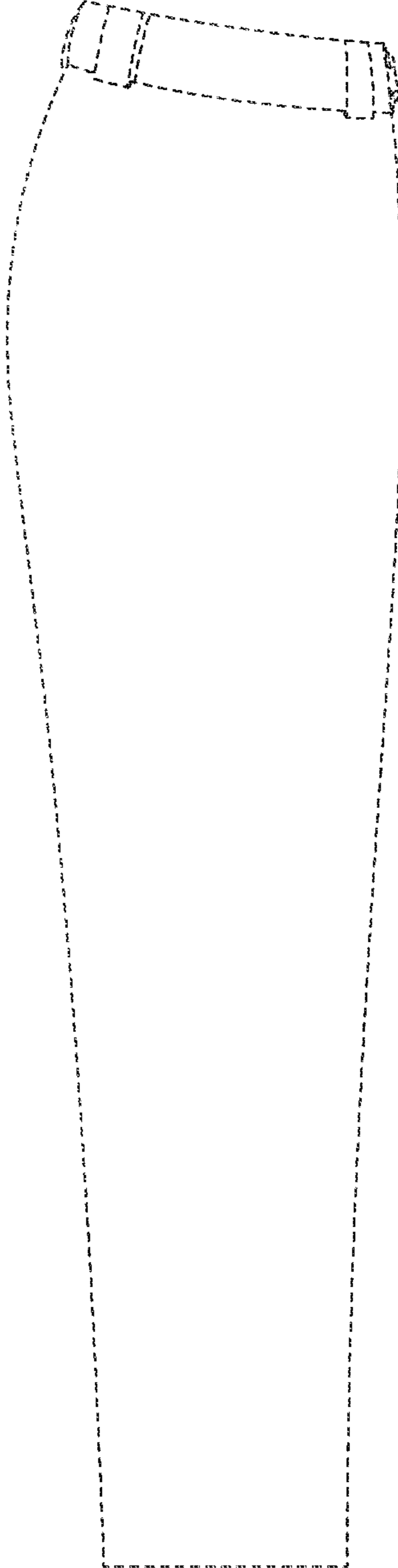

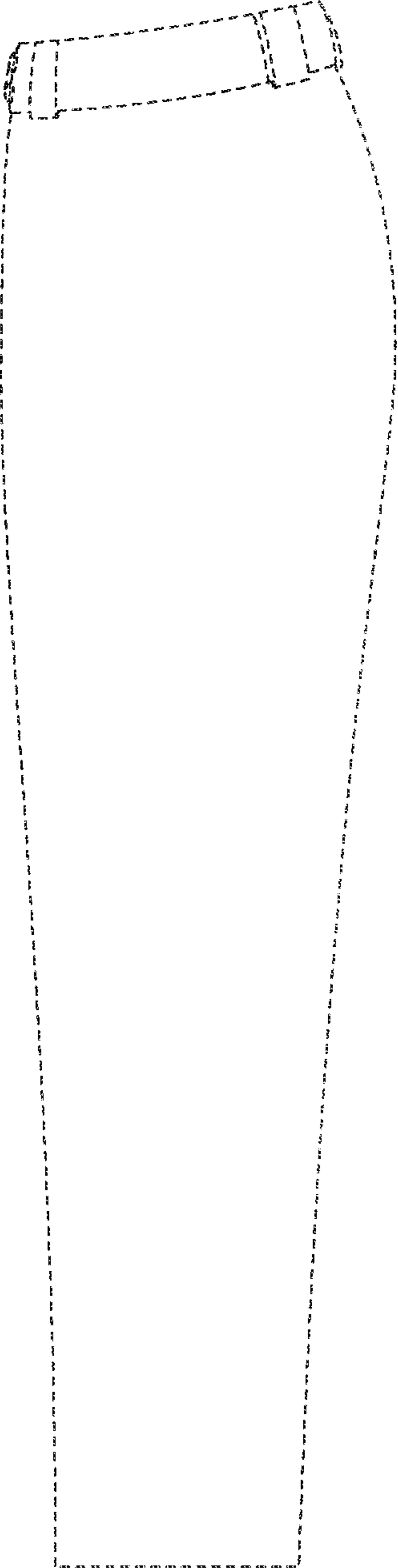
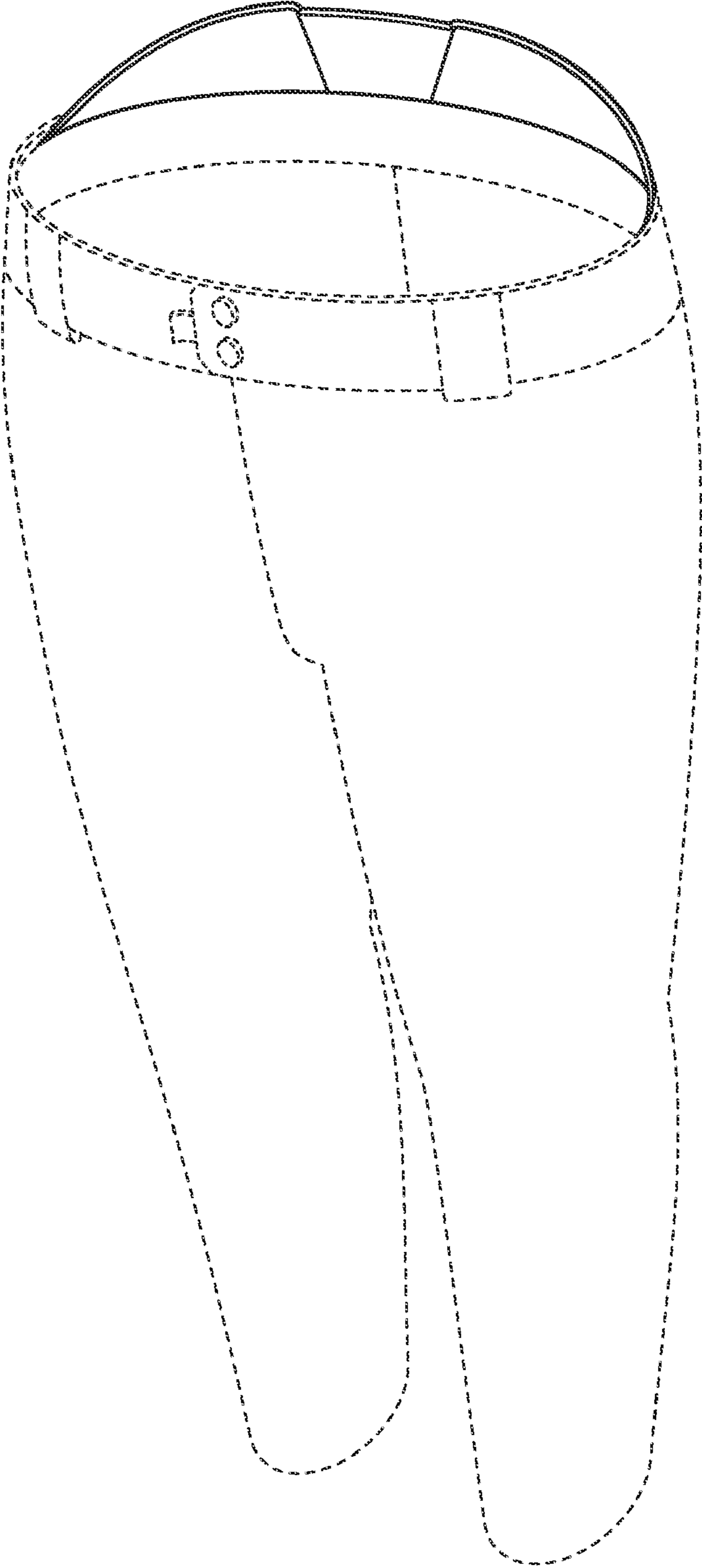

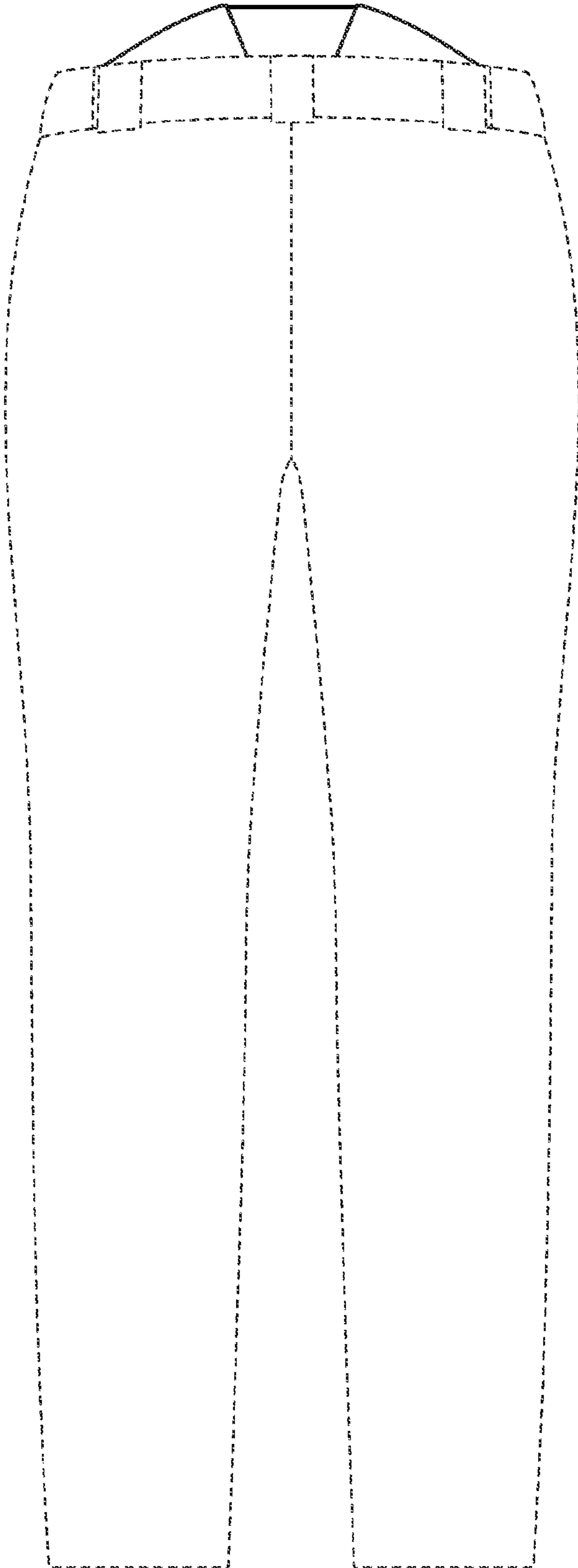

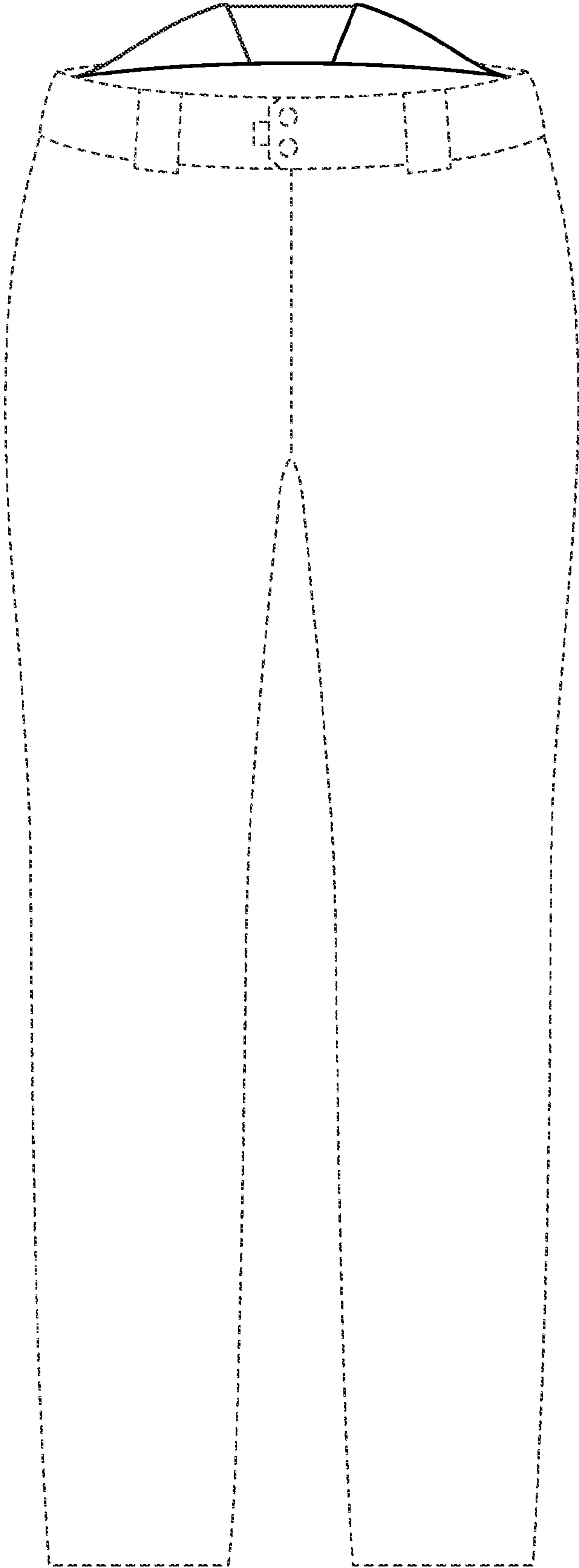

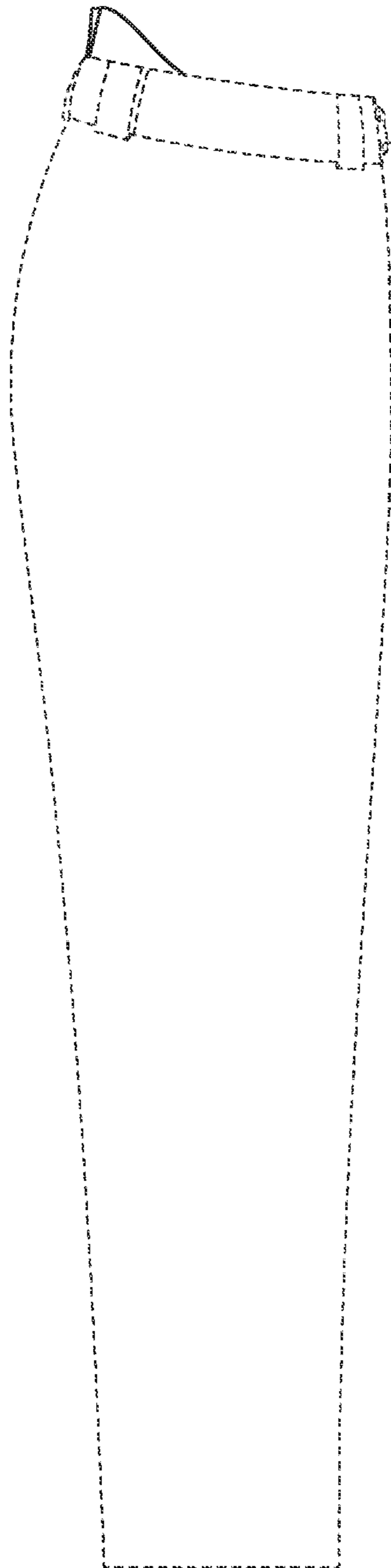

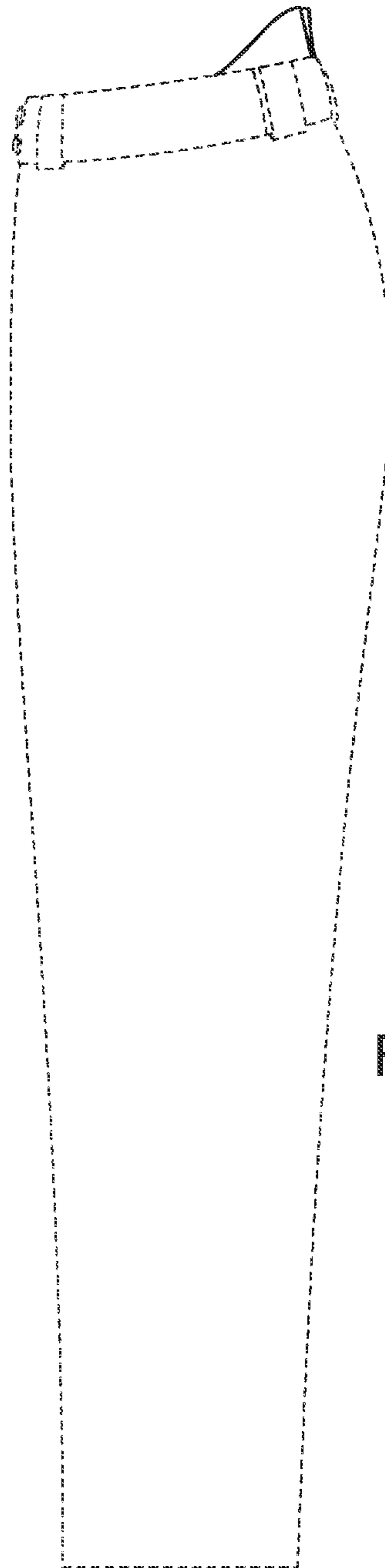

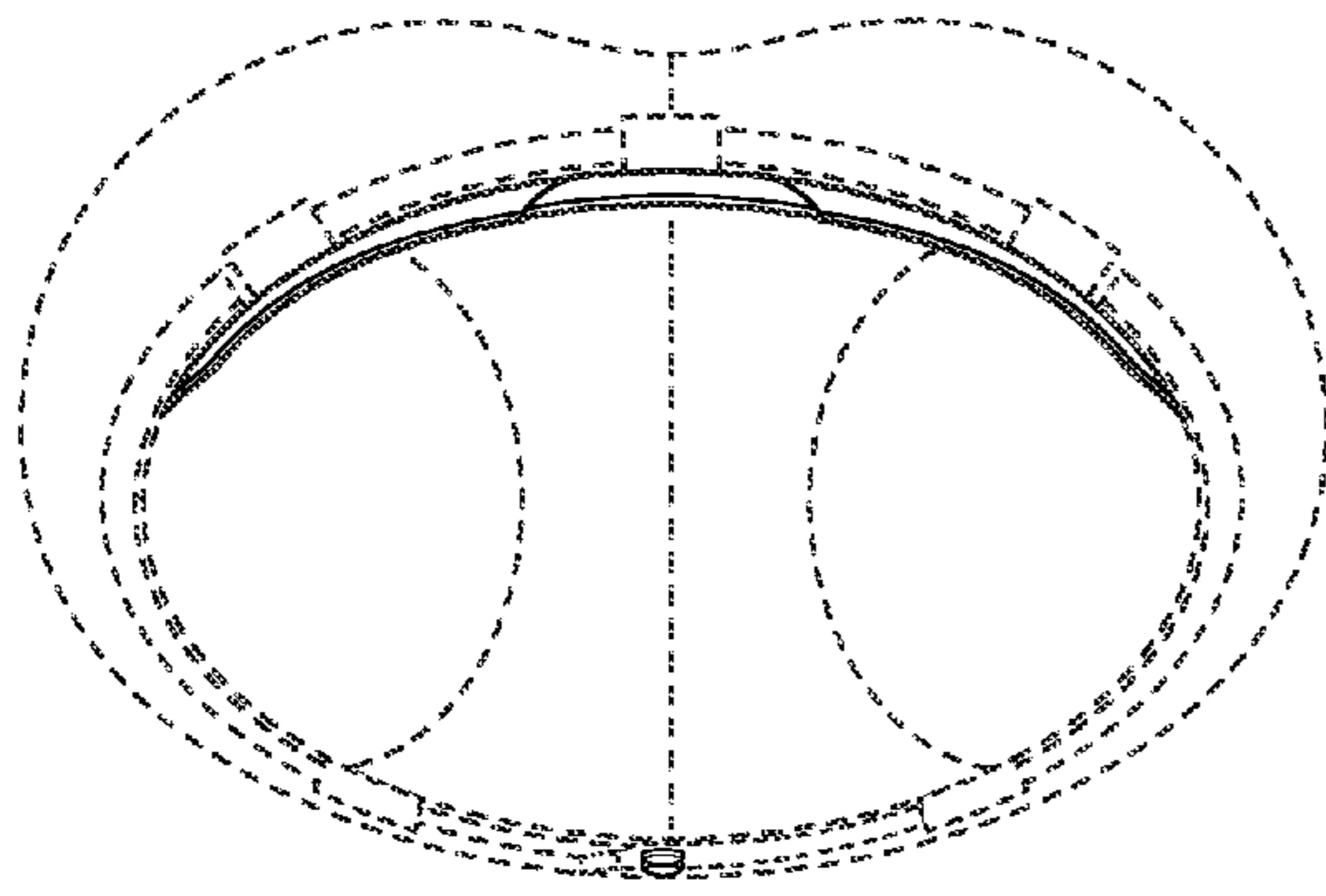

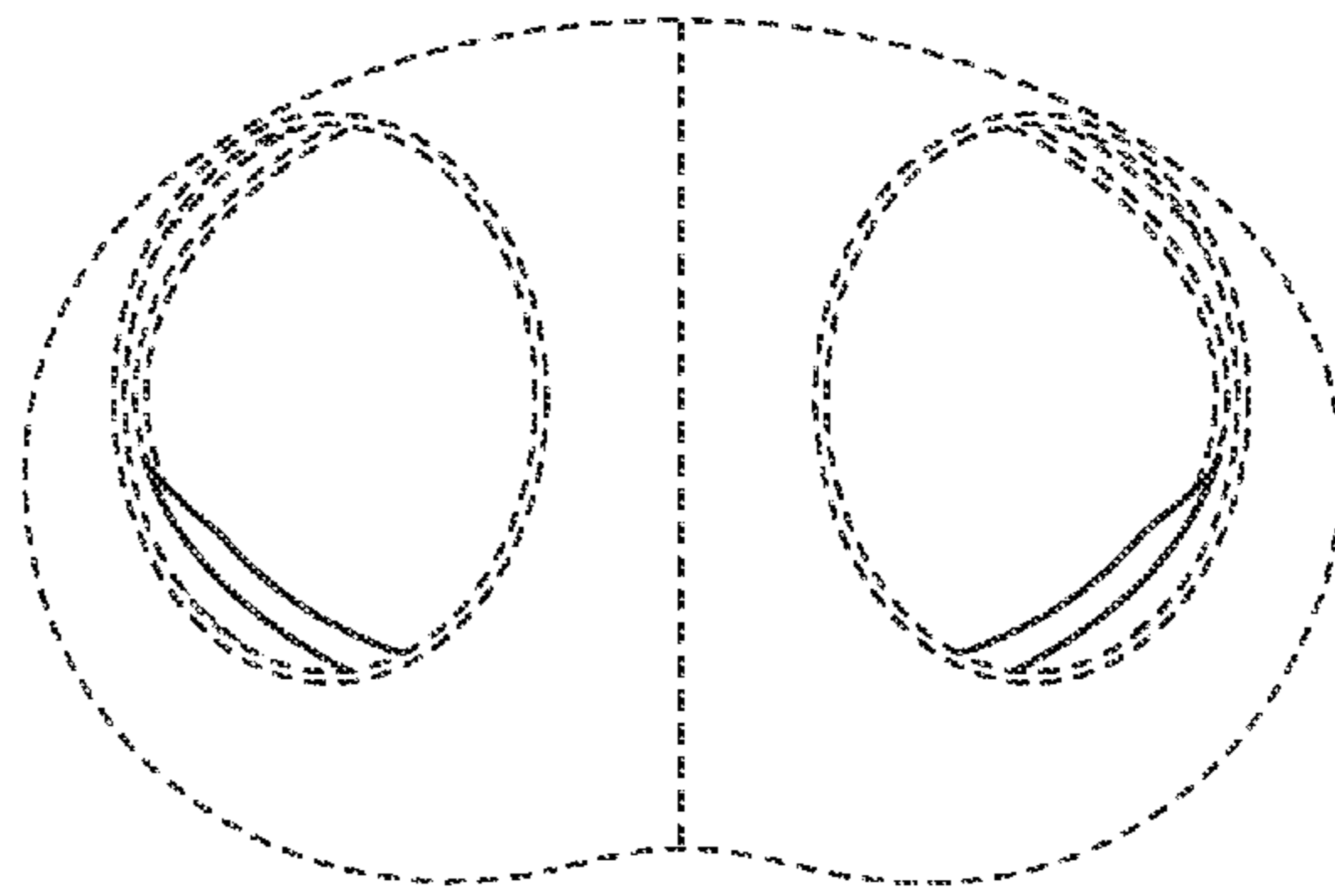

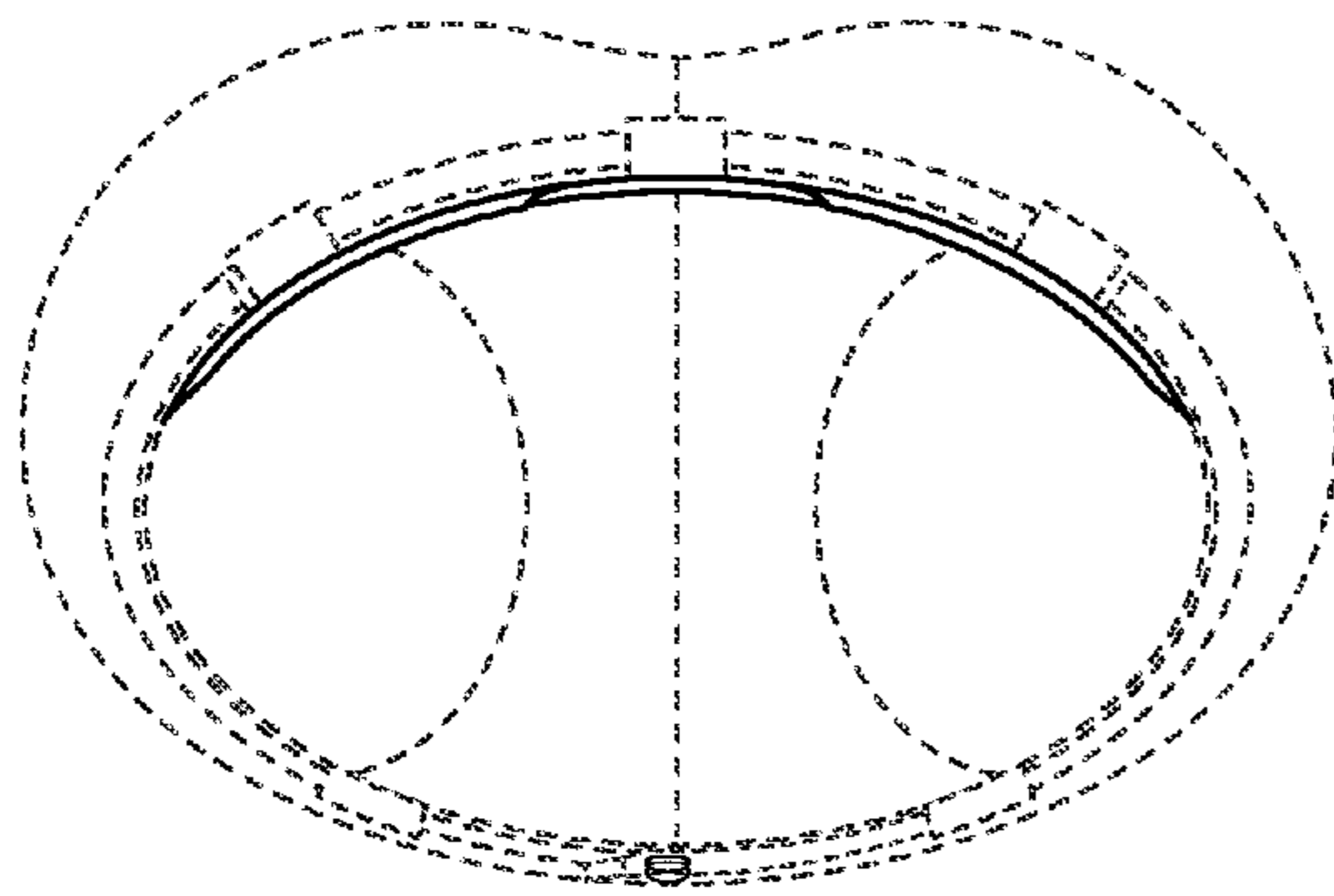

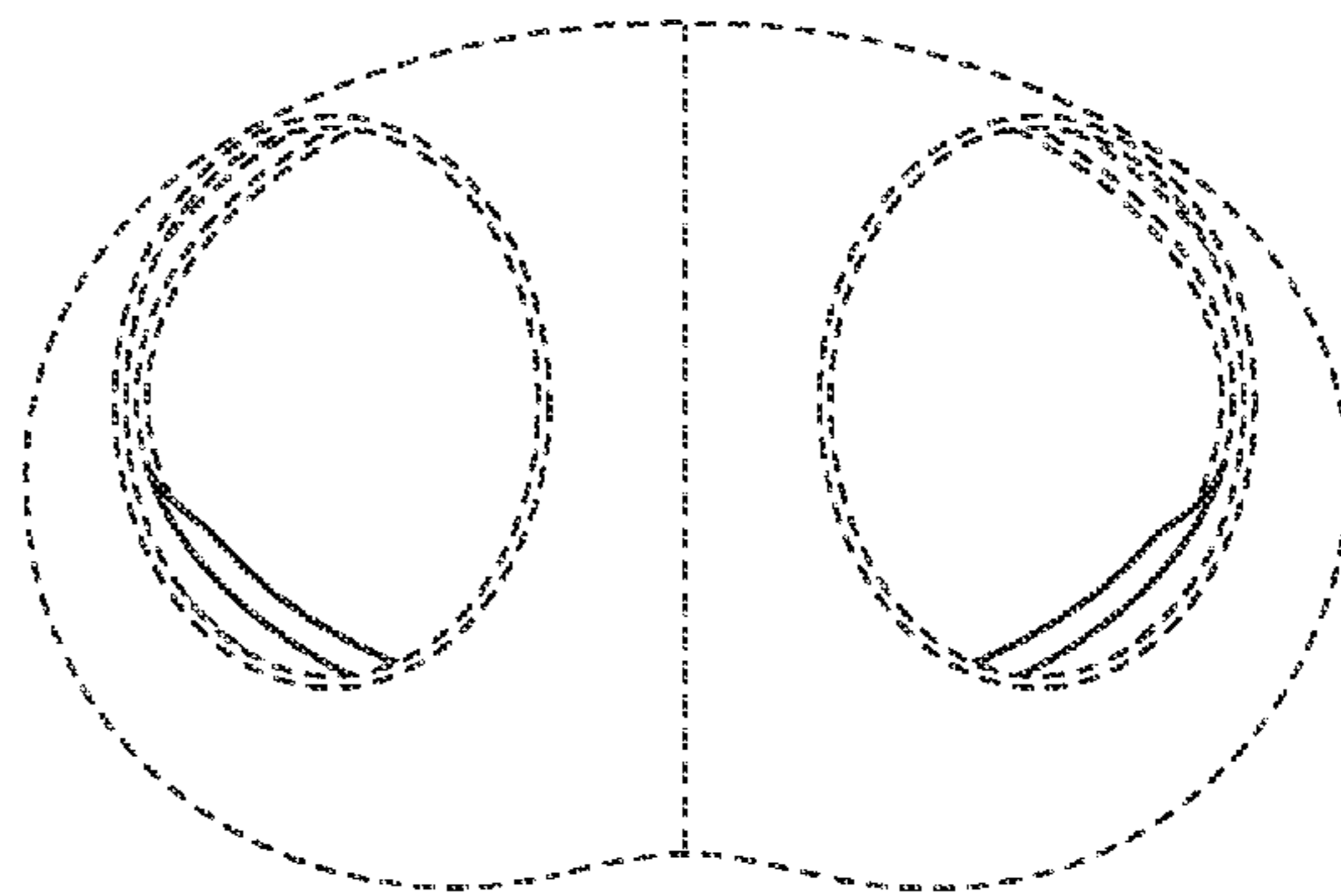
