FIG. 3 is a rear elevational view of the hooded apparel of FIG. 1.

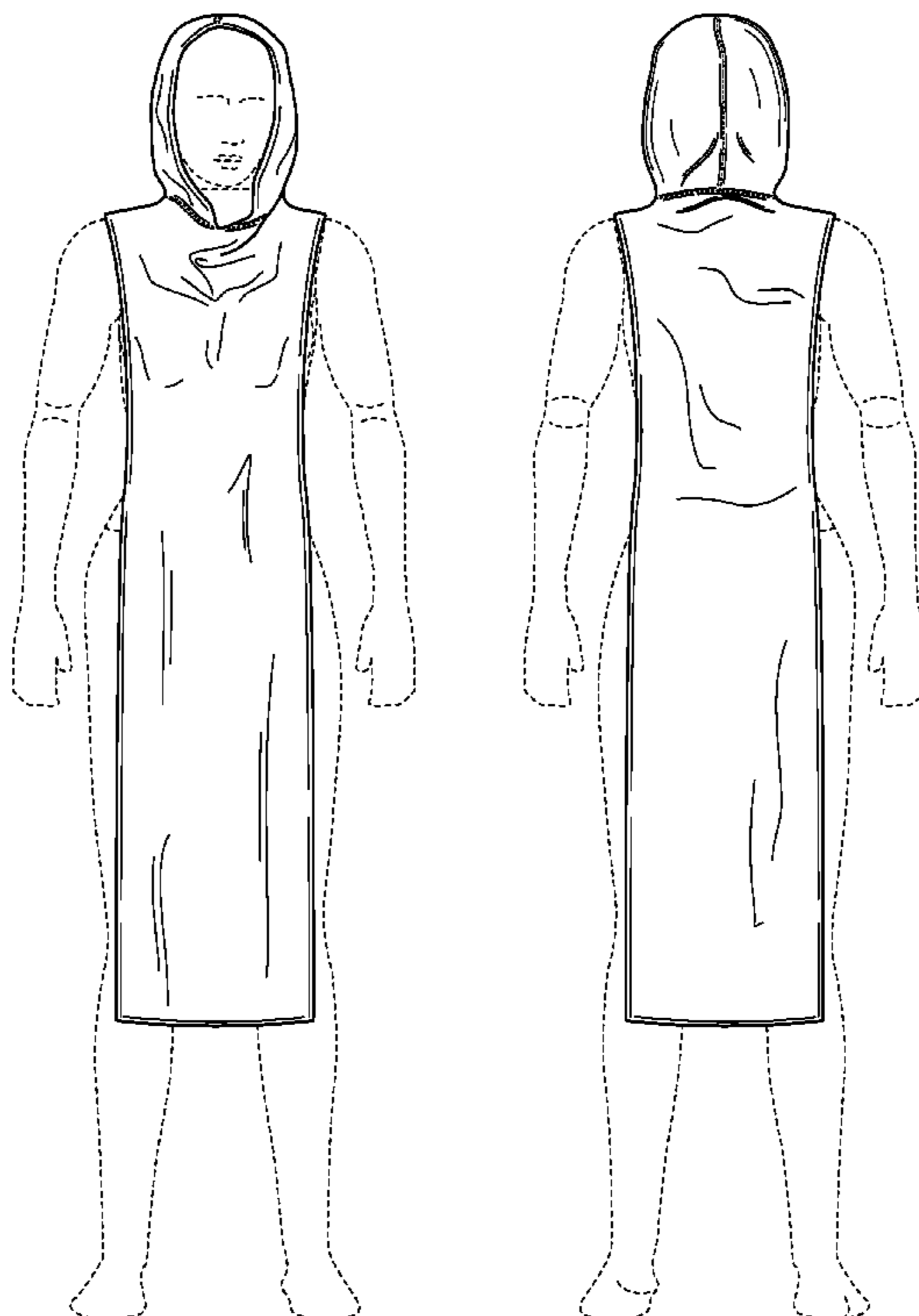
FIG. 4 is a left elevational view of the hooded apparel of FIG. 1.

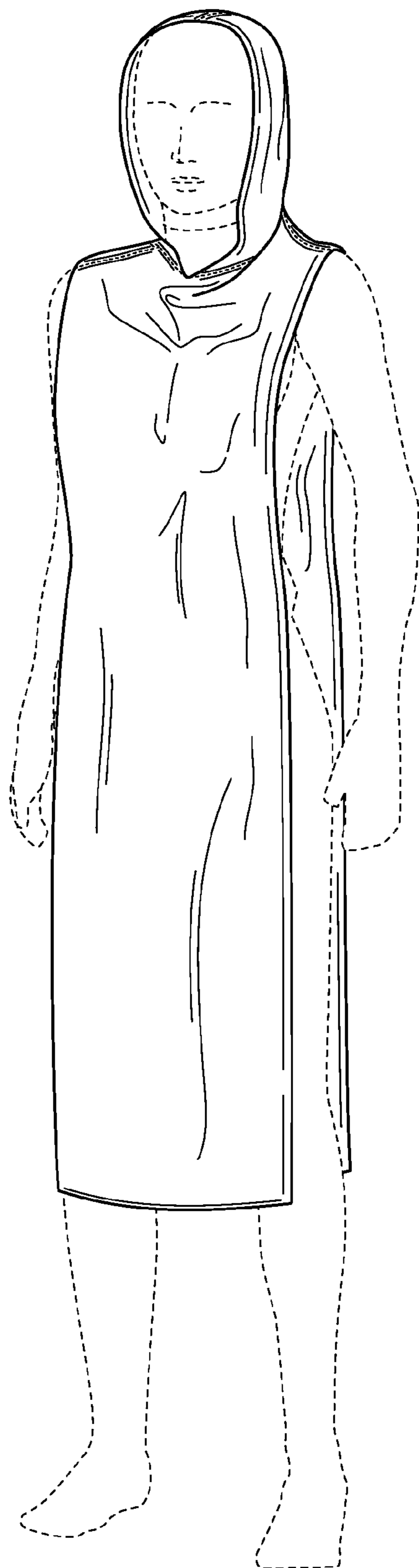

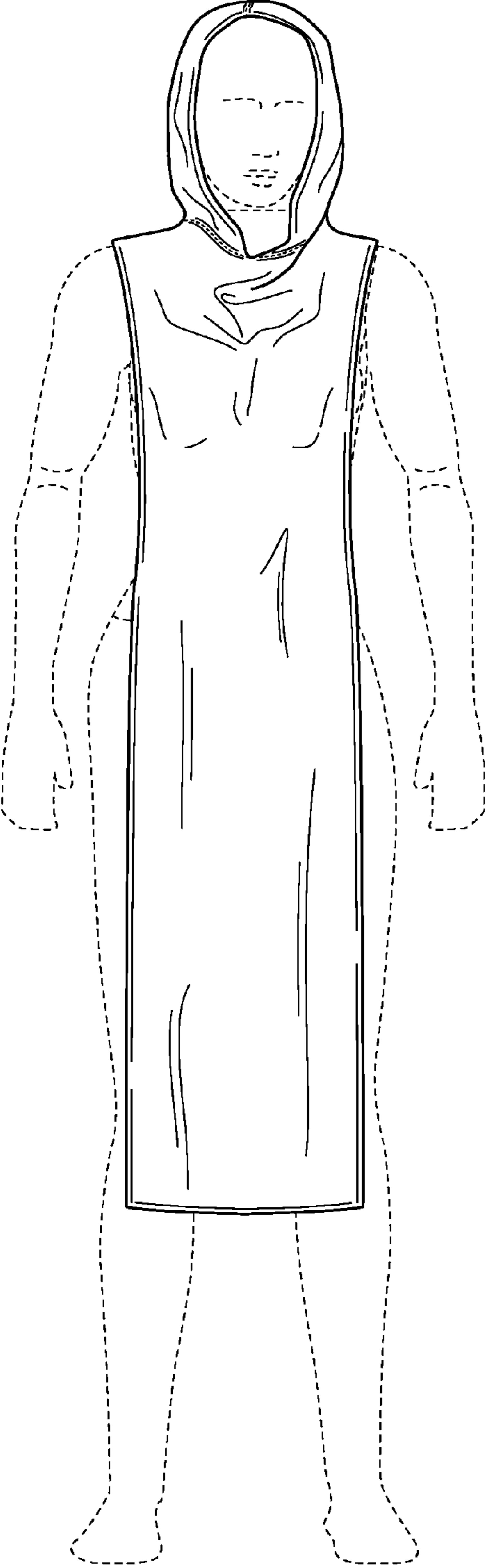

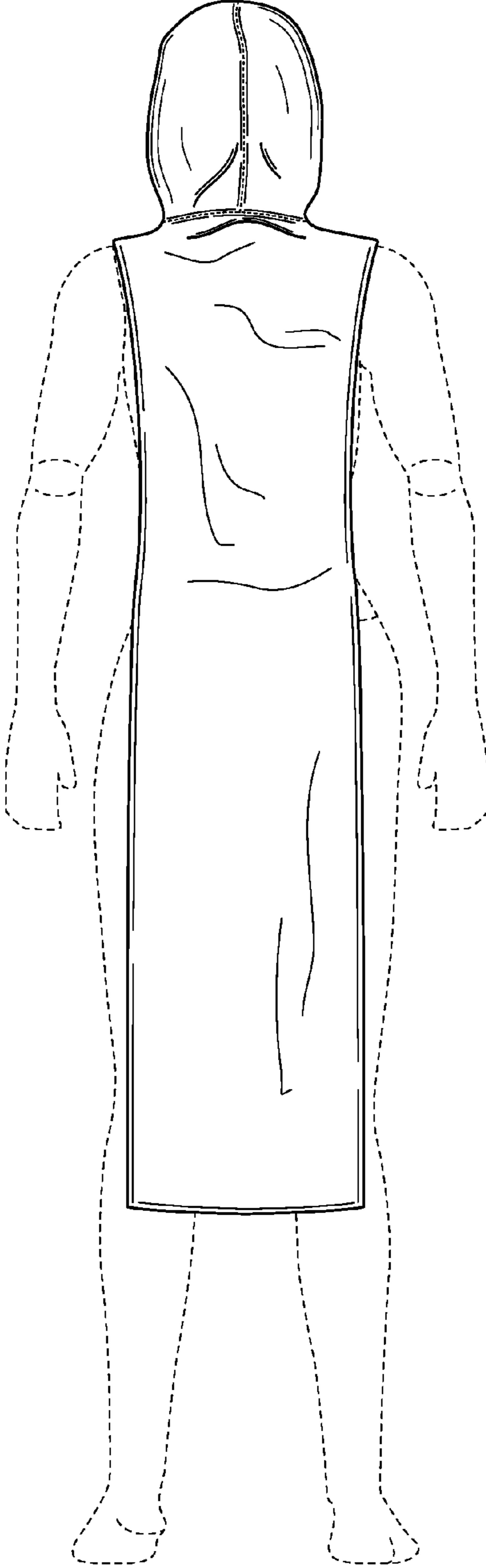

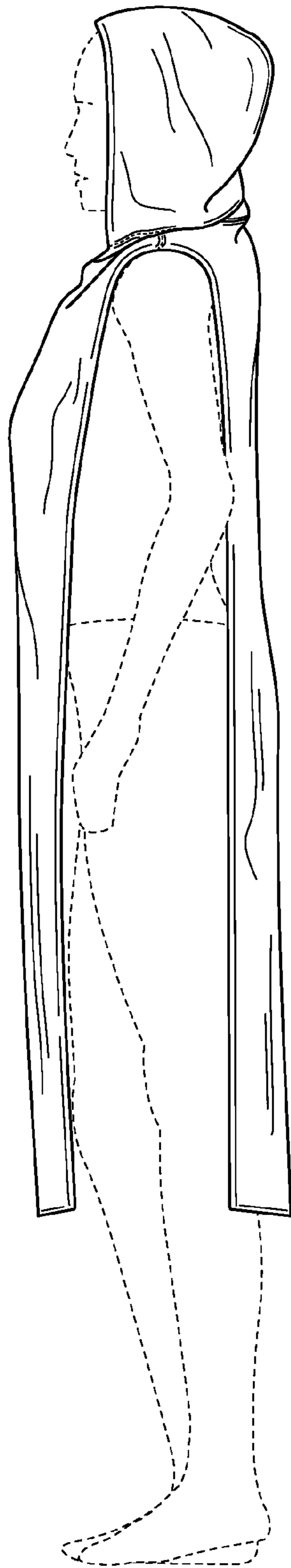

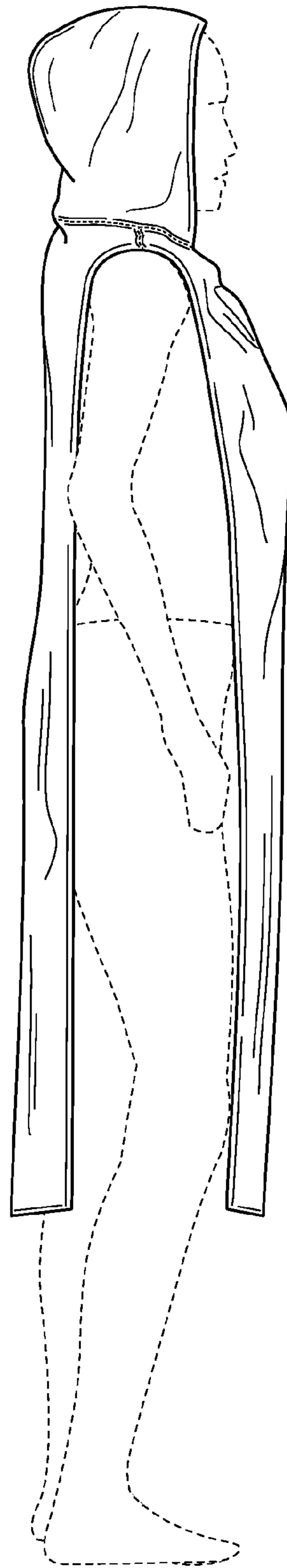

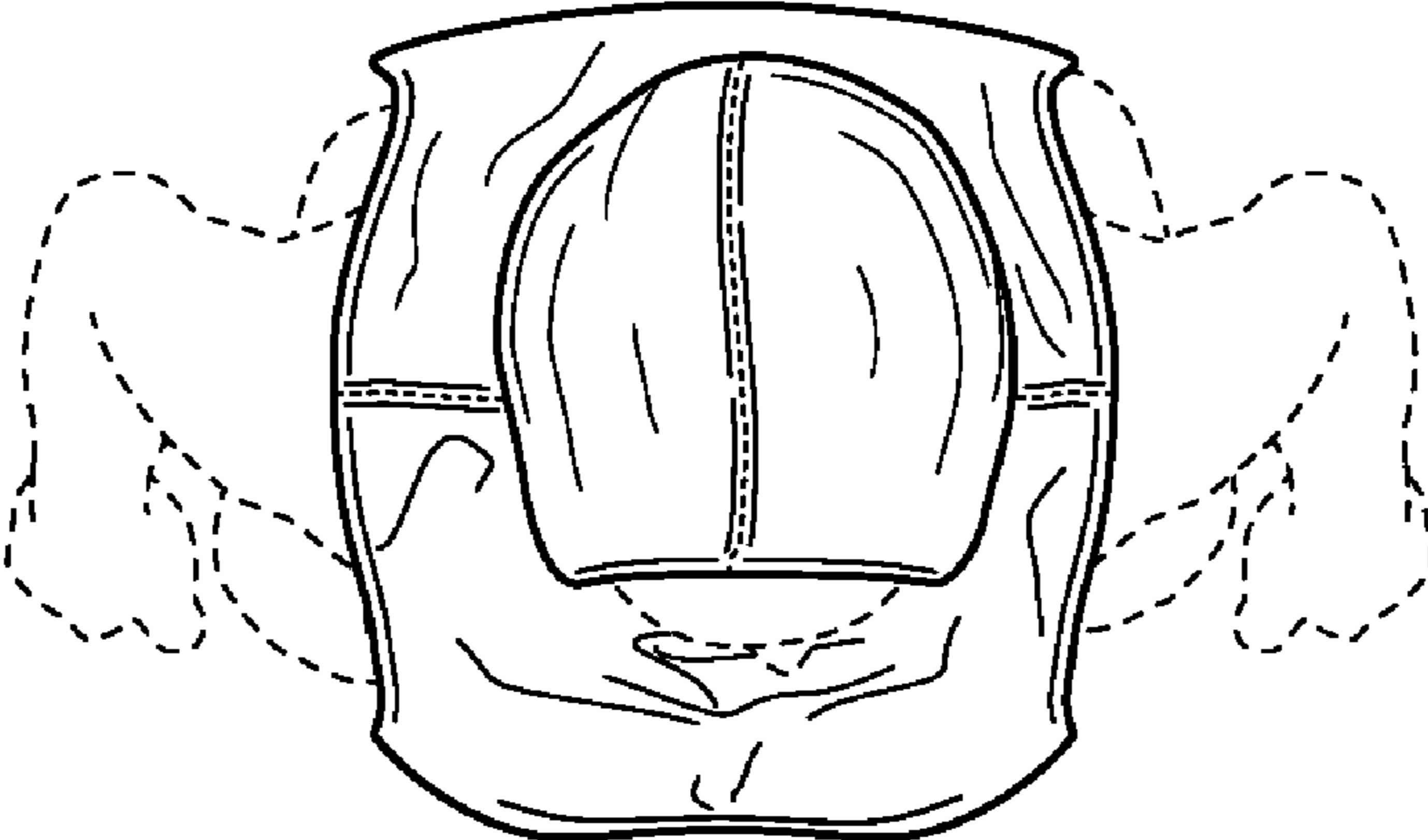

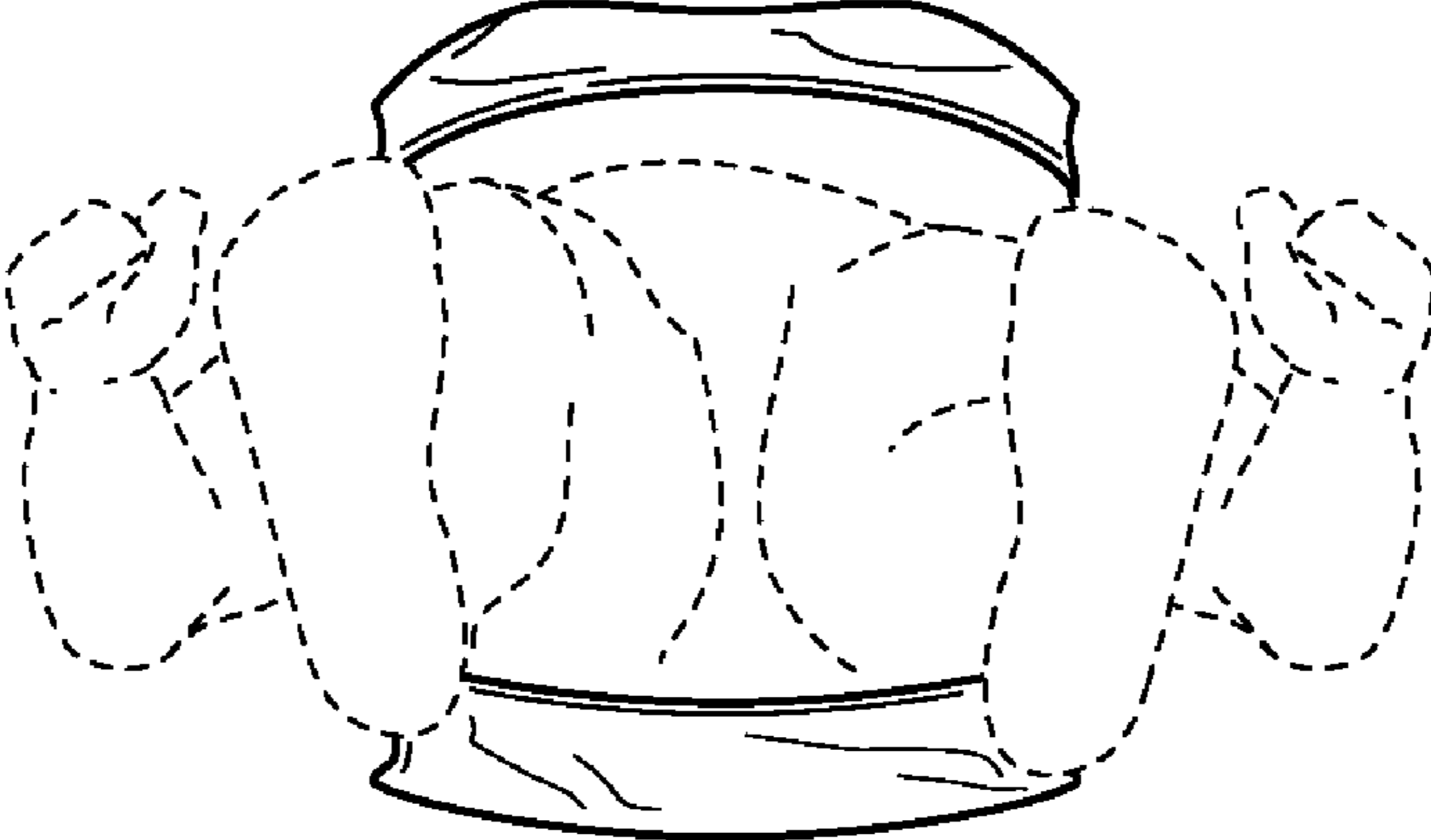
