DESCRIPTION

FIG. 1 is a perspective view of the front, right and bottom of a door handle for automobile showing my new design;

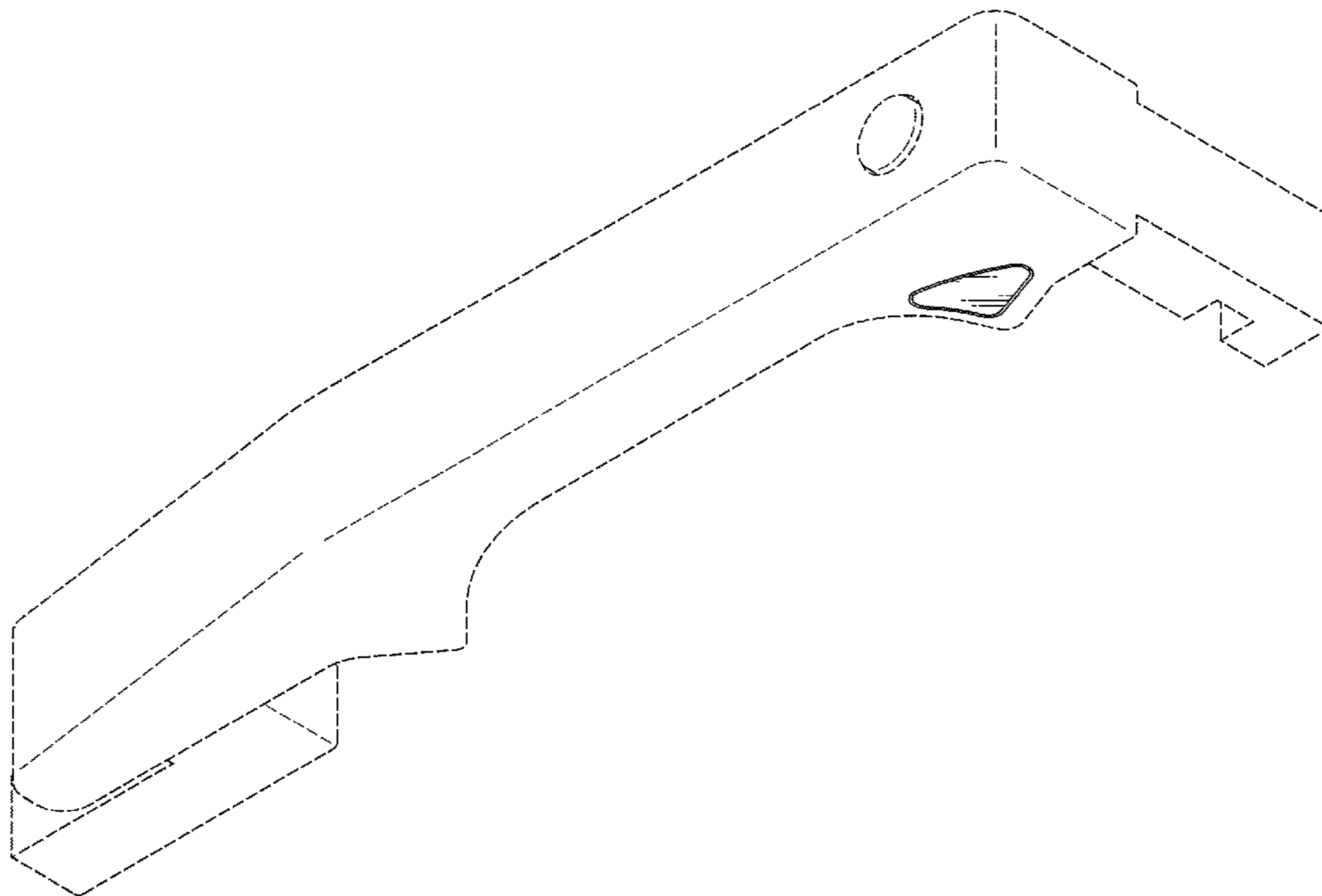

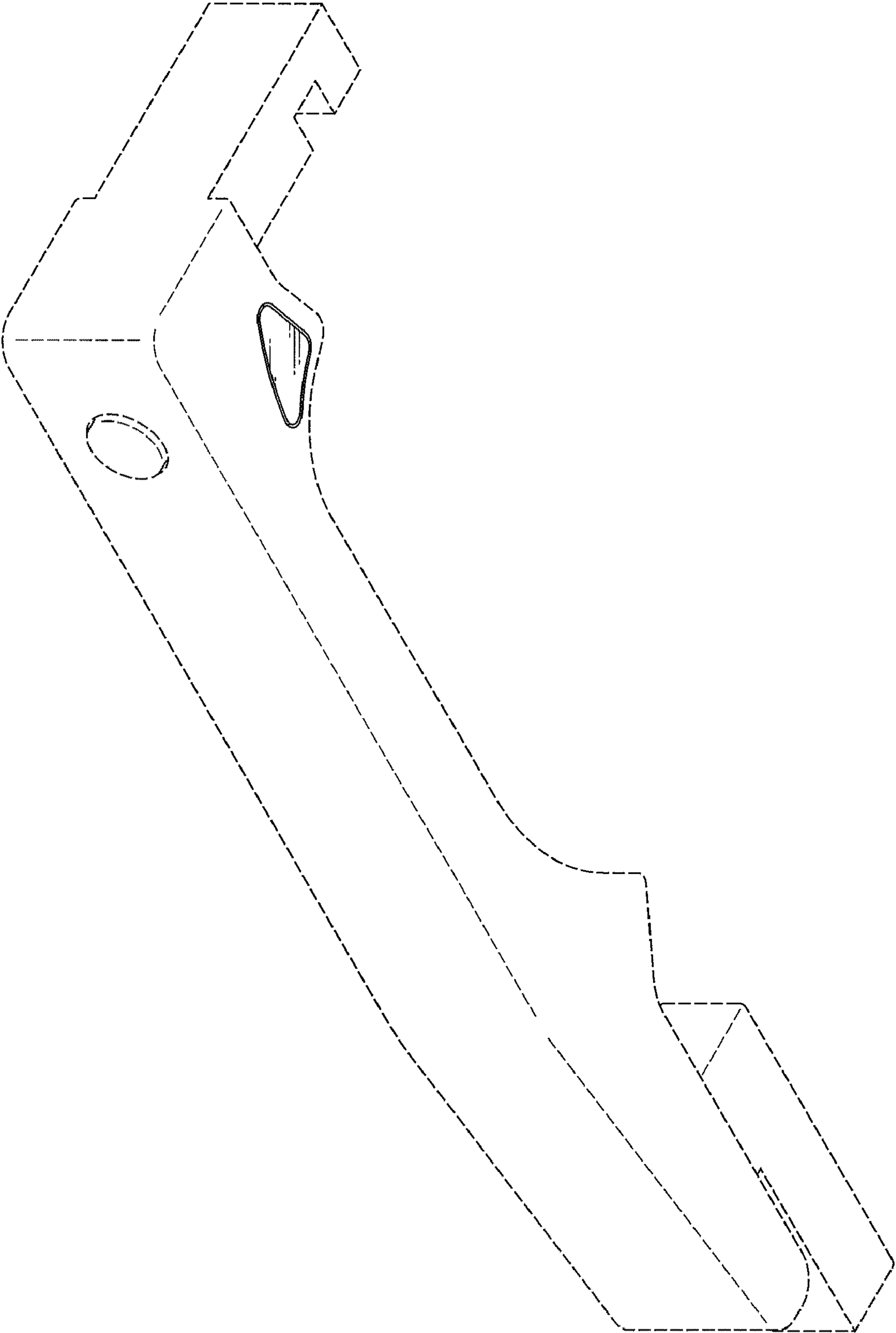

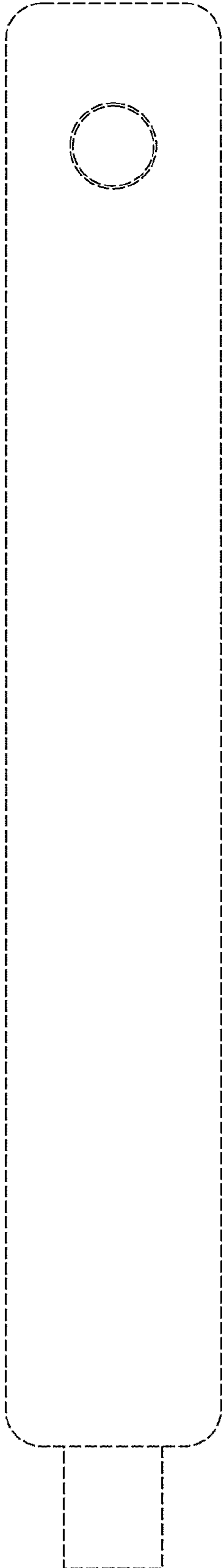

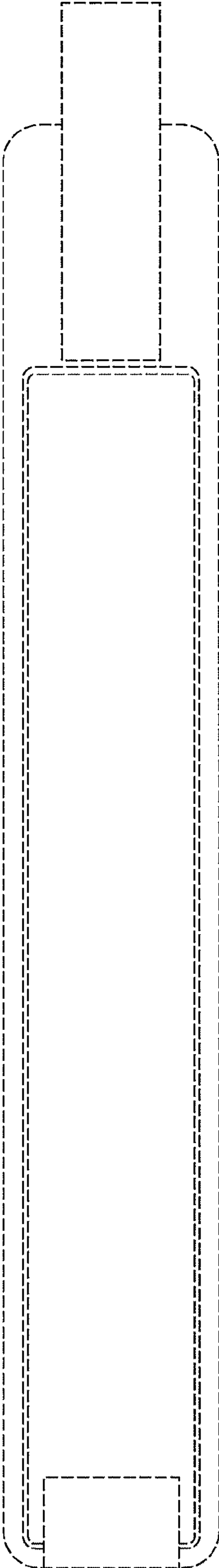

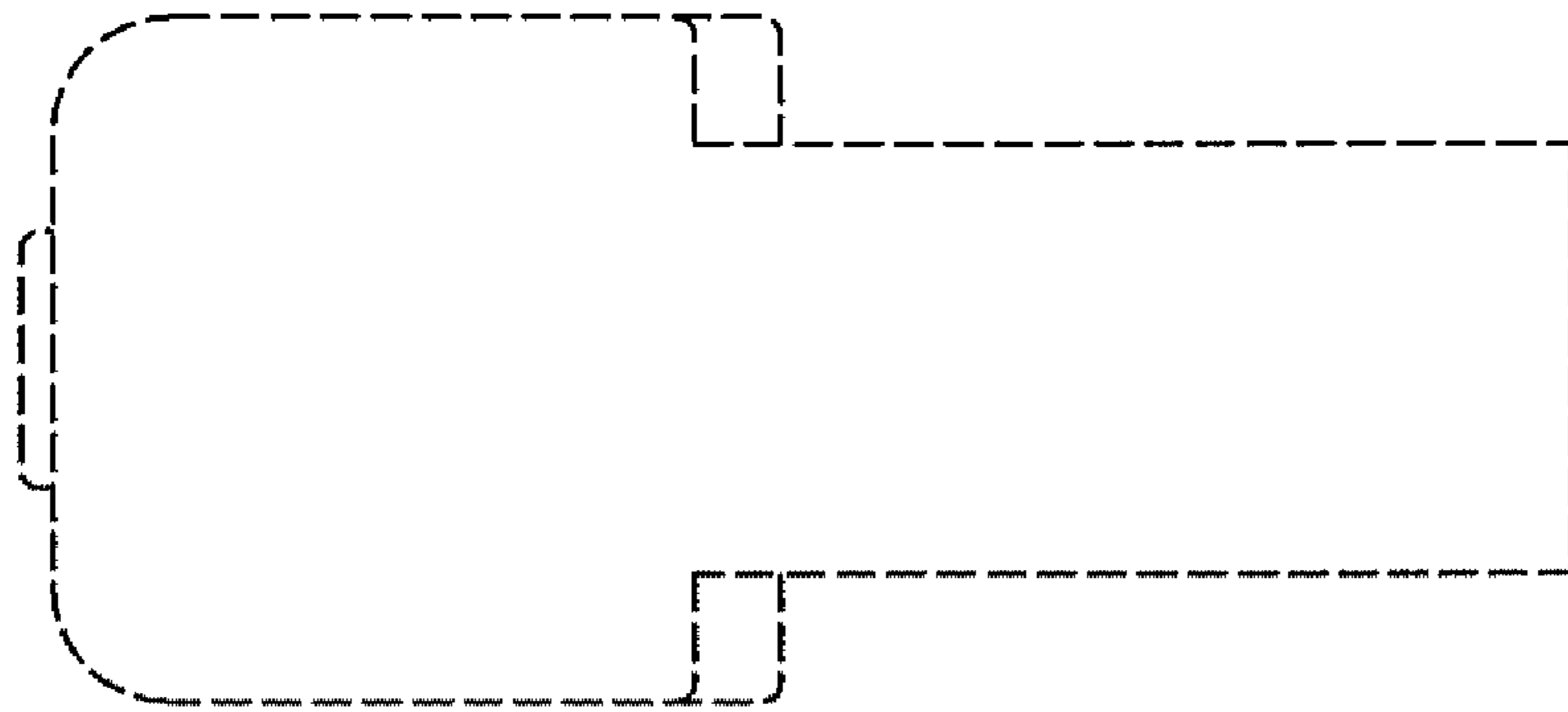

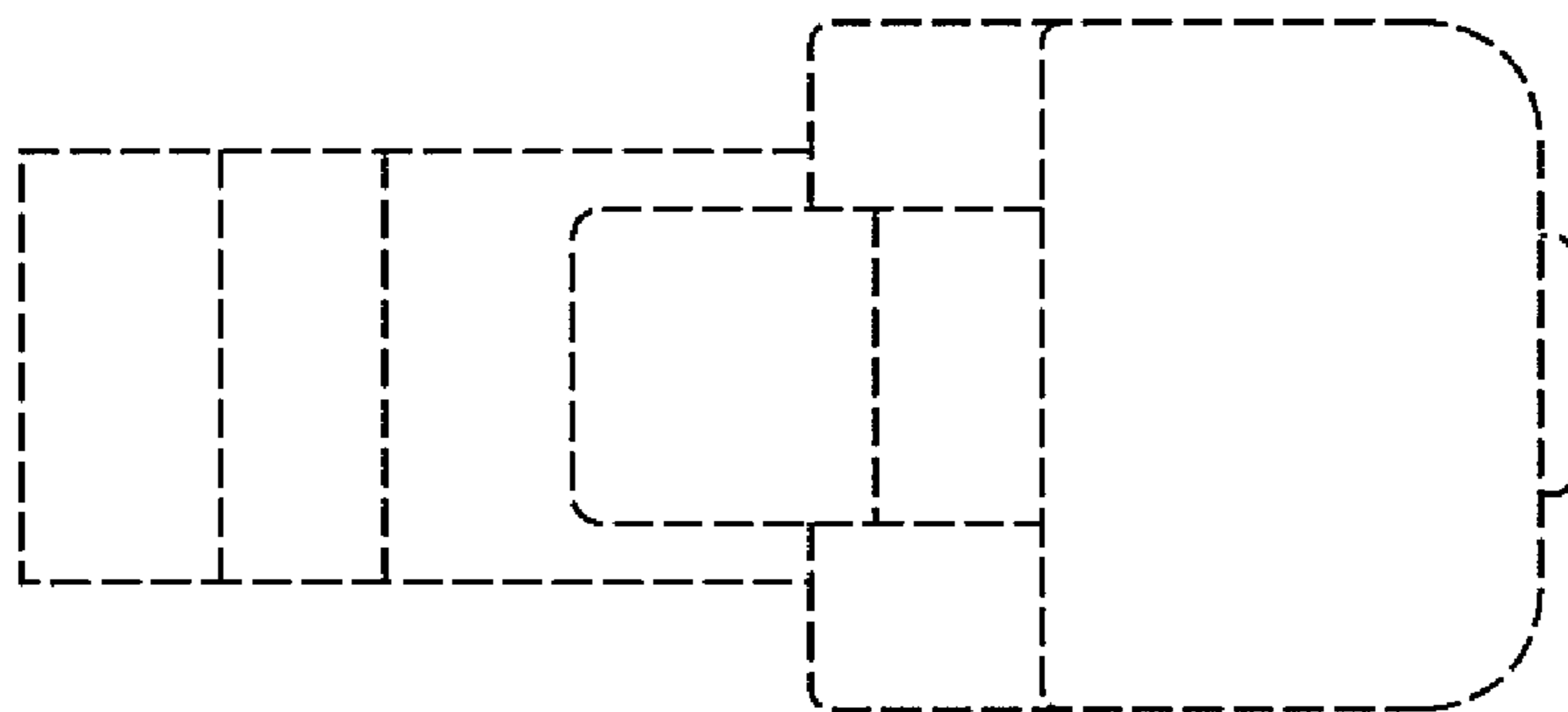

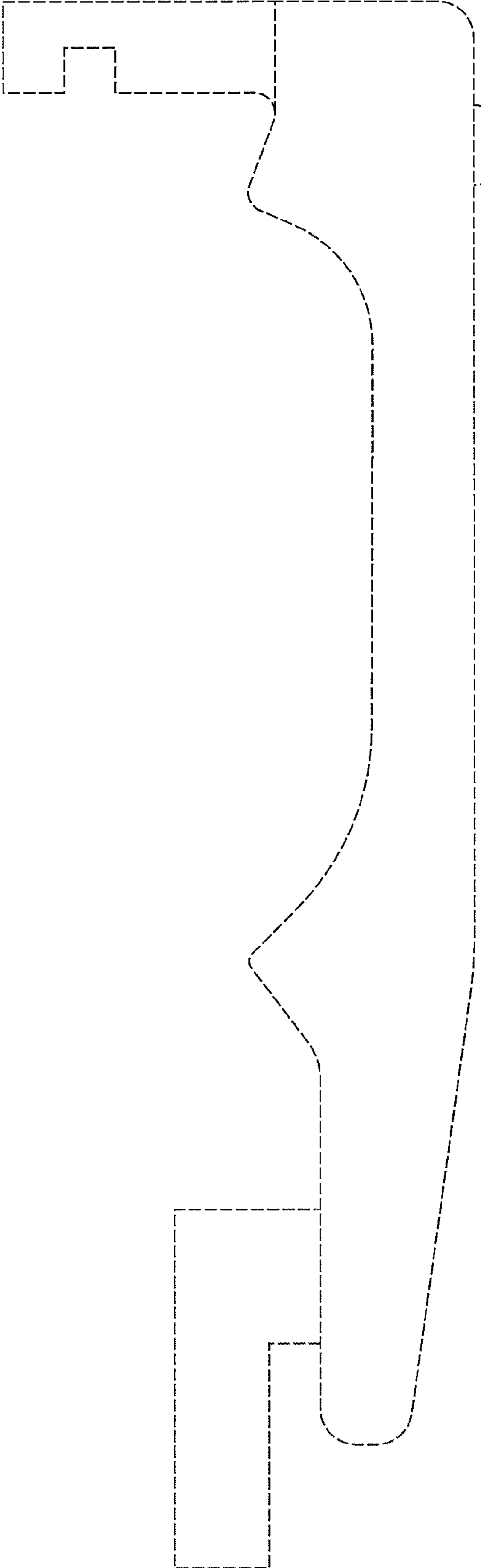

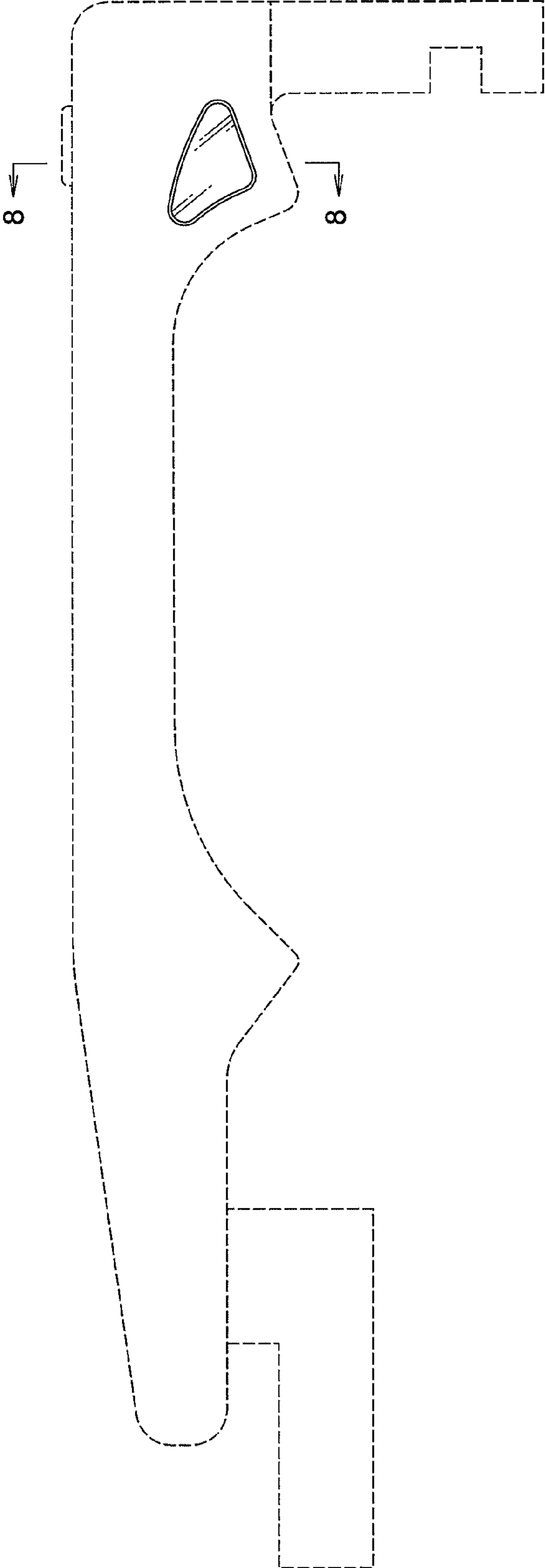
