(57) **CLAIM**

The ornamental design for disposable diaper product package or wipes product package with surface indicia, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a first embodiment of product package for disposable diapers or wipes showing our new design;

FIG. 2 is a front view of the product package for disposable diapers or wipes as shown in FIG. 1;

FIG. 3 is a top view of the product package for disposable diapers or wipes as shown in FIG. 1;

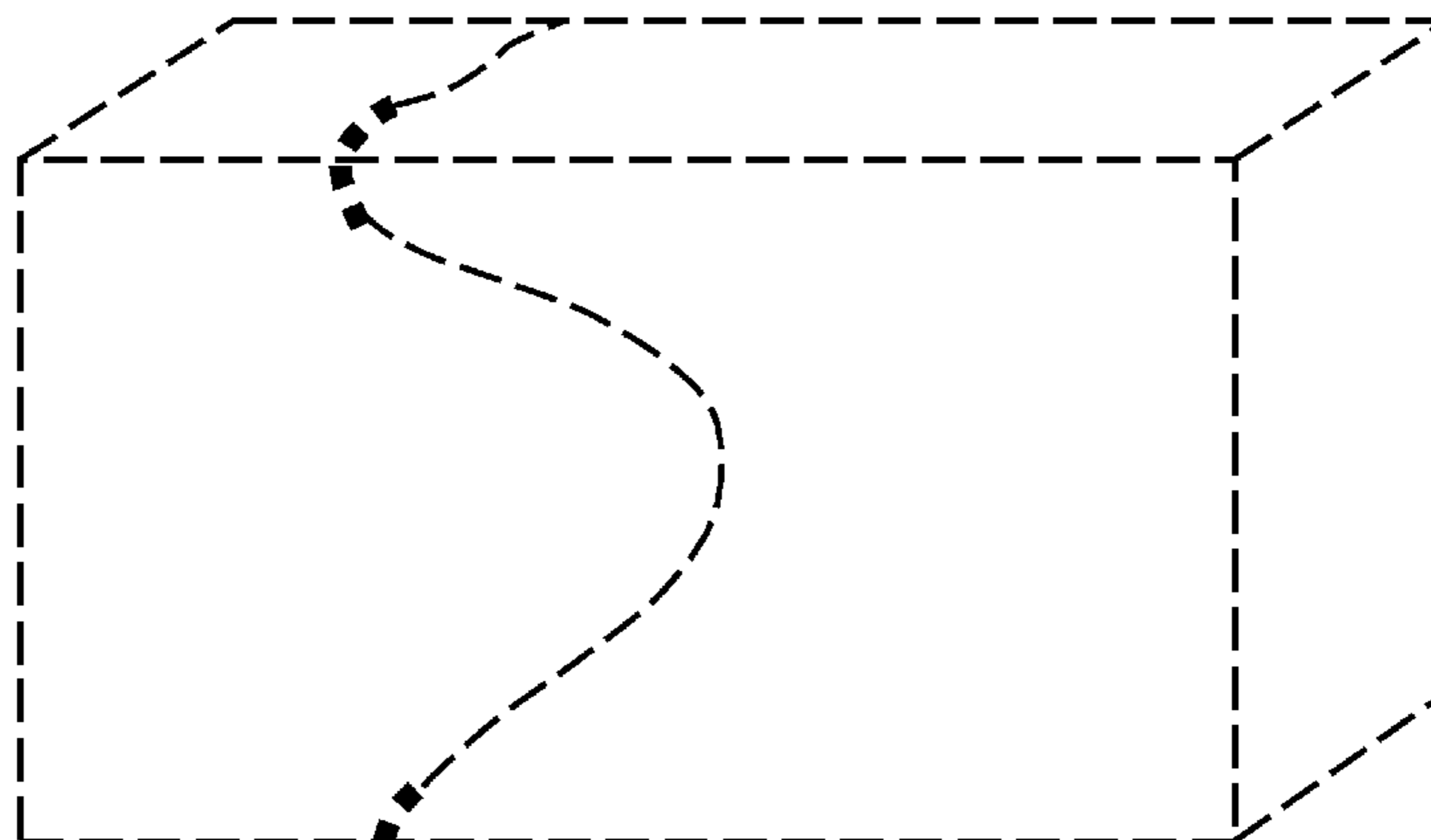


FIG. 4 is a perspective view of a second embodiment of product package for disposable diapers or wipes showing our new design;

FIG. 13 is a perspective view of a fifth embodiment of product package for disposable diapers or wipes showing our new design;

FIG. 14 is a front view of the product package for disposable diapers or wipes as shown in FIG. 13;

FIG. 15 is a front view of a sixth embodiment of the product package for disposable diapers or wipes as shown in FIG. 13.

FIG. 16 is a perspective view of a seventh embodiment of our design comprising solid regions of blue color having a CIE $L^*a^*b^*$ value of about 77, -20, -35 and a Color Space Volume of less than about 10,000.

FIG. 17 is a front view of the design as shown in FIG. 16; and,

FIG. 18 is a top view of the design as shown in FIG. 16.

The claim is directed solely to the array of solid shaped elements and their spatial relationship on the unclaimed substrate. The solid shaped elements represent color contrast. The broken lines in the drawing show environmental subject matter and form no part of the claimed design.

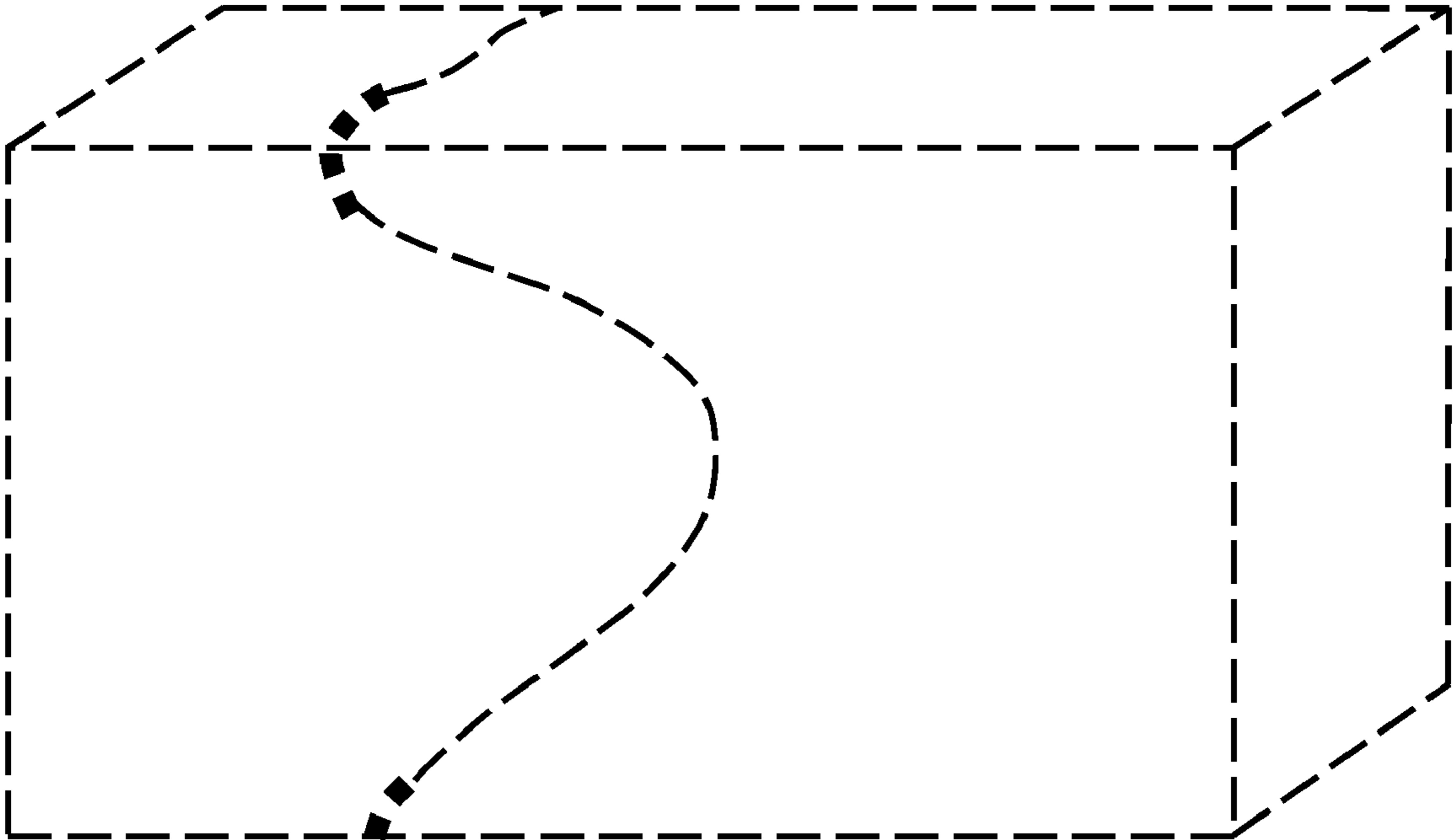

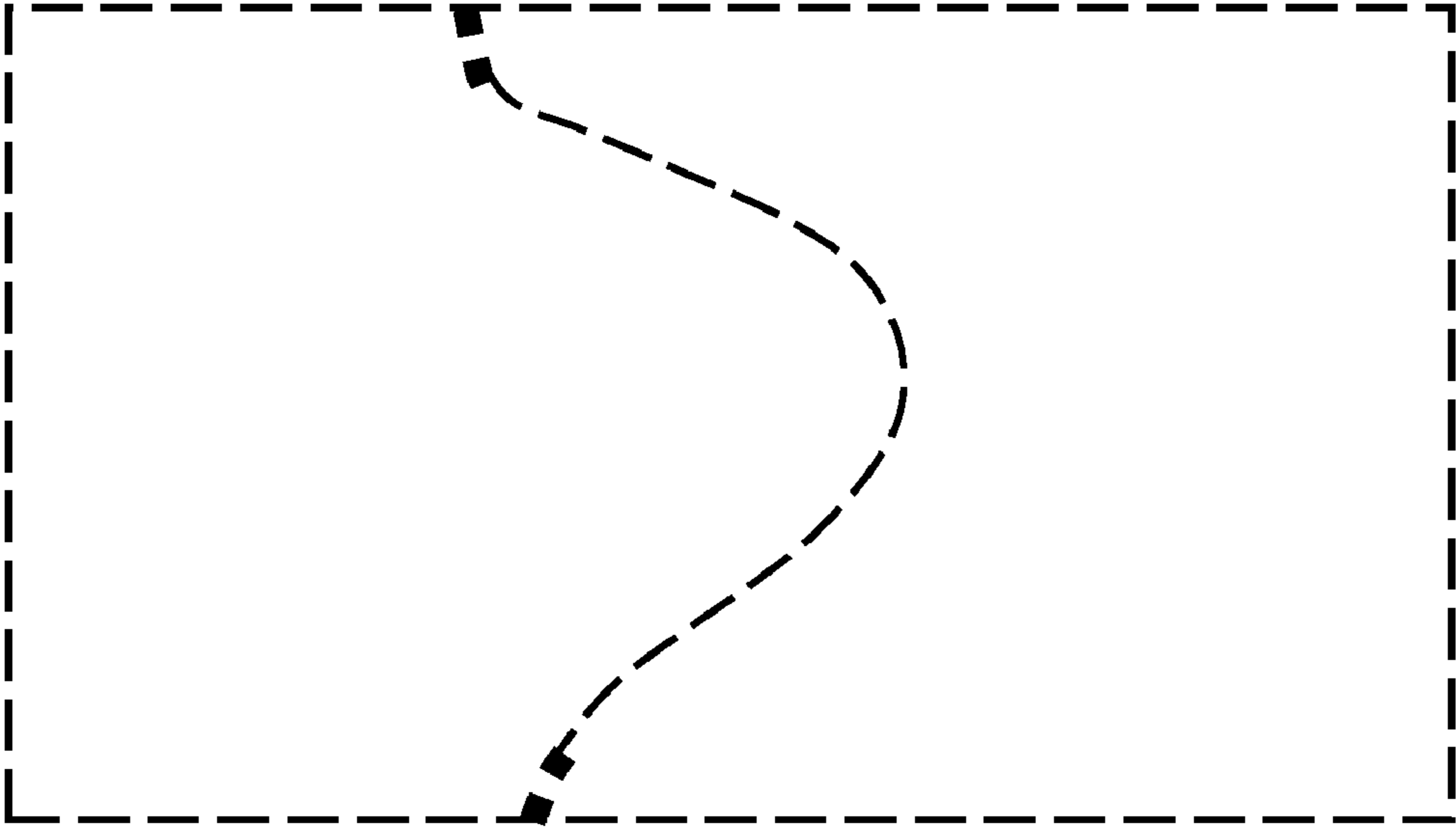

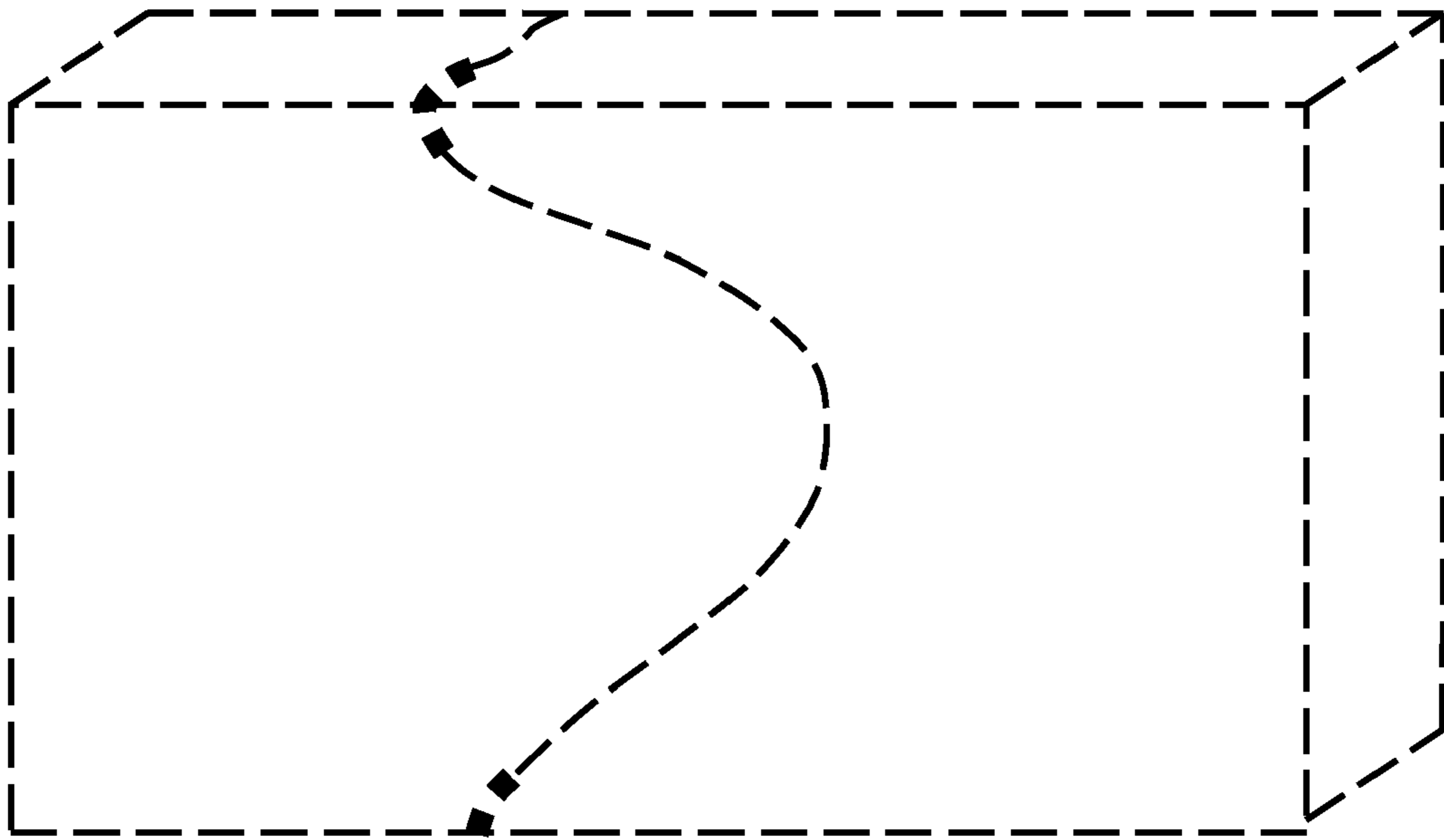

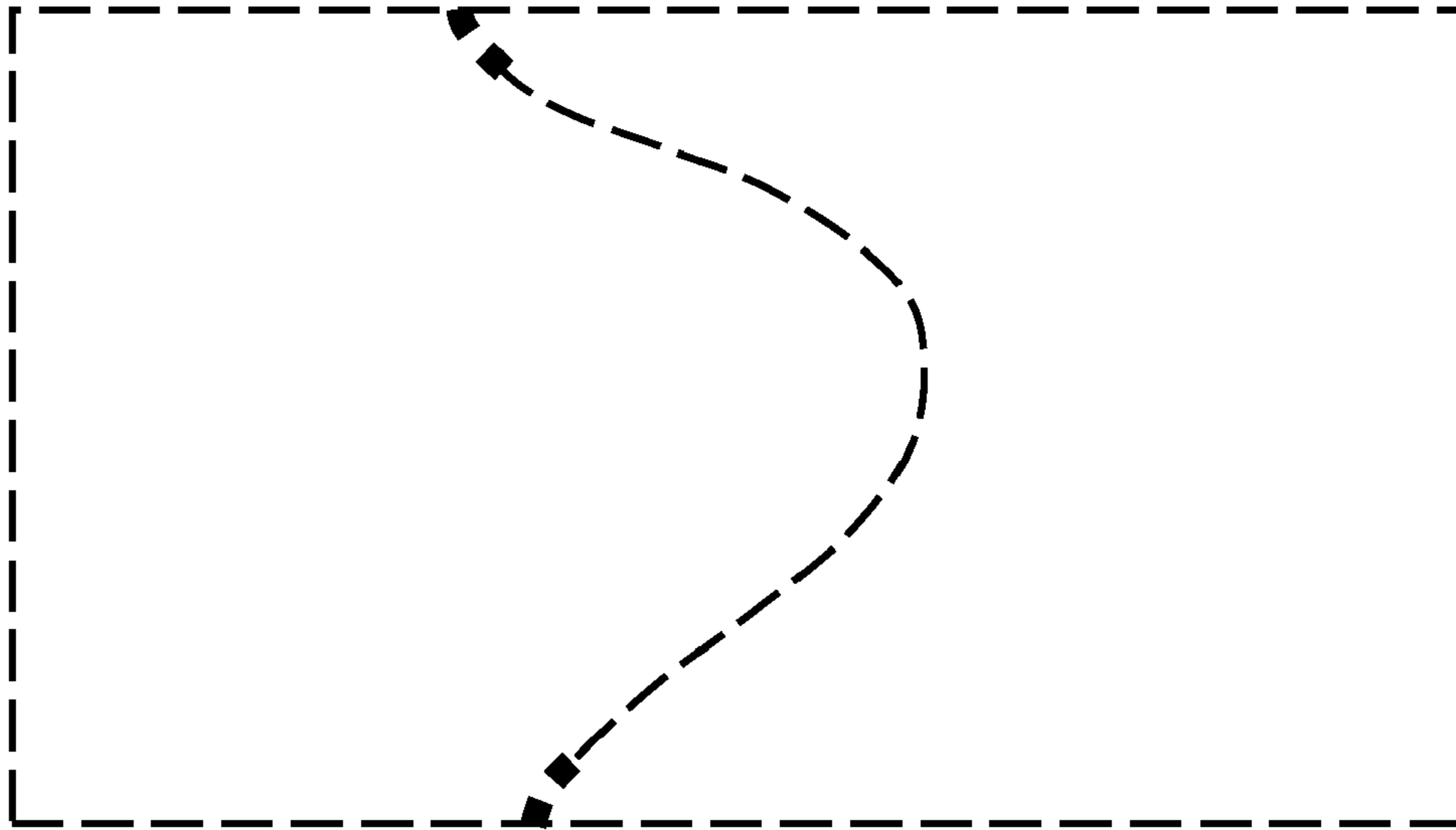

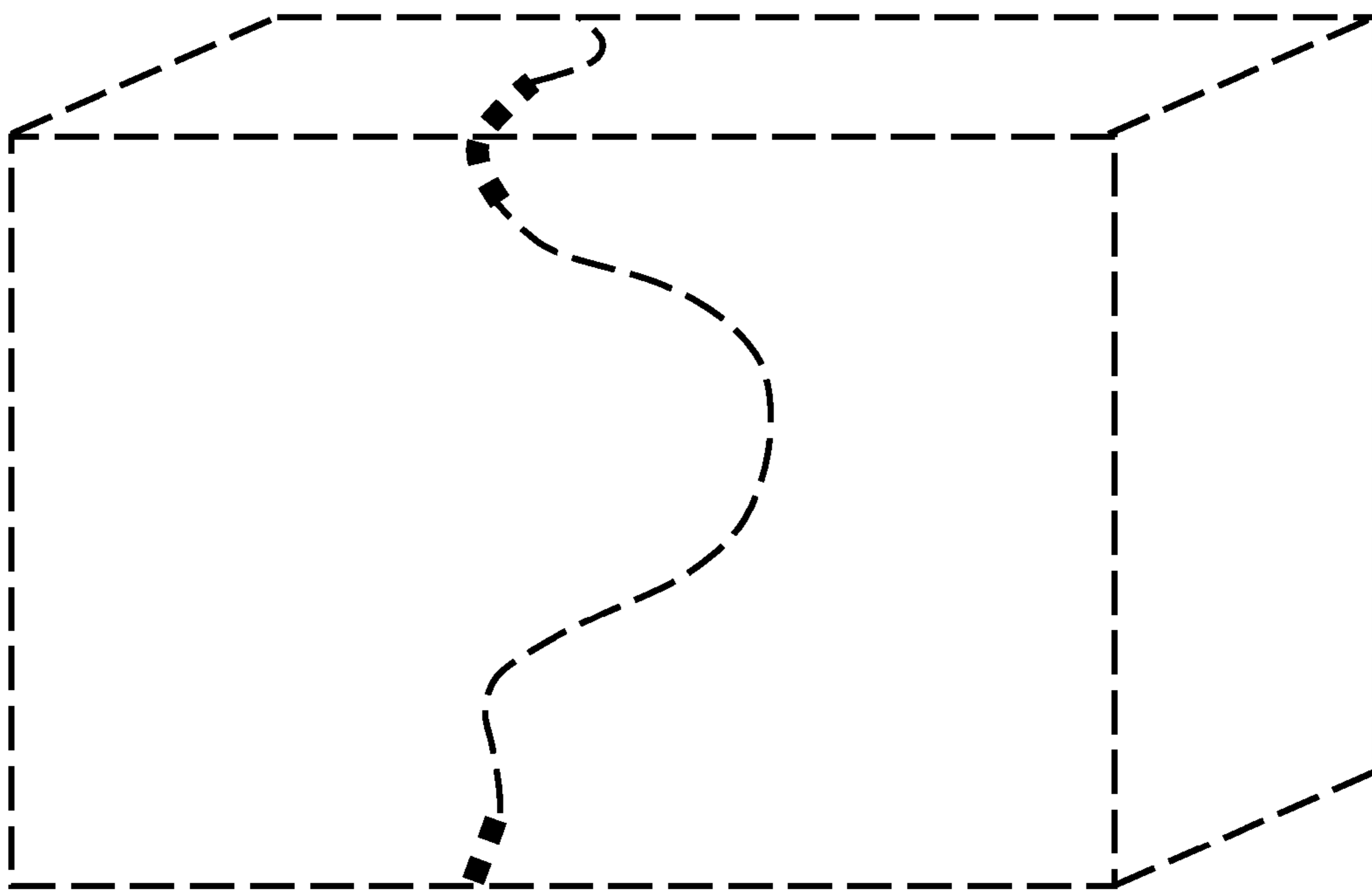

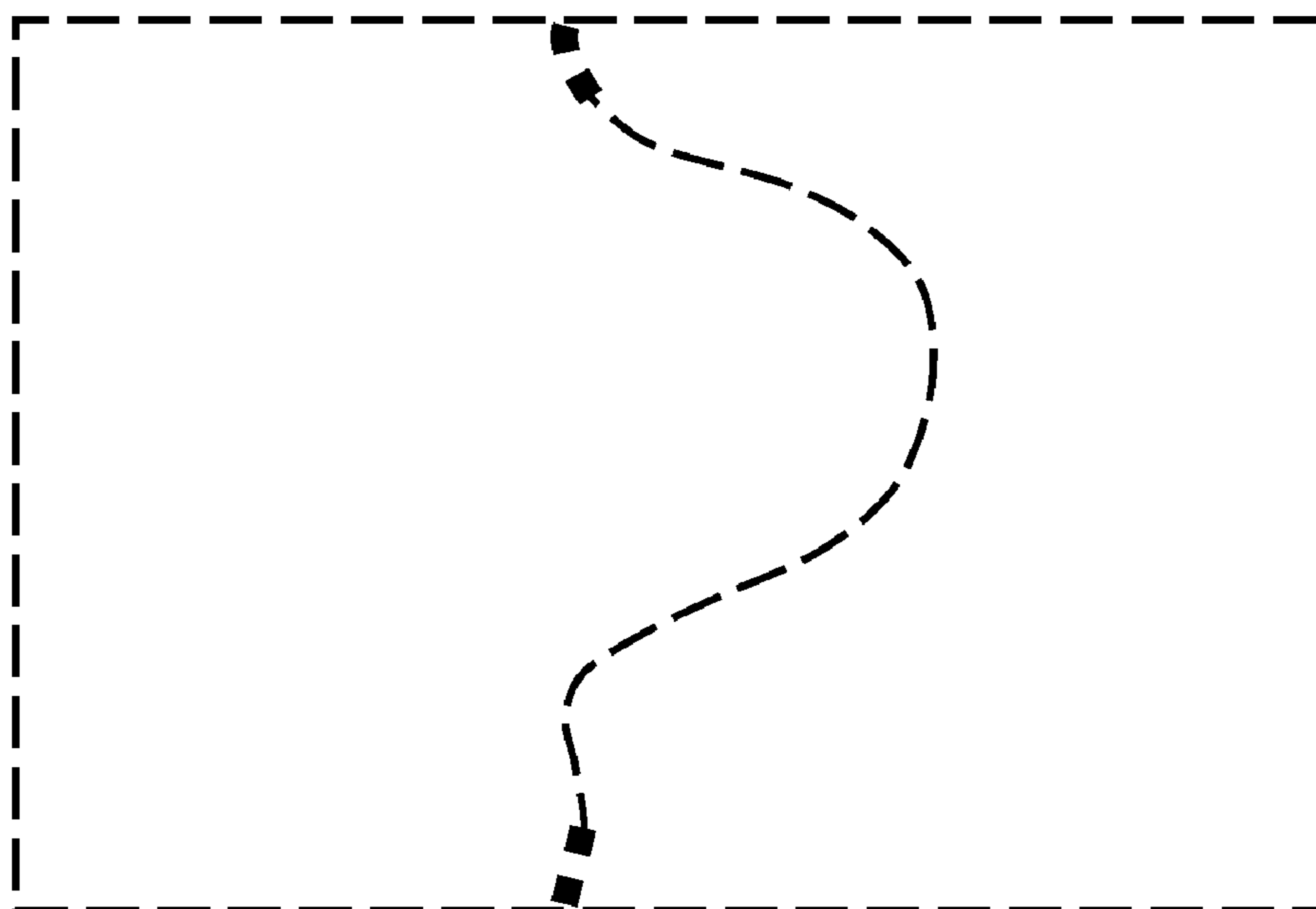

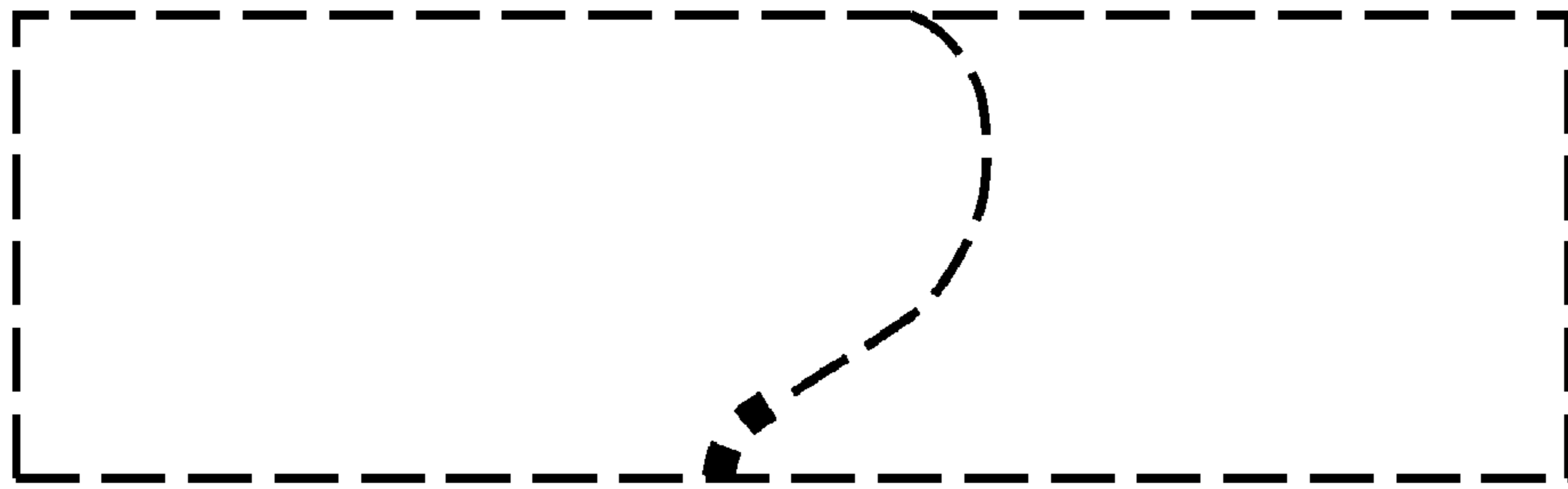

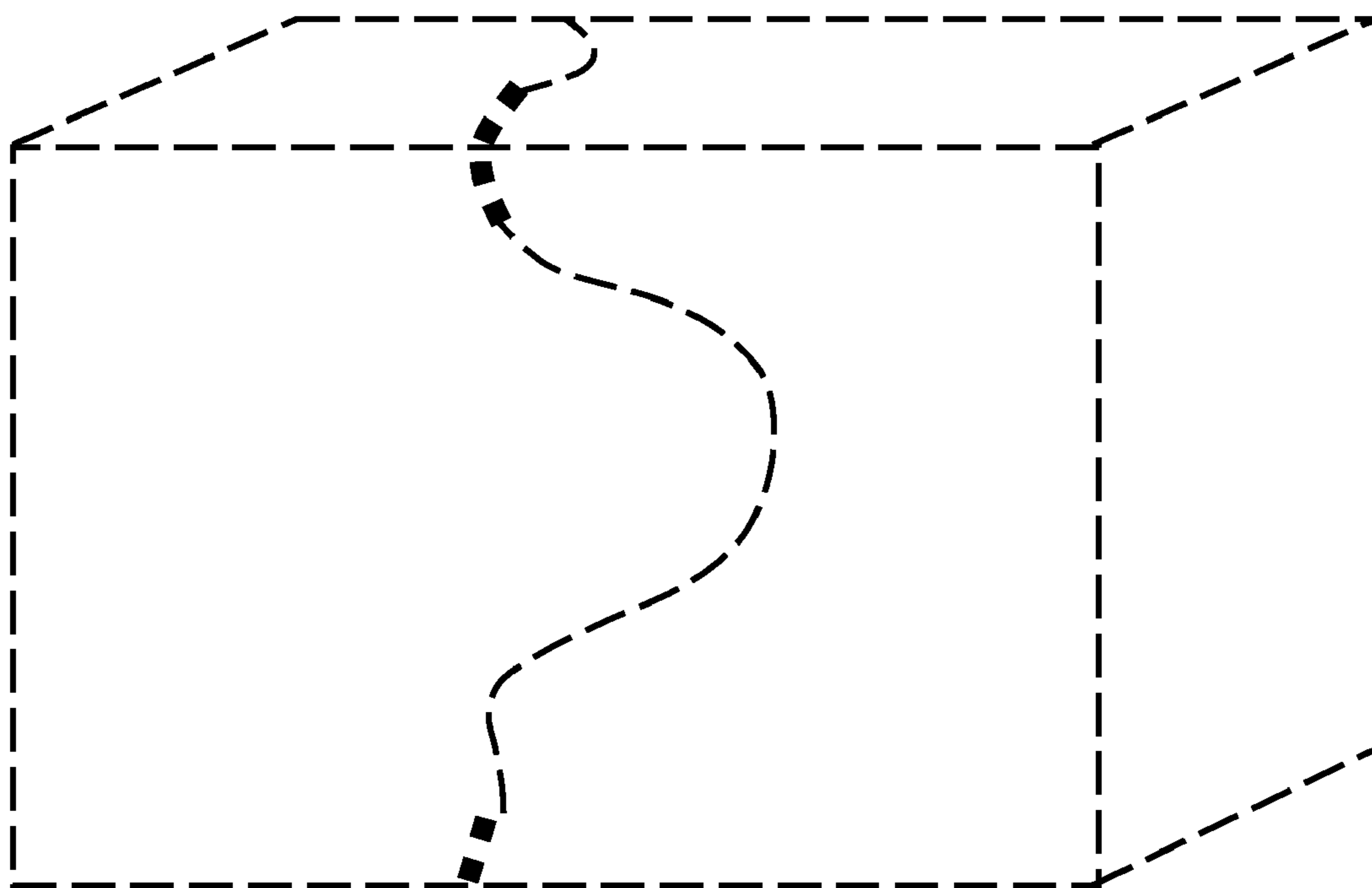

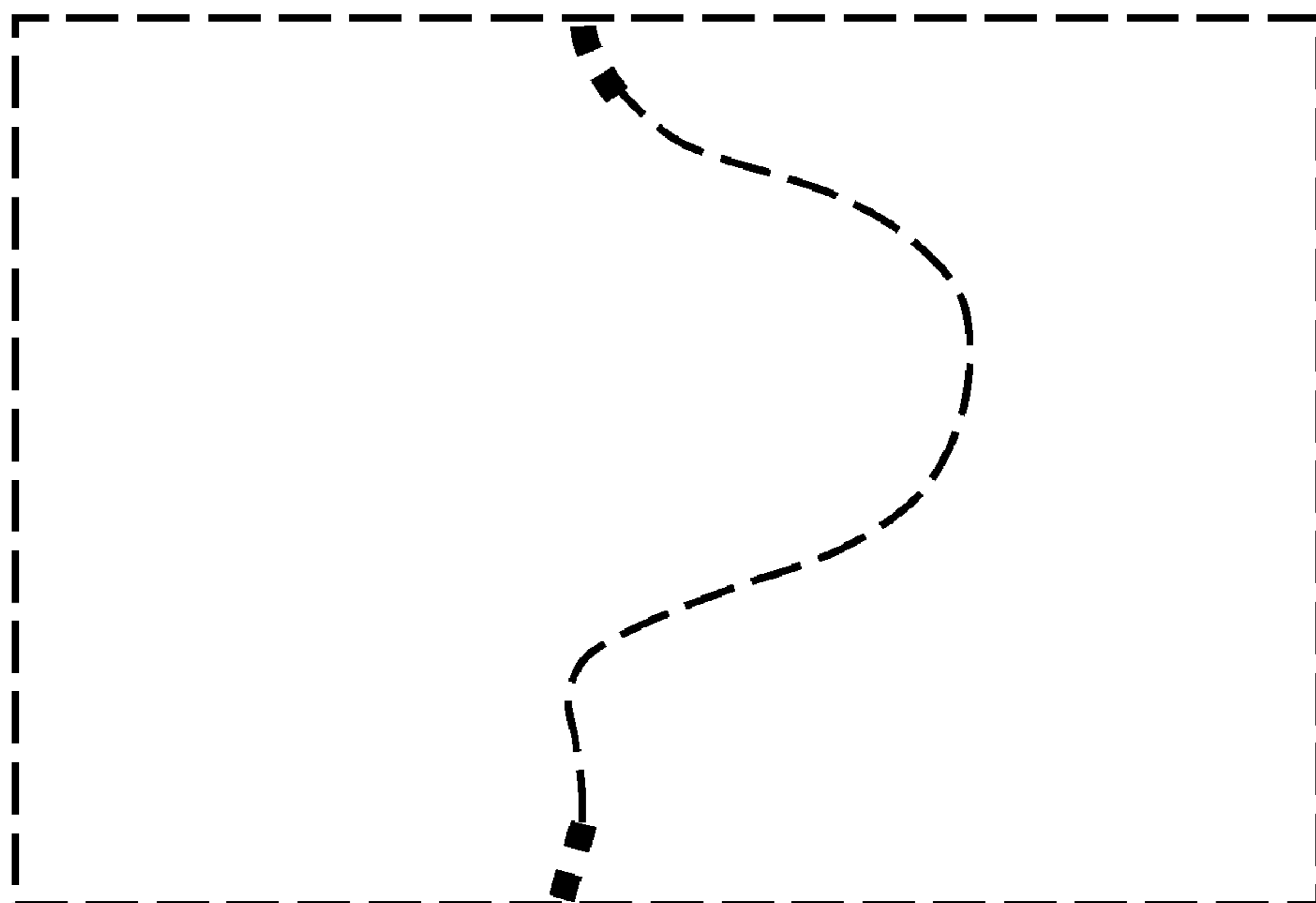

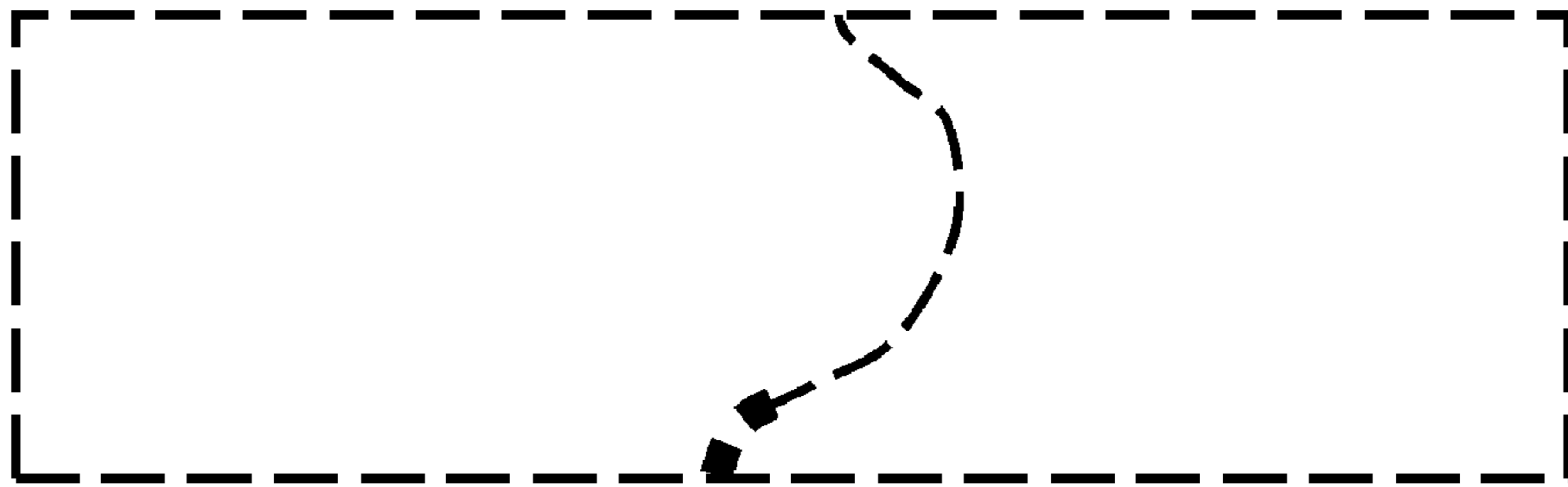

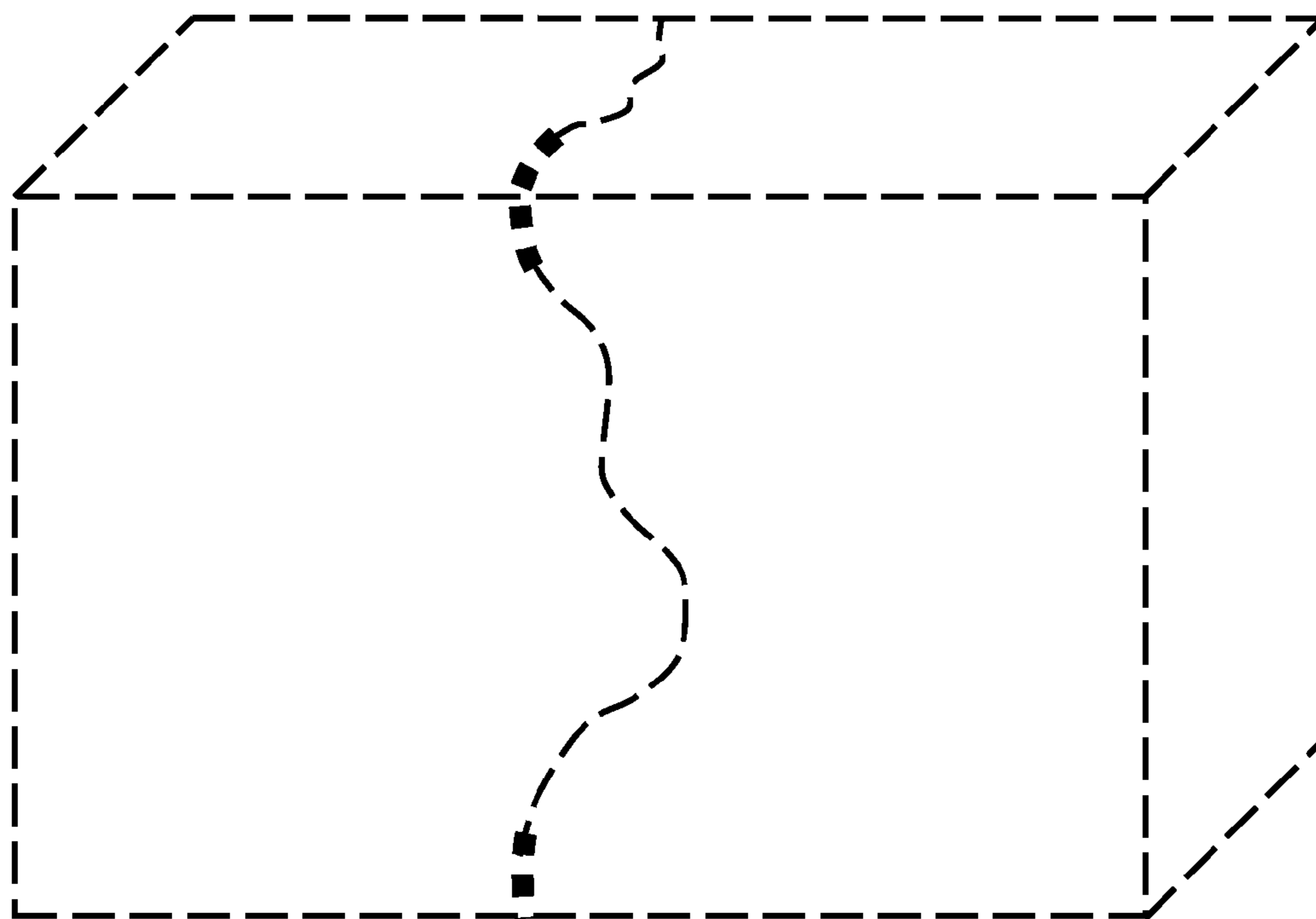

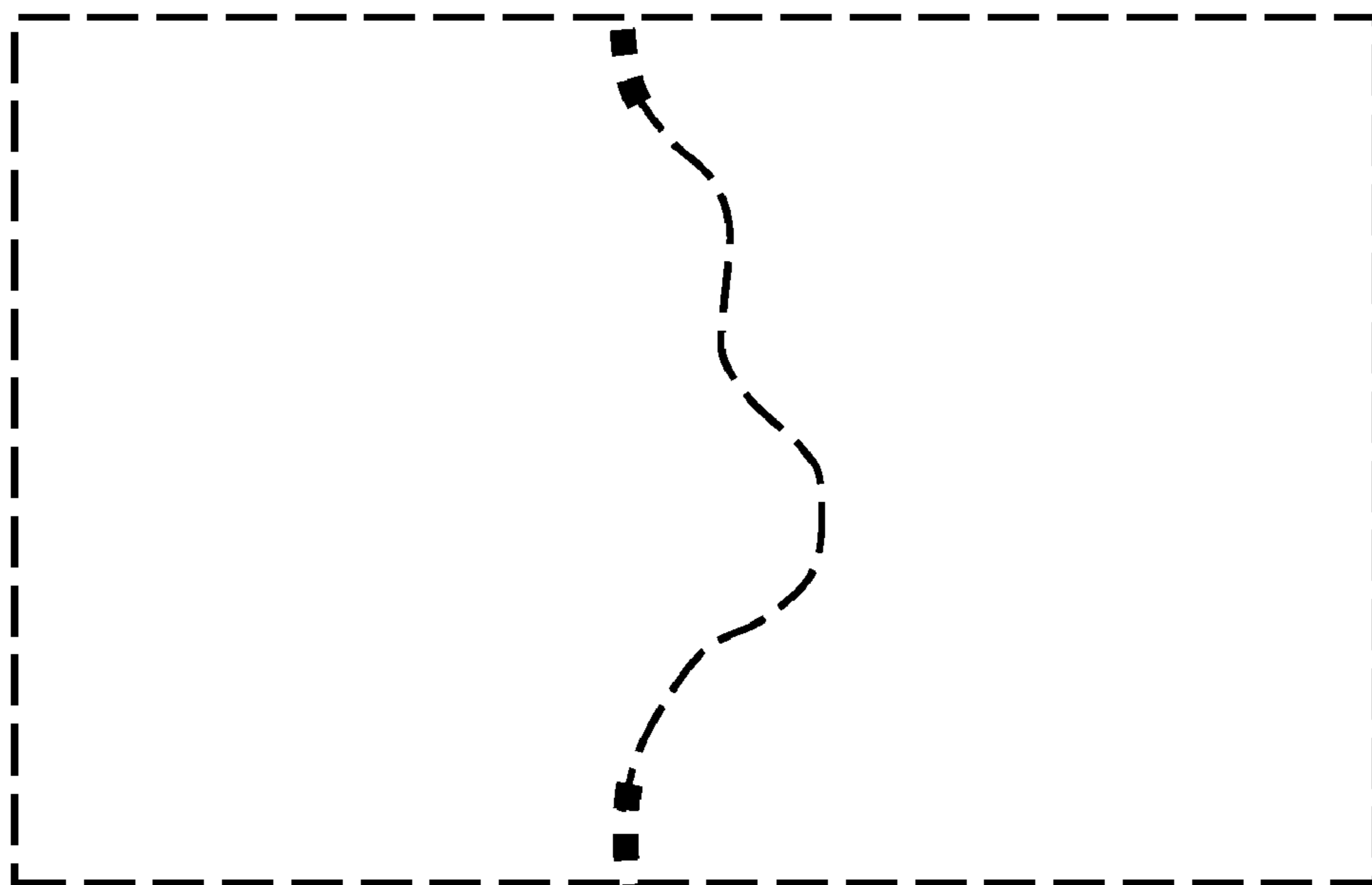

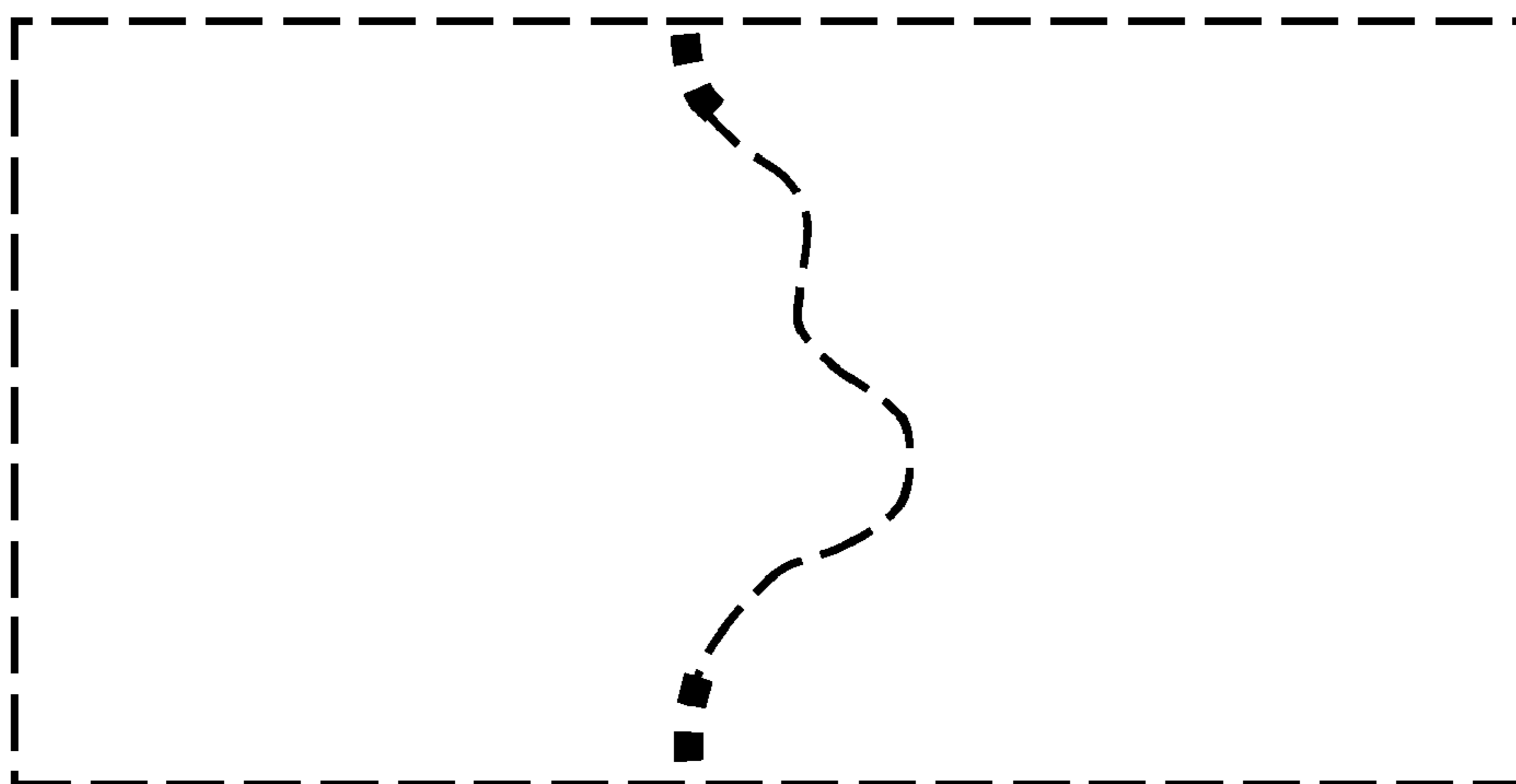

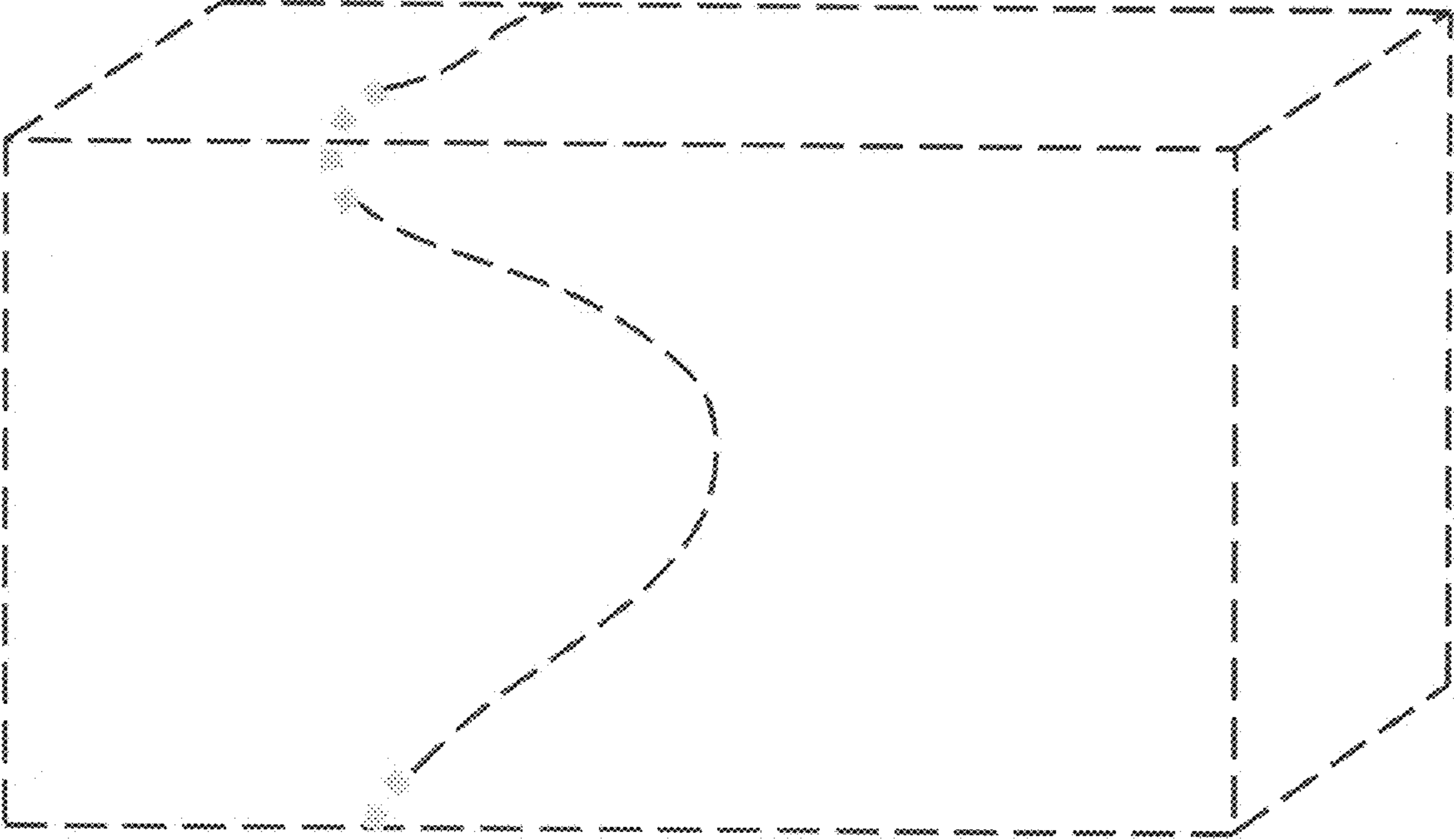

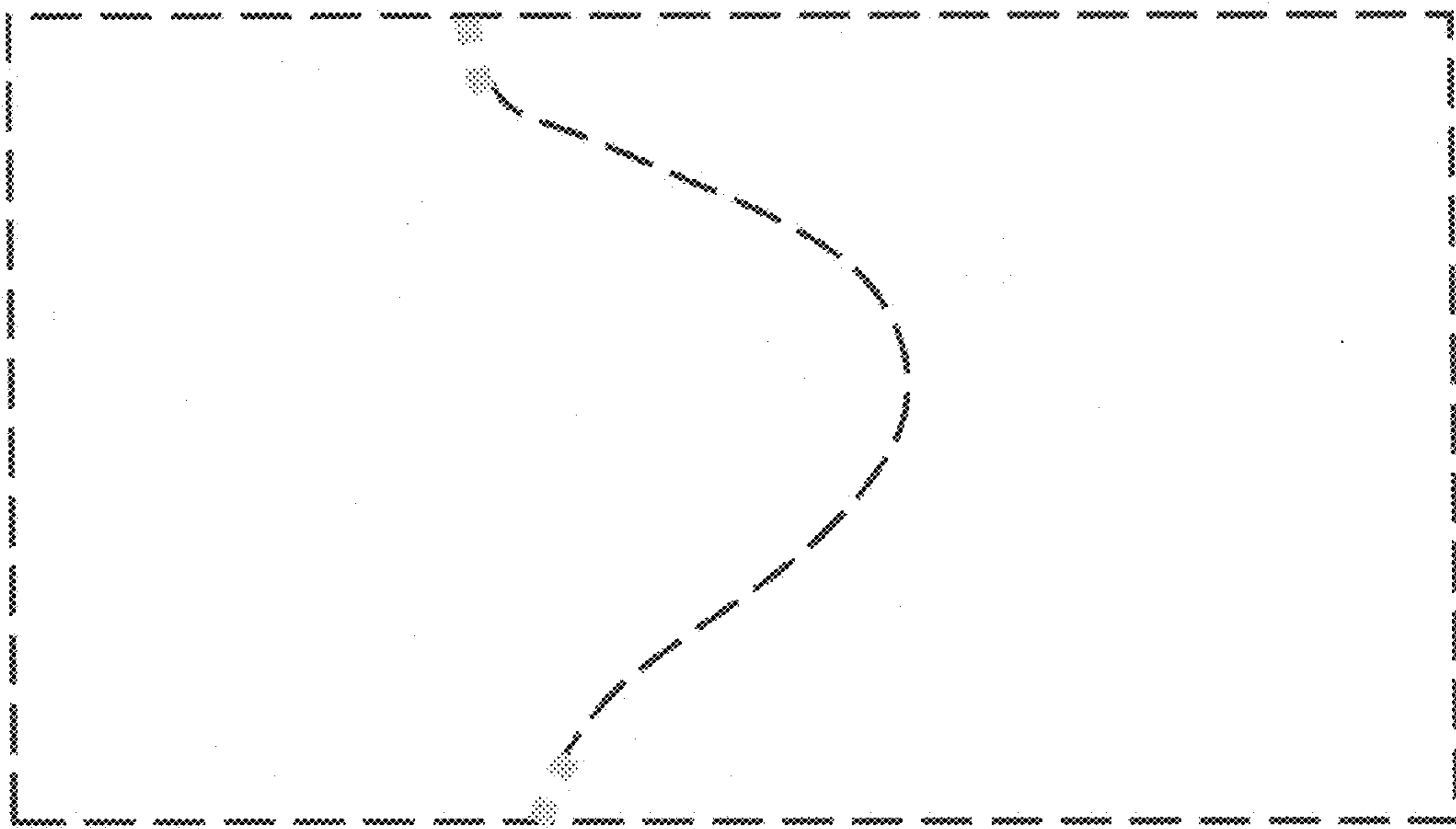

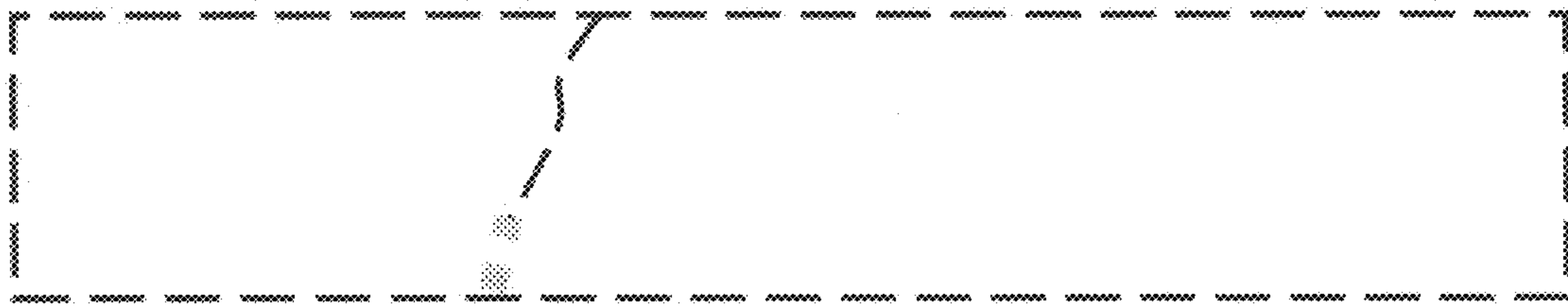
