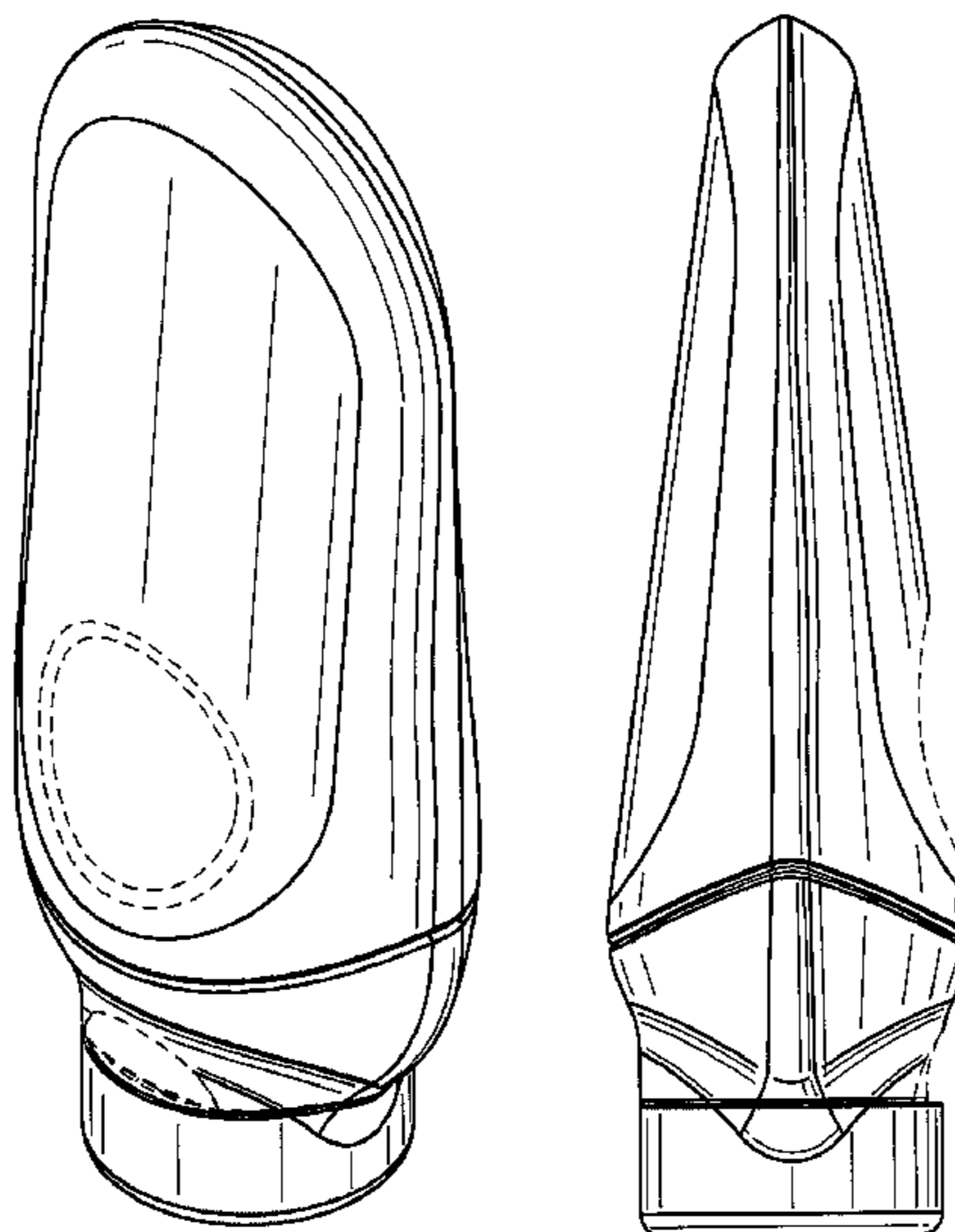
(57) **CLAIM**

The ornamental design for a container, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a first embodiment of a container showing our new design; FIG. 2 is a right side elevational view of the container of FIG. 1, the left side elevational view being a mirror image thereof; FIG. 3 is a front elevational view of the container of FIG. 1; FIG. 4 is a bottom plan view of the container of FIG. 1; FIG. 5 is a top plan view of the container of FIG. 1; and, FIG. 6 is a rear elevational view of the container of FIG. 1. The broken lines shown are included for the purpose of illustrating the unclaimed portions of the article and form no part of the claim.

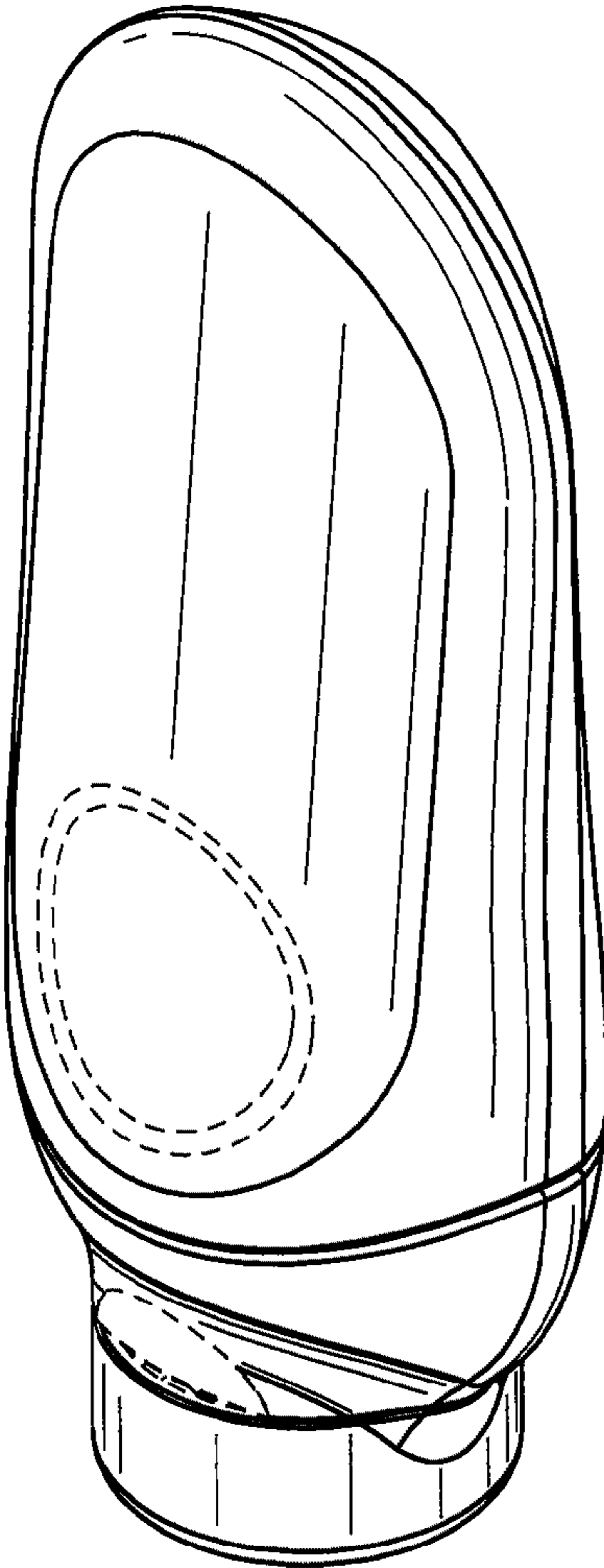

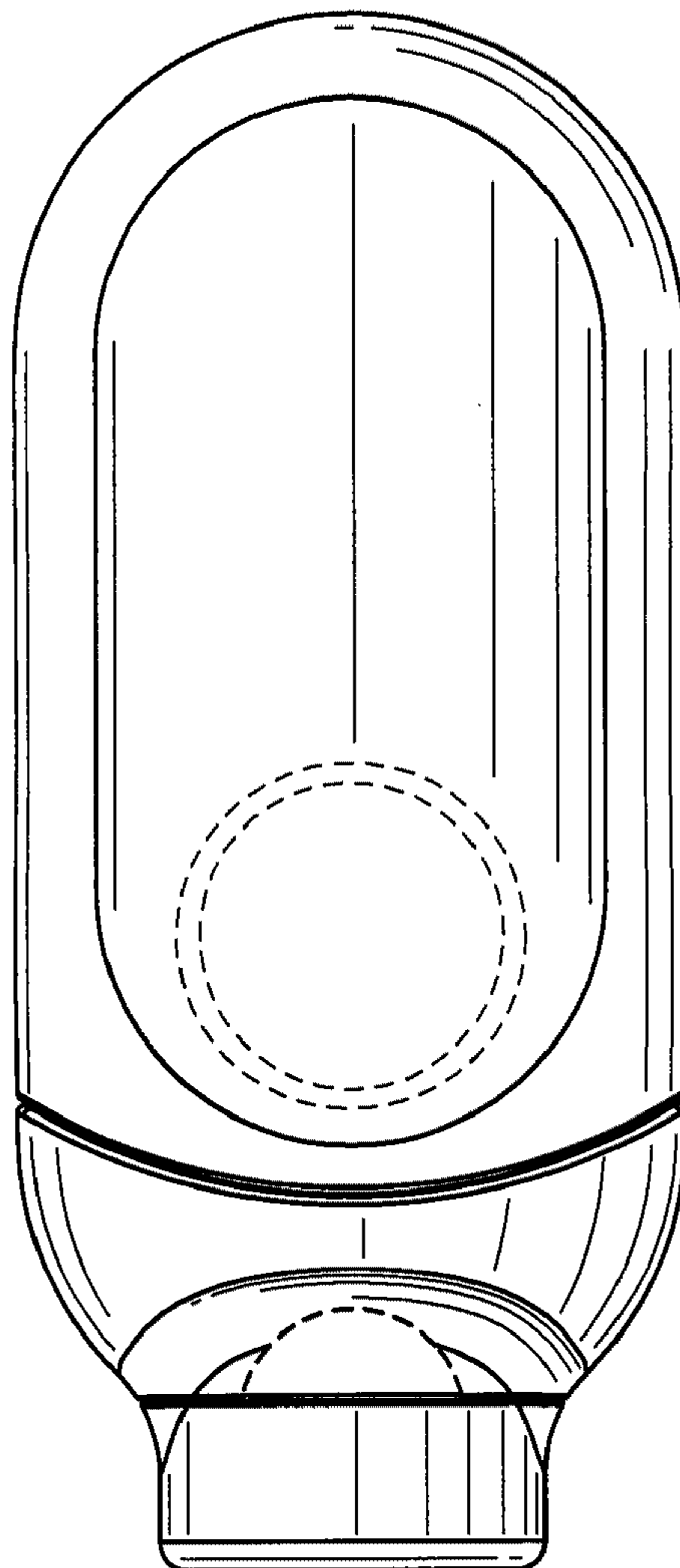

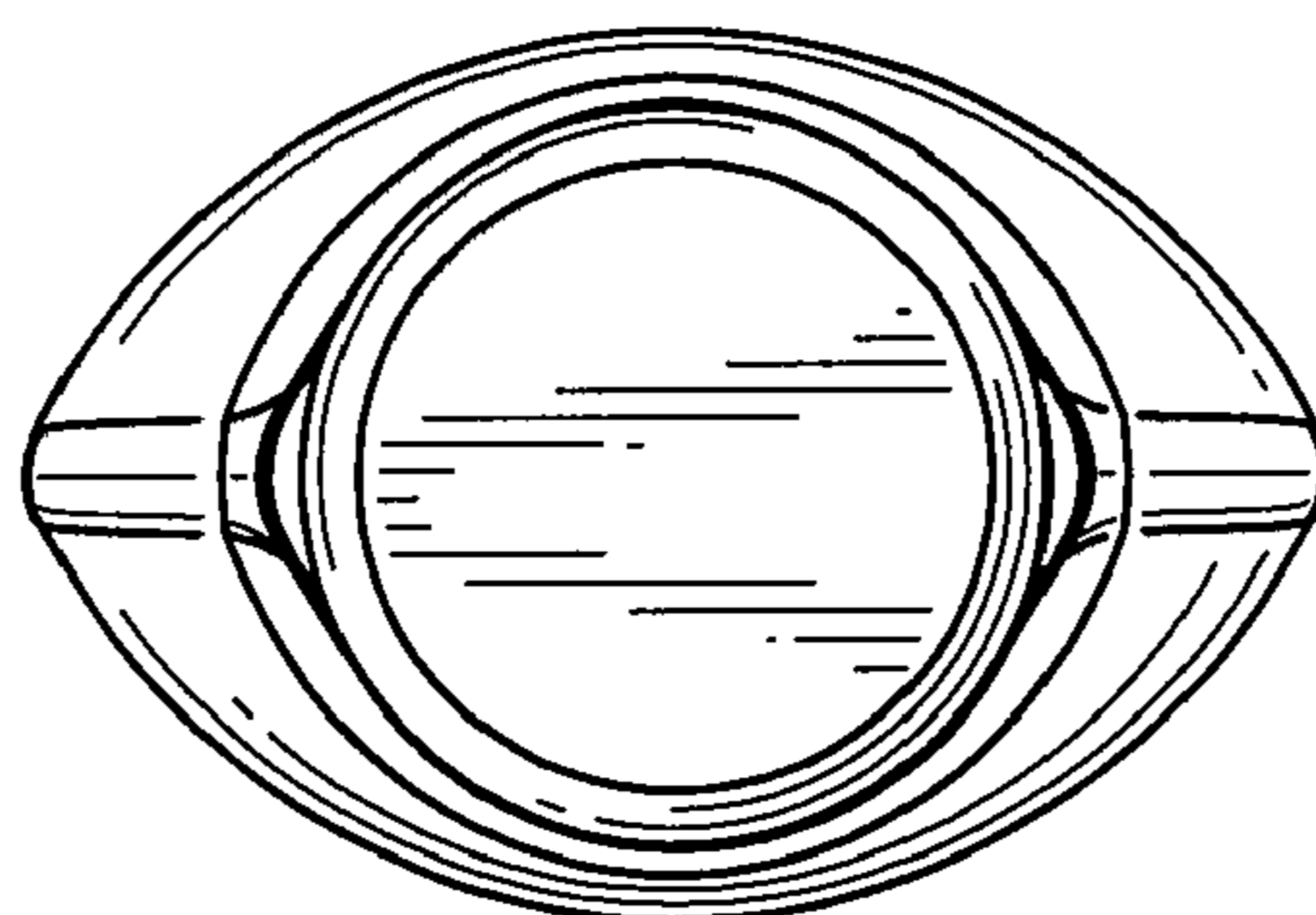

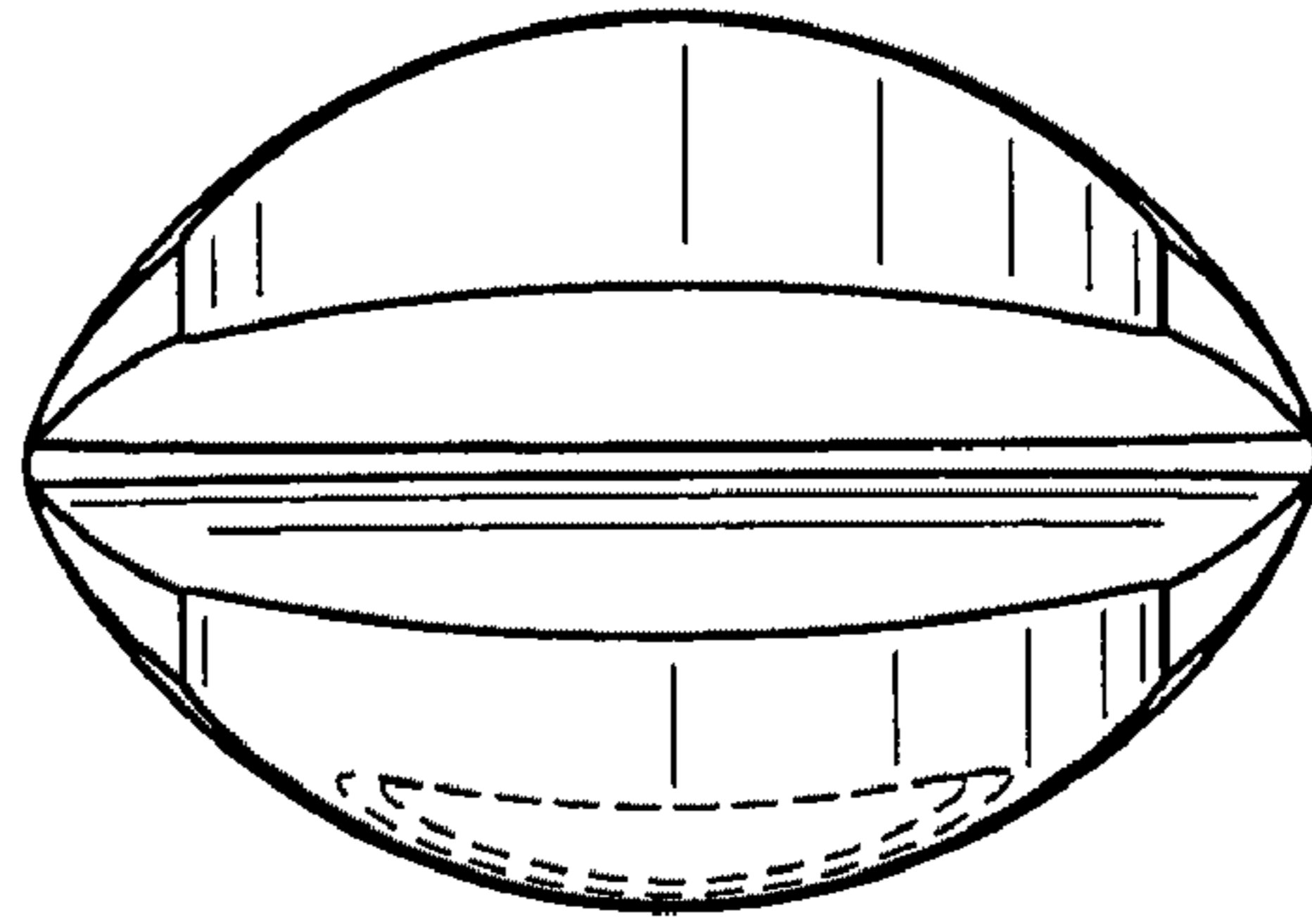
