(57) **CLAIM**

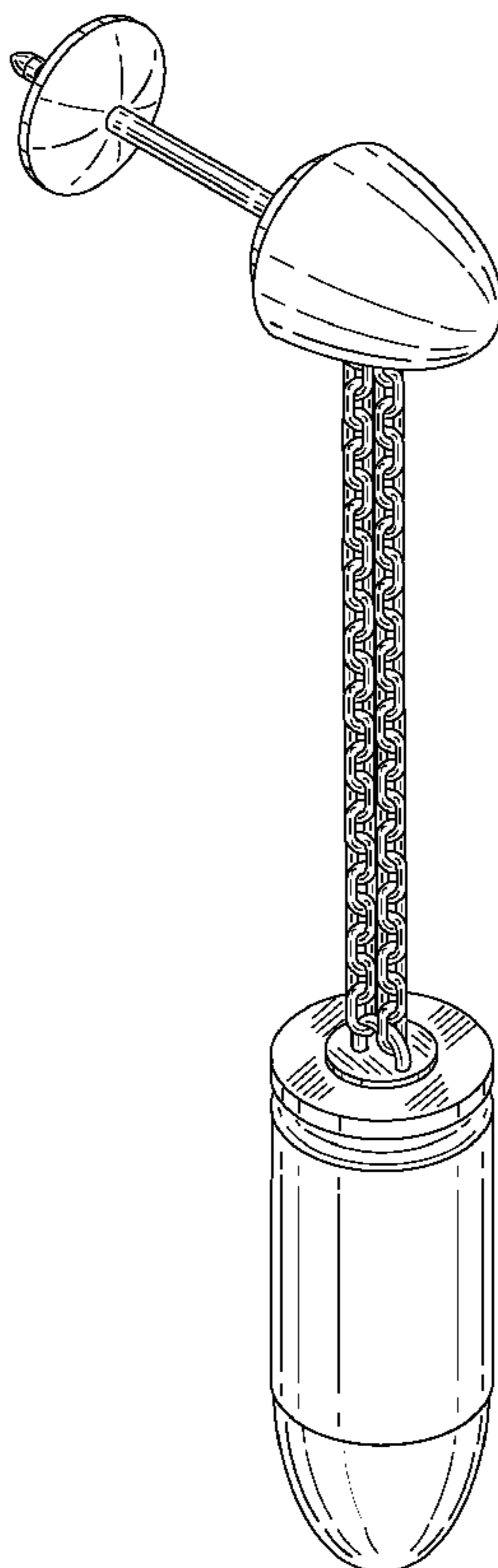
The ornamental design for an ear pendant, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of the ear pendant;  
FIG. 2 is a rear view thereof;  
FIG. 3 is a right side view thereof, the left side view being a mirror image thereof;  
FIG. 4 is a top view thereof;  
FIG. 5 is a bottom view thereof;  
FIG. 6 is a front top perspective view thereof; and,  
FIG. 7 is a rear top perspective view thereof.

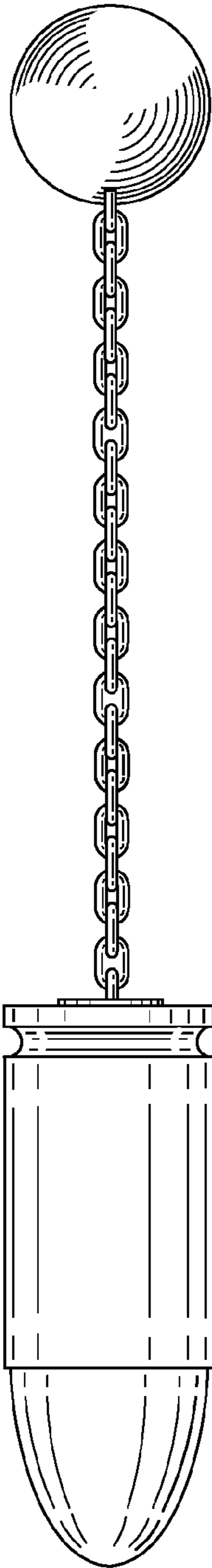

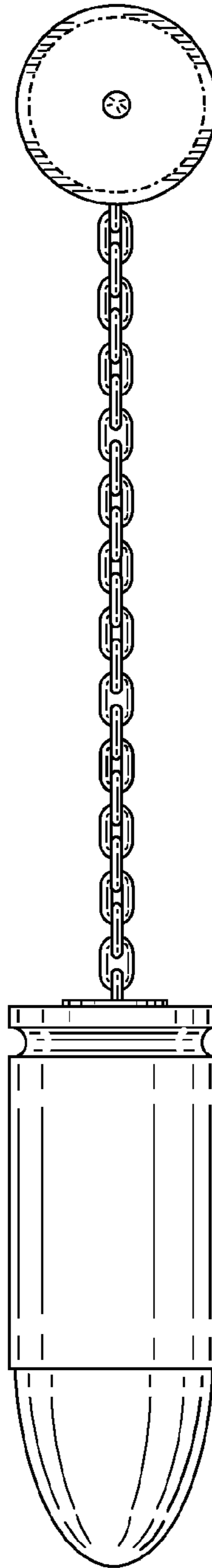

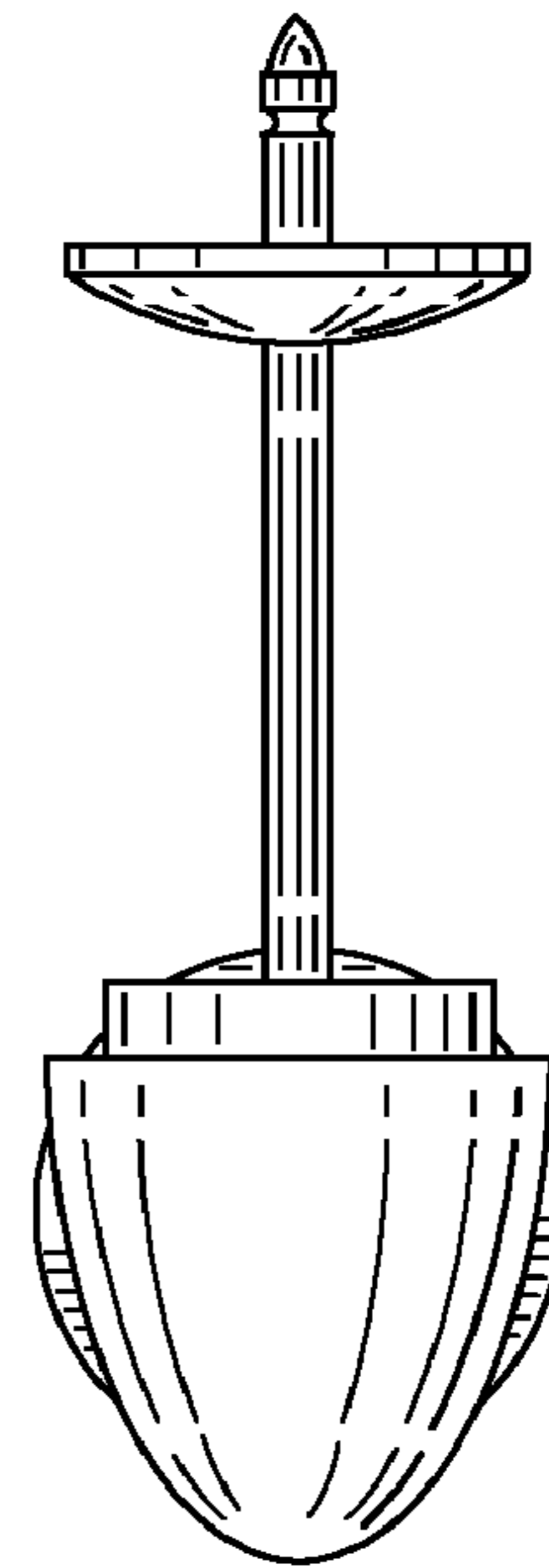
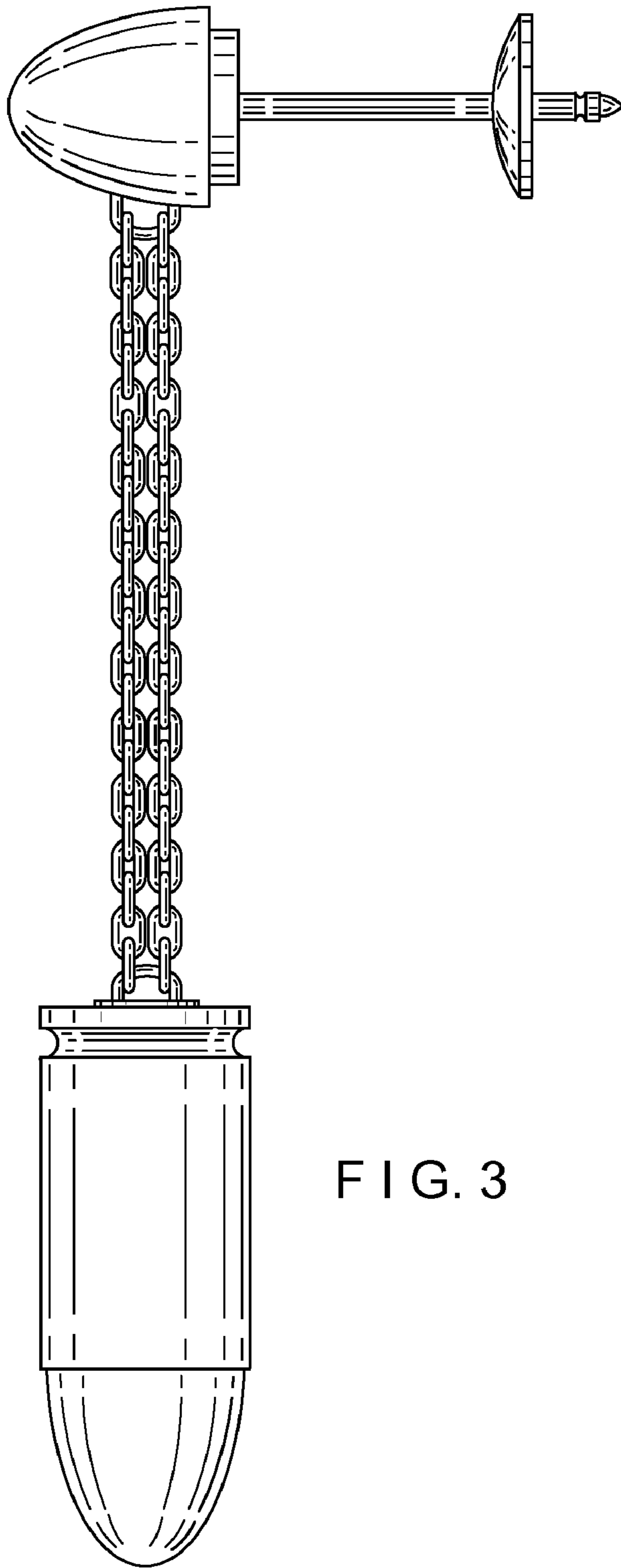

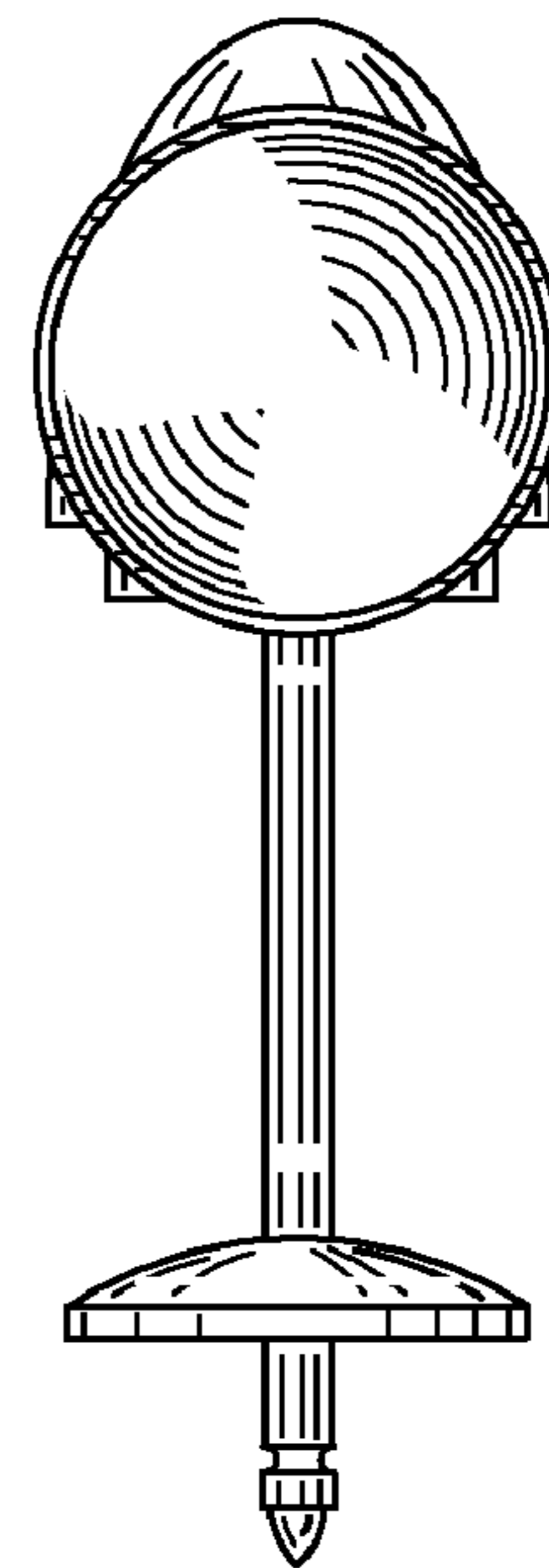

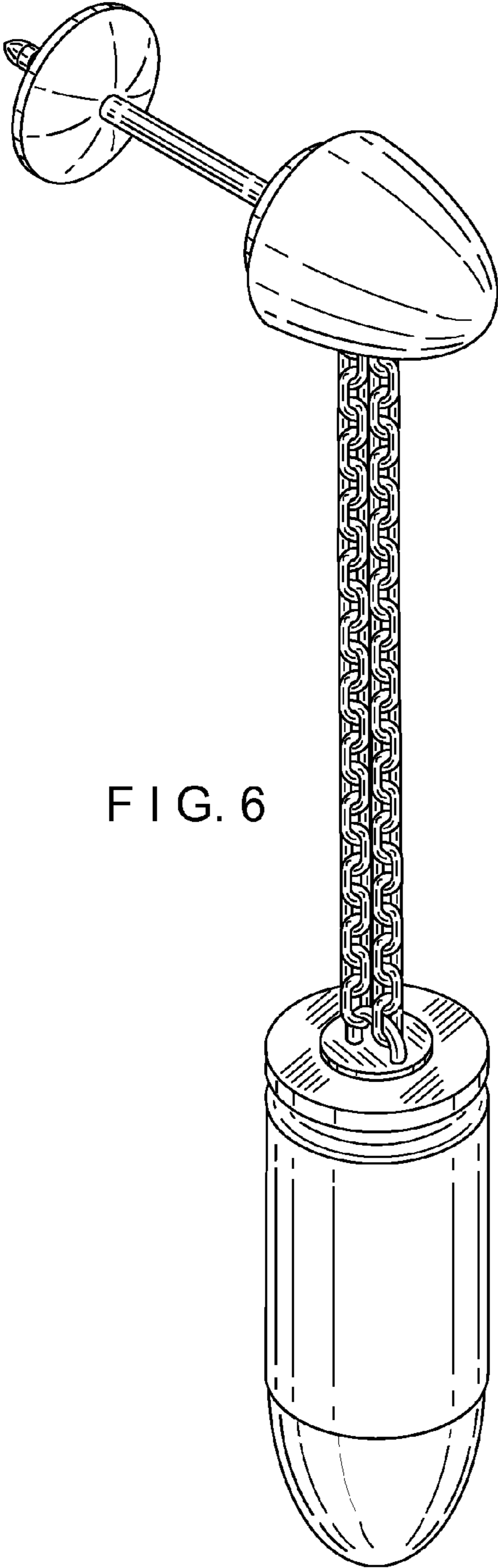

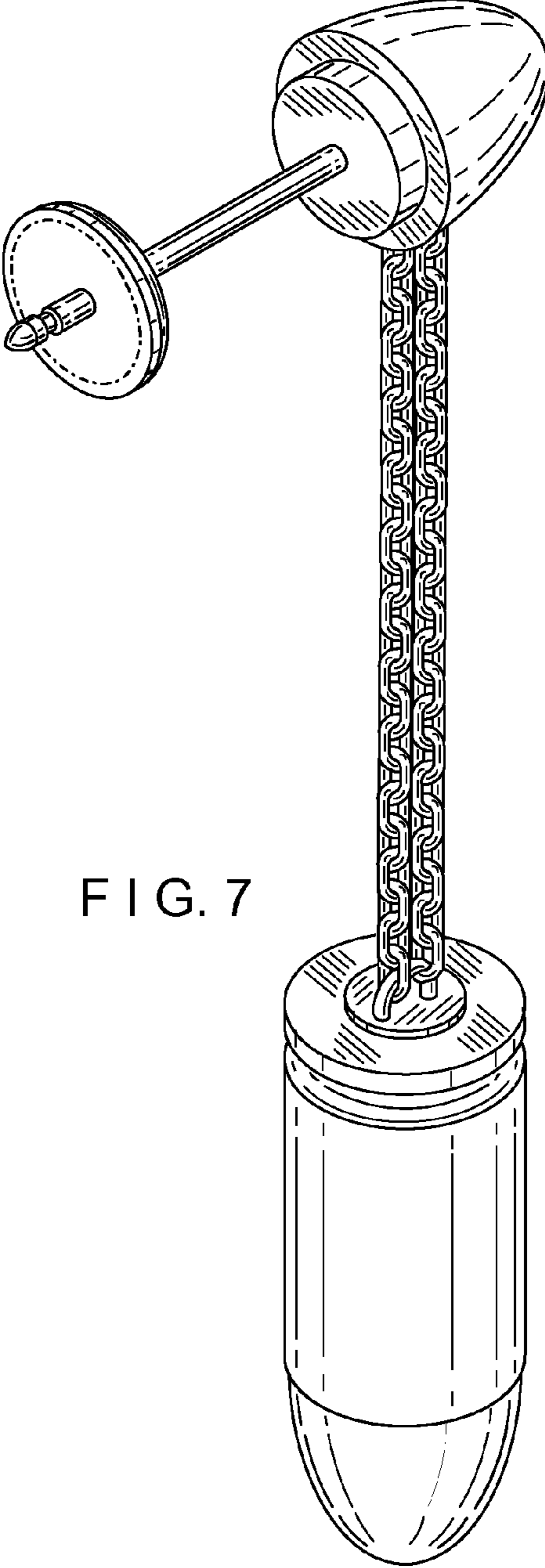
