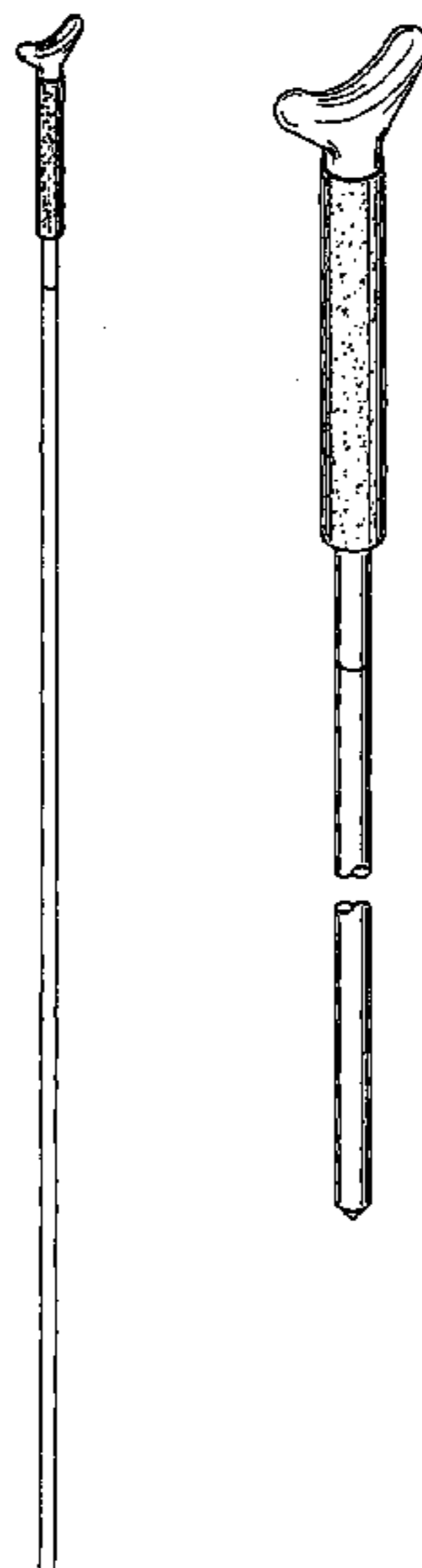
(57) **CLAIM**

The ornamental design for a mooring shaft, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of my new design for a mooring shaft;
FIG. 2 is a front view thereof;
FIG. 3 is a right and left side view thereof;
FIG. 4 is a top view thereof;
FIG. 5 is a bottom view thereof;
FIG. 6 is an enlarged view of a portion of FIG. 1;
FIG. 7 is an enlarged view of a portion of FIG. 2;
FIG. 8 is an enlarged view of a portion of FIG. 3;
FIG. 9 is an enlarged view of a portion of FIG. 4; and,
FIG. 10 is an enlarged view of a portion of FIG. 5.
The shaft in FIGS. 6-8 has been shown broken away for the ease and clarity of illustration.

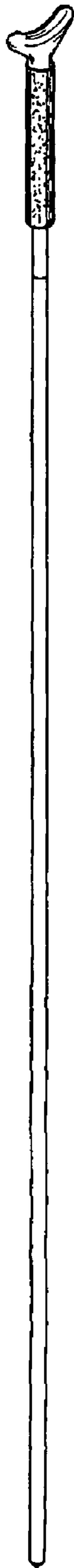

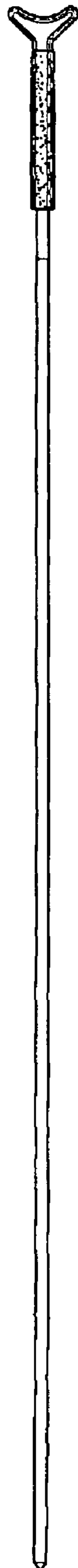

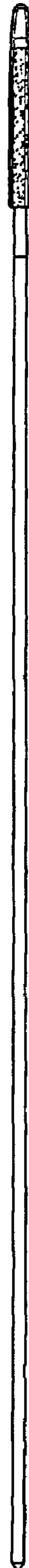

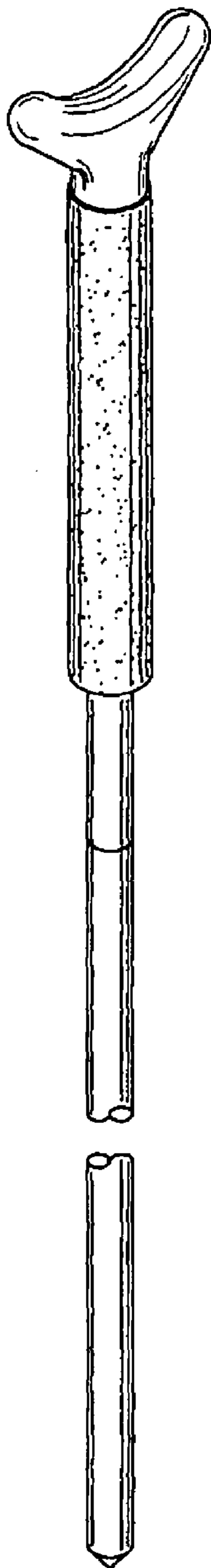

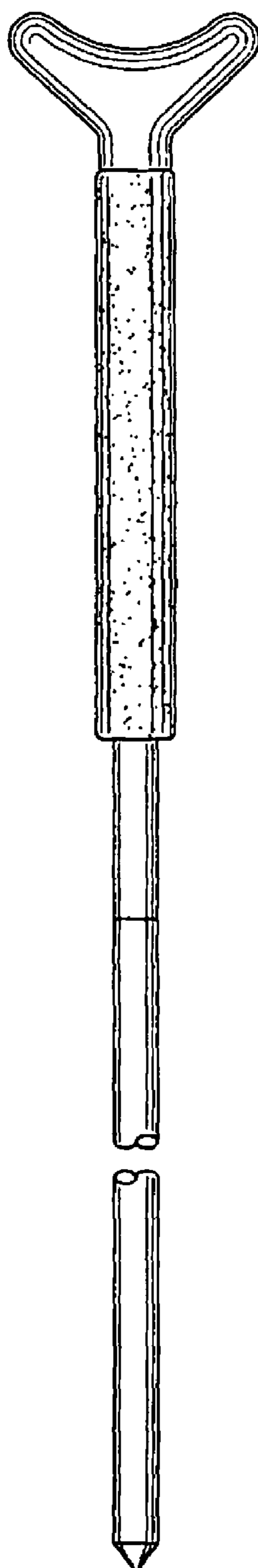

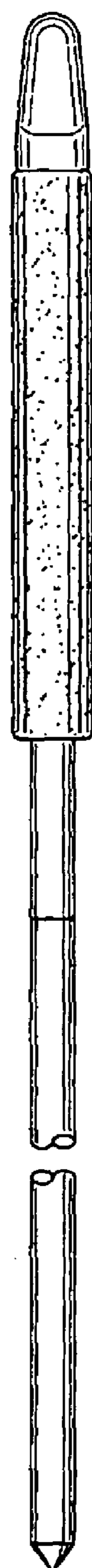
