(57) **CLAIM**

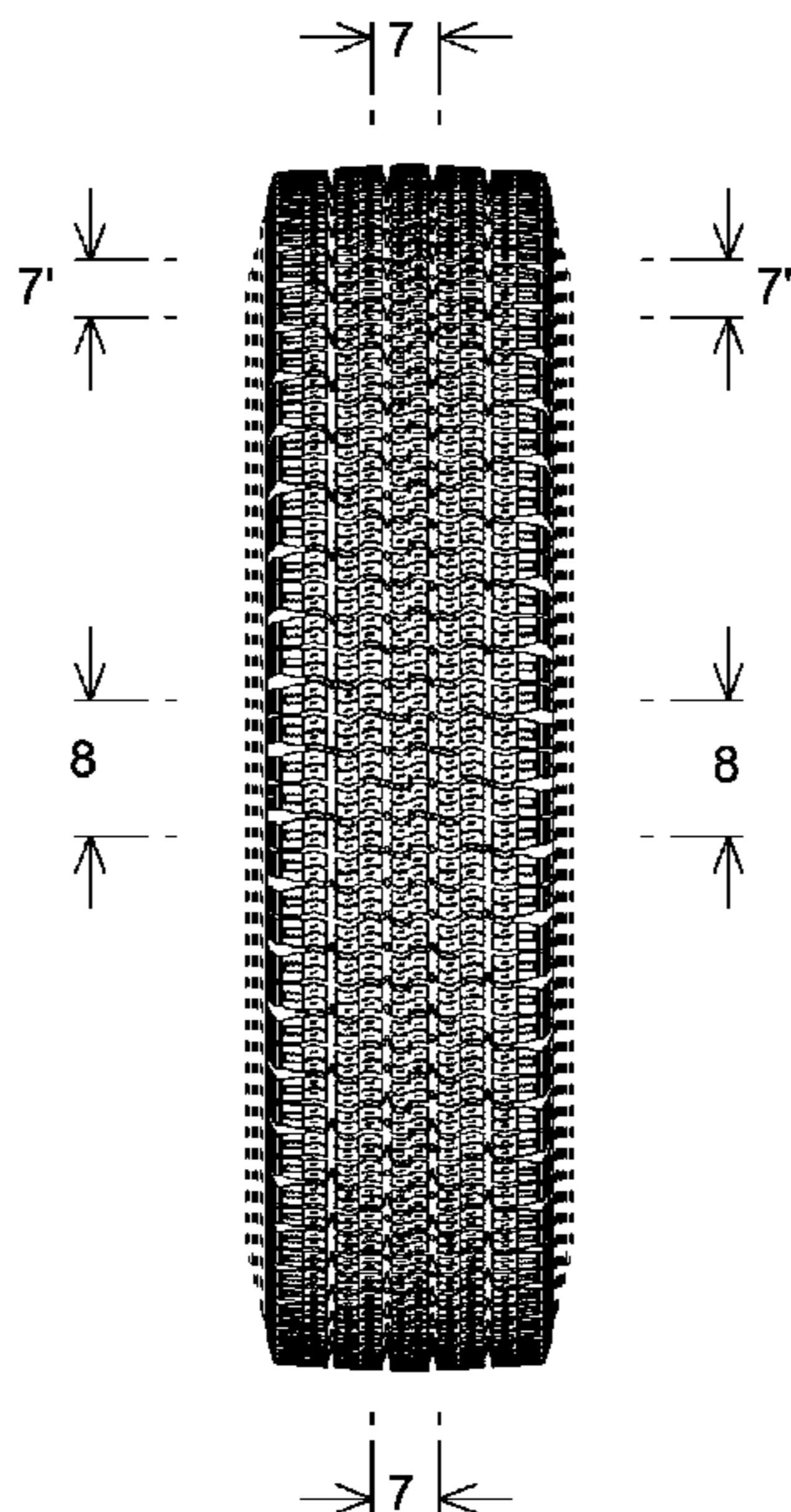
The ornamental design for a tire, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a tire showing my new design;
FIG. 2 is a rear view thereof;
FIG. 3 is a top view thereof;
FIG. 4 is a bottom view thereof;
FIG. 5 is a right side view thereof;
FIG. 6 is a left side view thereof;
FIG. 7 is an enlarged view of the intersection of the areas 7—7 and 7'—7' in FIG. 1;
FIG. 8 is an enlarged view of the area 8—8 in FIG. 1; and,
FIG. 9 is a cross-sectional view taken along line 9—9 in FIG. 5 and along line 9'—9' in FIG. 8.

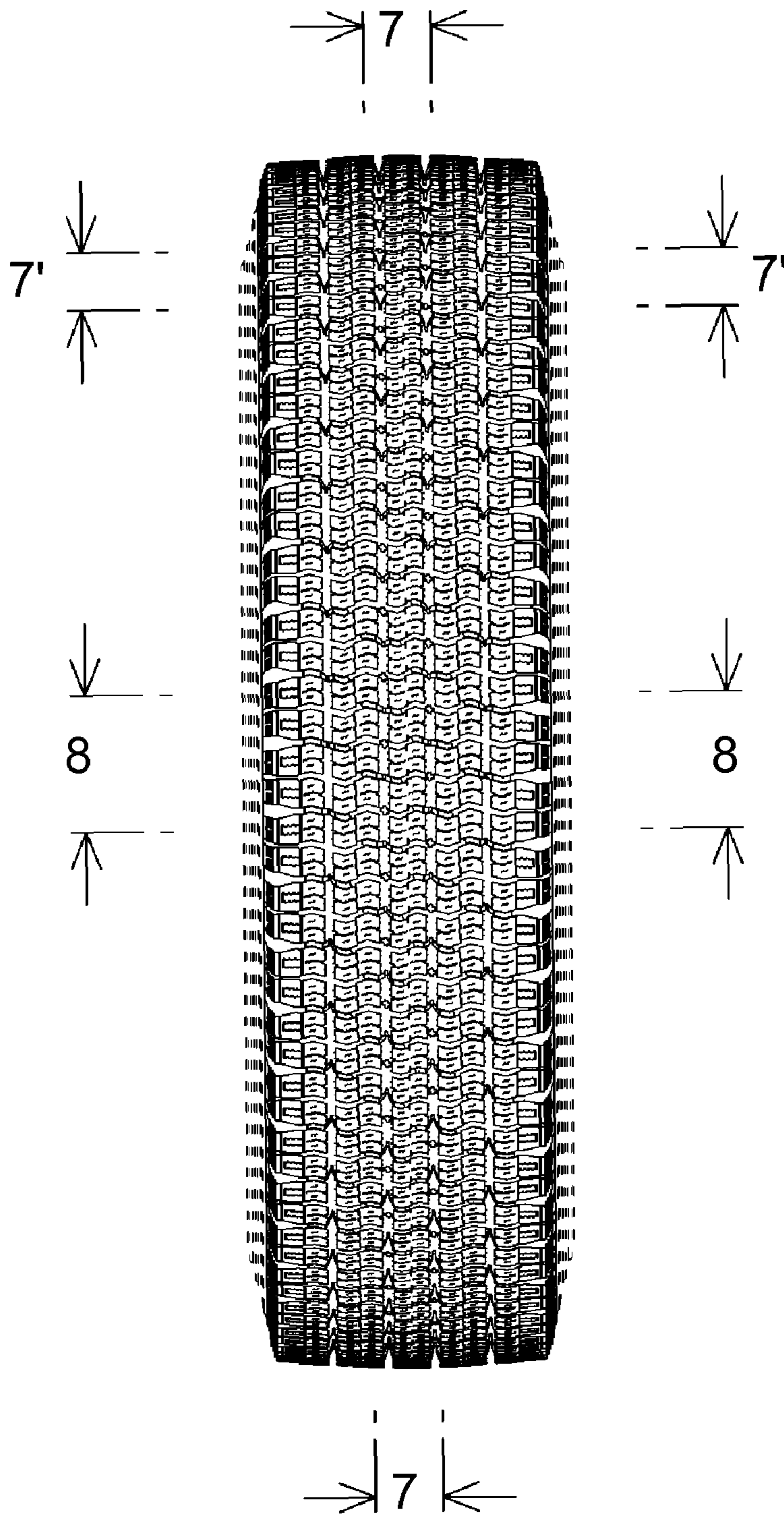

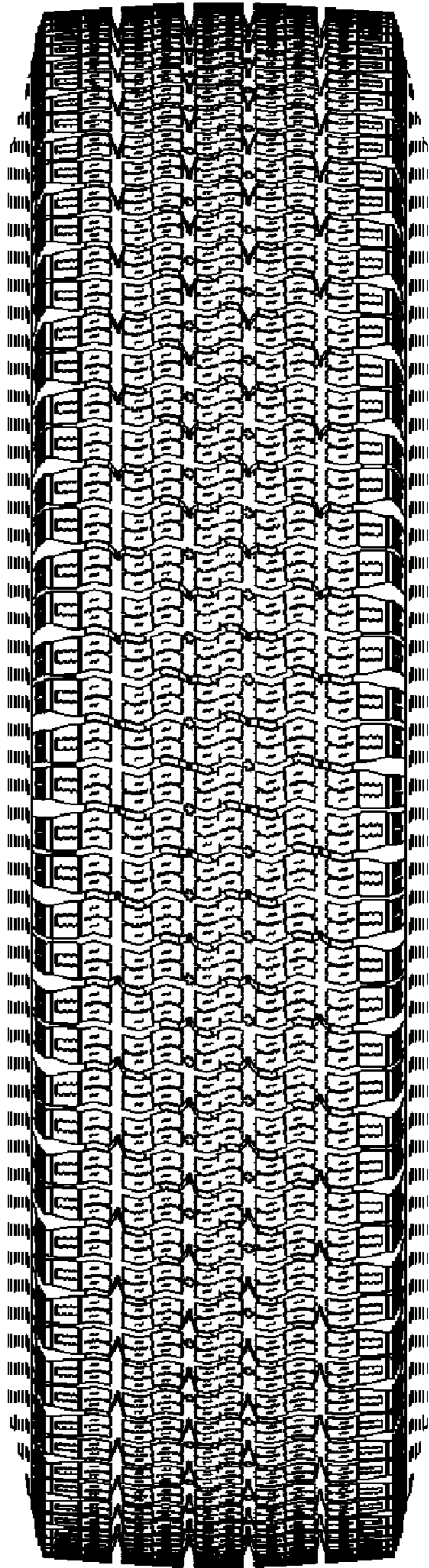

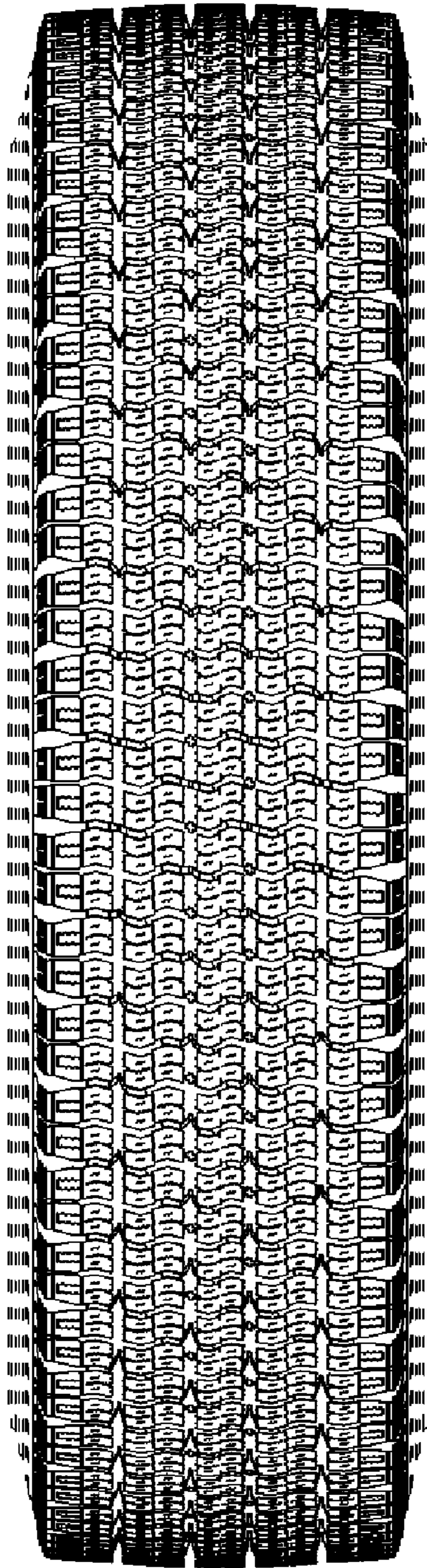

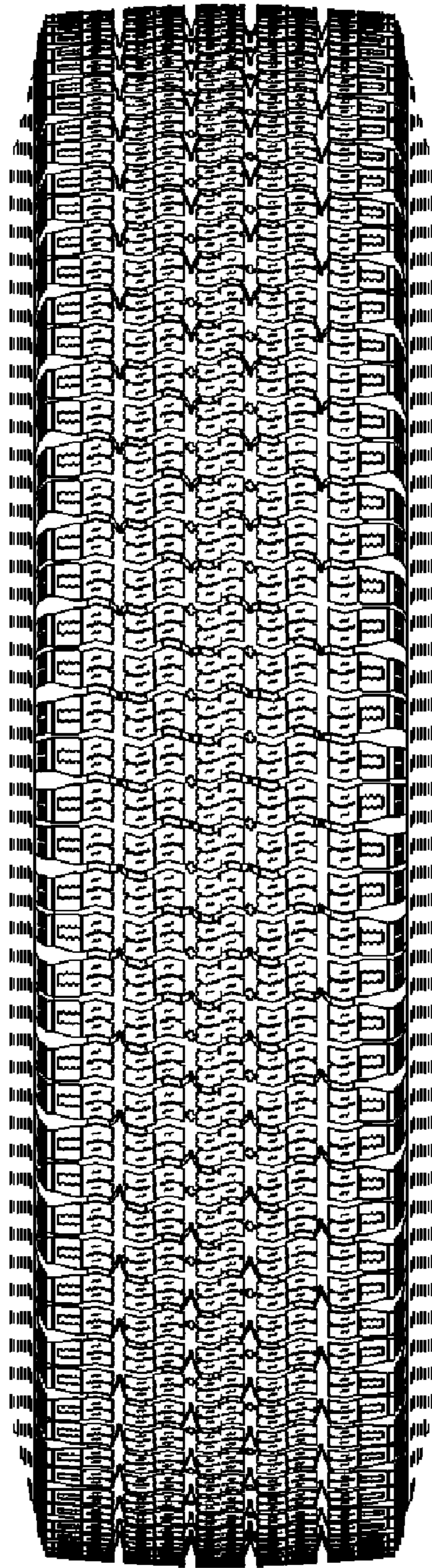

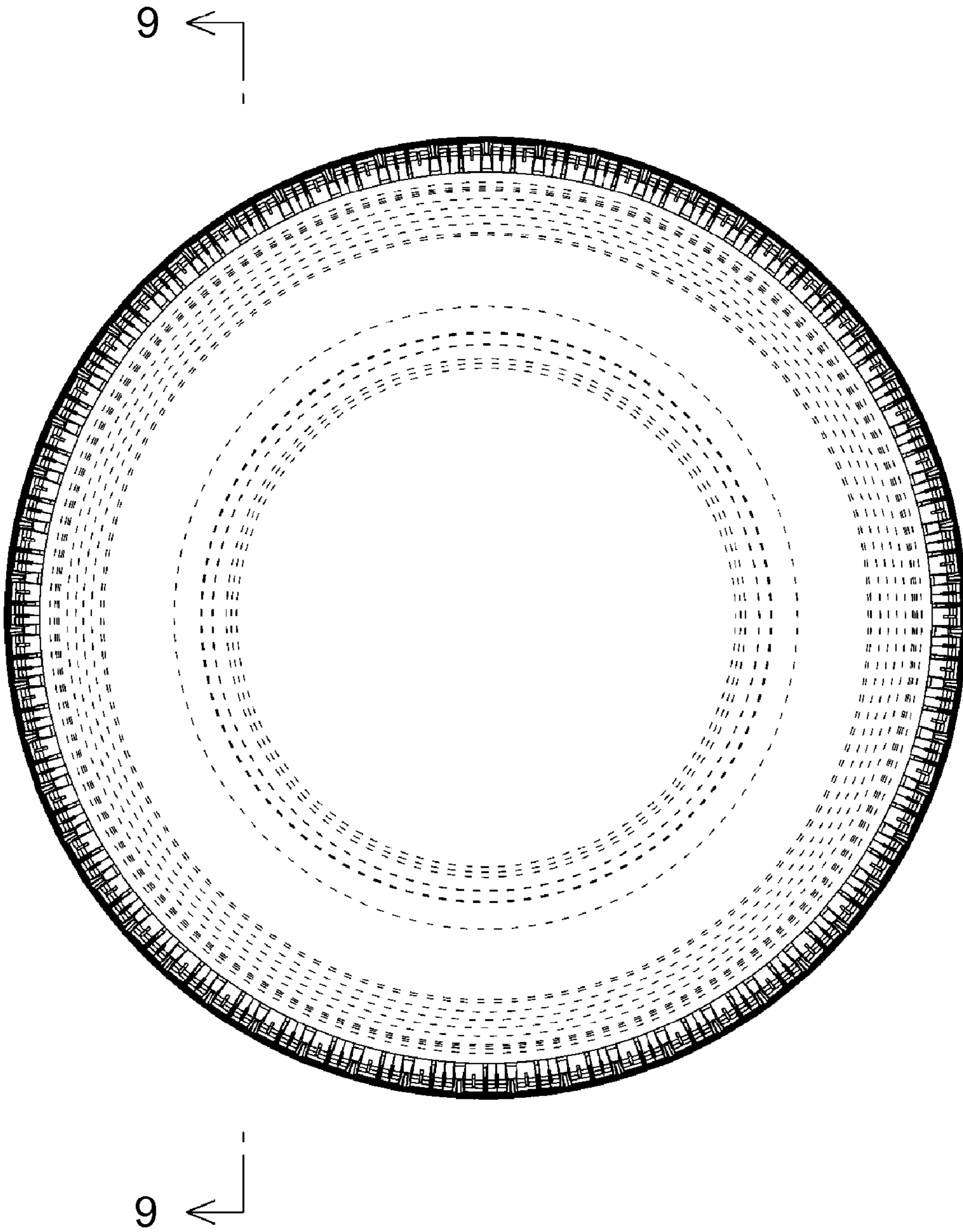

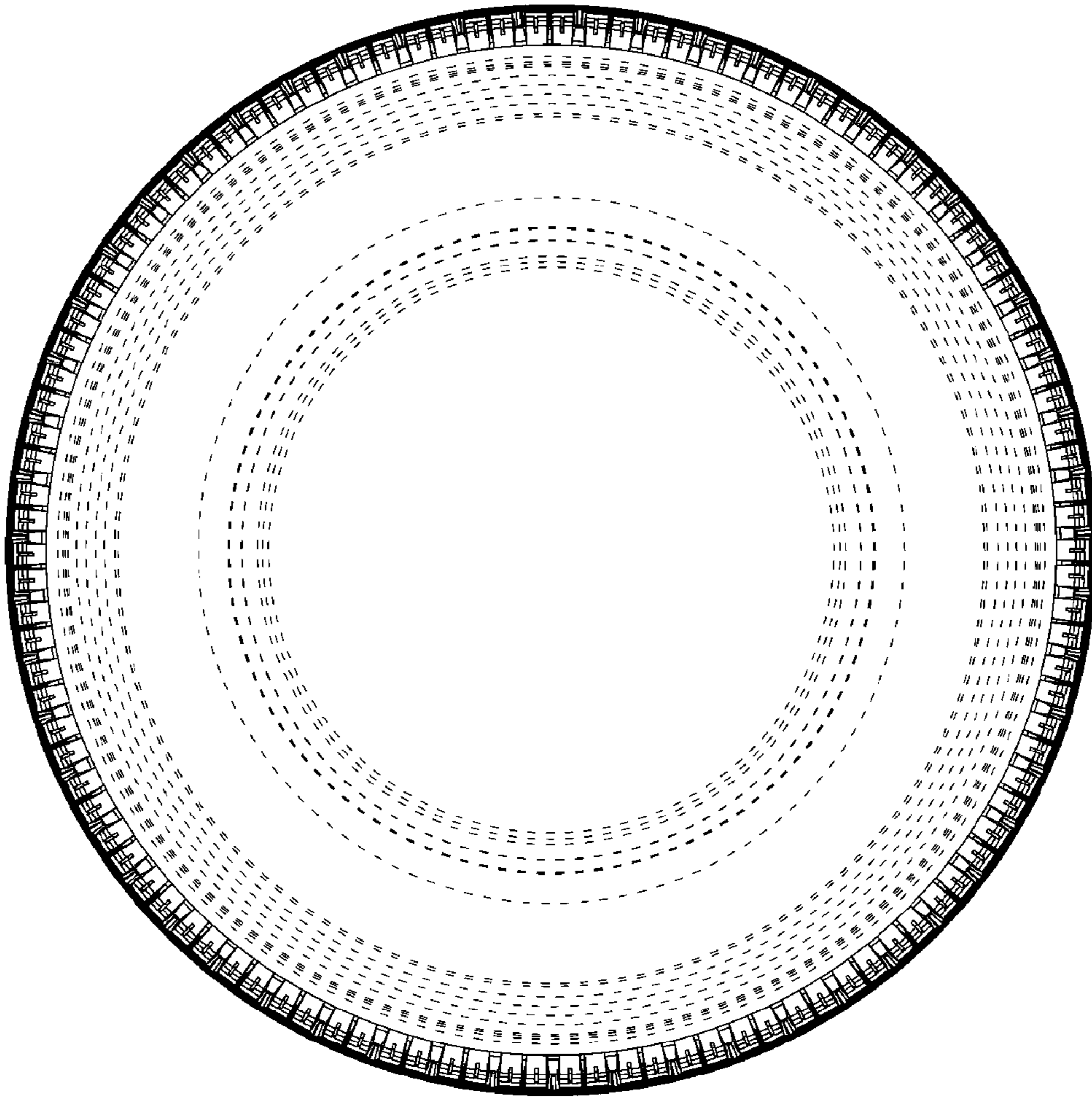

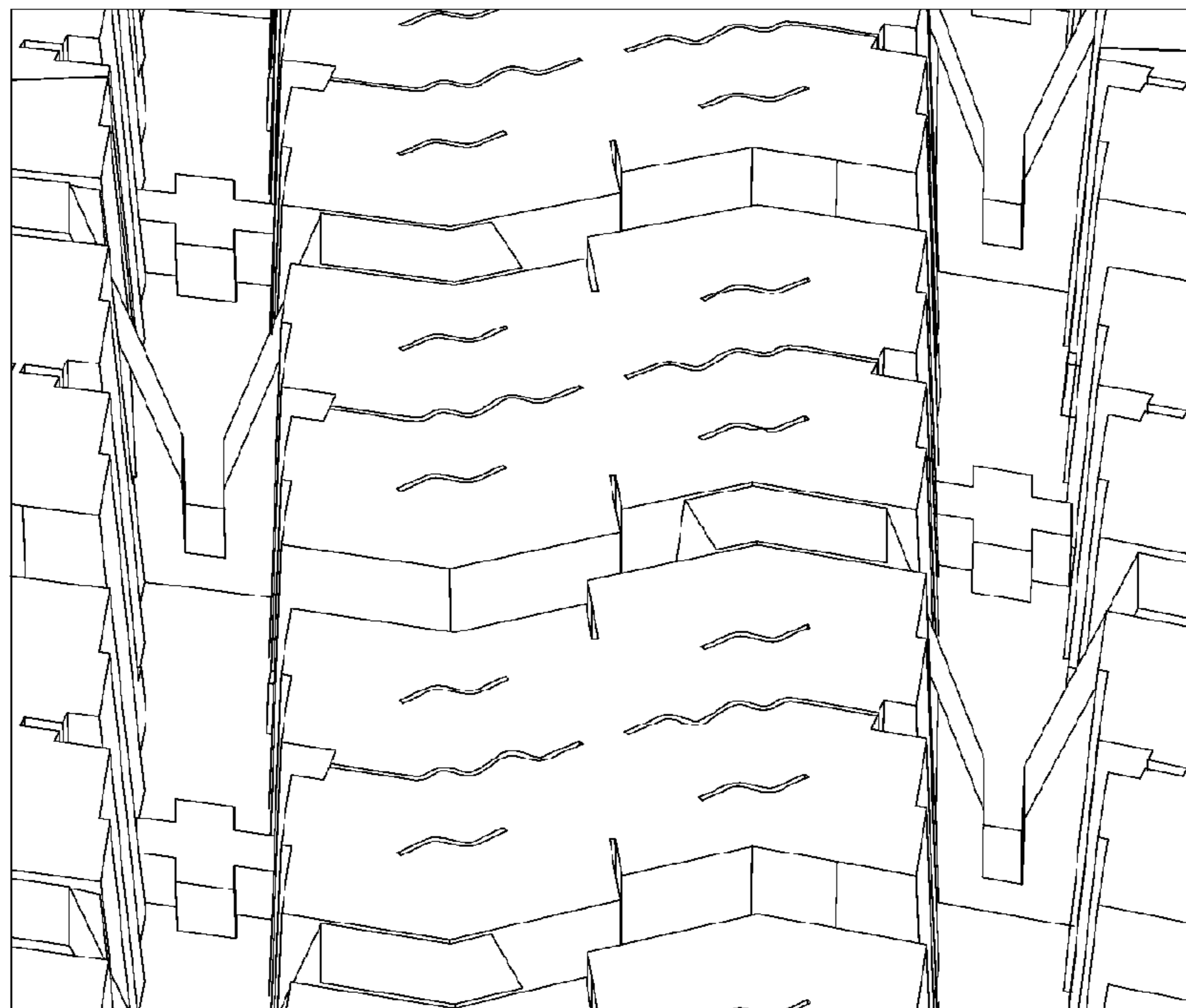

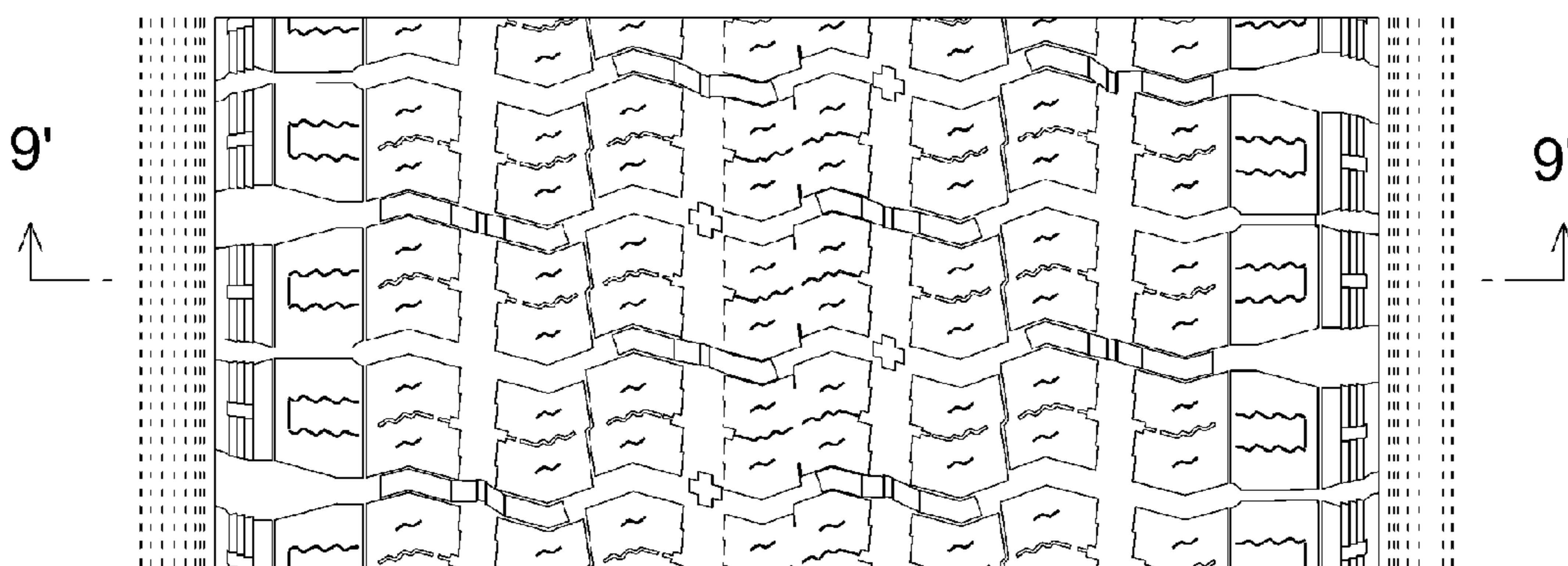

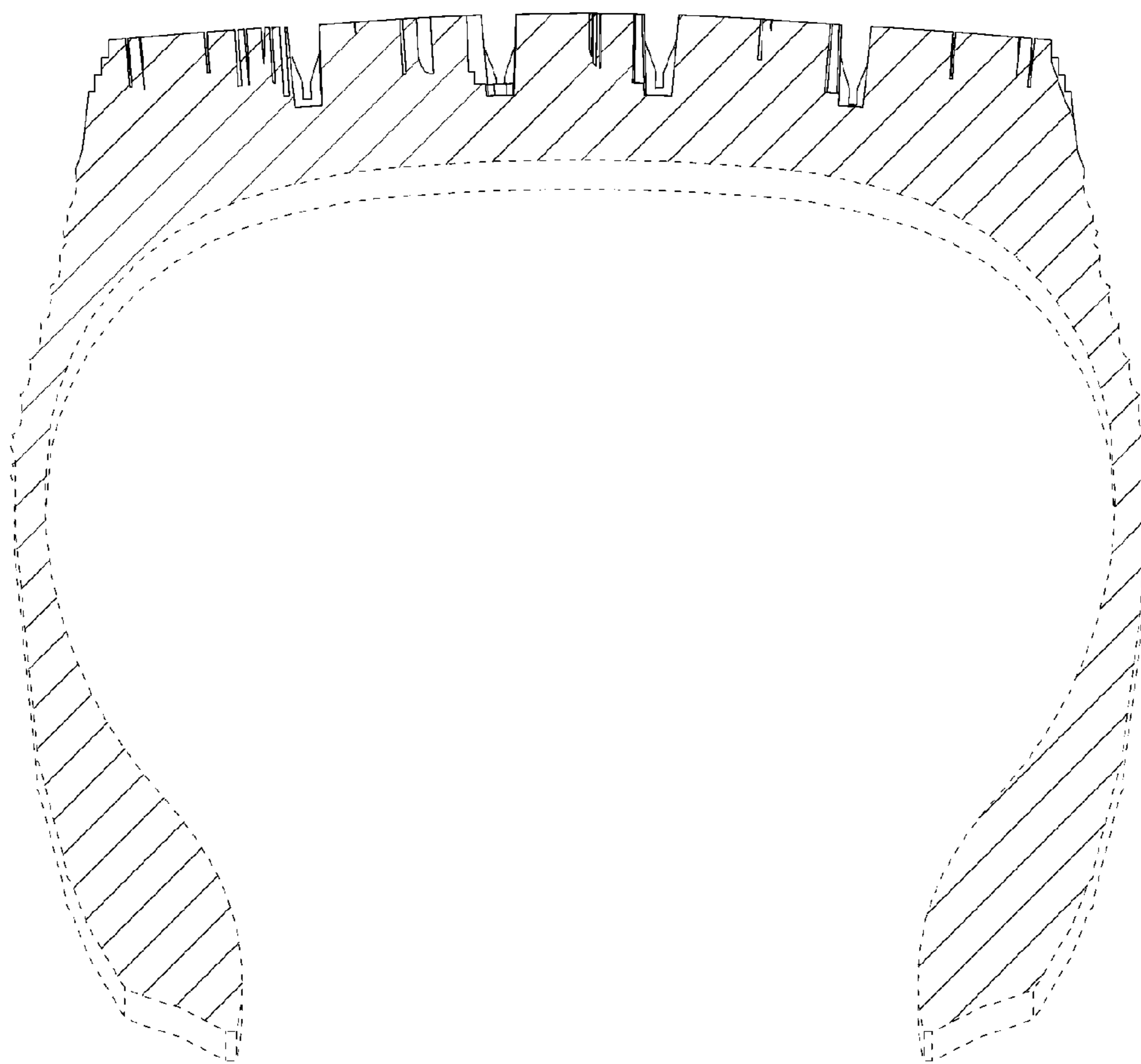
