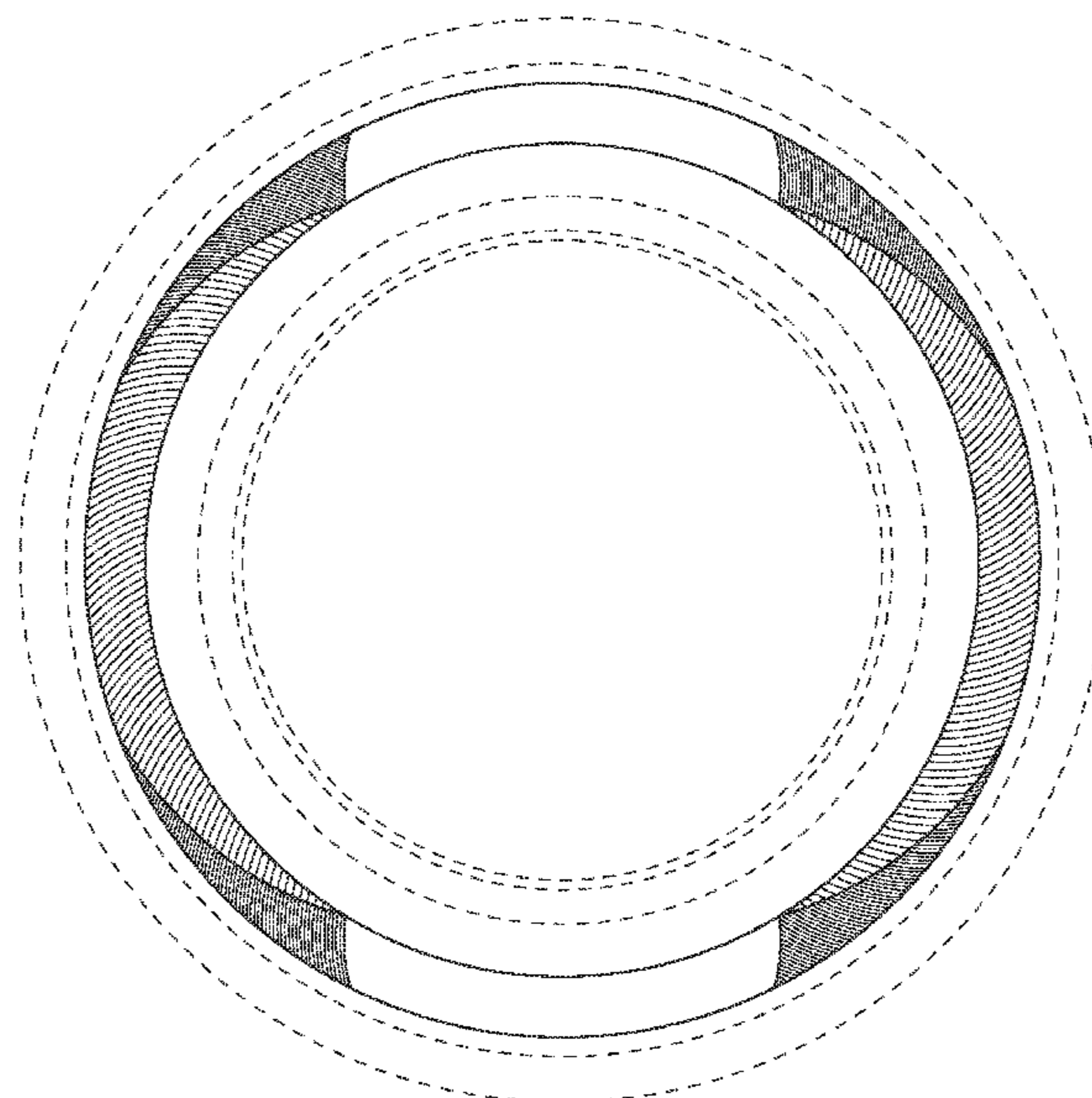
The ornamental design for a tire sidewall, as shown and described.
