(57) **CLAIM**

We claim the ornamental design for a substrate for light
source of light emitting diode, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a substrate for light
source of light emitting diode of the present invention;
FIG. 2 is a front view thereof;
FIG. 3 is a rear view thereof;
FIG. 4 is a first side view thereof;
FIG. 5 is a second side view thereof;
FIG. 6 is a top view thereof; and,
FIG. 7 is a bottom view thereof.

The broken line showing of substrate for light source of light
emitting diode is included for the purpose of illustrating envi-
ronment and forms no part of the claimed design. Addition-
ally, the unevenly broken lines in the drawings define the
limits of the claimed design.

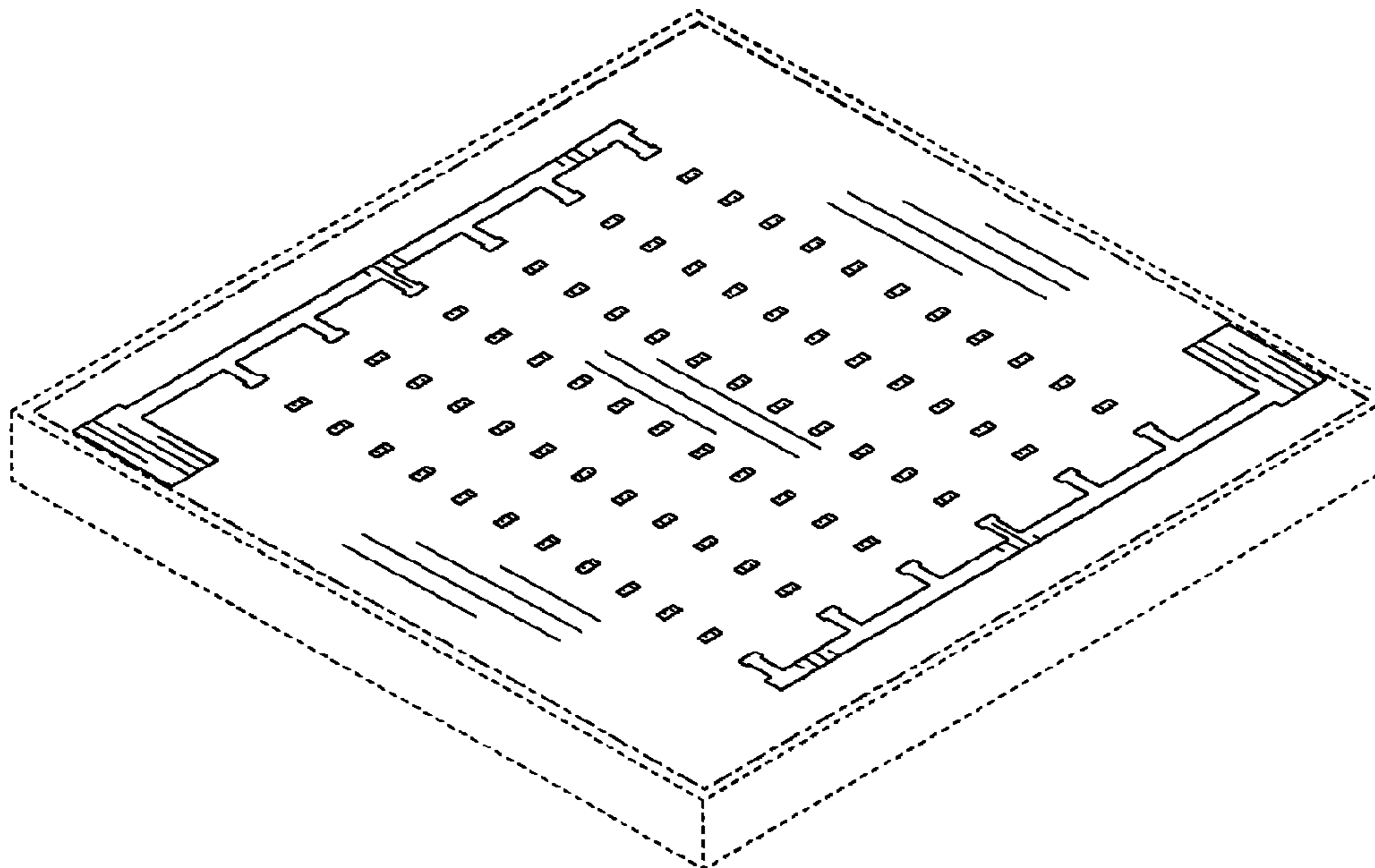

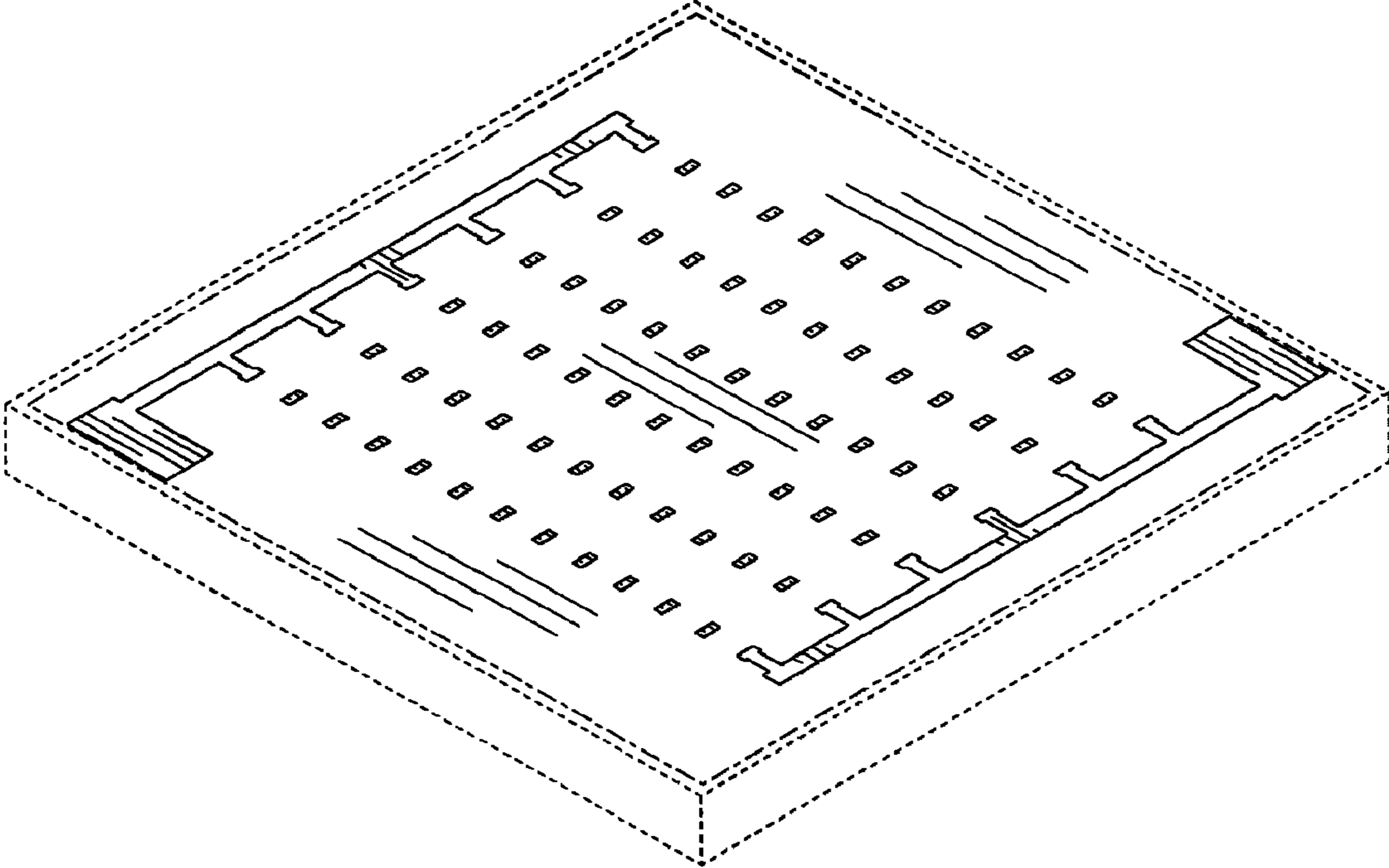

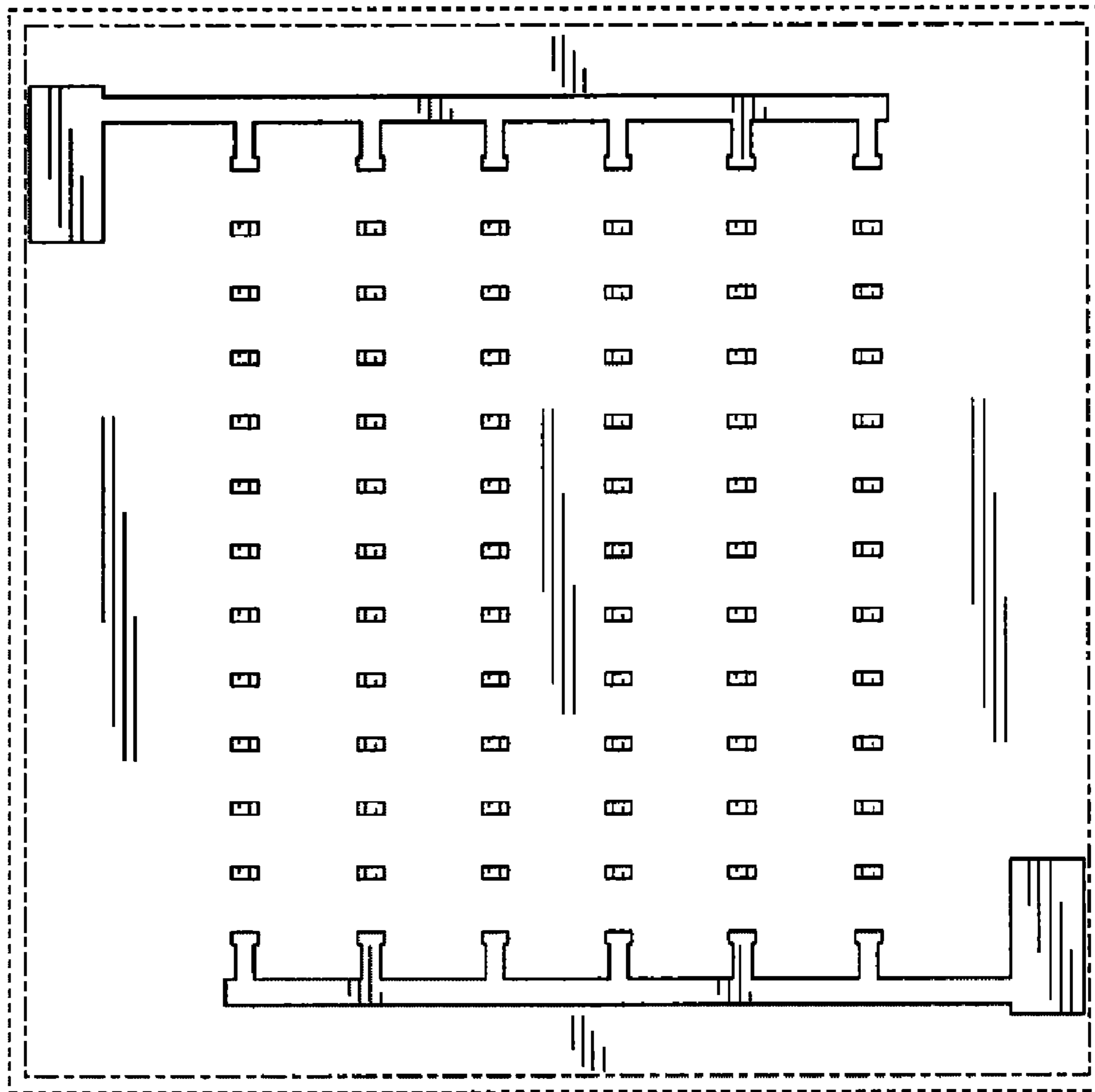

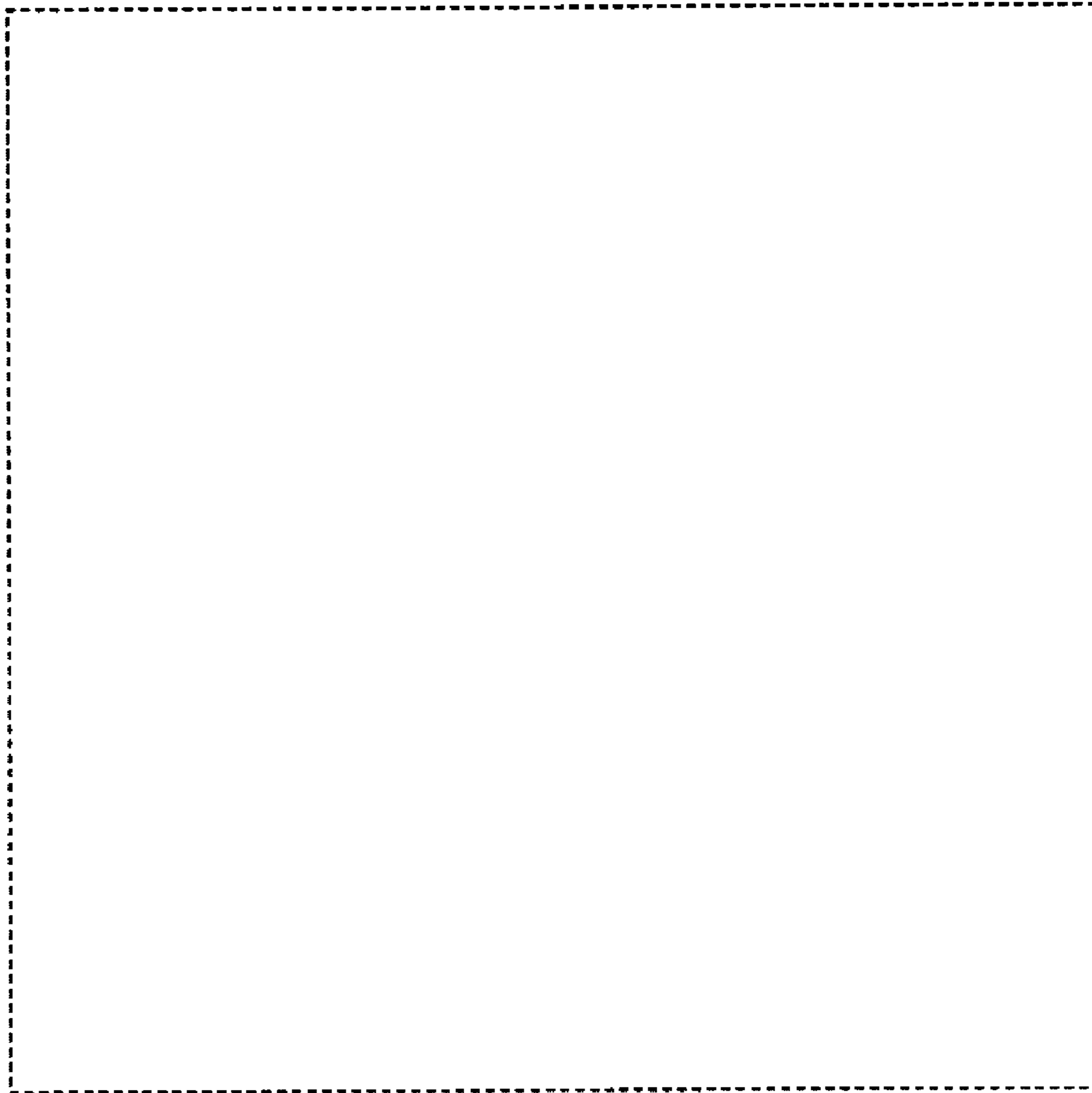

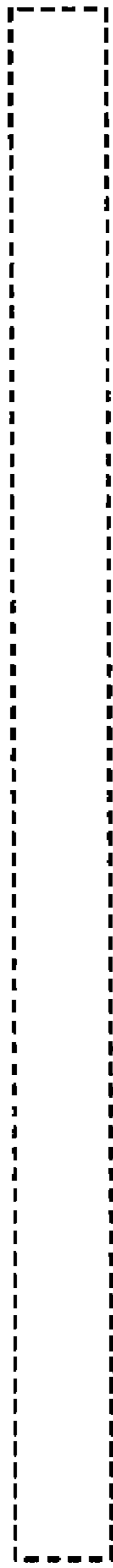

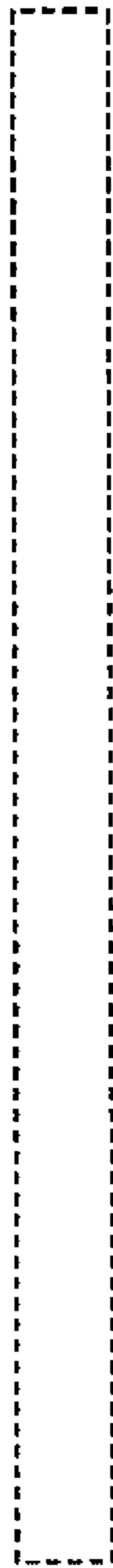
