DESCRIPTION

FIG. 1 is a front, top and right side perspective view of a digital video camera showing our new design;
 FIG. 2 is a rear, top, left-side perspective view thereof with a monitor opened;
 FIG. 3 is a front elevation view thereof;
 FIG. 4 is a rear elevation view thereof;
 FIG. 5 is a top plan view thereof;

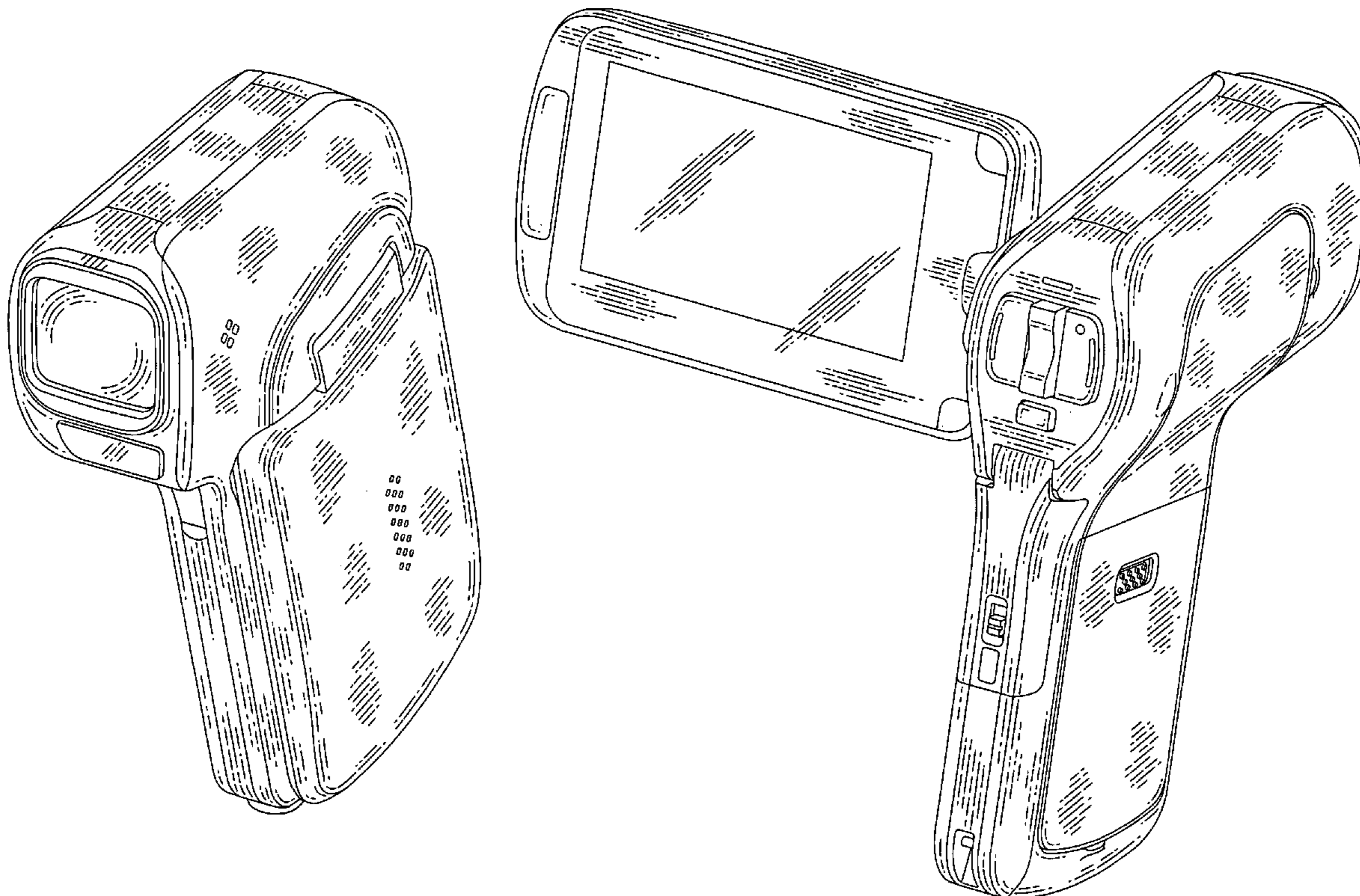

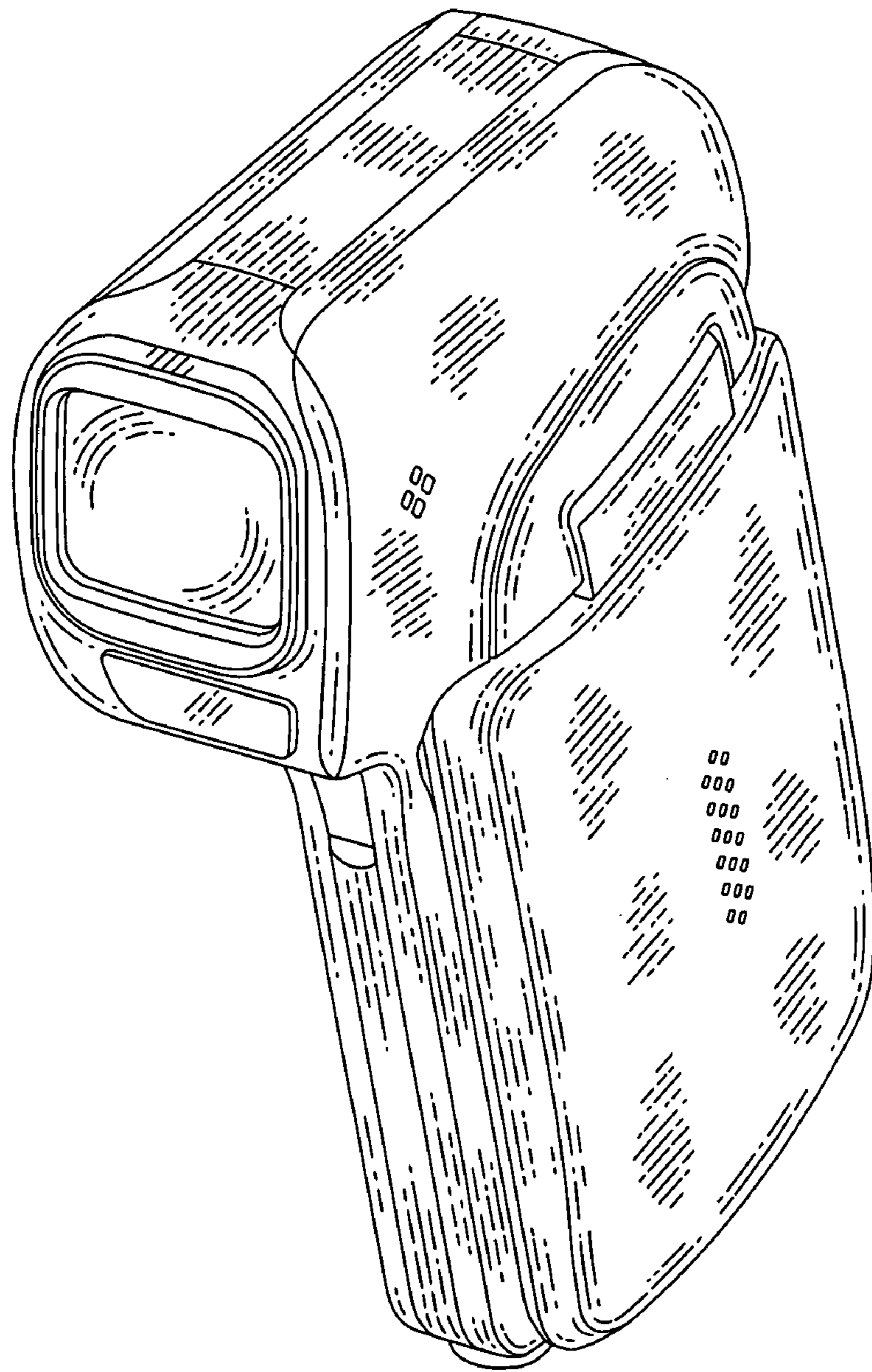

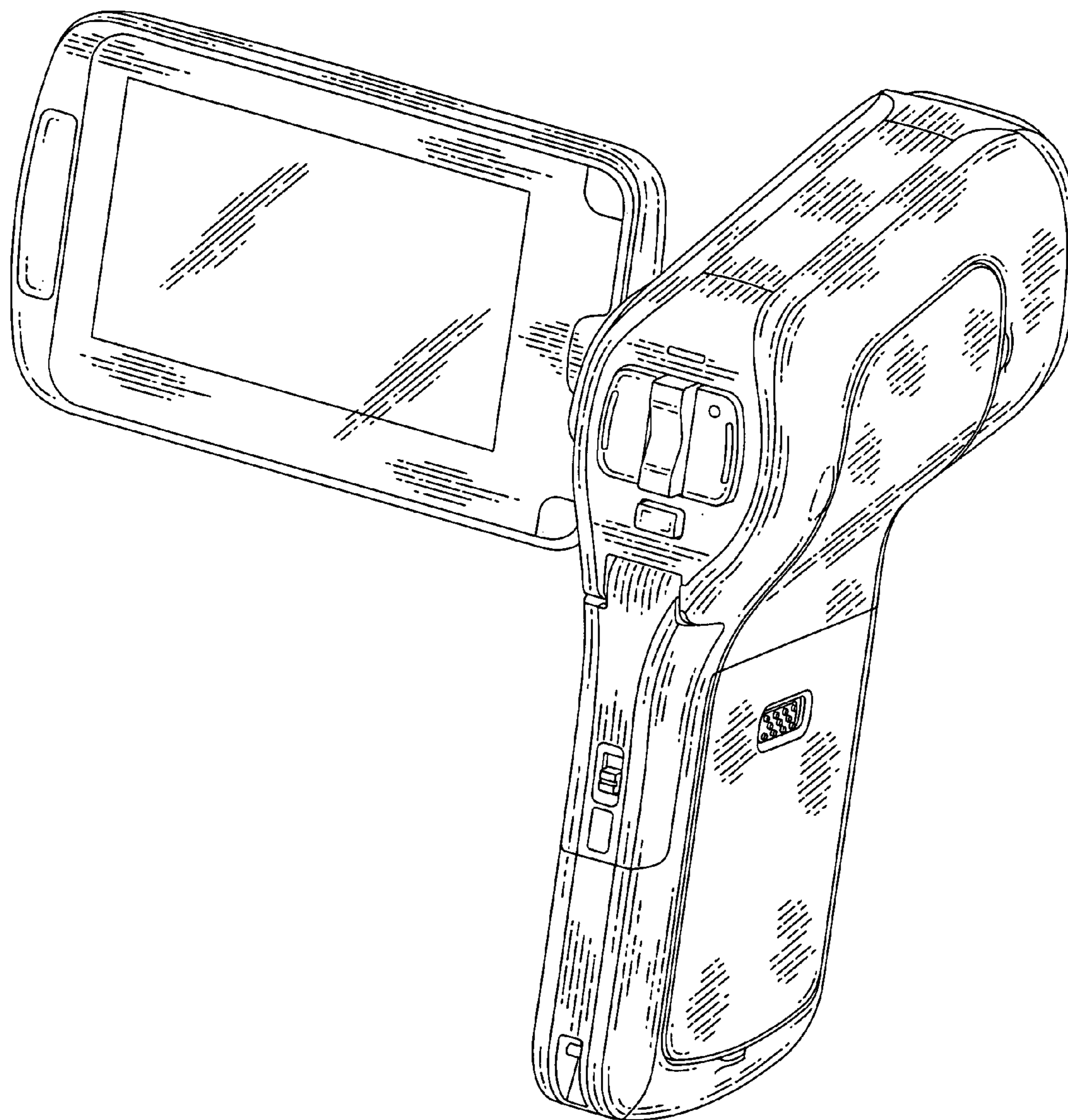

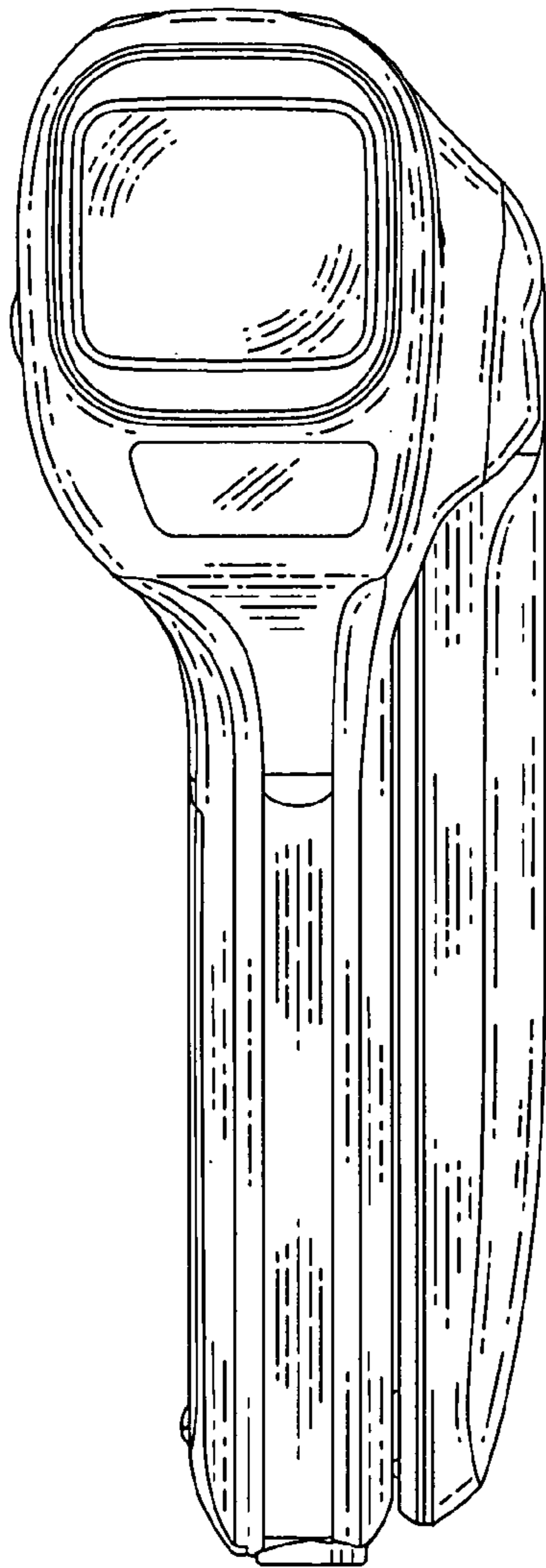

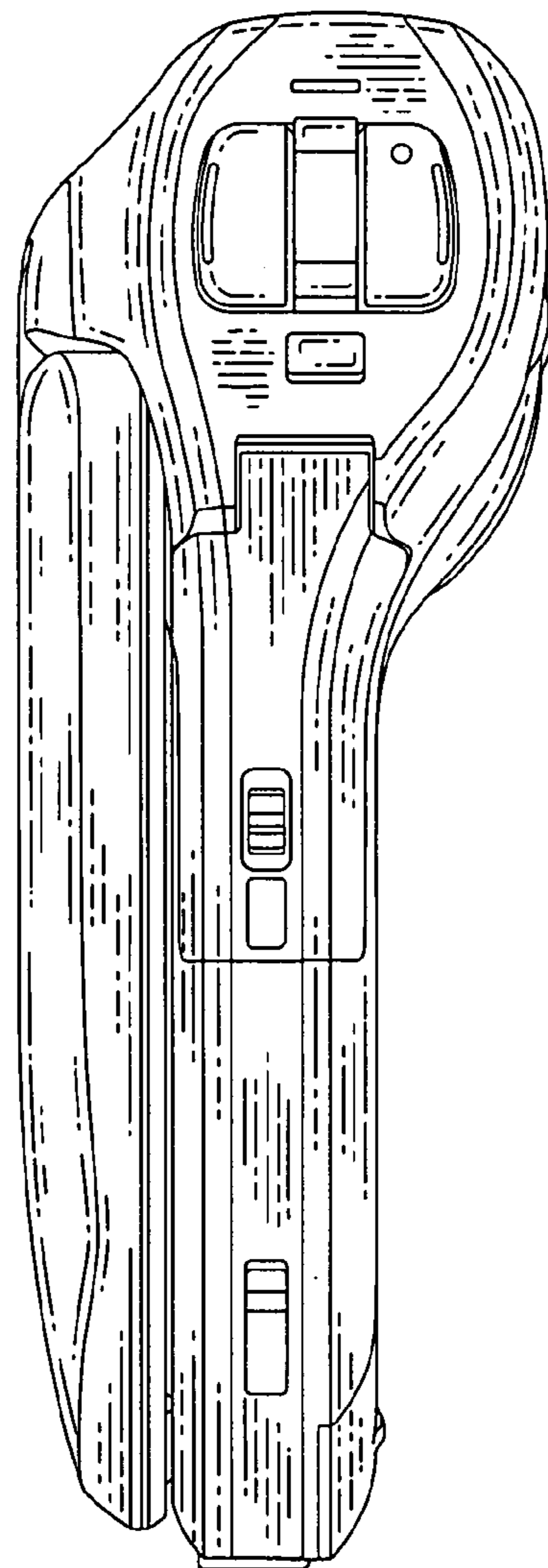

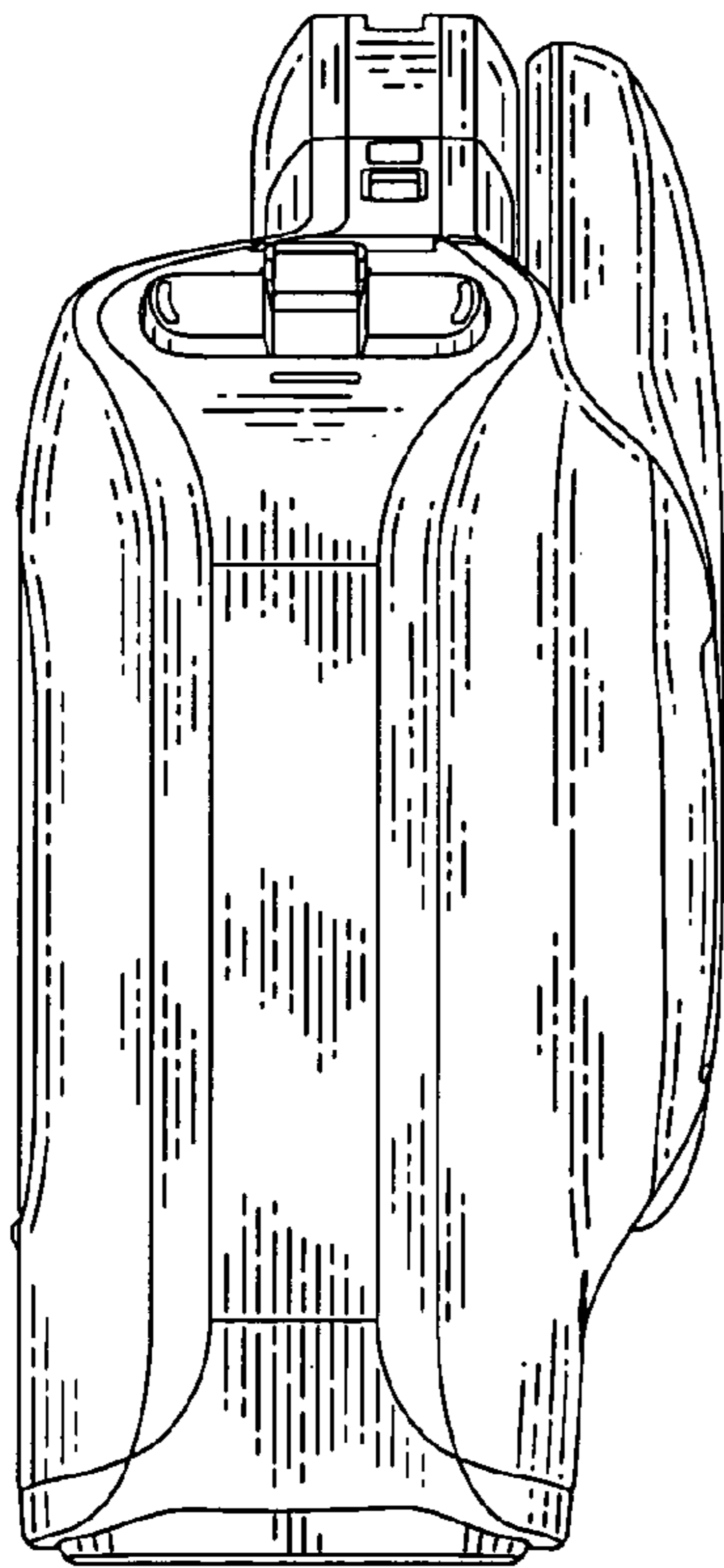

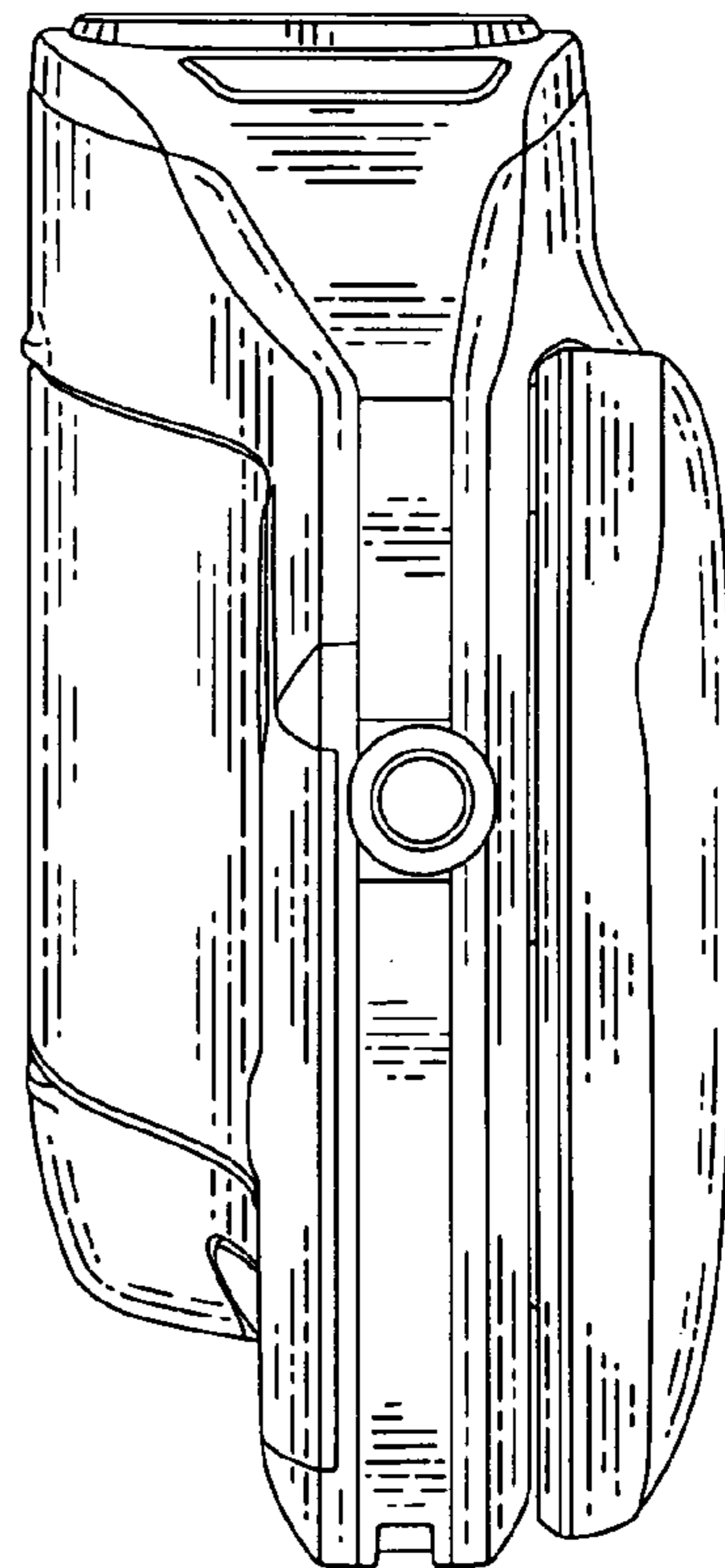

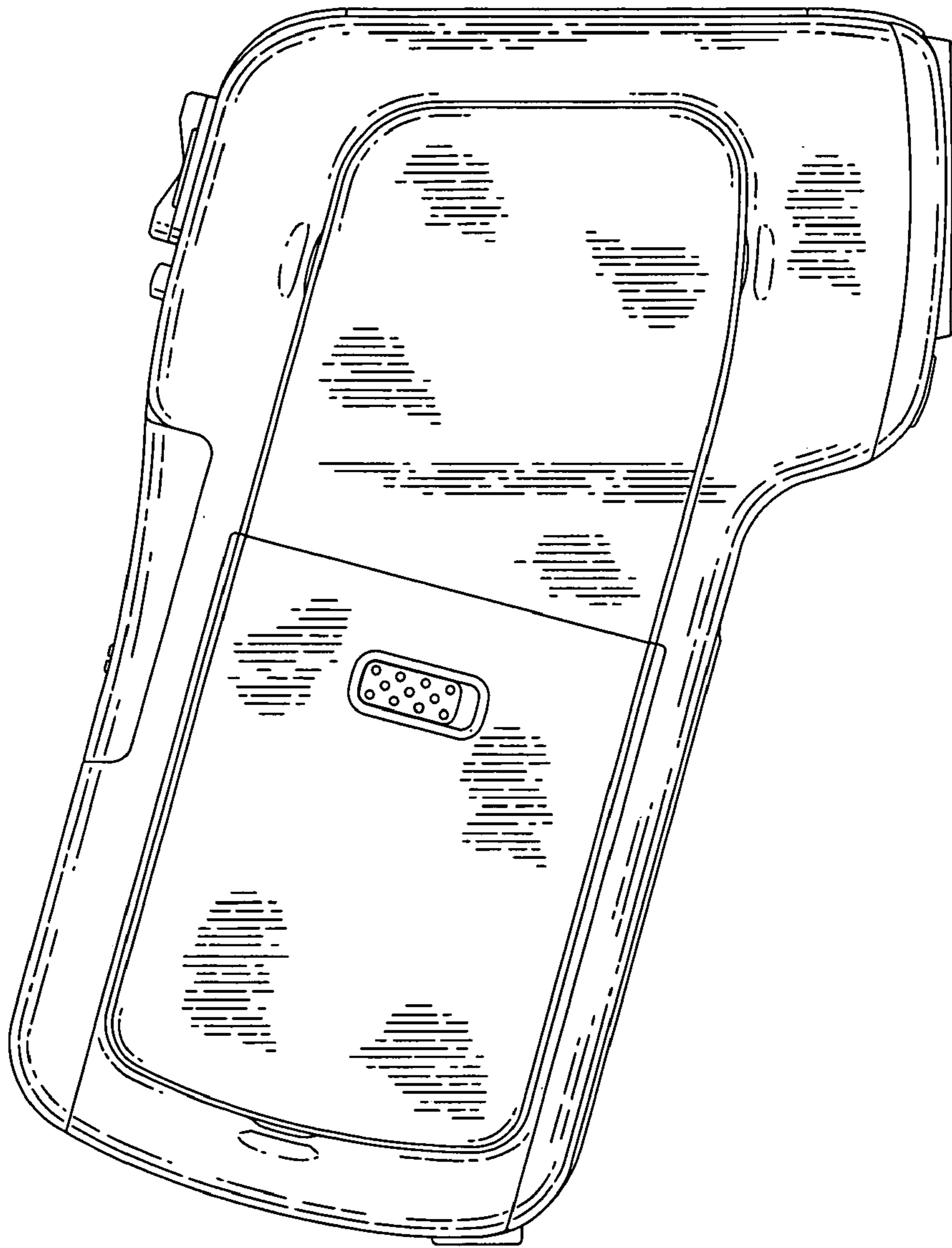
