(57) **CLAIM**

The ornamental design of a finger manipulated game, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a finger manipulated game showing my new design, shown in an open position with one flap unfolded to the left side of the figure;

FIG. 2 is a perspective view thereof, wherein an unfolded flap is shown at the top of the figure;

FIG. 3 is a left side elevation view thereof, wherein an unfolded flap is shown at the left side of the figure;

FIG. 4 is a front side elevation view thereof, wherein an unfolded flap is shown at the back side of the figure;

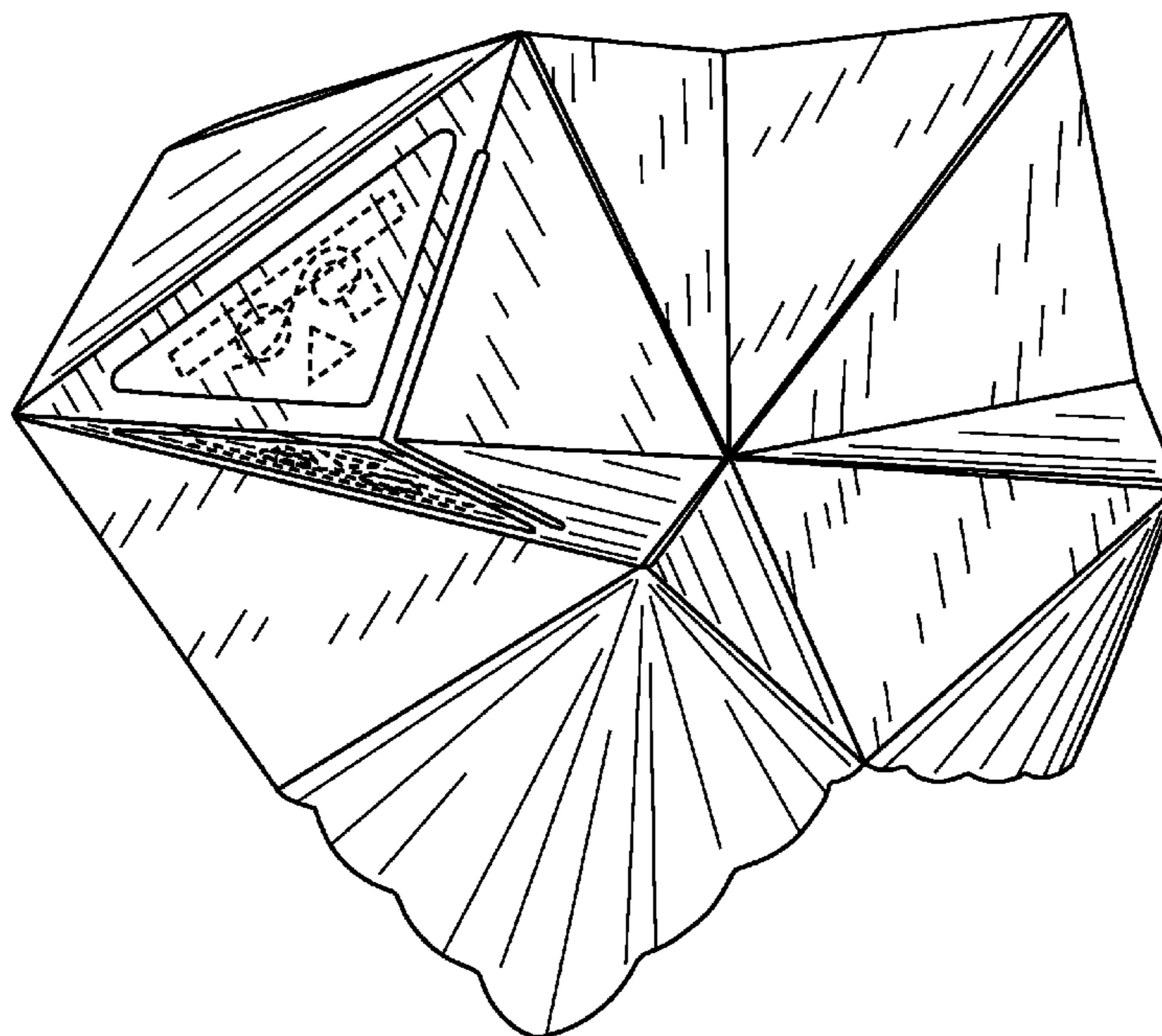
FIG. 5 is a rear elevation view thereof, wherein an unfolded flap is shown at the front side of the figure;

FIG. 6 is a top plan view thereof, wherein an unfolded flap is shown at the top of the figure; and,

FIG. 7 is a bottom plan view thereof, wherein an unfolded flap is shown at the bottom of the figure.

The broken lines showing the stickers are for illustrative purpose only and form no part of the claimed design.

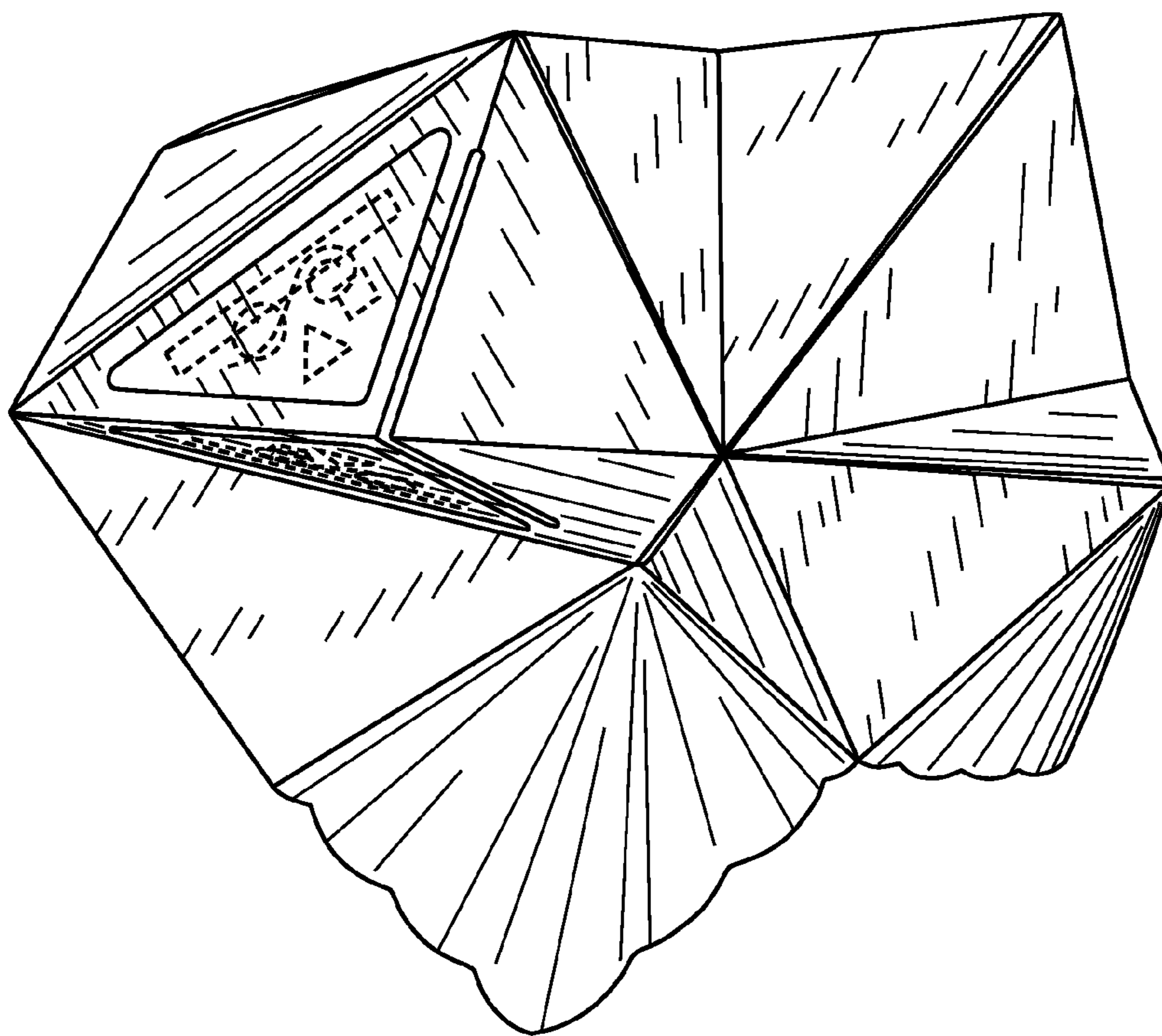

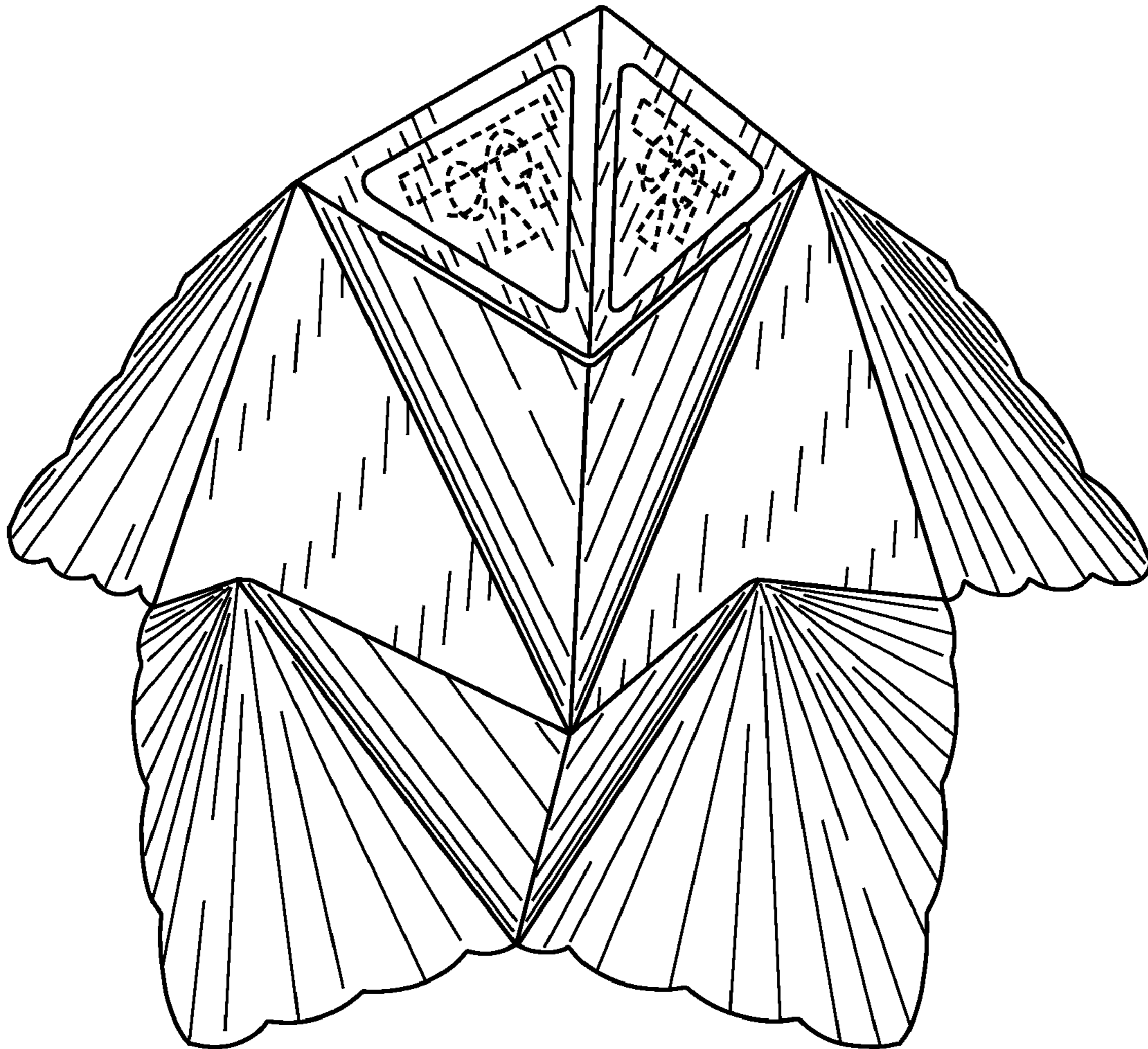

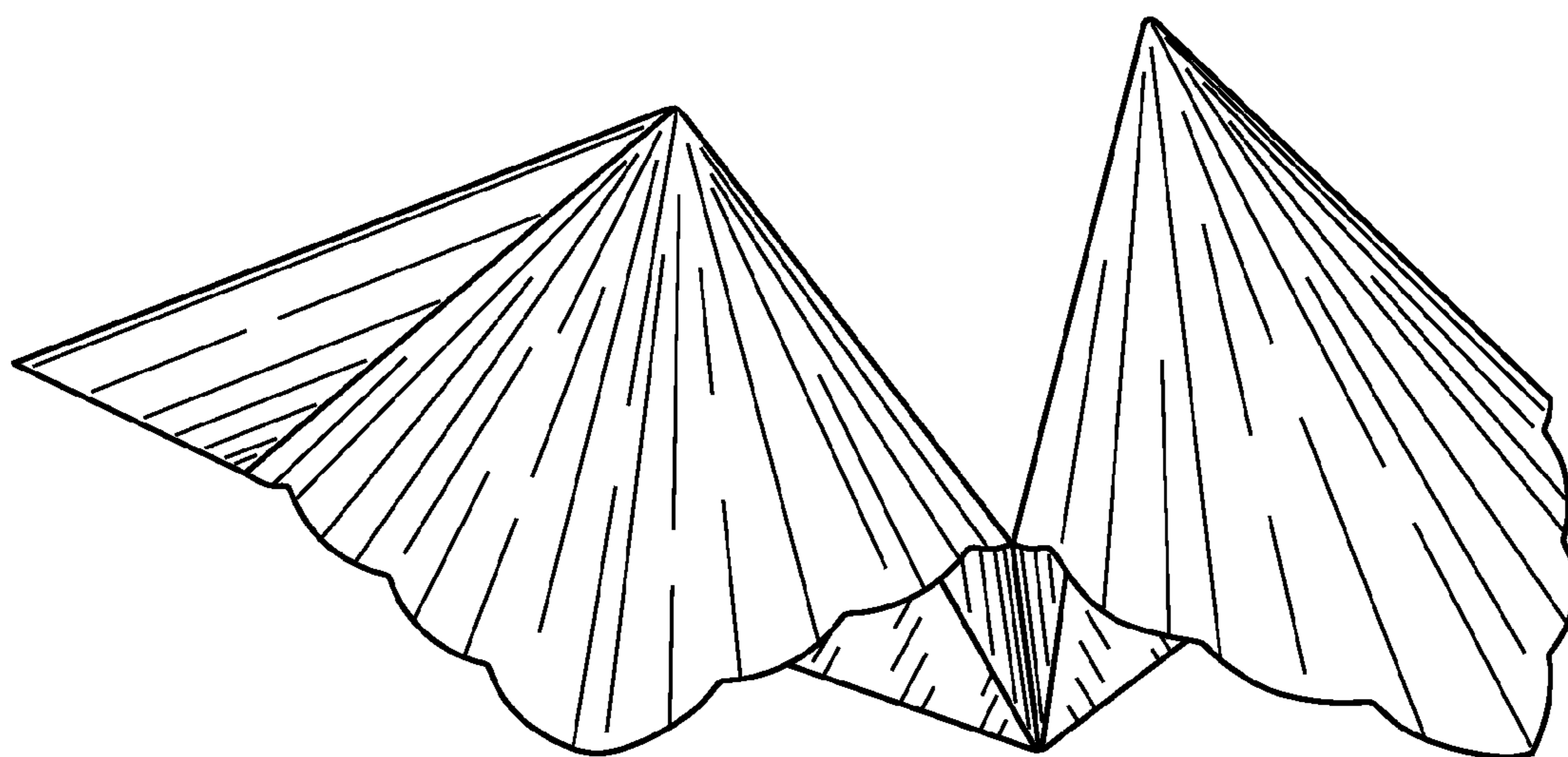

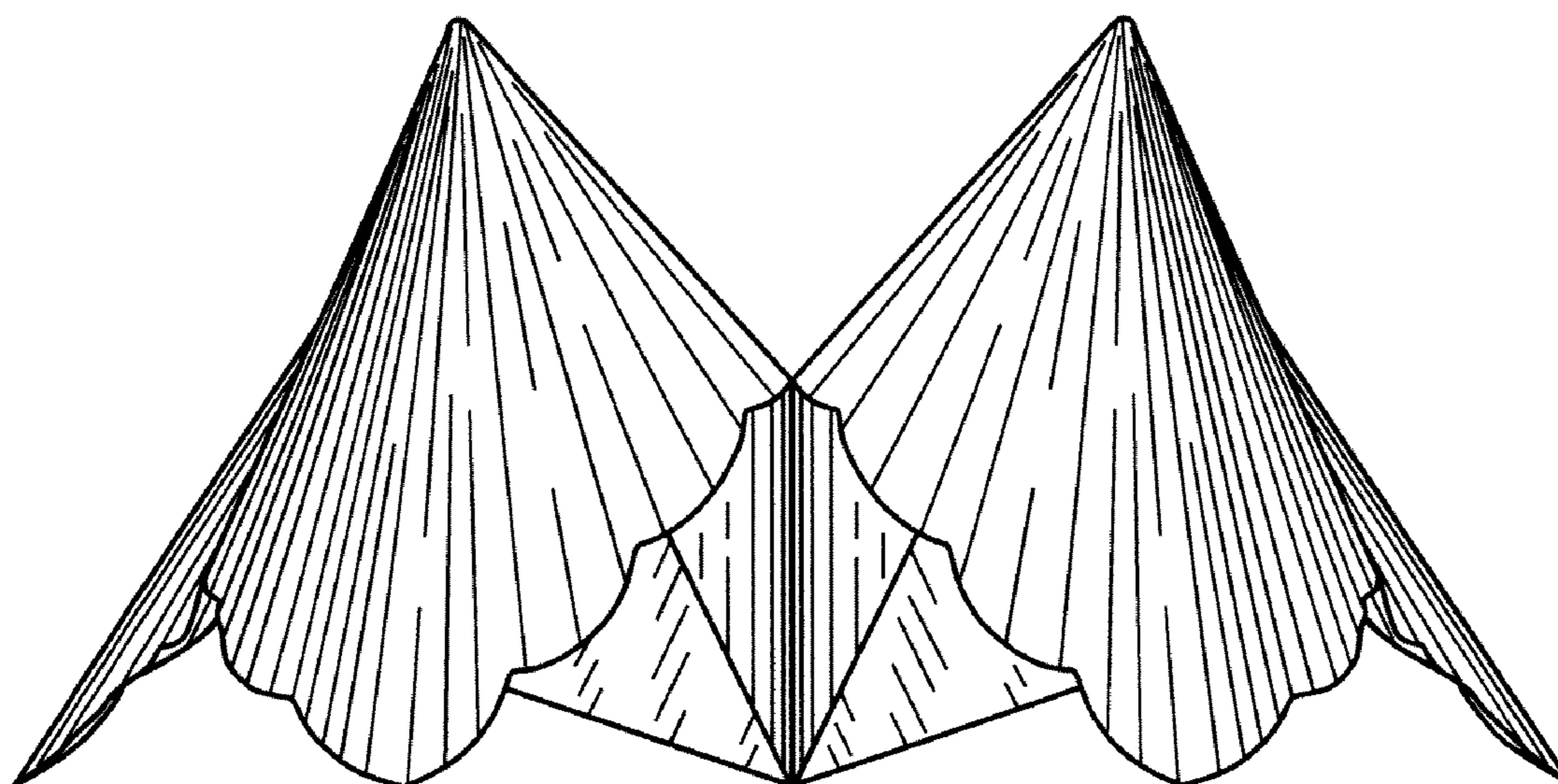

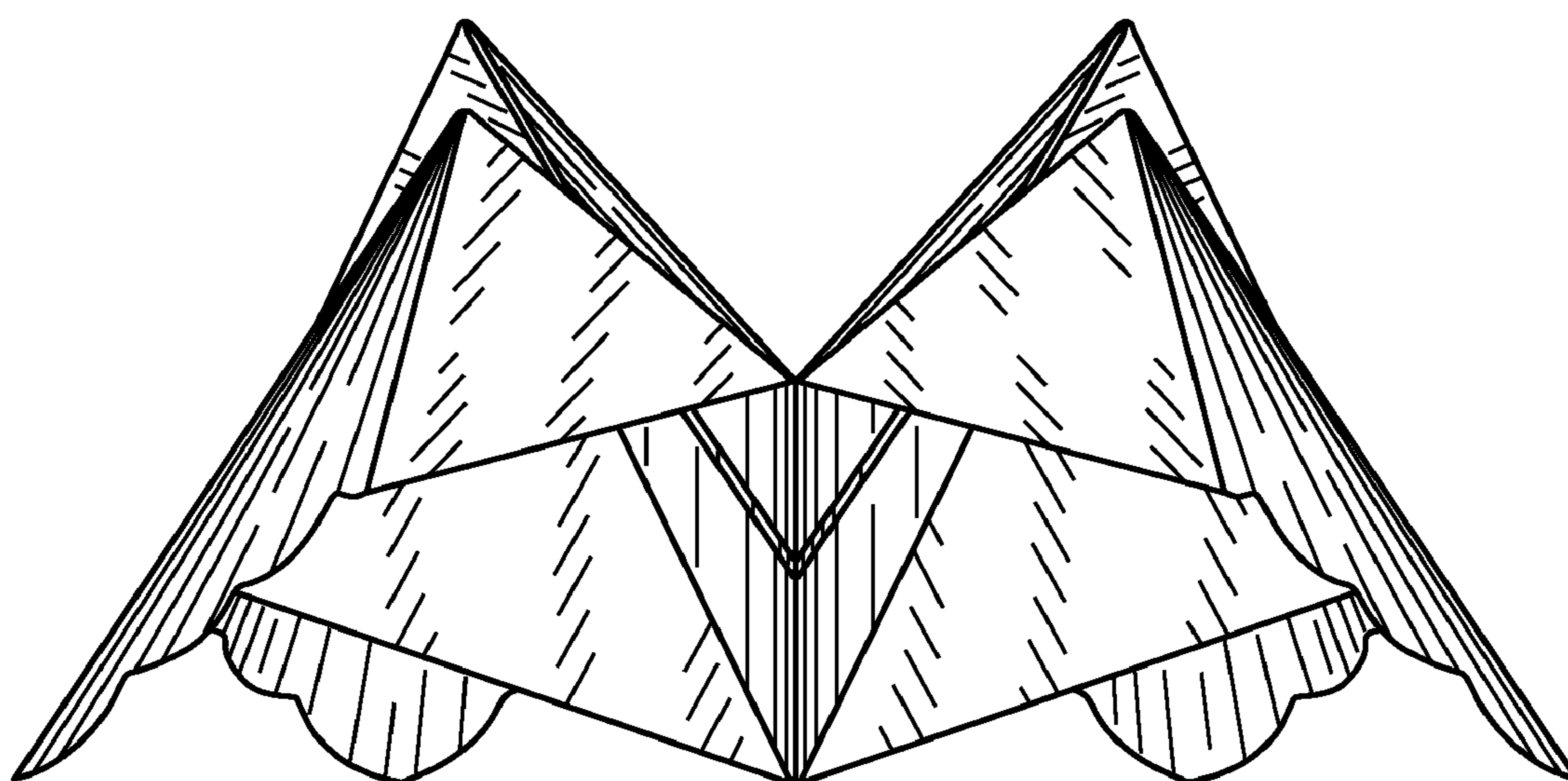

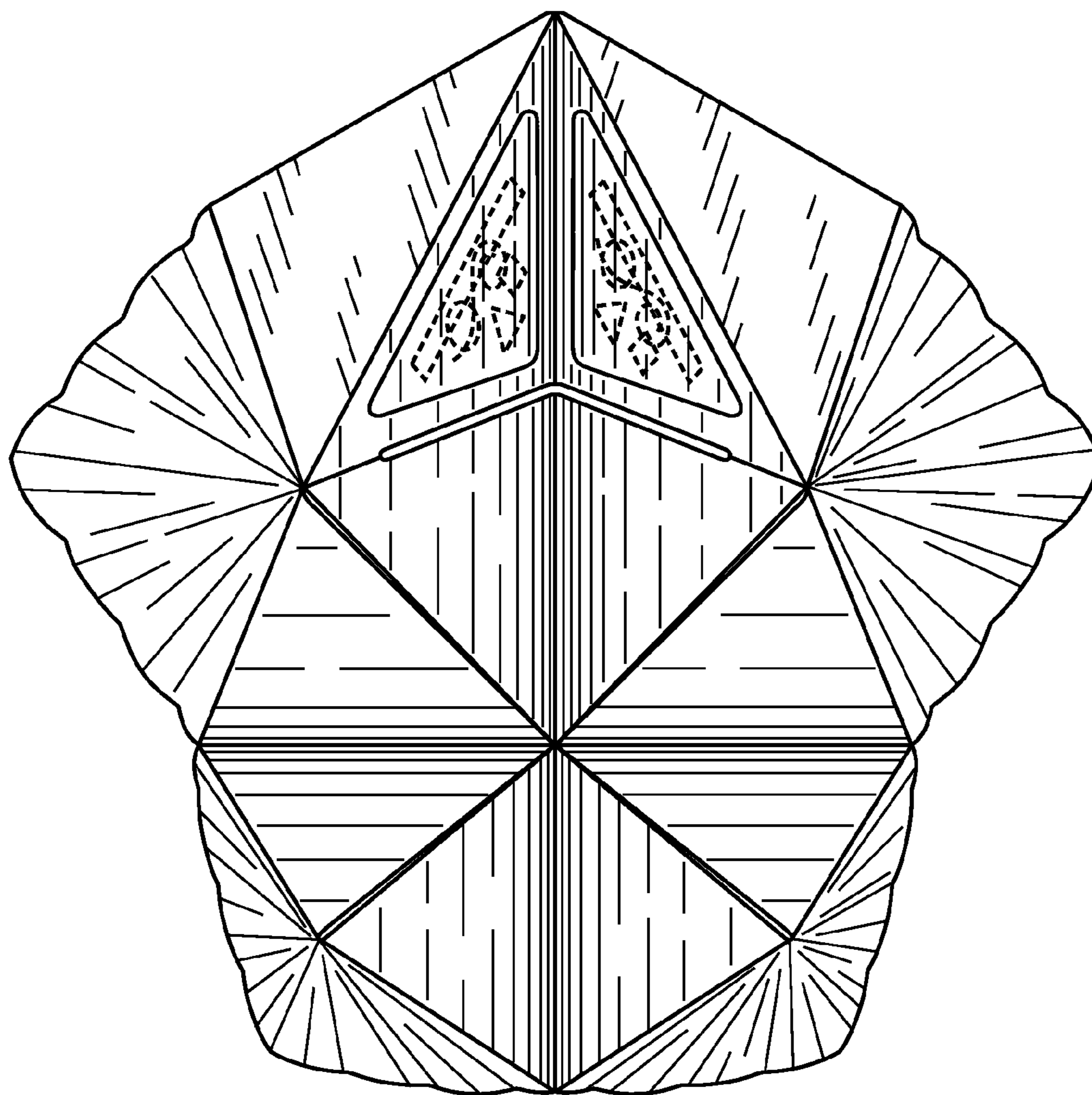

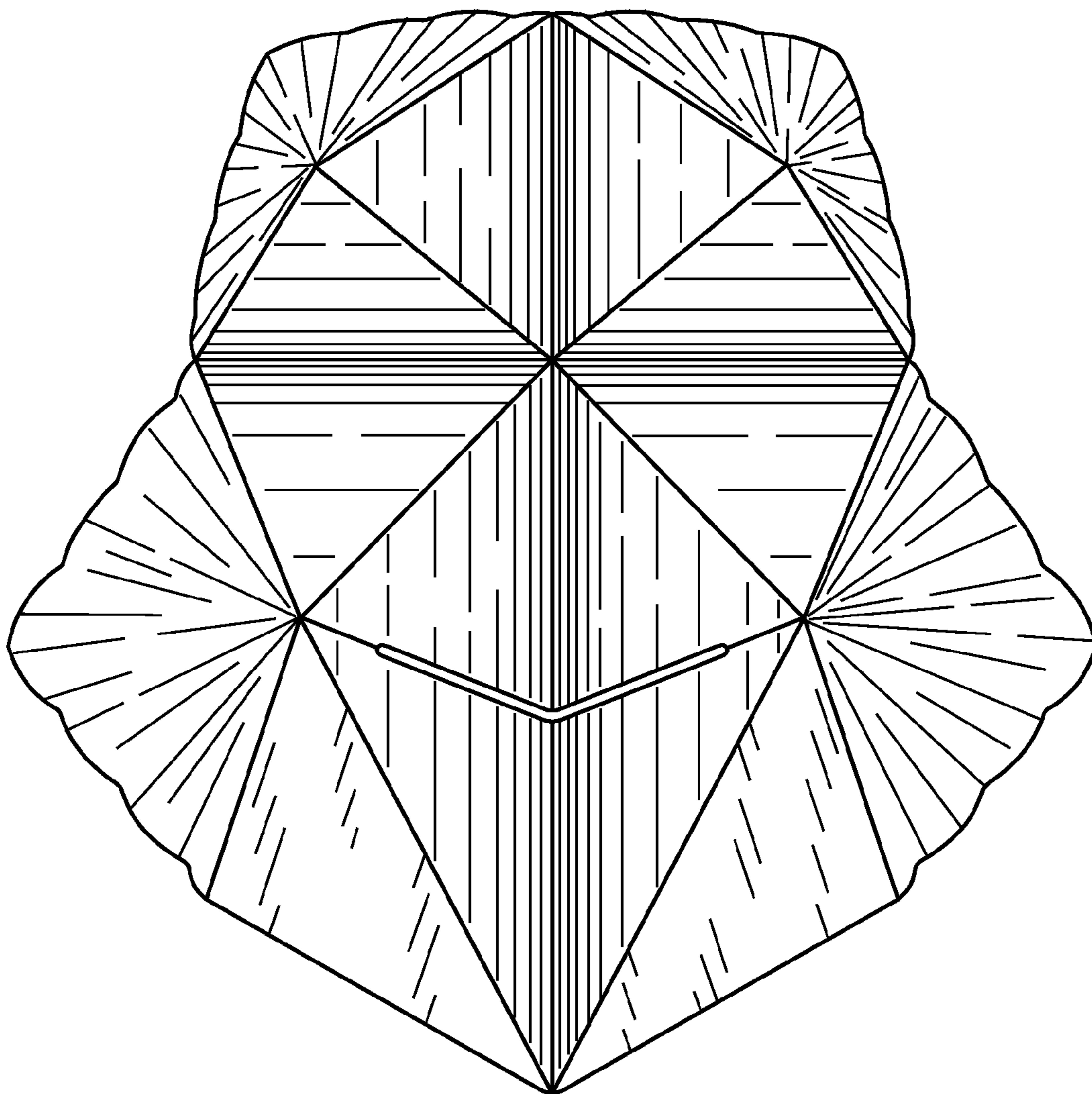
