(57) **CLAIM**

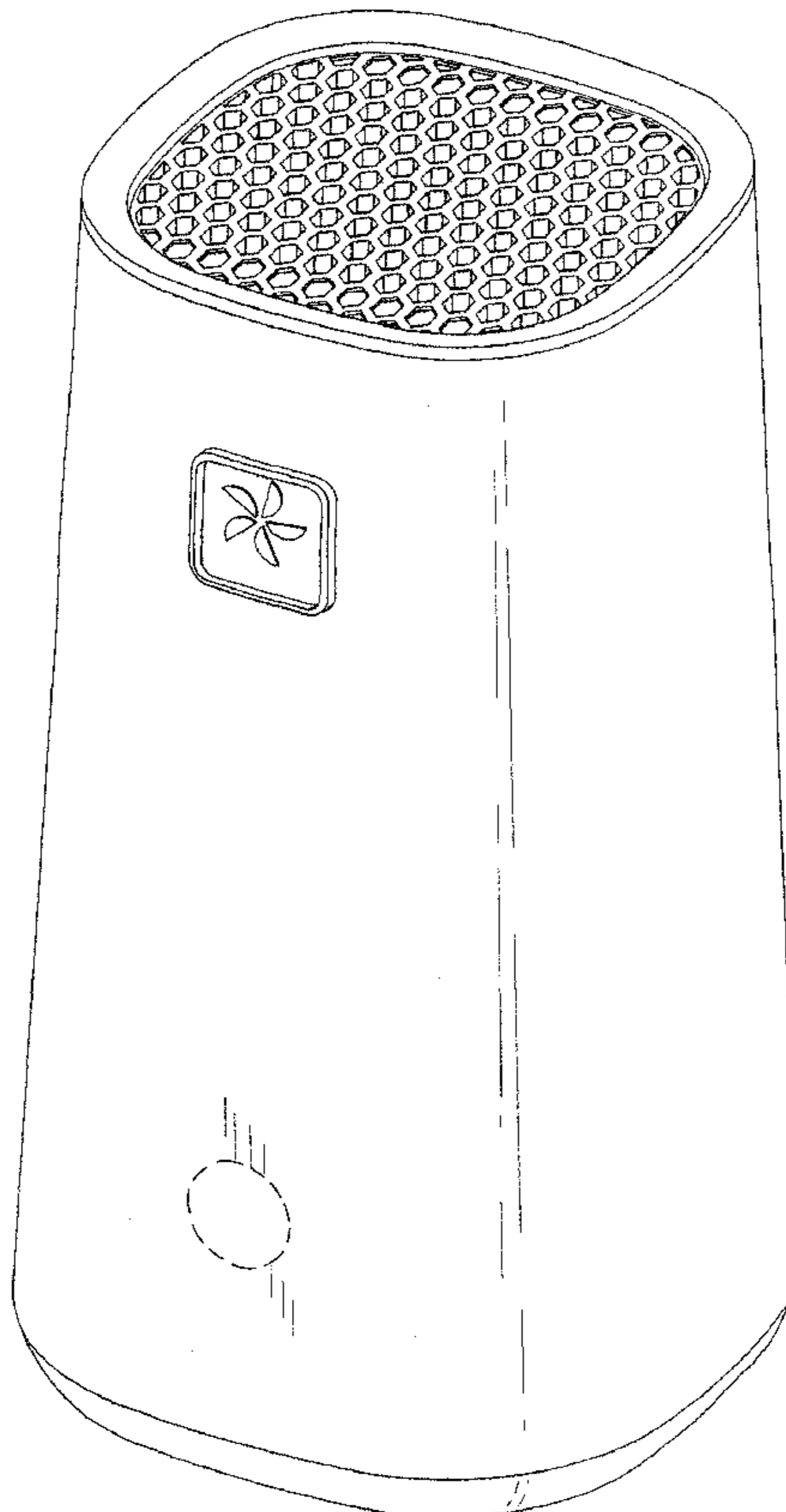
I claim the ornamental design for an air sterilizer, as shown

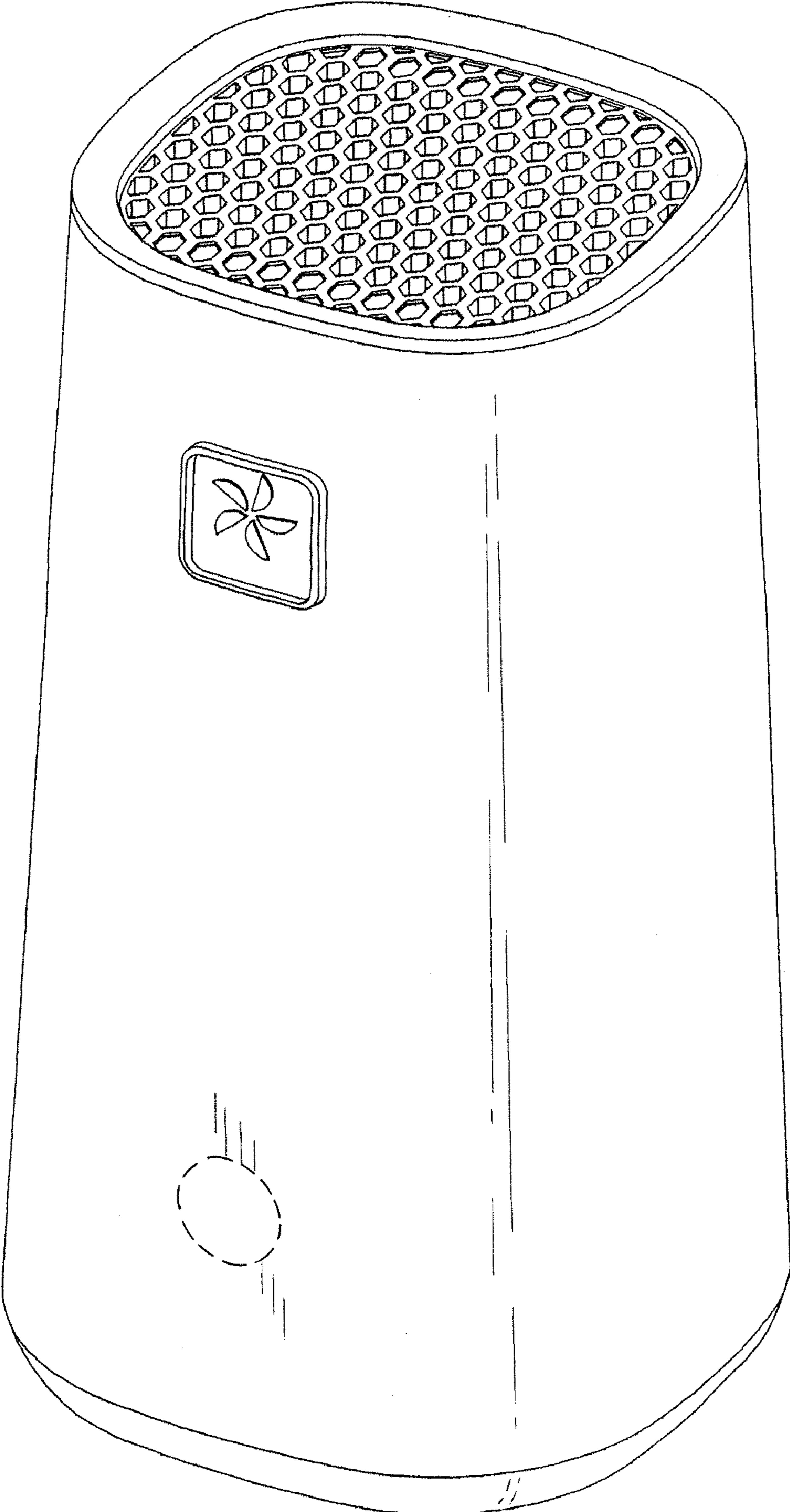

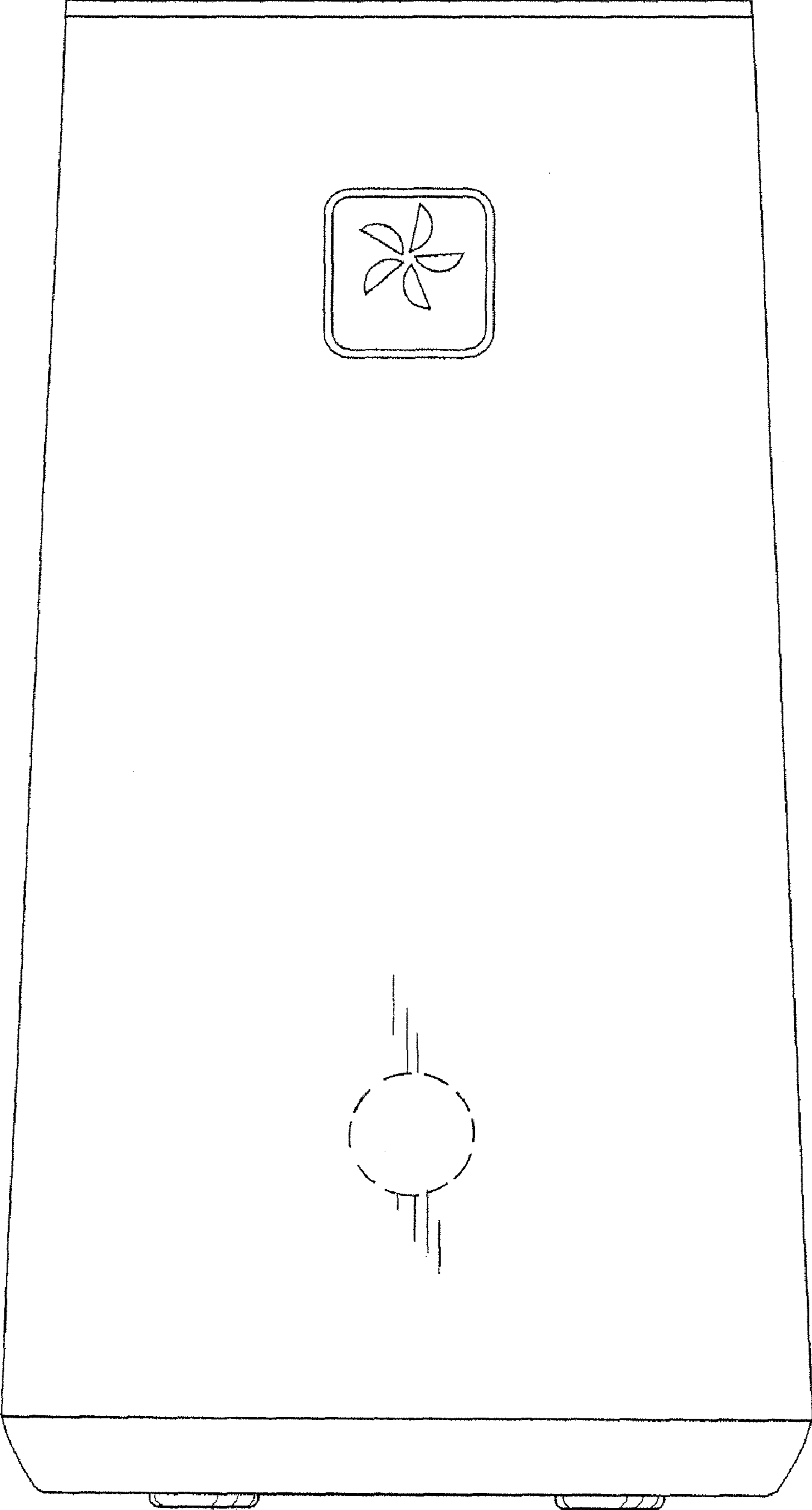

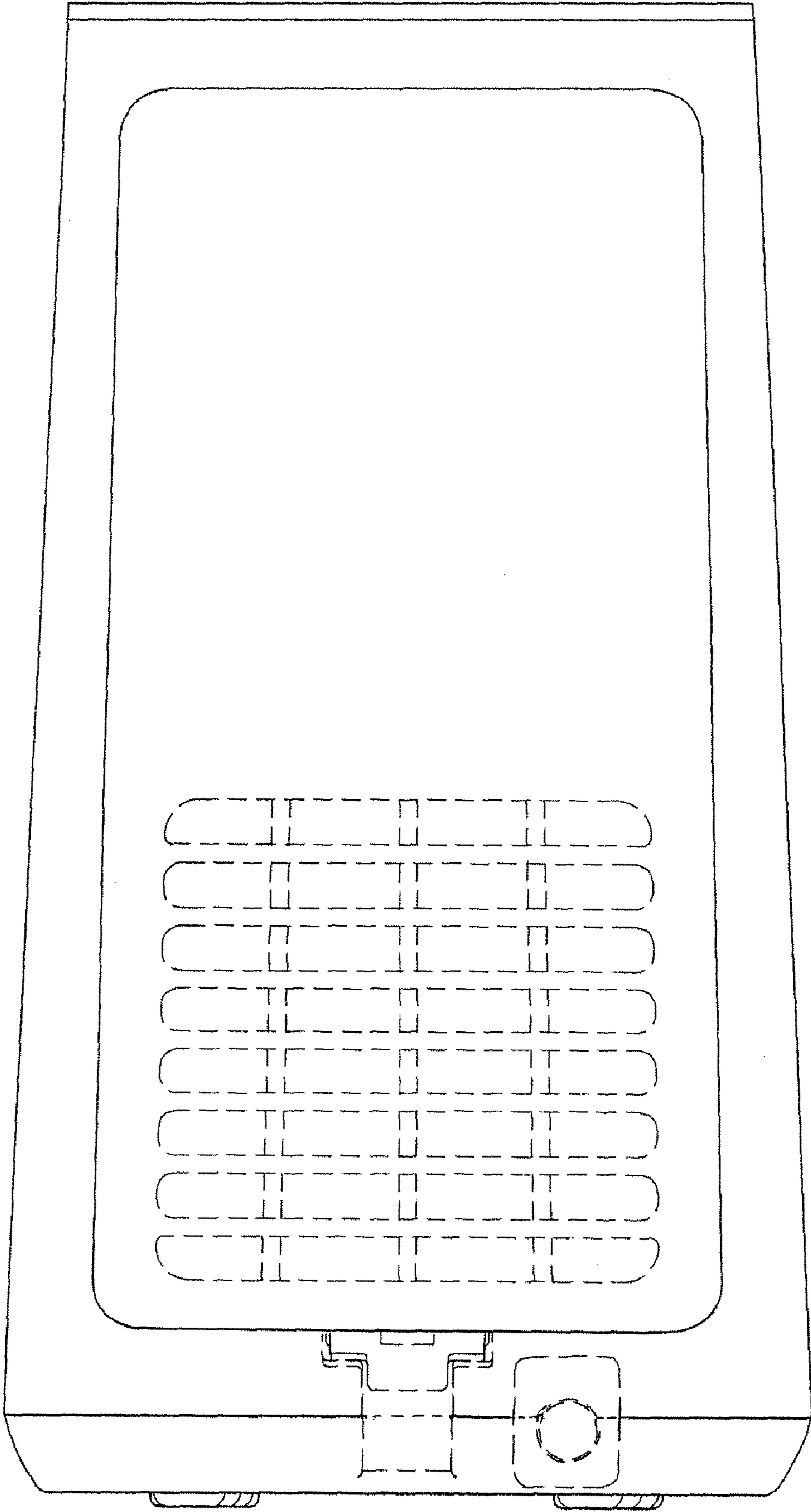

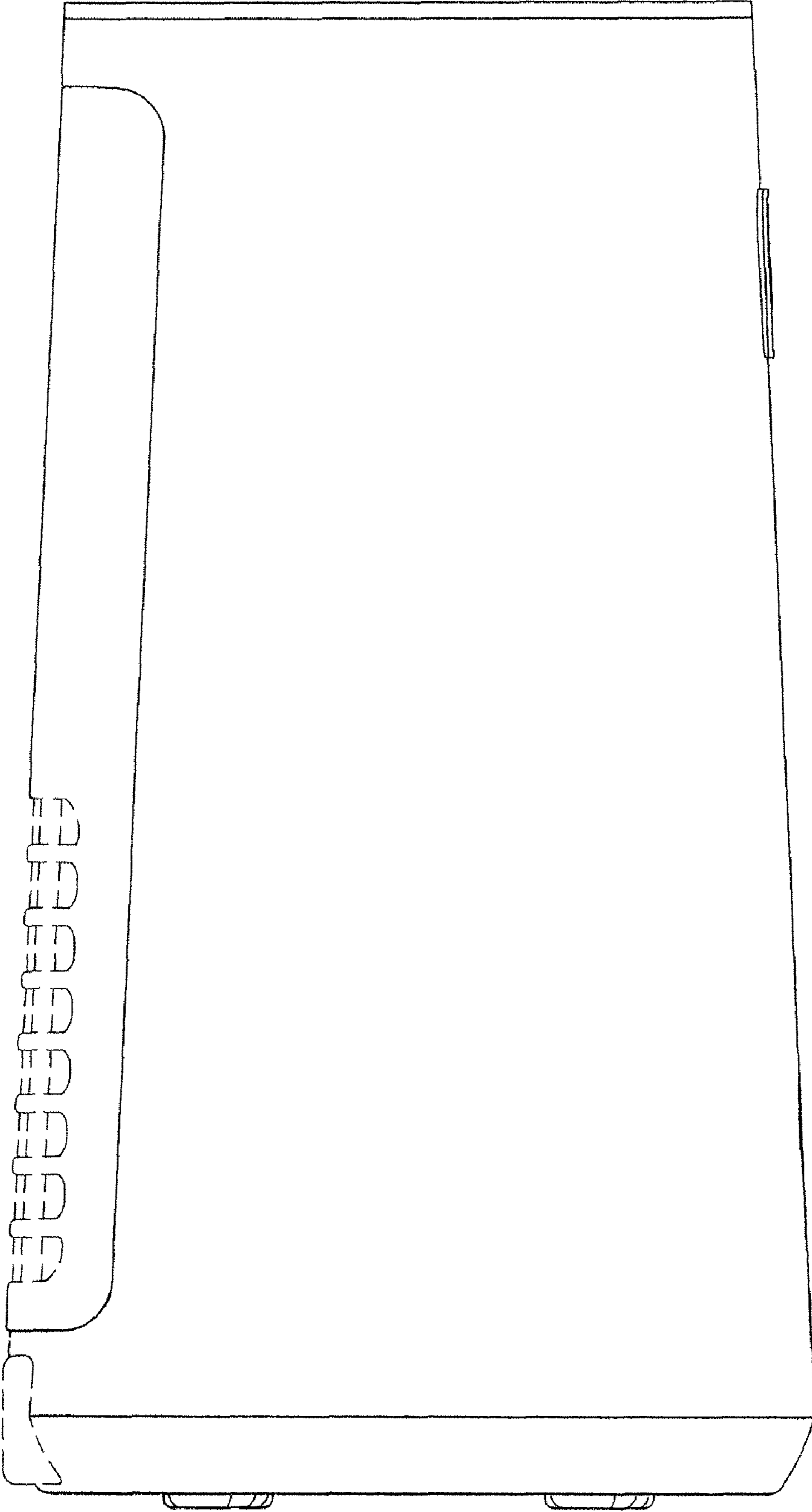

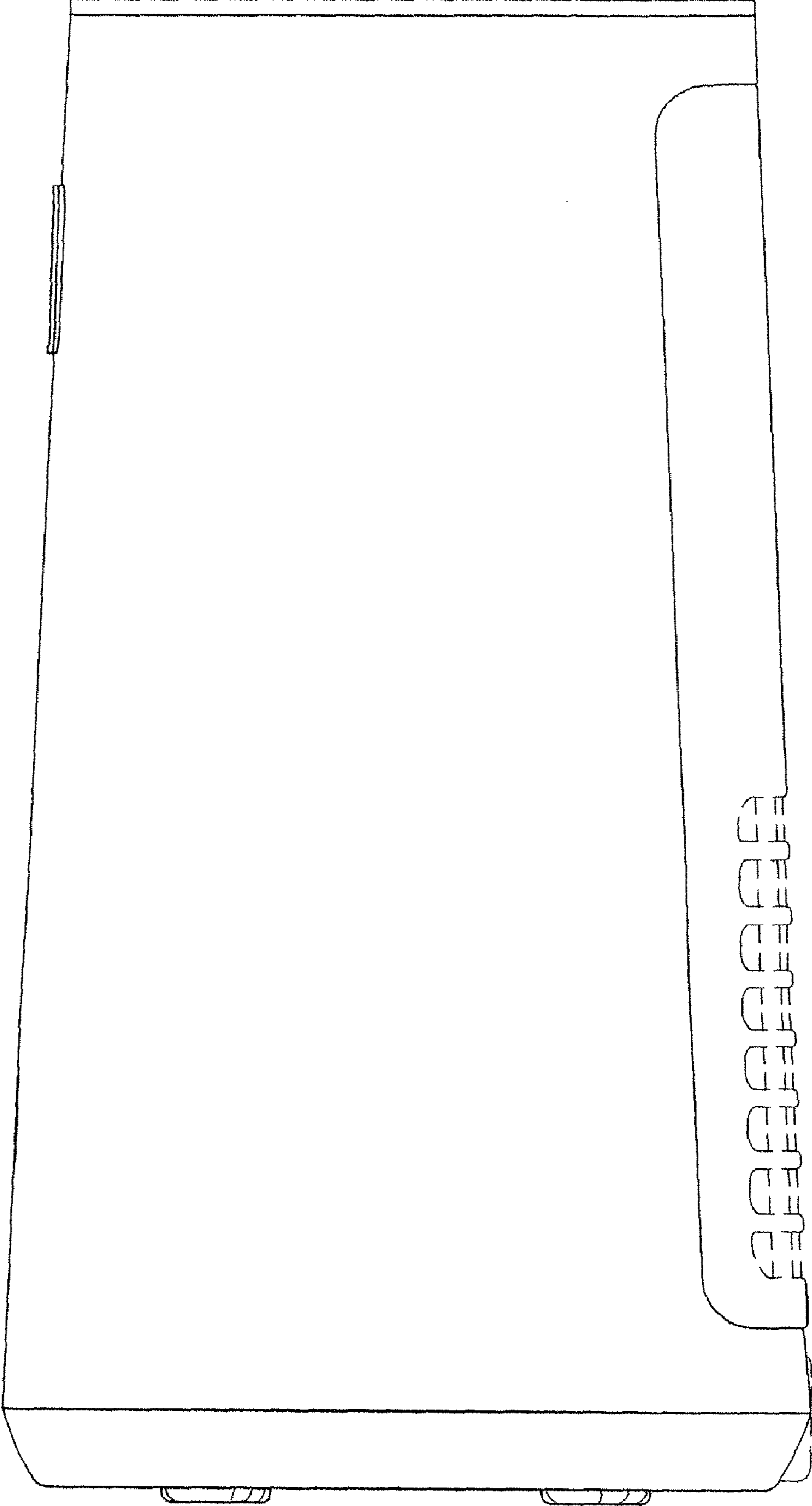

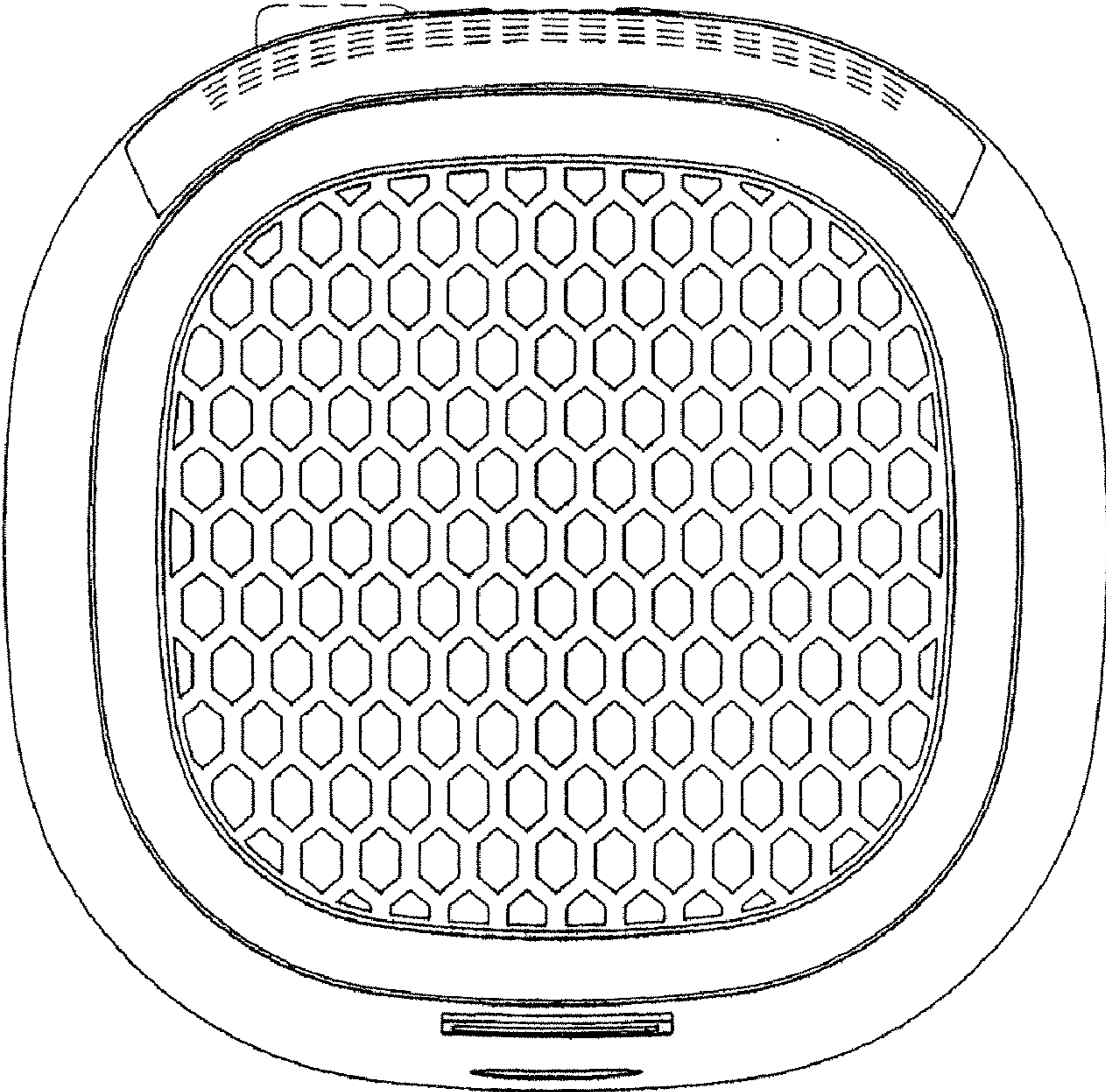
