DESCRIPTION

FIG. 1 is a left side perspective view of an insert for medical device according to the present invention.

FIG. 2 is a right side perspective view of the insert for medical device of FIG. 1.

FIG. 3 is a front perspective view of the insert for medical device of FIG. 1.

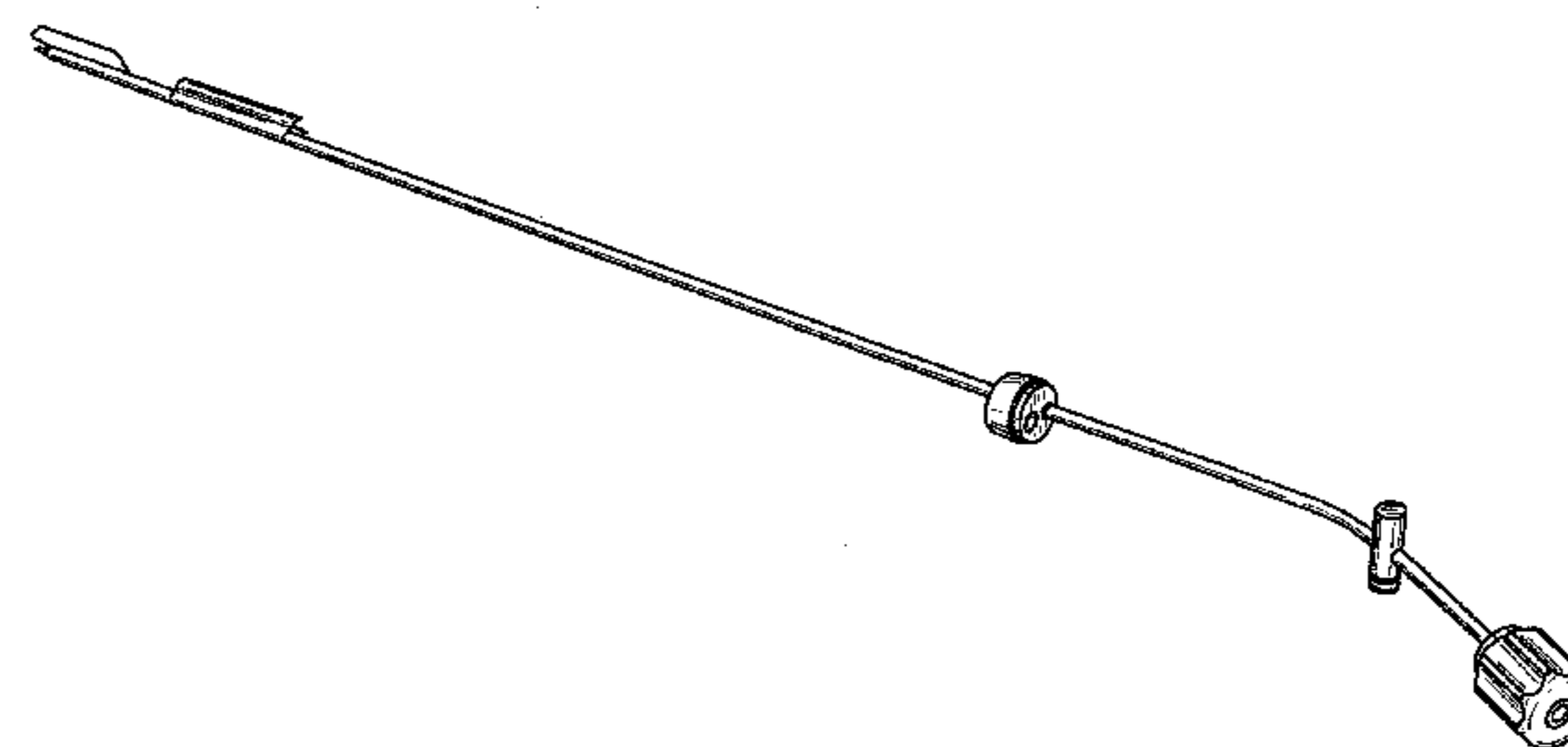
FIG. 4 is a rear perspective view of the insert for medical device of FIG. 1.

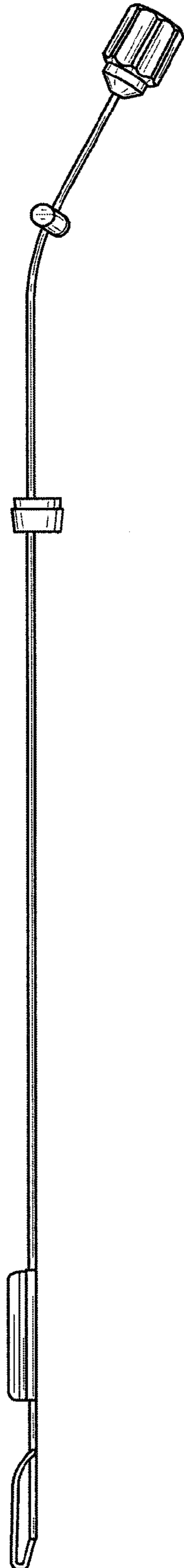

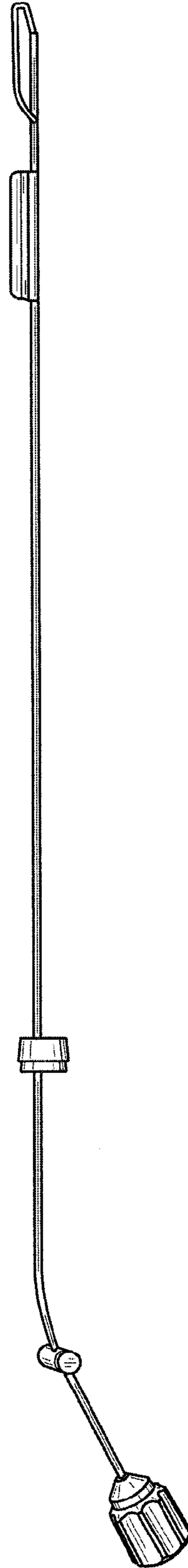

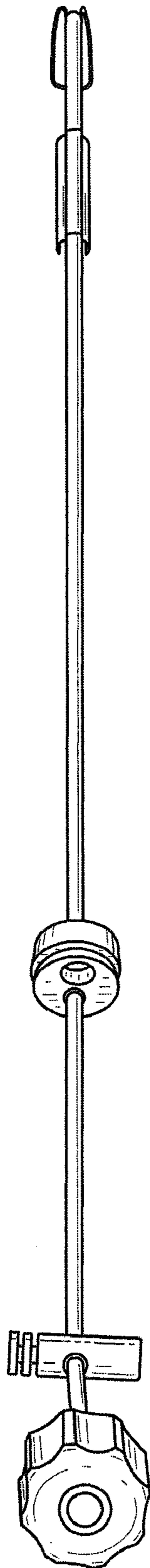

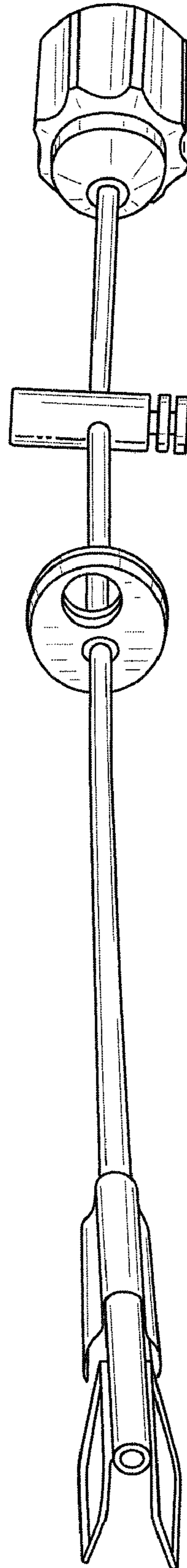

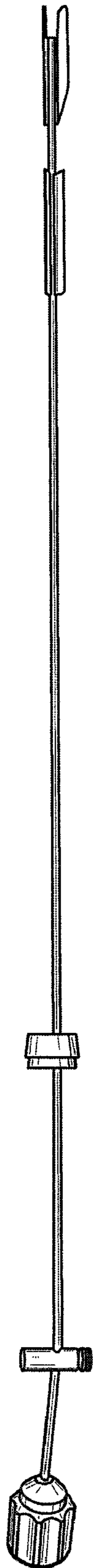

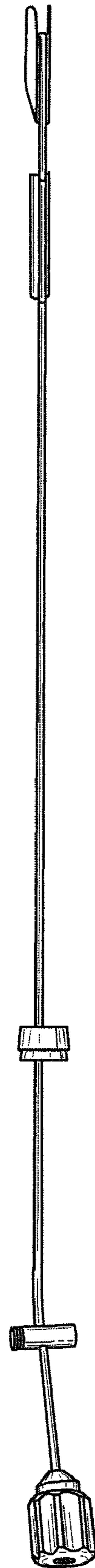

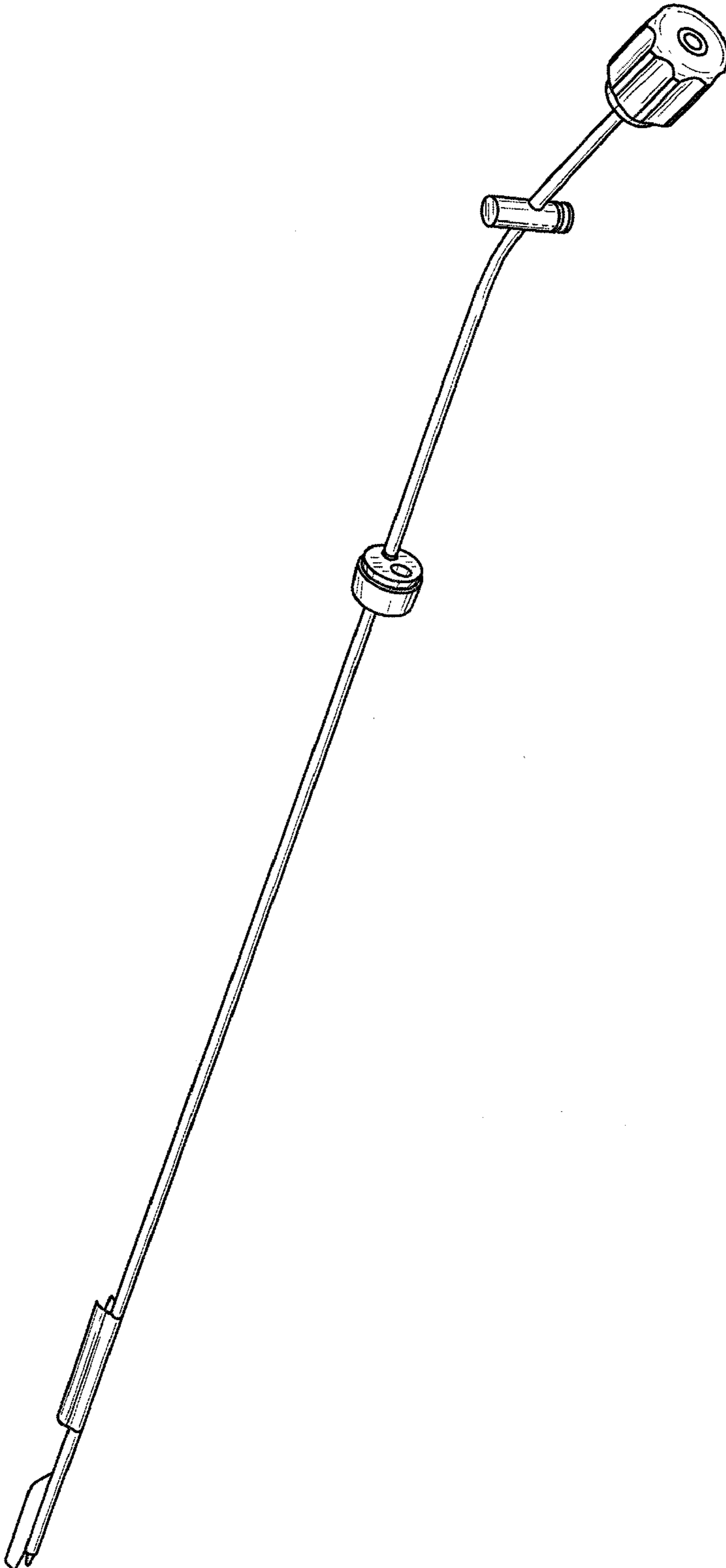
