(57) **CLAIM**

The ornamental design for a lotion applicator pummel, as shown and described.

FIG. 1 is an isometric view of the lotion applicator pummel showing the top from a rear-left perspective in an embodiment where no lotion applicator pad is attached to the pummel body.

FIG. 2 is an isometric view of the lotion applicator pummel showing the bottom from a right-side perspective as illustrated in the embodiment according to FIG. 1.

FIG. 3 is a rear view of the lotion applicator pummel as illustrated in the embodiment according to FIG. 1.

FIG. 4 is a front view of the lotion applicator pummel as illustrated in the embodiment according to FIG. 1.

FIG. 5 is a left side view of the lotion applicator pummel as illustrated in the embodiment according to FIG. 1.

FIG. 6 is a top view of the lotion applicator pummel as illustrated in the embodiment according to FIG. 1.

FIG. 7 is a bottom view of the lotion applicator pummel as illustrated in the embodiment according to FIG. 1.

FIG. 8 is an isometric view of the lotion applicator pummel showing the top from a rear-left perspective with a second embodiment where an elliptical lotion applicator pad attachment ring is snapped in place to side walls of lotion applicator pummel body. The dotted line represents an interchangeable lotion applicator pad material which forms no part of the claimed design.

FIG. 9 is an isometric view of the lotion applicator pummel showing the bottom from a right-side perspective as illustrated in the embodiment according to FIG. 8.

FIG. 10 is a rear view of the lotion applicator pummel as illustrated in the embodiment according to FIG. 8.

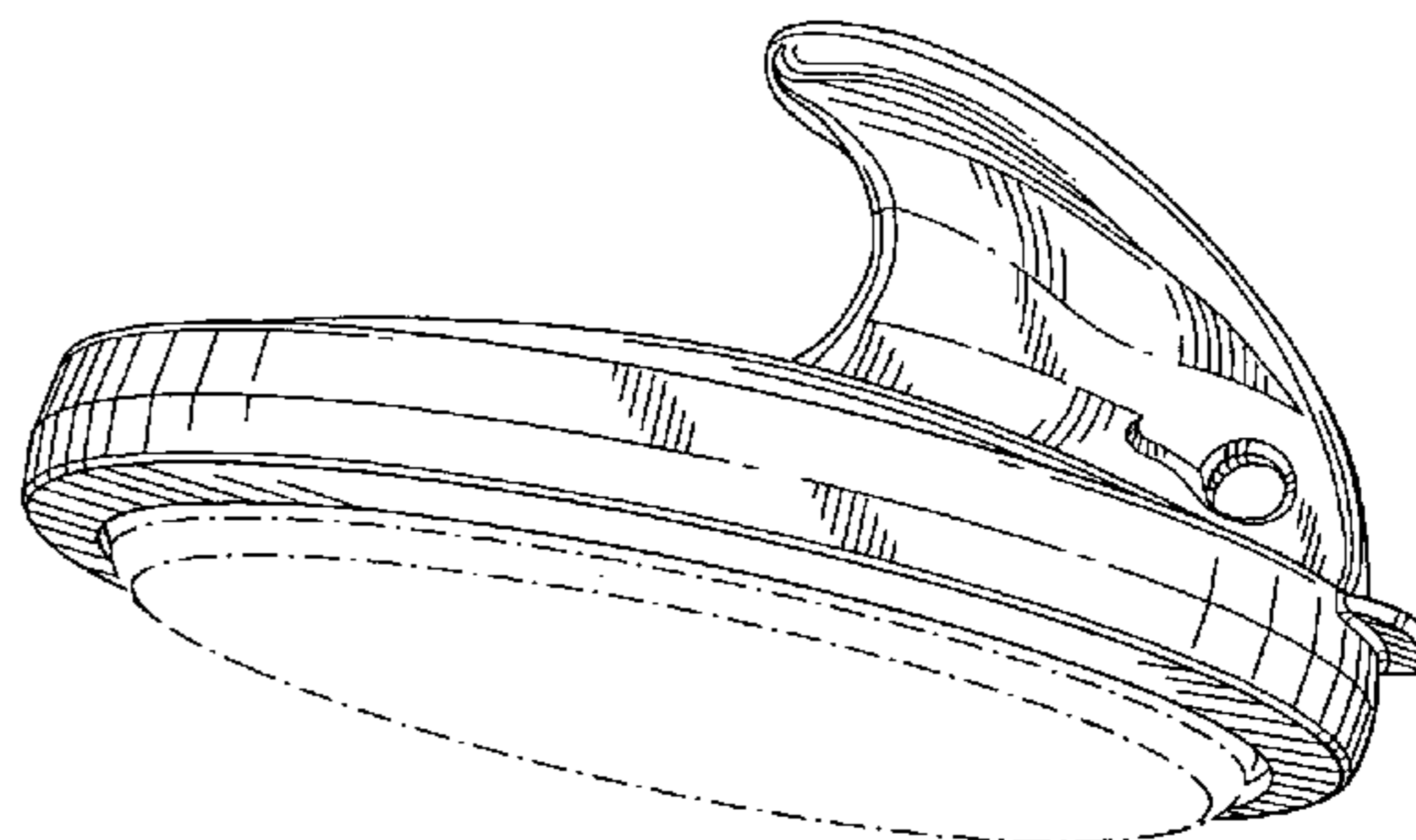
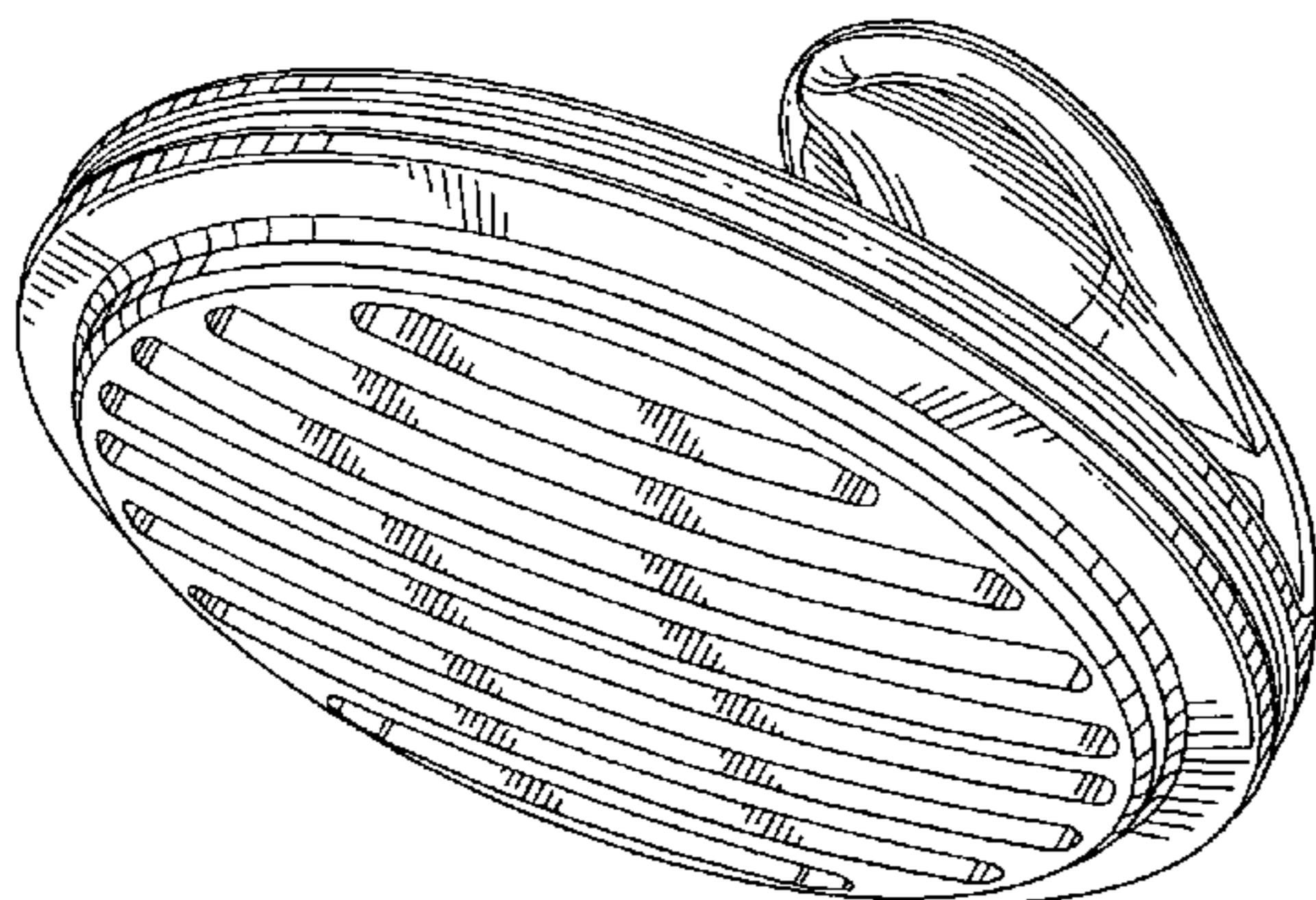
FIG. 11 is a front view of the lotion applicator pummel as illustrated in the embodiment according to FIG. 8.

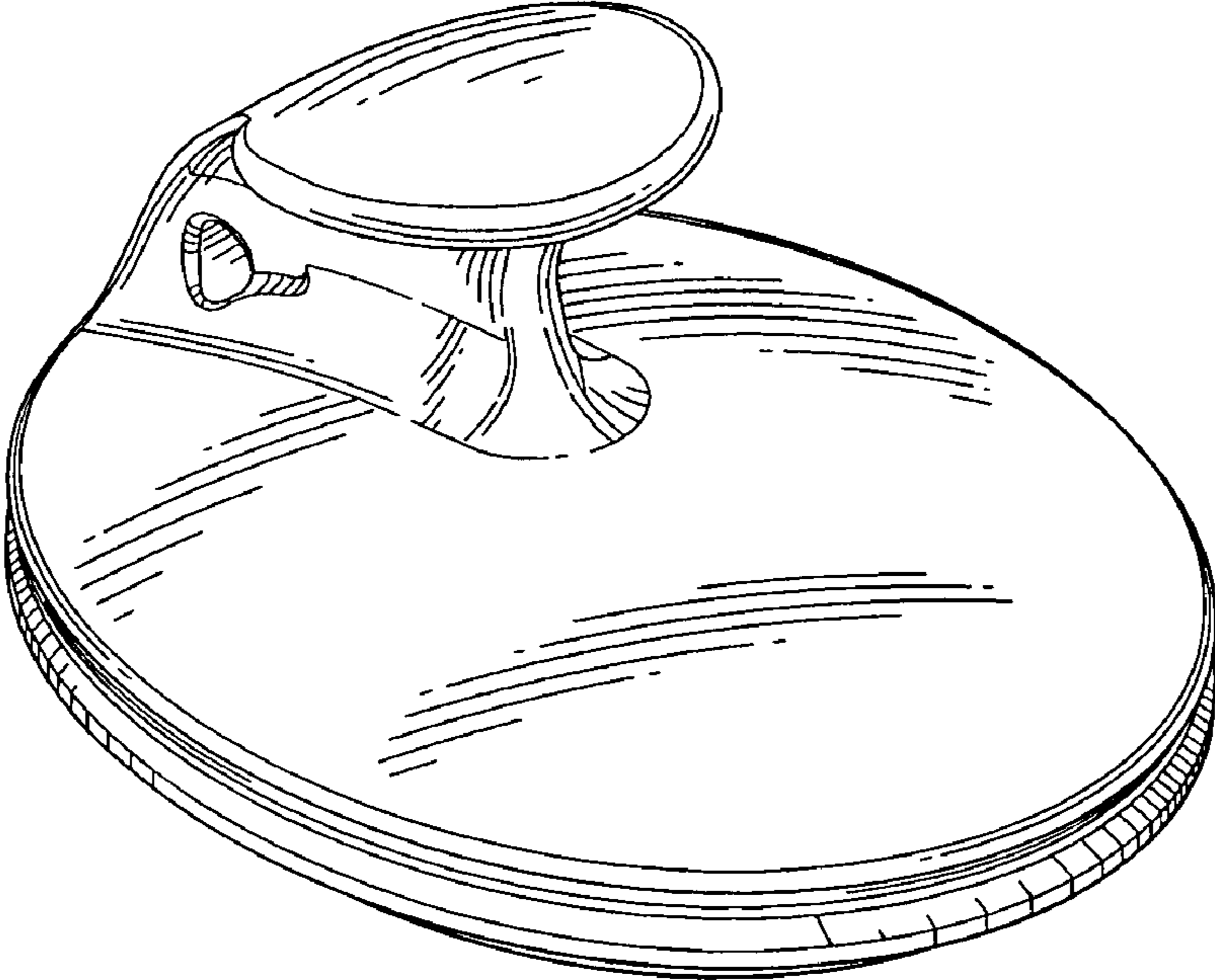

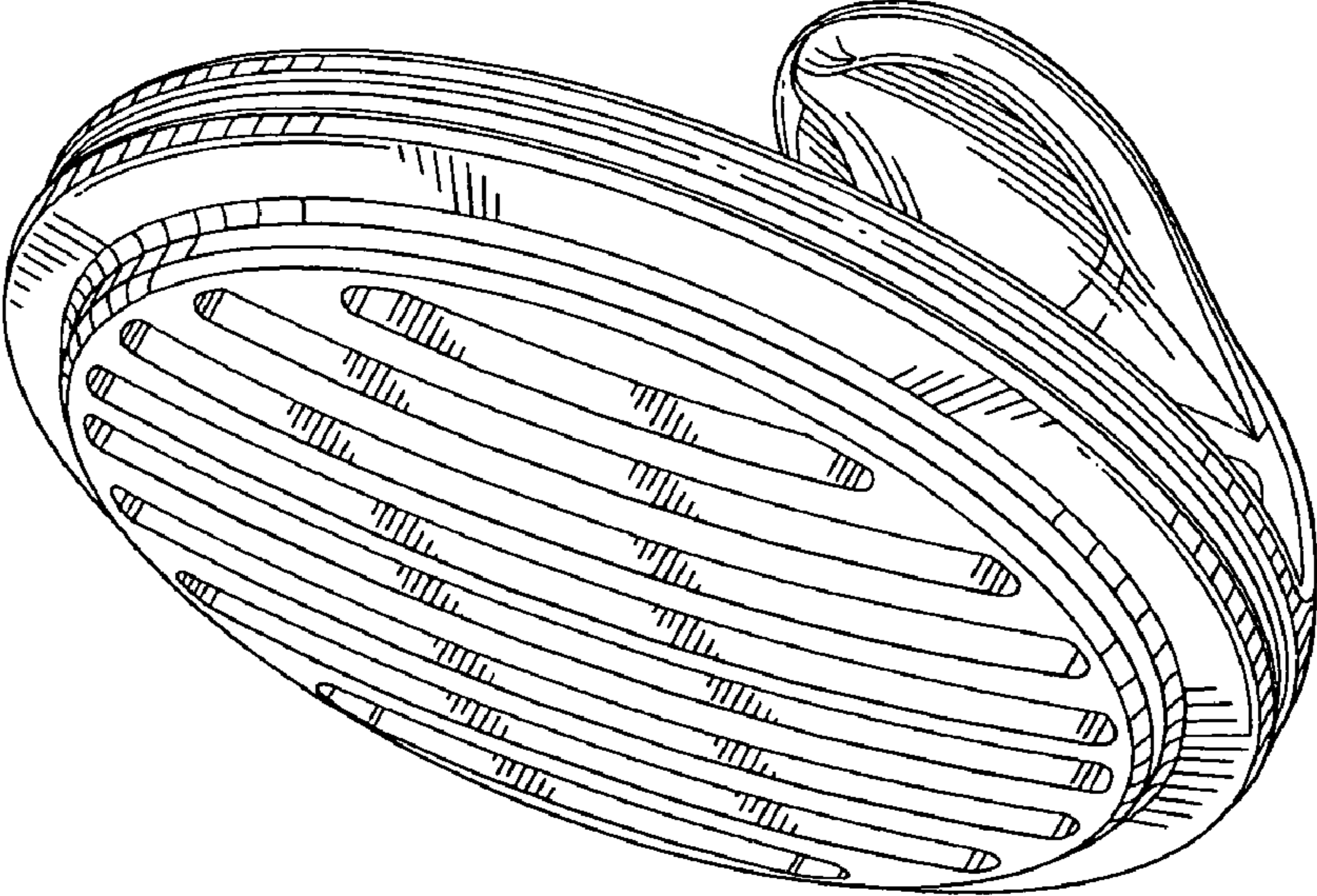

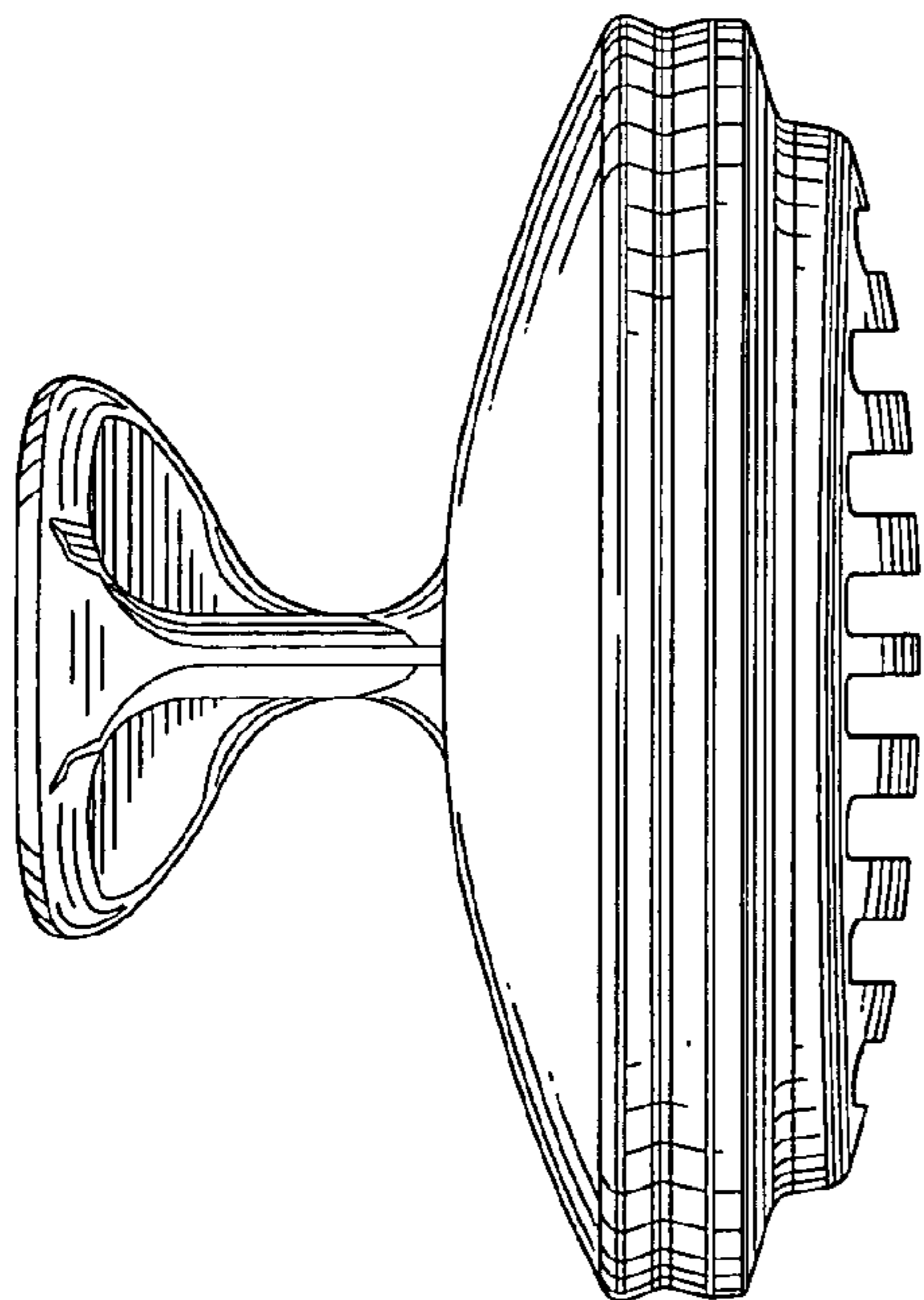

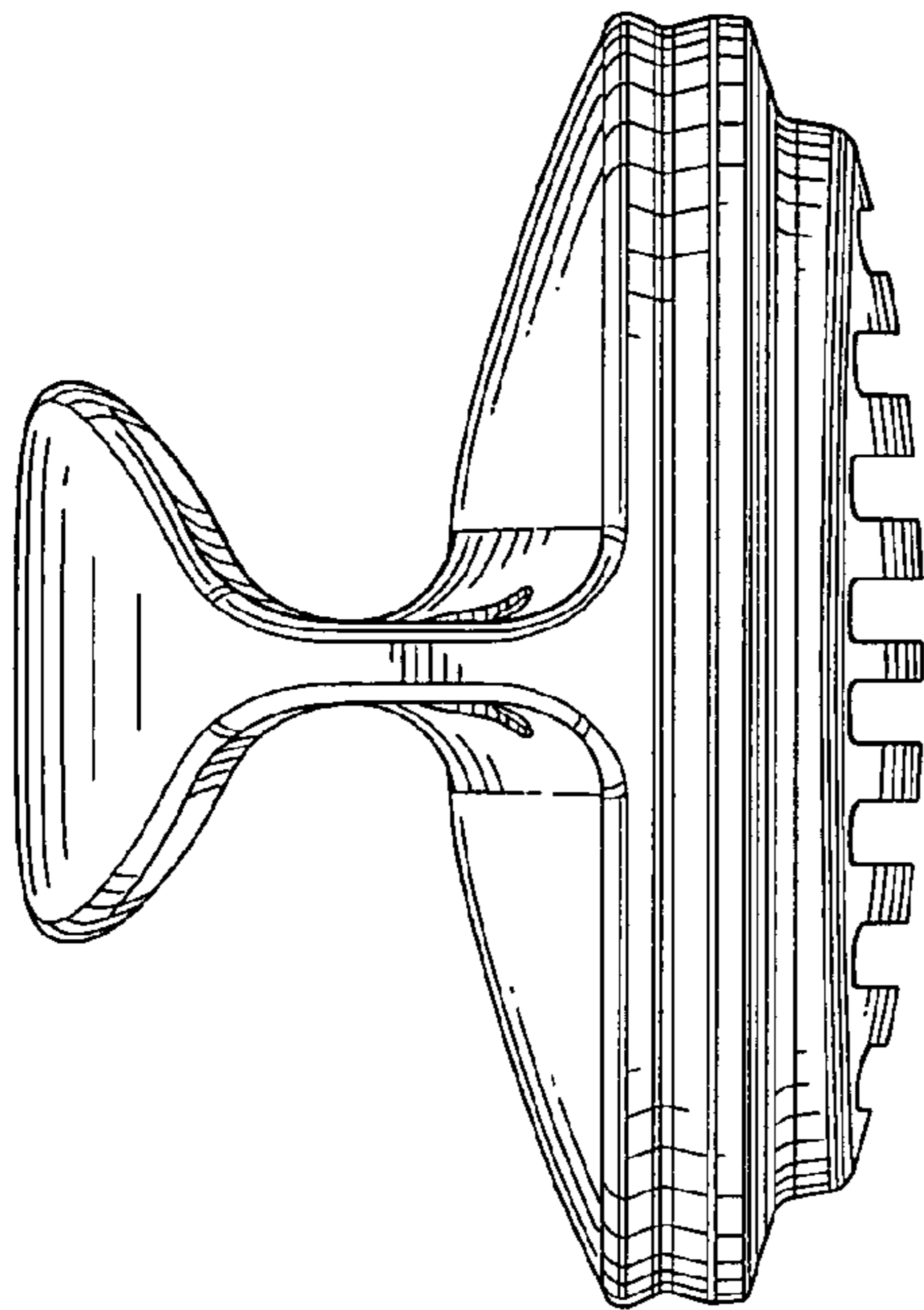

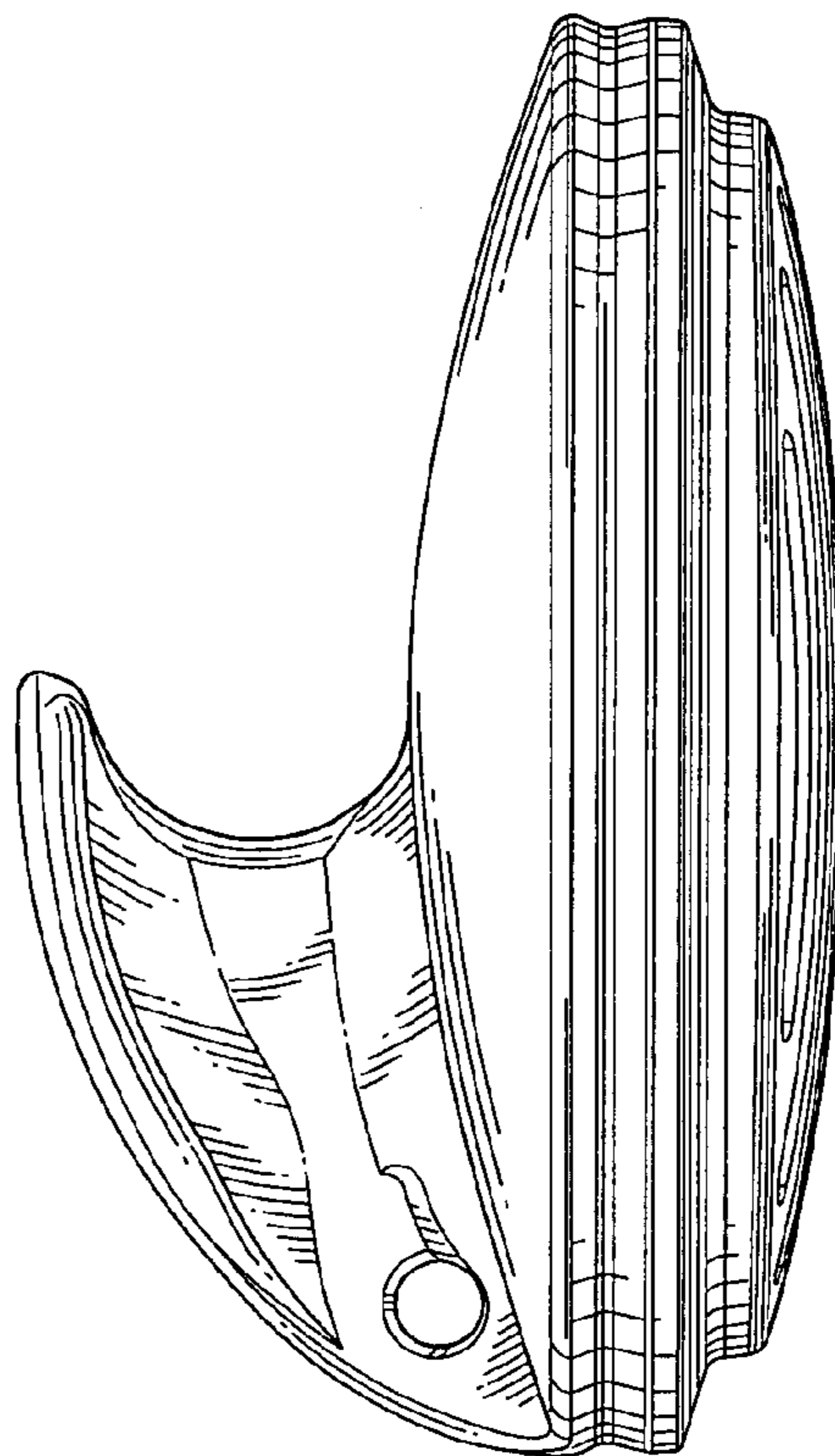

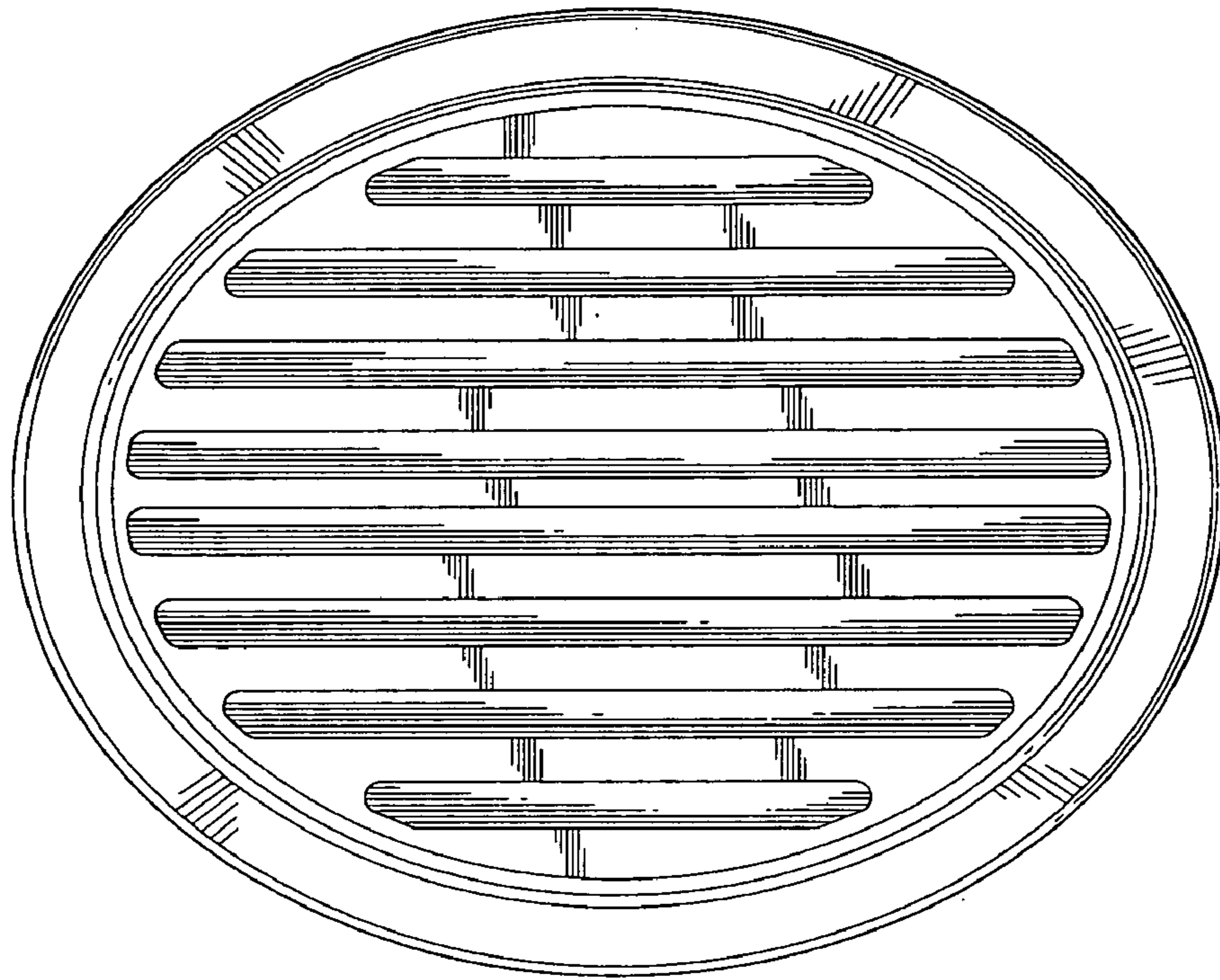

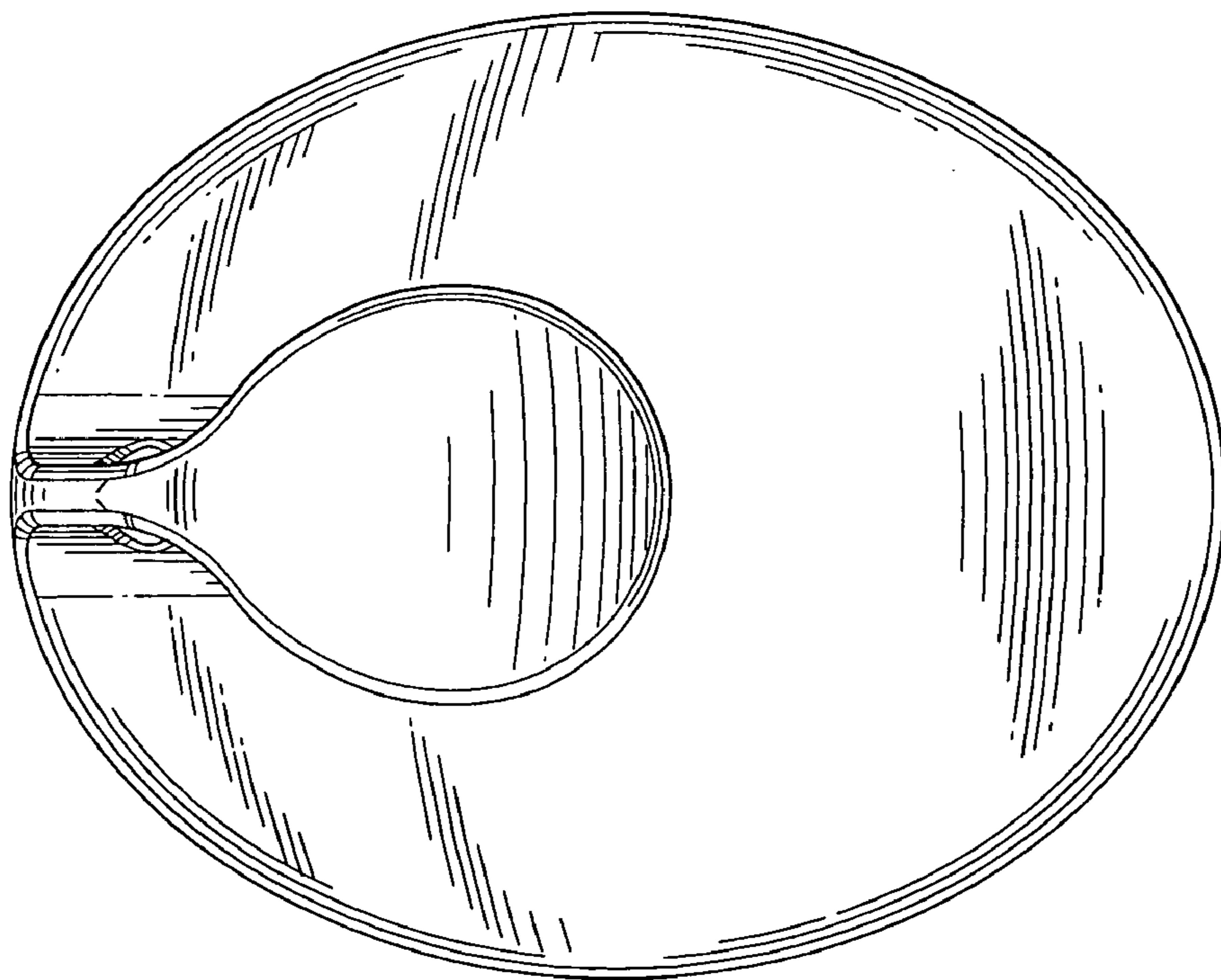

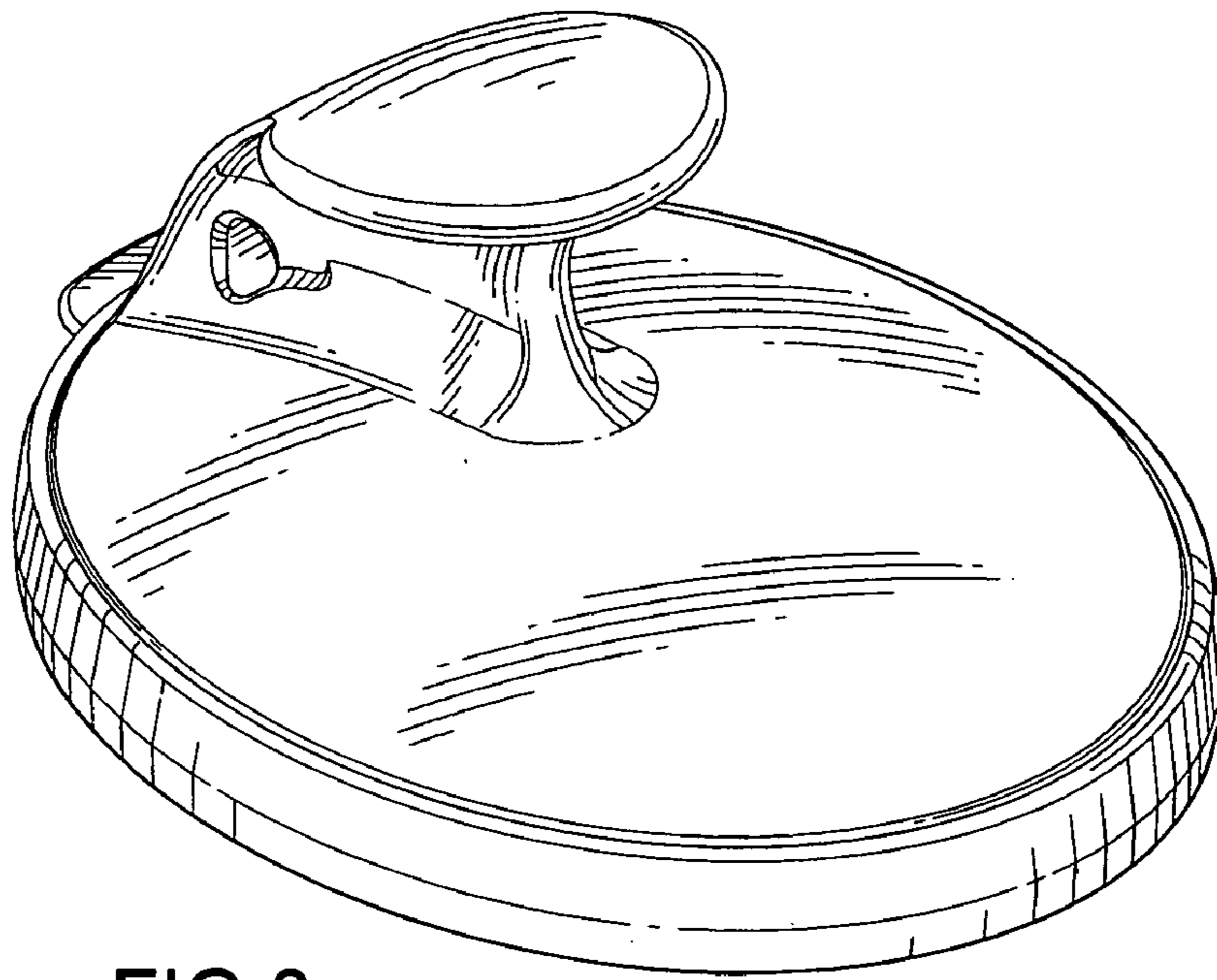

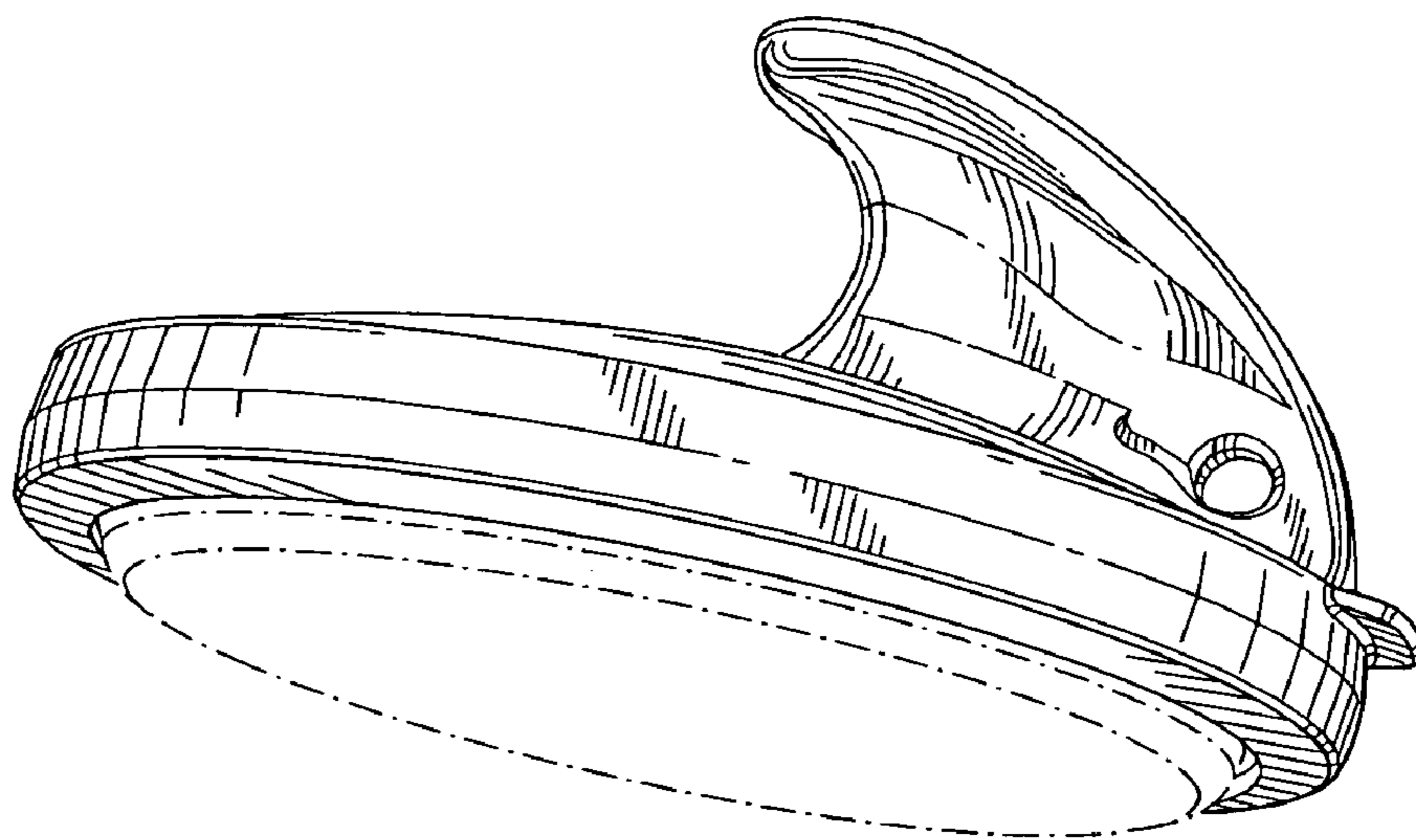

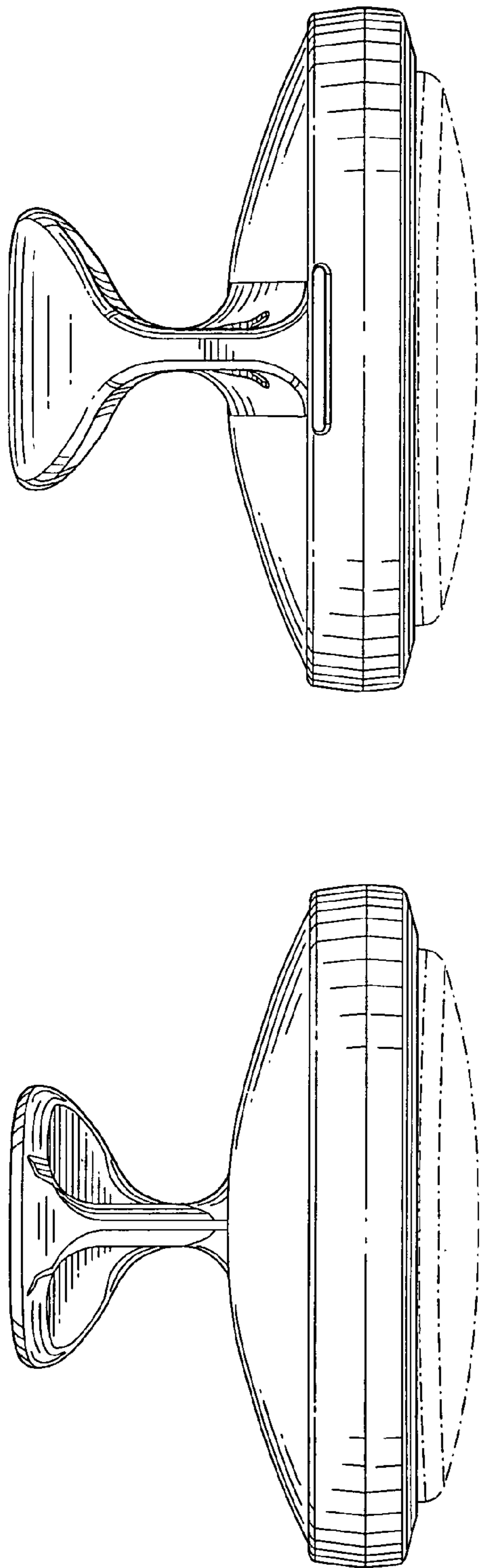

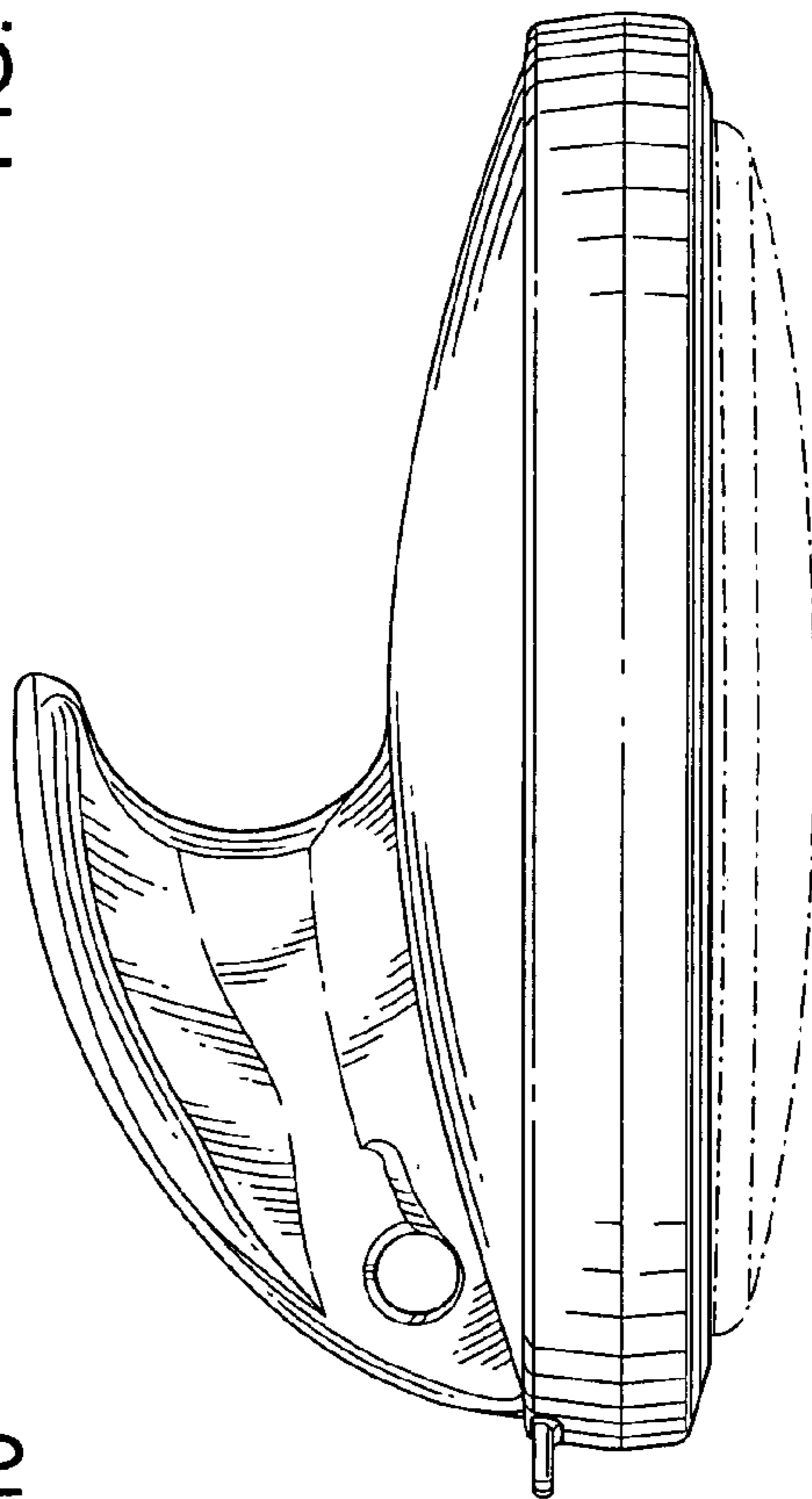

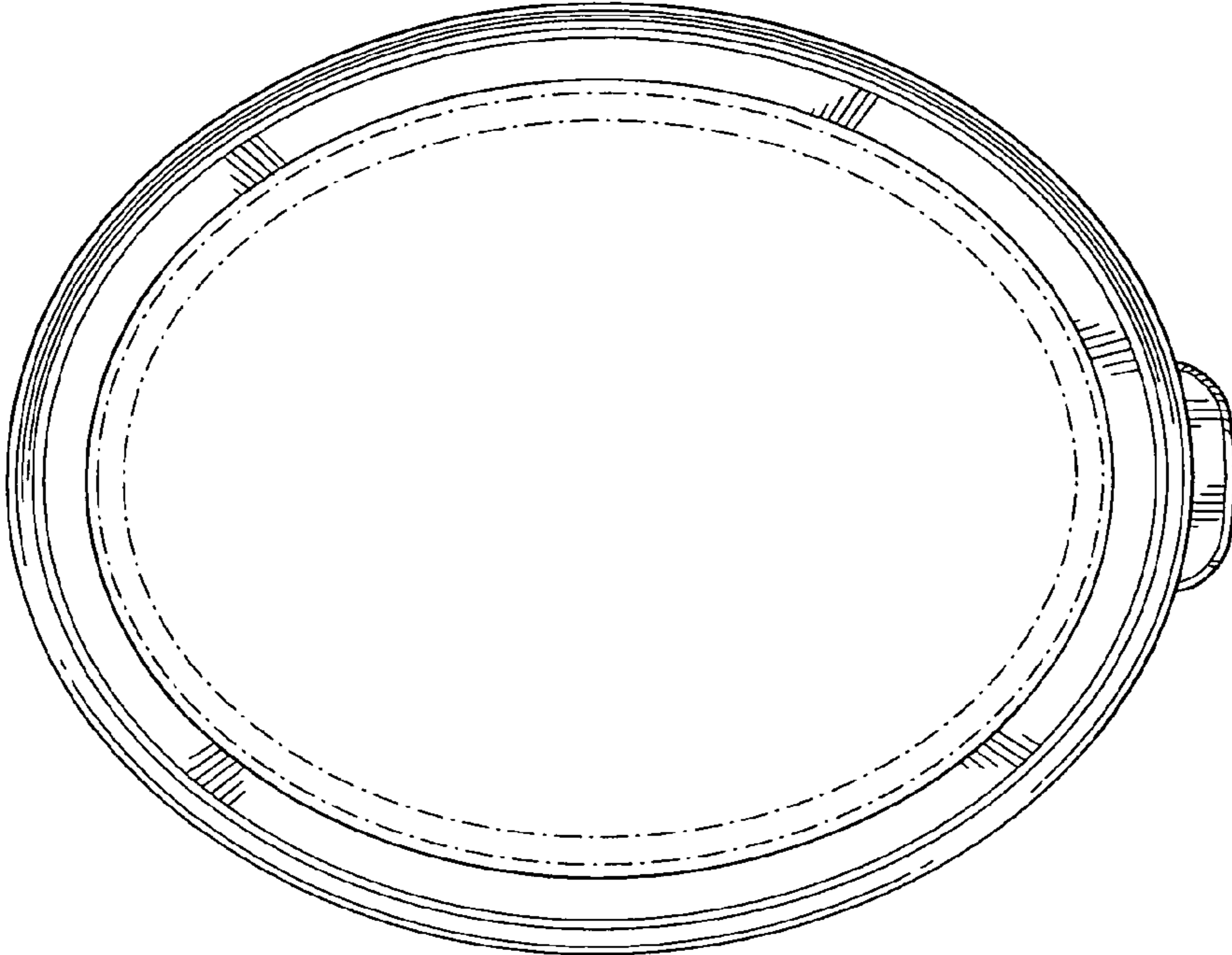

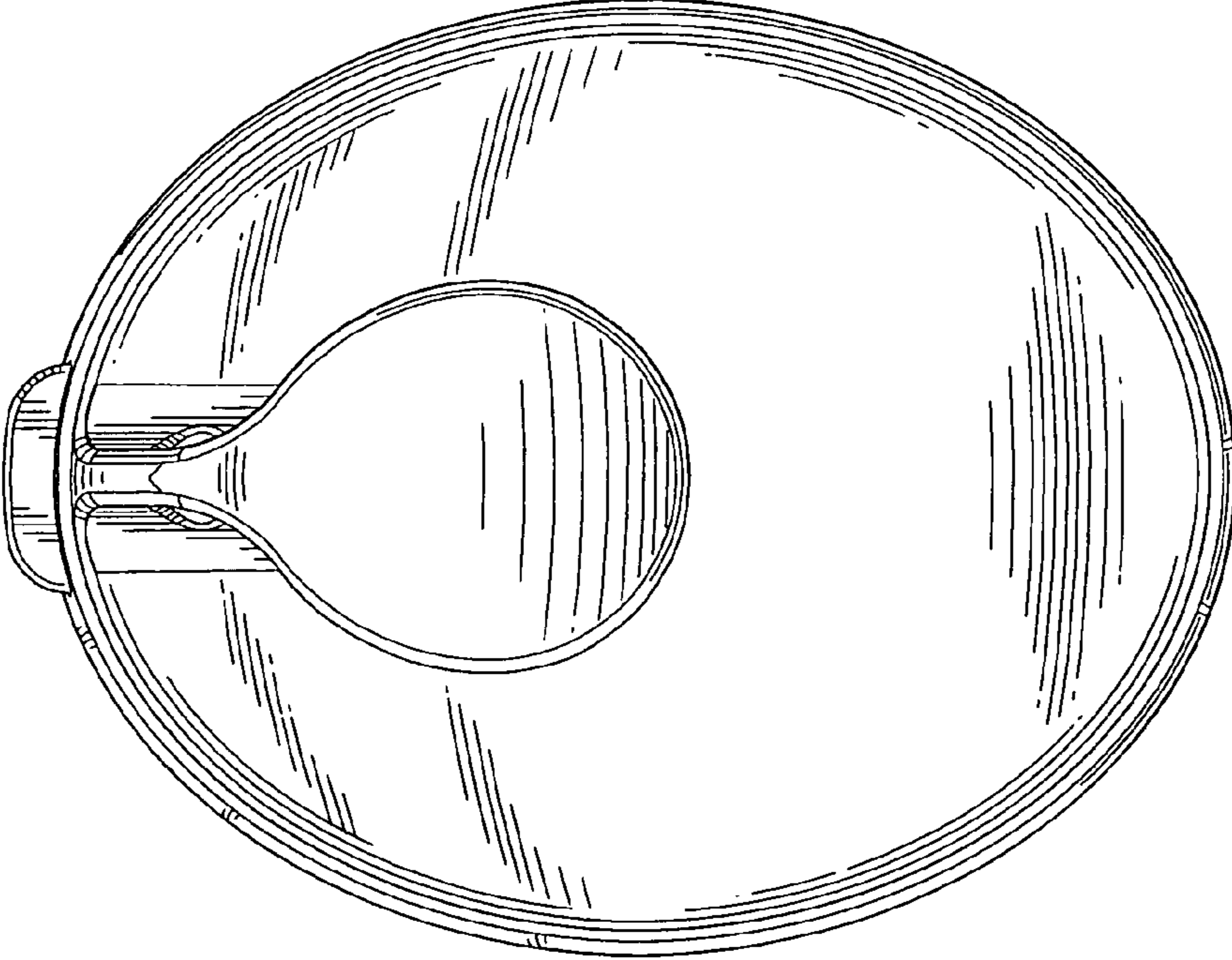
