(57) **CLAIM**

The ornamental design for a neck warmer with removable belt, thereof as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevation view of a neck warmer showing our new design;

FIG. 2 is a rear elevation view thereof;

FIG. 3 is a right side view thereof;

FIG. 4 is a left side view thereof;

FIG. 5 is a top plan view thereof;

FIG. 6 is a bottom plan view thereof;

FIG. 7 is front elevation view of a removable belt of the neck warmer;

FIG. 8 is a rear elevation view of a removable belt of the neck warmer;

FIG. 9 is a right side view of a removable belt of the neck warmer, the left side view being identical;

FIG. 10 is a top plan view of a removable belt of the neck warmer;

FIG. 11 is a referential view showing a state with the front fastener being unzipped and a removable belt being attached; and,

FIG. 12 is another referential view showing a state with the front fastener being unzipped and a removable belt being detached.

The belt of the neck warmer is shown separately in FIGS. 7-10 for clarity of illustration.

The broken lines shown in the drawings are stitching.

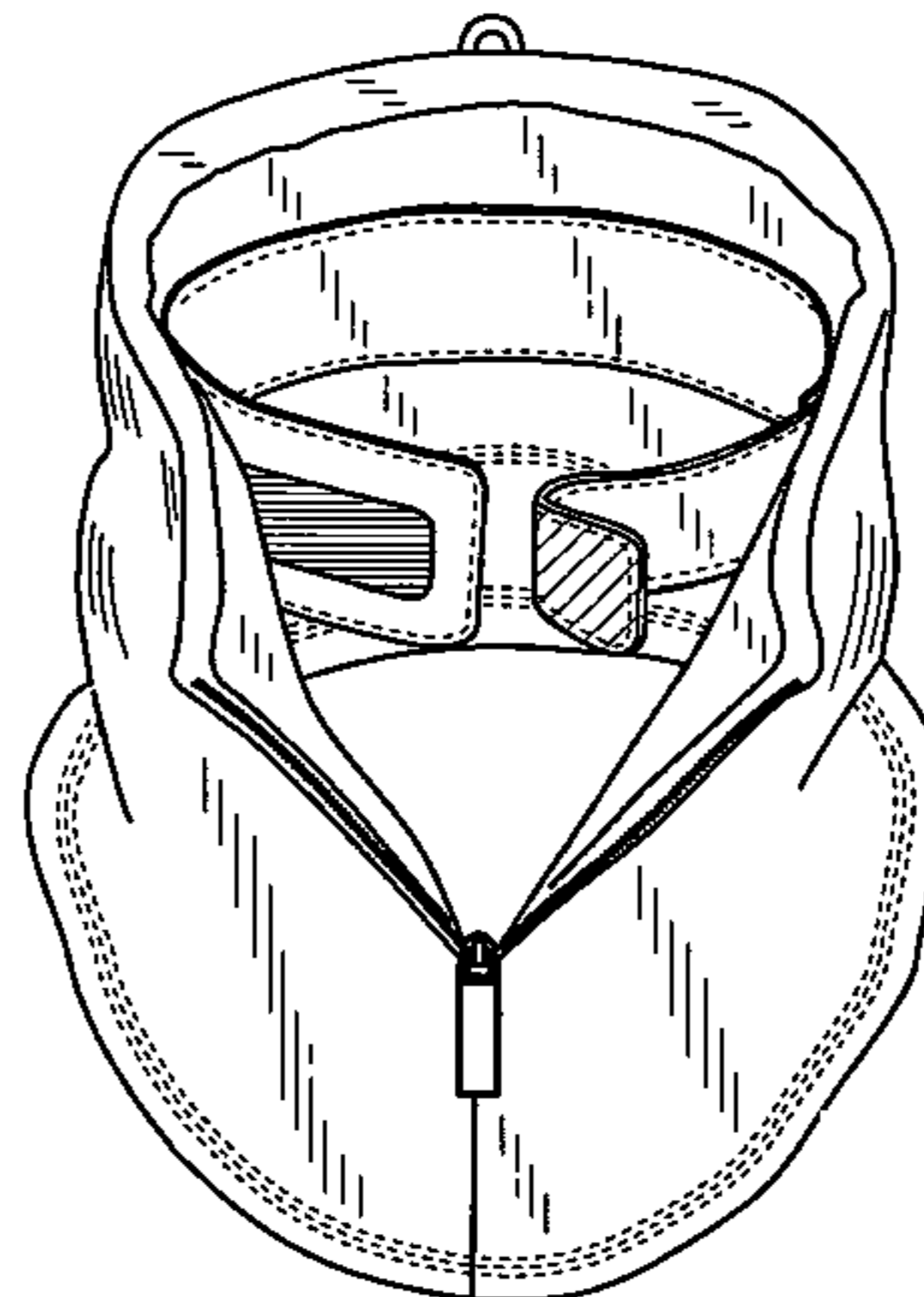
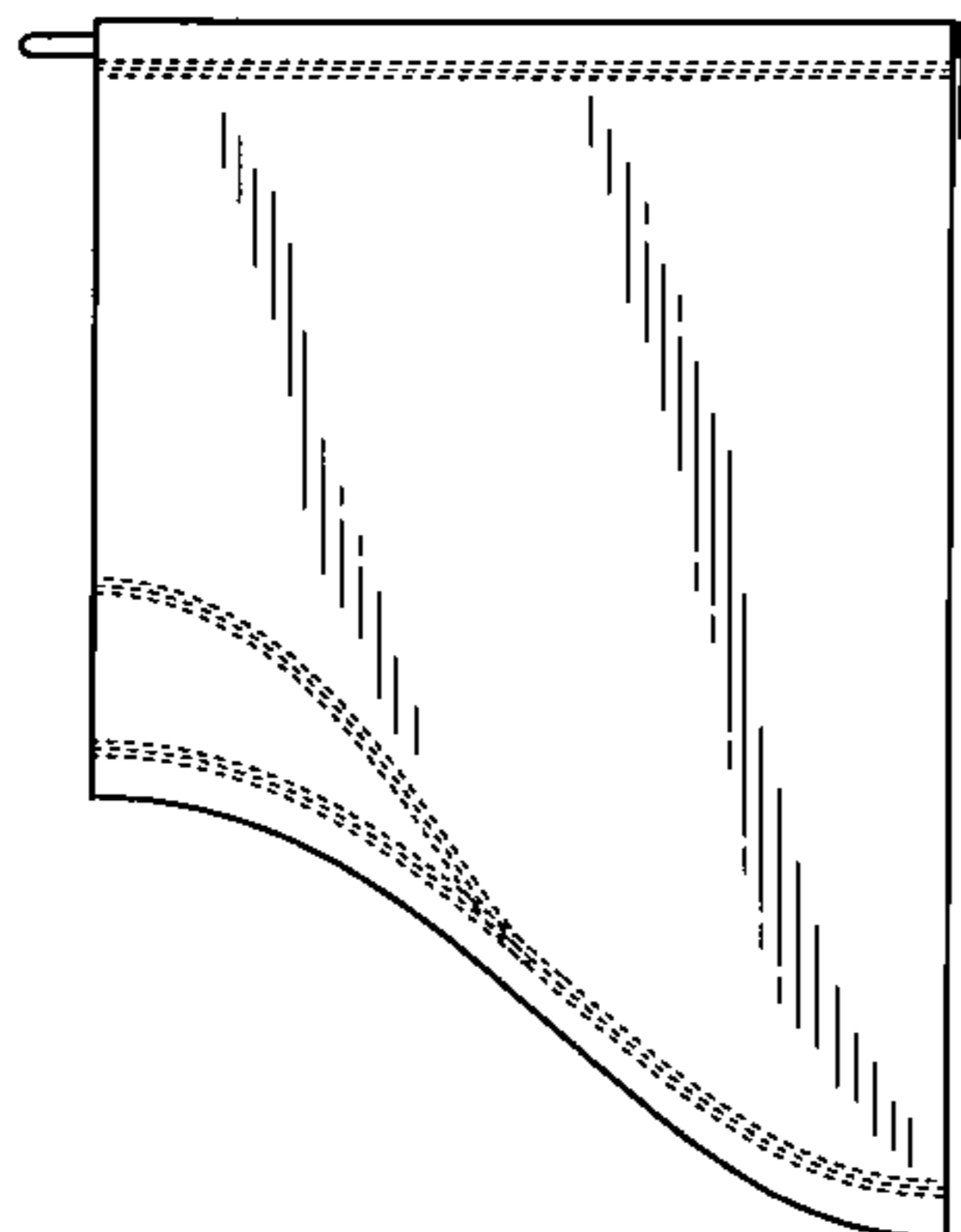

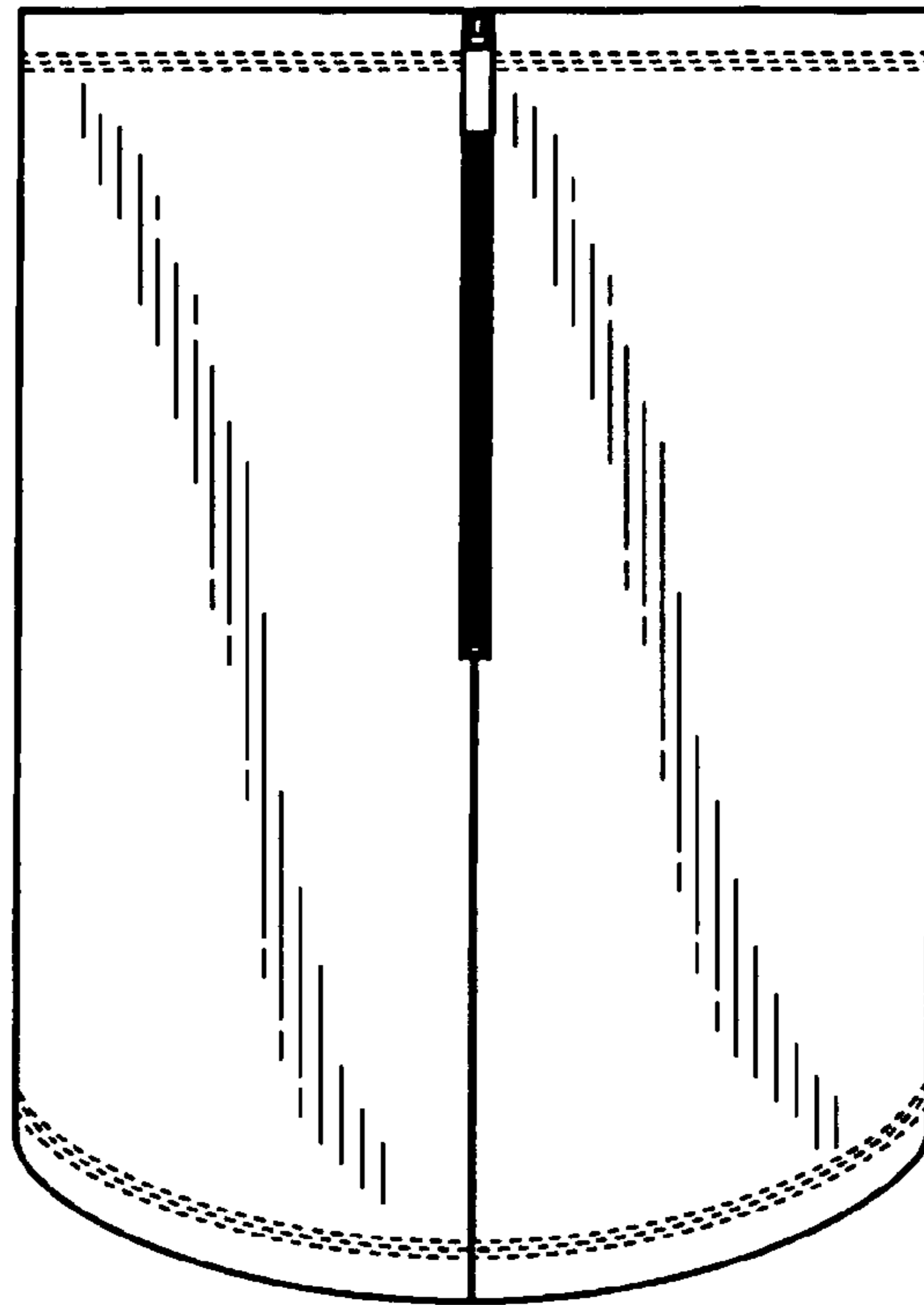

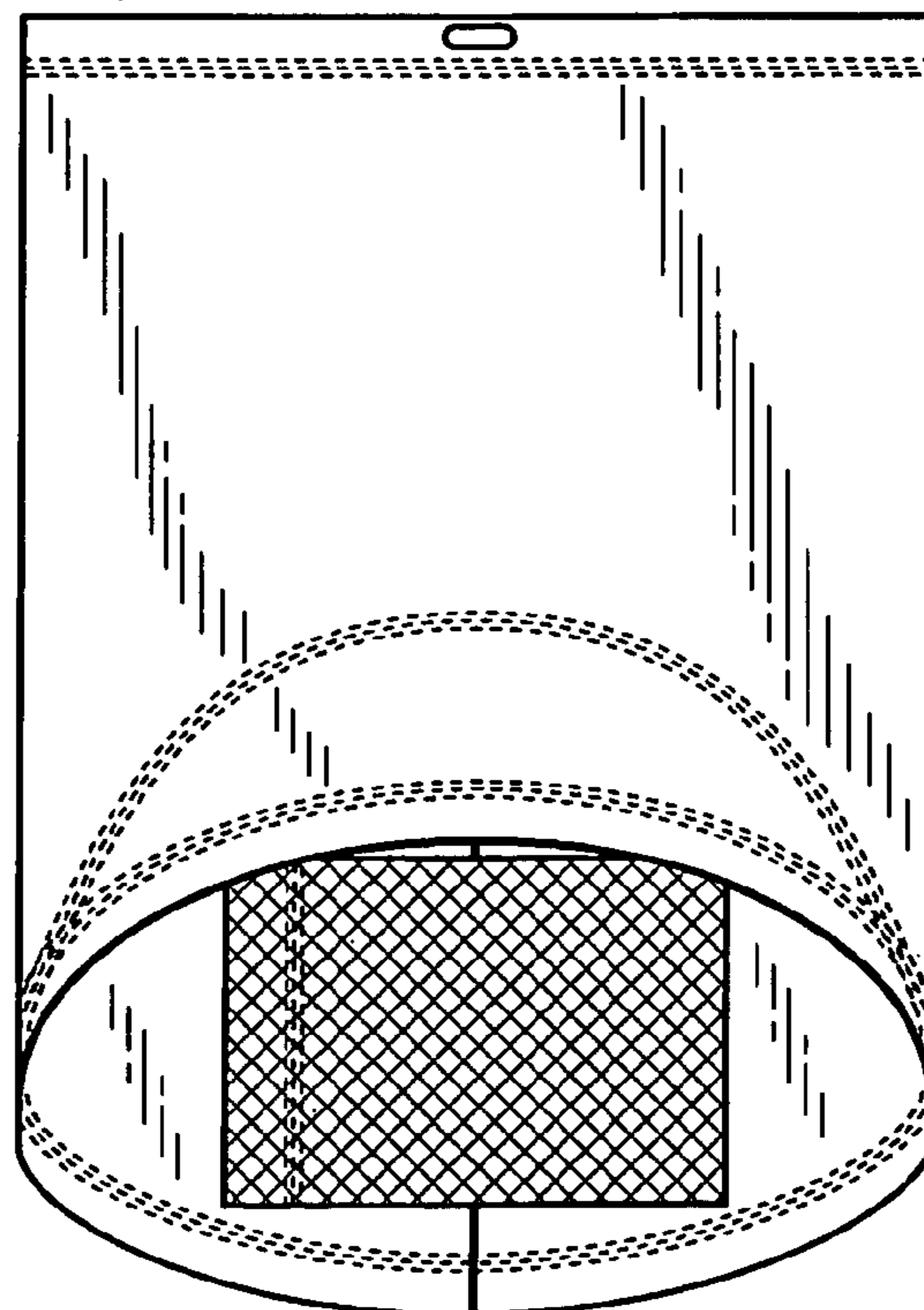

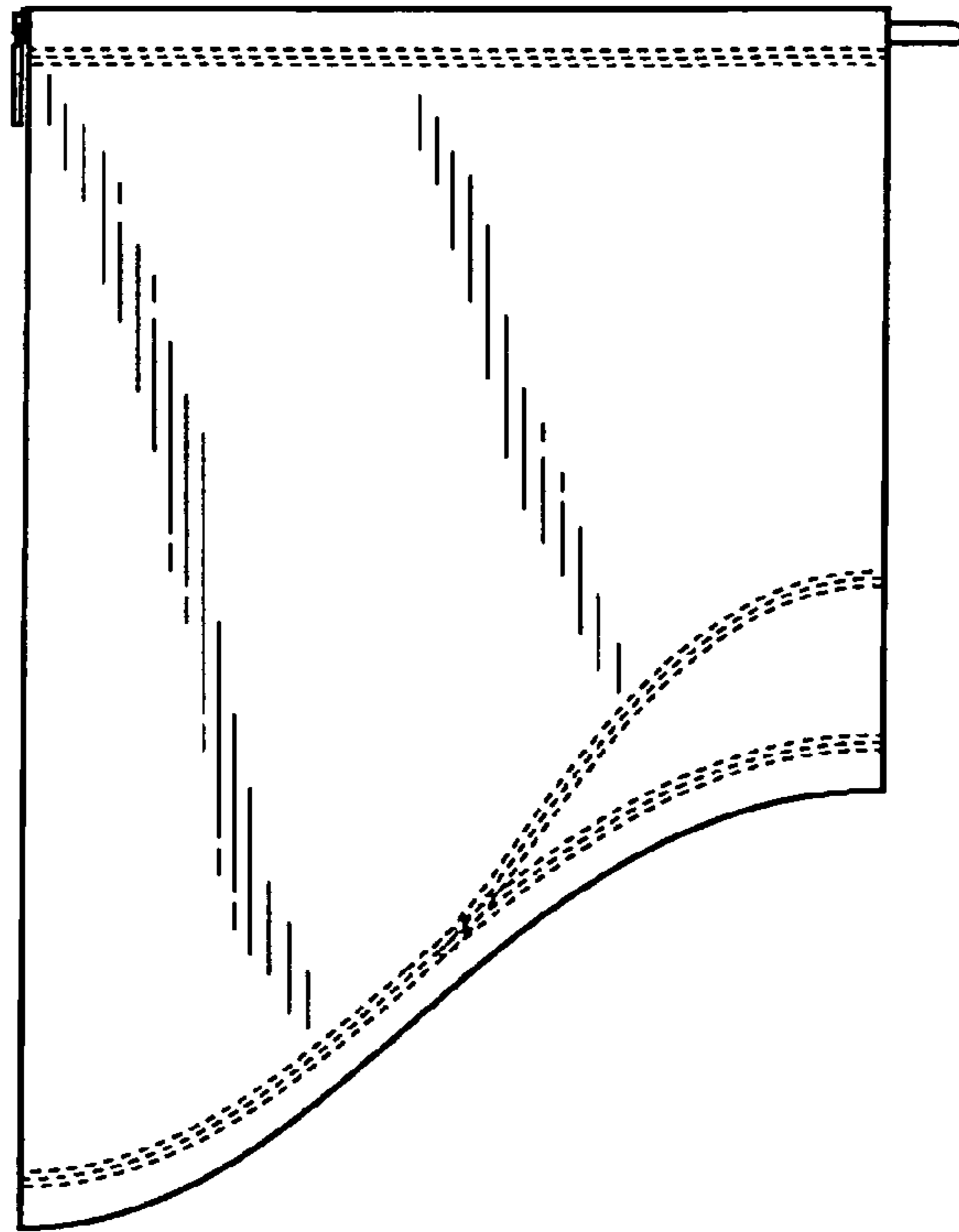

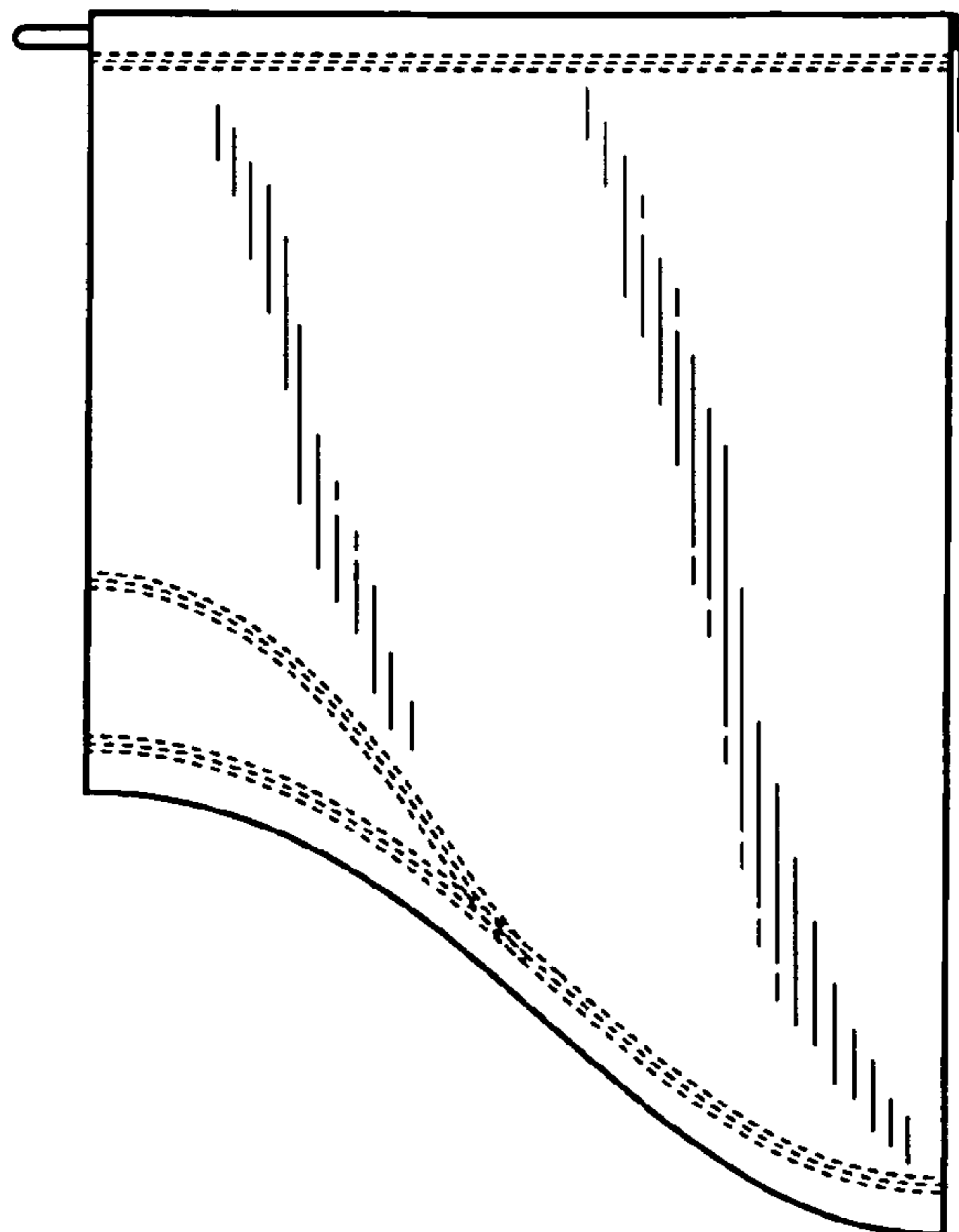

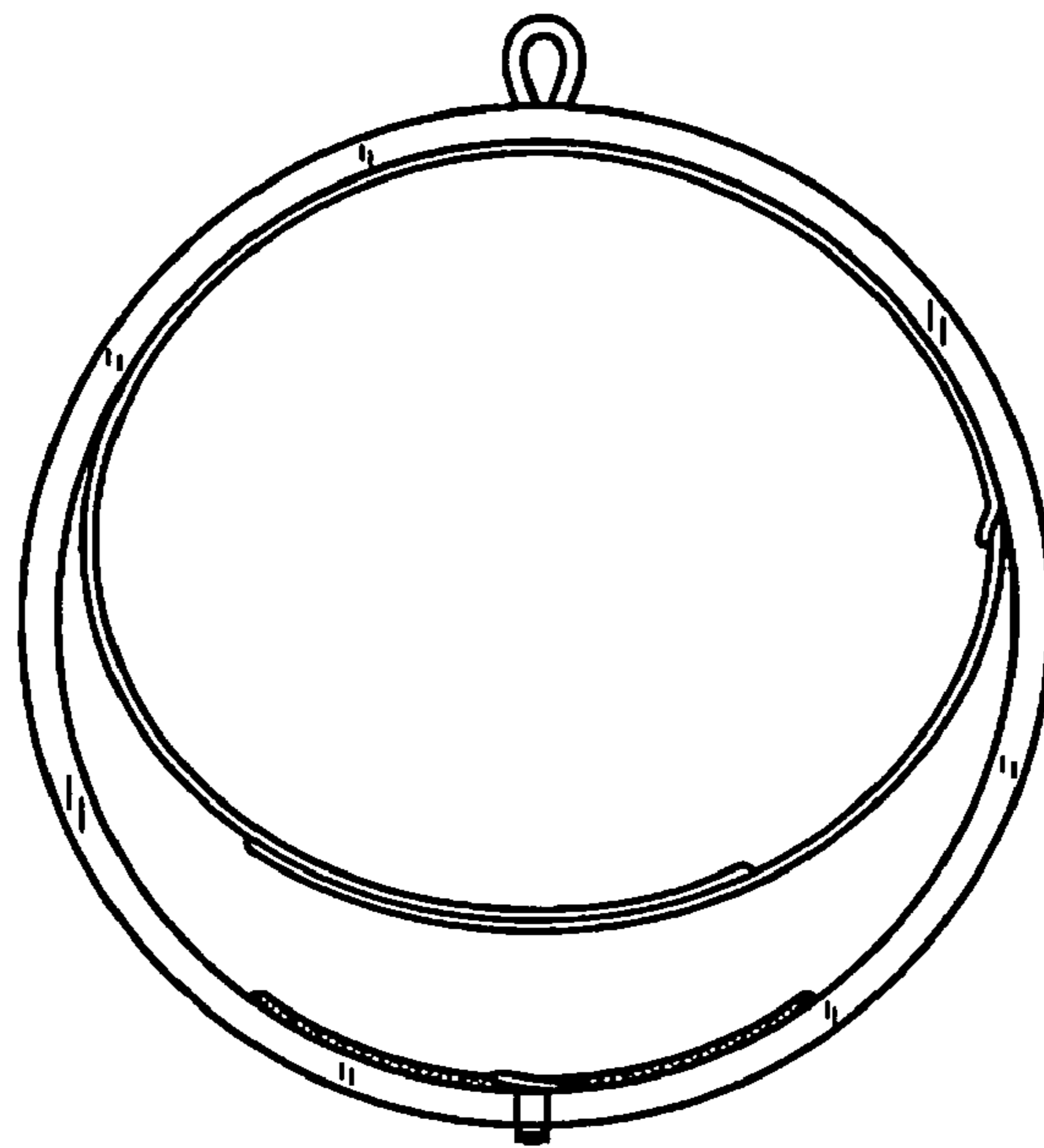

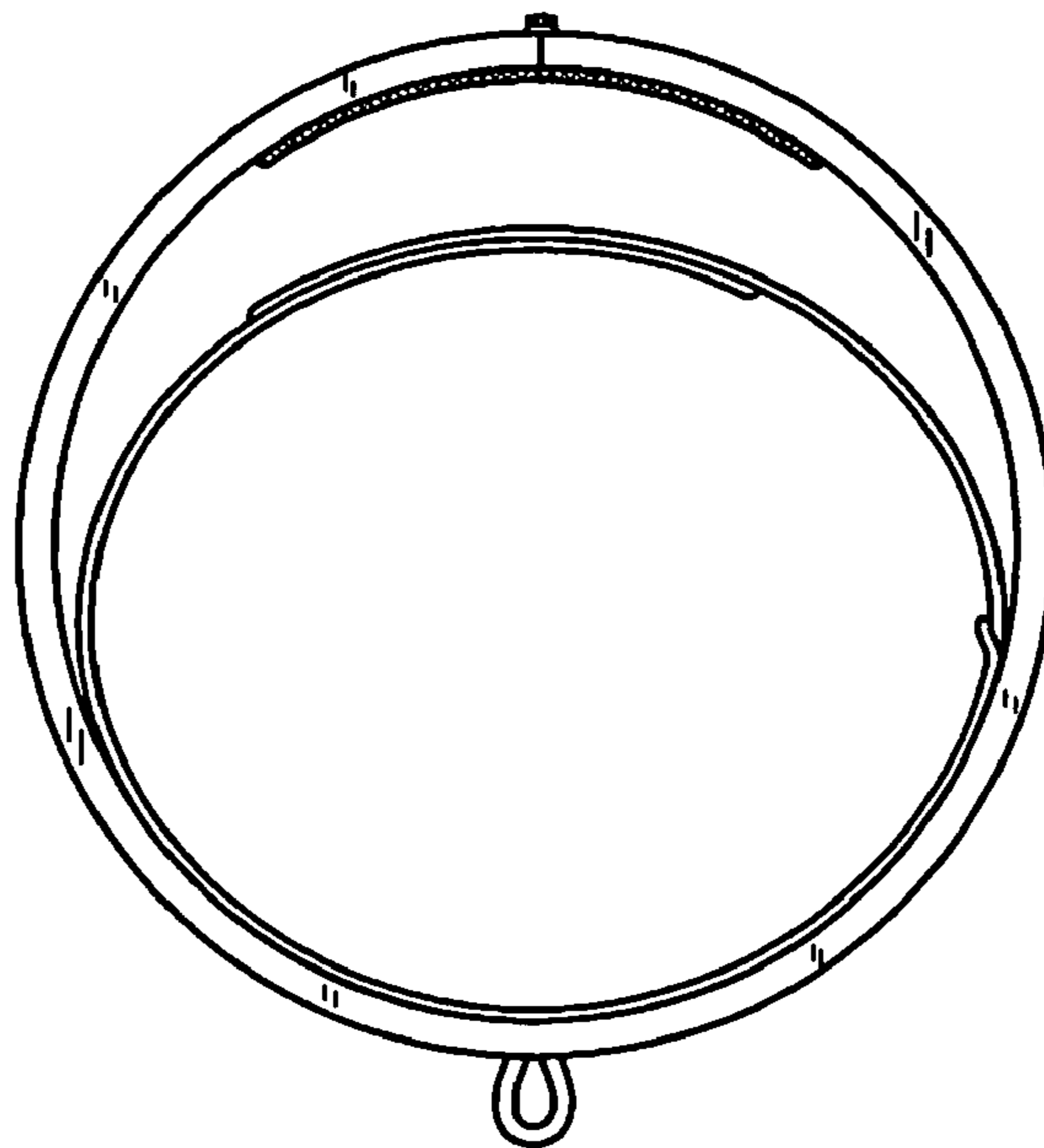

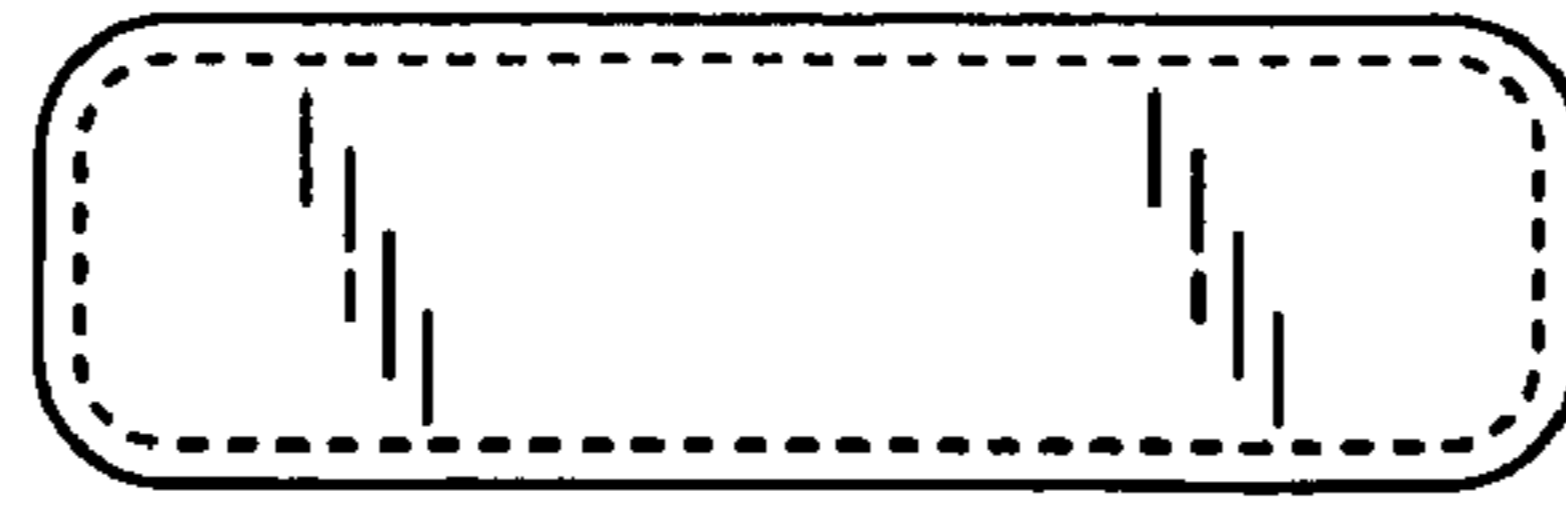

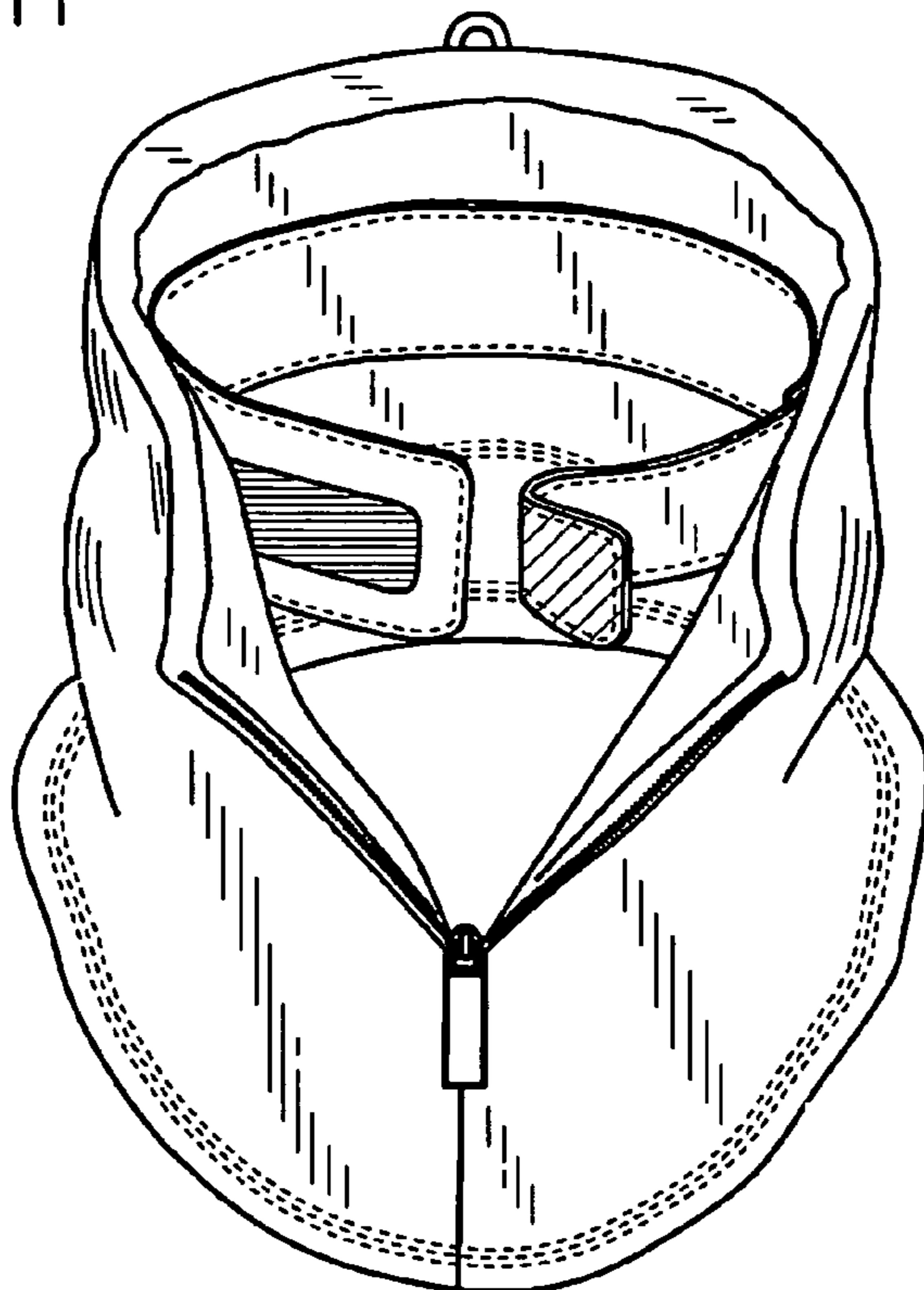
