FIG. 4 is an exploded left side elevational view thereof;

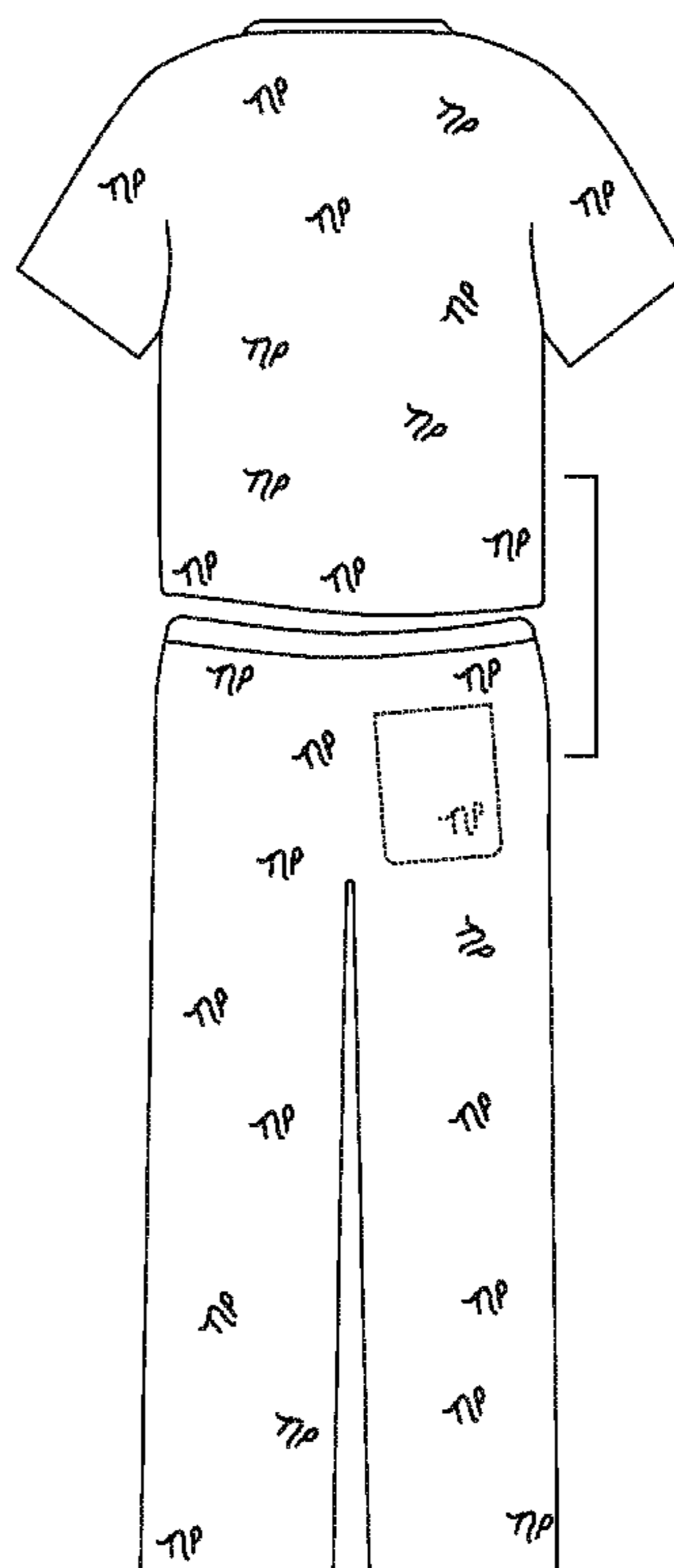
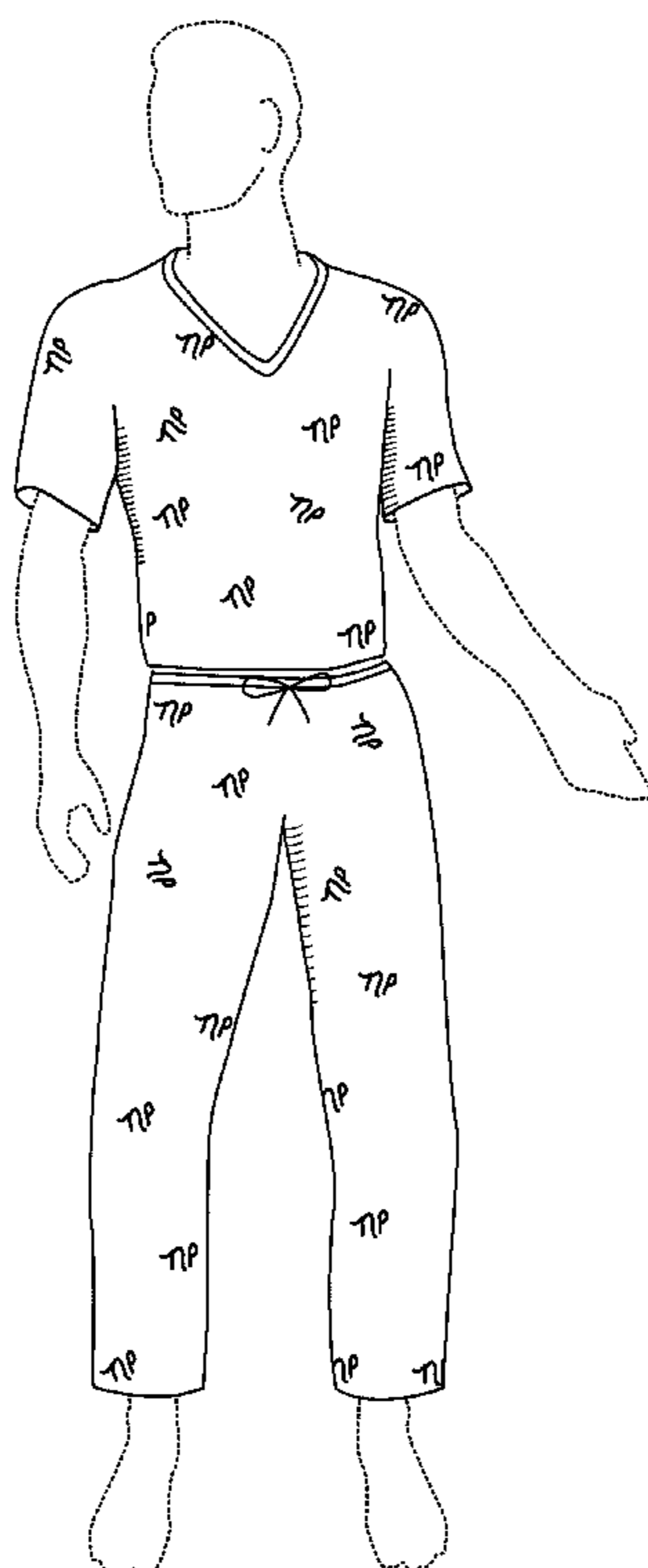
FIG. 5 is an exploded right side elevational view thereof;

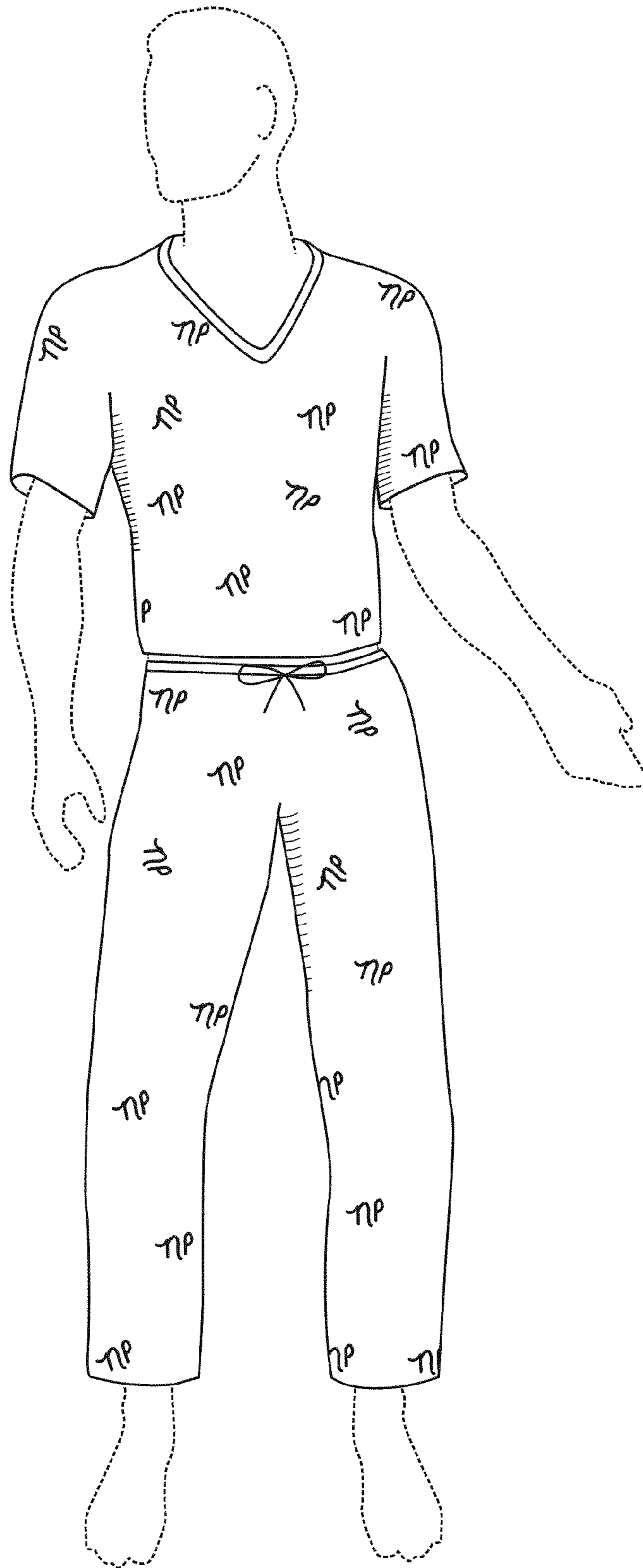

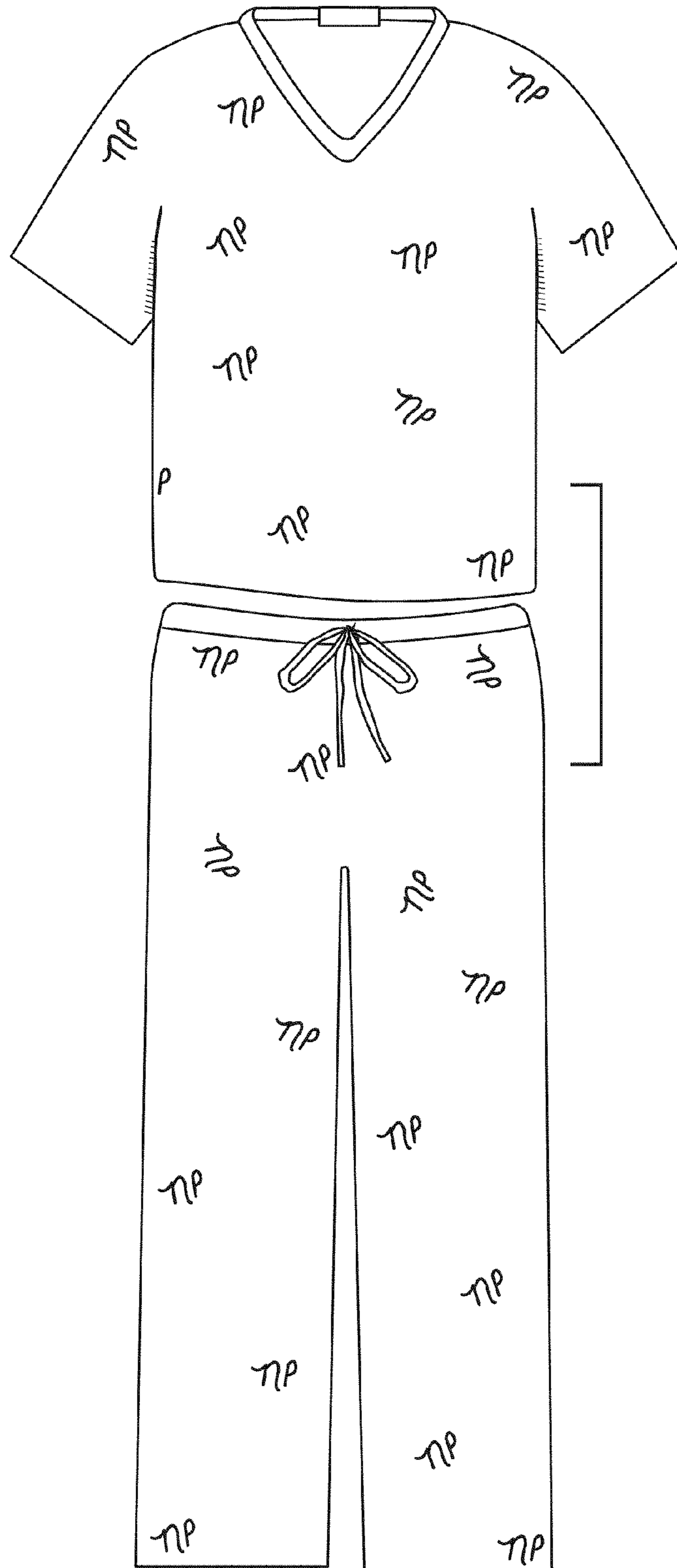

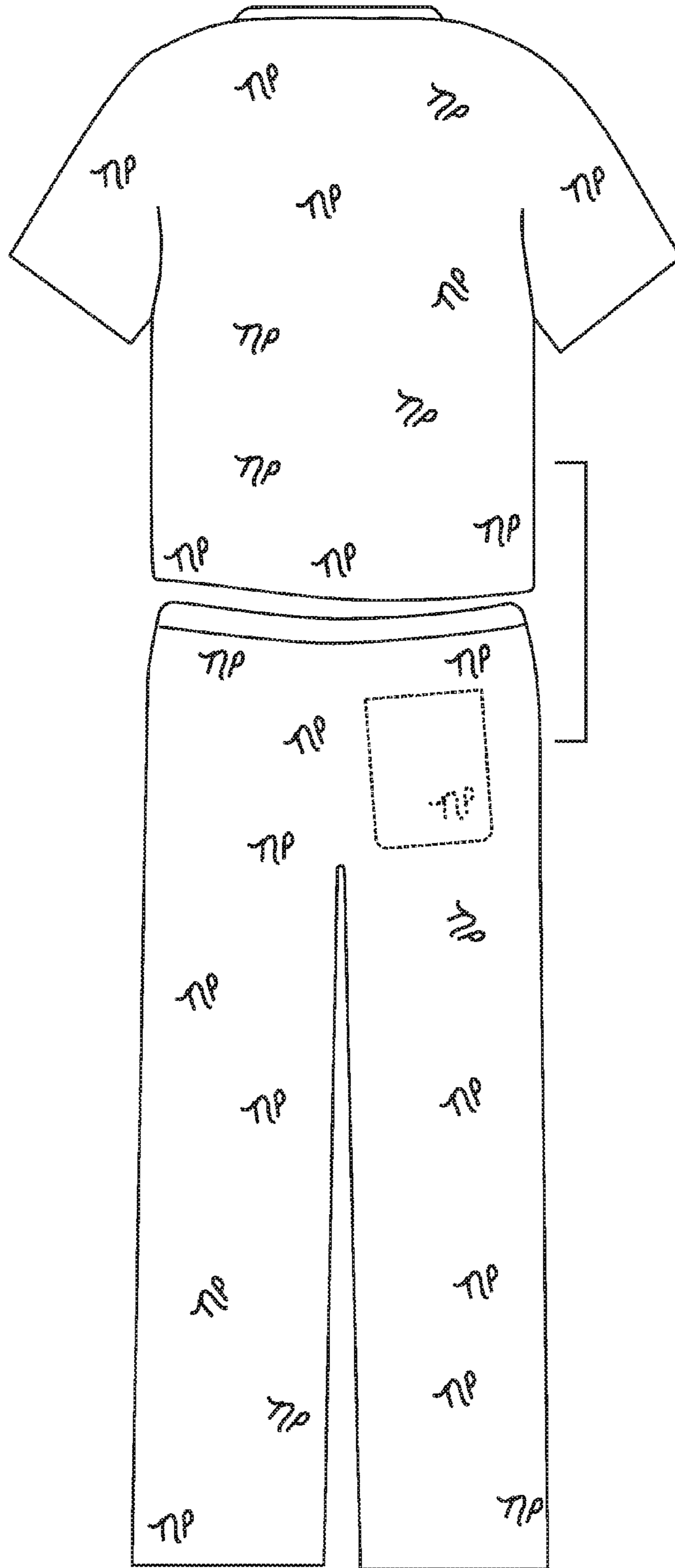

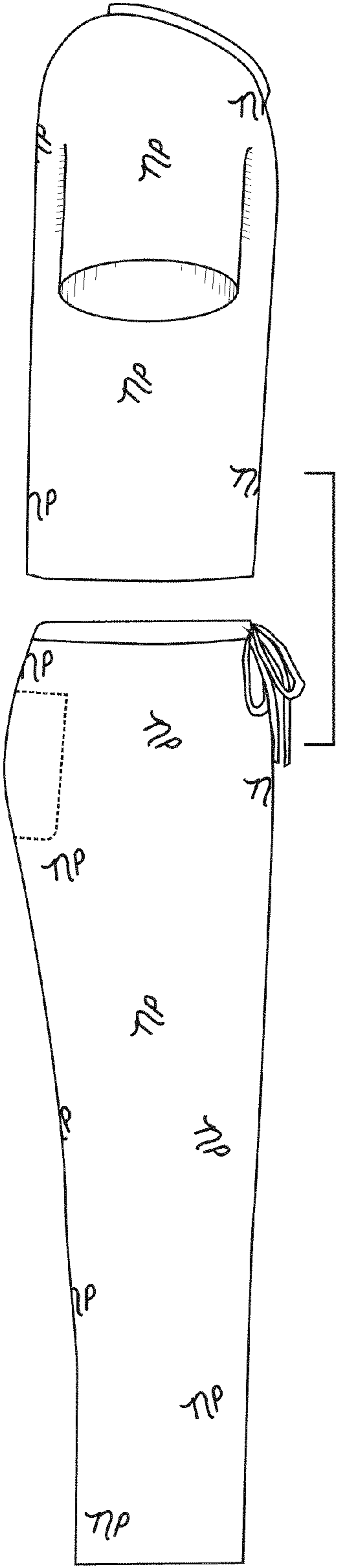

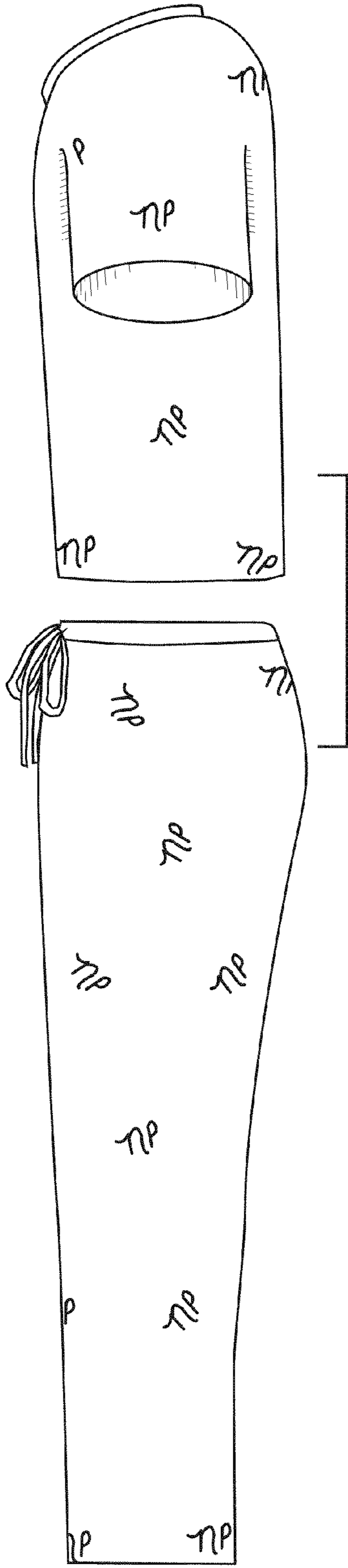

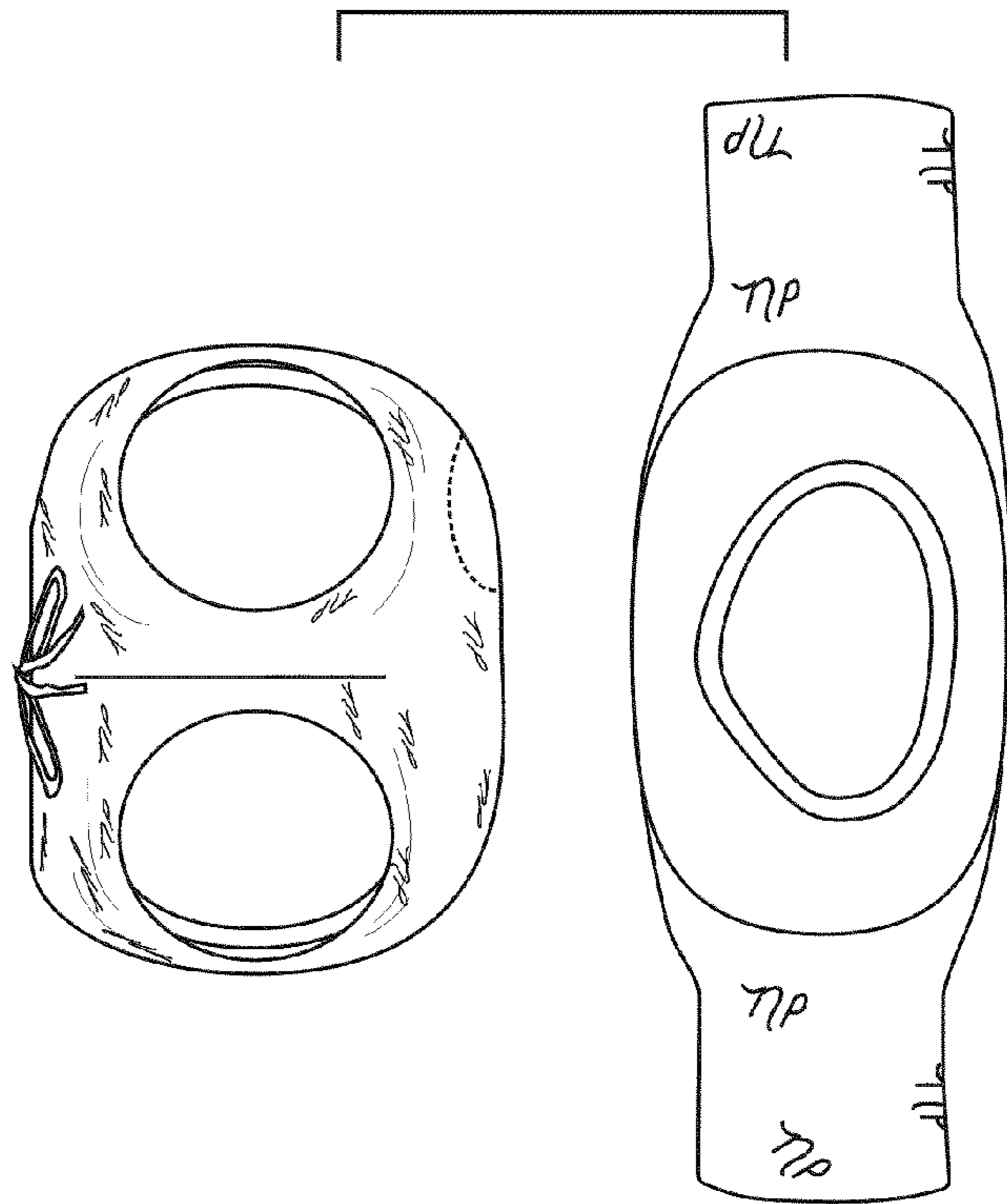

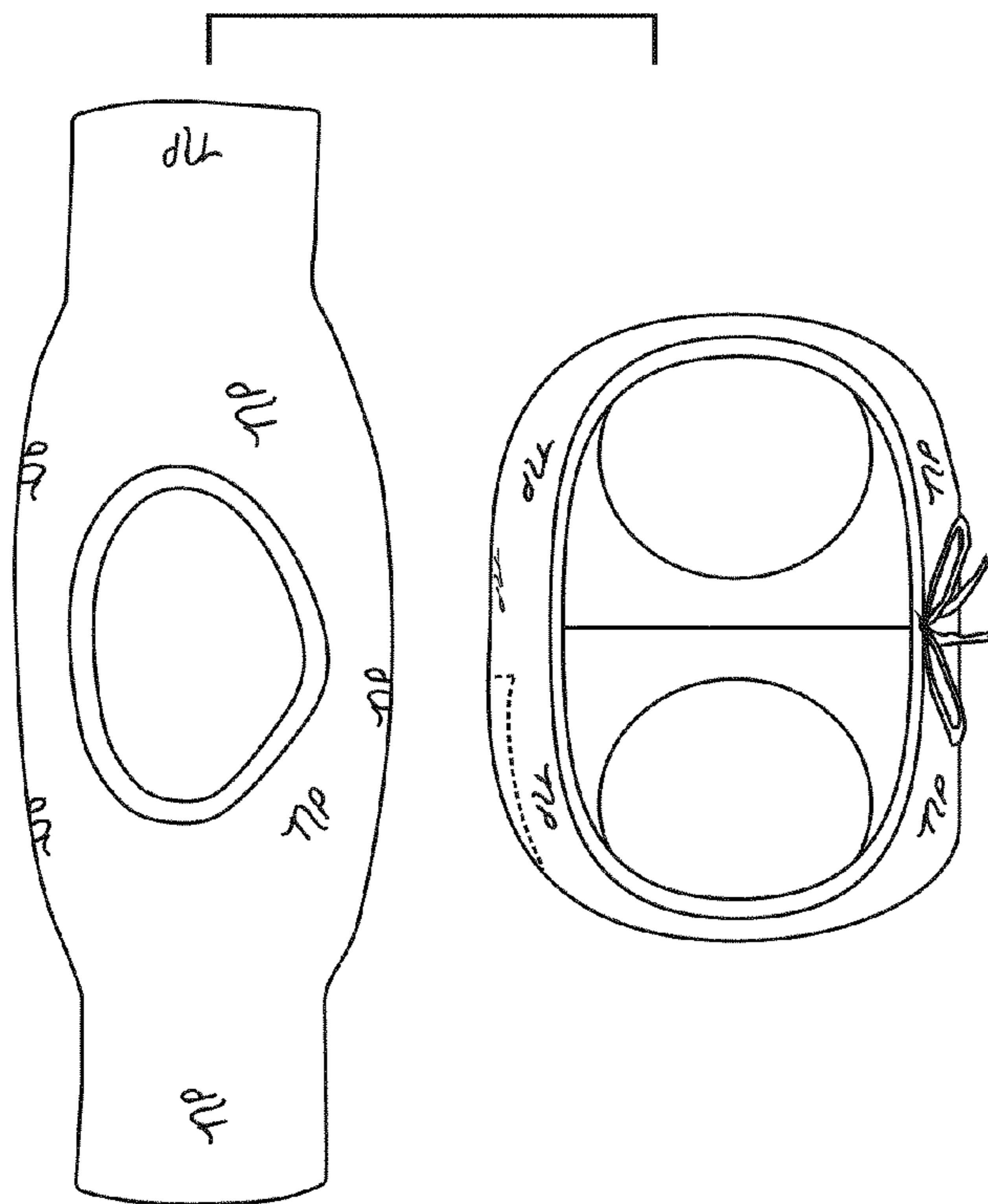
