FIG. 5 is a front view of a jacket according to a second embodiment;

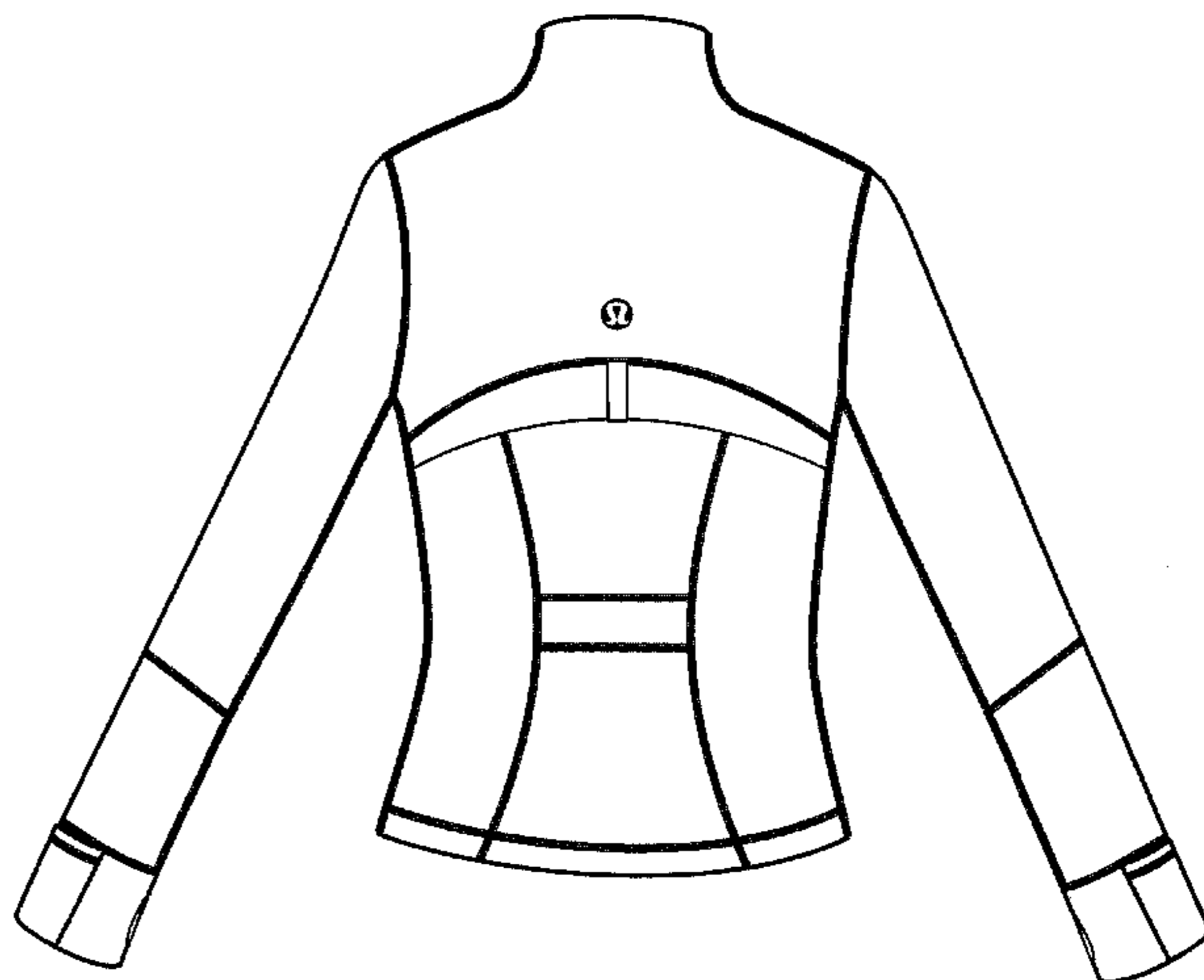
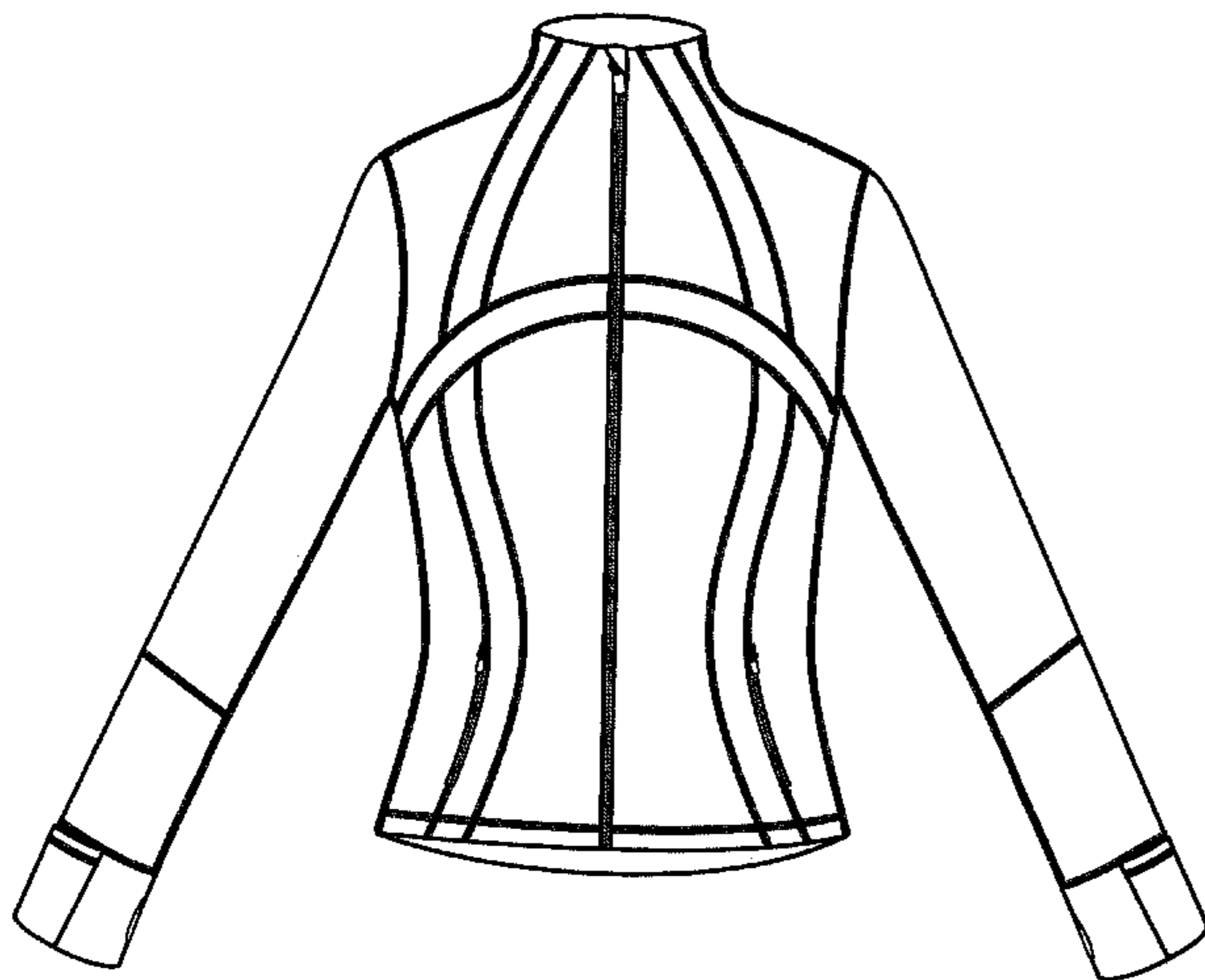
FIG. 6 is a rear view thereof;

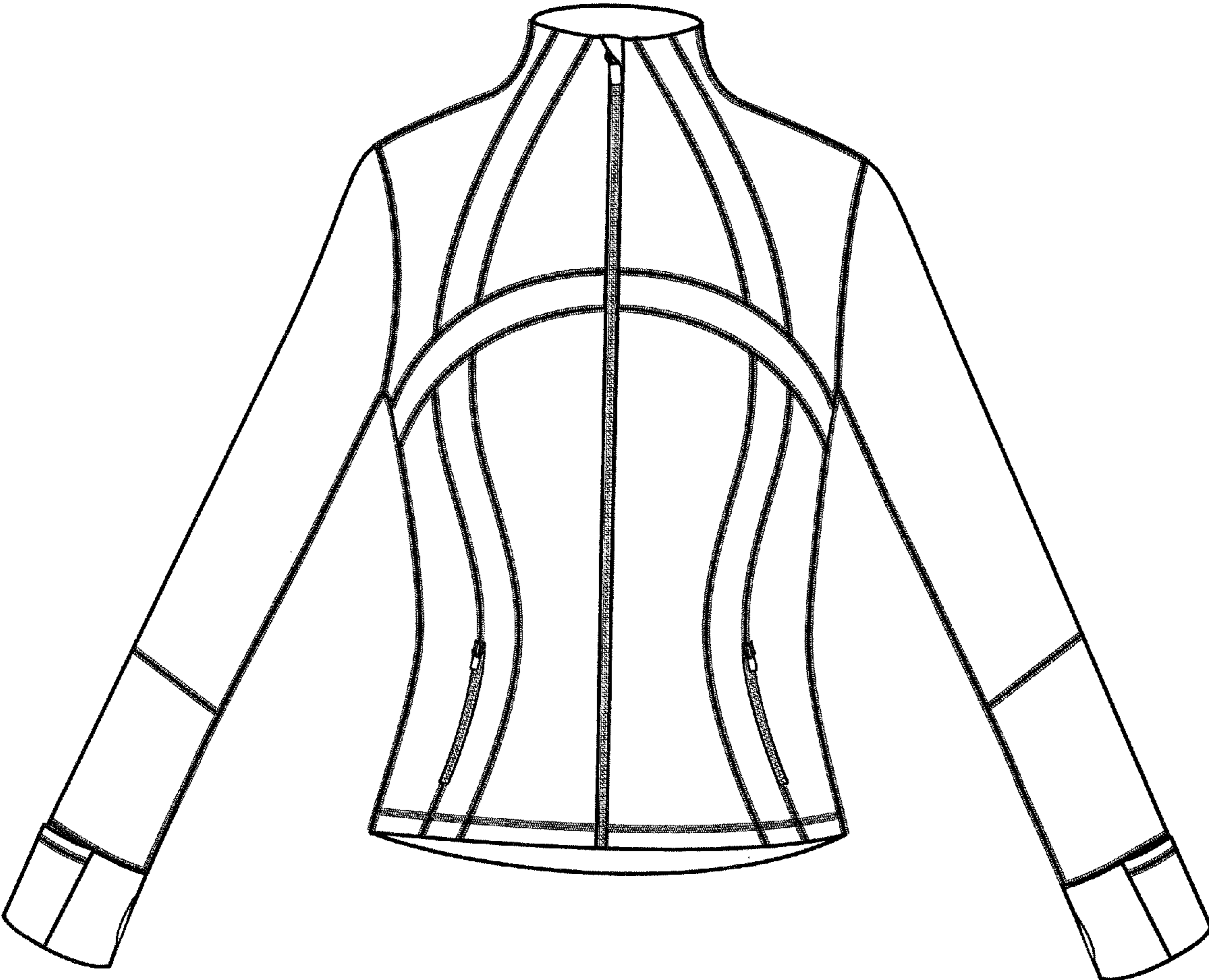

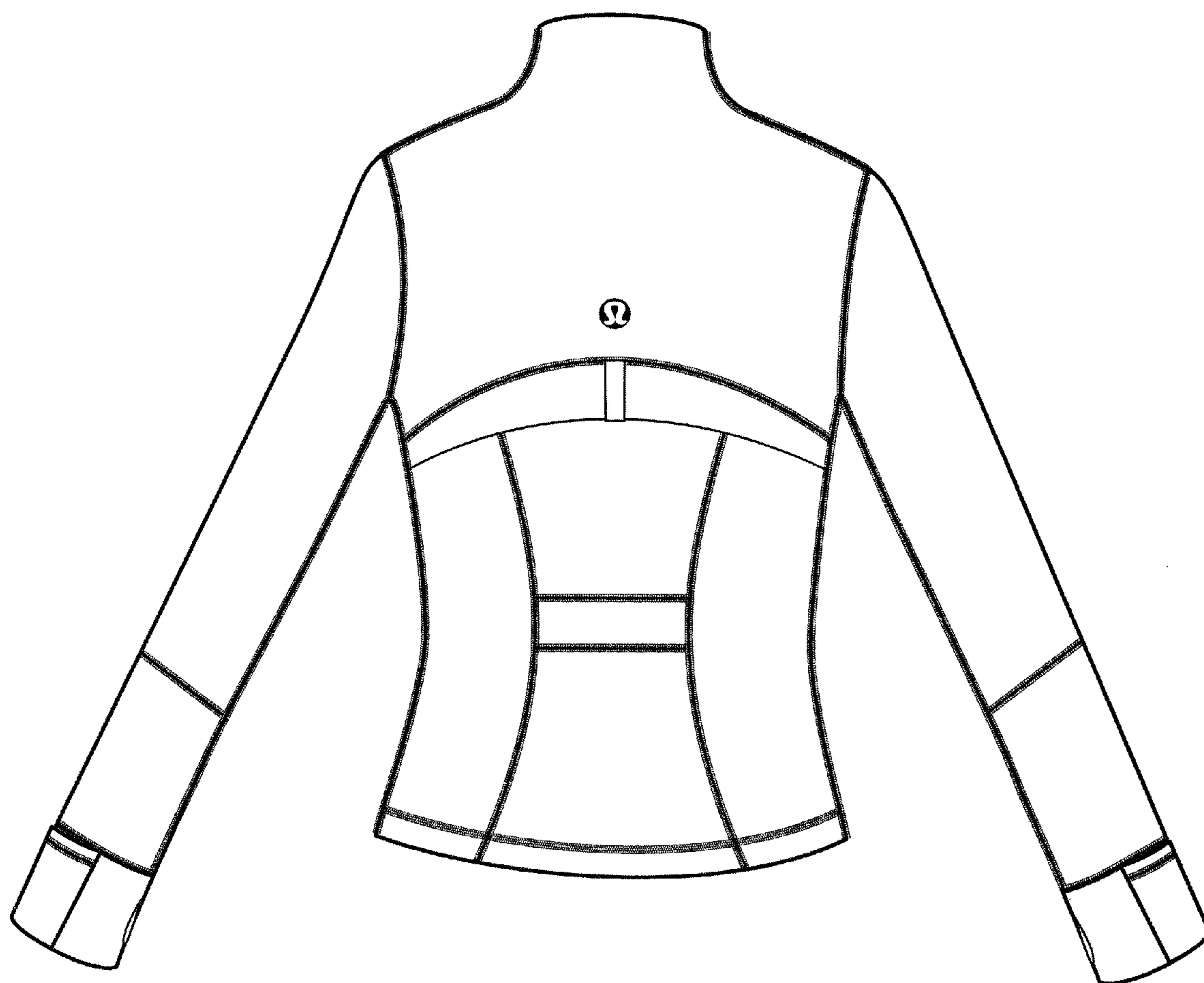

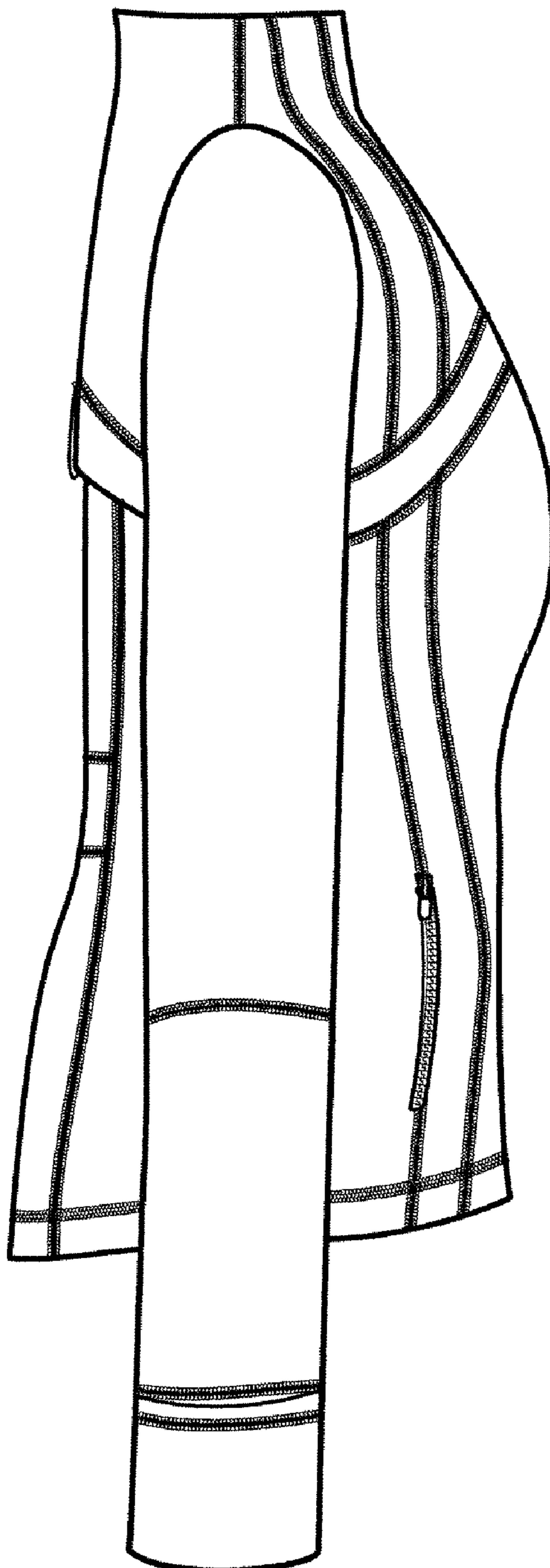

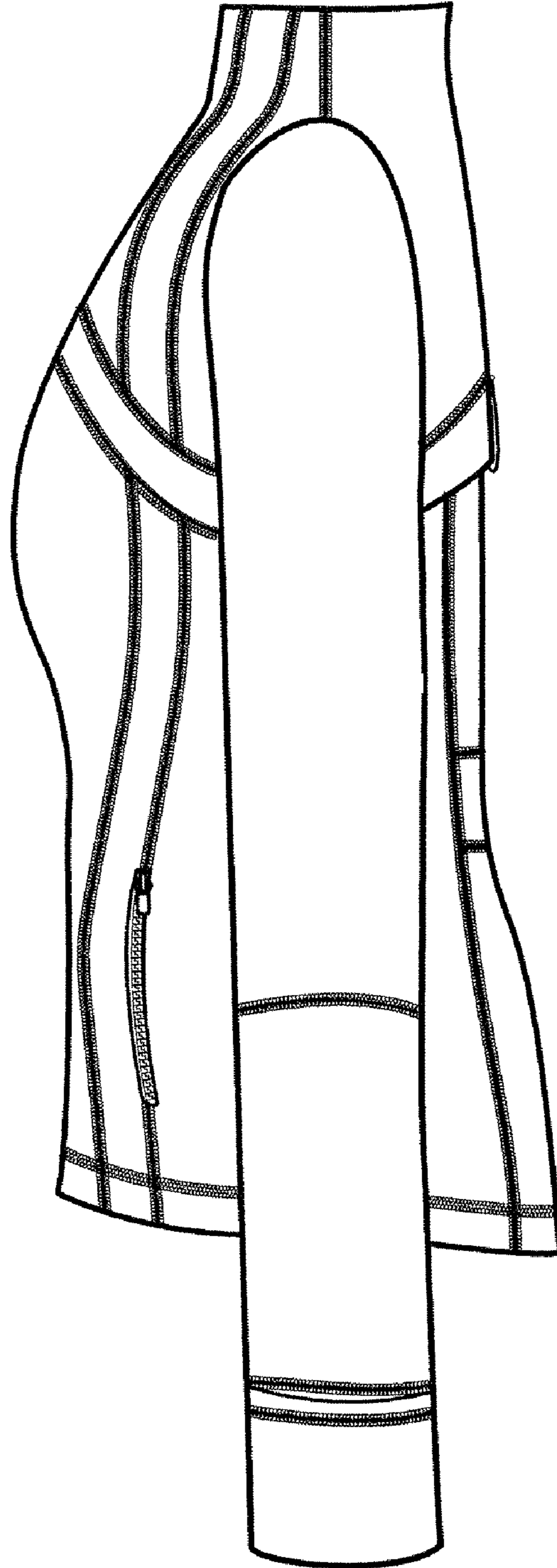

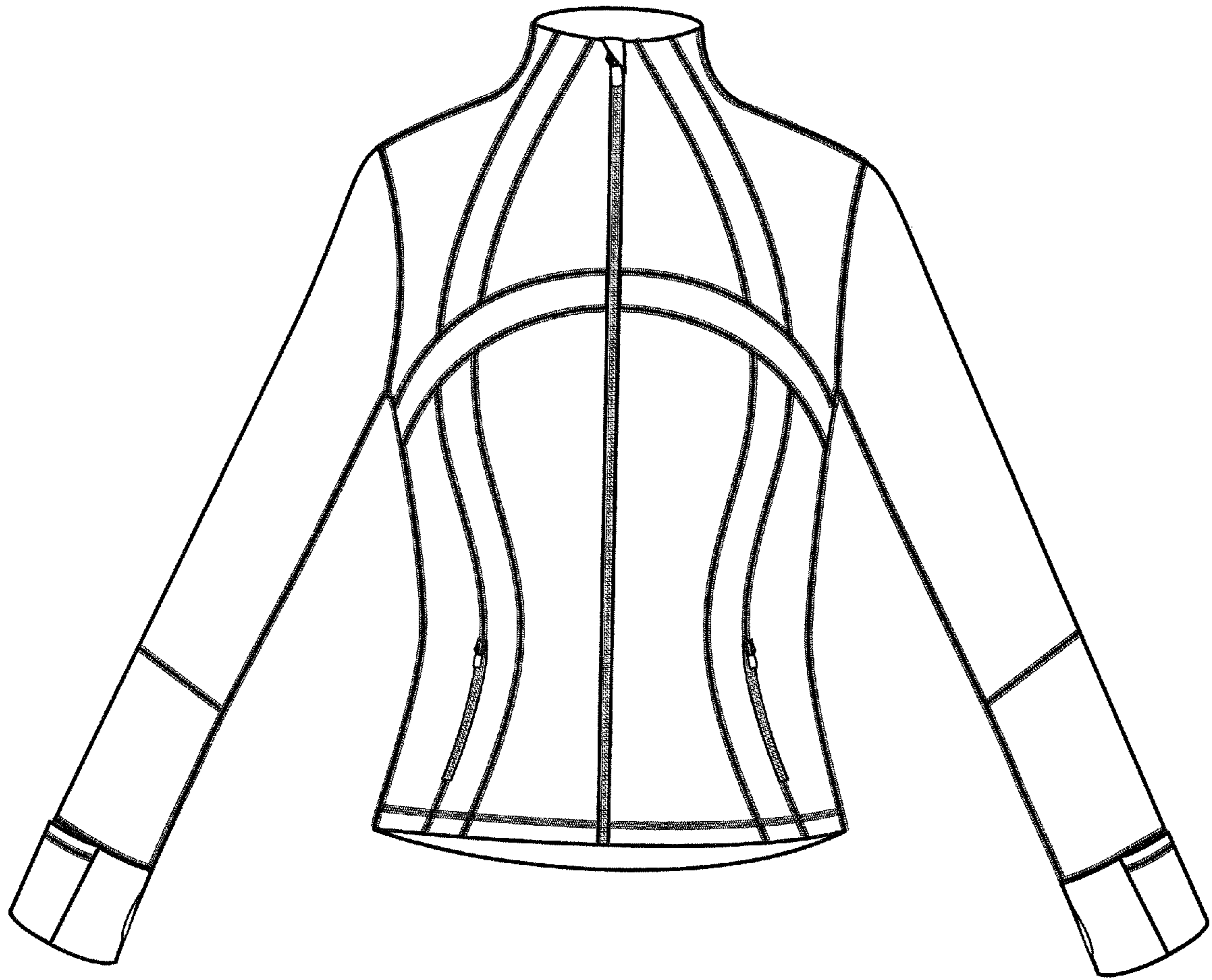

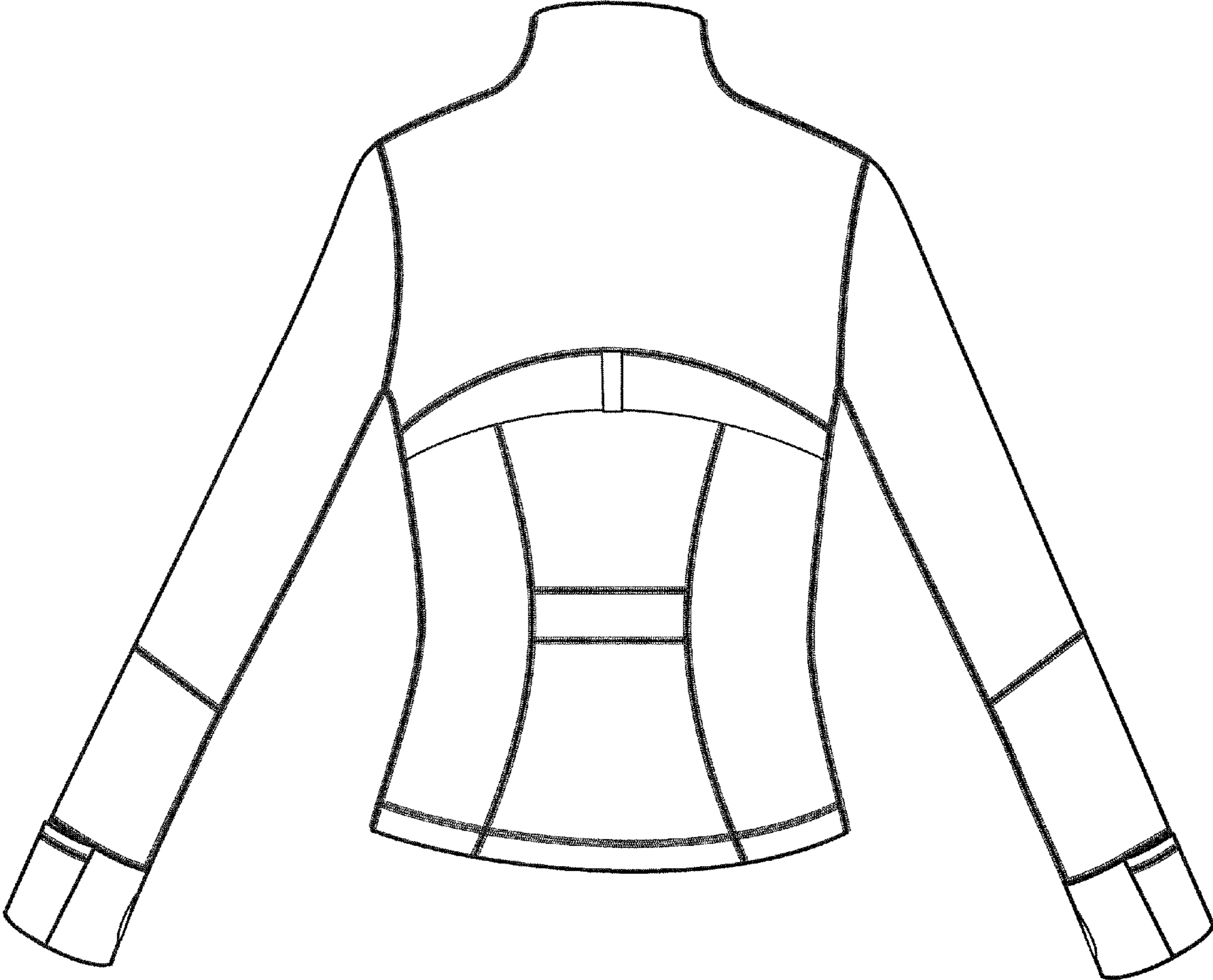

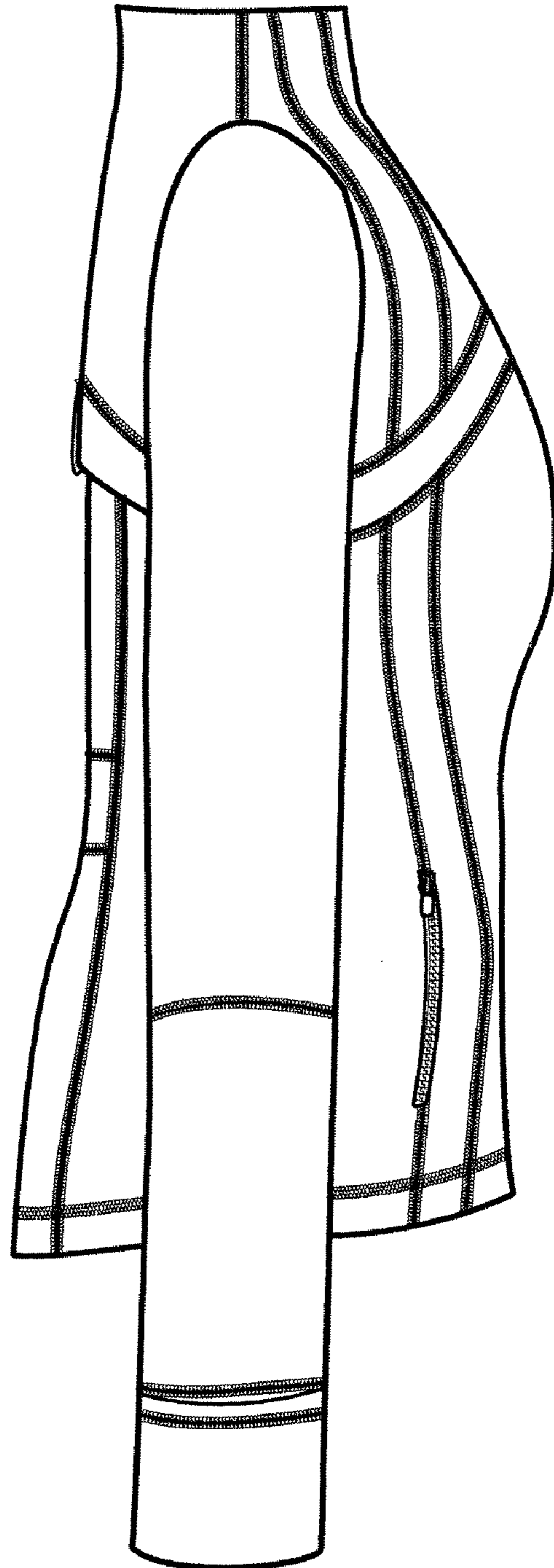

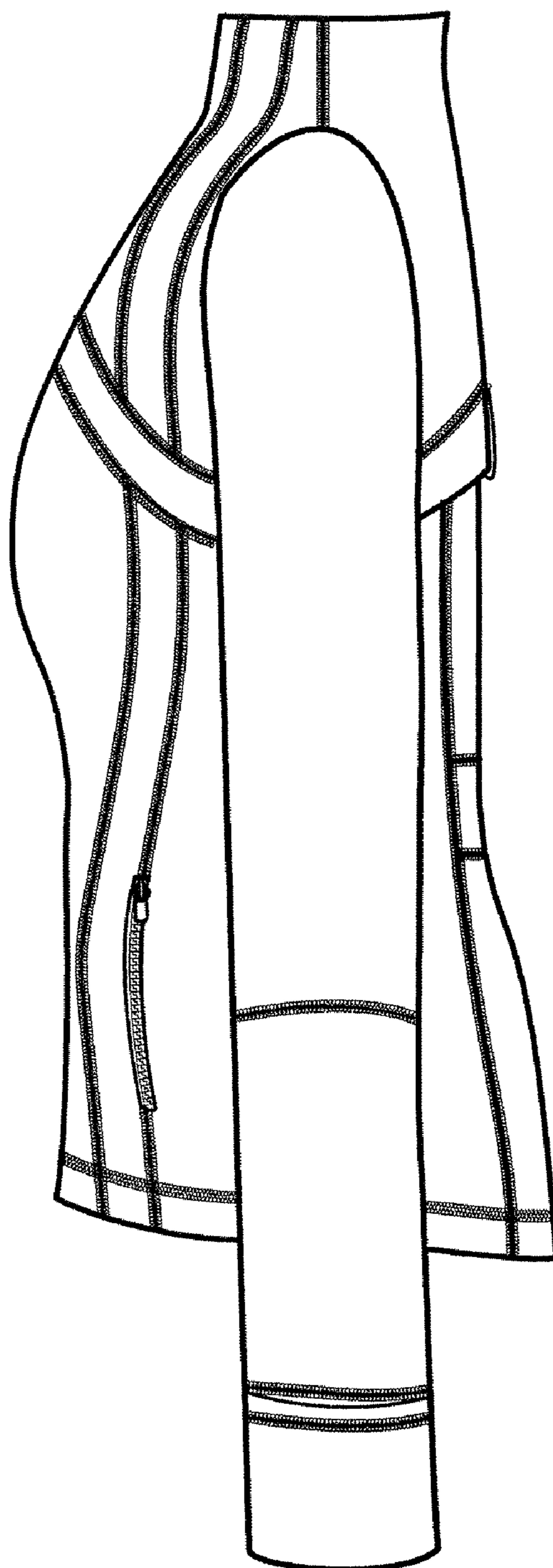
