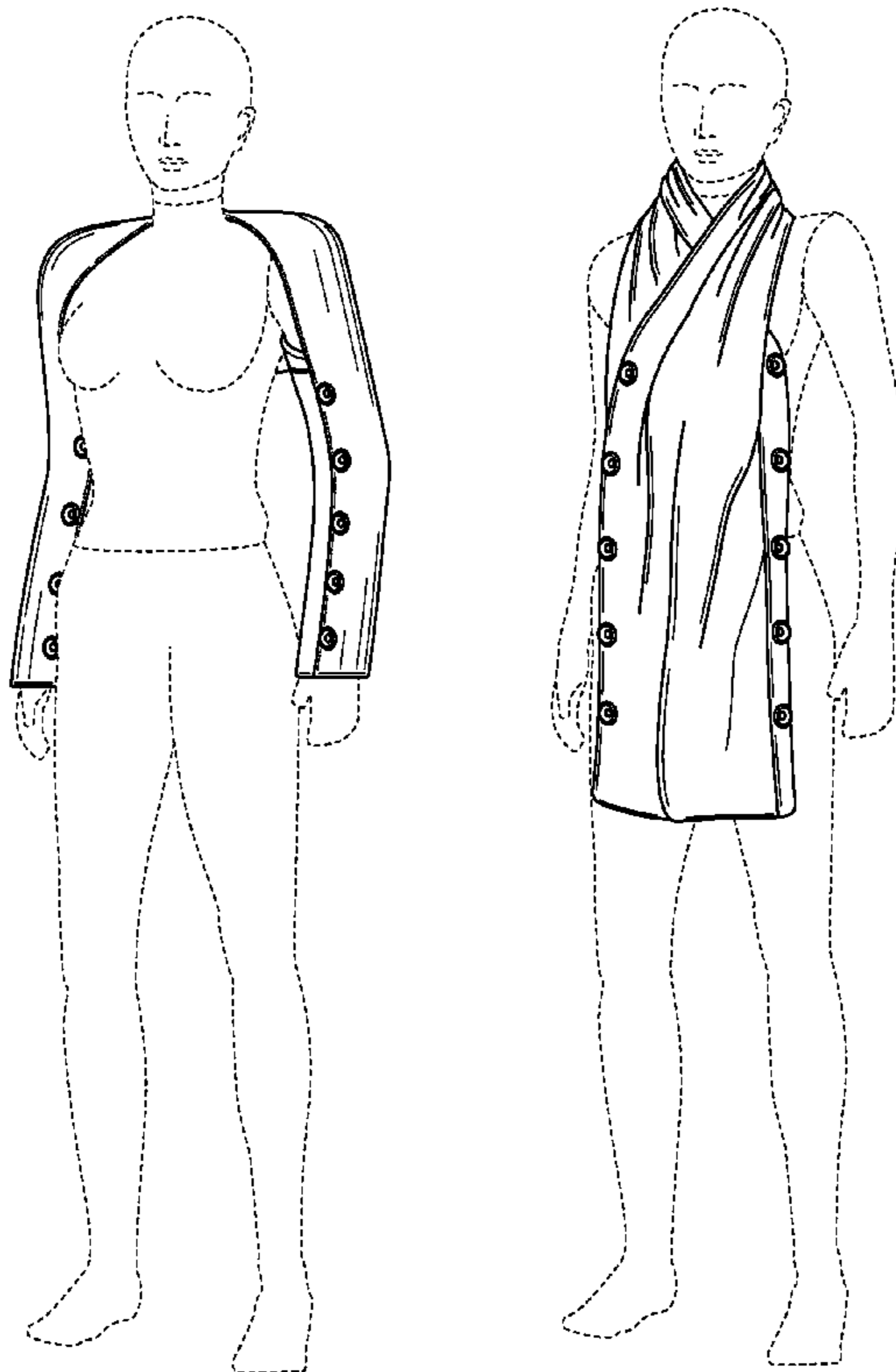

DESCRIPTION

FIG. 1 is a perspective view of apparel, showing my new design;
FIG. 2 is a front elevational view of the apparel of FIG. 1.
FIG. 3 is a rear elevational view of the apparel of FIG. 1.
FIG. 4 is a left elevational view of the apparel of FIG. 1.
FIG. 5 is a right elevational view of the apparel of FIG. 1.
FIG. 6 is a perspective view of the apparel, shown in an alternate configuration and draped around the wearer's neck; and,
FIG. 7 is a top plan view of the apparel, shown completely flat.
The broken lines are included for illustrative purposes only and form no part of the claimed design.

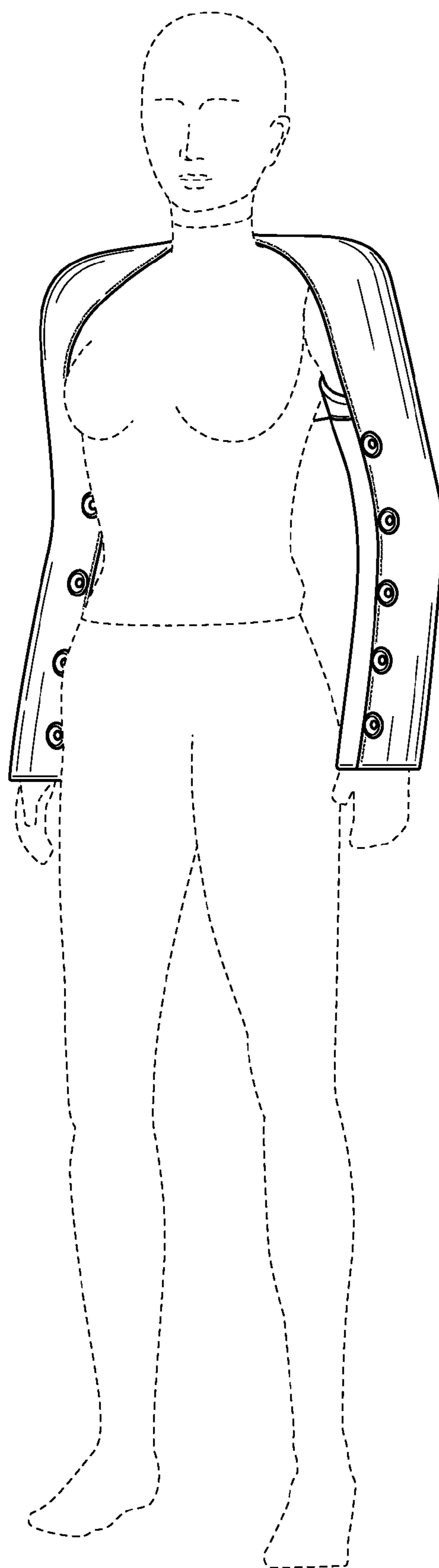

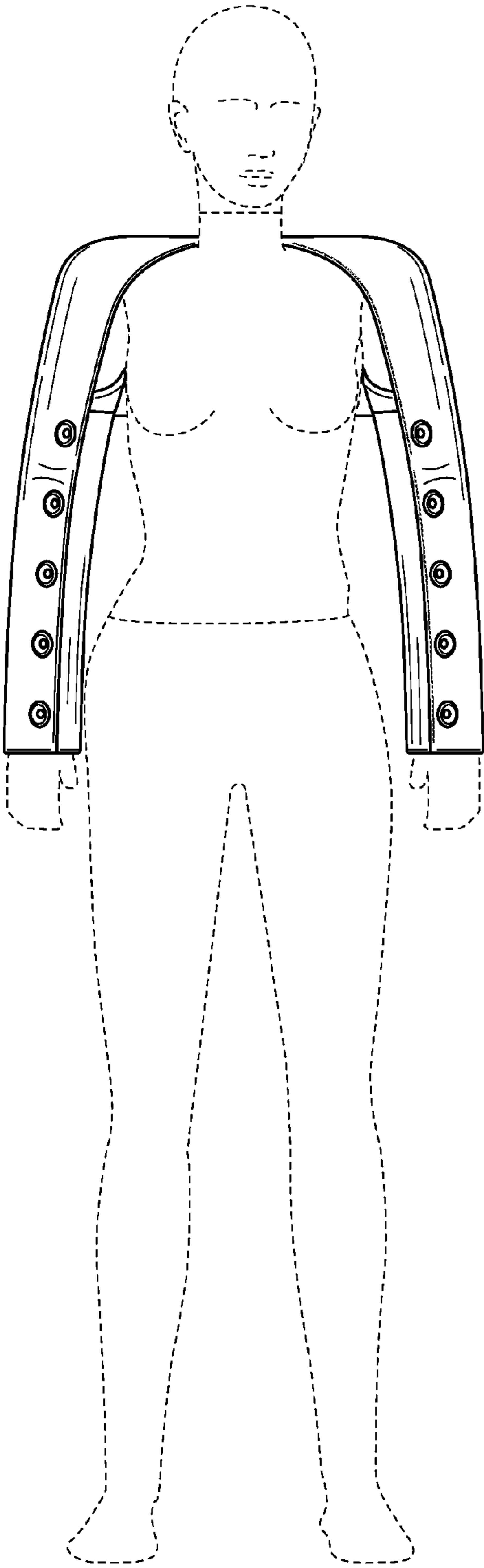

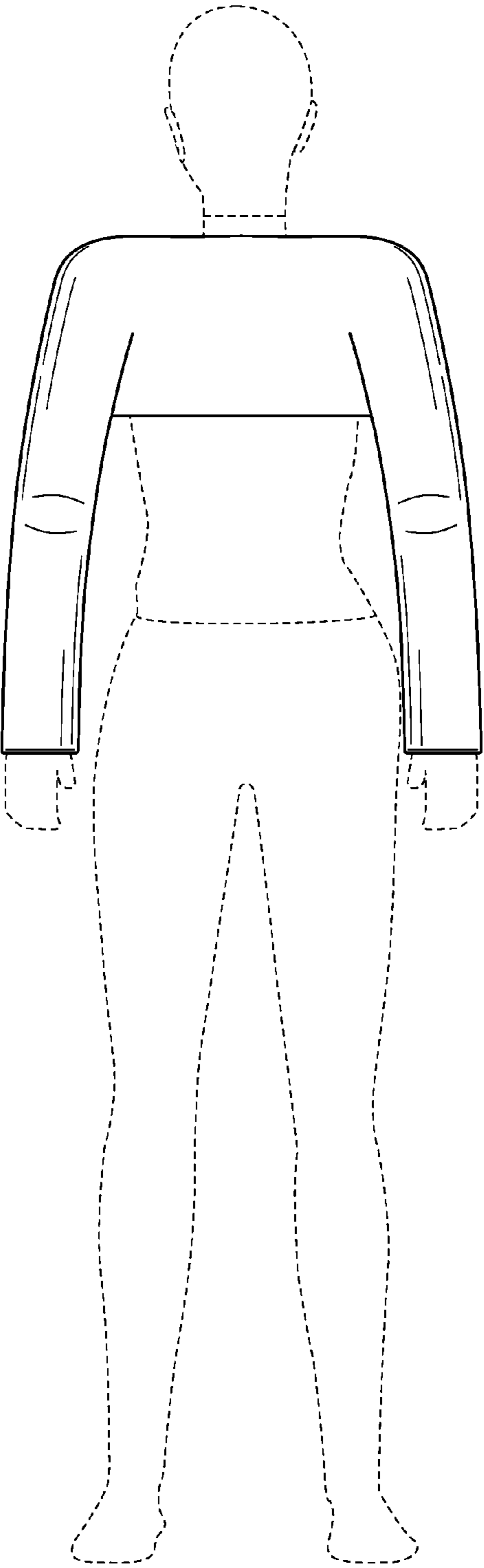

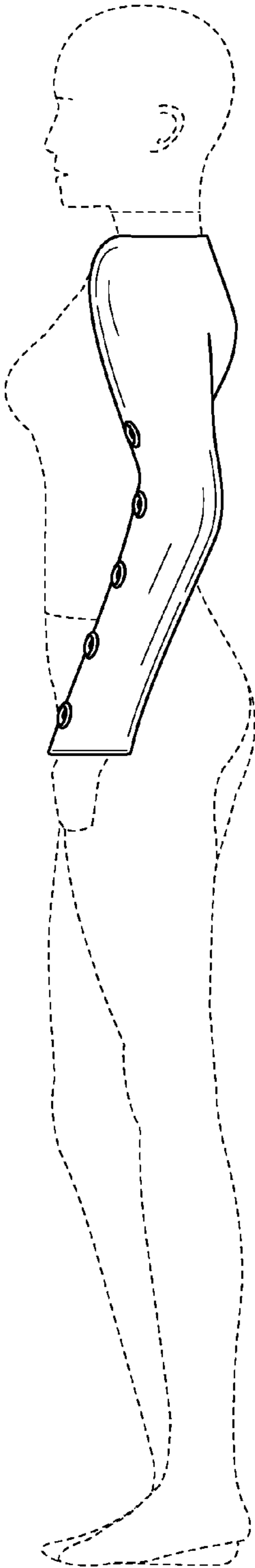

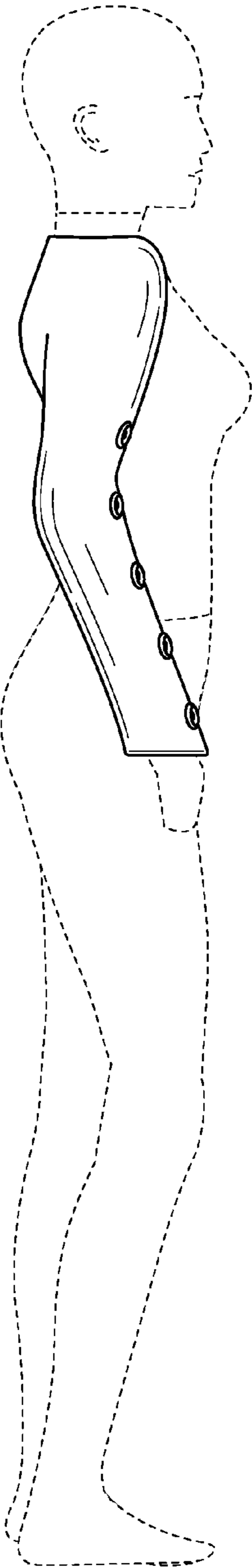

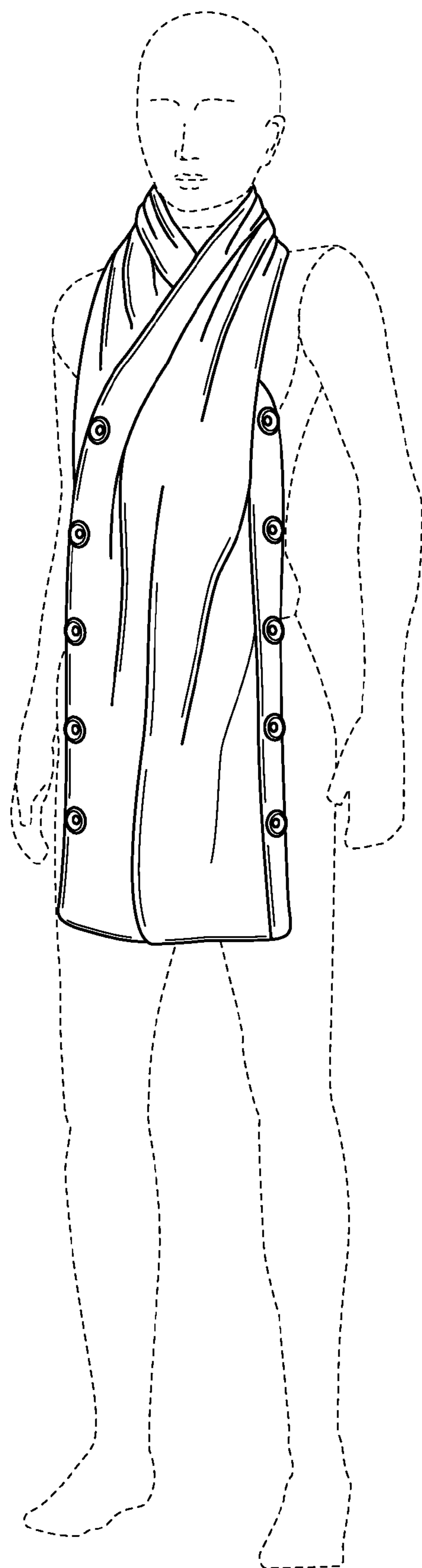

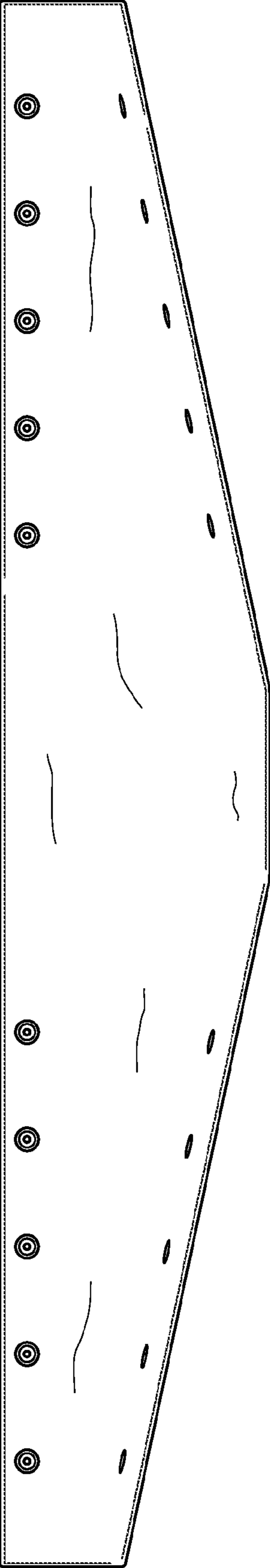
