FIG. 4 is a bottom view of the shoe of the present design.

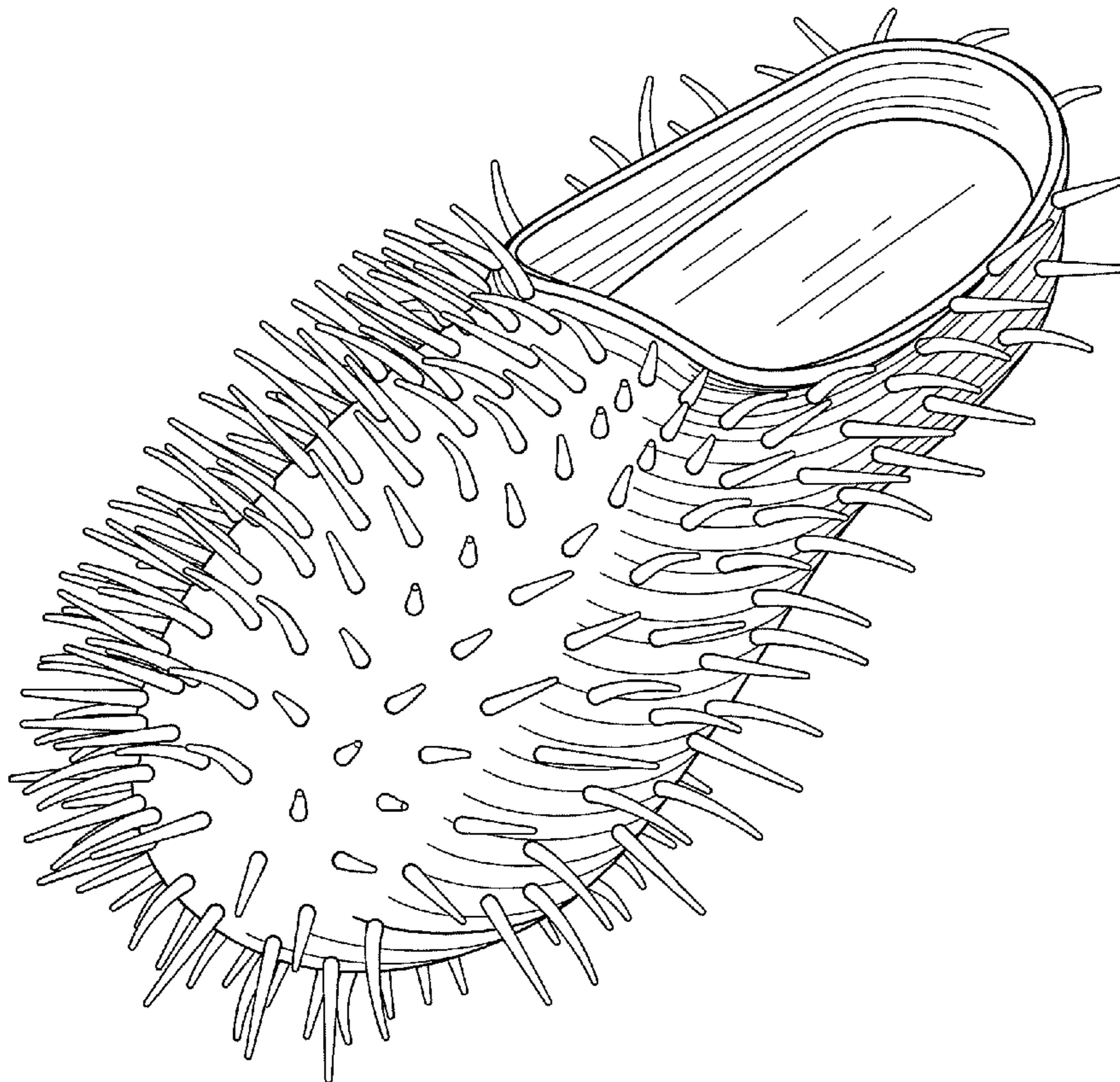
FIG. 5 is a right view of the shoe of the present design.

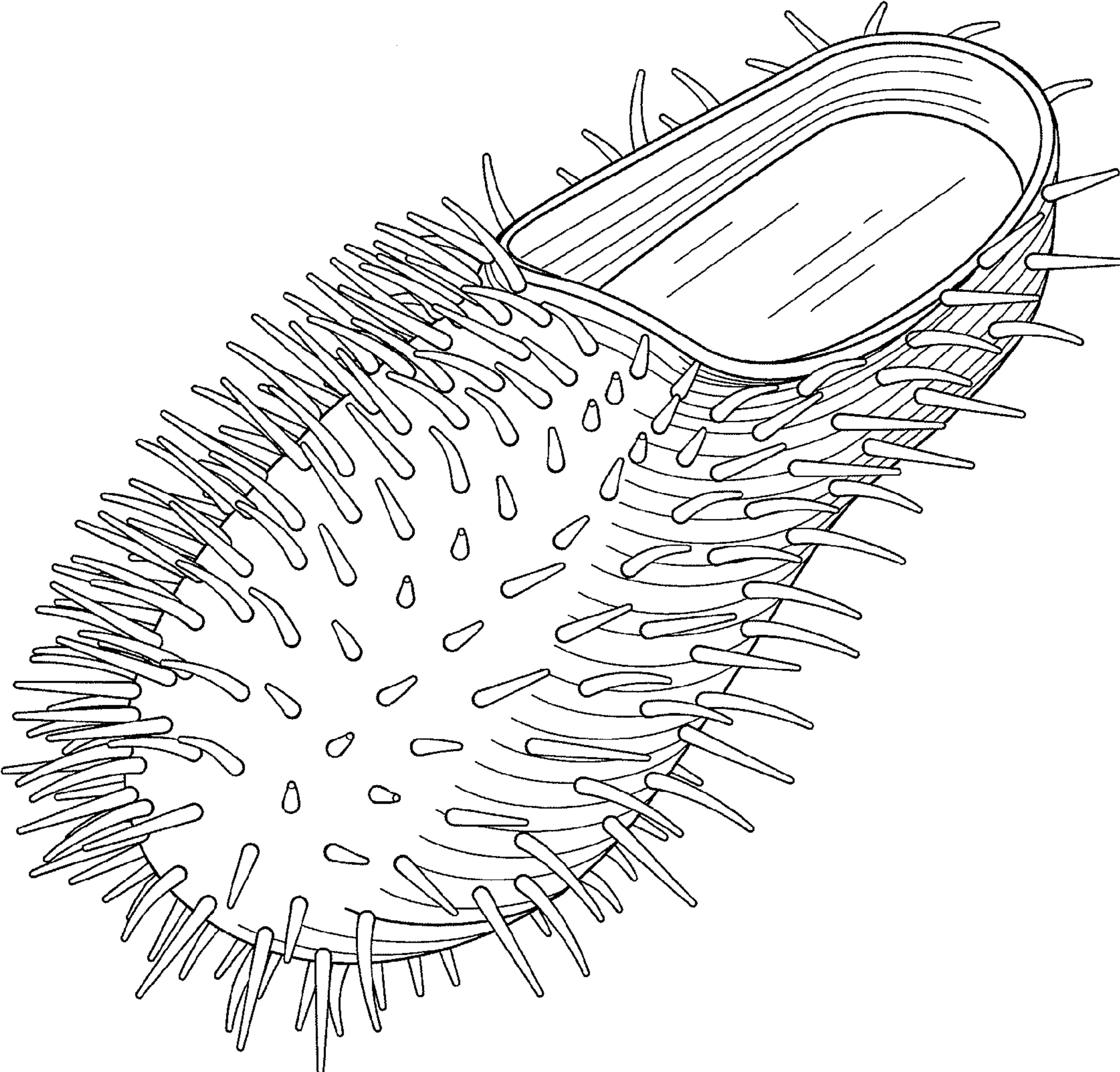

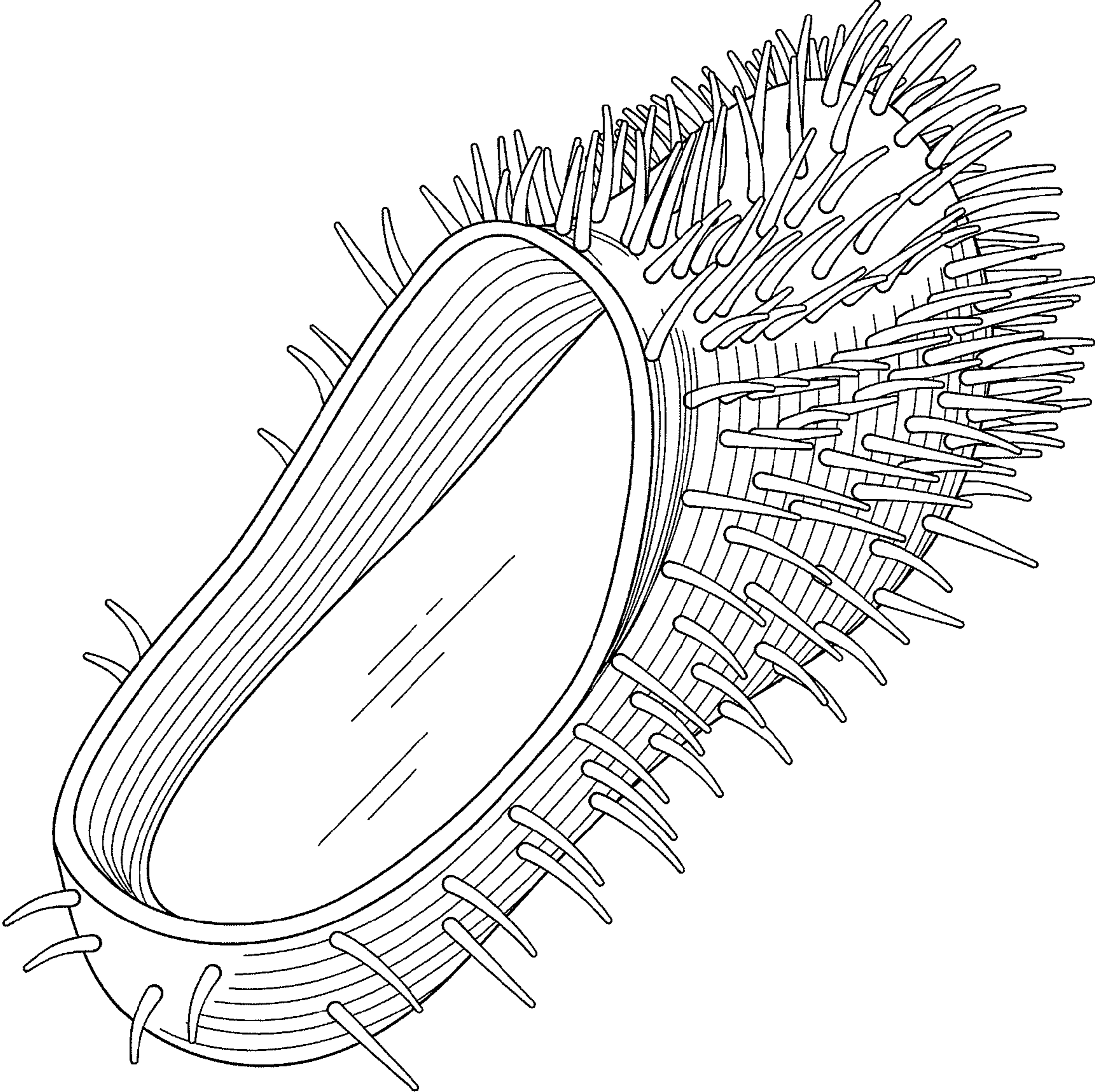

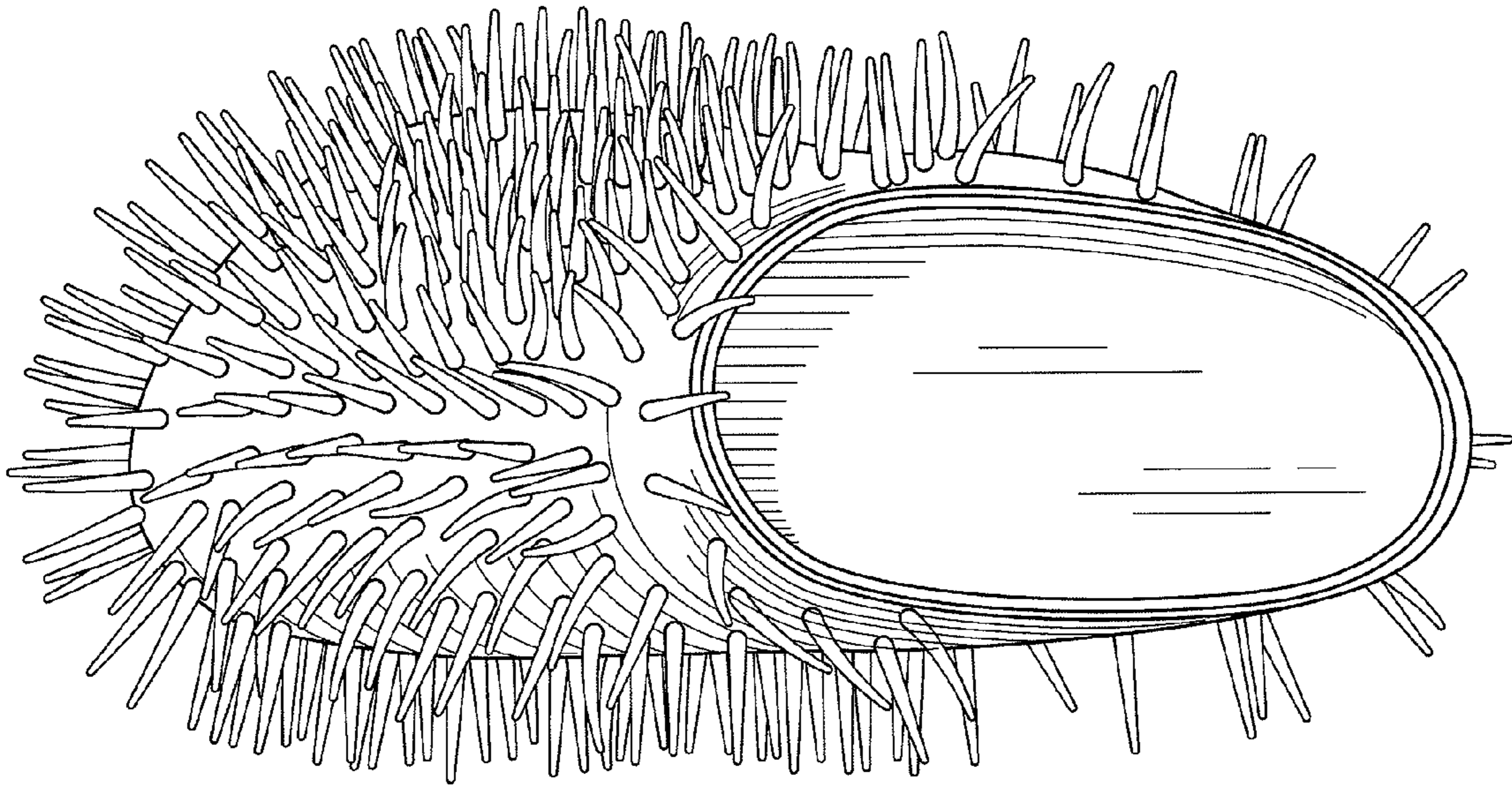

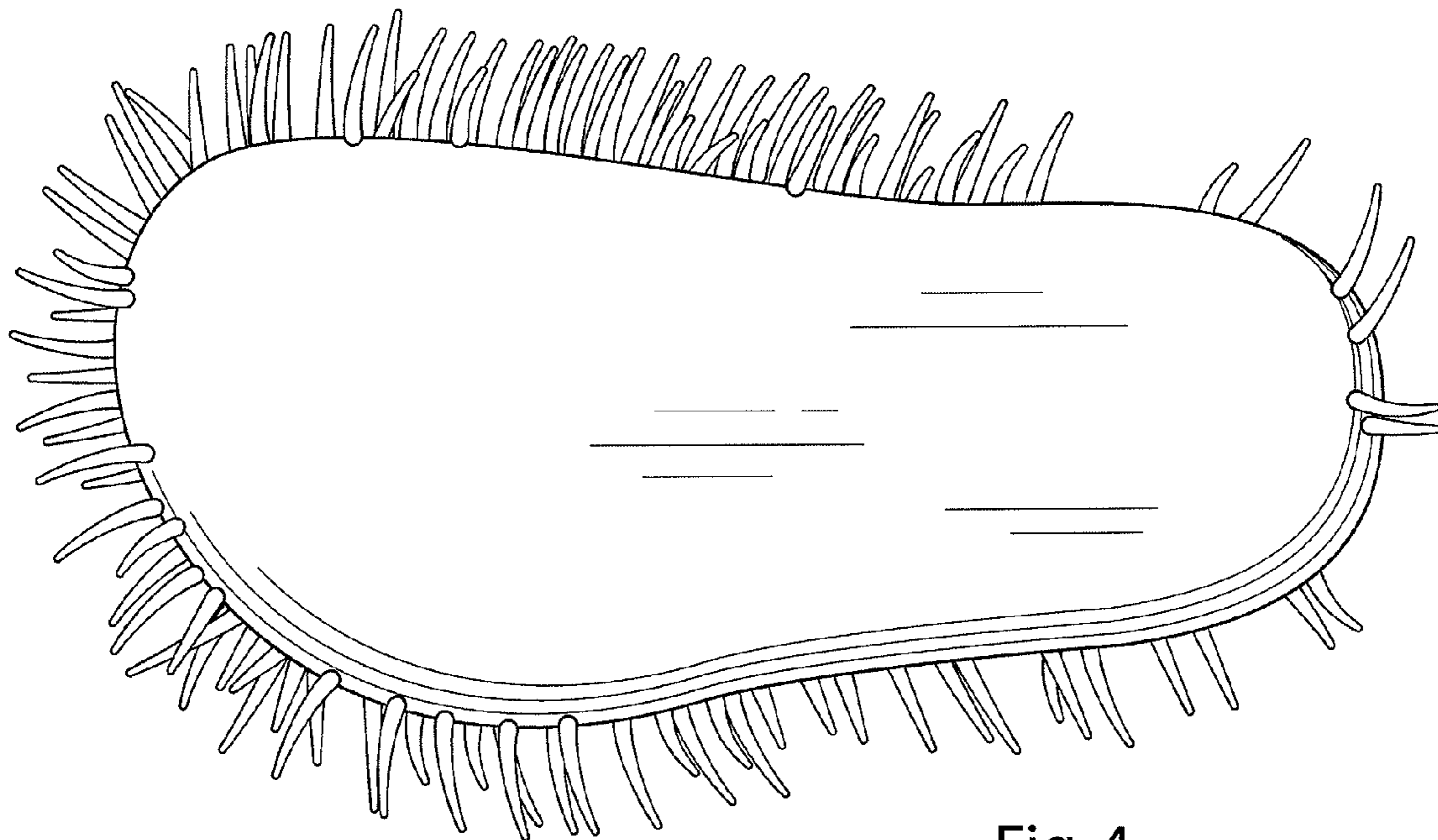

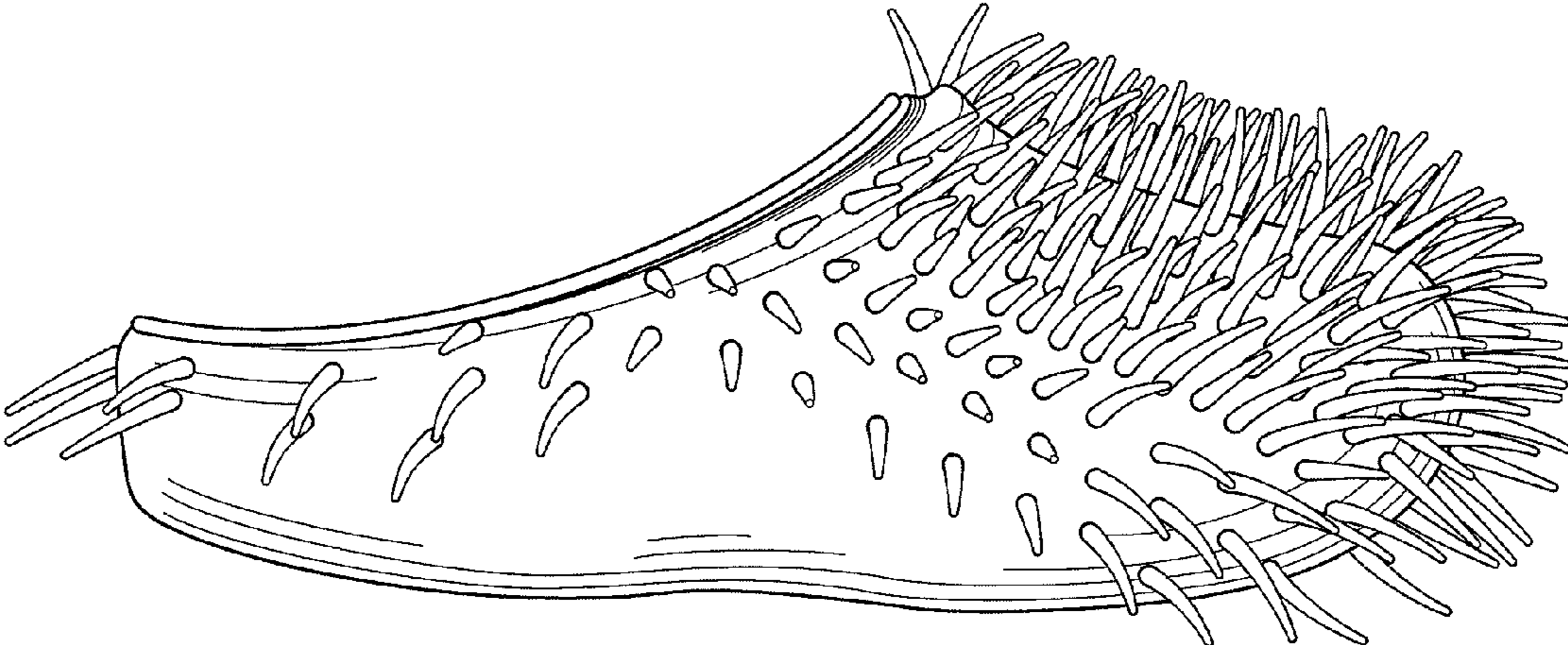

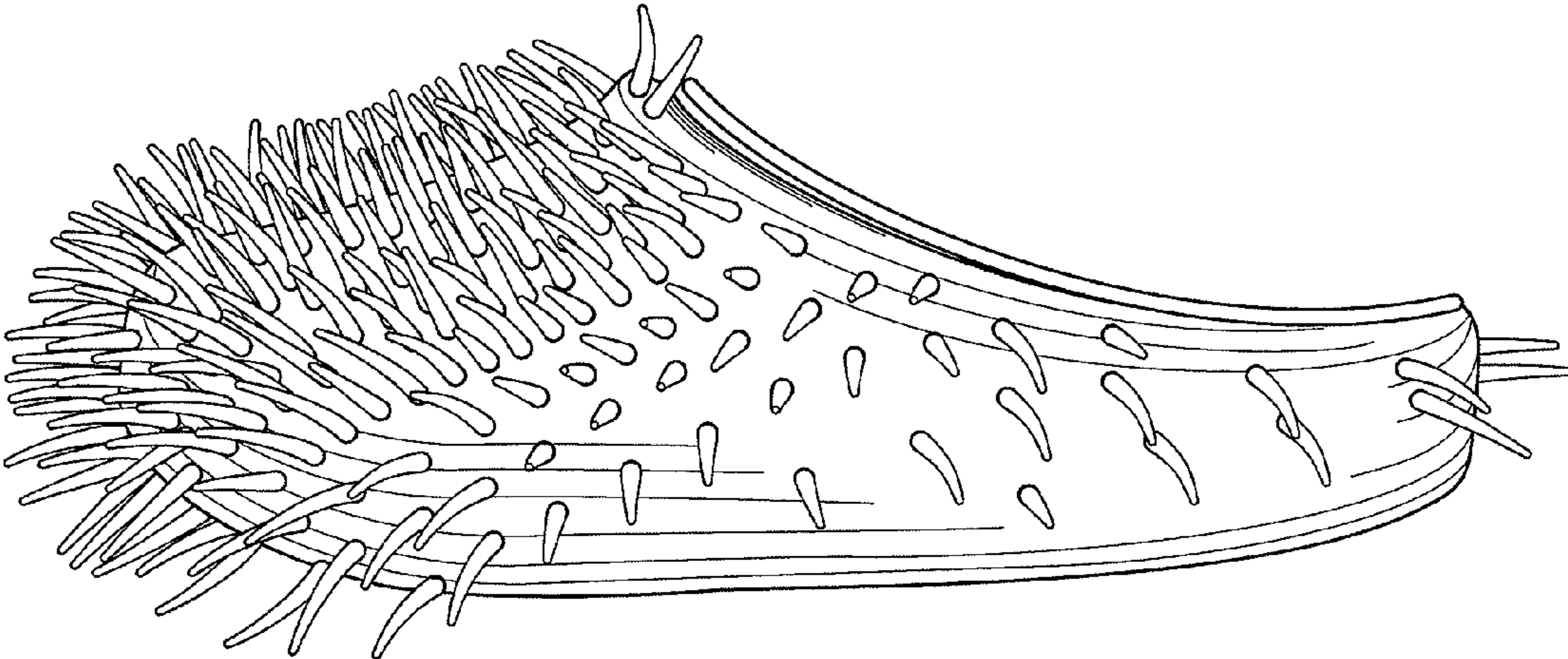

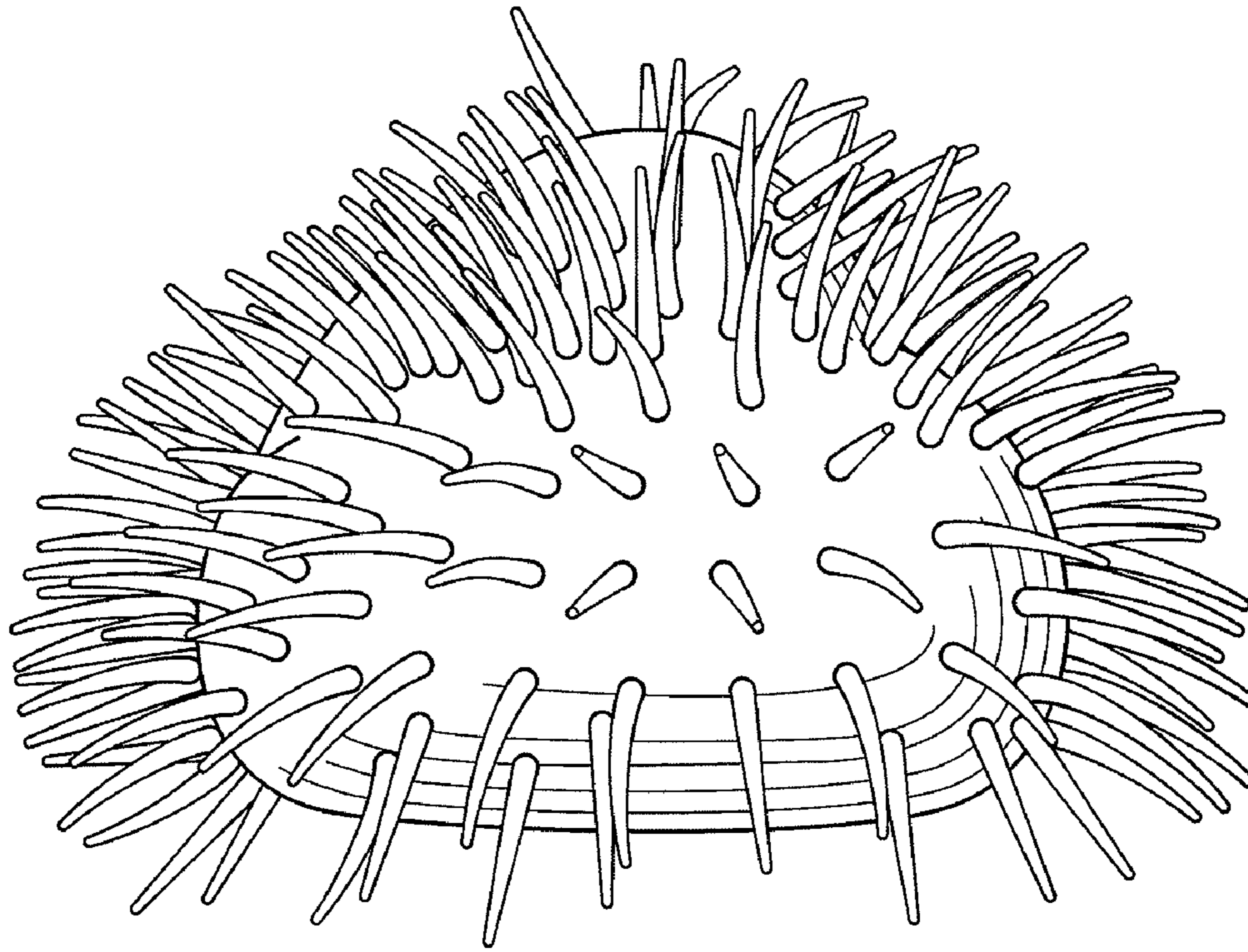

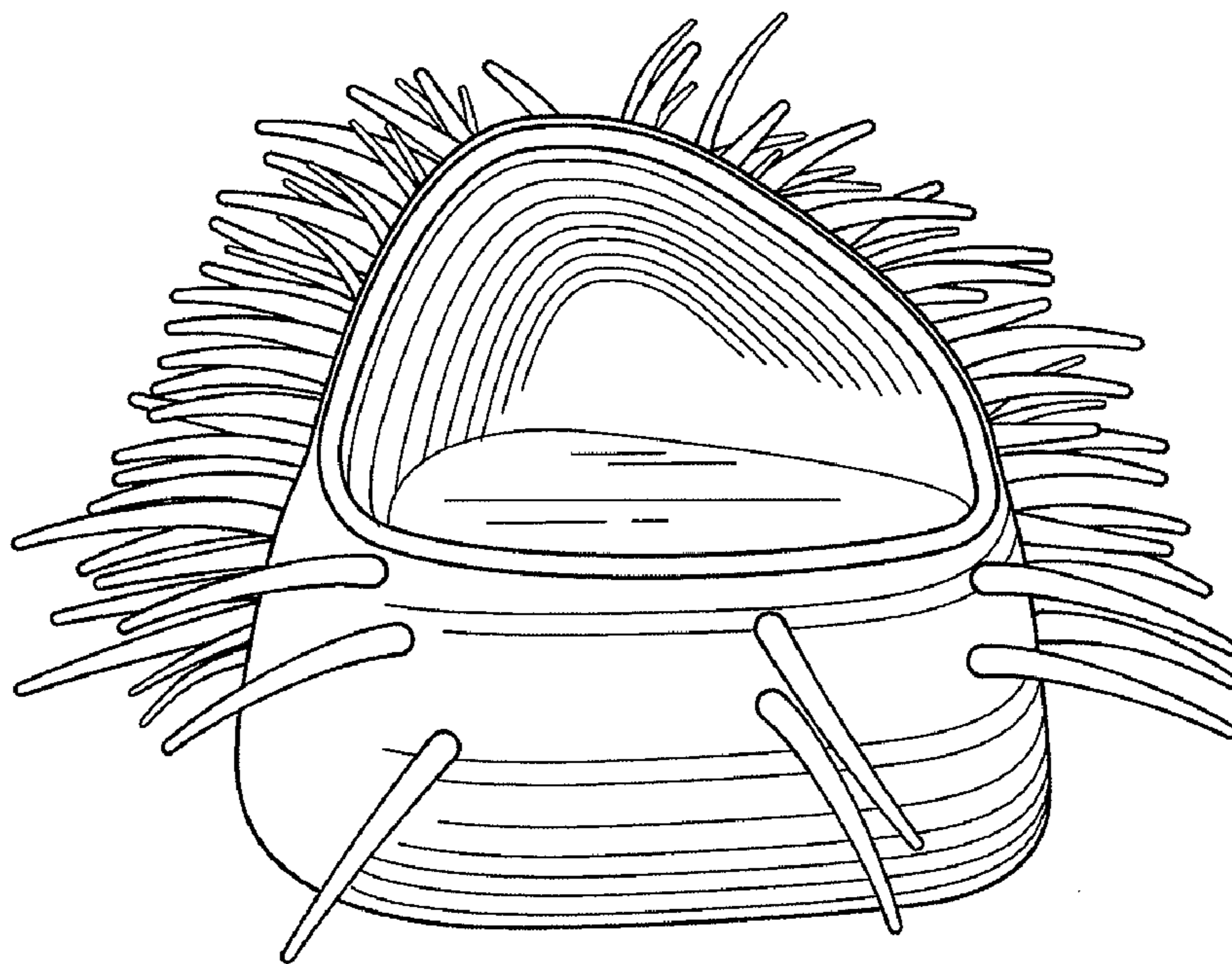
