I claim an ornamental design for footwear, as shown and described.

DESCRIPTION

FIG. 5 is a front view thereof;

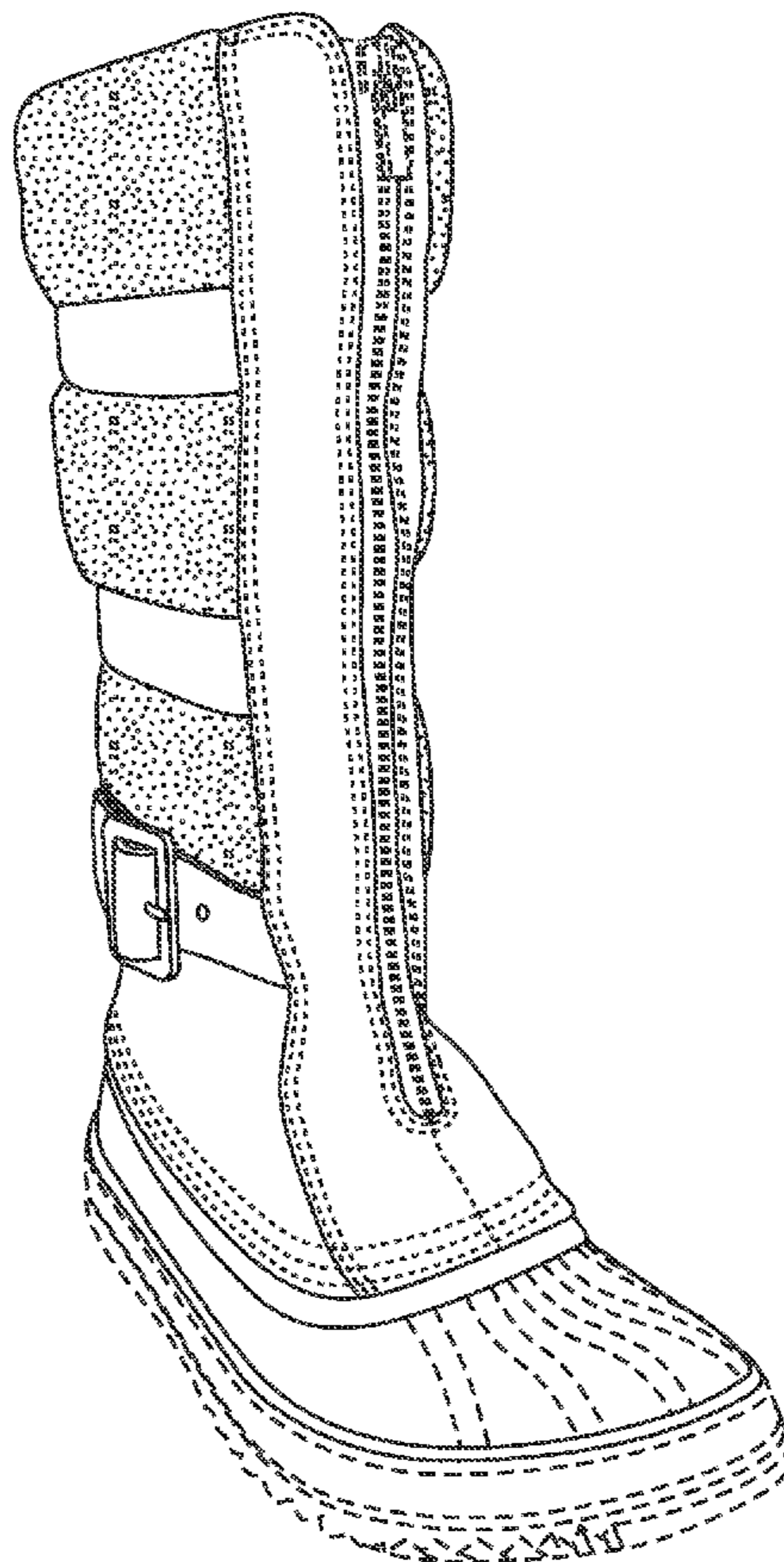
FIG. 6 is a back view thereof;

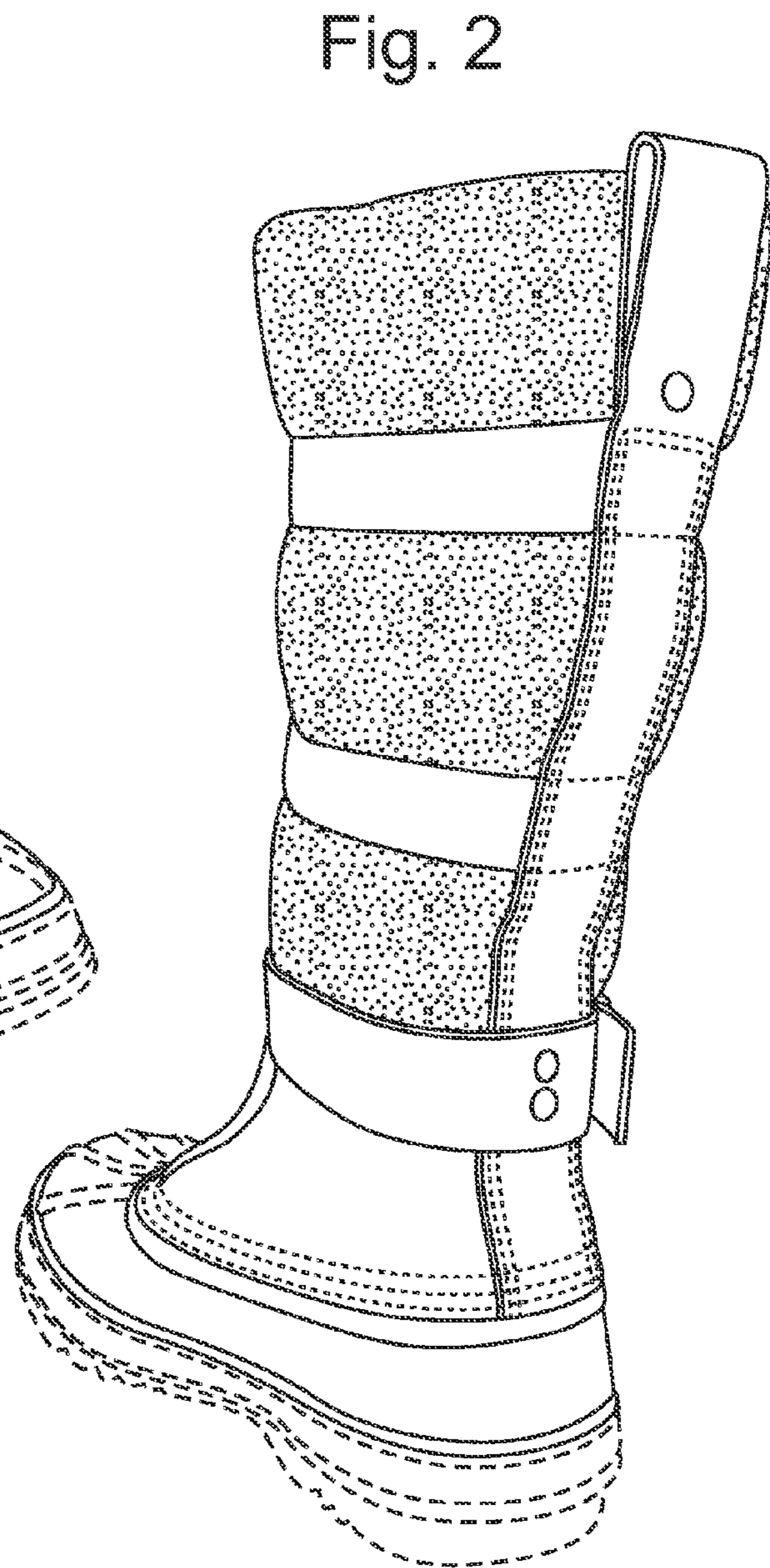
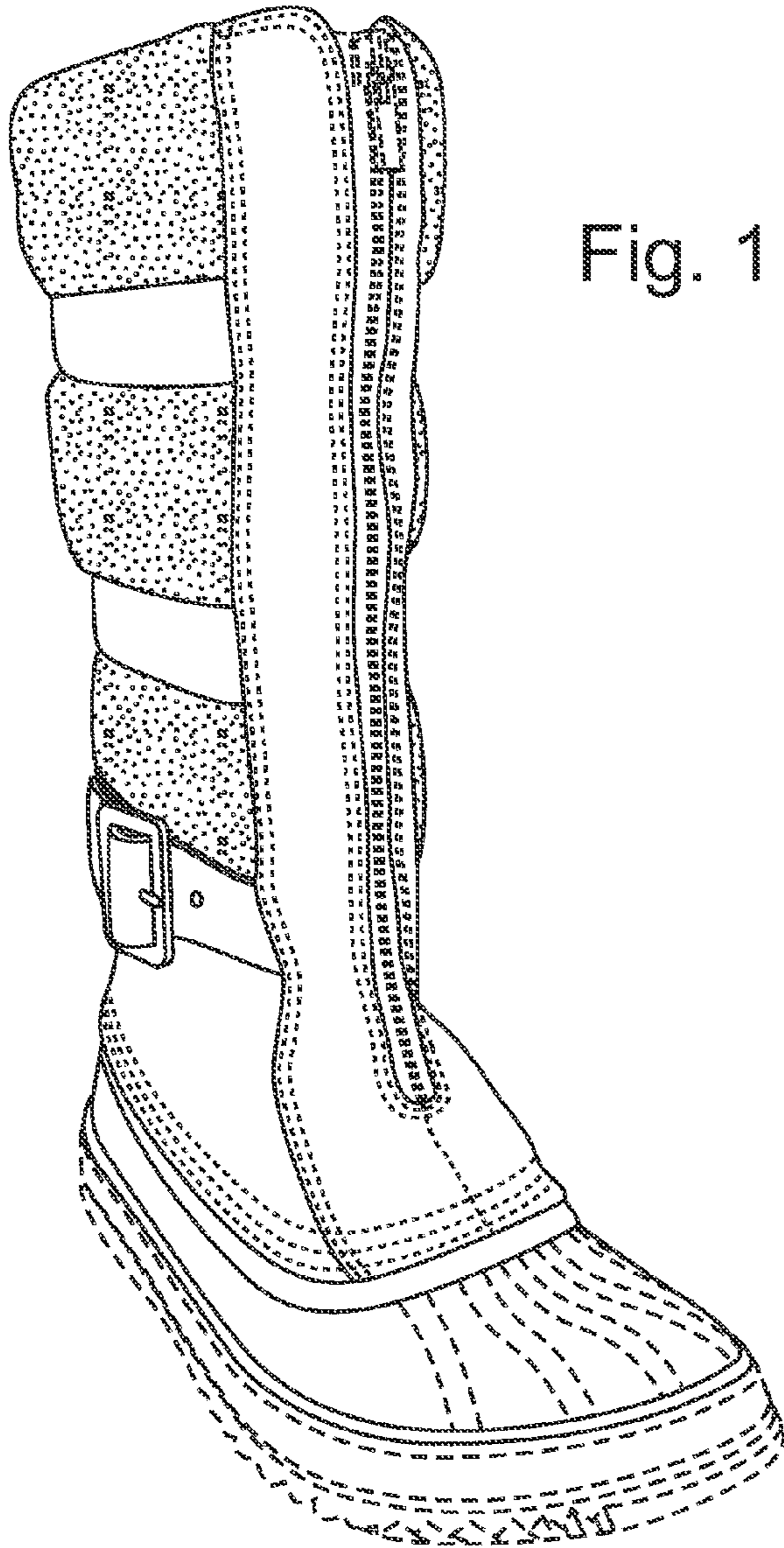
FIG. 7 is a bottom view thereof; and,

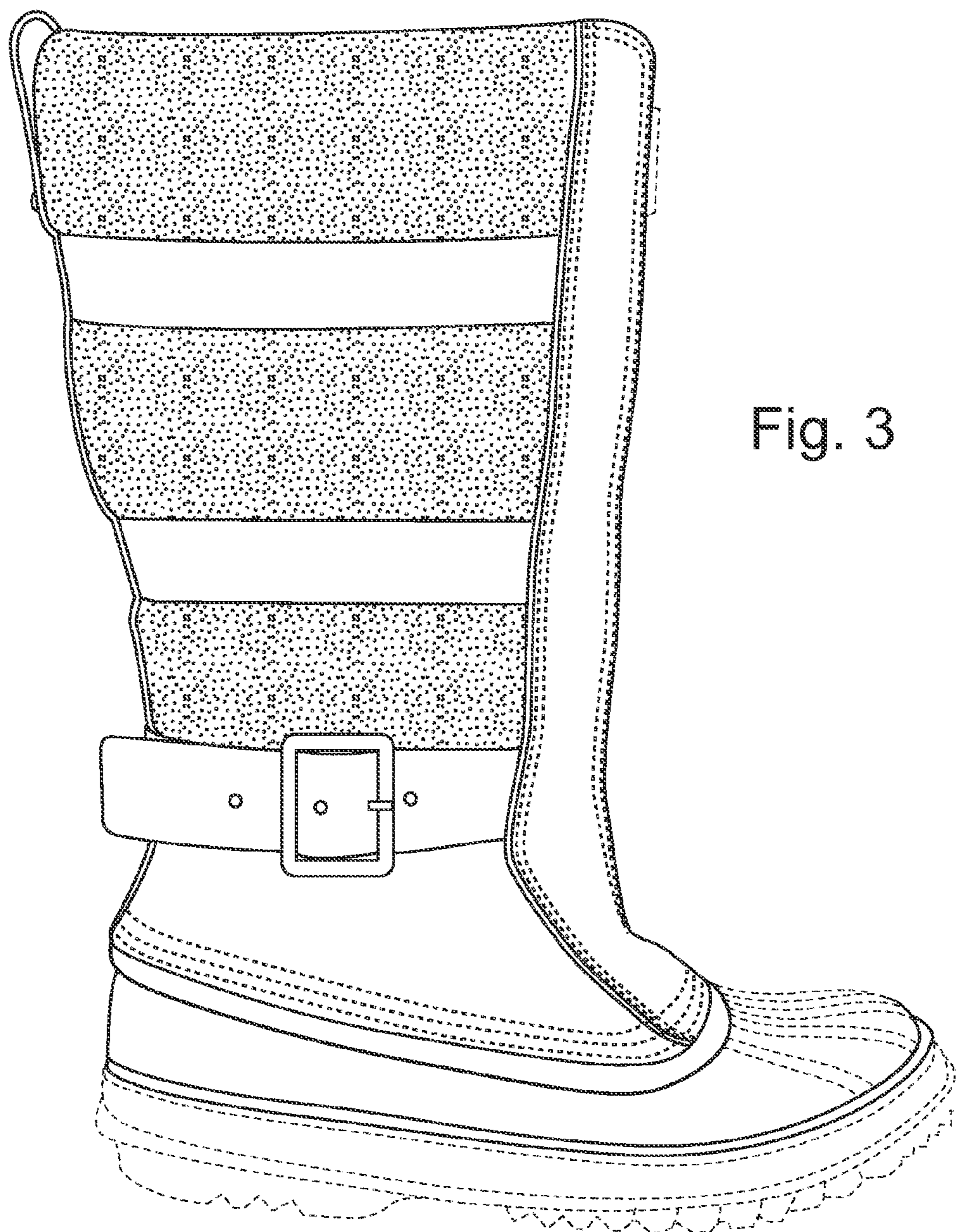
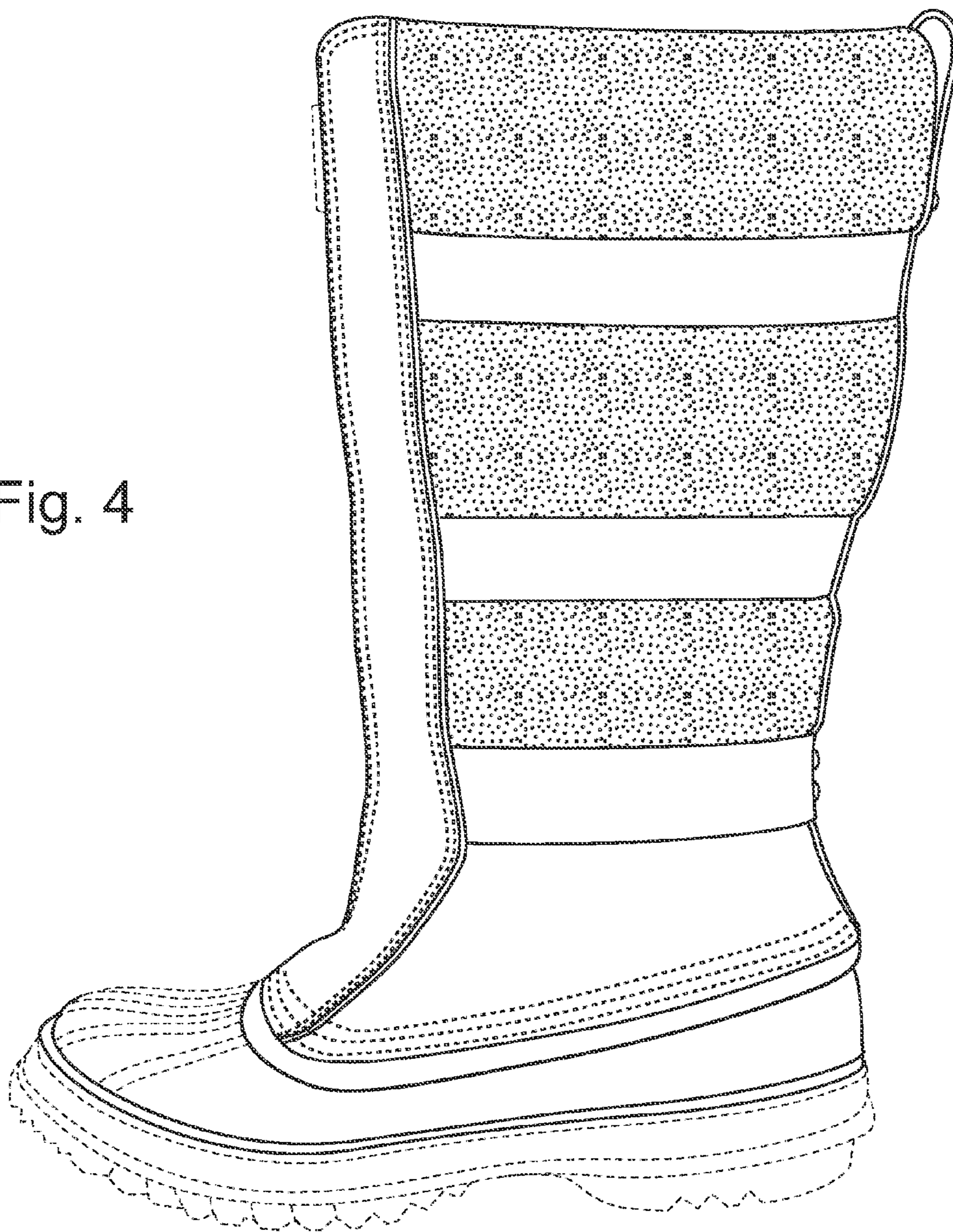

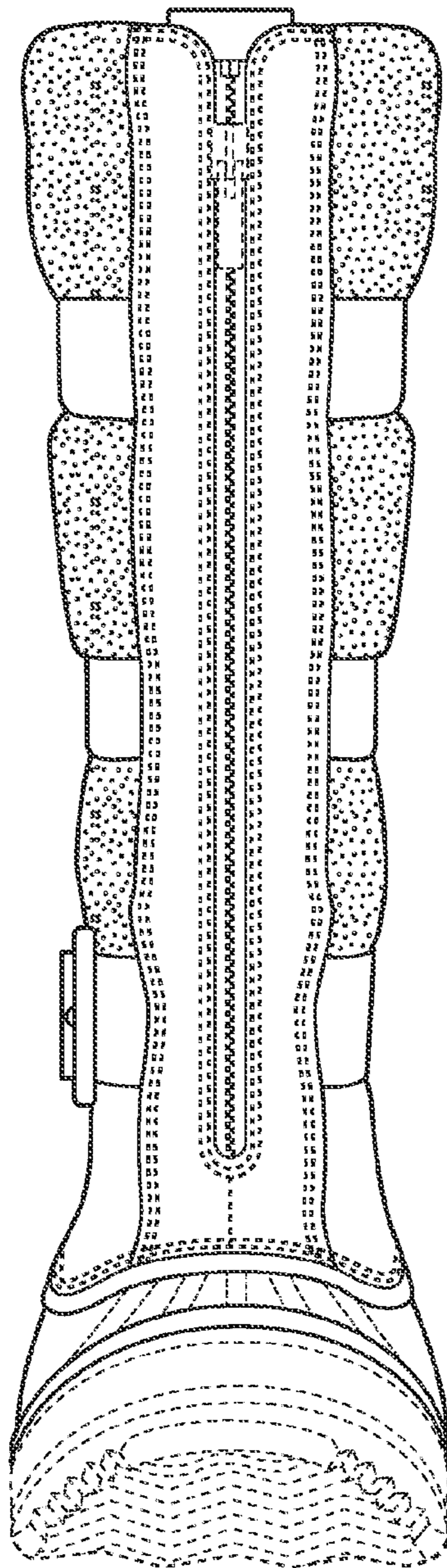

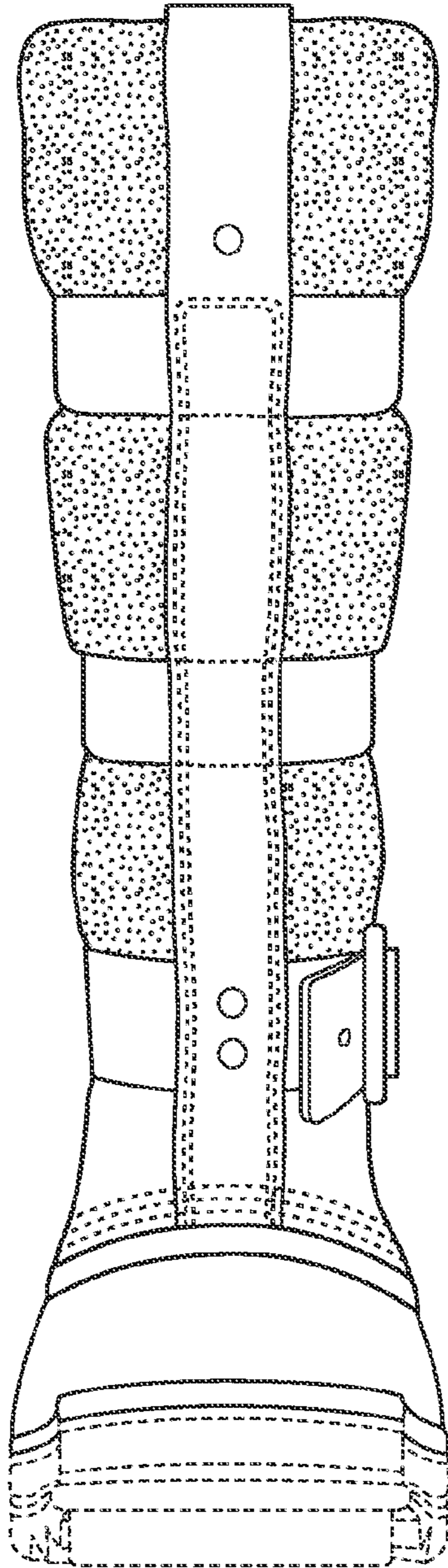

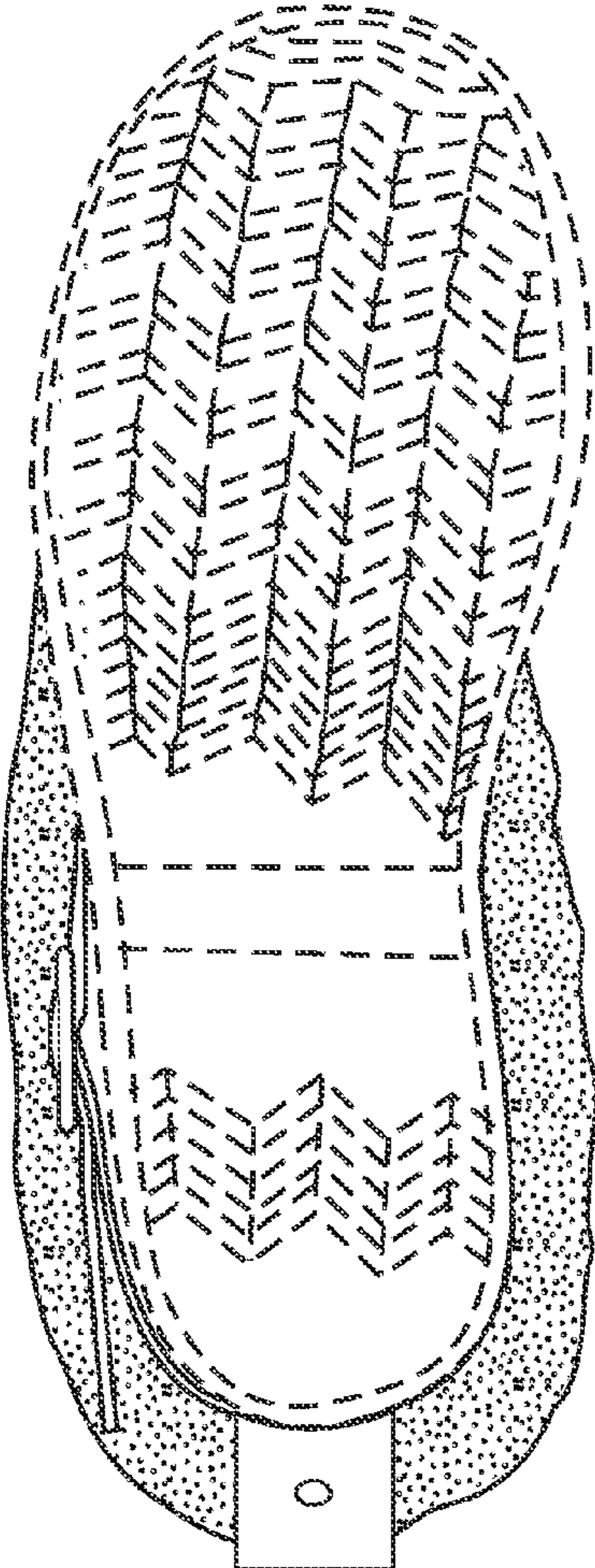
