(57) **CLAIM**

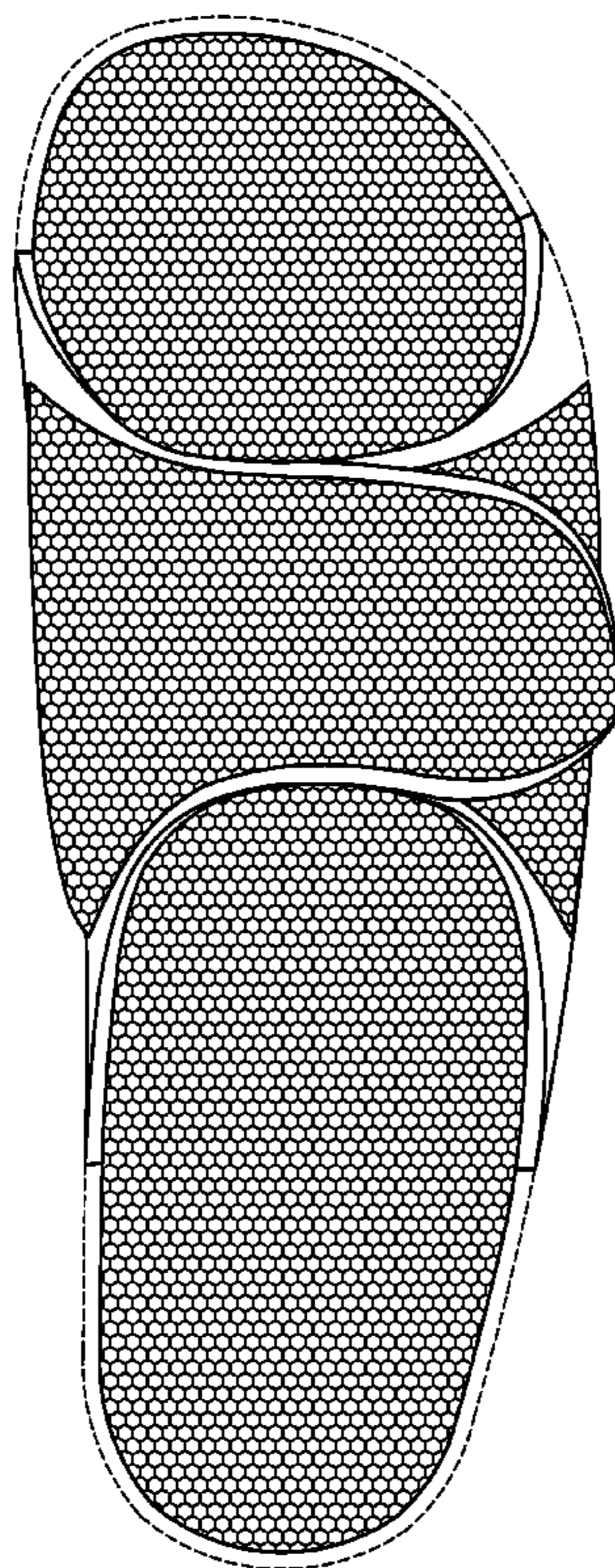
The ornamental design for a sports sandal, as shown and described.

DESCRIPTION

FIG. 1 is a top view of a sports sandal, showing our design. FIG. 2 is a left side view of a sports sandal of FIG. 1. FIG. 3 is a right side view of a sports sandal of FIG. 1. FIG. 4 is a bottom view of a sports sandal of FIG. 1. FIG. 5 is a rear view of a sports sandal of FIG. 1; and, FIG. 6 is a front view of a sports sandal of FIG. 1.

The broken lines showing portions of the all sports sandal are included for the purpose of illustrating environmental structure and form no part of the claimed design.

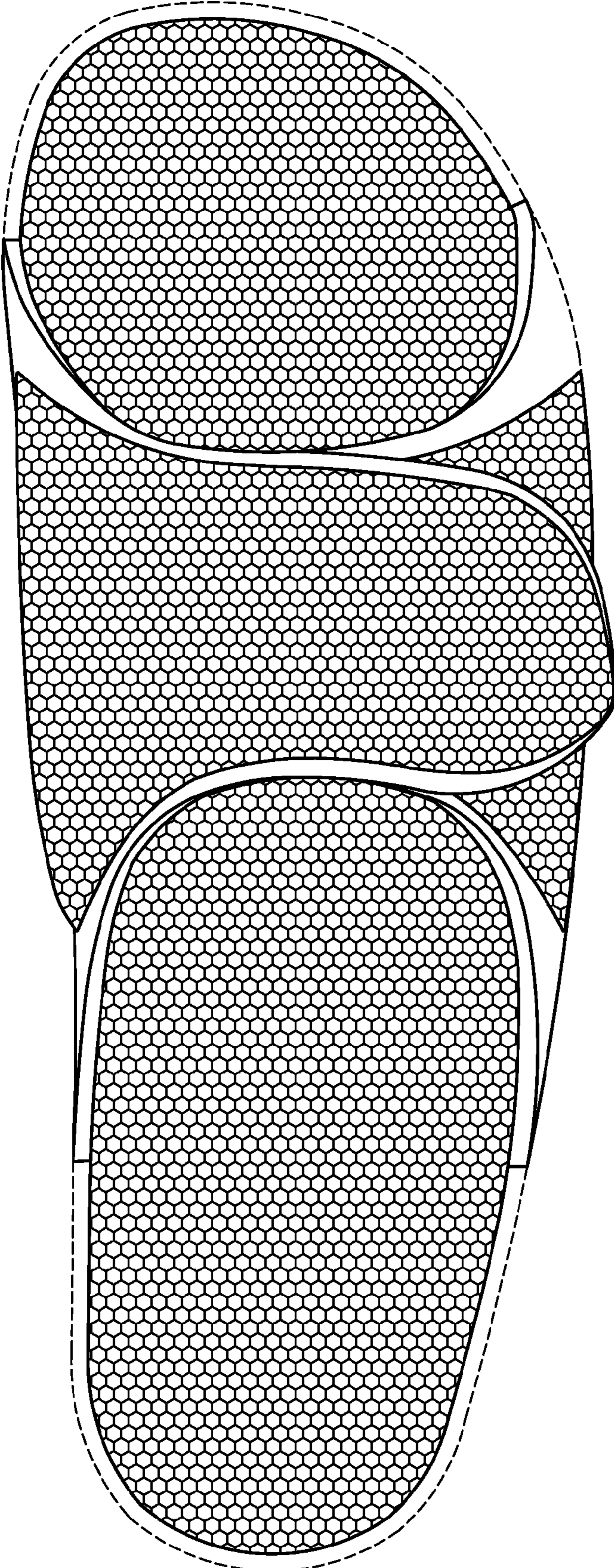

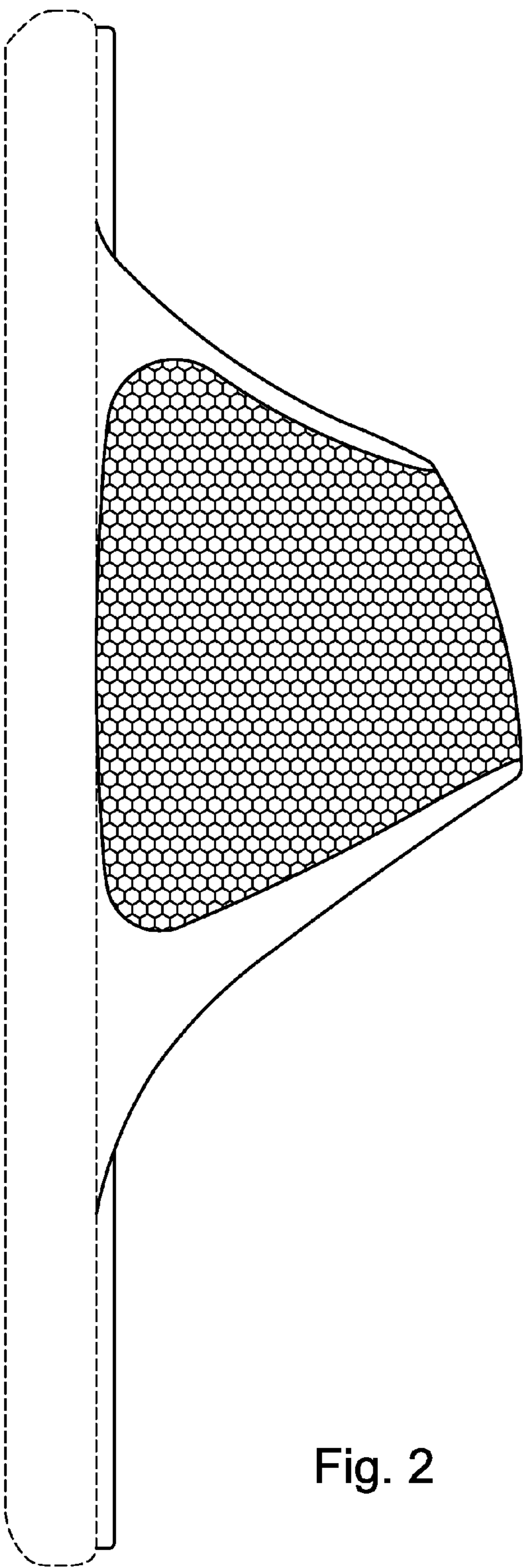

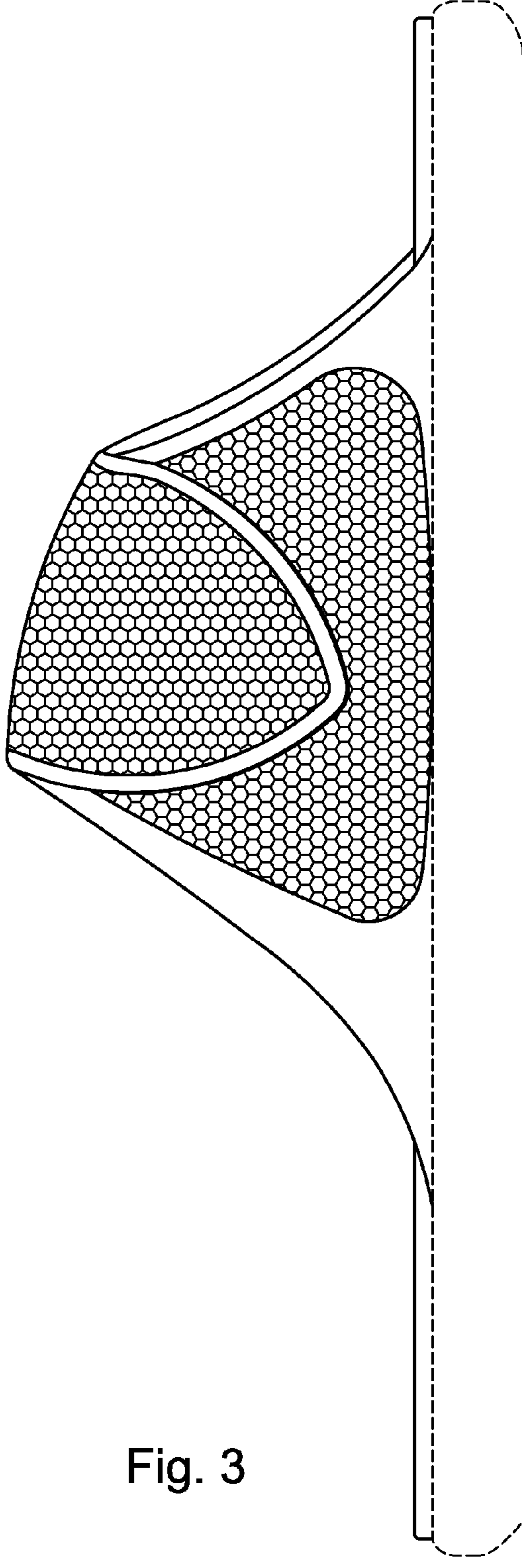

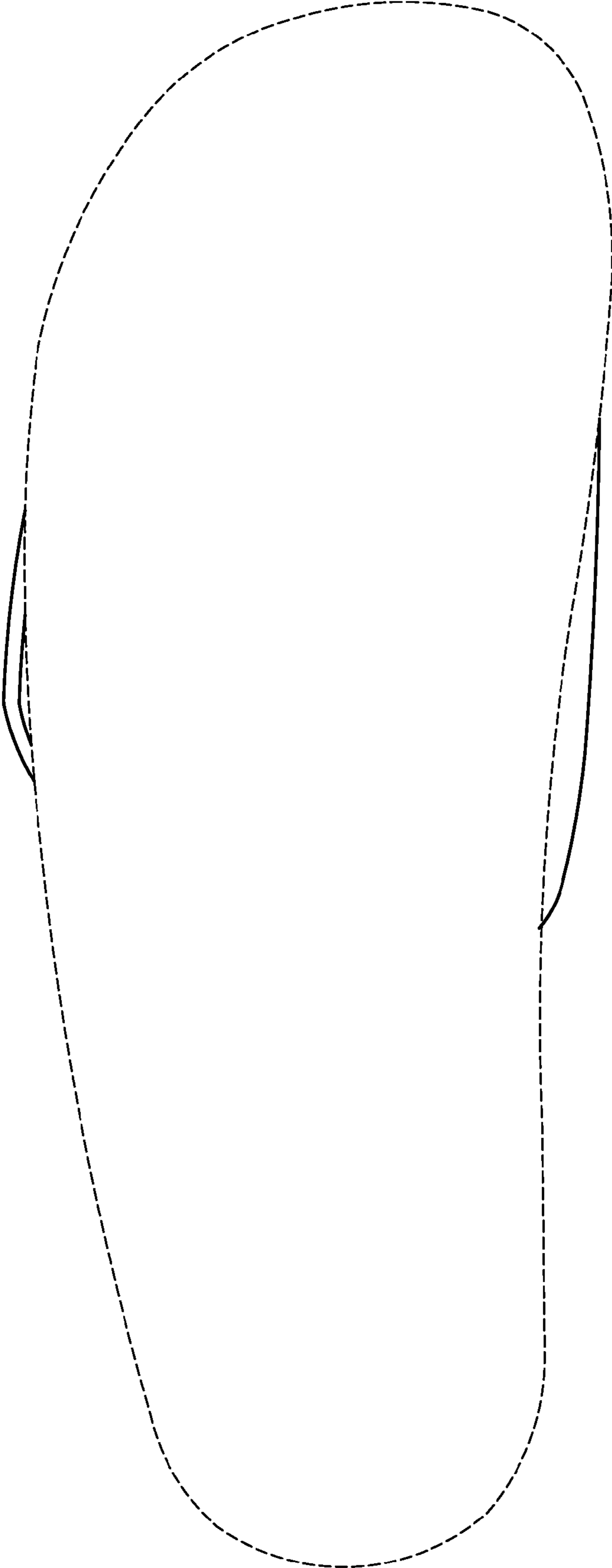

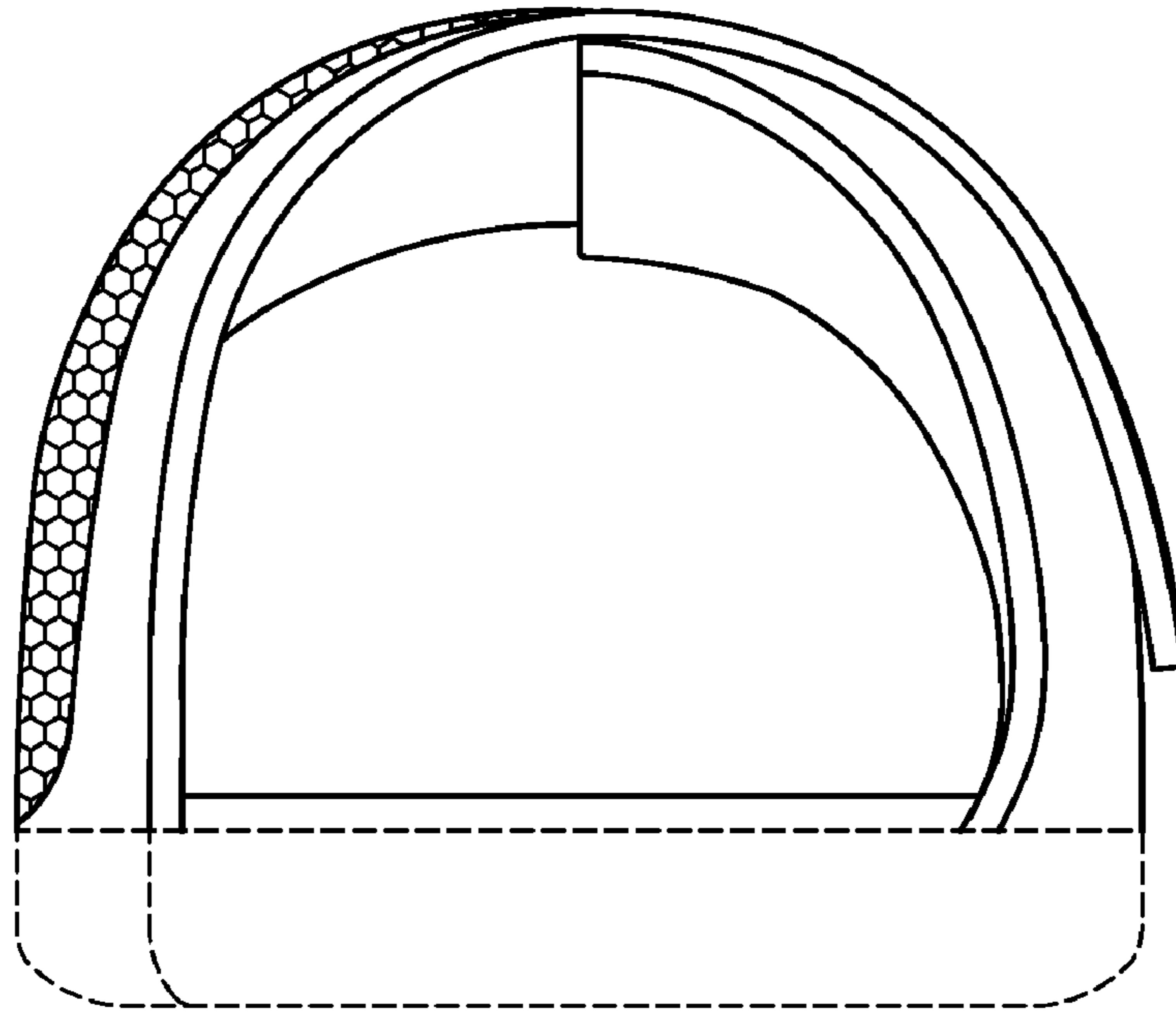

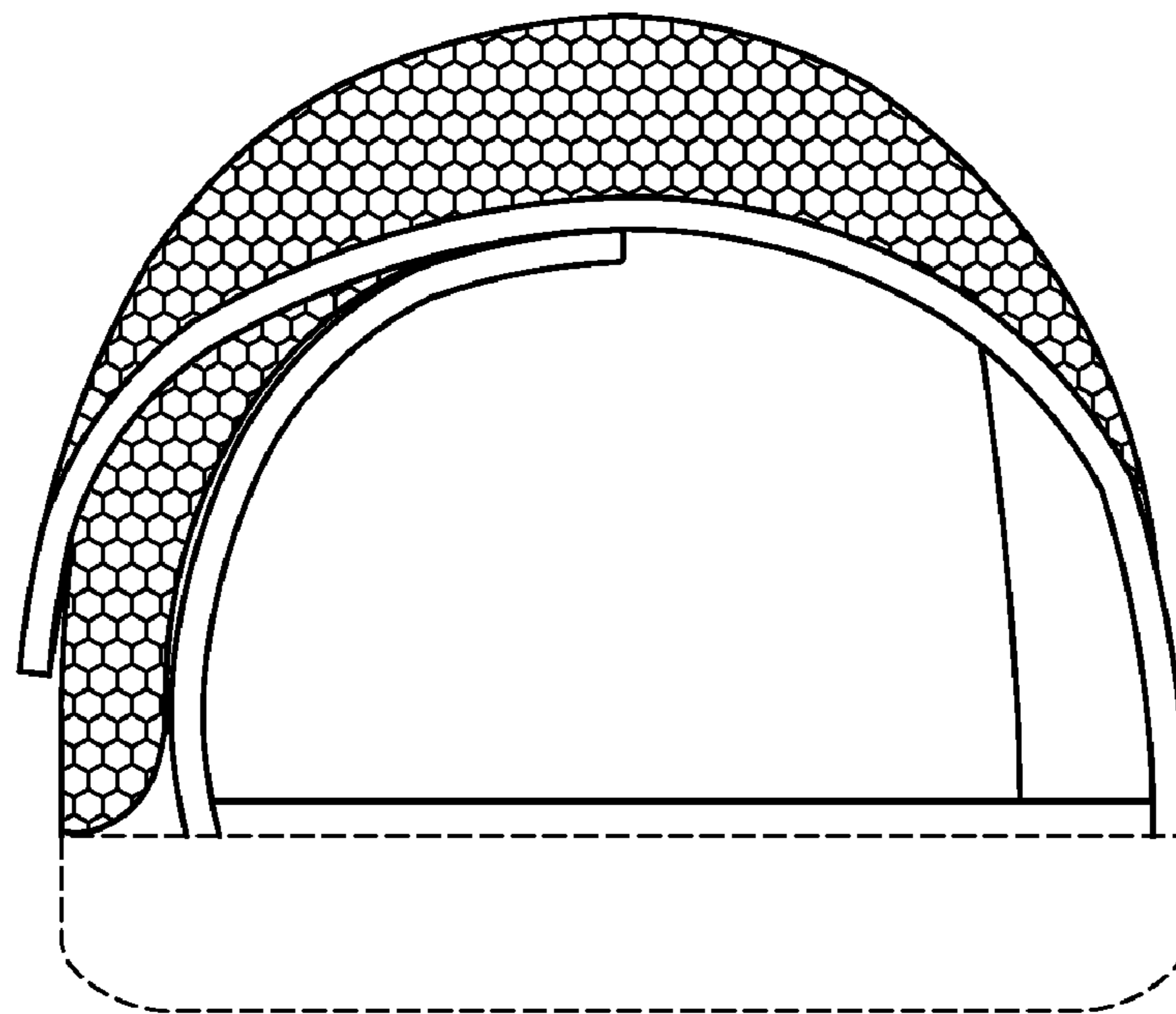
