The ornamental design for a shoe insole, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an embodiment of a shoe insole according to our new design;

FIG. 2 is an enlarged perspective view thereof;

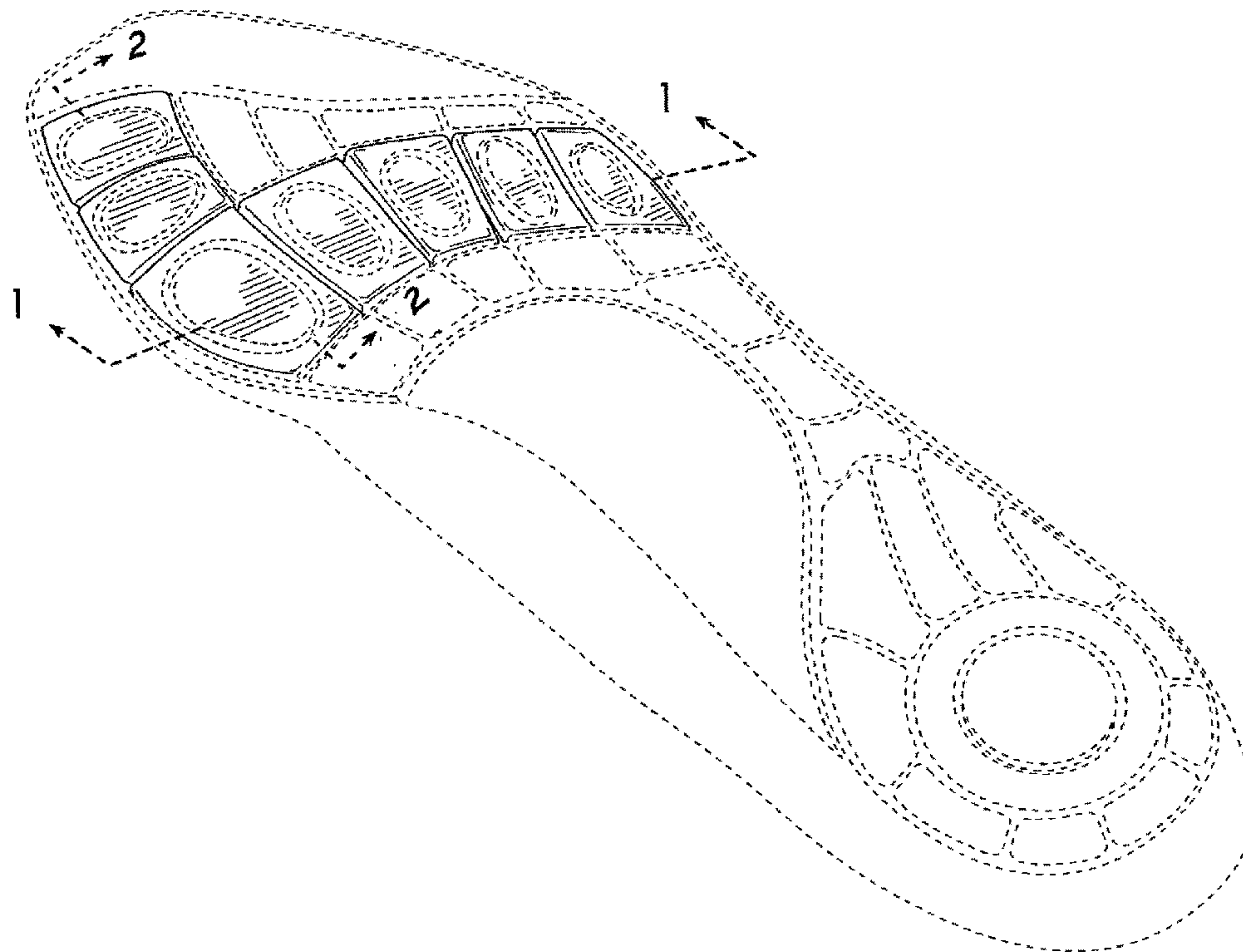
FIG. 3 is an enlarged top plan view thereof;

FIG. 4 is an enlarged cross-section view of the foreground only thereof taken along line 1—1; and,

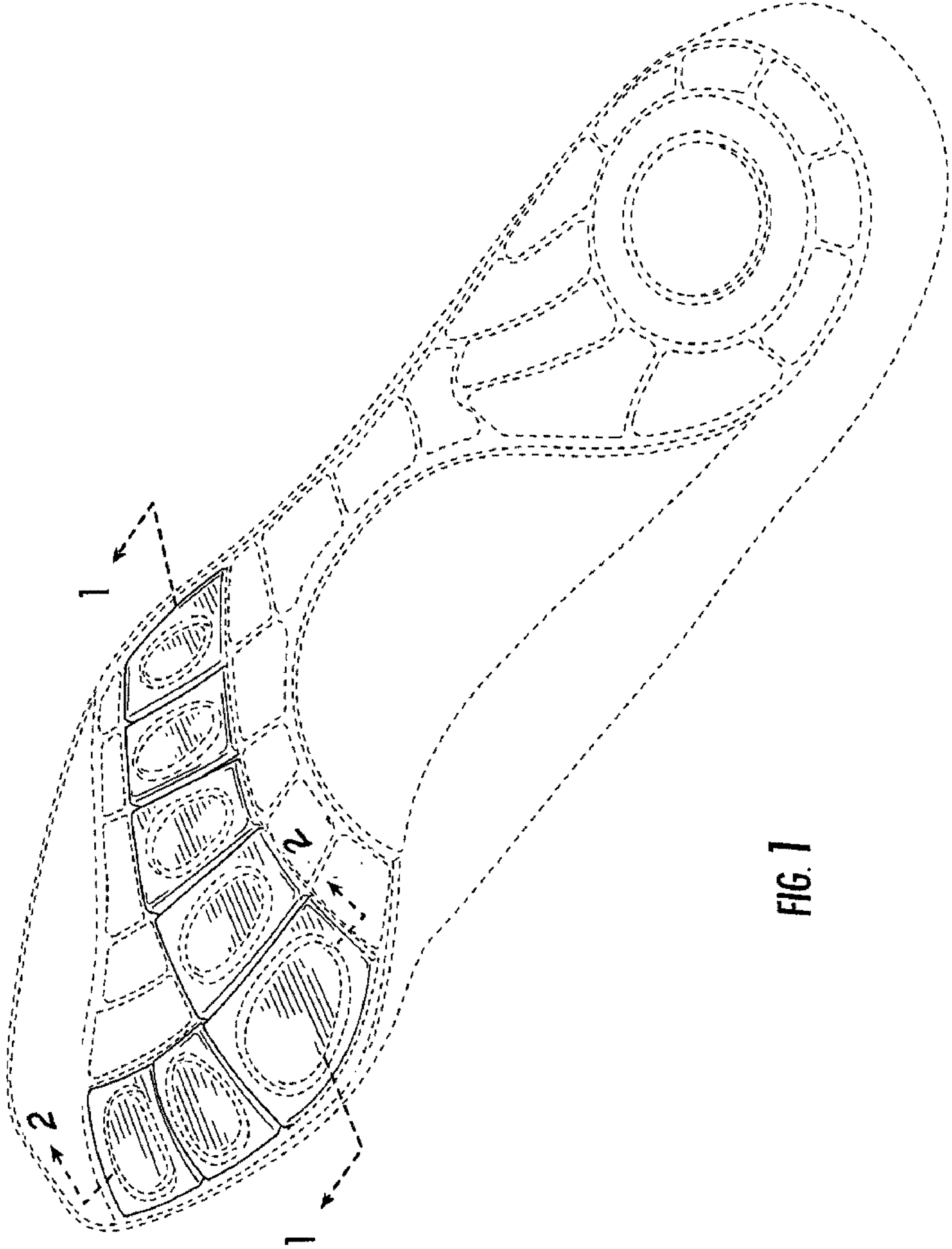

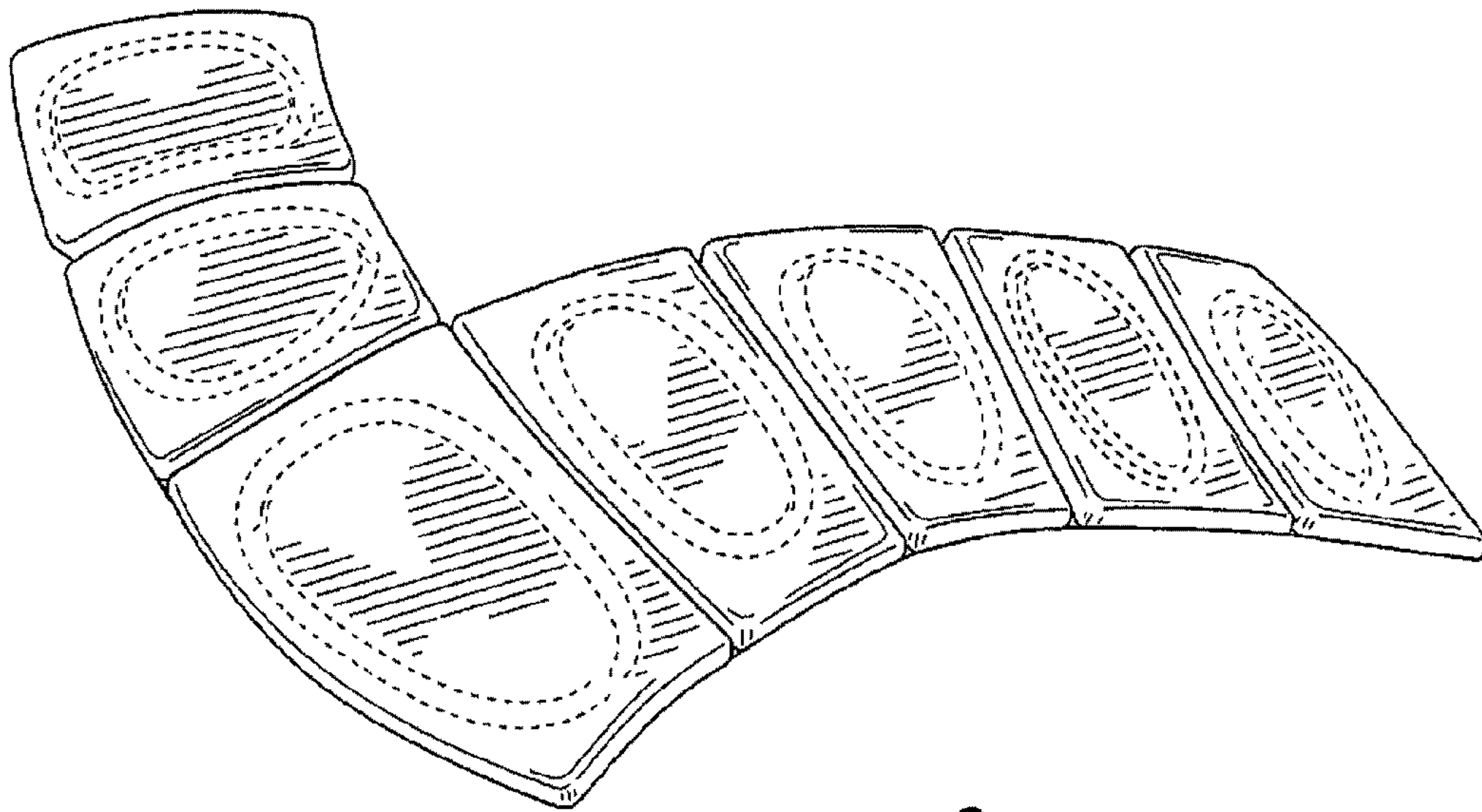

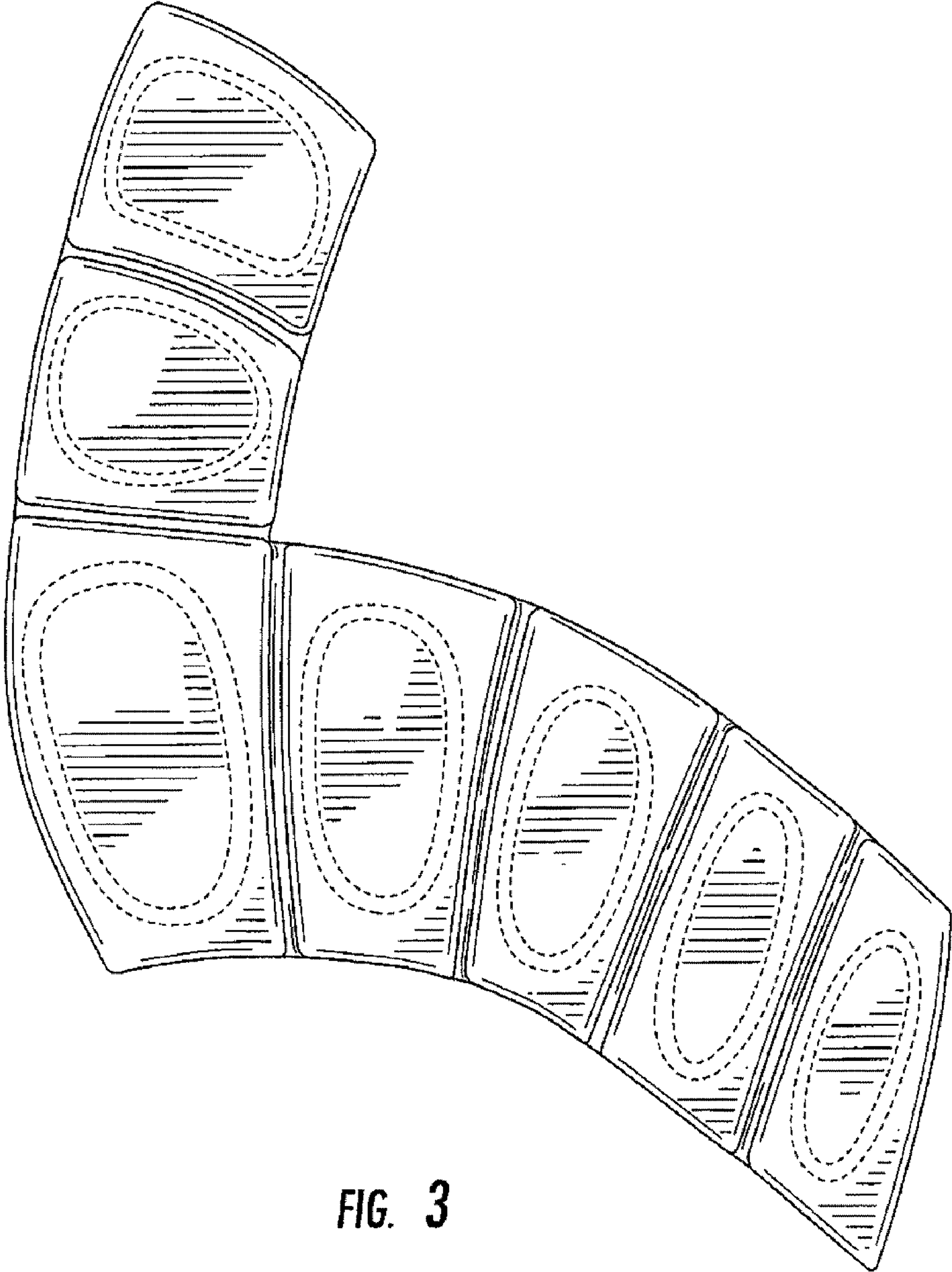

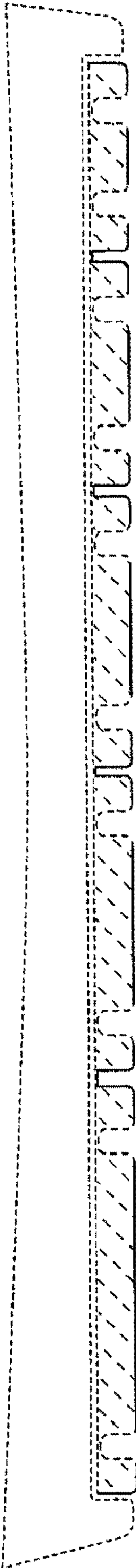

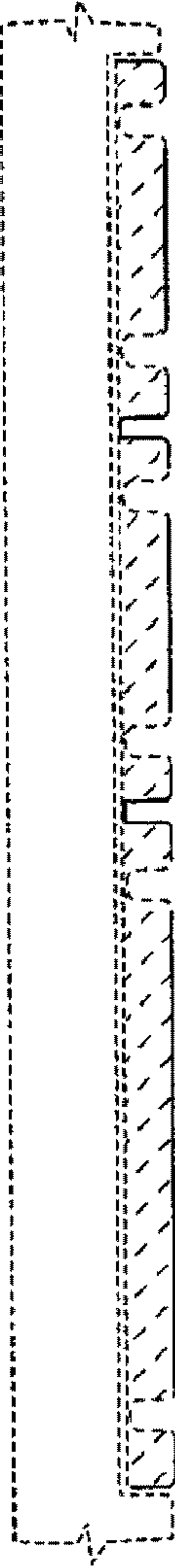
