**DESCRIPTION**

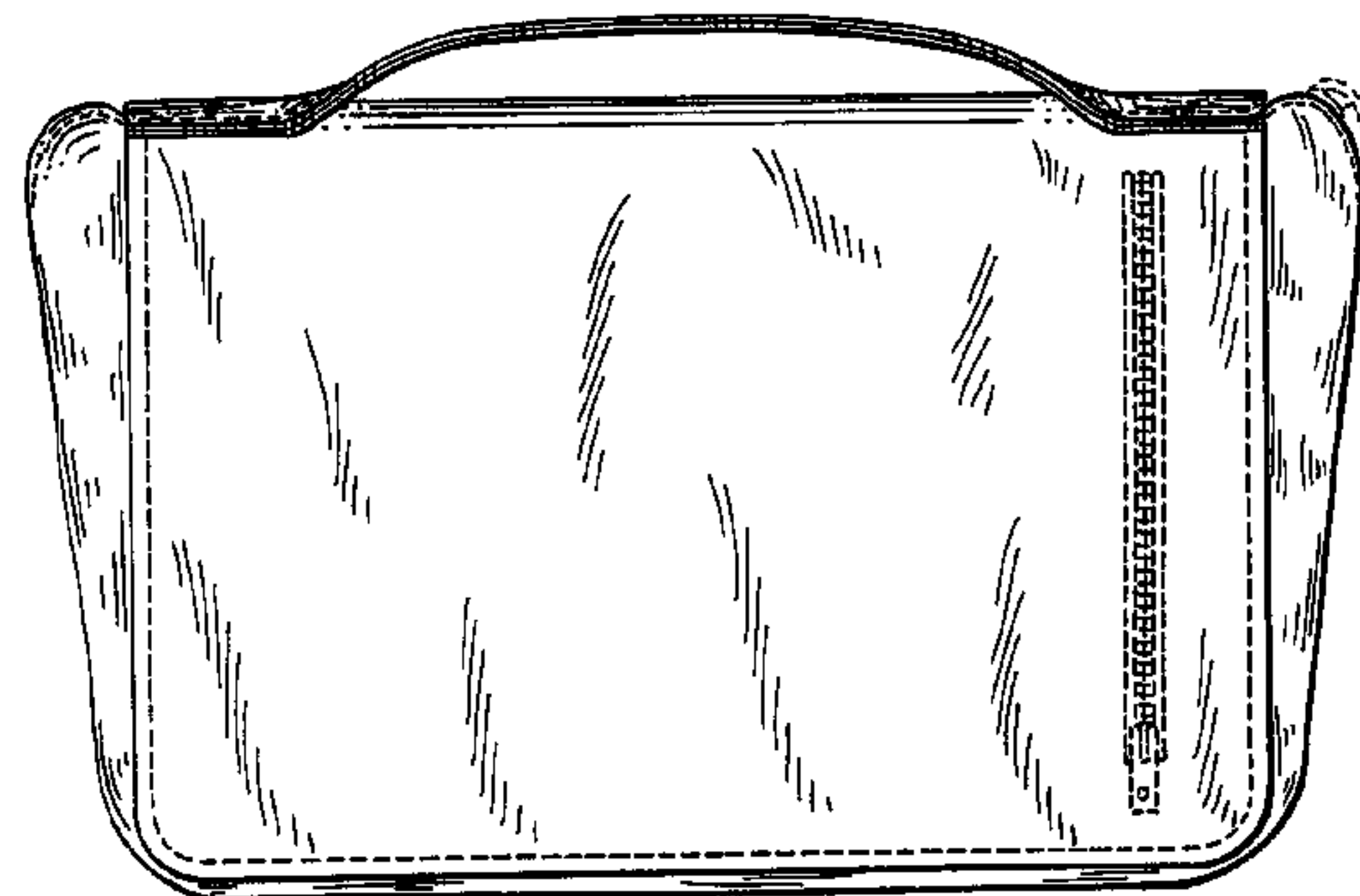
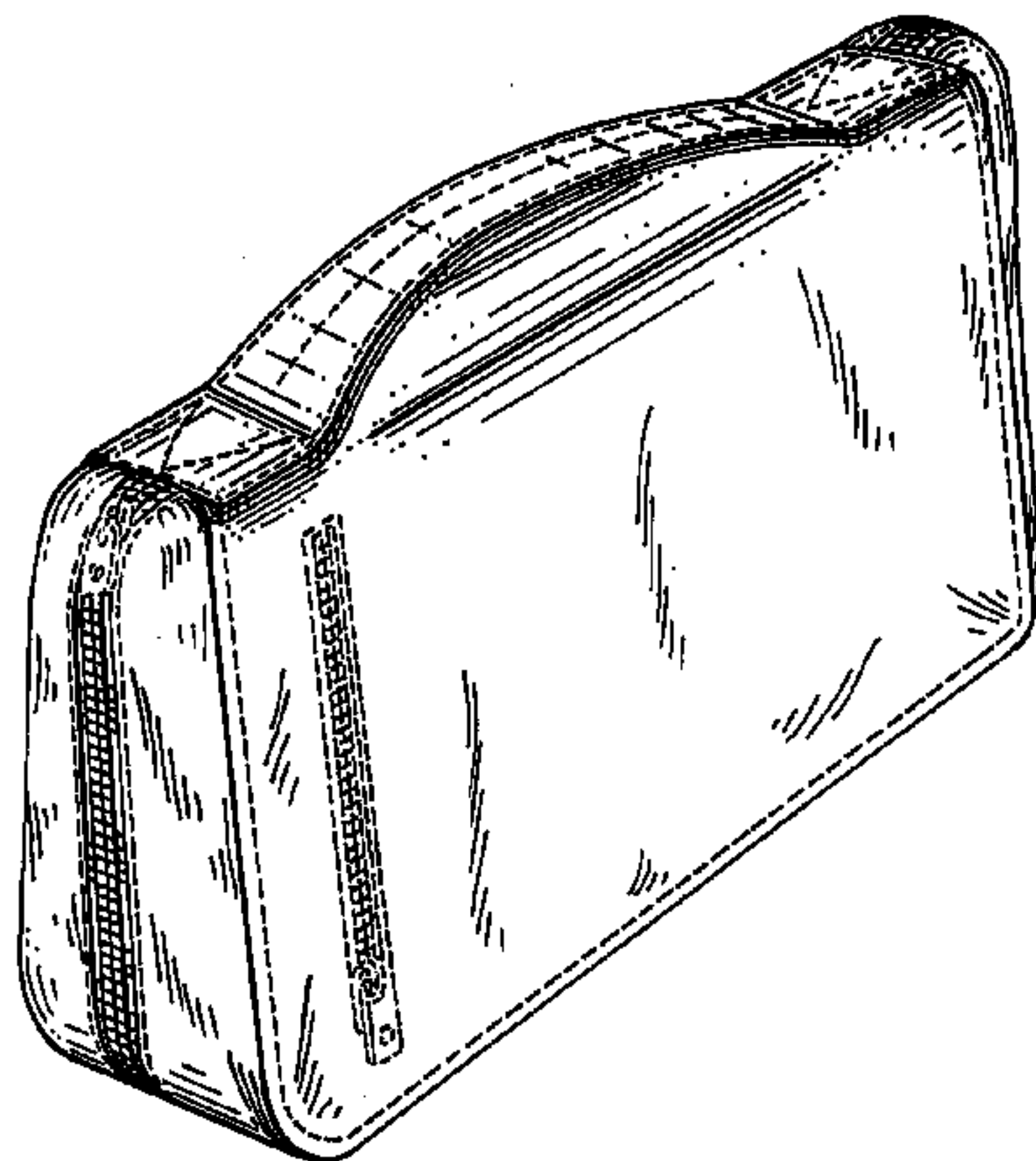

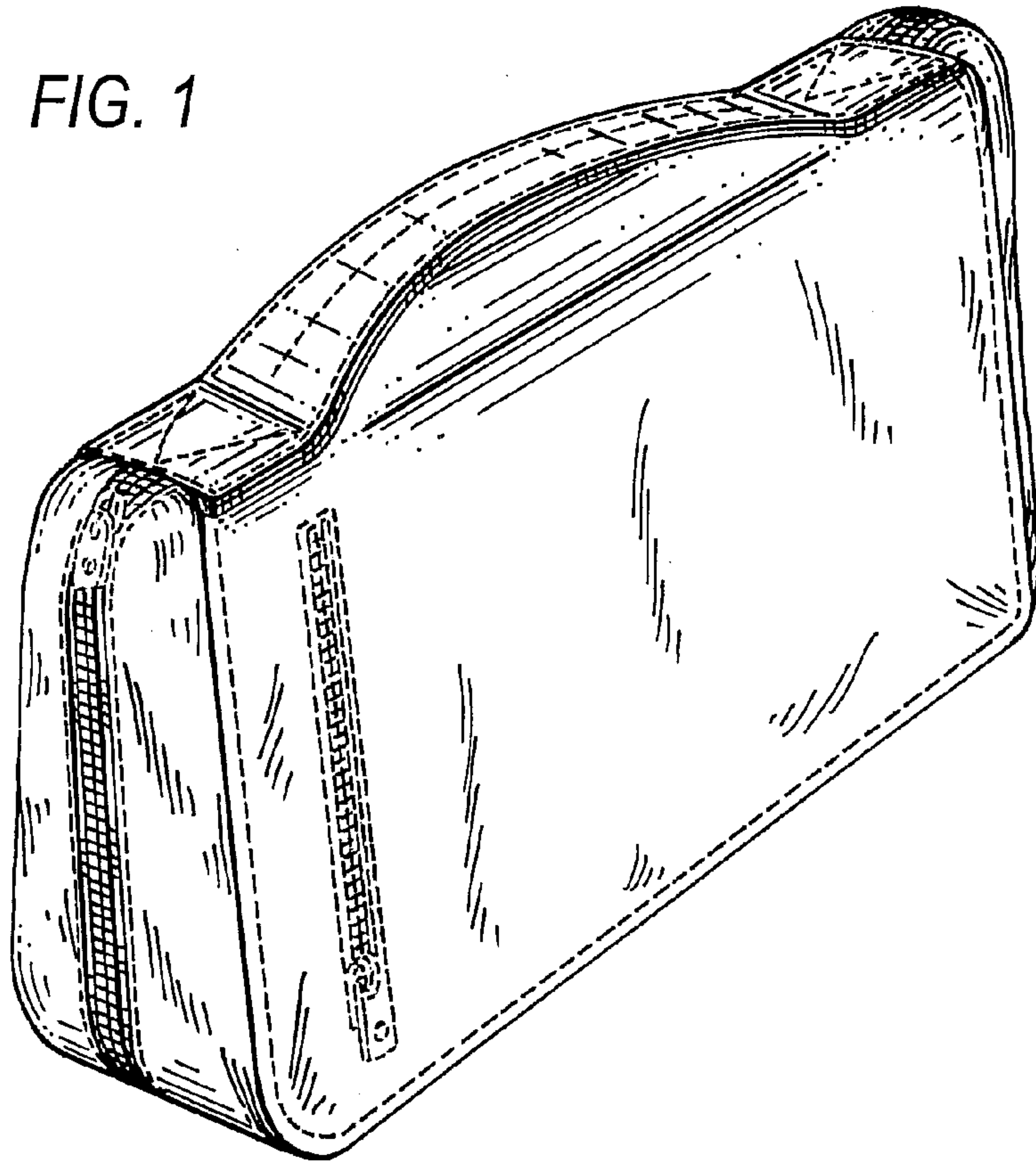
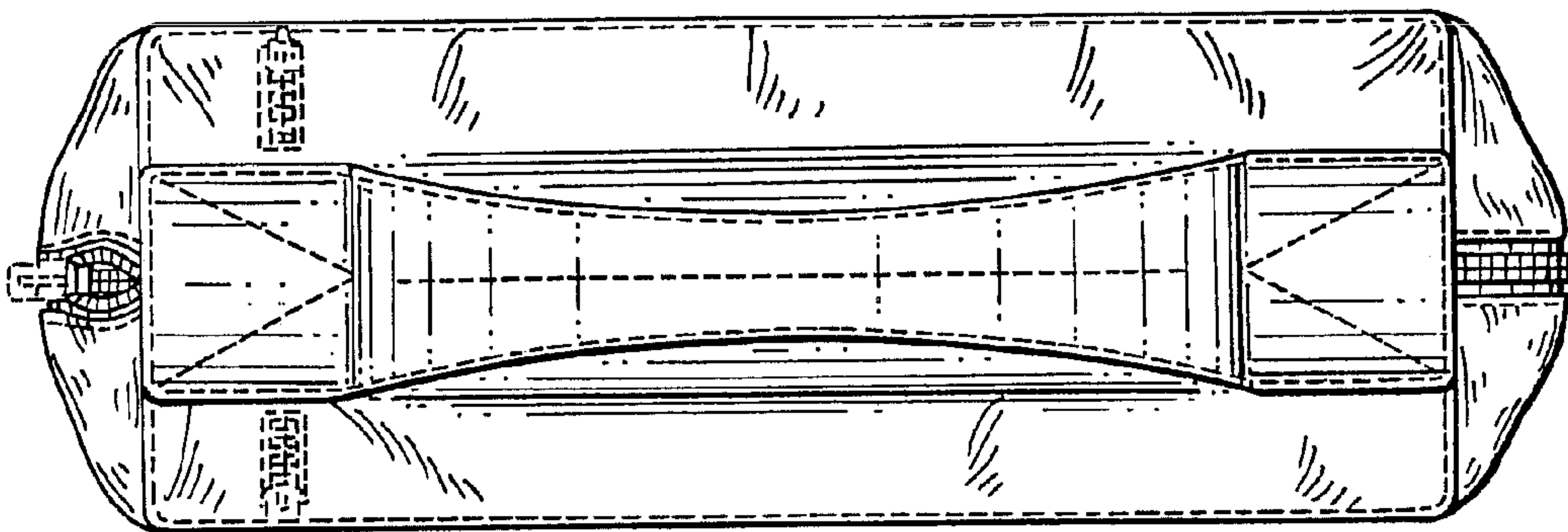

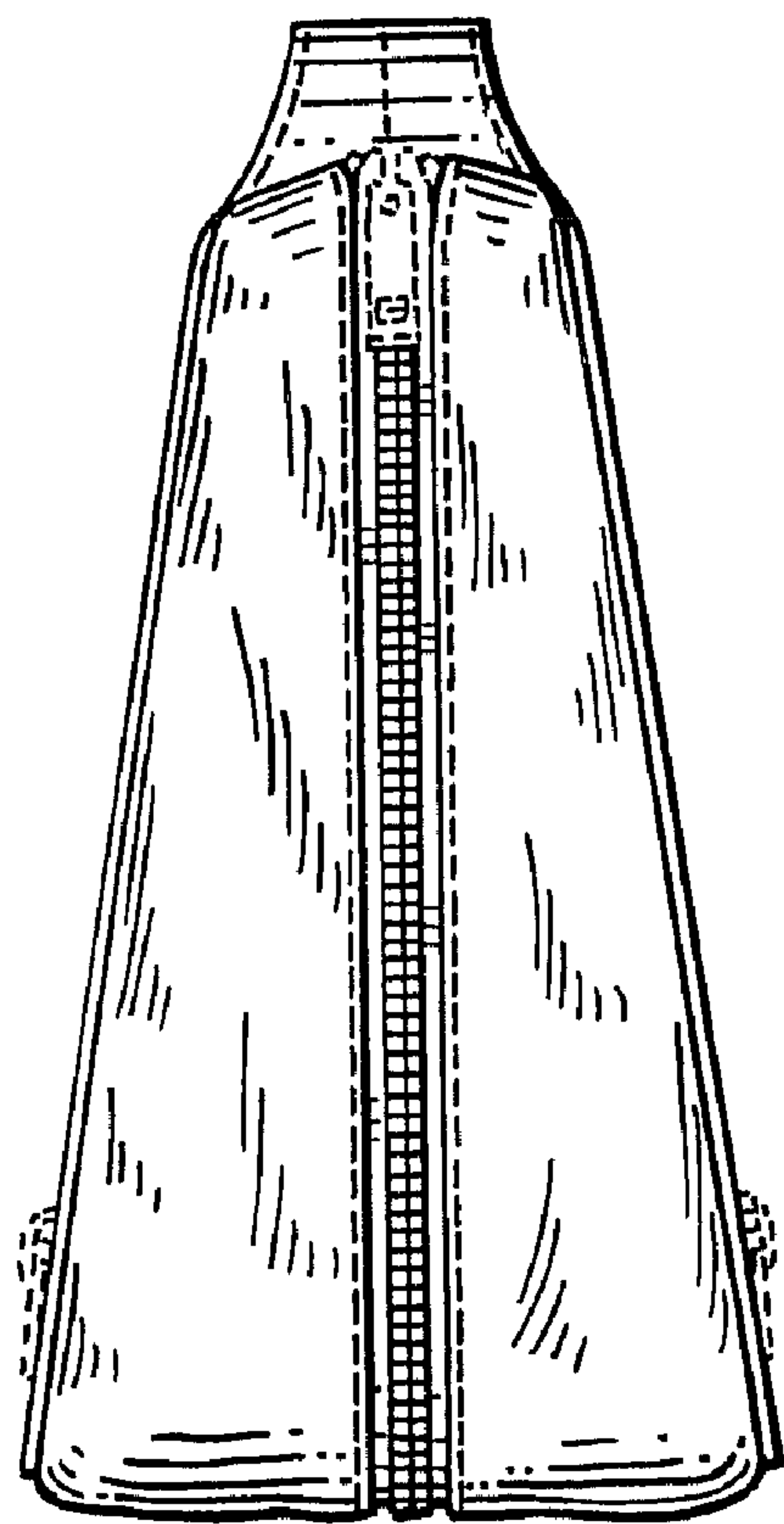

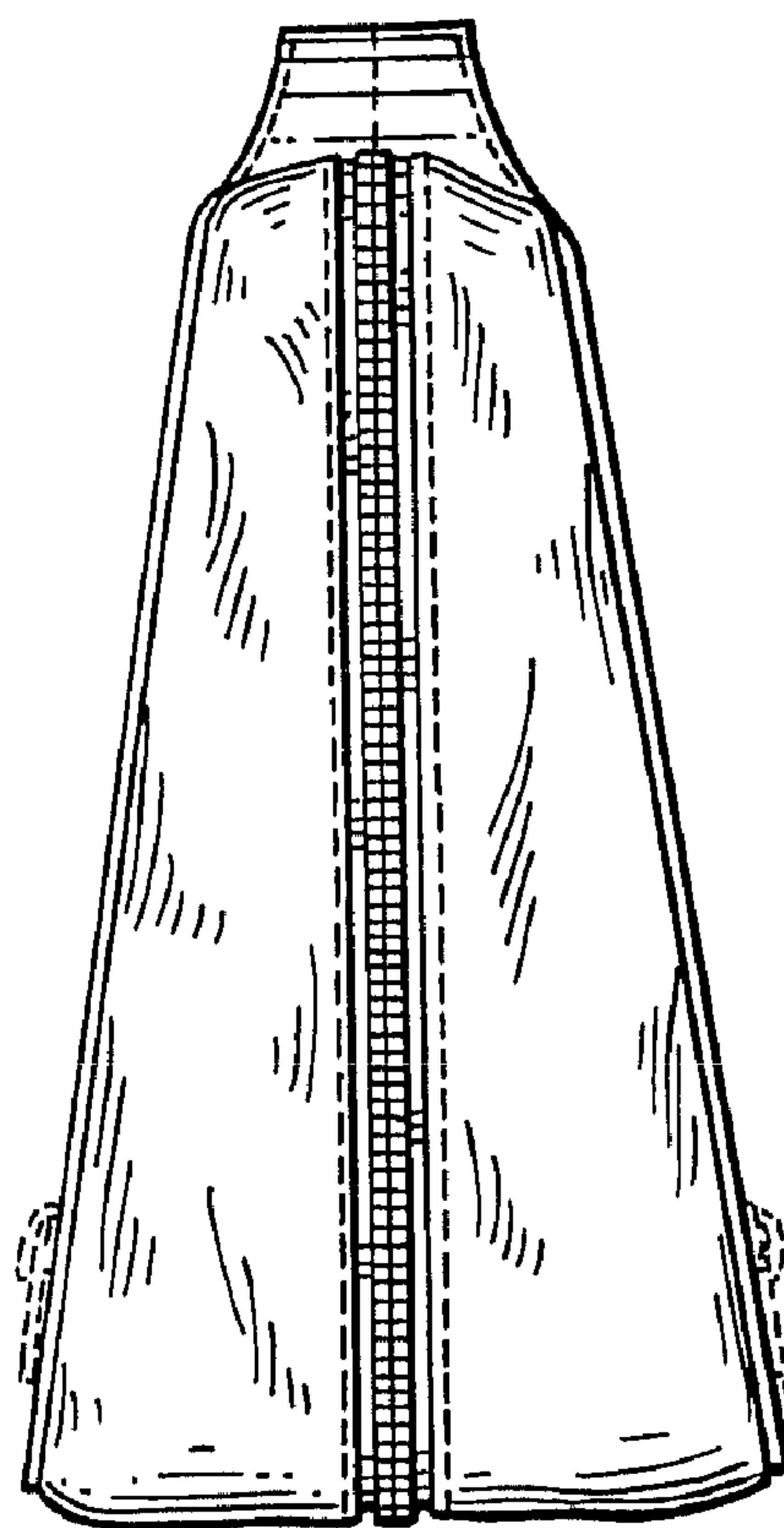

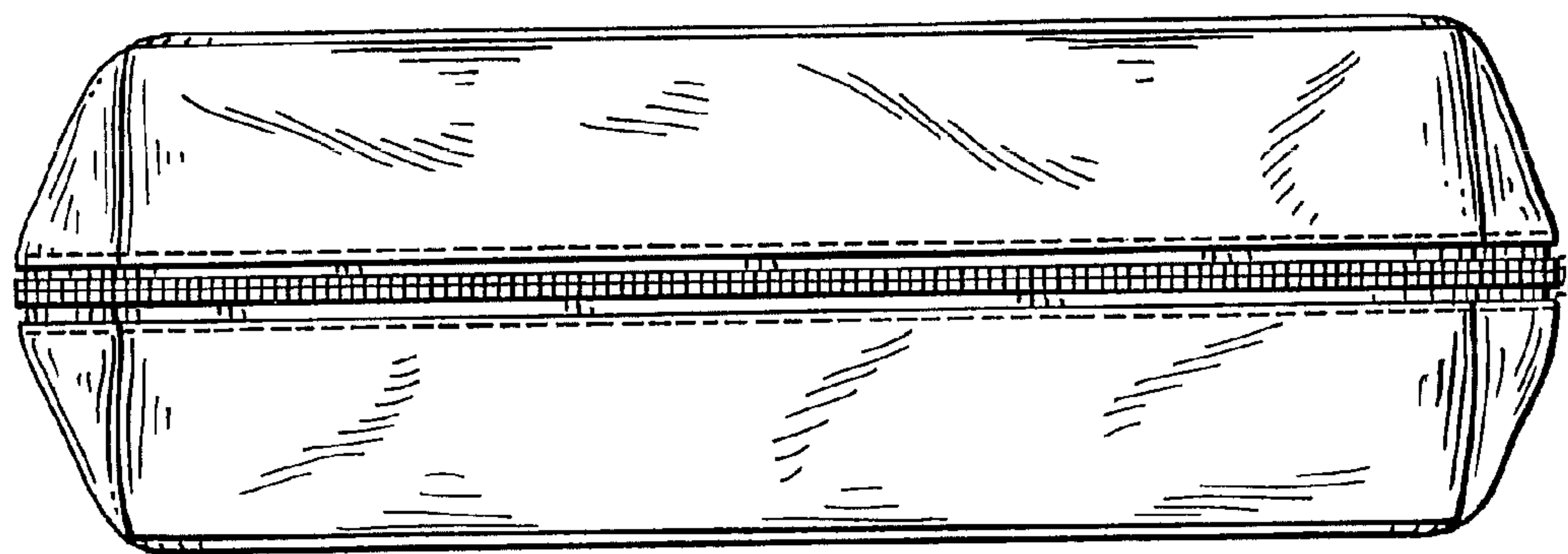
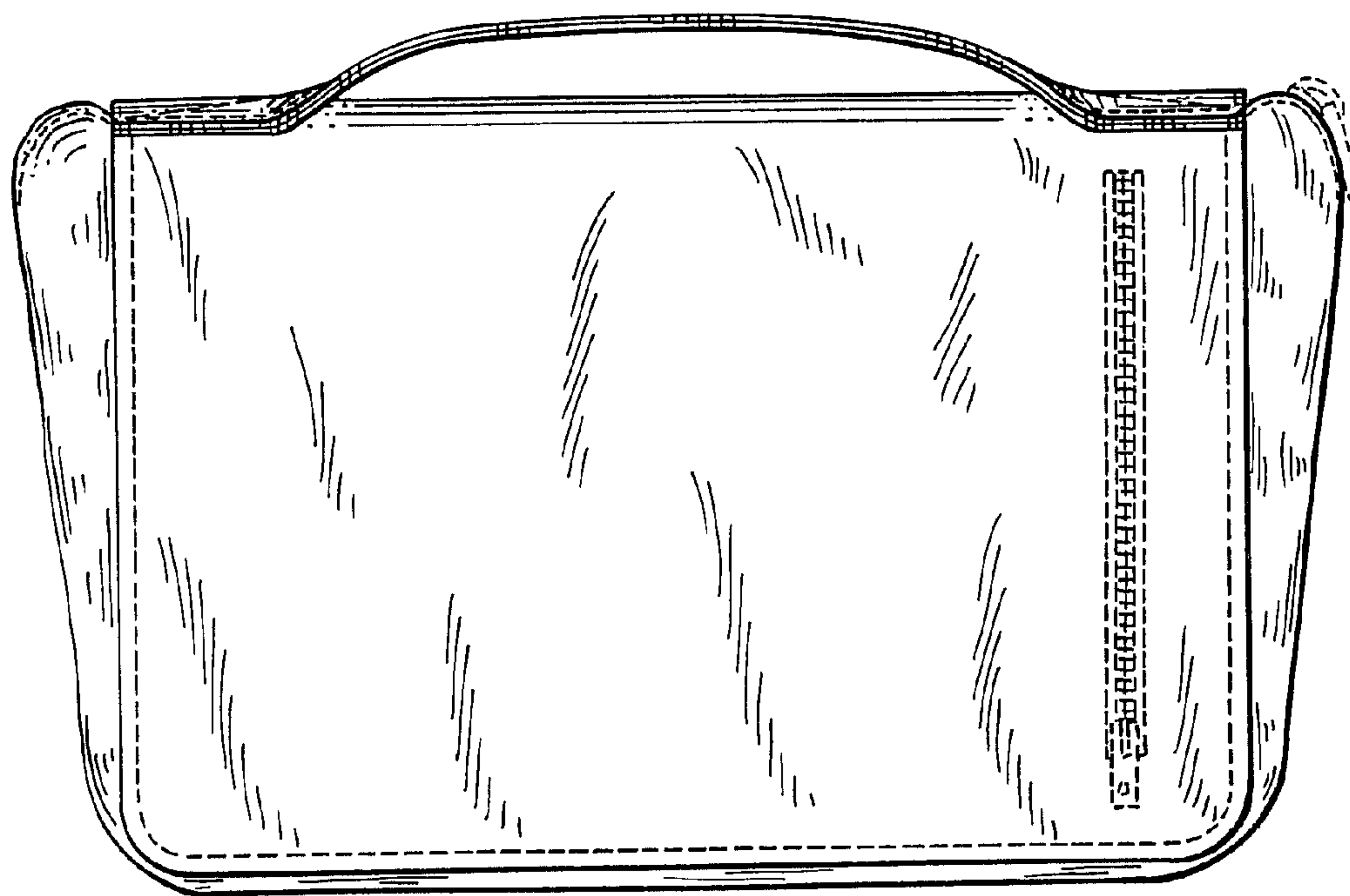

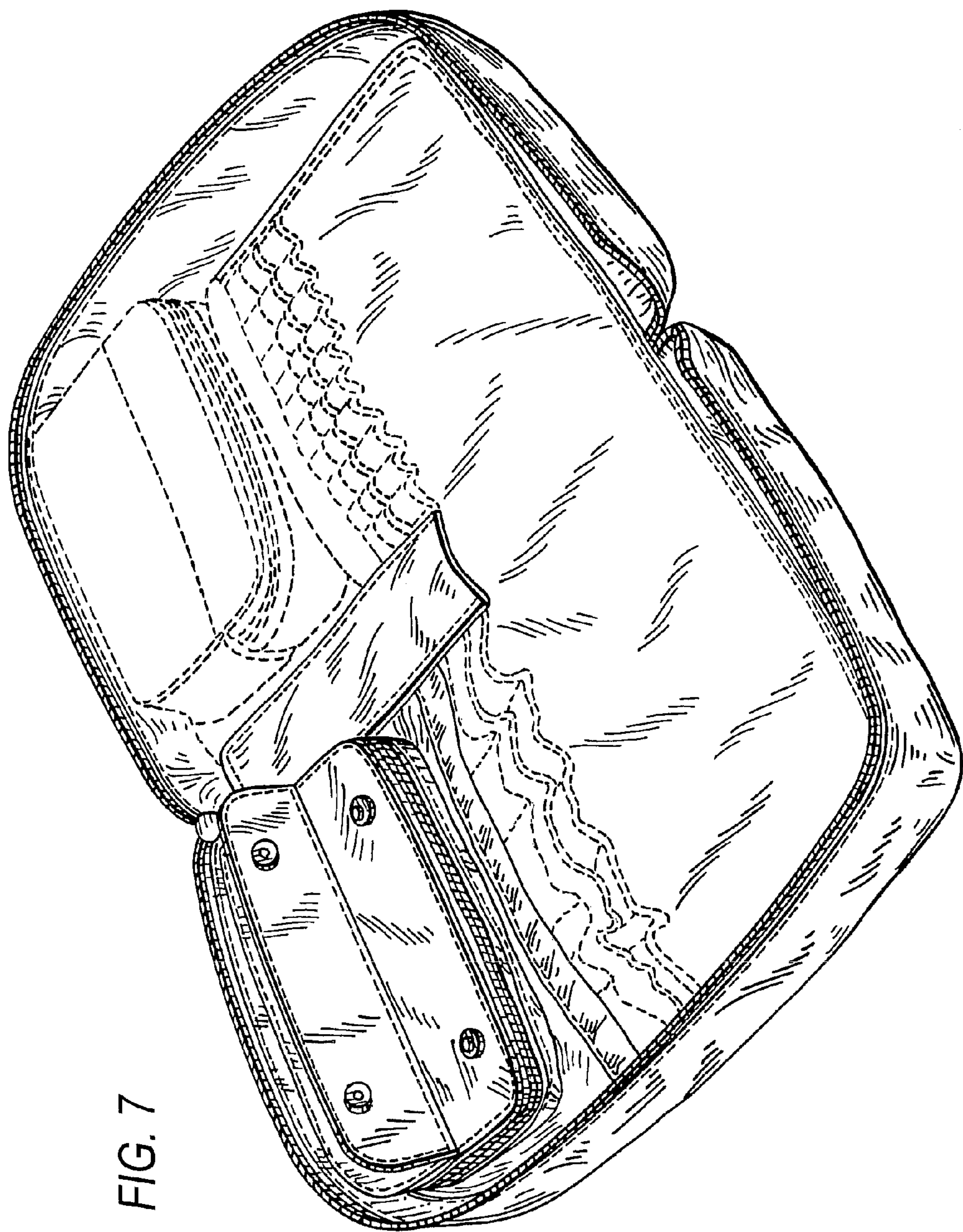
