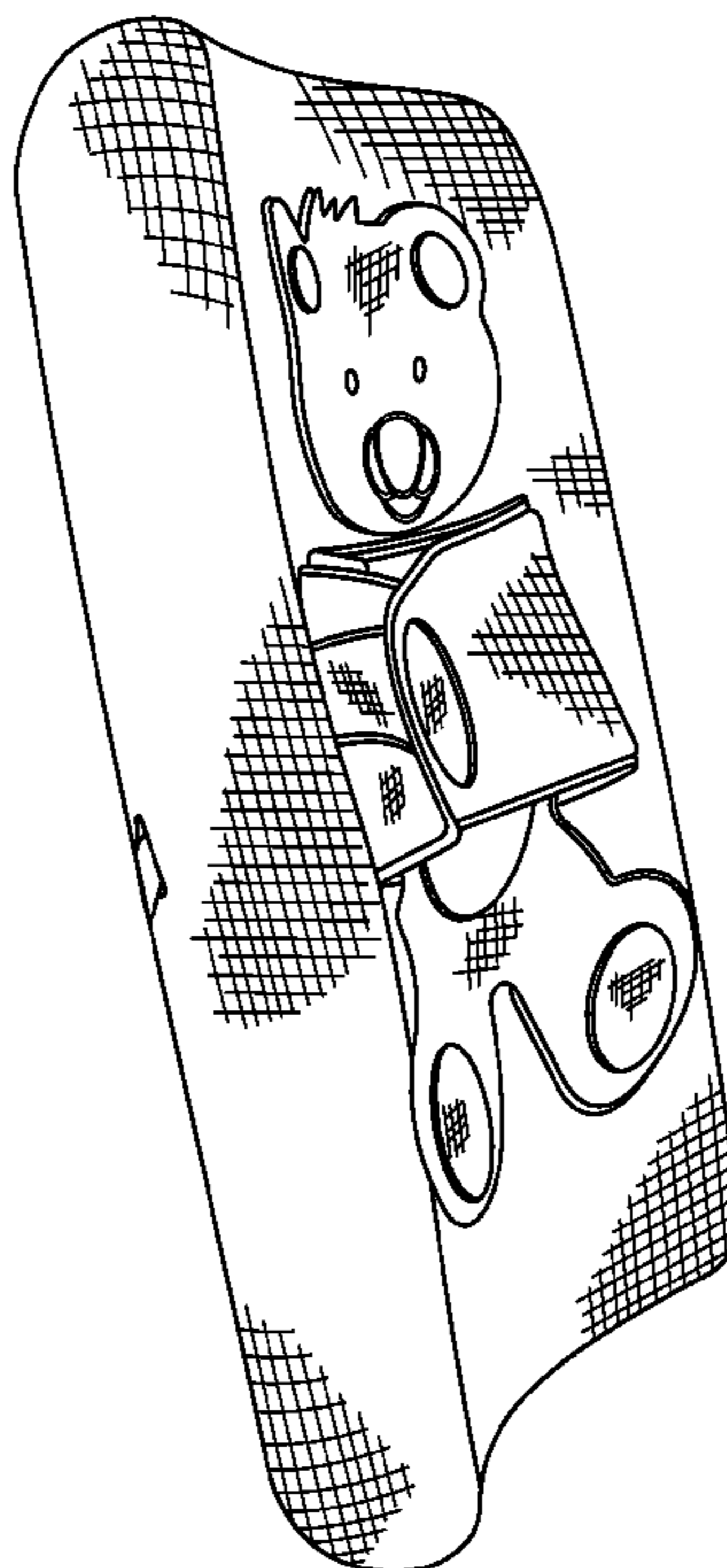
(57) **CLAIM**

I claim the ornamental design for a child swaddle apparatus,  
as shown and described.

**DESCRIPTION**

FIG. 1 is a side perspective view of a child swaddle apparatus;  
FIG. 2 is a front view of FIG. 1;  
FIG. 3 is a rear view of FIG. 1;  
FIG. 4 is a side view of FIG. 1; and,

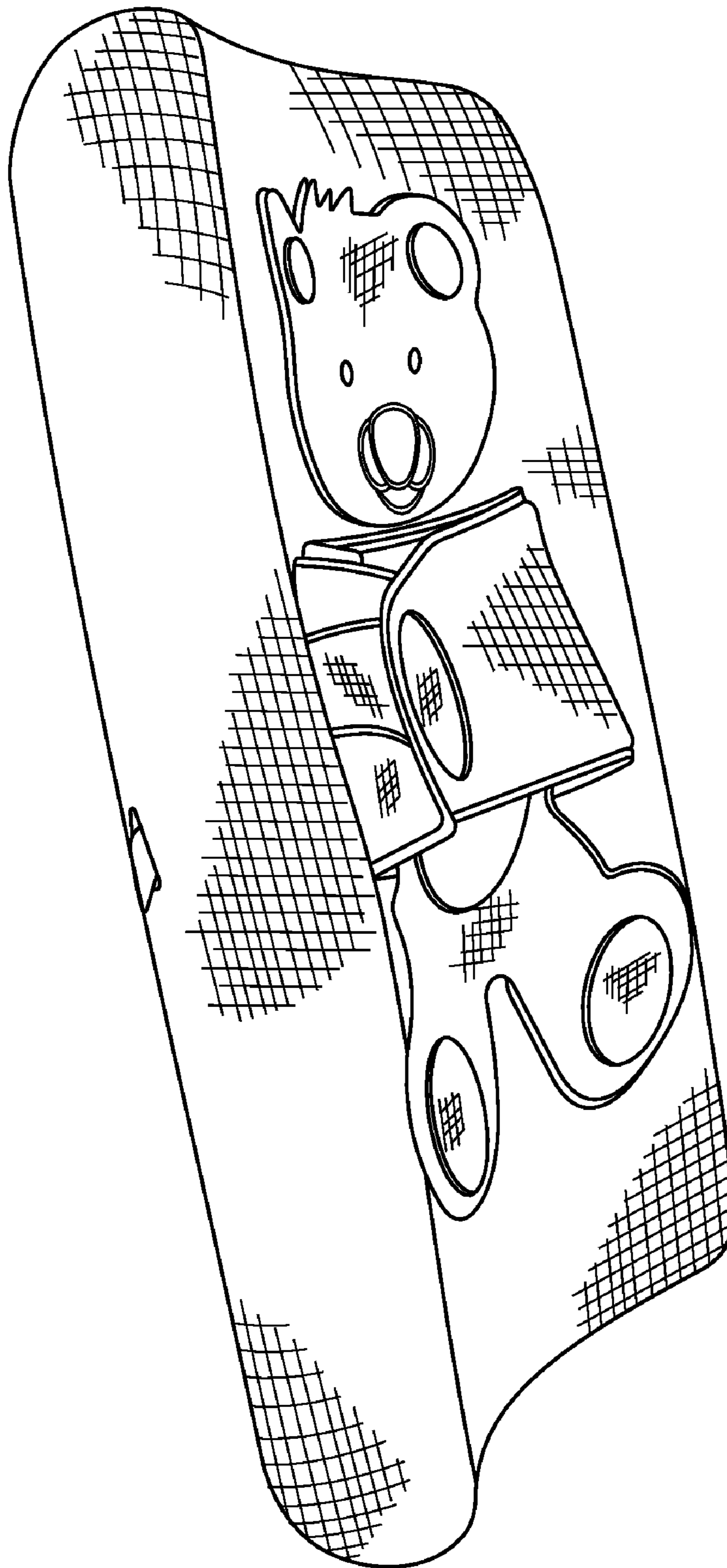

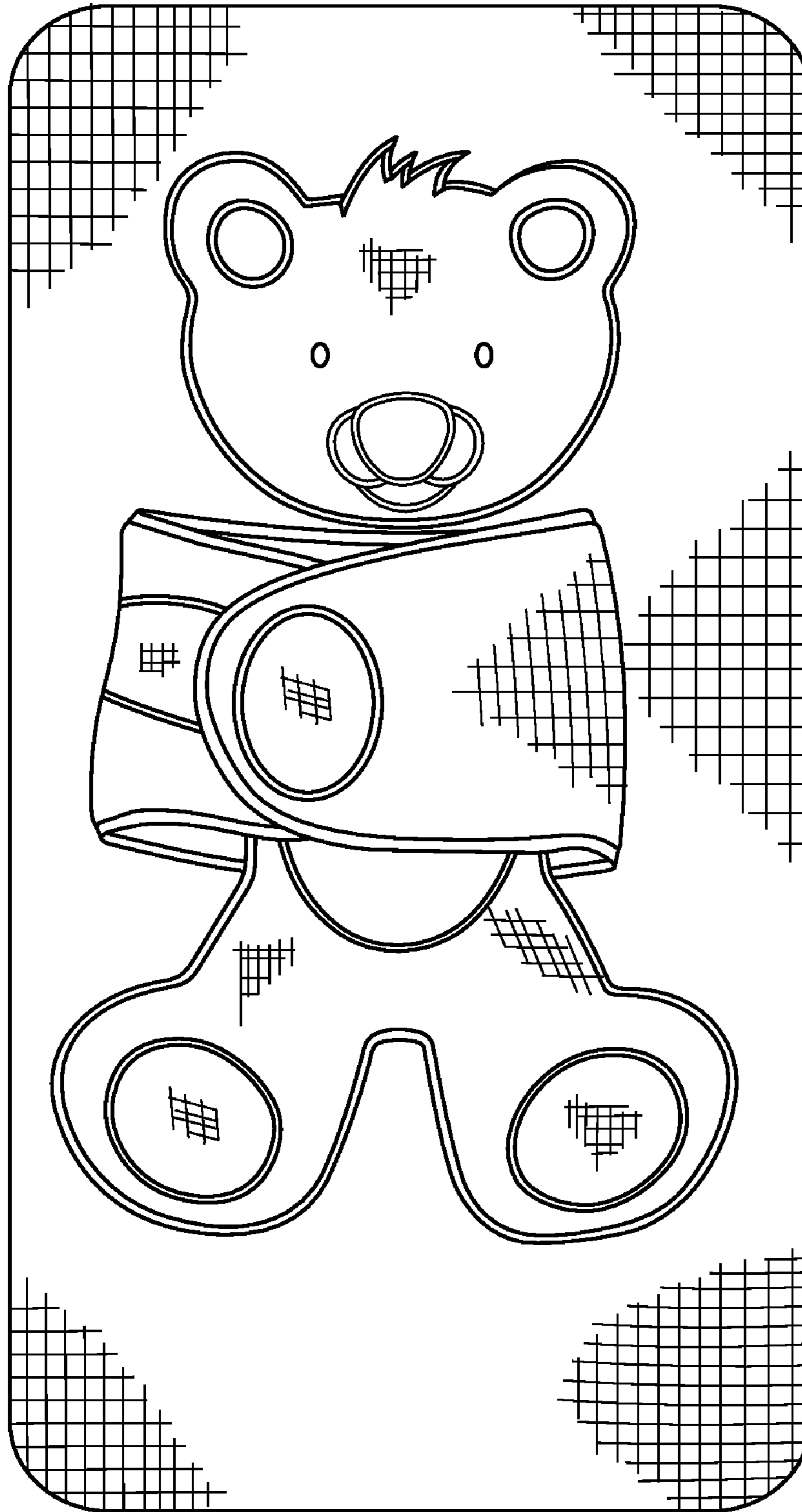

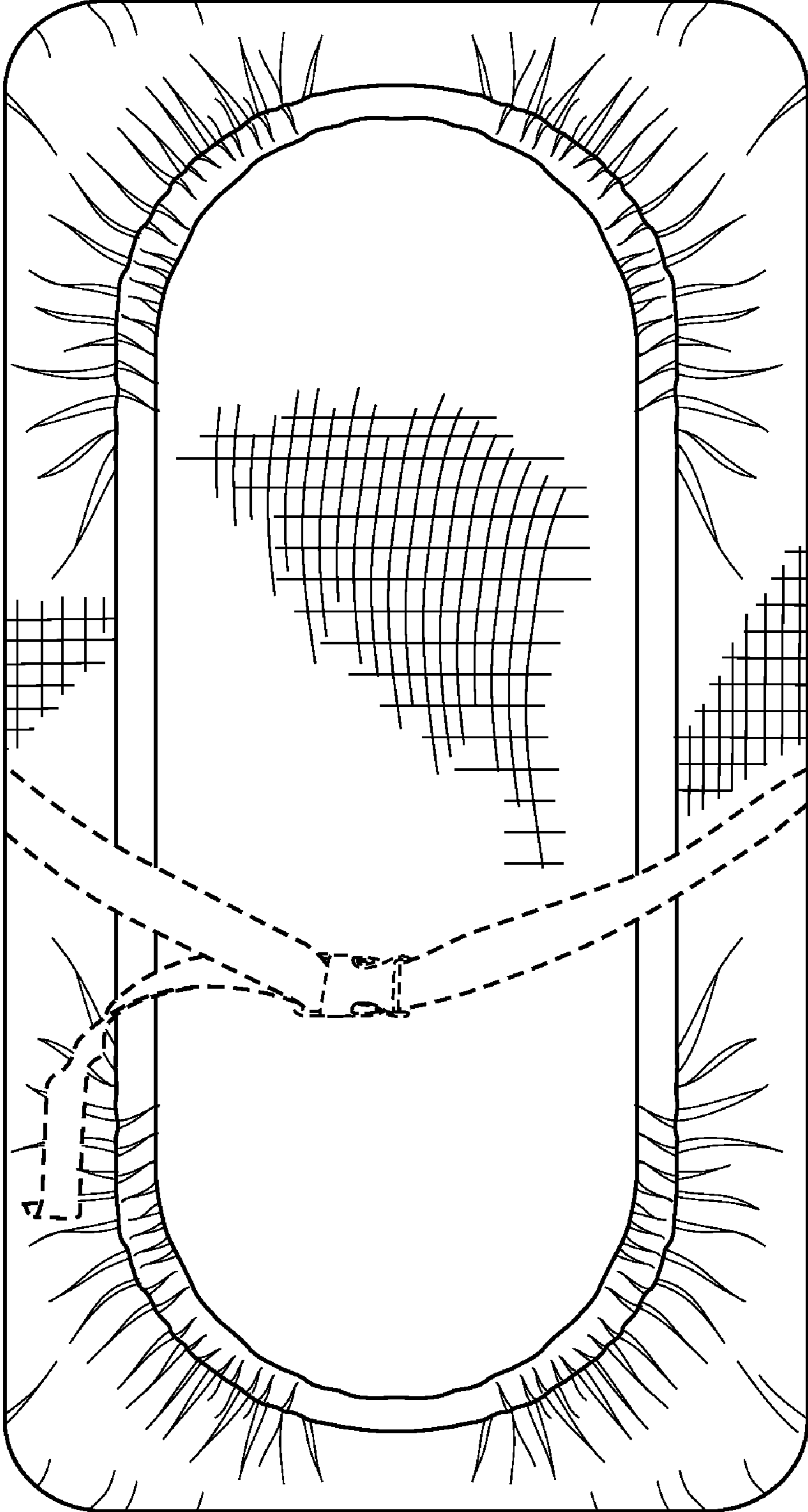

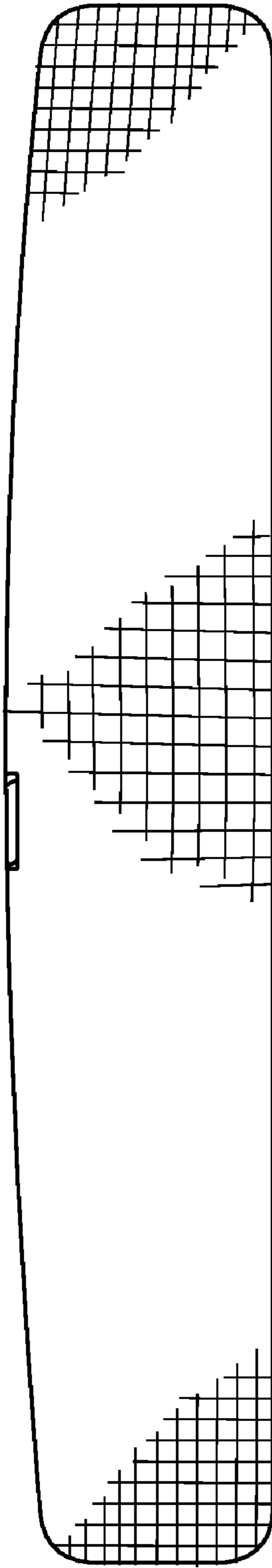

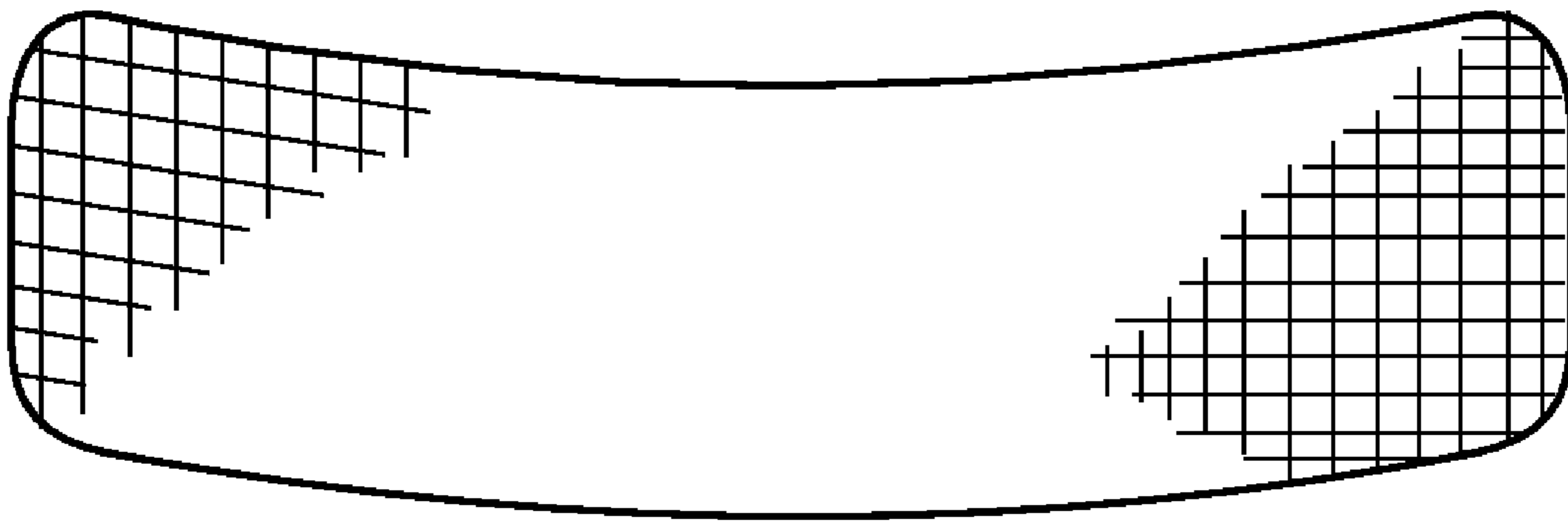
