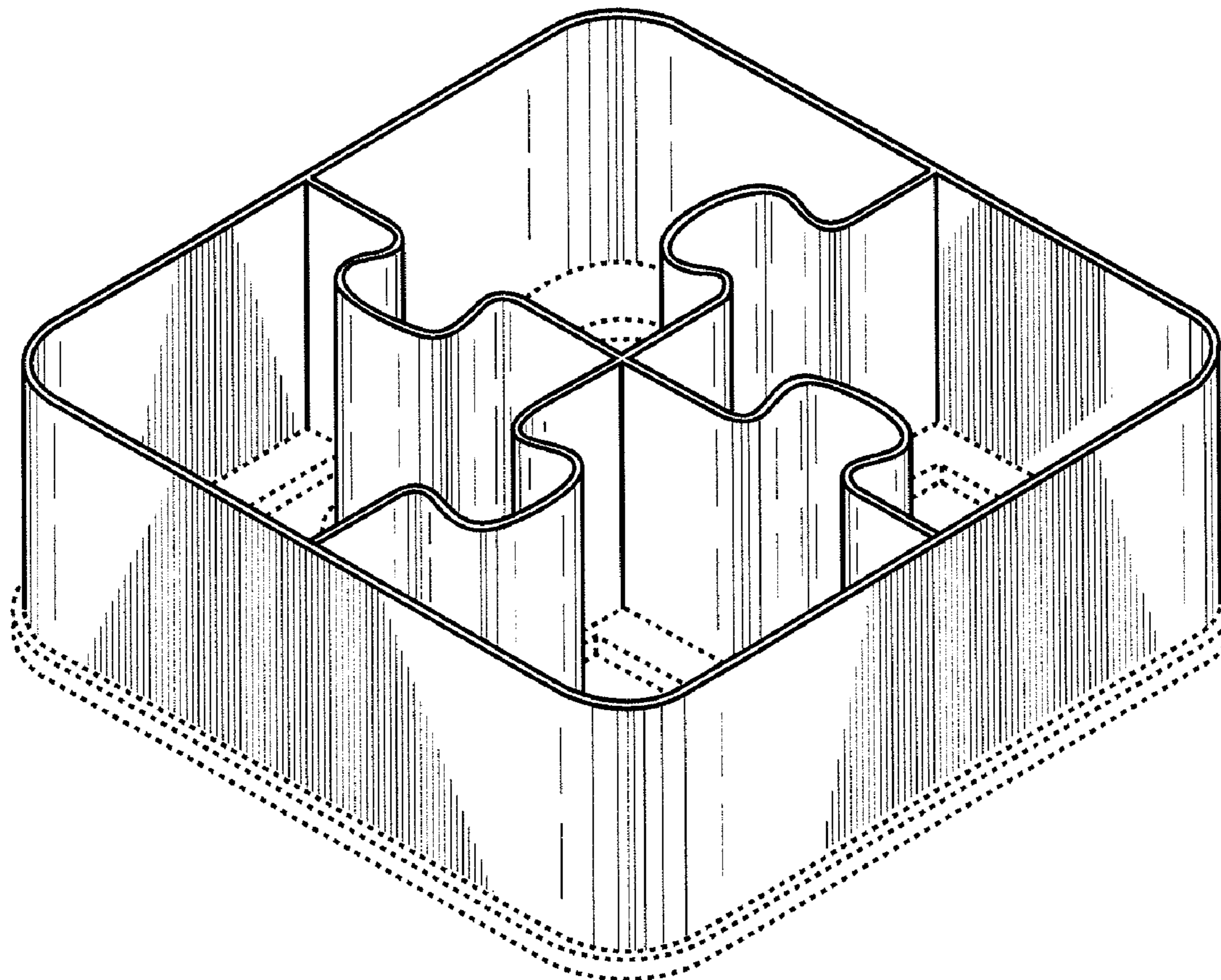
(57) **CLAIM**

The ornamental design for a sandwich bread crust cutter, as shown and described.

DESCRIPTION

FIG. 1 is a bottom view of the cutting pattern applied to a sandwich bread crust cutter showing my new design; FIG. 2. is a front elevation view thereof; FIG. 3. is an isometric view thereof; FIG. 4. is a top plan view thereof; FIG. 5. is a right side elevation view thereof; FIG. 6. is a left elevation view thereof; and, FIG. 7. is a rear elevation view thereof.

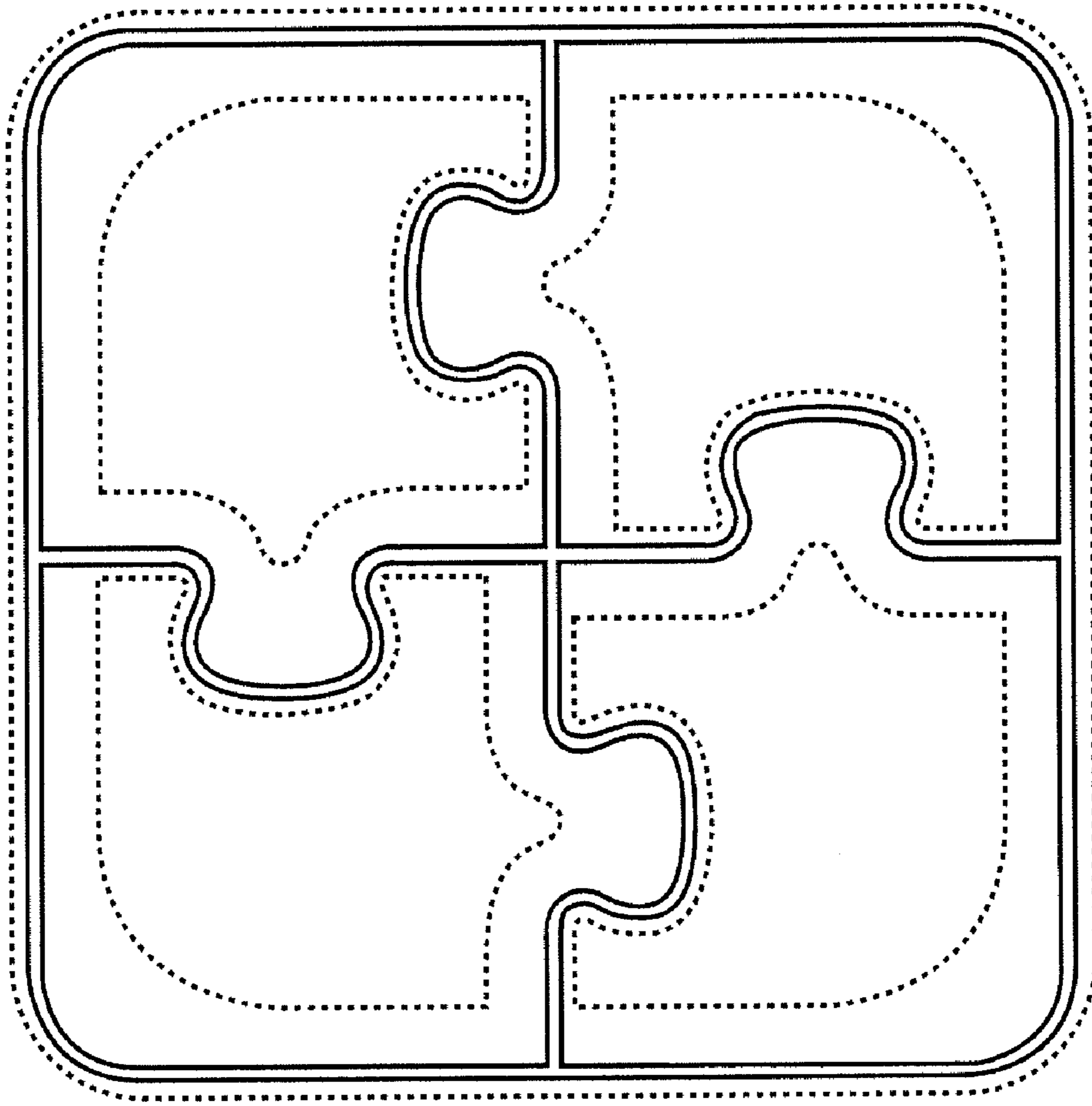

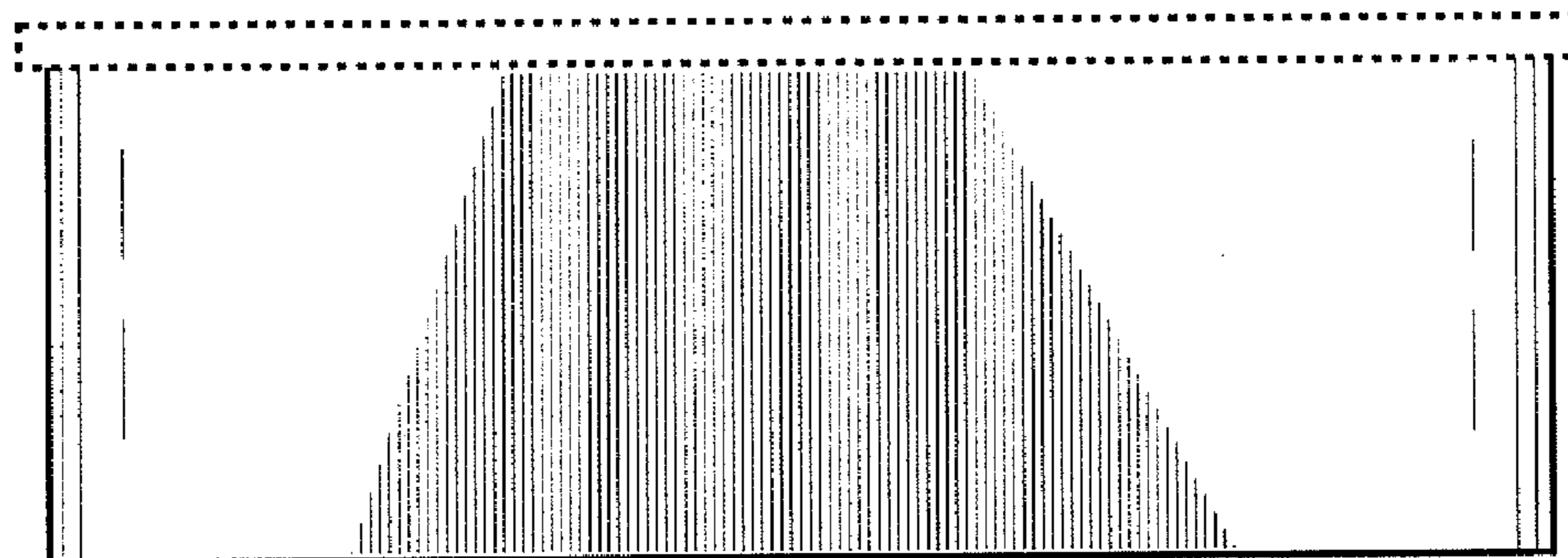

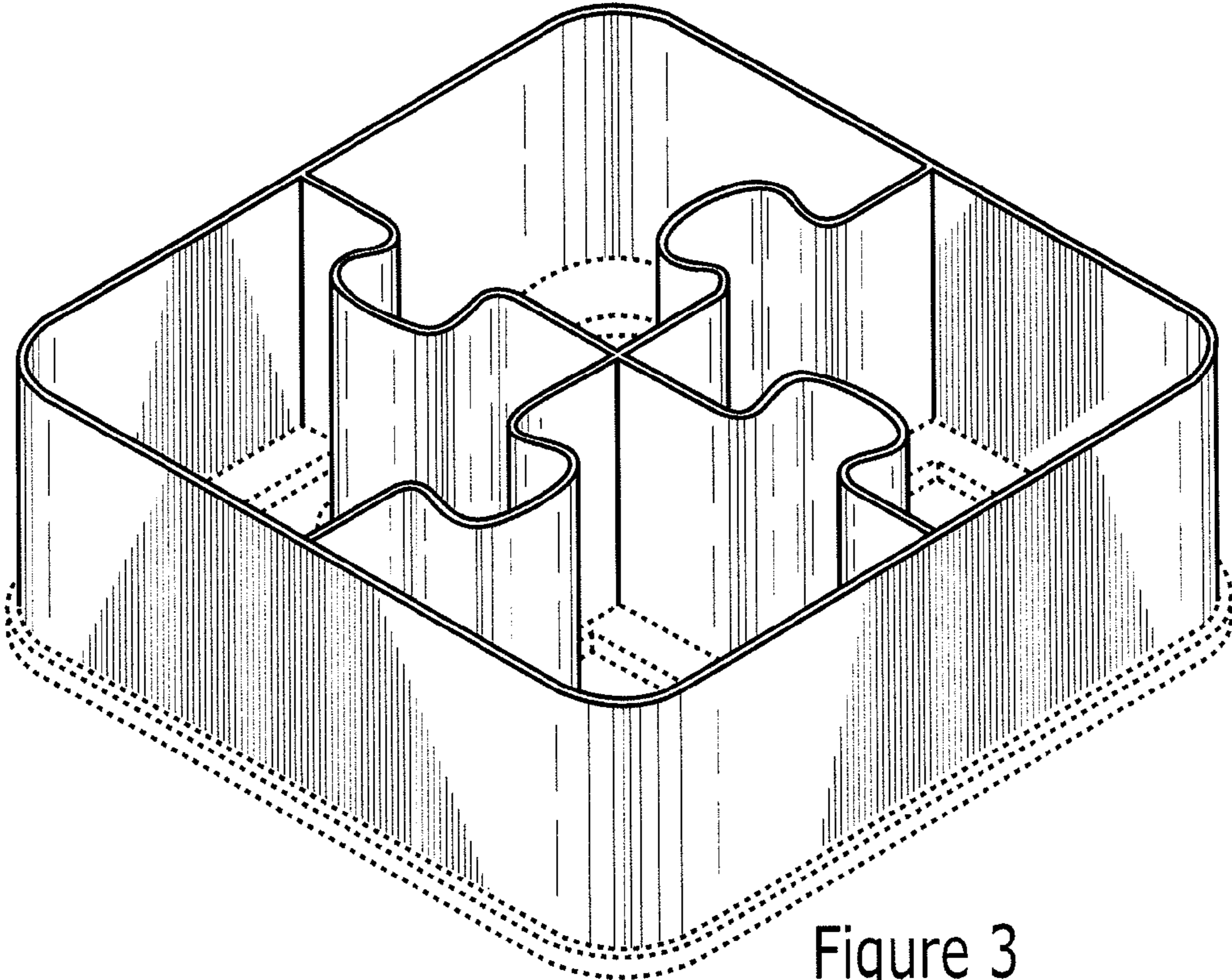

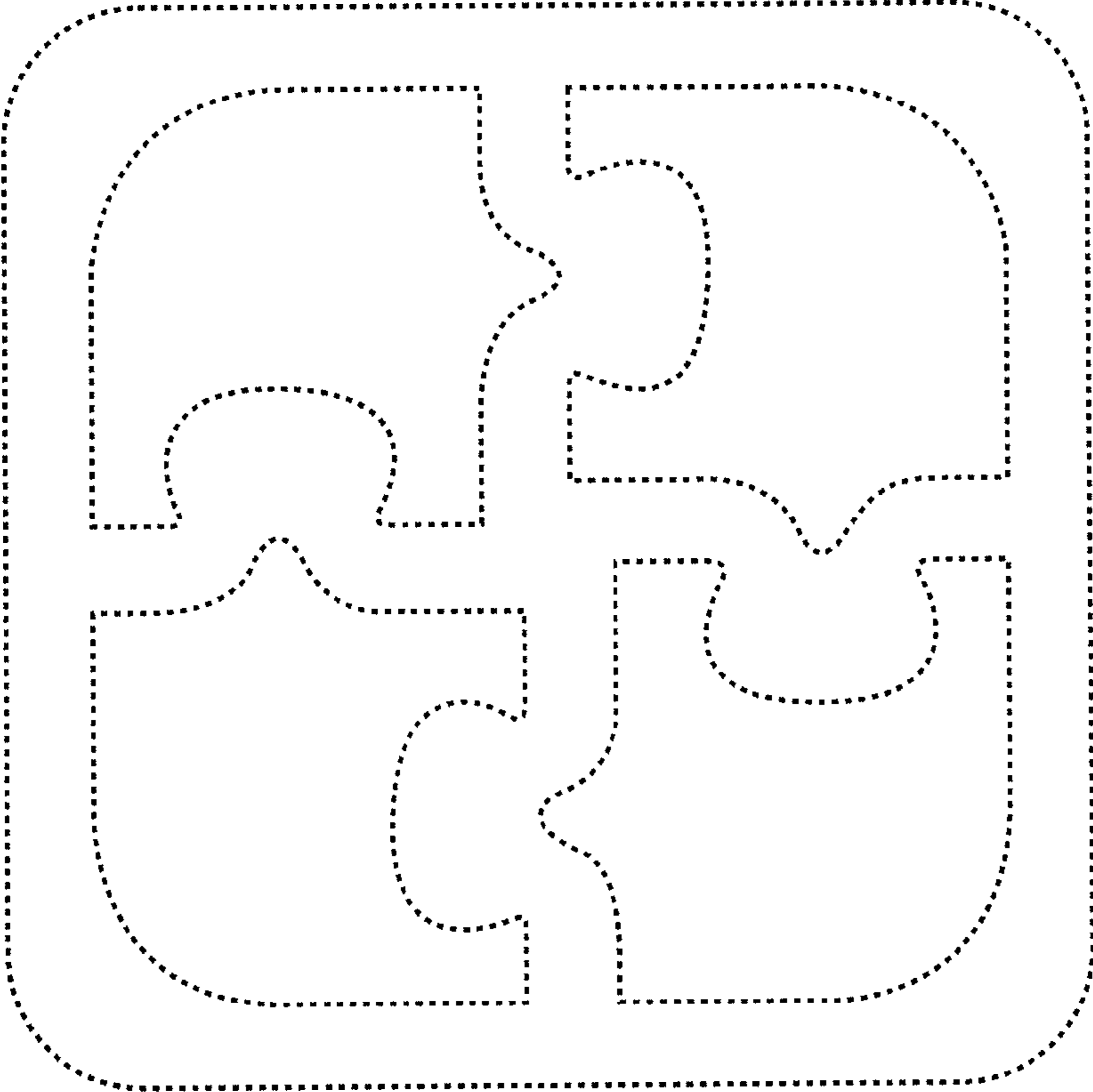

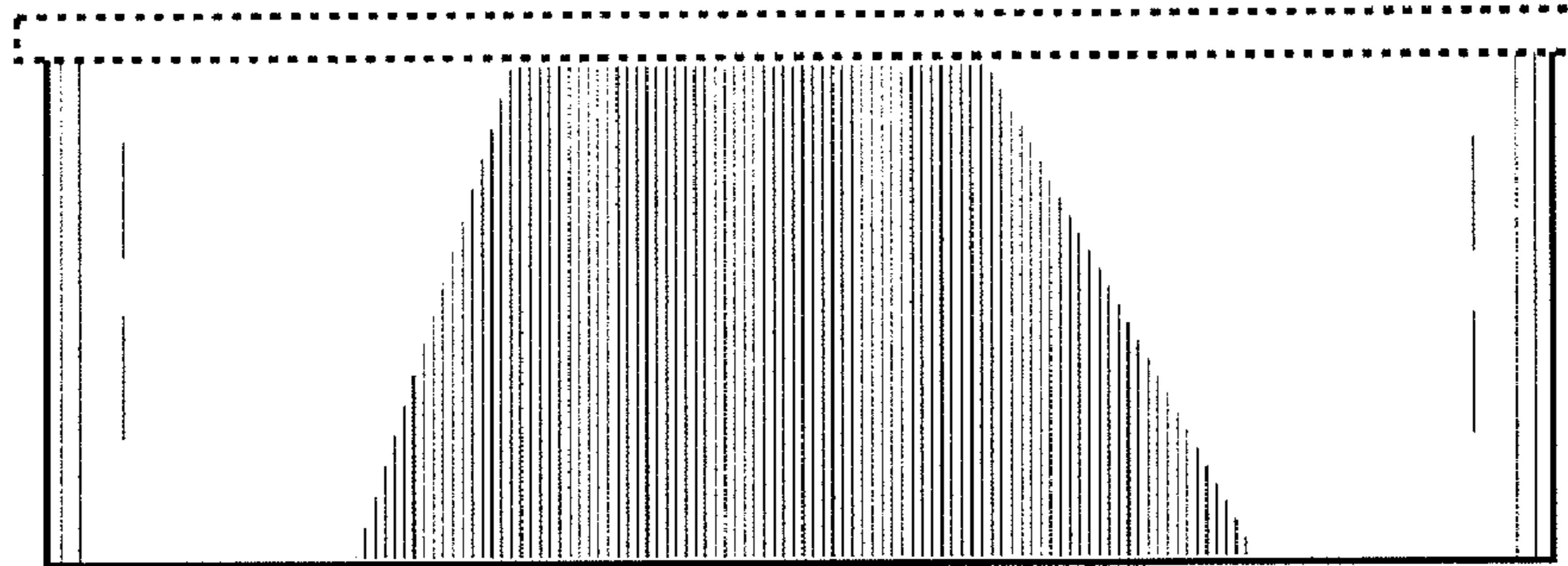

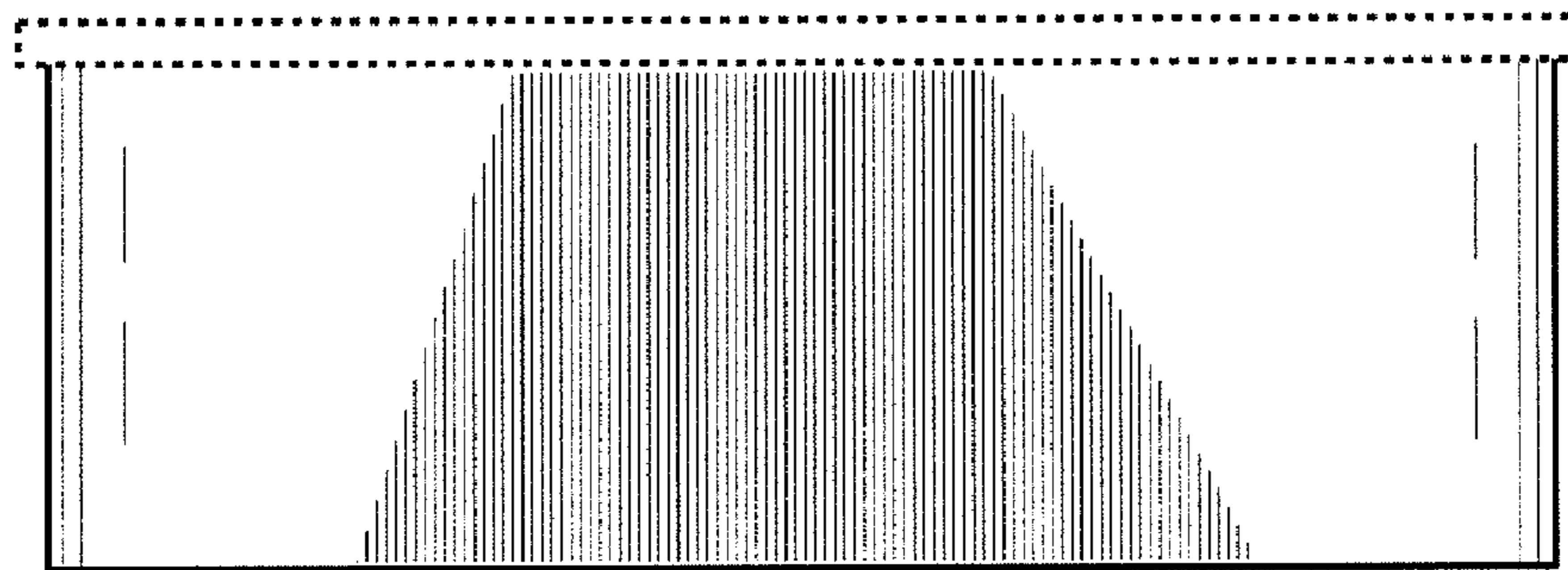

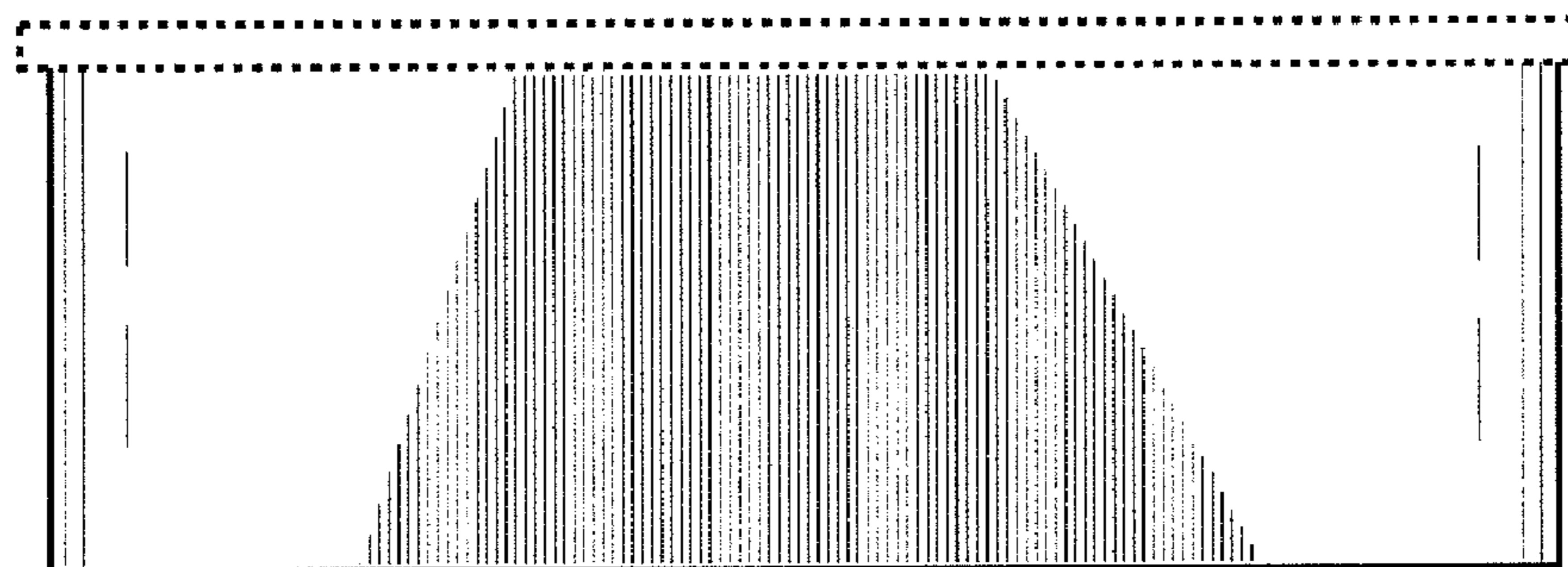
