The ornamental design for a patchworking template, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a patchworking template according to a first embodiment of my new design;

FIG. 2 is a front view of the template;

FIG. 3 is a rear view of the template;

FIG. 4 is a top plan view of the template;

FIG. 5 is a bottom view of the template;

FIG. 6 is a left side view of the template;

FIG. 7 is a right side view of the template;

FIG. 8 is a perspective view of a patchworking template according to a second embodiment of my new design;

FIG. 9 is a front view of the second embodiment template;

FIG. 10 is a rear view of the second embodiment template, the top plan view, bottom view, left side view and right side view of the second embodiment template being identical to those of the first embodiment template;

FIG. 11 is a perspective view of a patchworking template according to a third embodiment of my new design;

FIG. 12 is a front view of the third embodiment template; and,

FIG. 13 is a rear view of the third embodiment template, the top plan view, bottom view, left side view and right side view of the third embodiment template being identical to those of the first embodiment template.

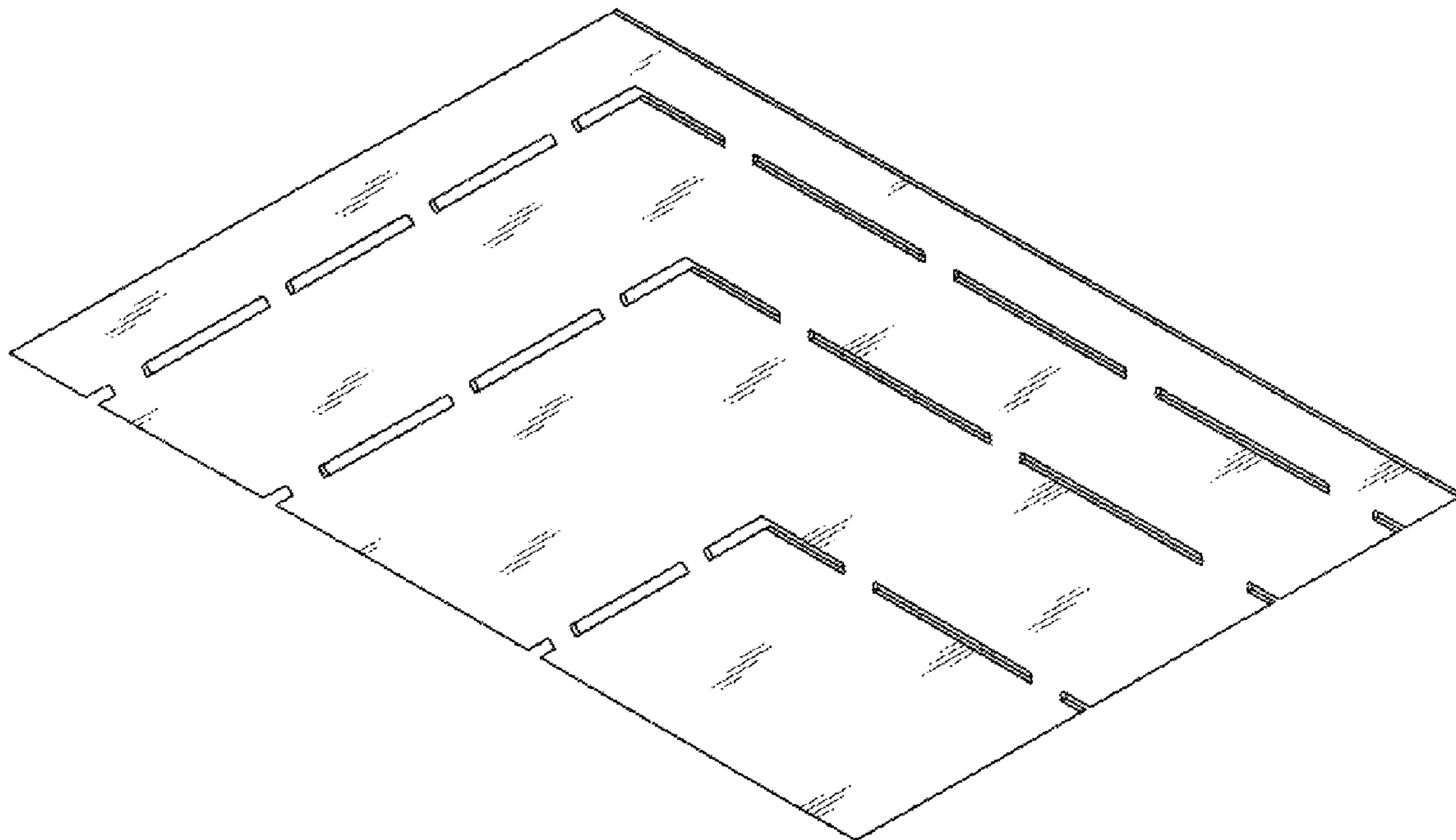

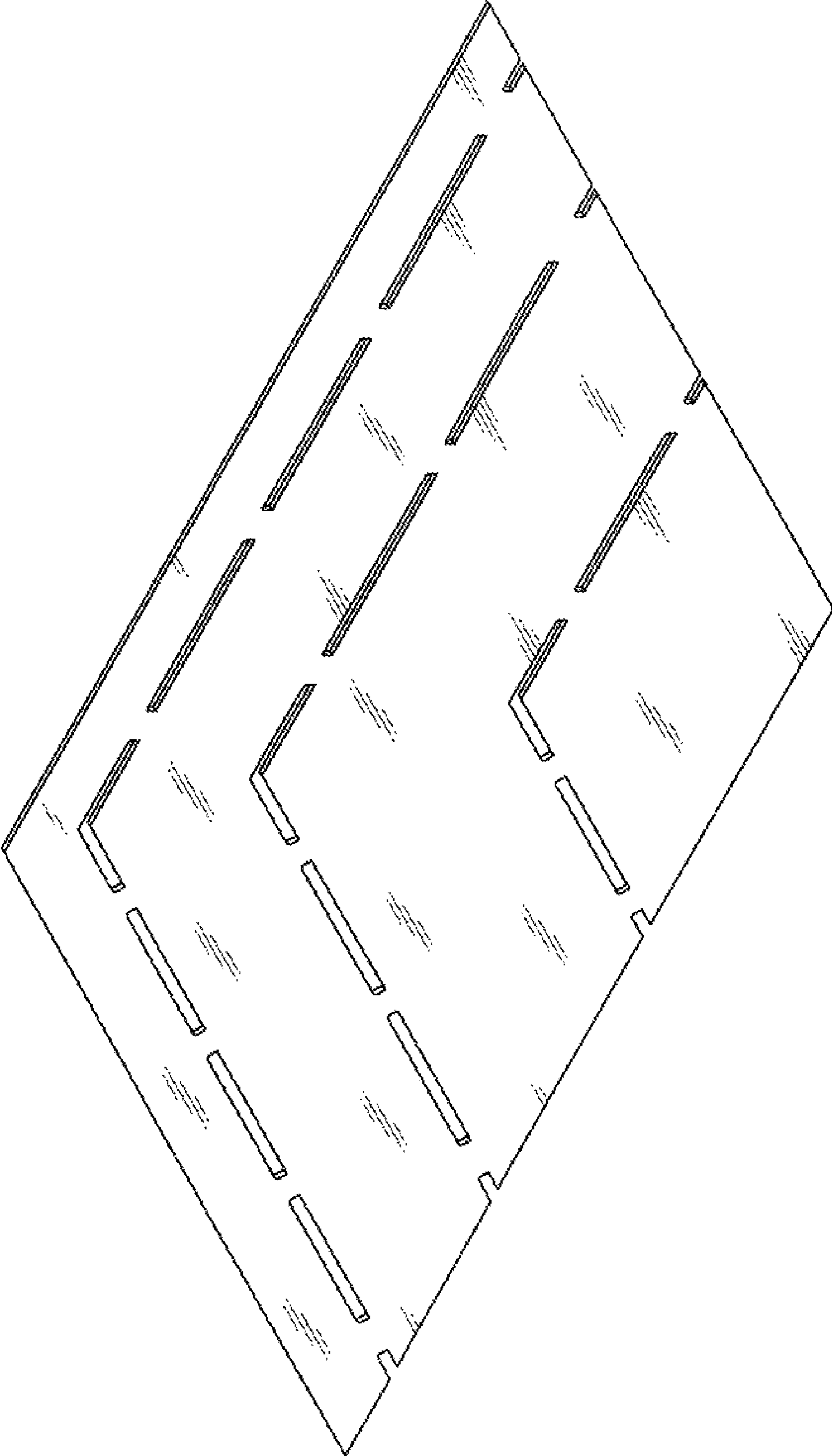

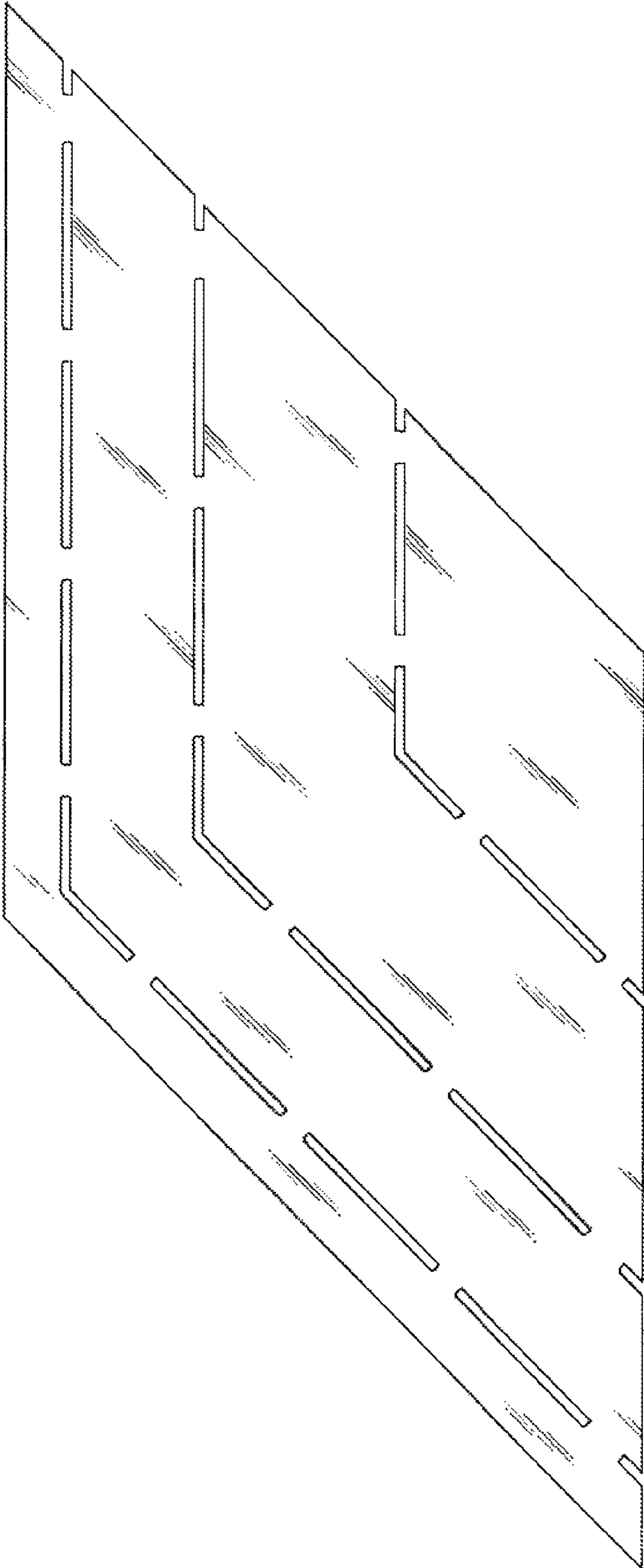

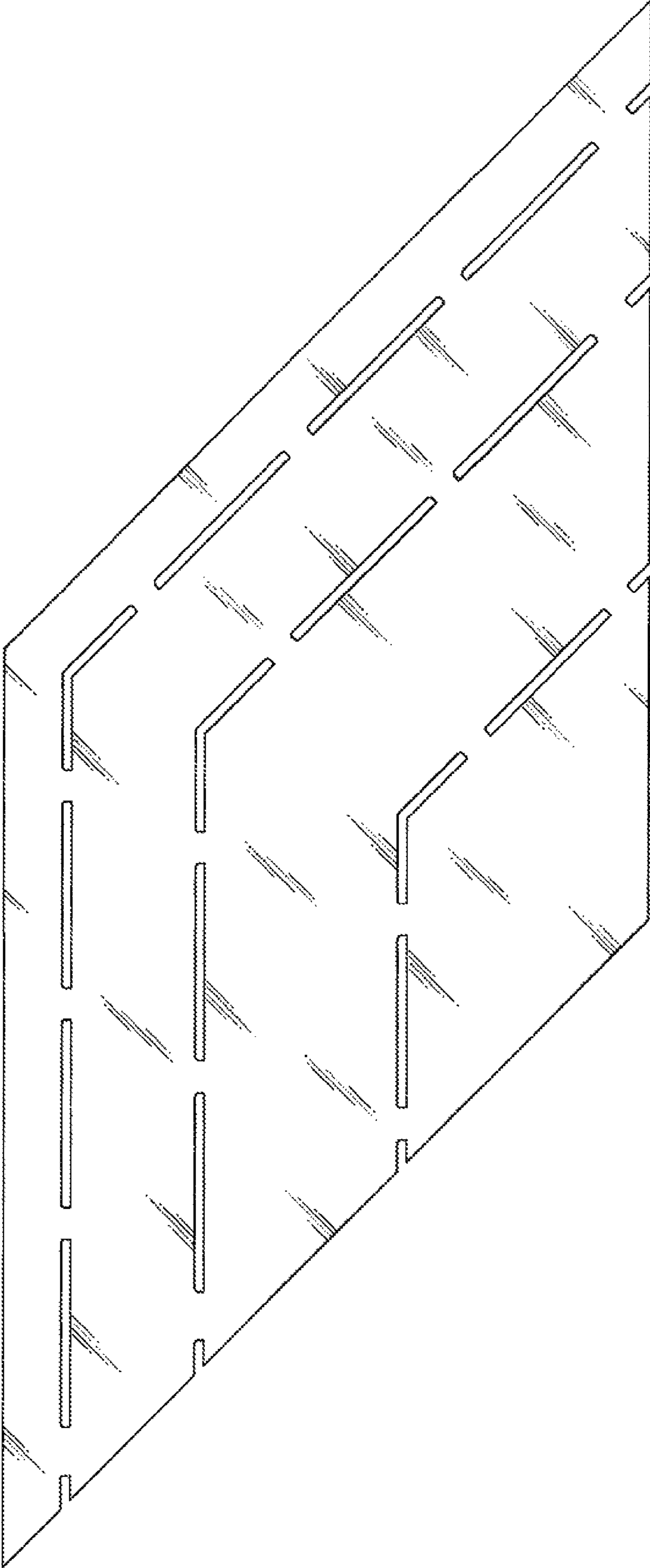

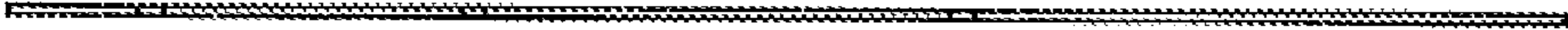

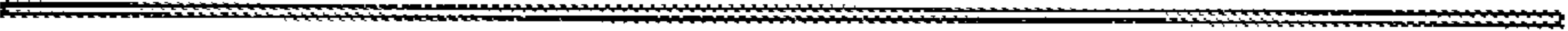

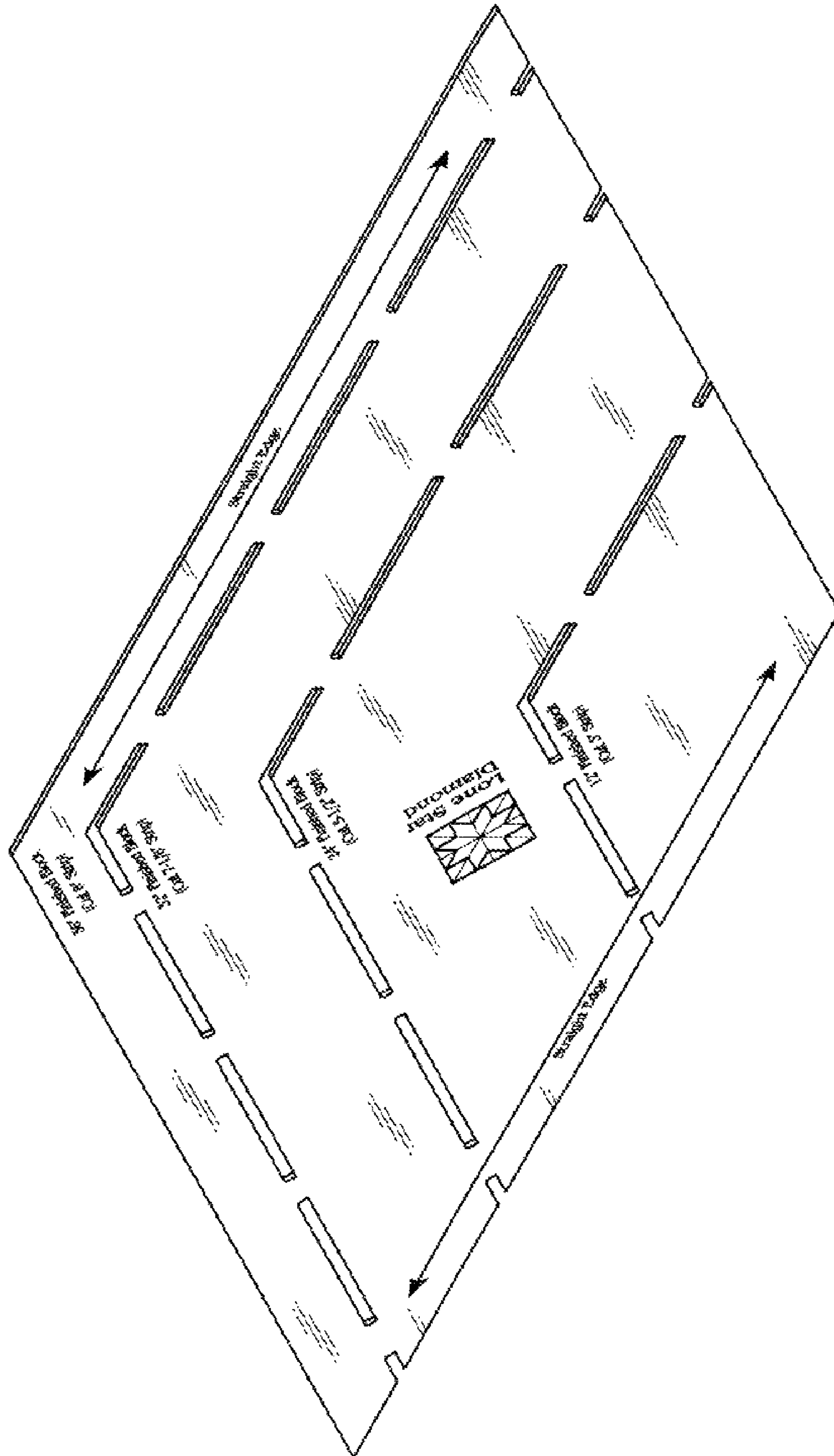

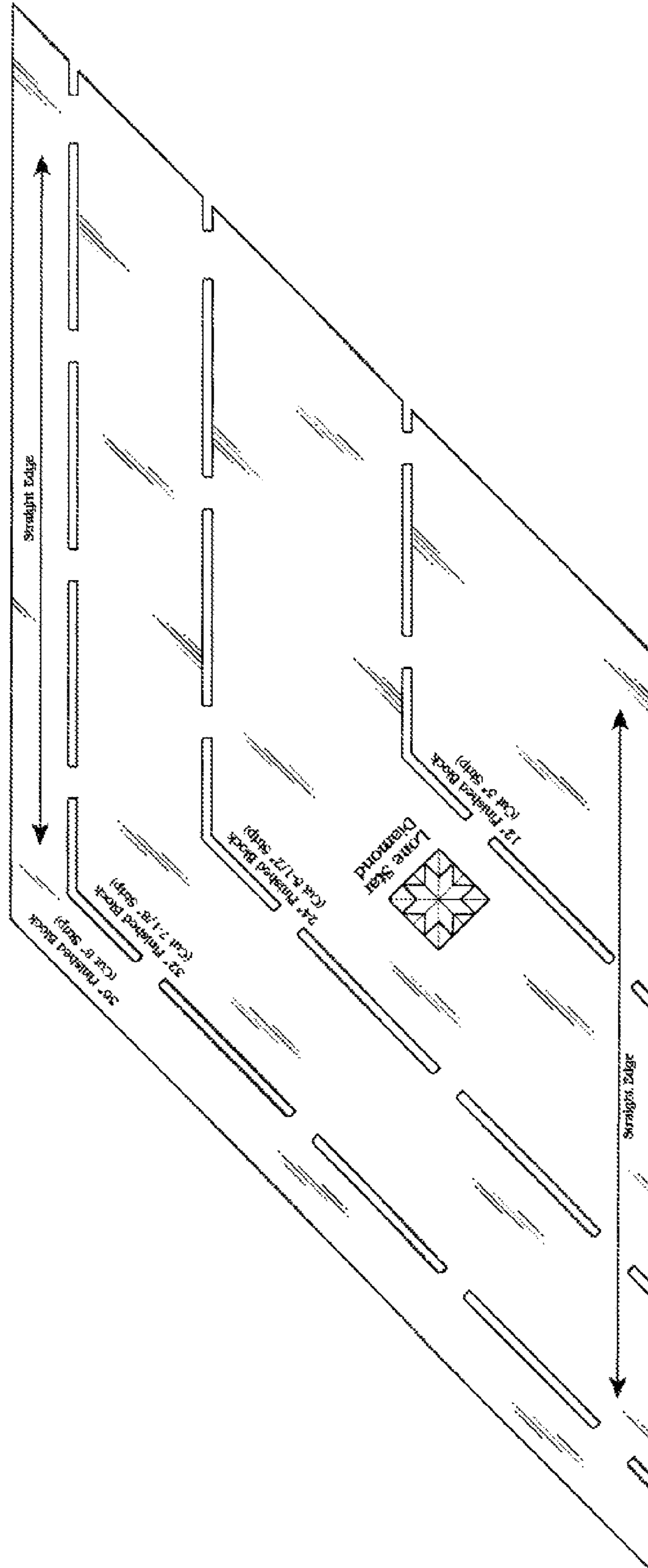

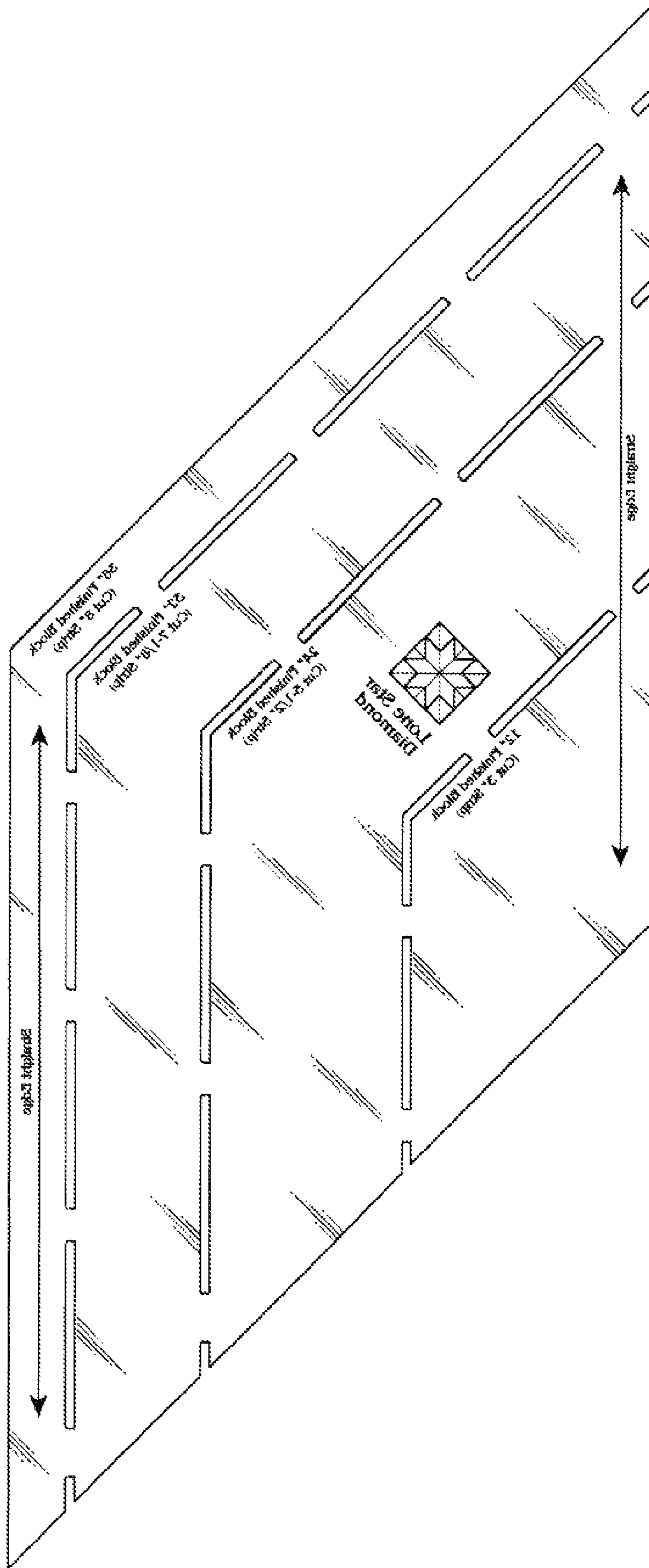

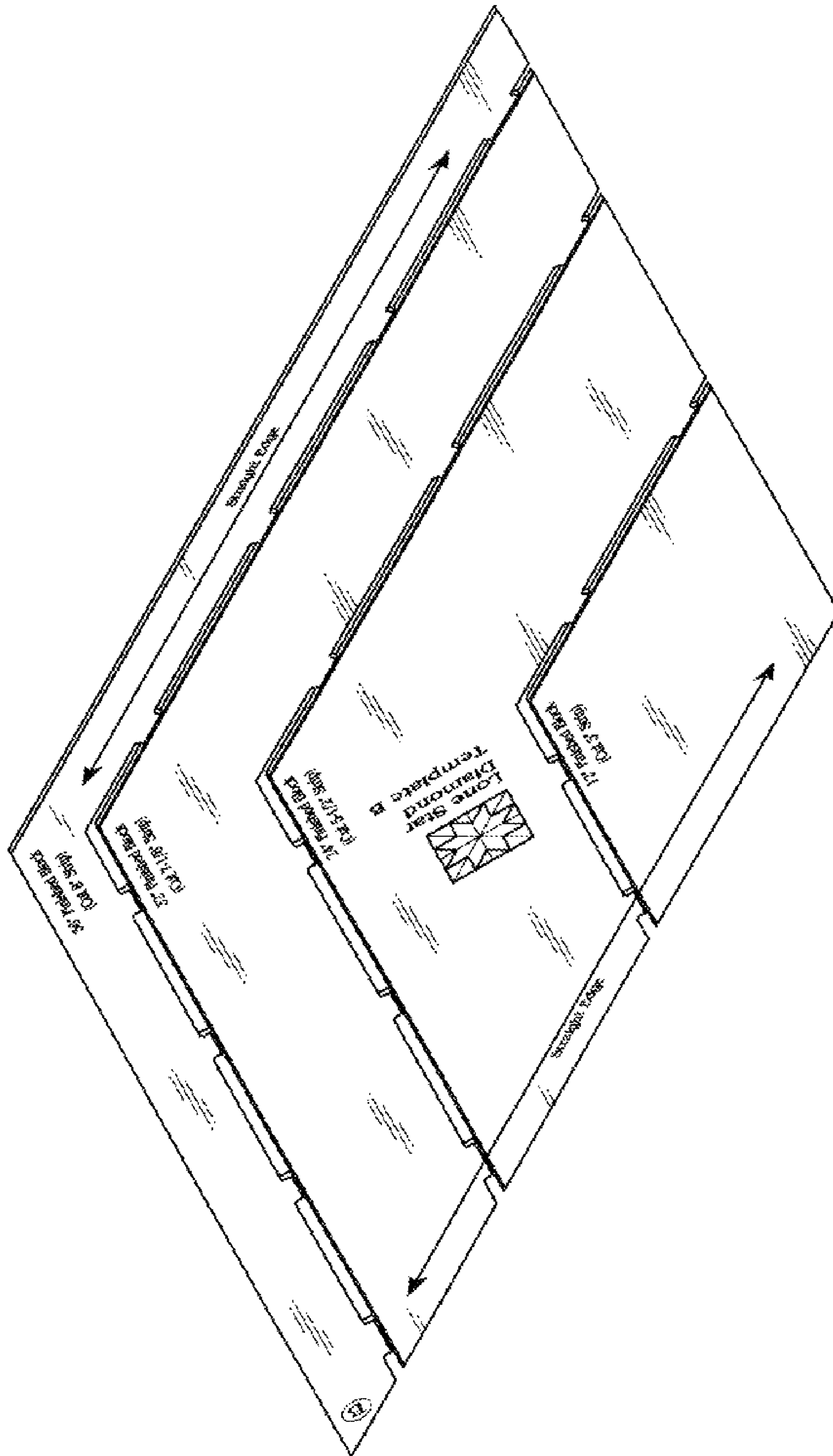

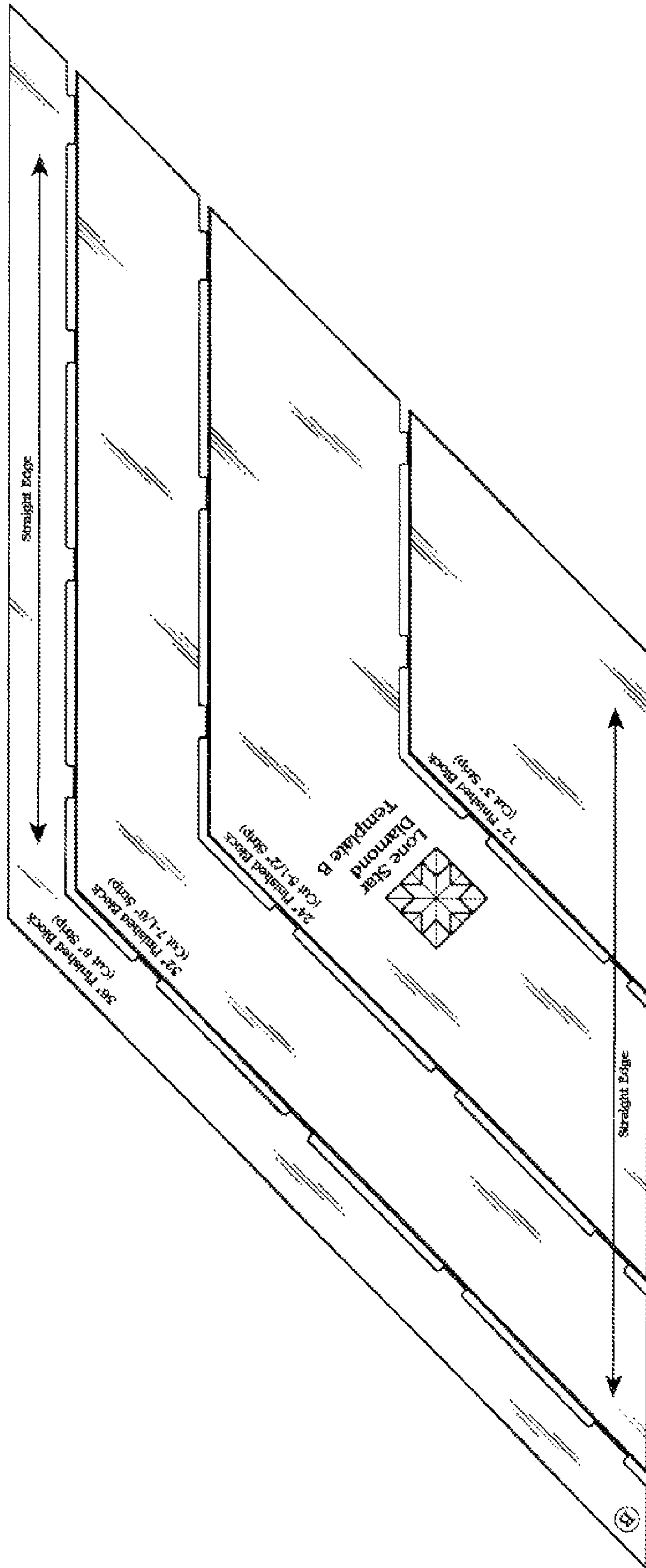
