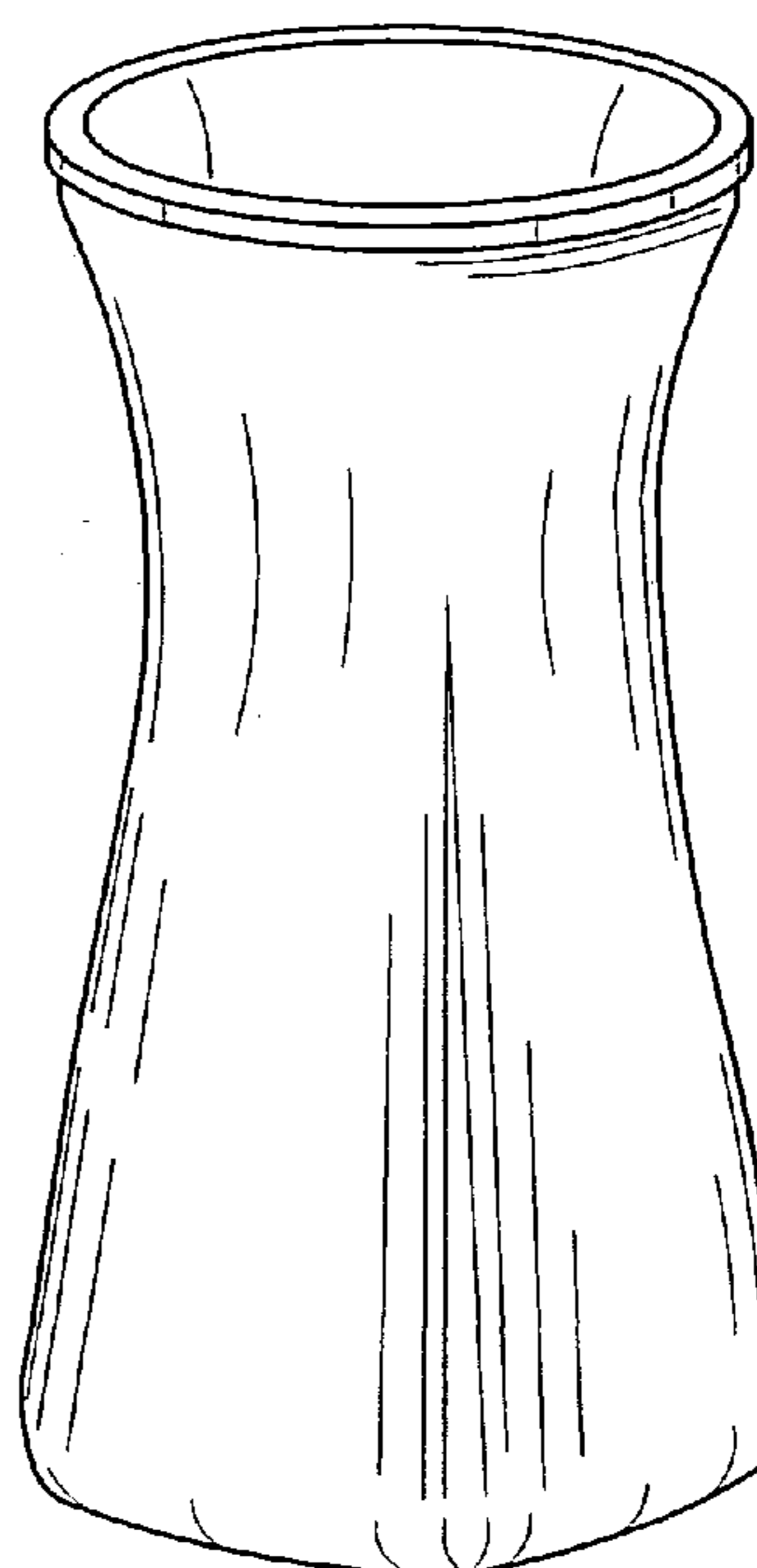
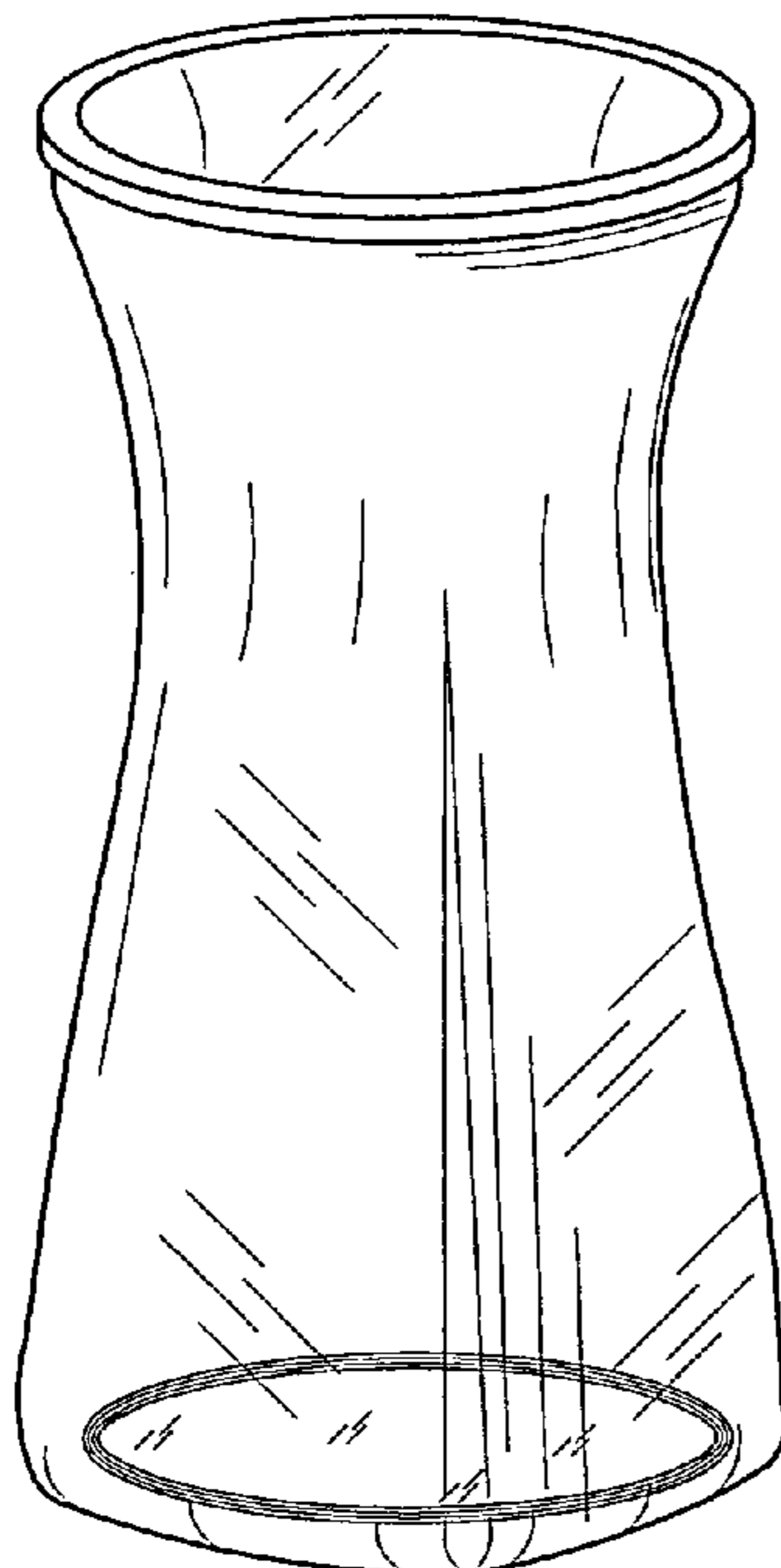
(57) **CLAIM**

The ornamental design for a blended vase, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a blended vase showing a first embodiment of my new design;  
 FIG. 2 is a top plan view thereof;  
 FIG. 3 is a front elevation view thereof, the rear elevation view being a mirror image thereof;  
 FIG. 4 is a right side elevation view thereof, the left side elevation view being a mirror image thereof;  
 FIG. 5 is a bottom plan view thereof;  
 FIG. 6 is a perspective view of a blended vase showing a second embodiment of my new design, which is identical to the embodiment shown in FIGS. 1-5 but is opaque;  
 FIG. 7 is a perspective view of a blended vase showing a third embodiment of my new design; and,  
 FIG. 8 is a perspective view of a blended vase showing a fourth embodiment of my new design, which is identical to the embodiment shown in FIG. 7 but is opaque.

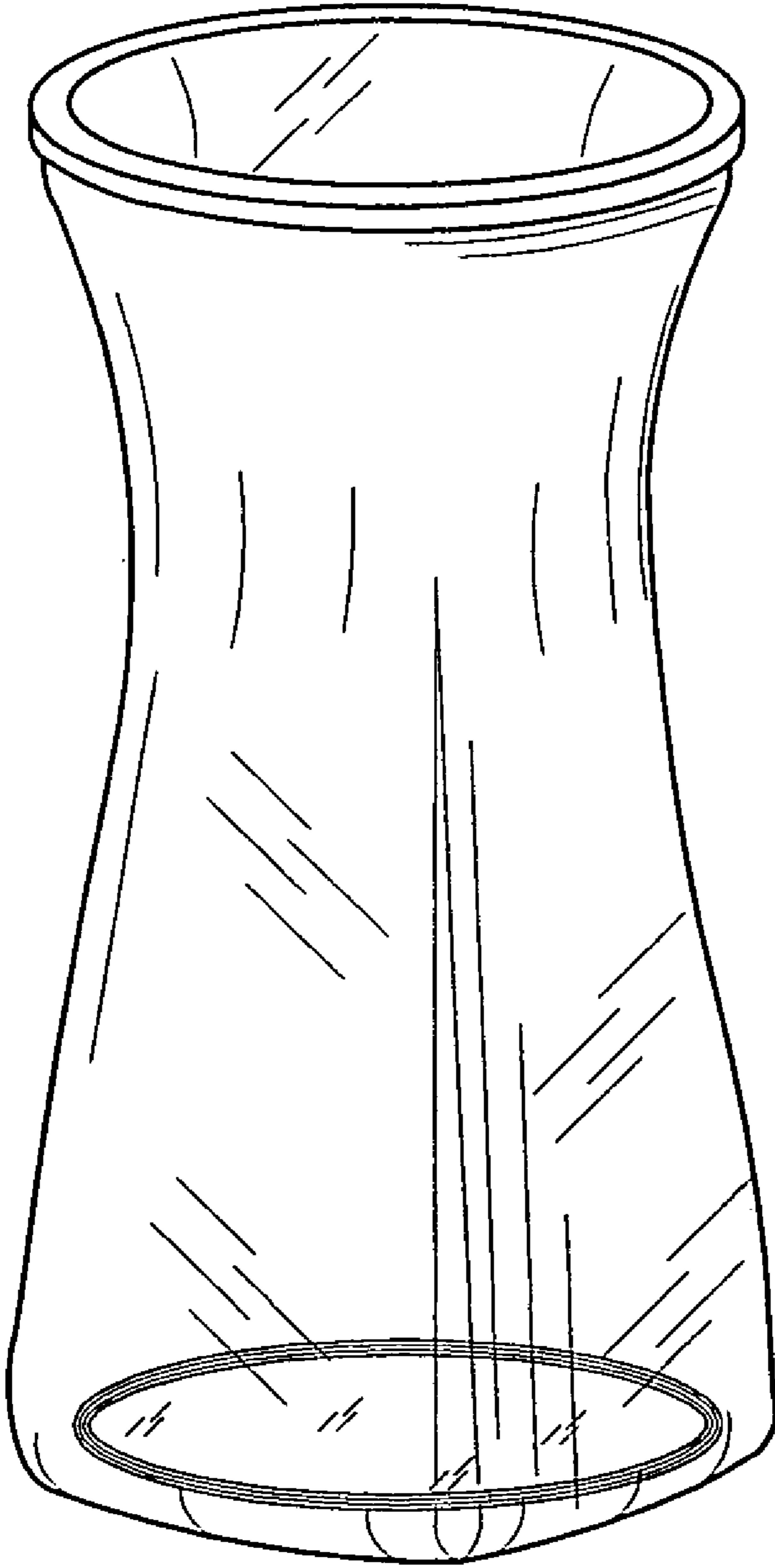

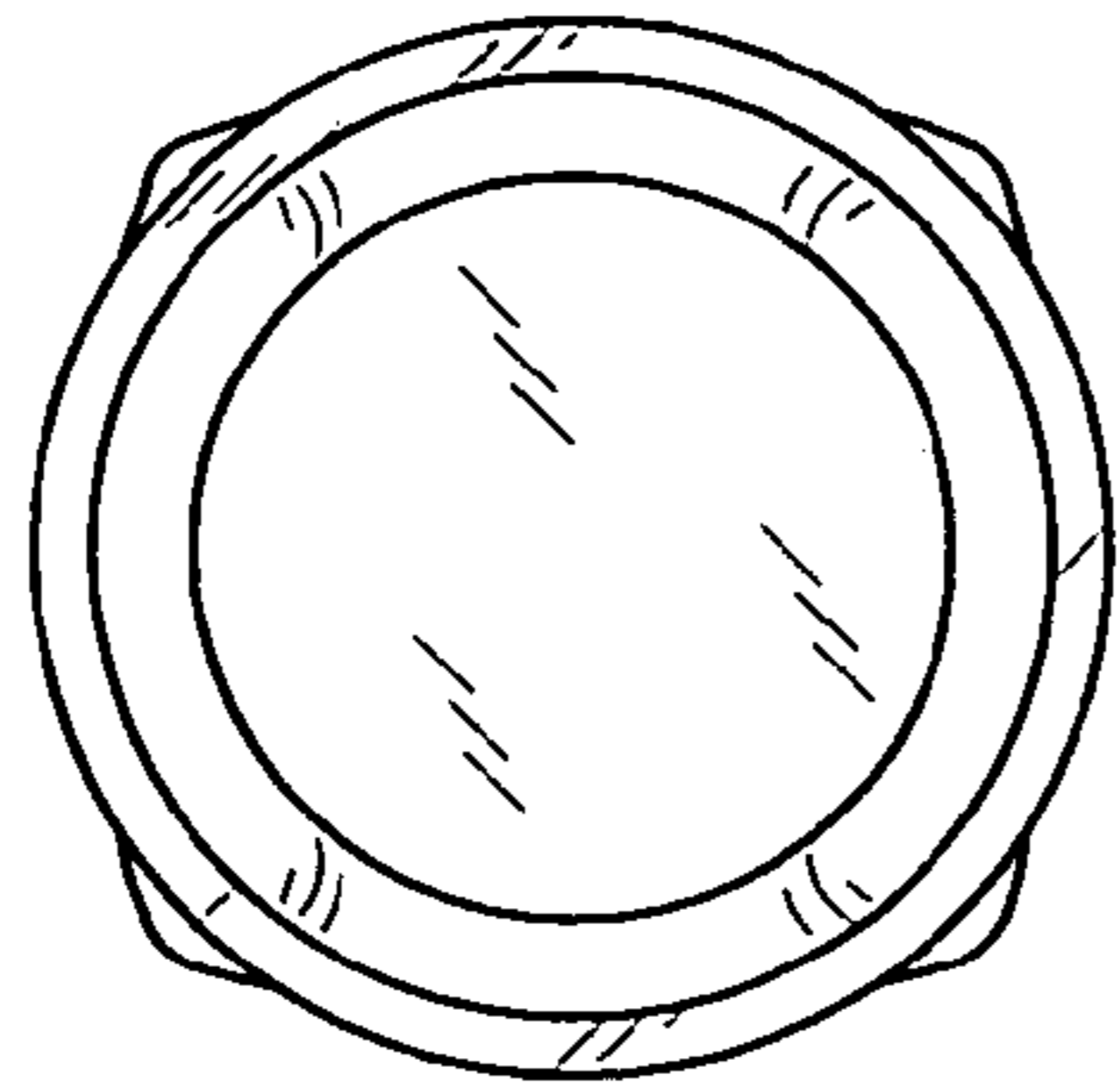

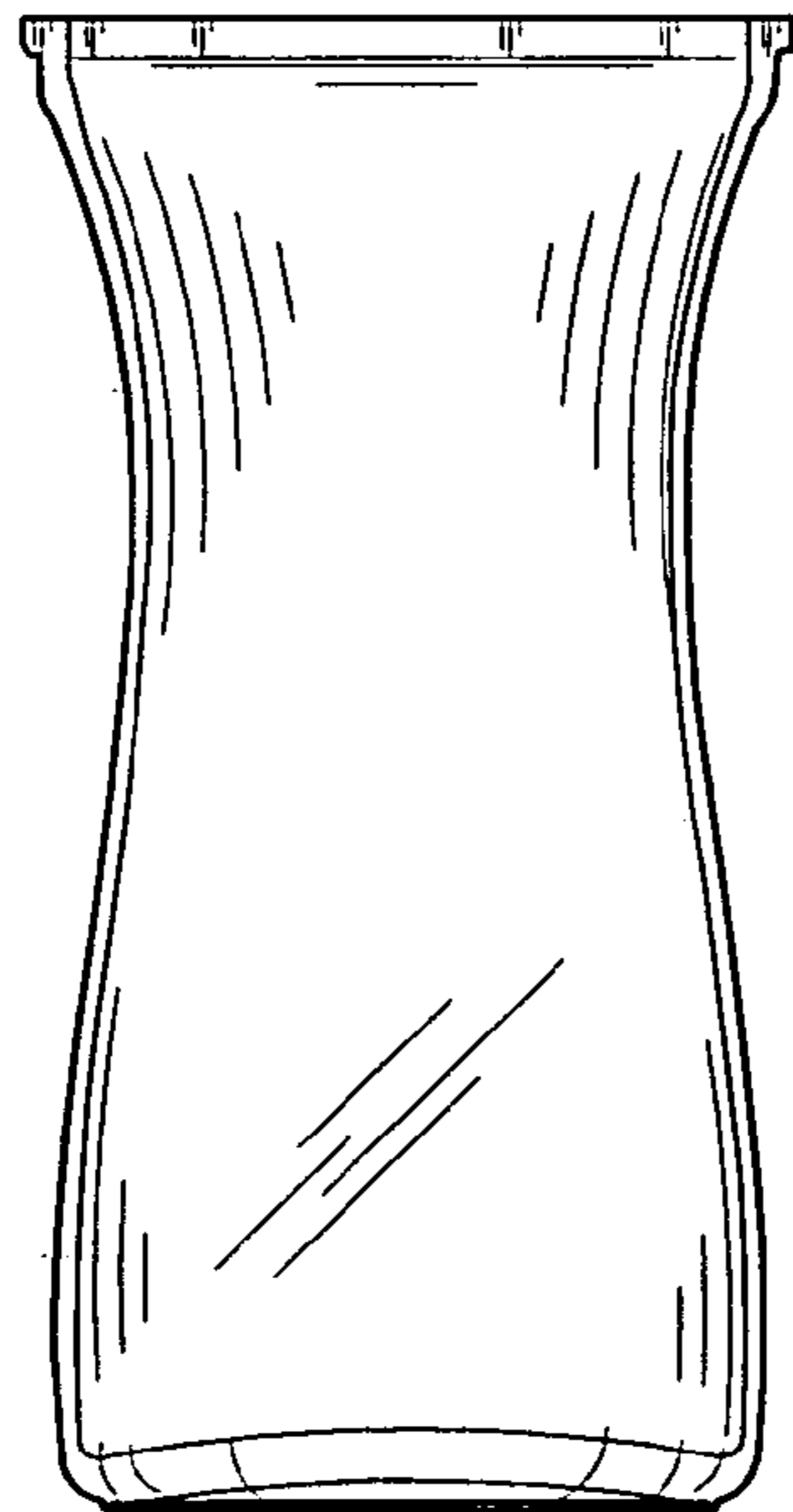

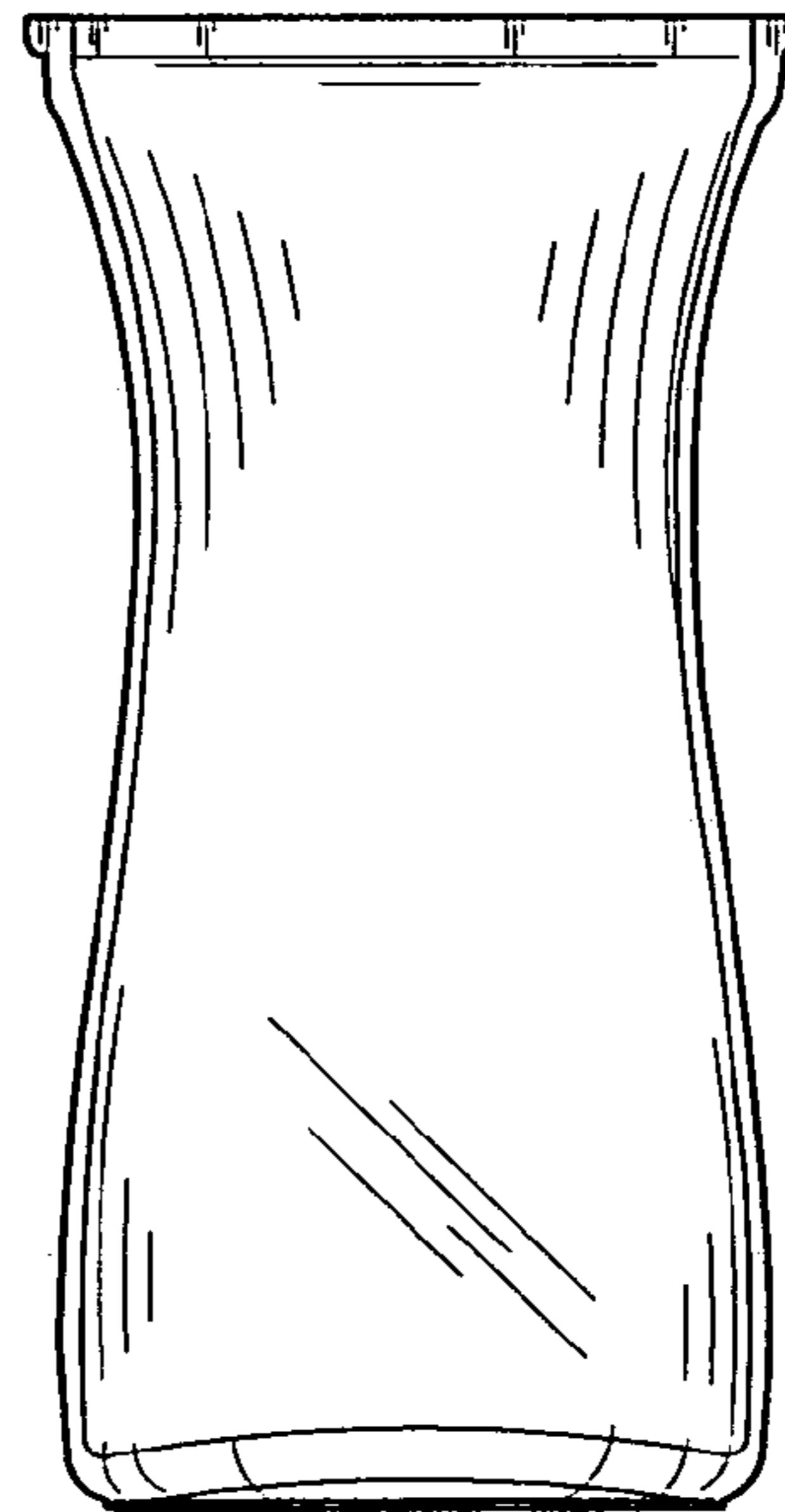

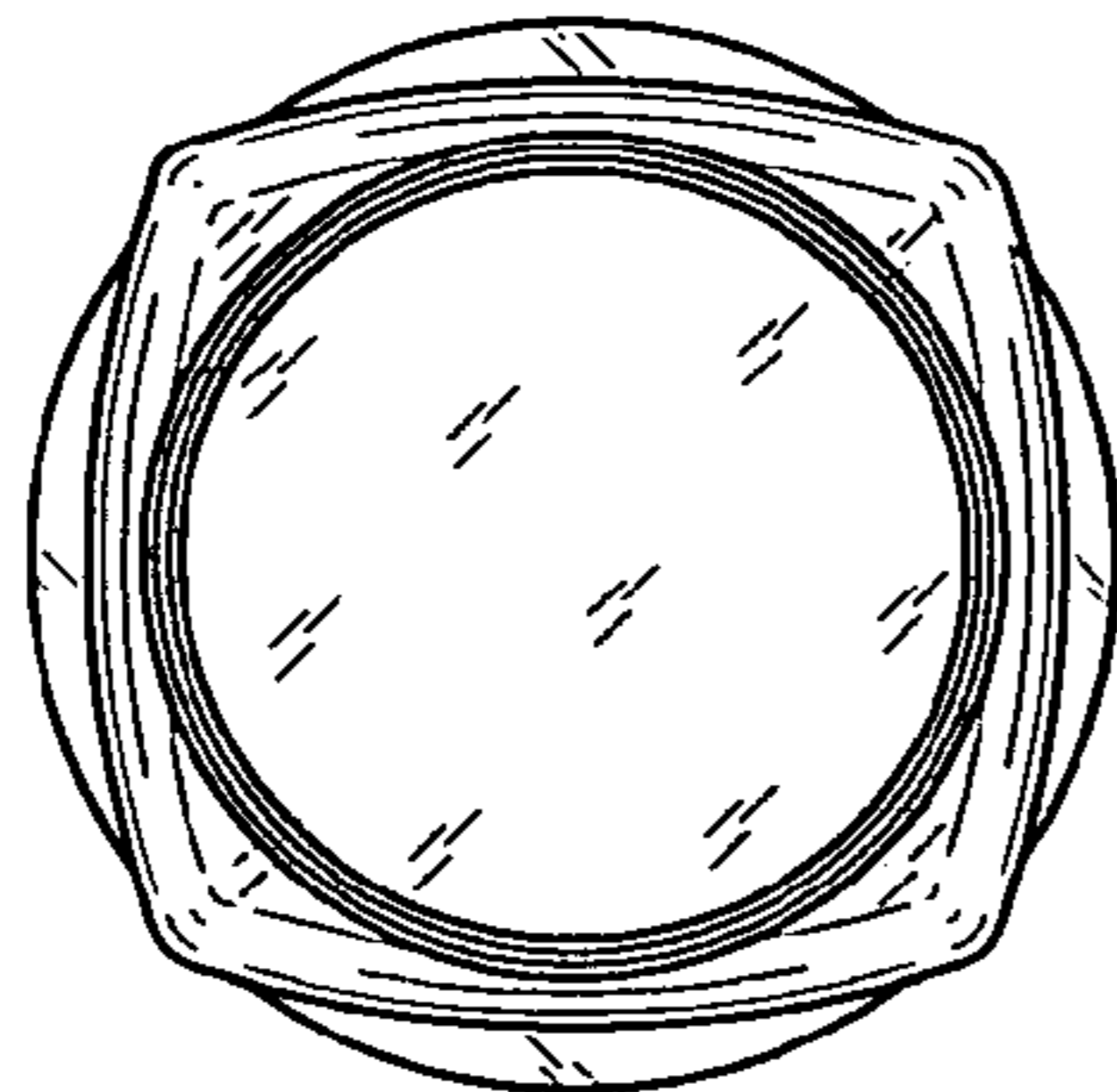

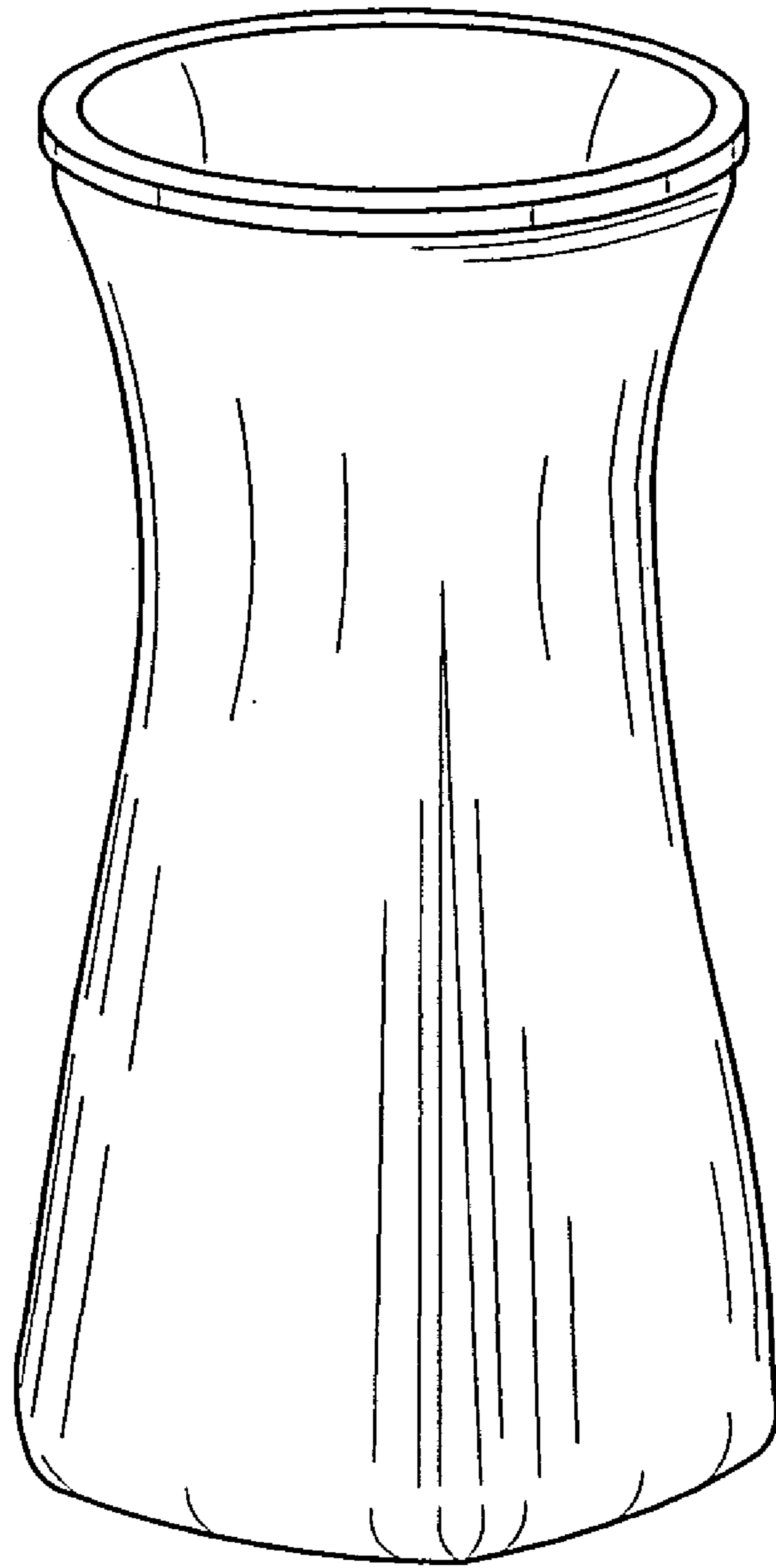

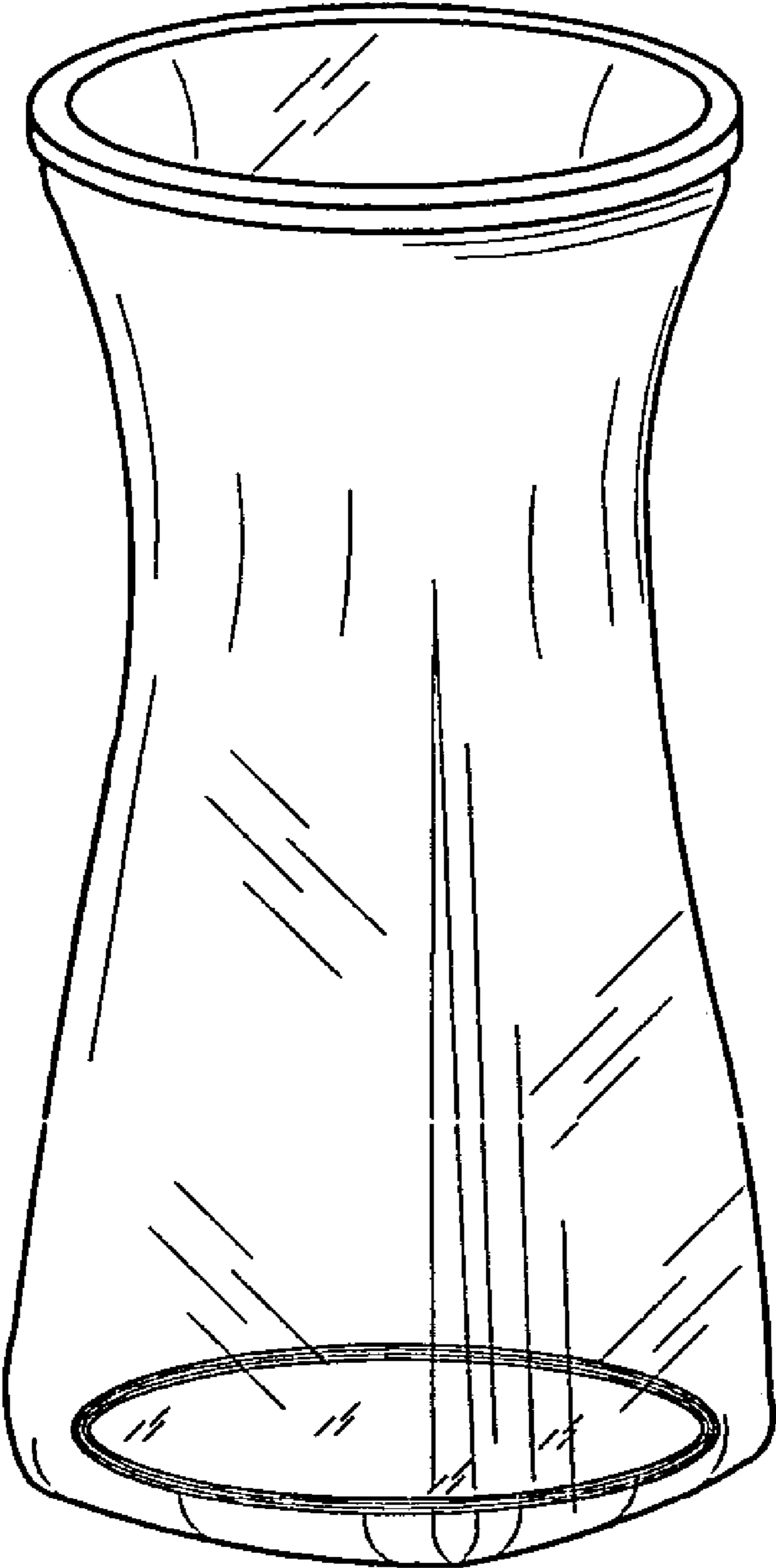
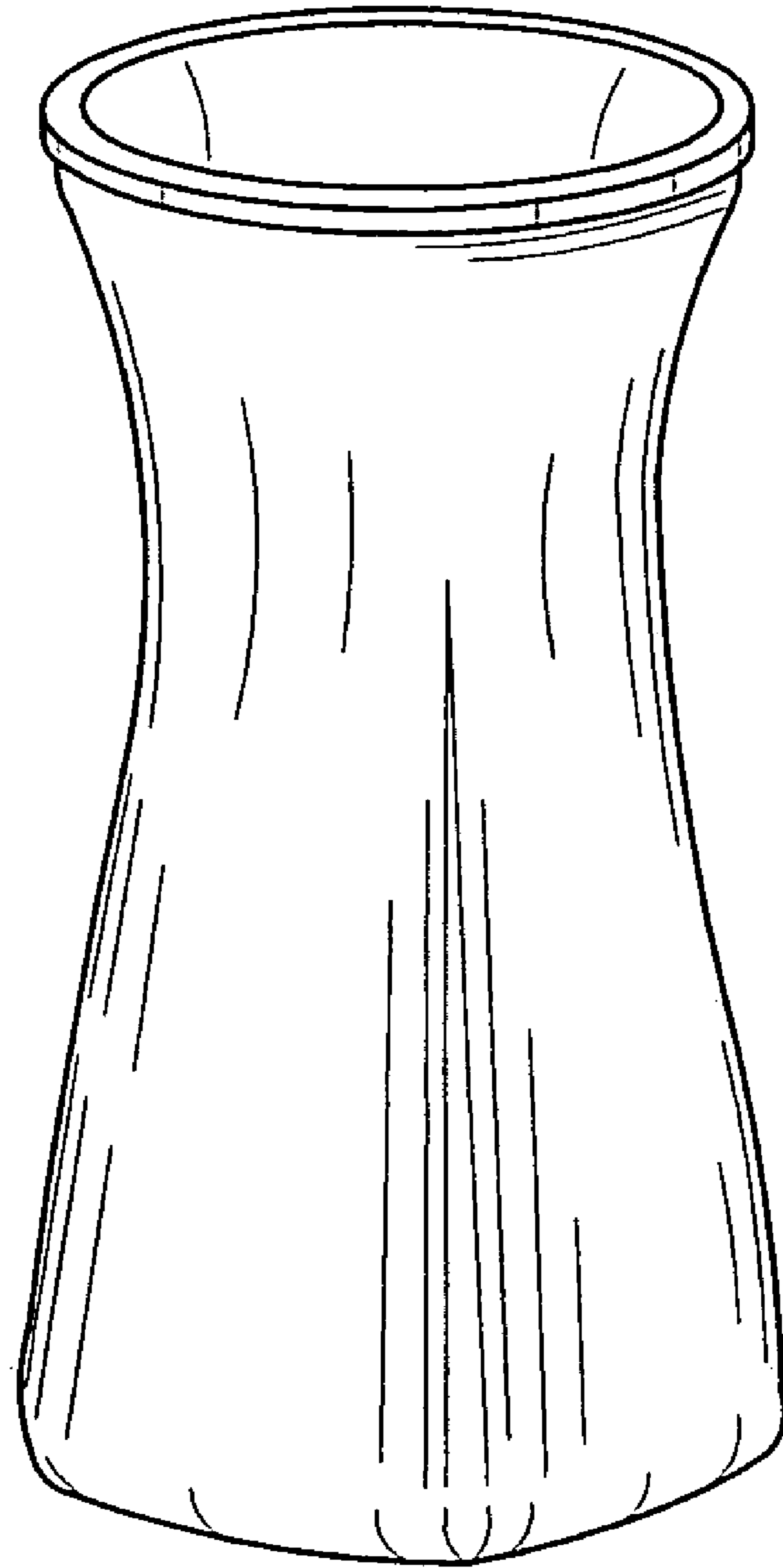
