The ornamental design for a rear bumper for a vehicle, as shown and described.

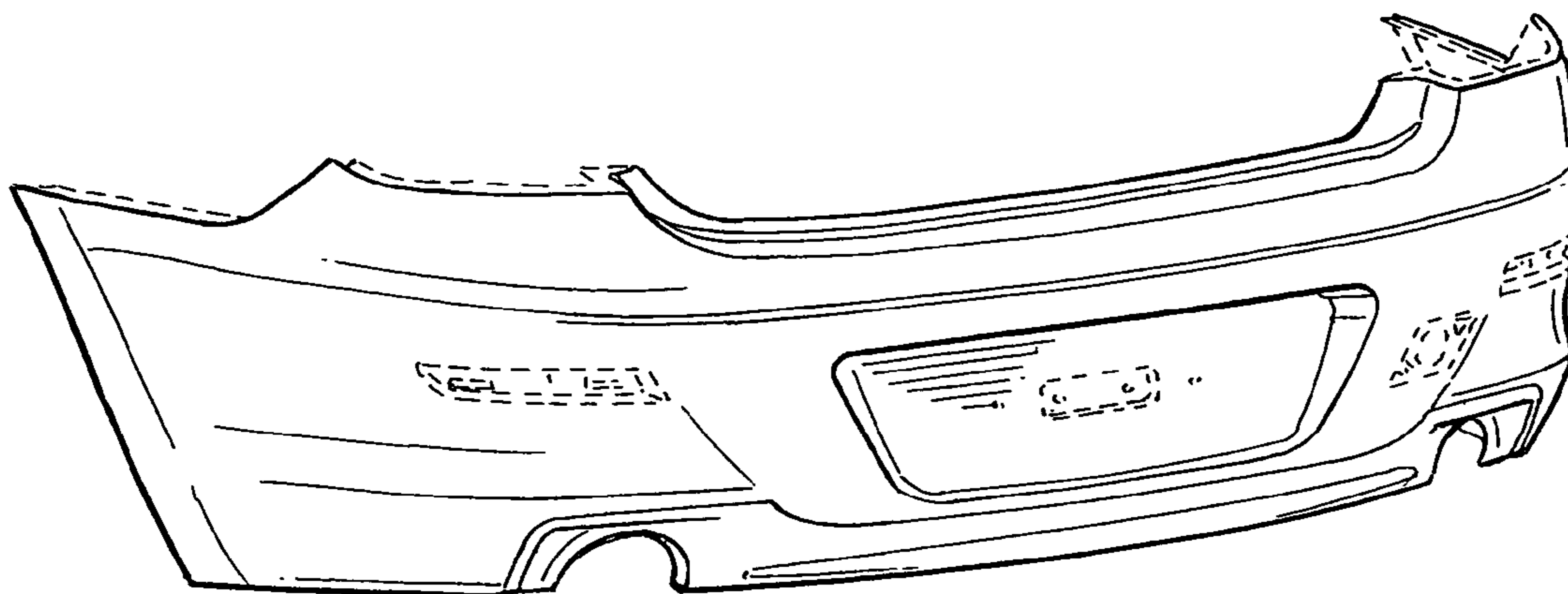
DESCRIPTION

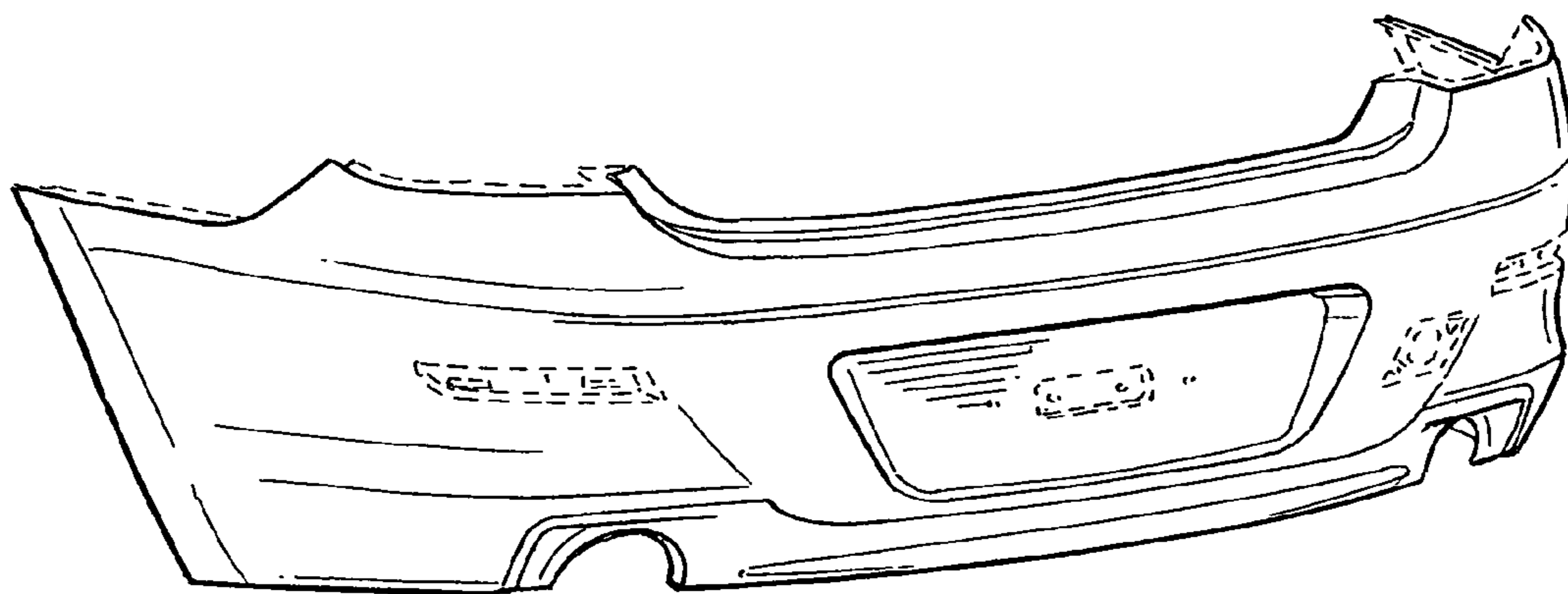

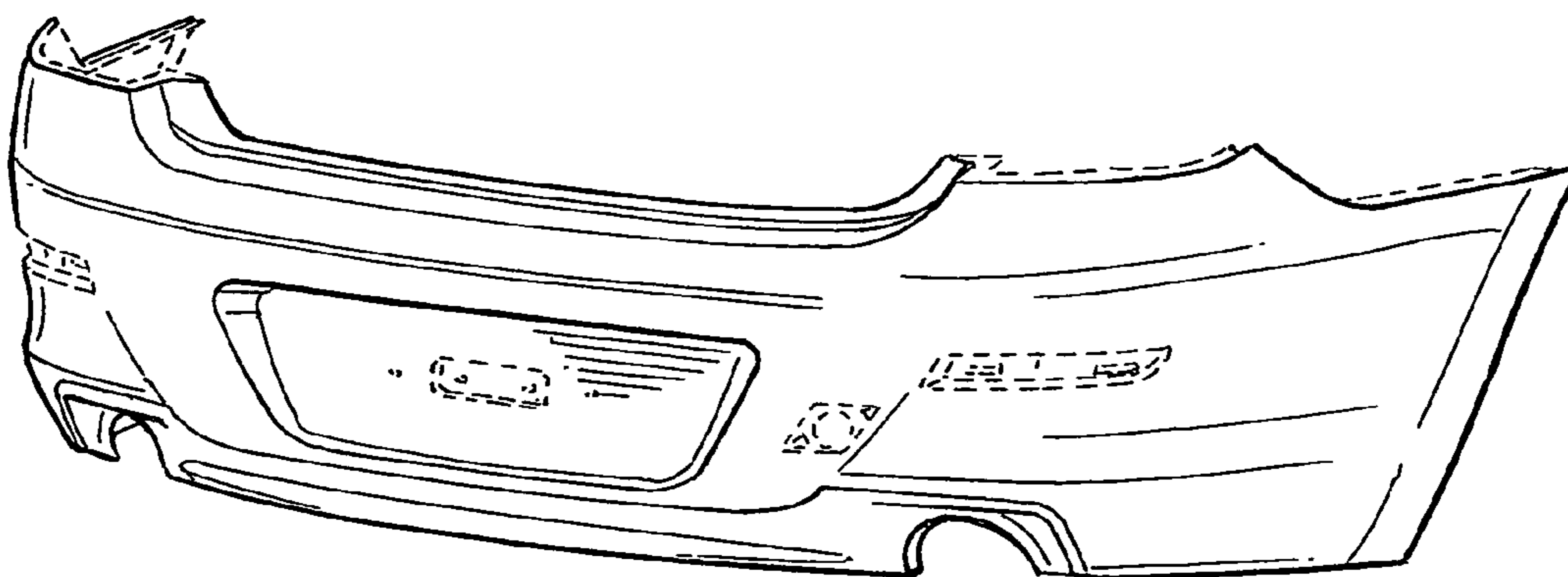

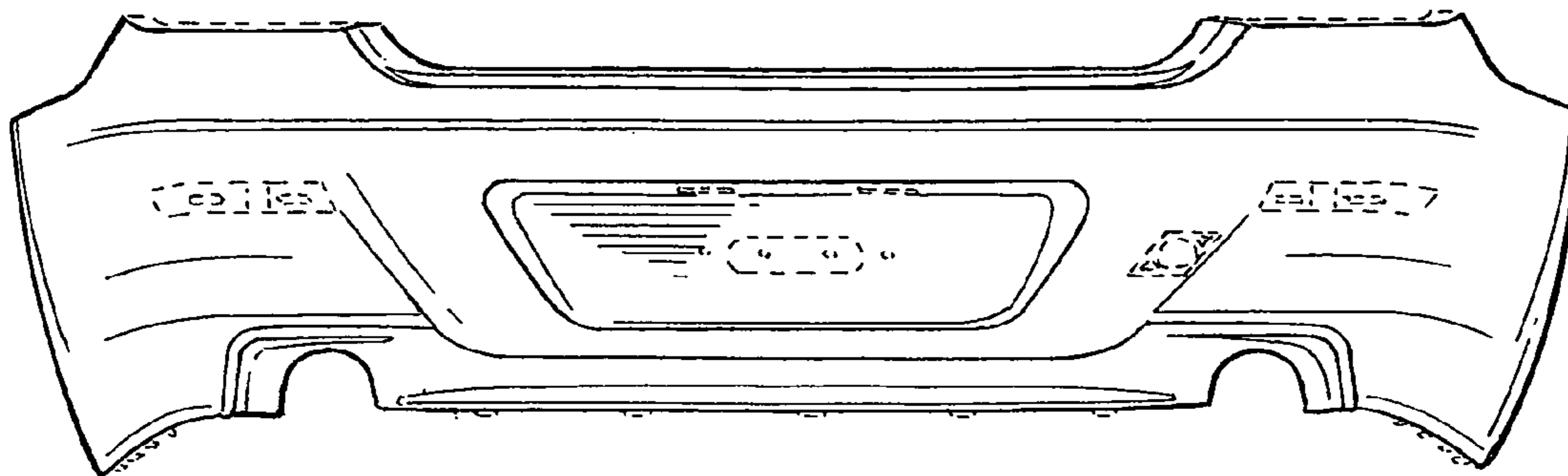

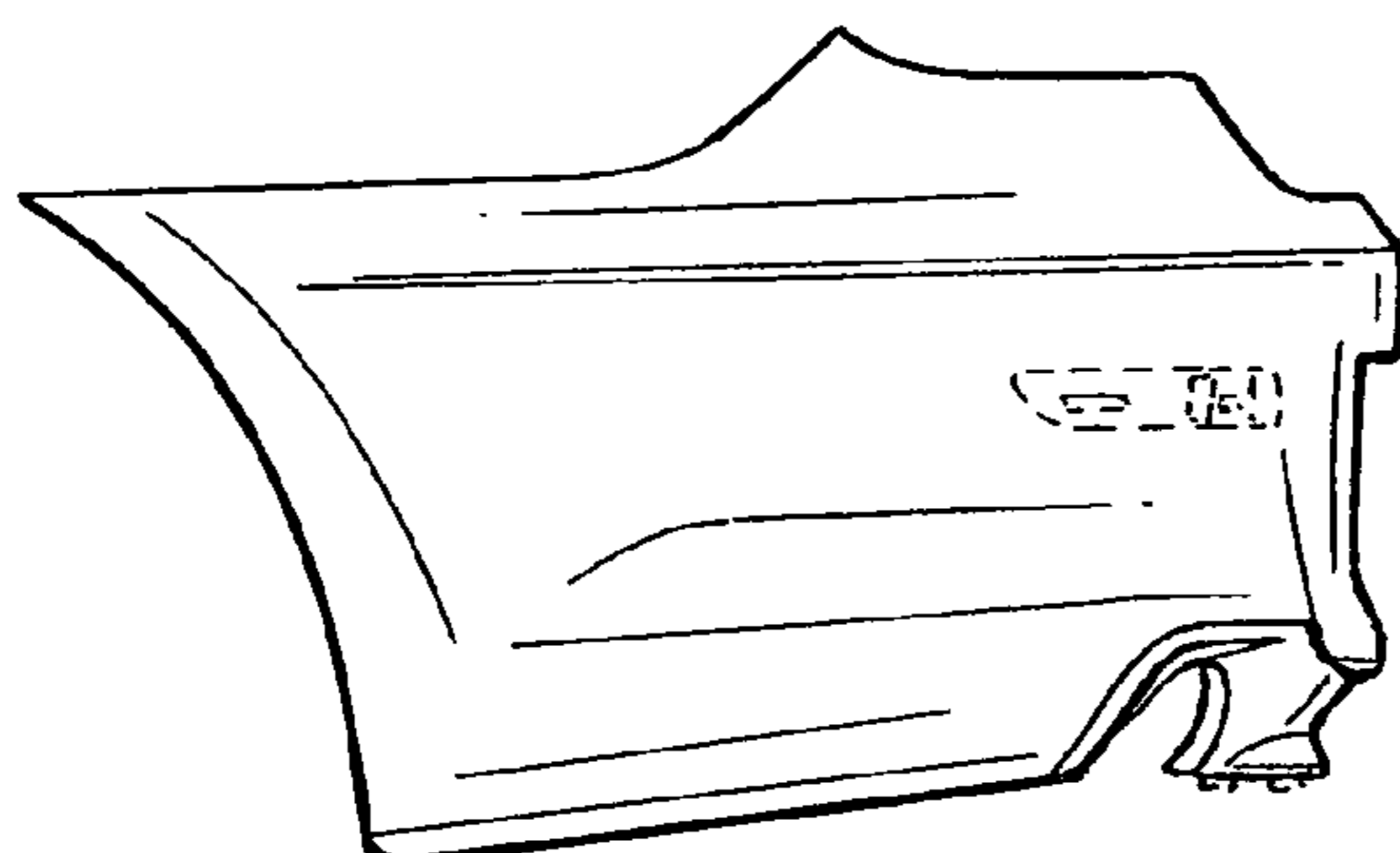

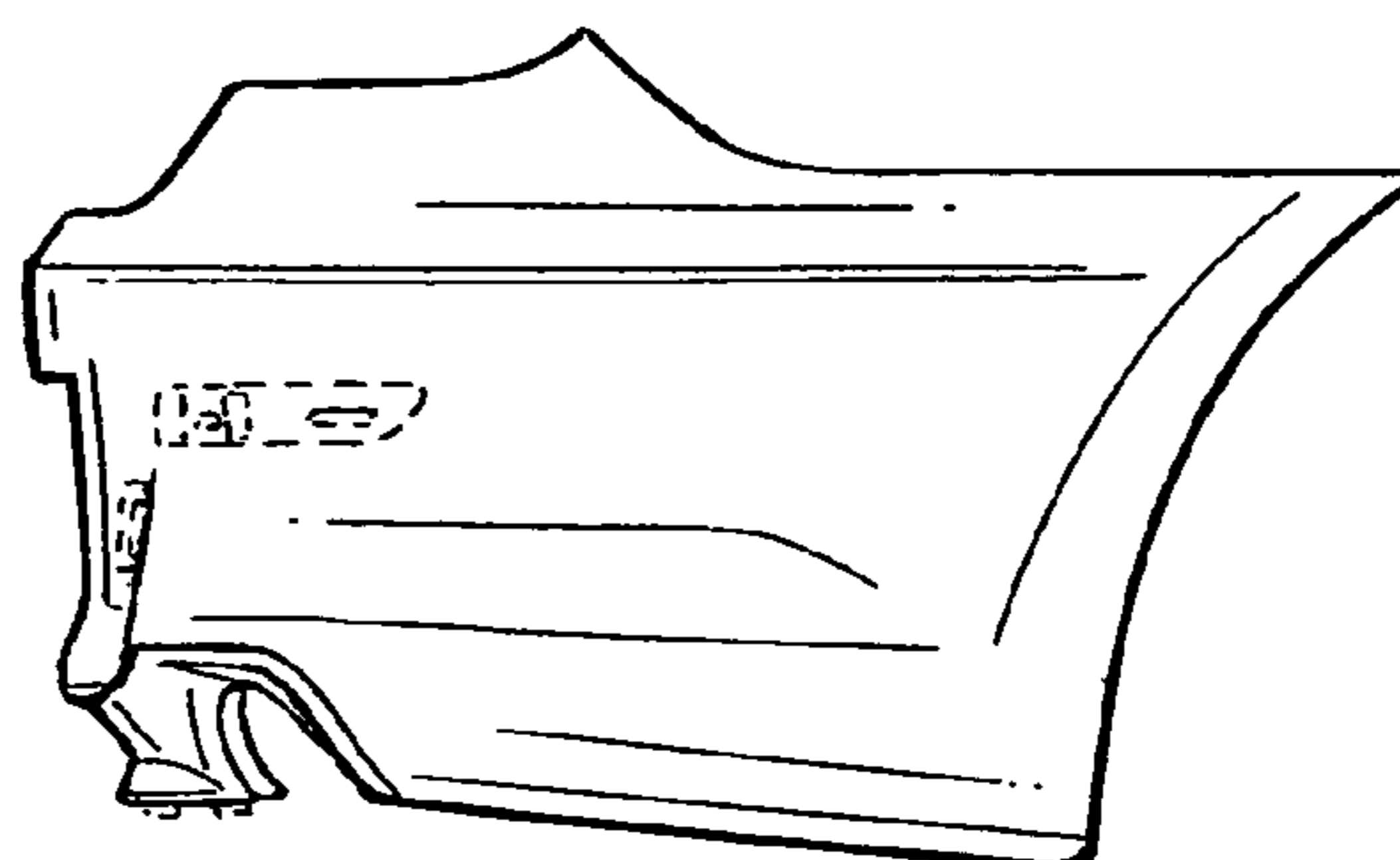

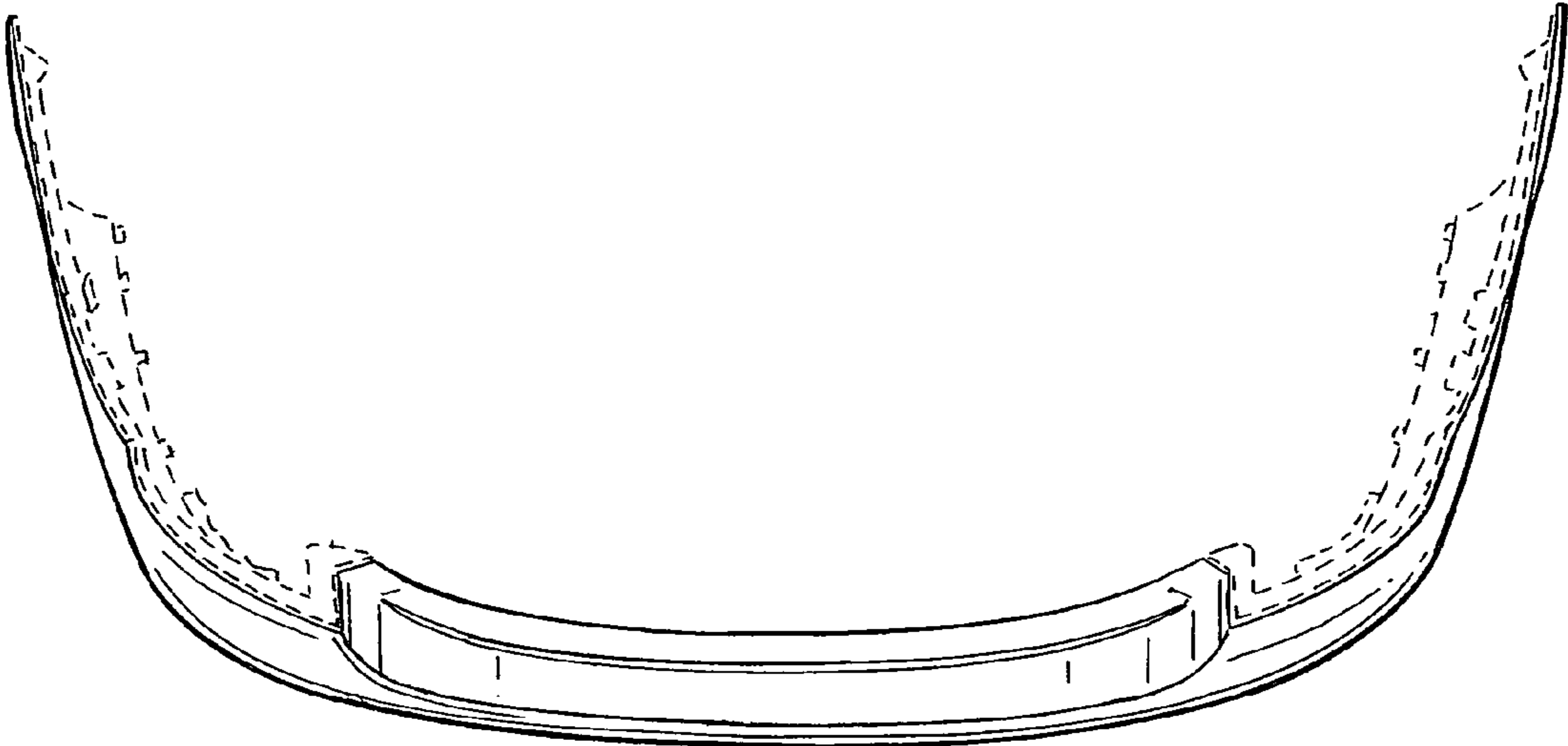

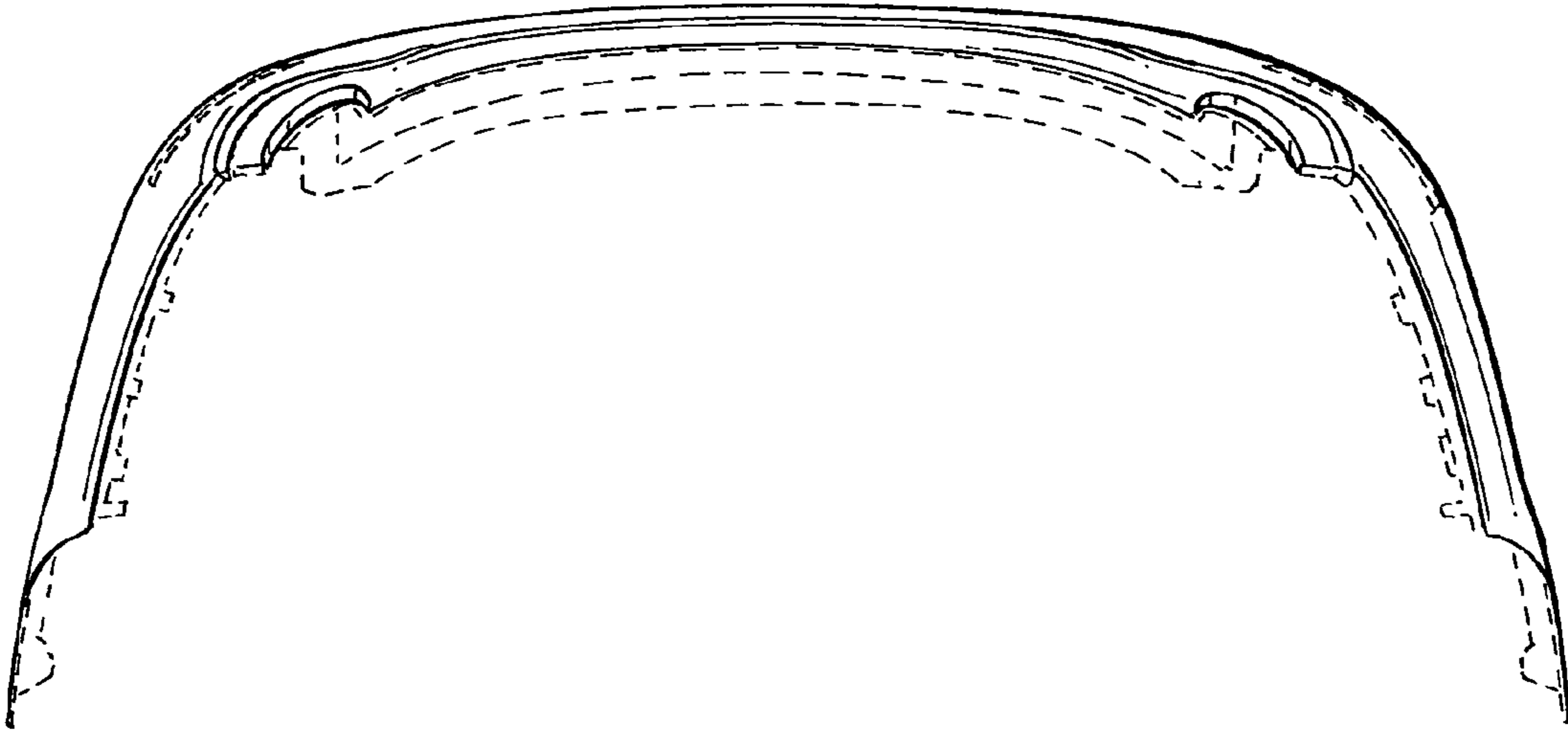
