FIG. 1 is a right, front perspective view of a hood for a vehicle according to my design, the left, front perspective view being mirror symmetrical thereof;

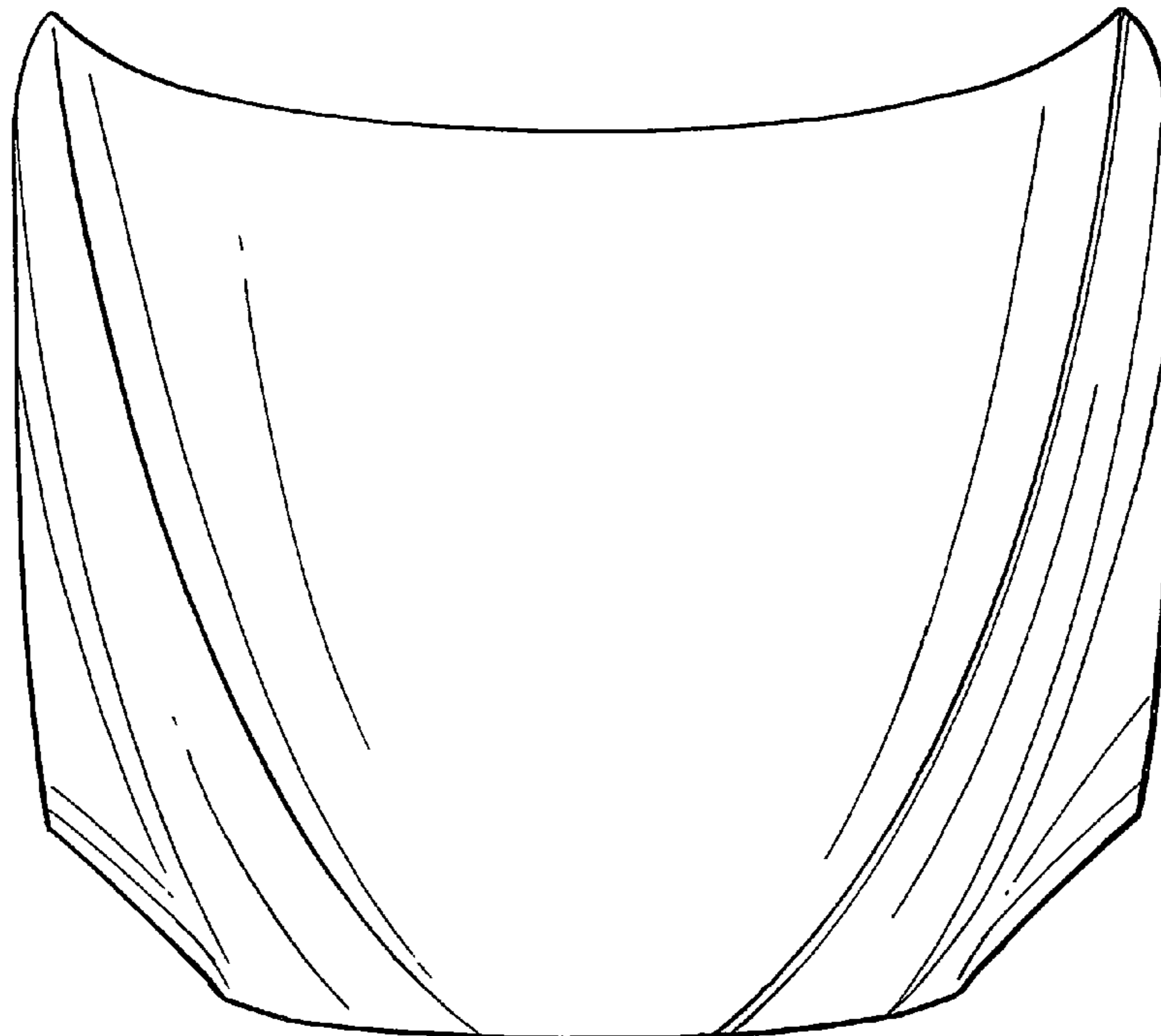
FIG. 2 is a front view thereof;

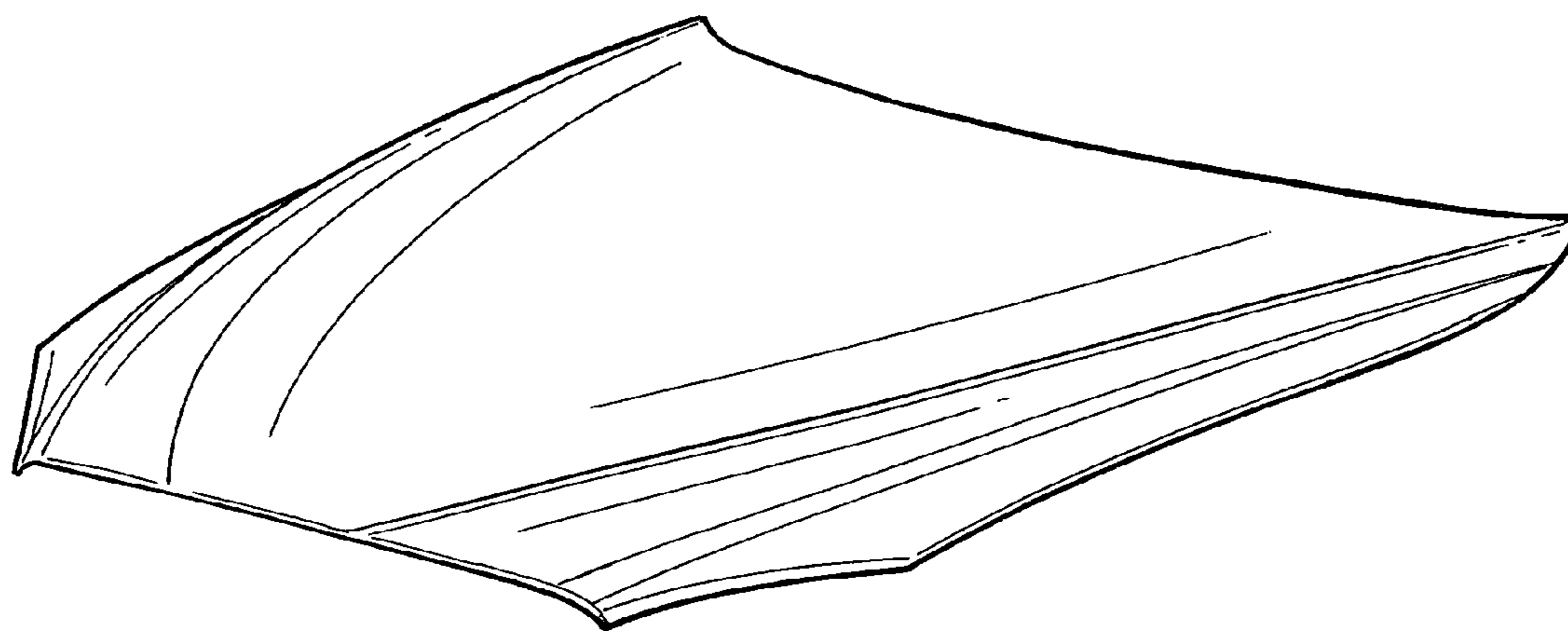

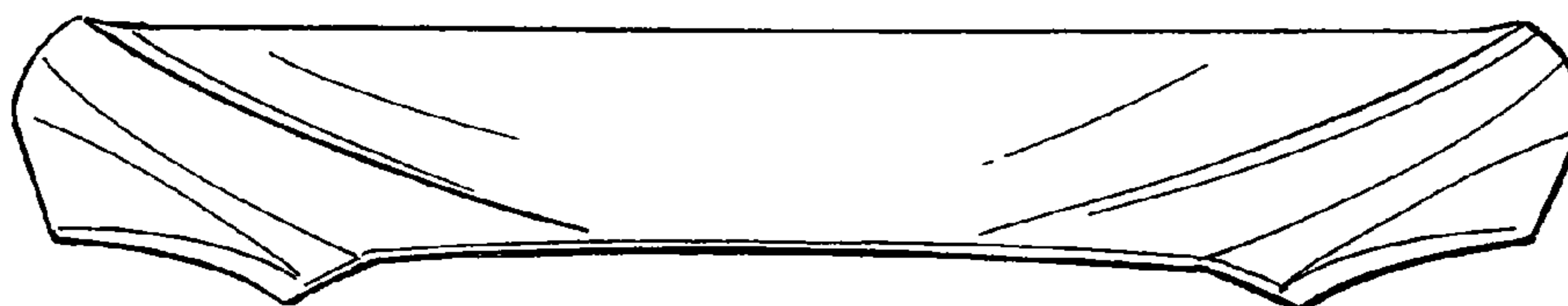

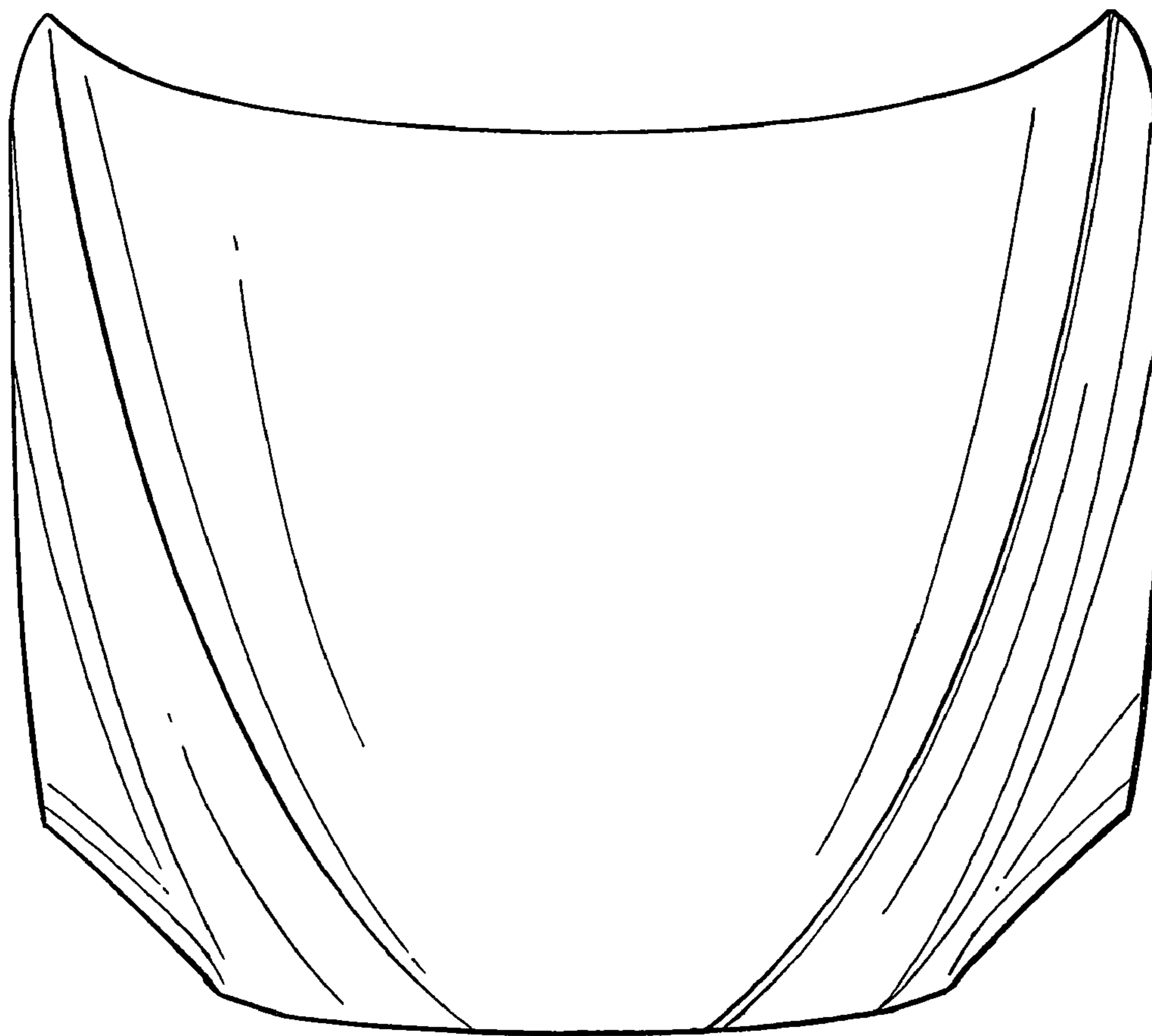

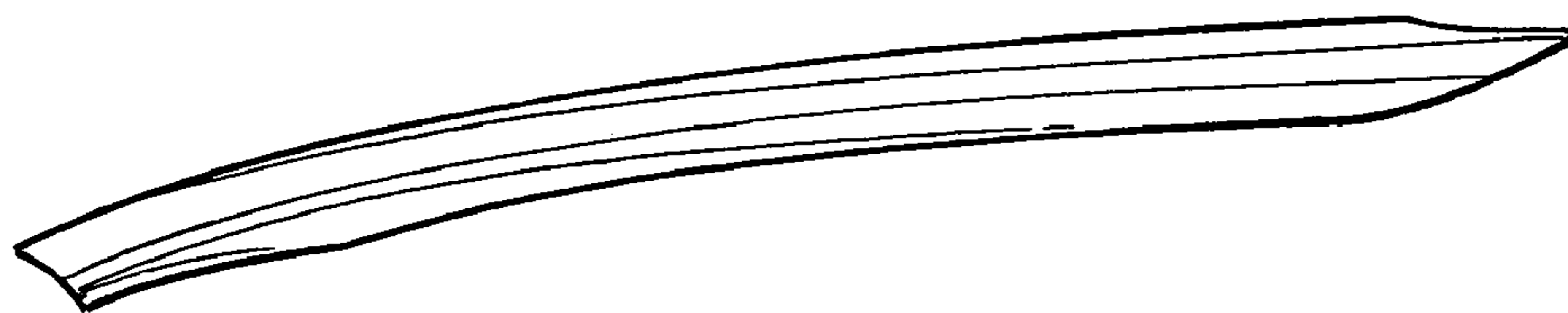
