(57) **CLAIM**

The ornamental design for a tire with surface pattern, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a tire with surface pattern showing our new design, it being understood that the pattern repeats uniformly throughout the circumference of the tread; FIG. 2 is a front elevational view thereof;

FIG. 3 is a right side elevational view thereof; the other side being a mirror image thereof;

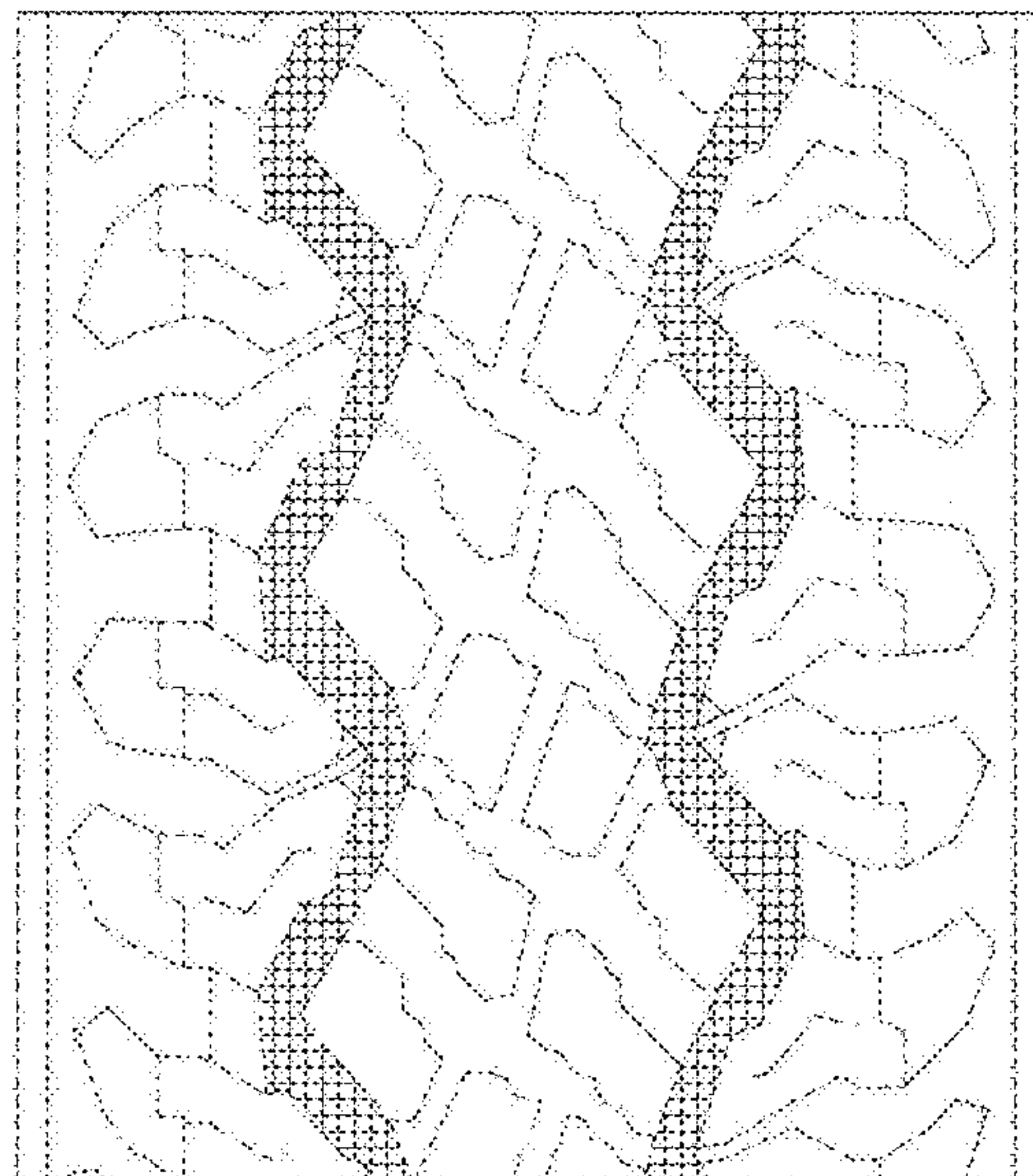
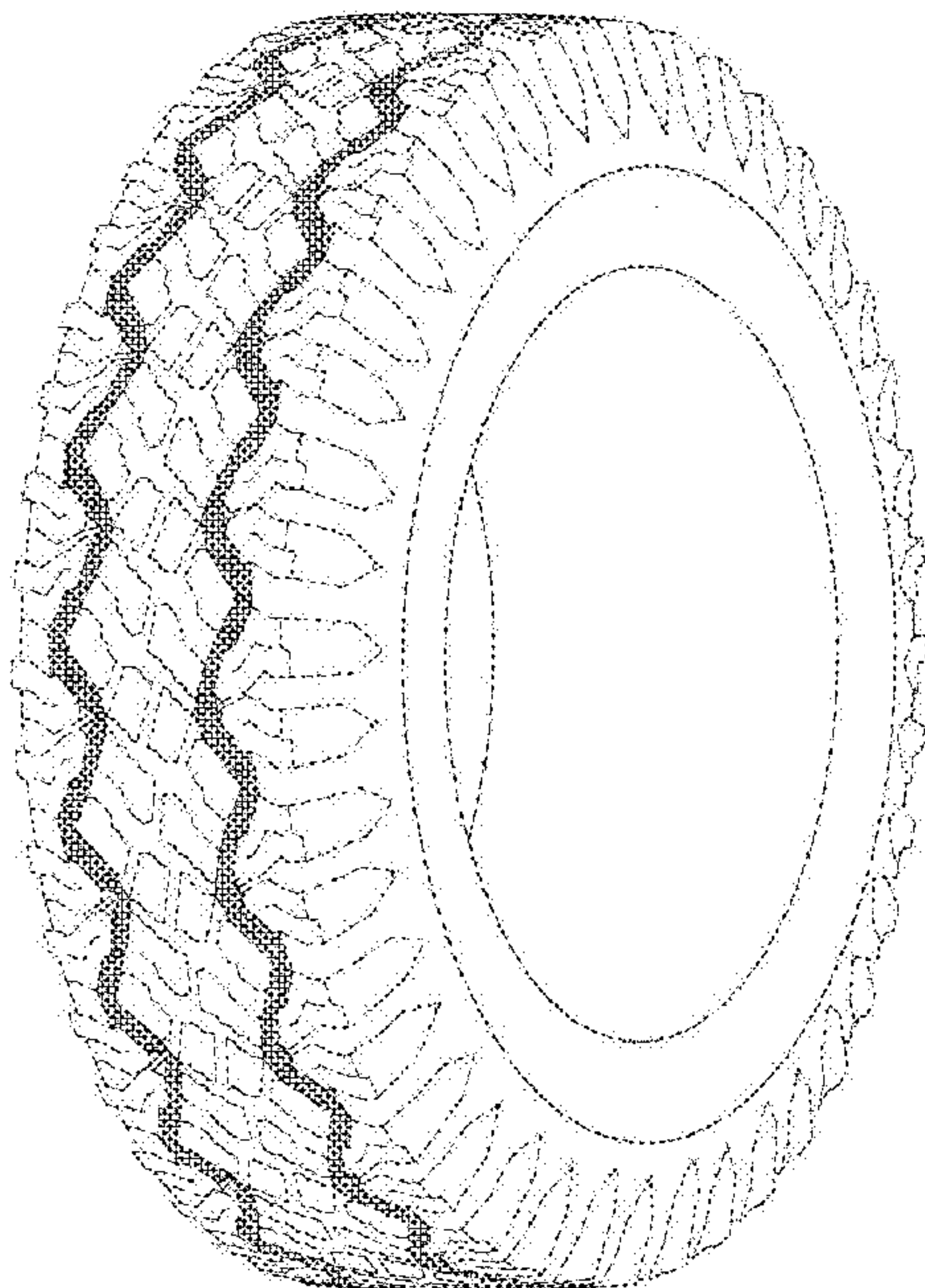
FIG. 4 is an enlarged fragmentary front elevational view thereof;

FIG. 5 is a perspective view of a second embodiment of a tire with surface pattern showing our new design, it being understood that the pattern repeats uniformly throughout the circumference of the tread and that the opposite side perspective view is a mirror image thereof; and,

FIG. 6 is a front elevational view of a second embodiment, it being understood that an enlarged fragmentary view thereof would be substantially identical to that shown in FIG. 4, with the exception of the inclusion of the sidewall in solid lines.

In the drawings, the broken lines defining the tire tread, sidewall, inner bead in FIGS. 1 through 4 depict environmental subject matter that forms no part of the claimed design.

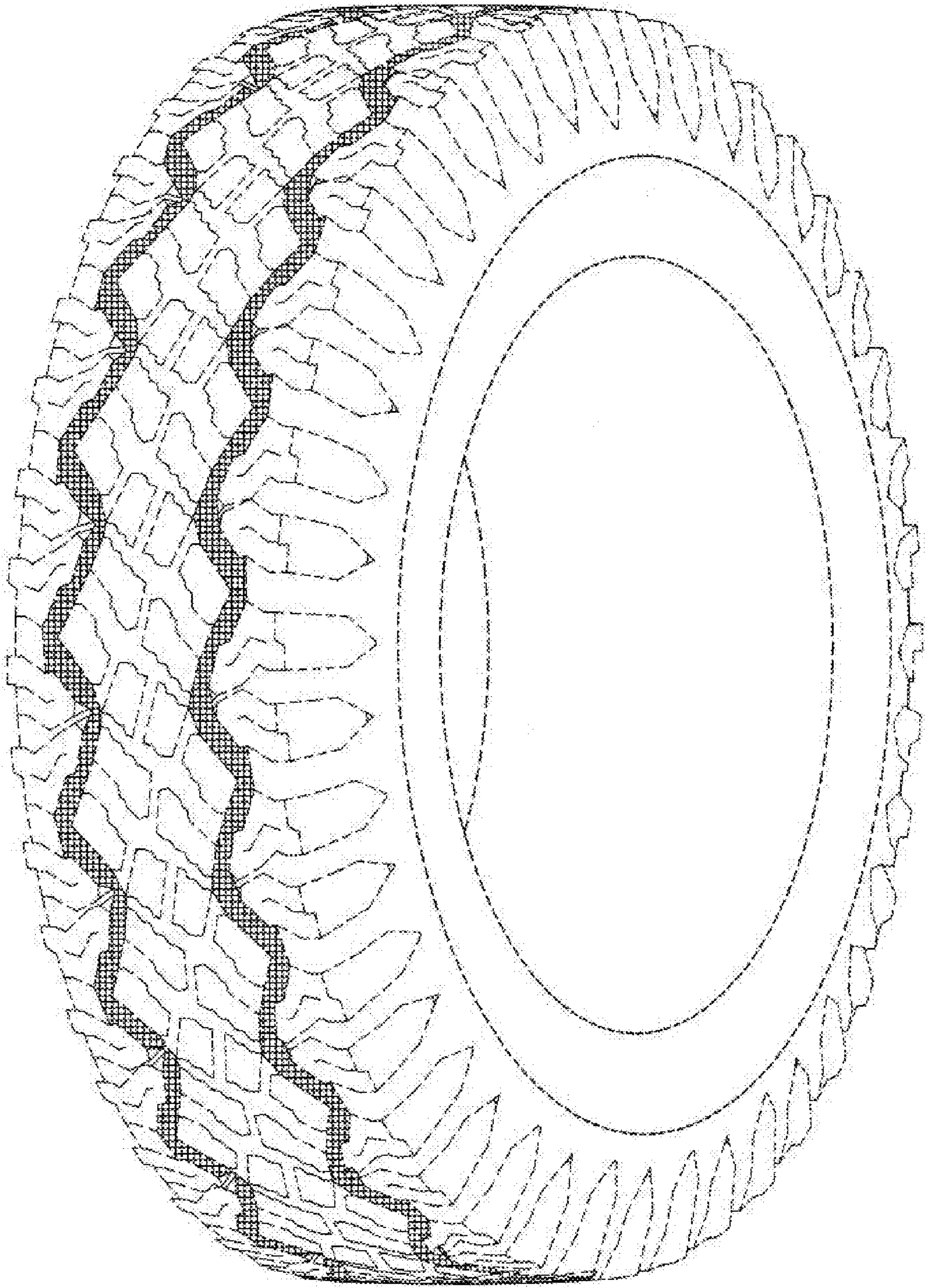

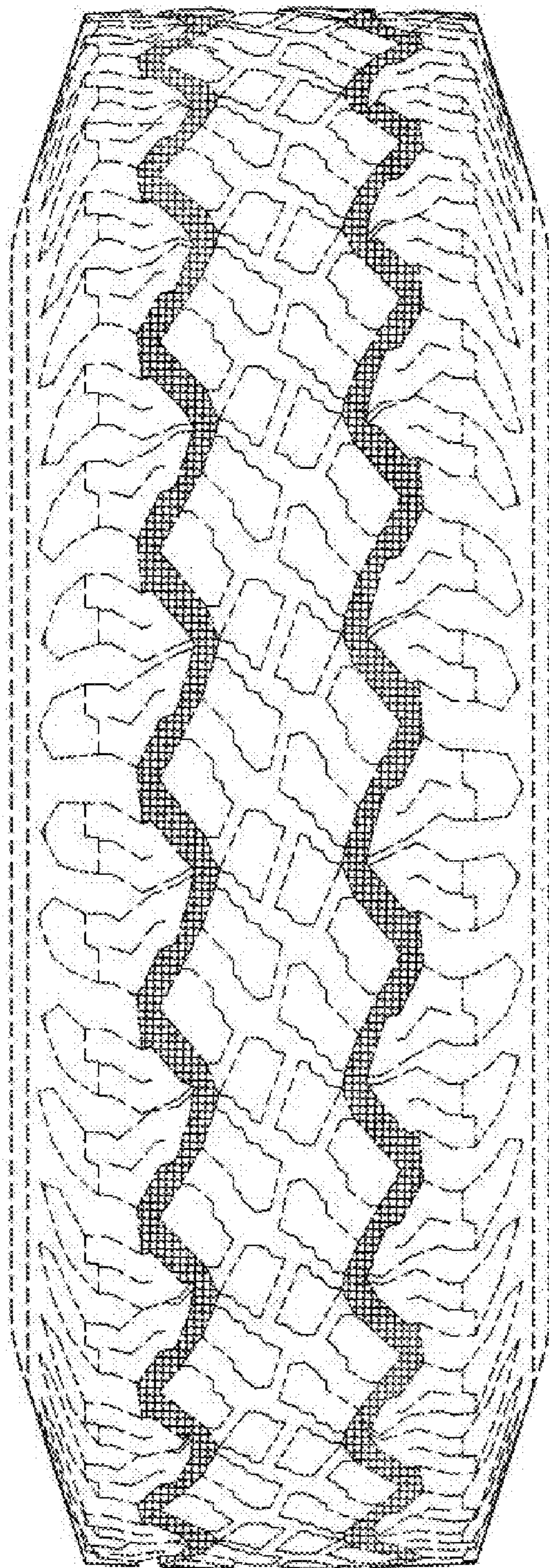

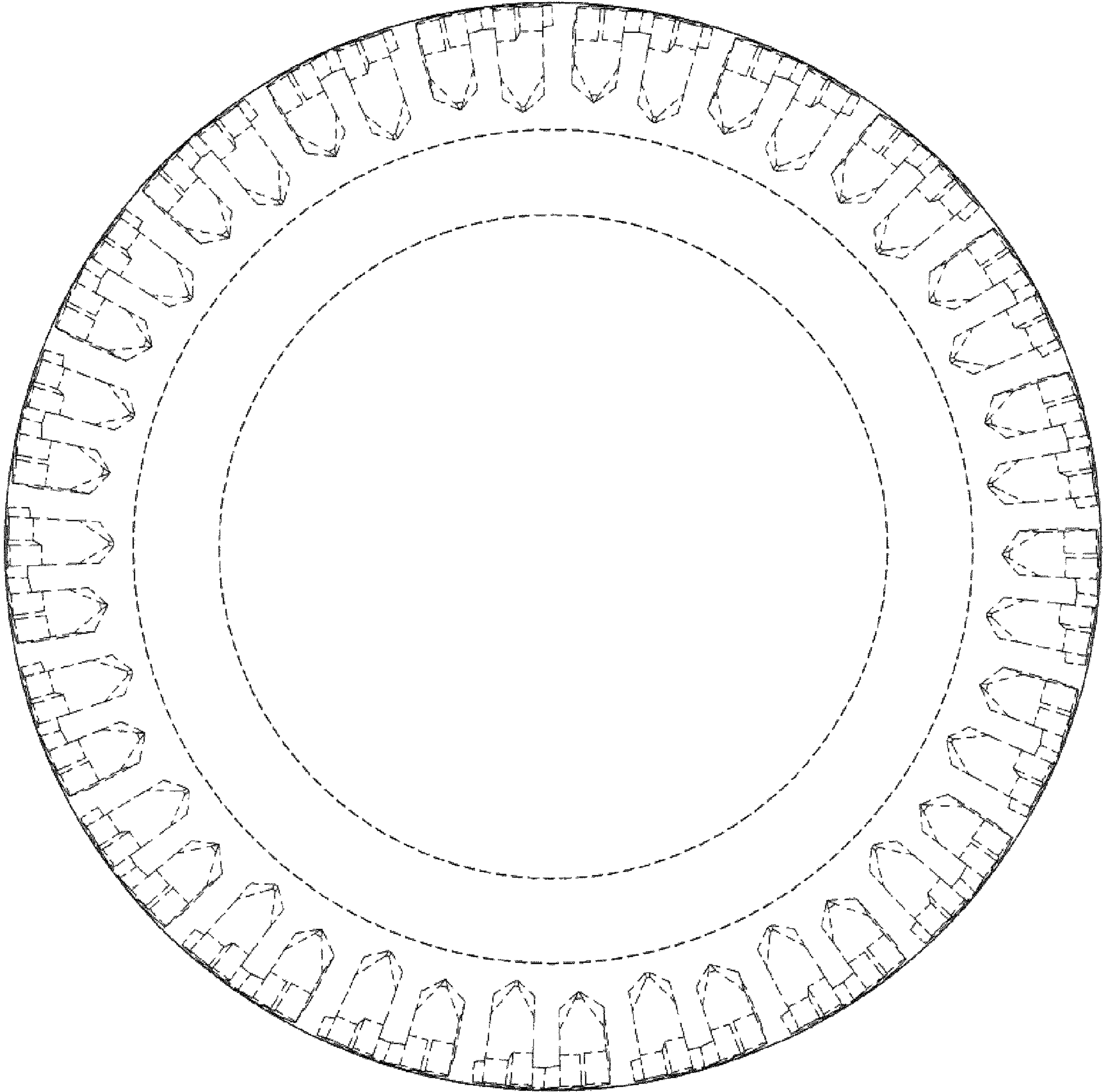

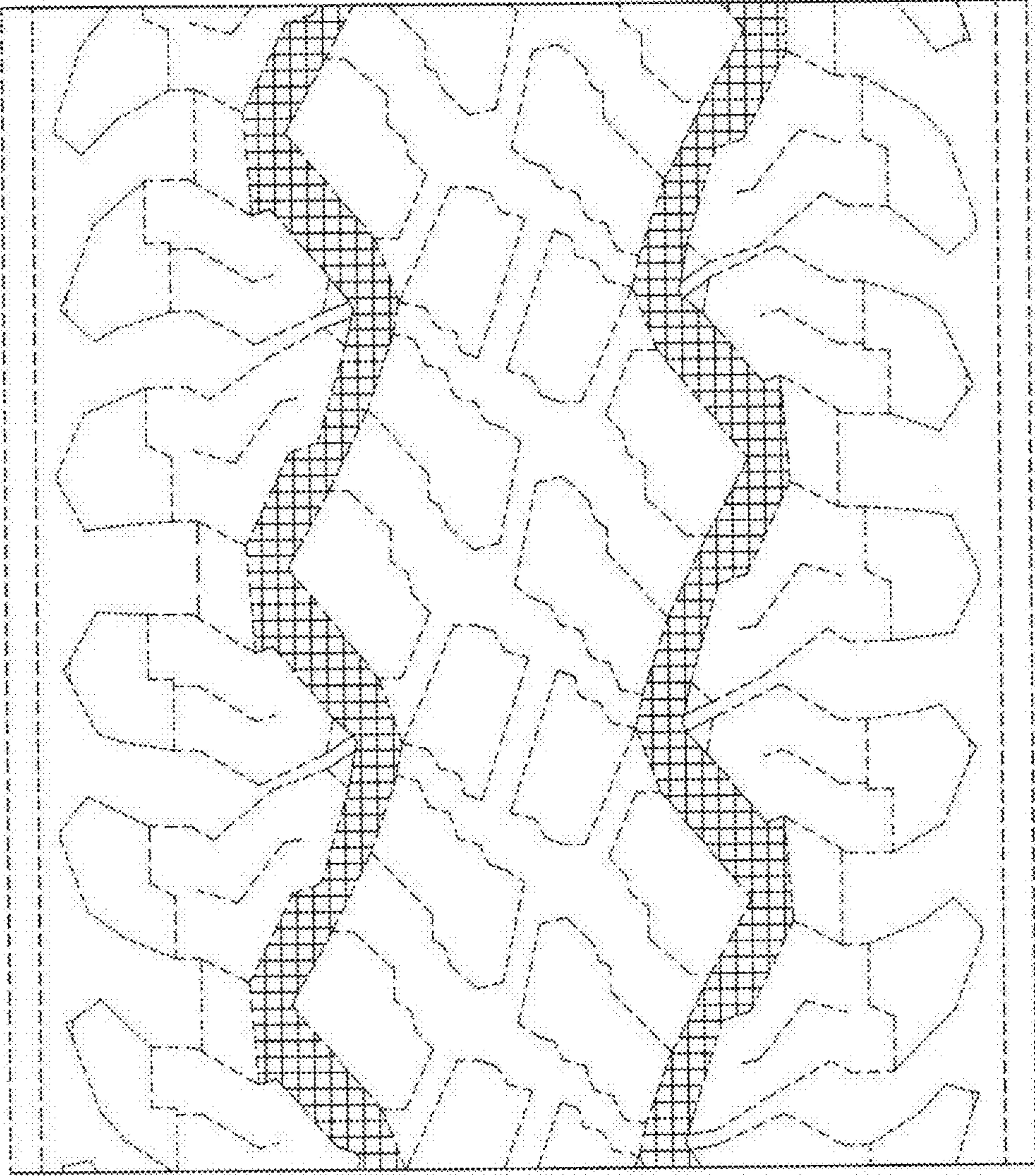

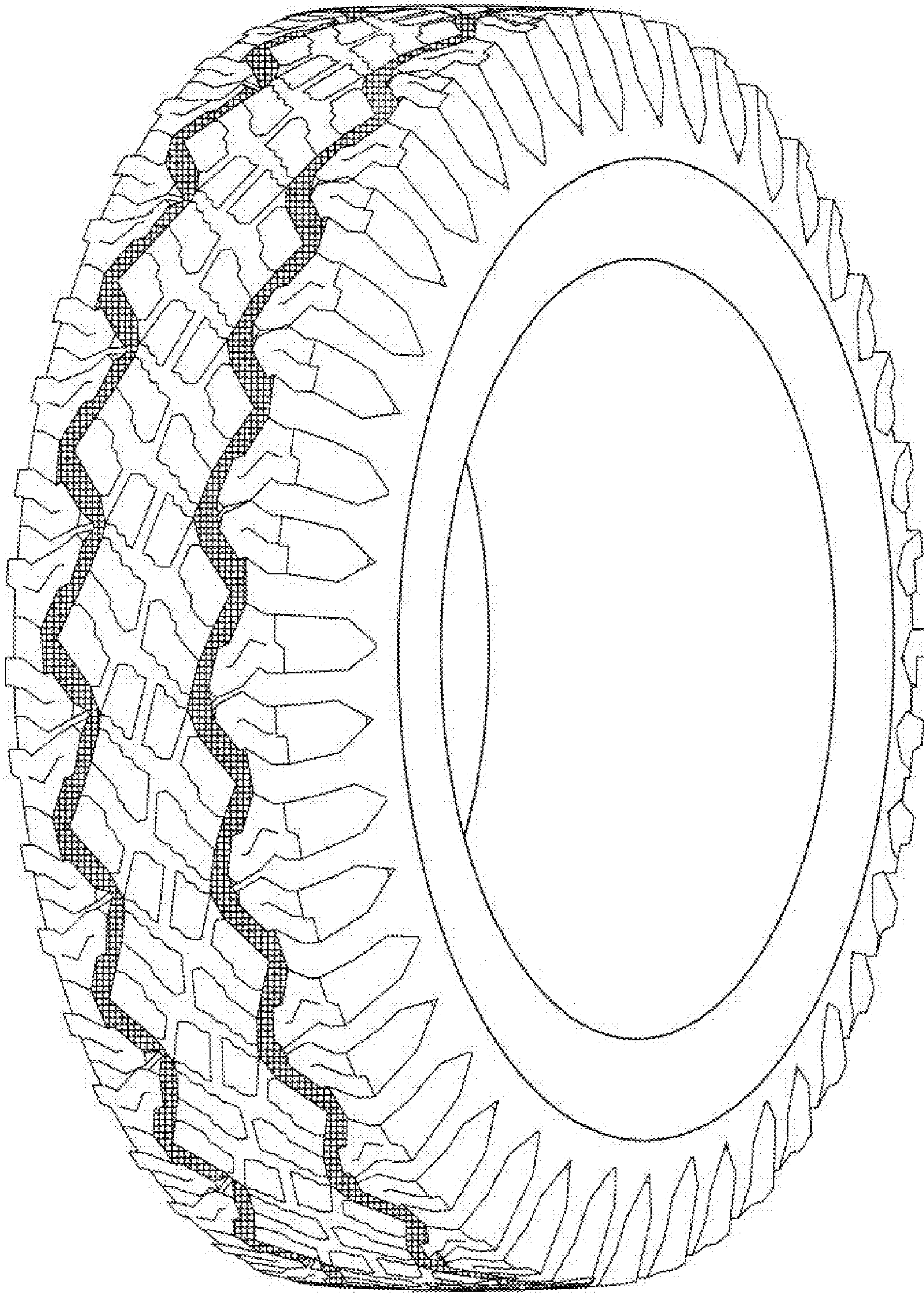

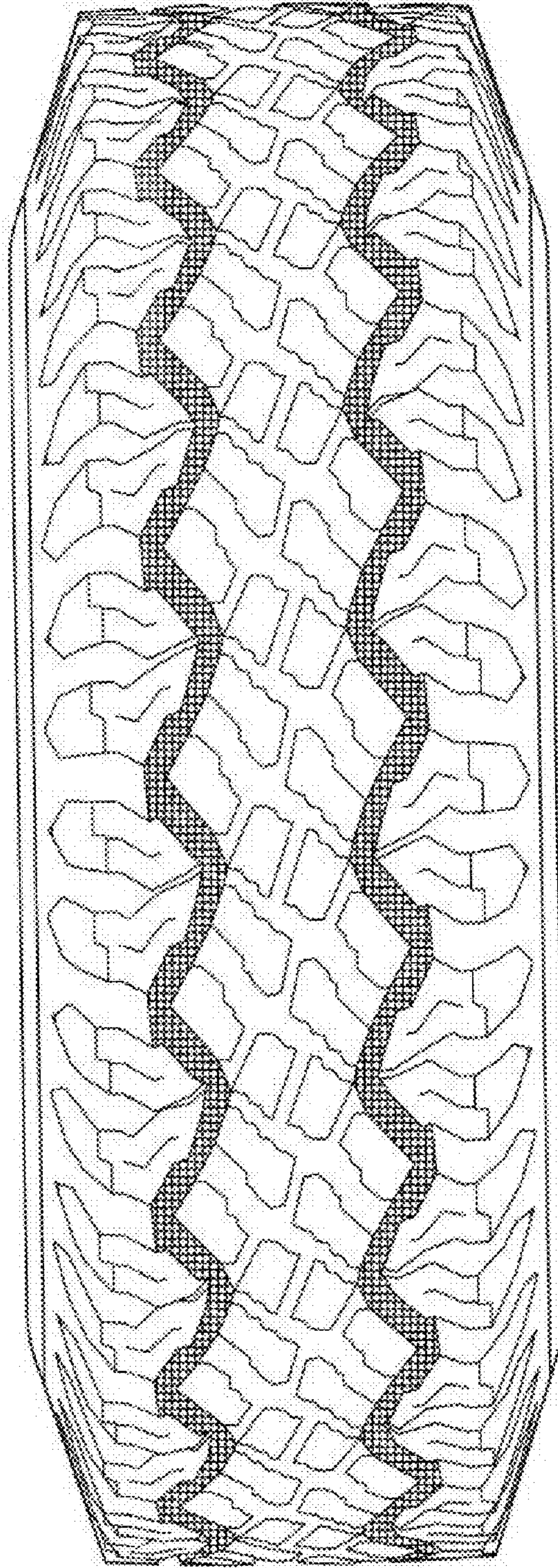
