(57) **CLAIM**

The ornamental design for a portable sign having elongate side panels, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of an ornamental design for a portable sign having elongate side panels in accordance with the present disclosure;

FIG. 2 is a front elevation view of the portable sign having elongate side panels shown in FIG. 1;

FIG. 3 is a right side elevation view of the portable sign having elongate side panels shown in FIG. 1;

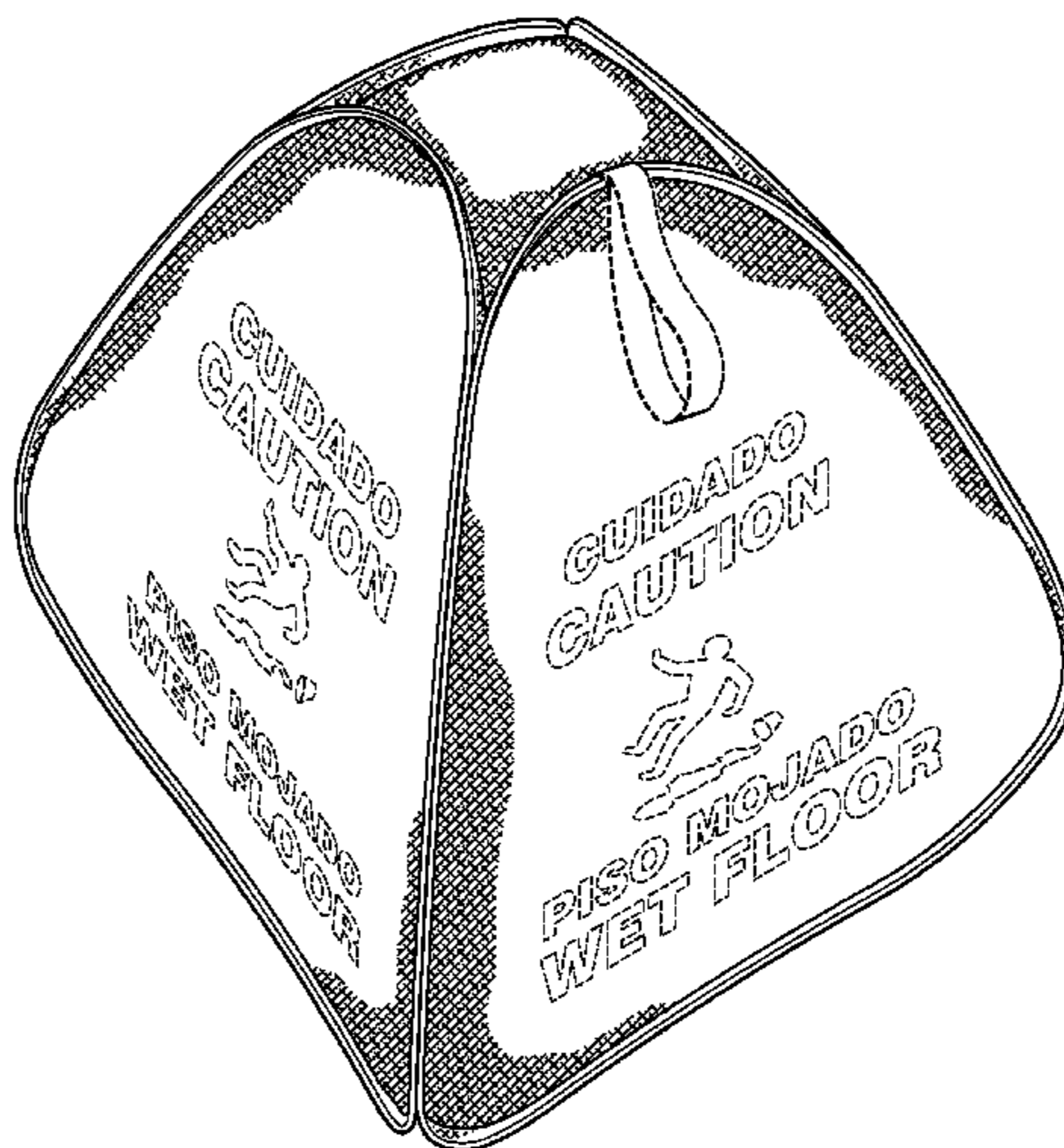
FIG. 4 is a left side elevation view of the portable sign having elongate side panels shown in FIG. 1;

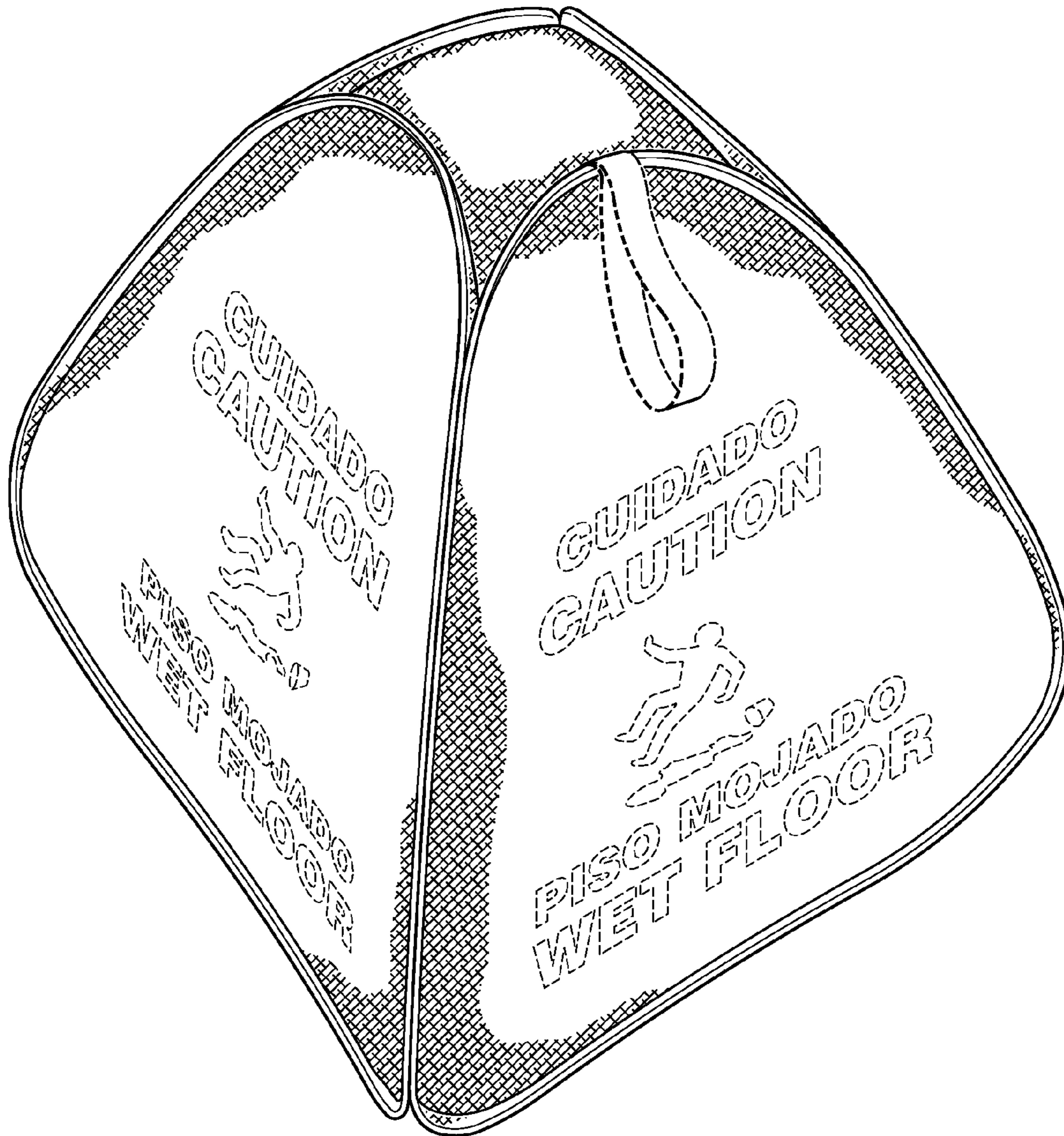

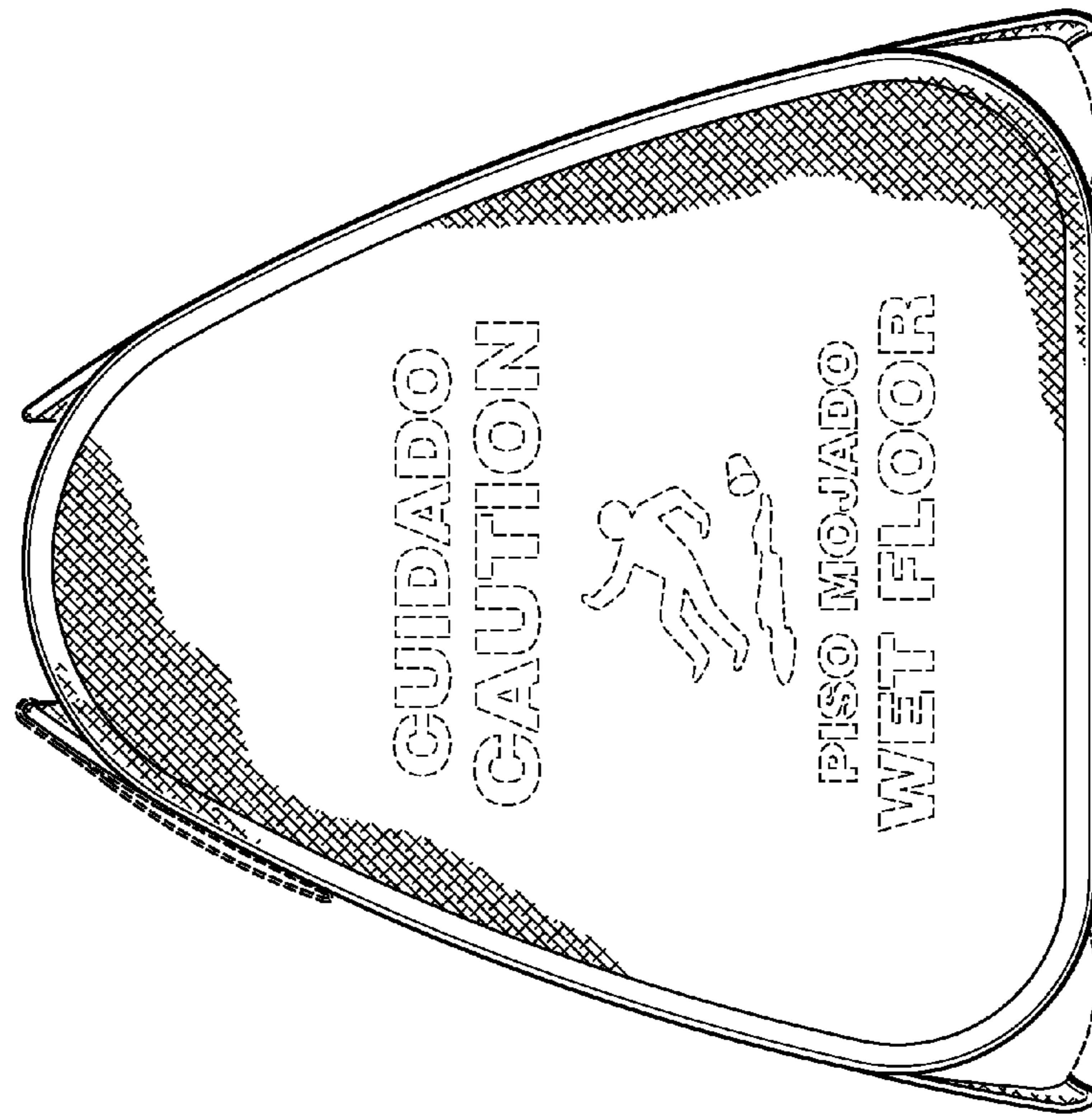

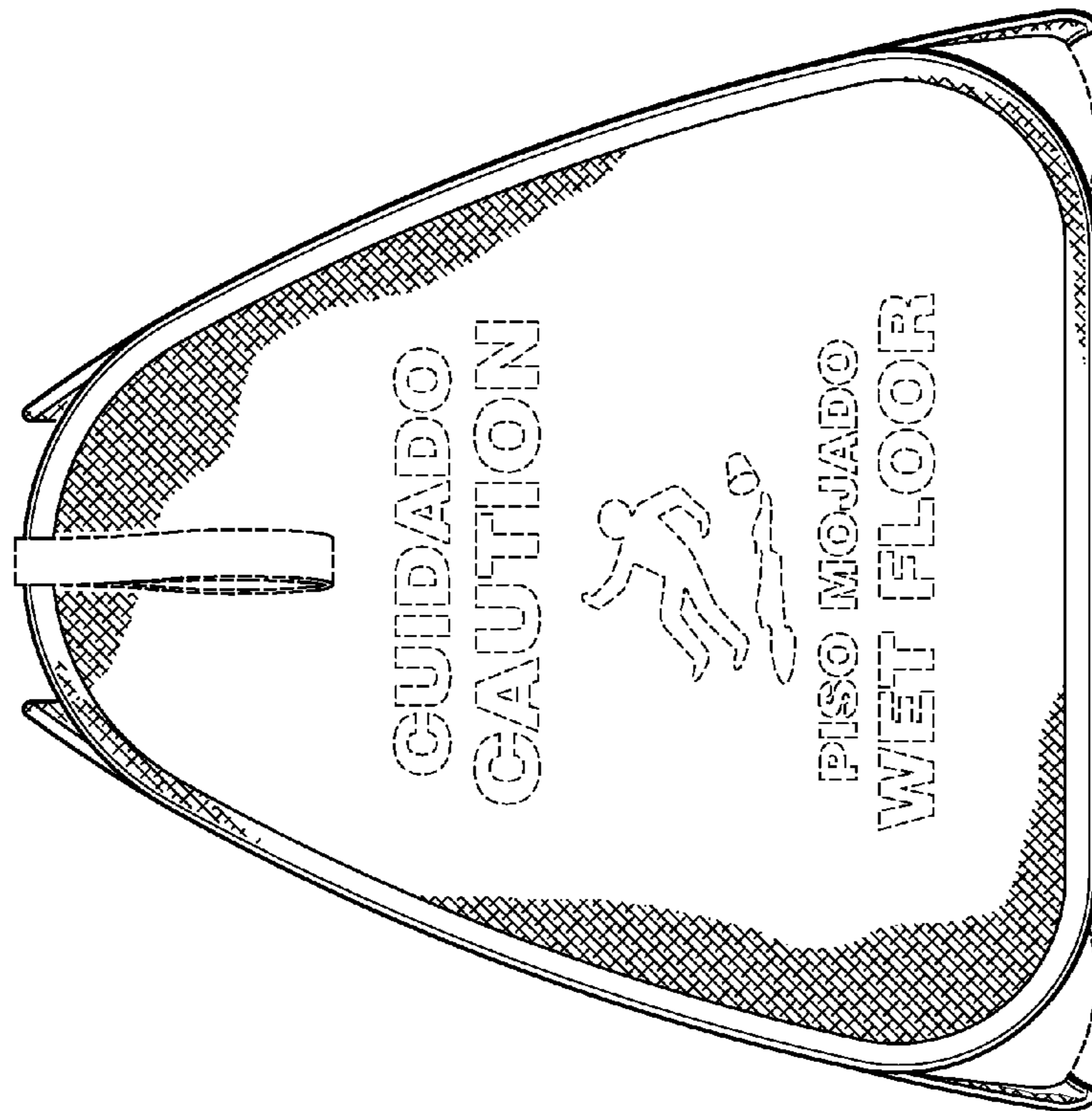

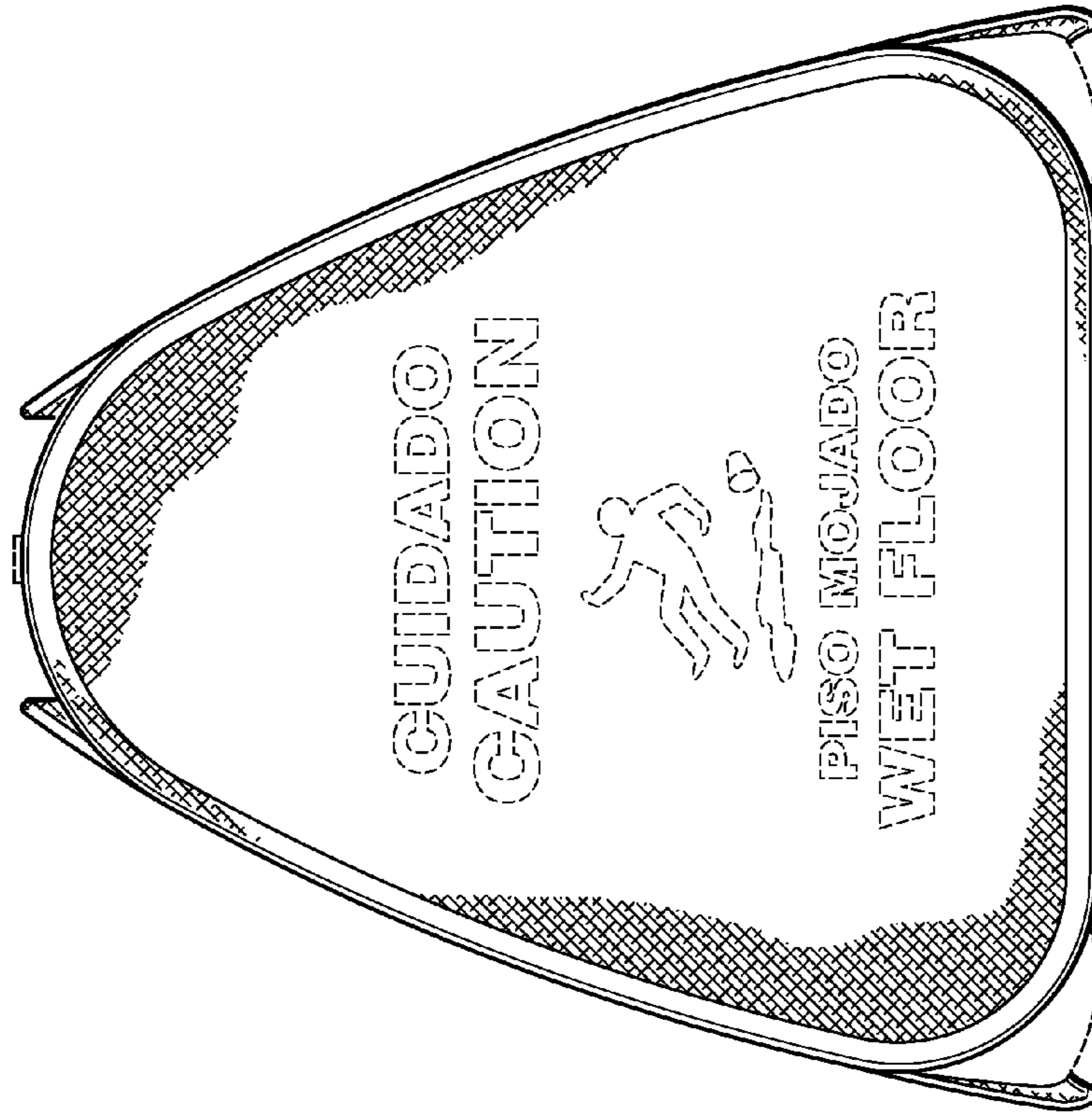

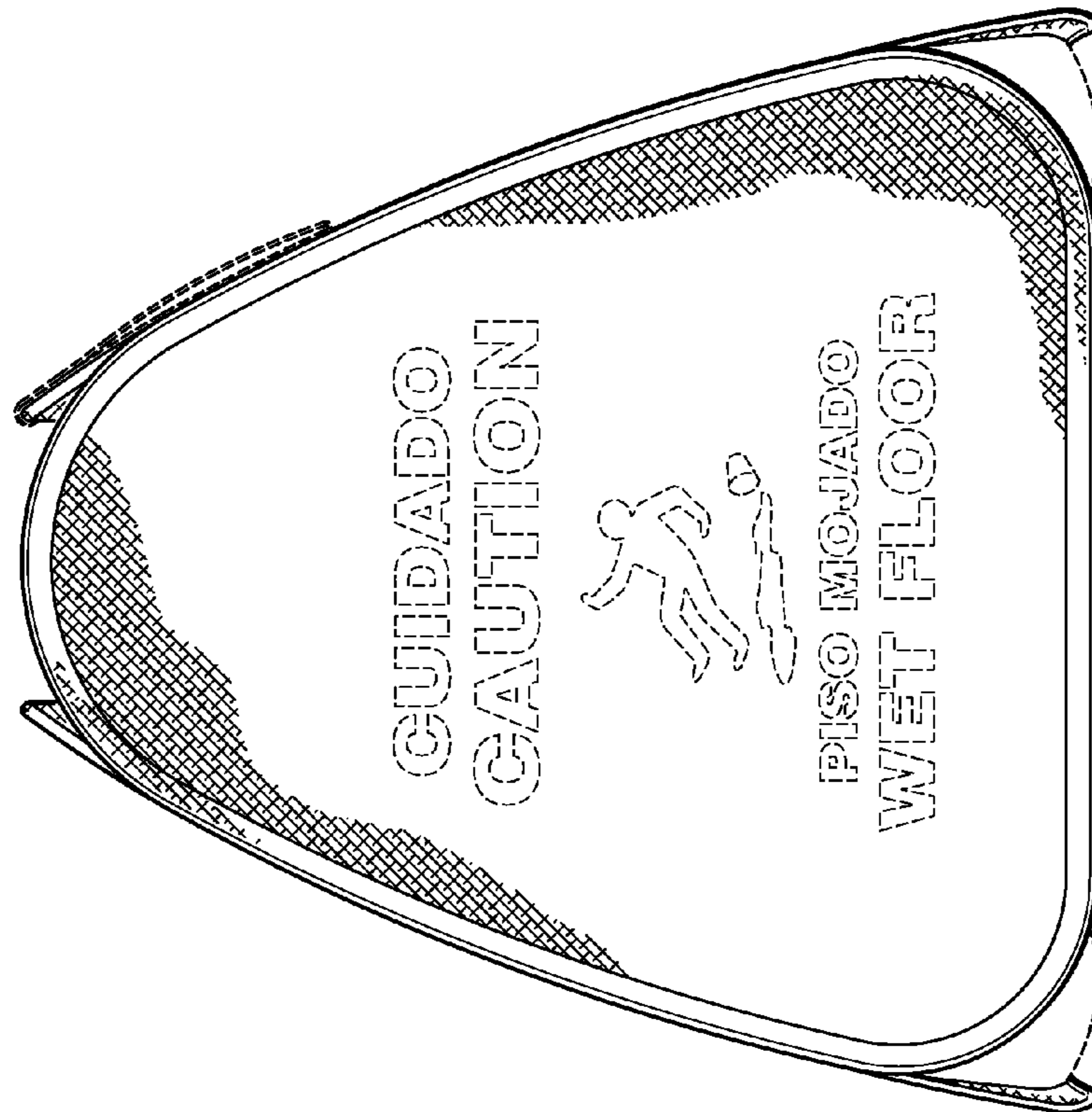

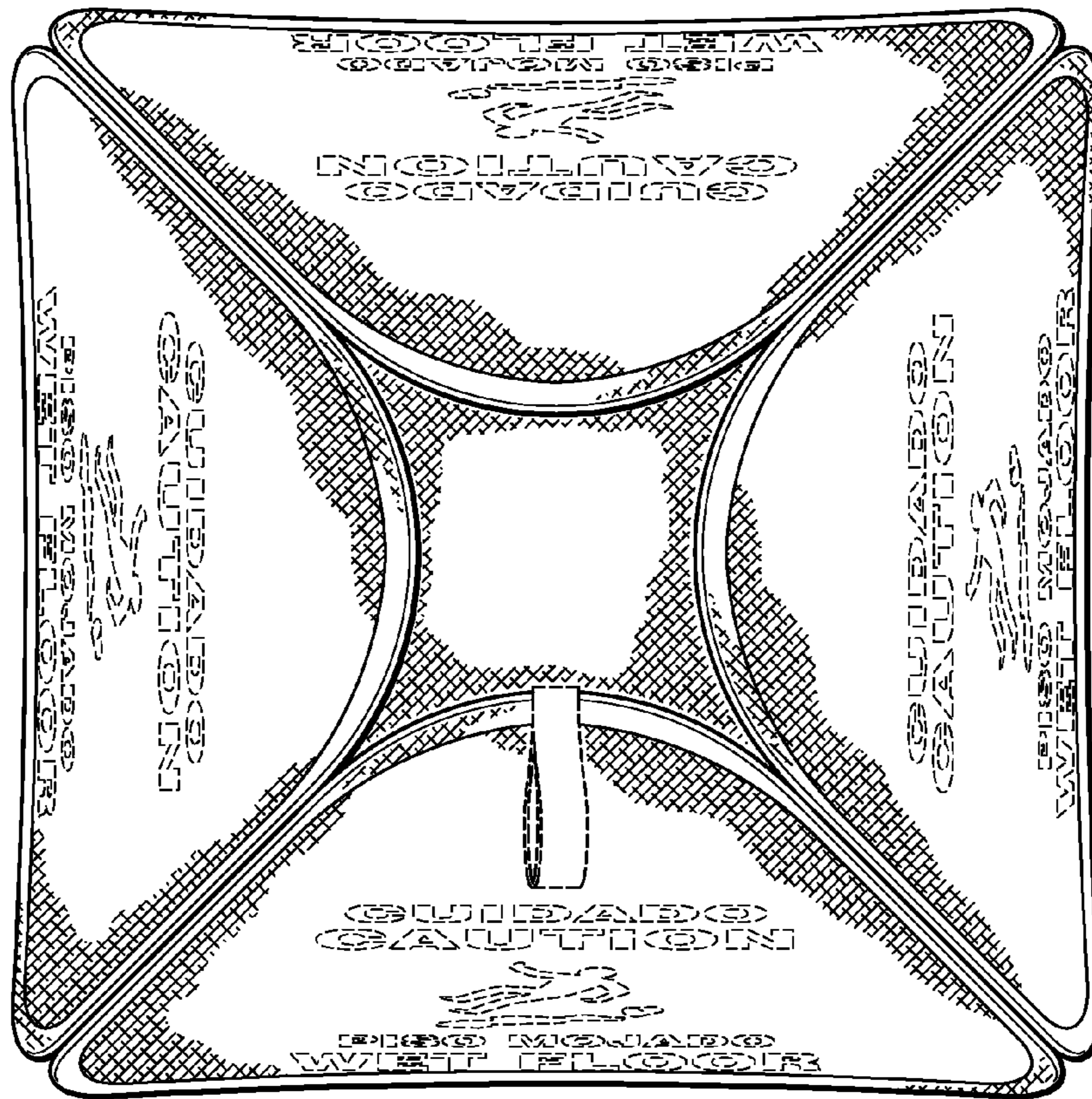
