FIG. 4 is a bottom view thereof;

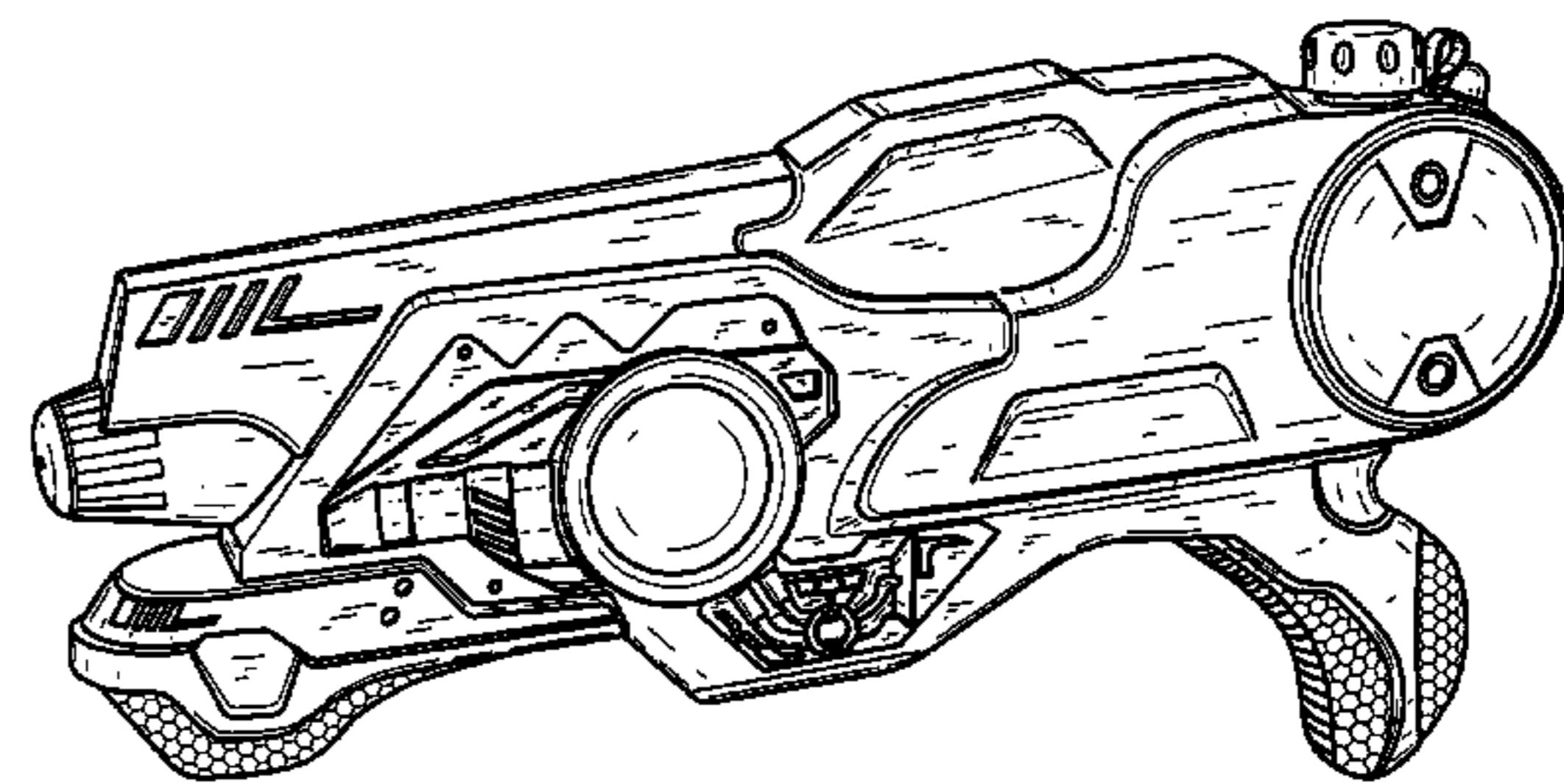
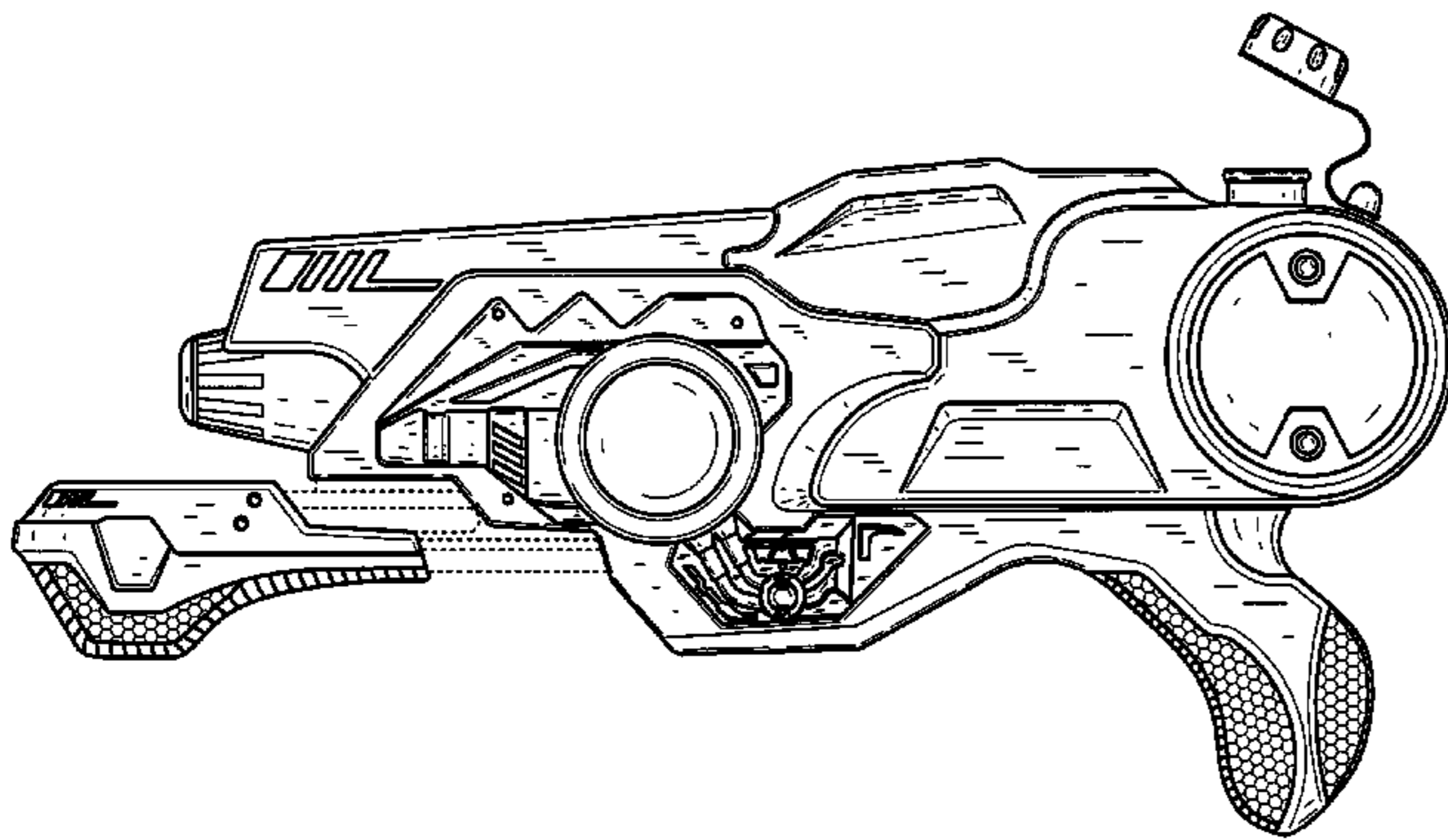
FIG. 5 is an additional front view thereof with an open cap and a bottom part of the toy water gun slid open;

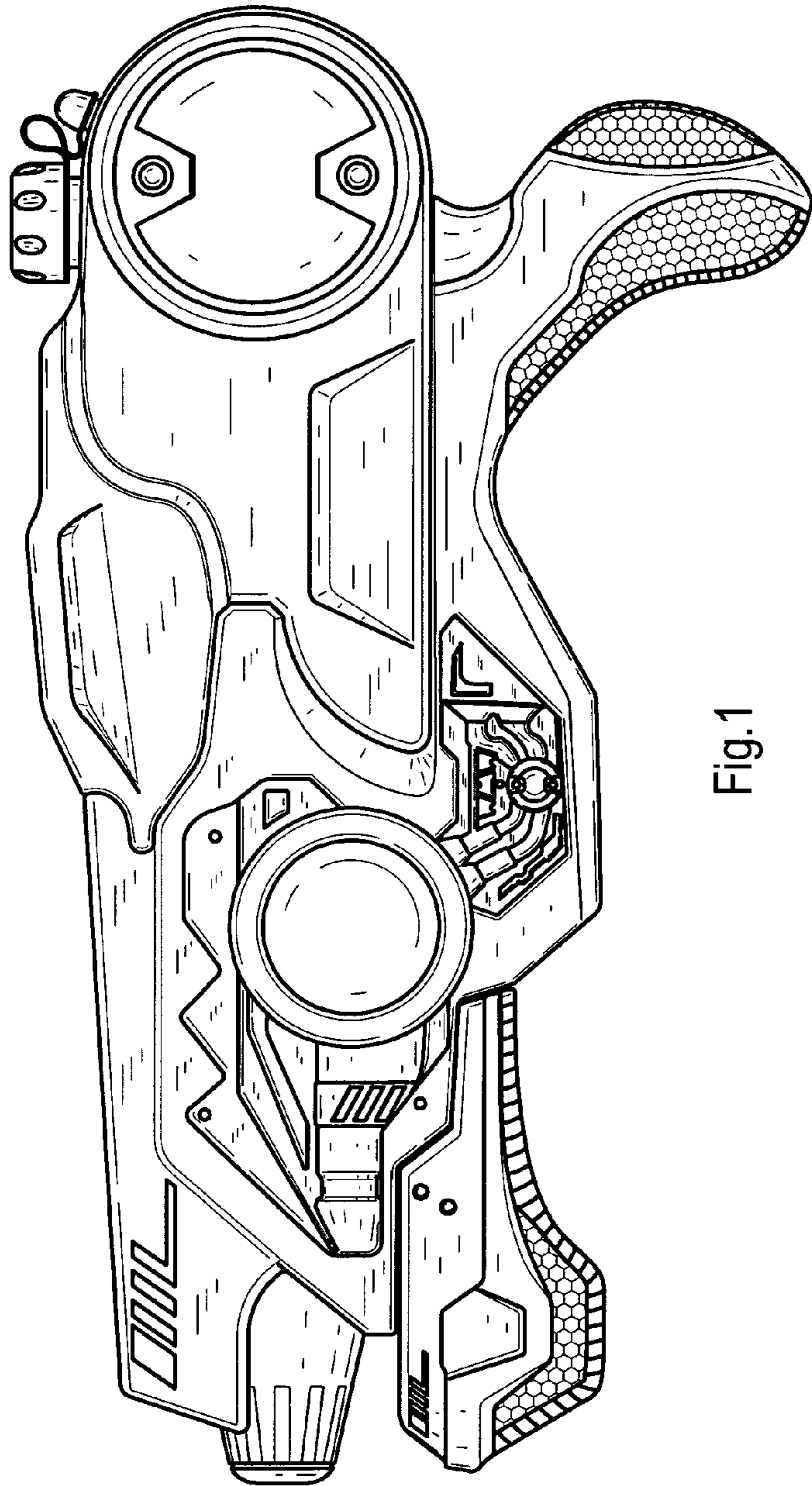

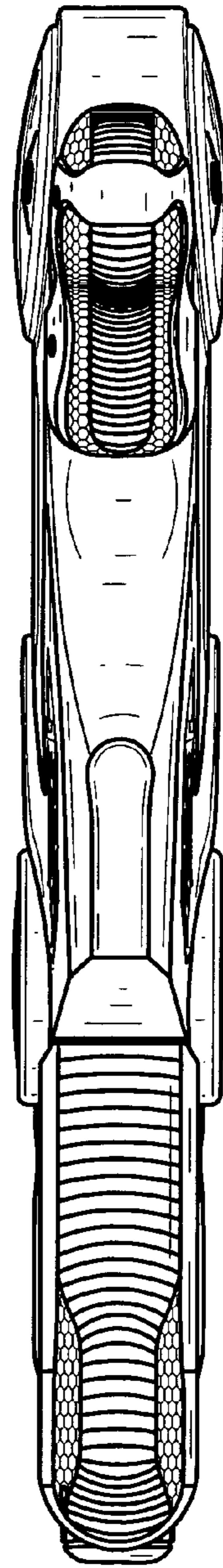

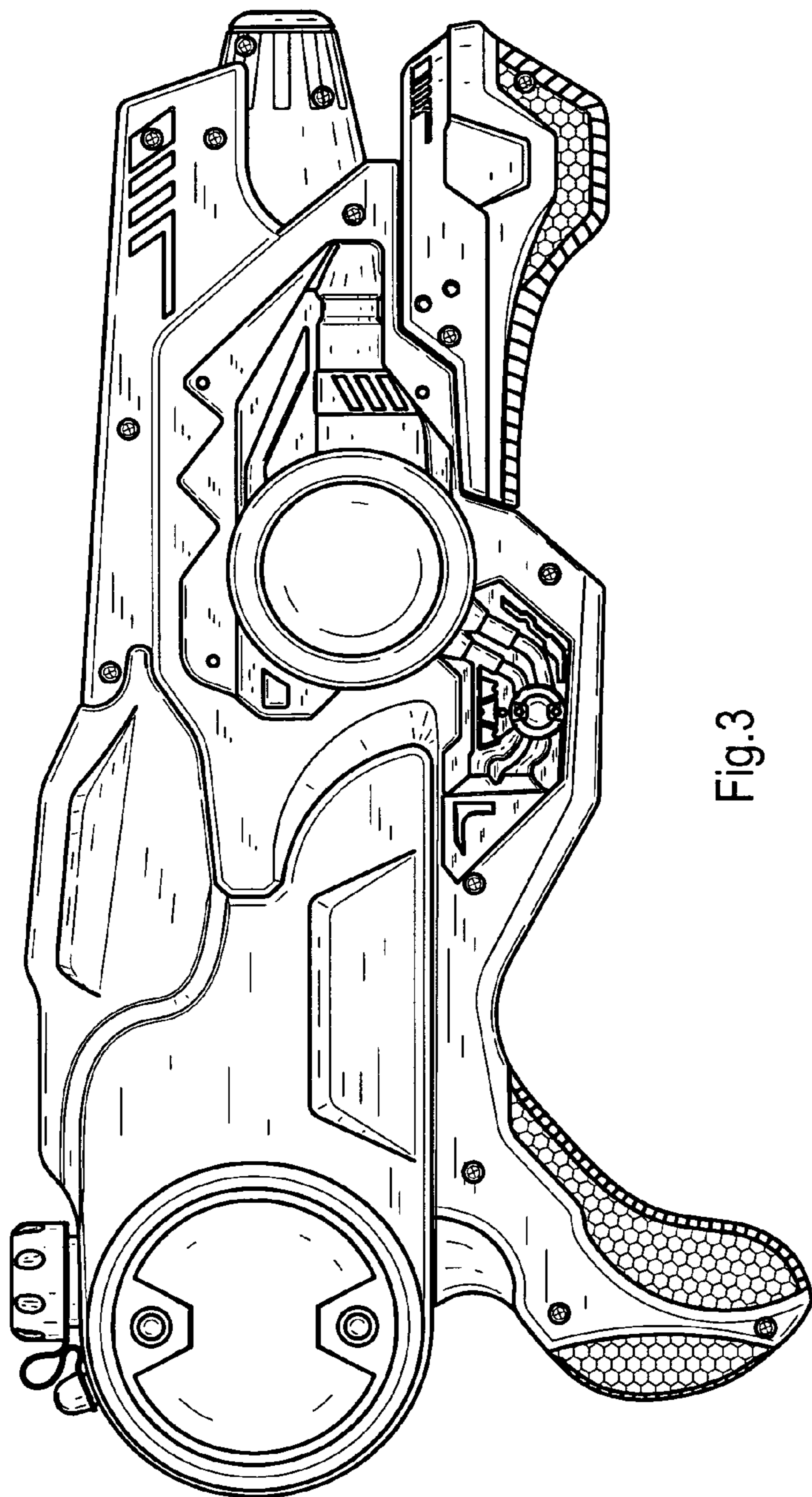

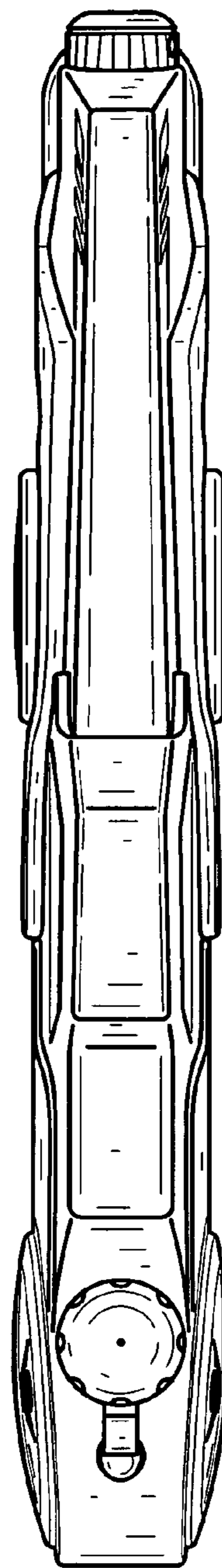

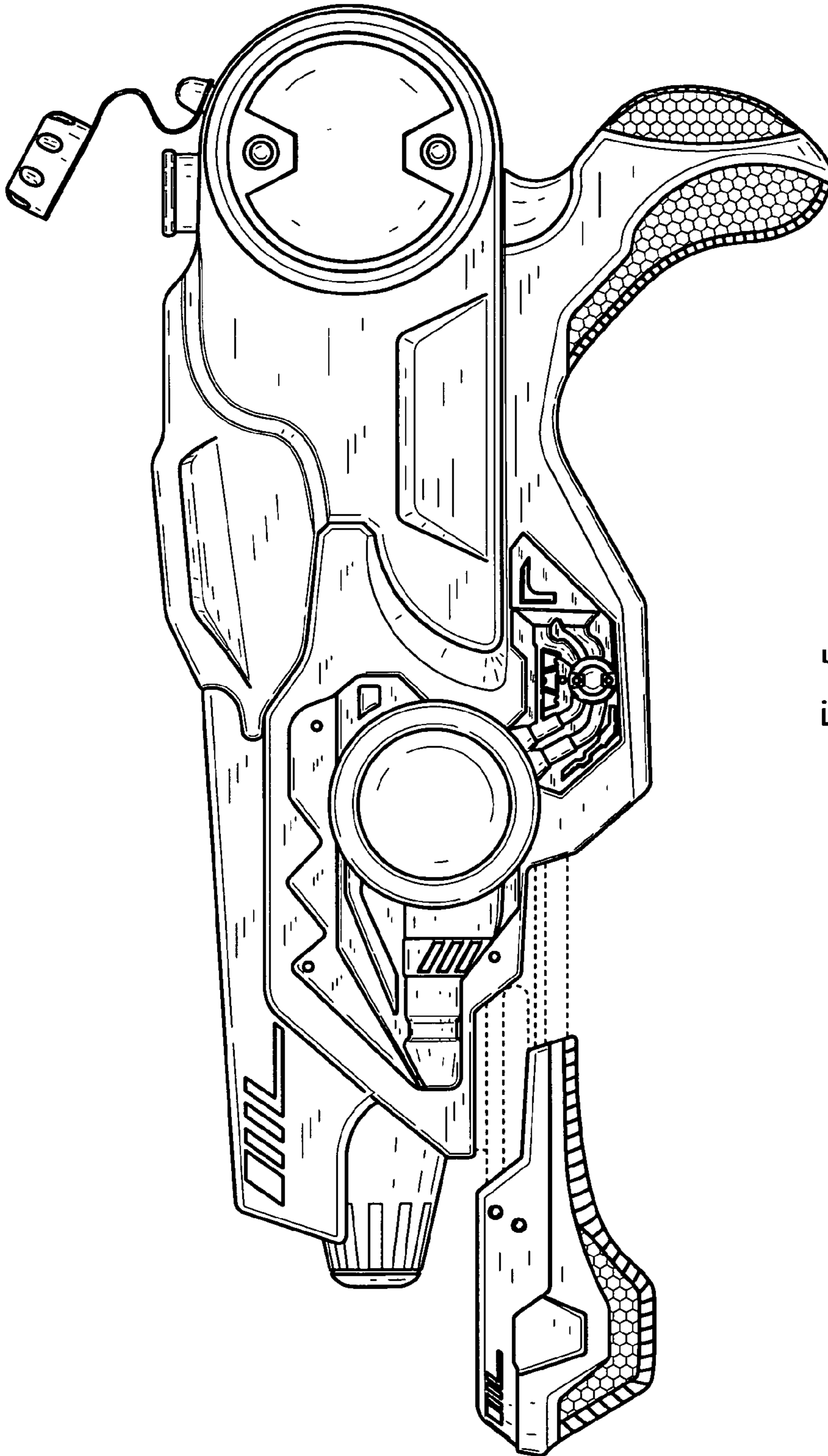

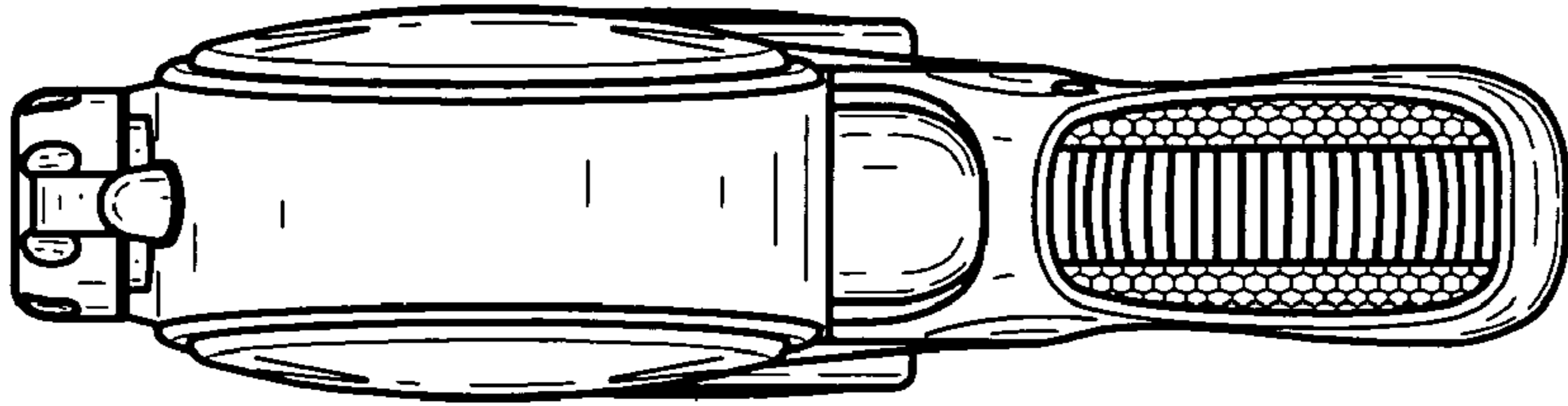

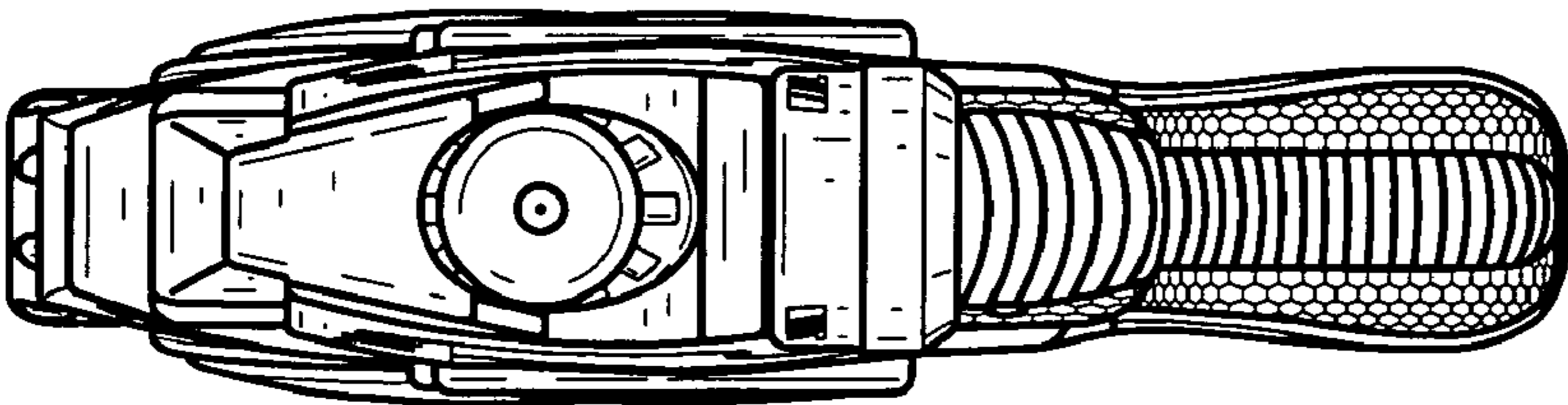

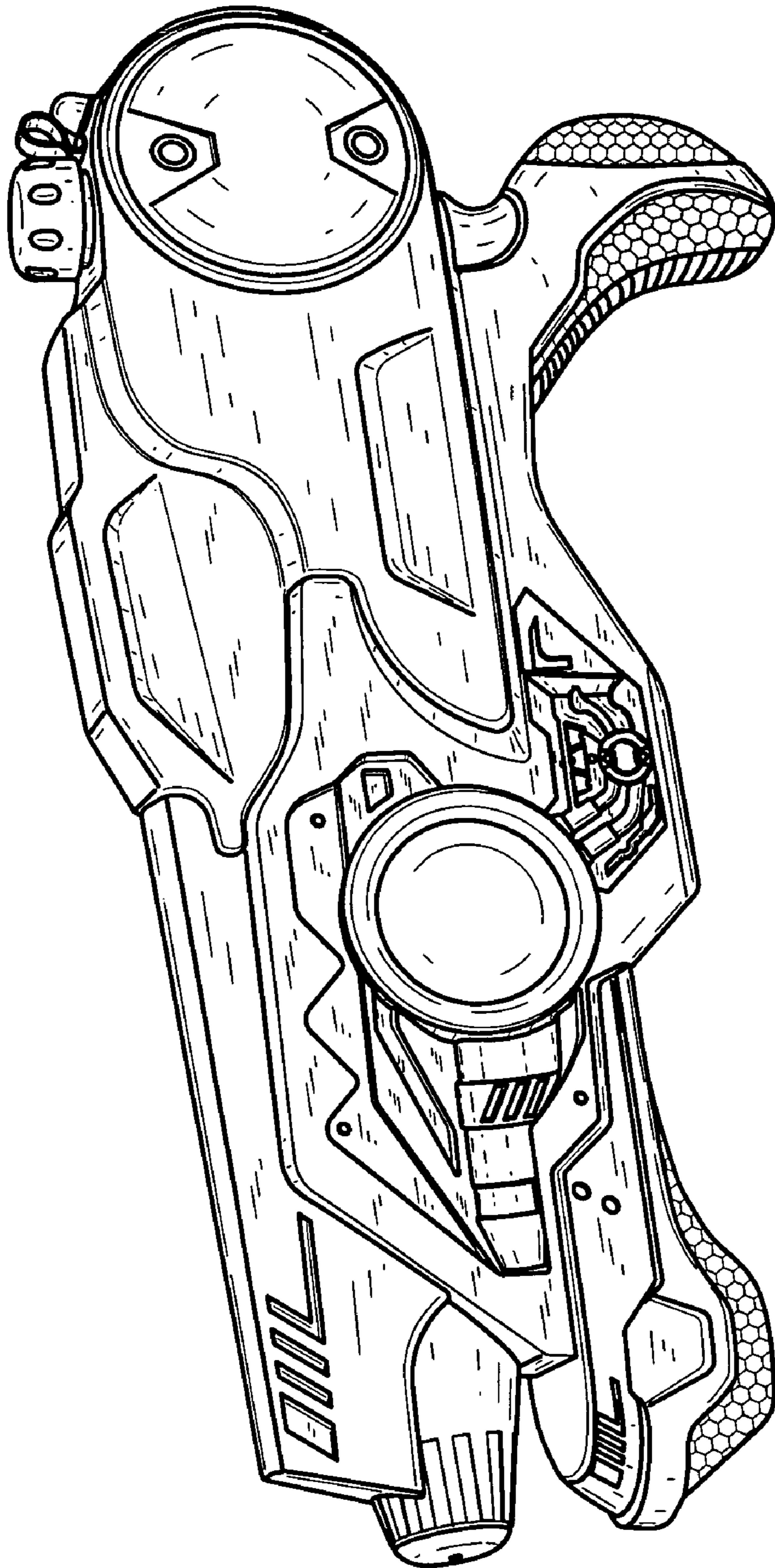
