What is claimed is the ornamental design for a hockey stick protective applique, as shown and described.

DESCRIPTION

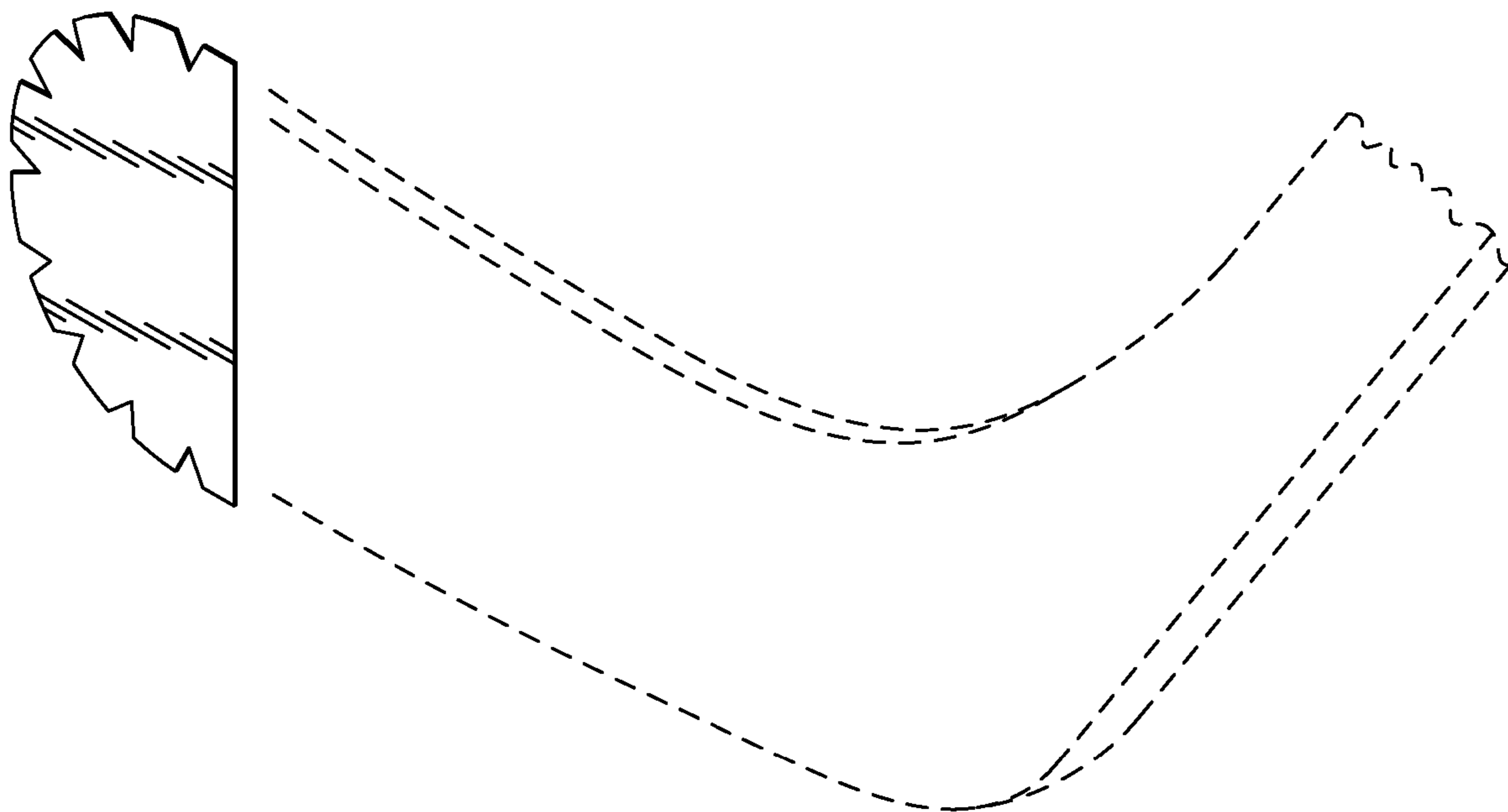
FIG. 1 is a perspective view of a hockey stick protective applique, showing the new design;
 FIG. 2 is a front elevational view thereof, the rear elevational view being a mirror image thereof;
 FIG. 3 is a left-side elevational view thereof;
 FIG. 4 is a right-side elevational view thereof; and,
 FIG. 5 is a top plan view thereof, the bottom plan view being a mirror image thereof.
 The broken lines showing a hockey stick in FIG. 1 are environmental matter, and form no part of the claimed design.

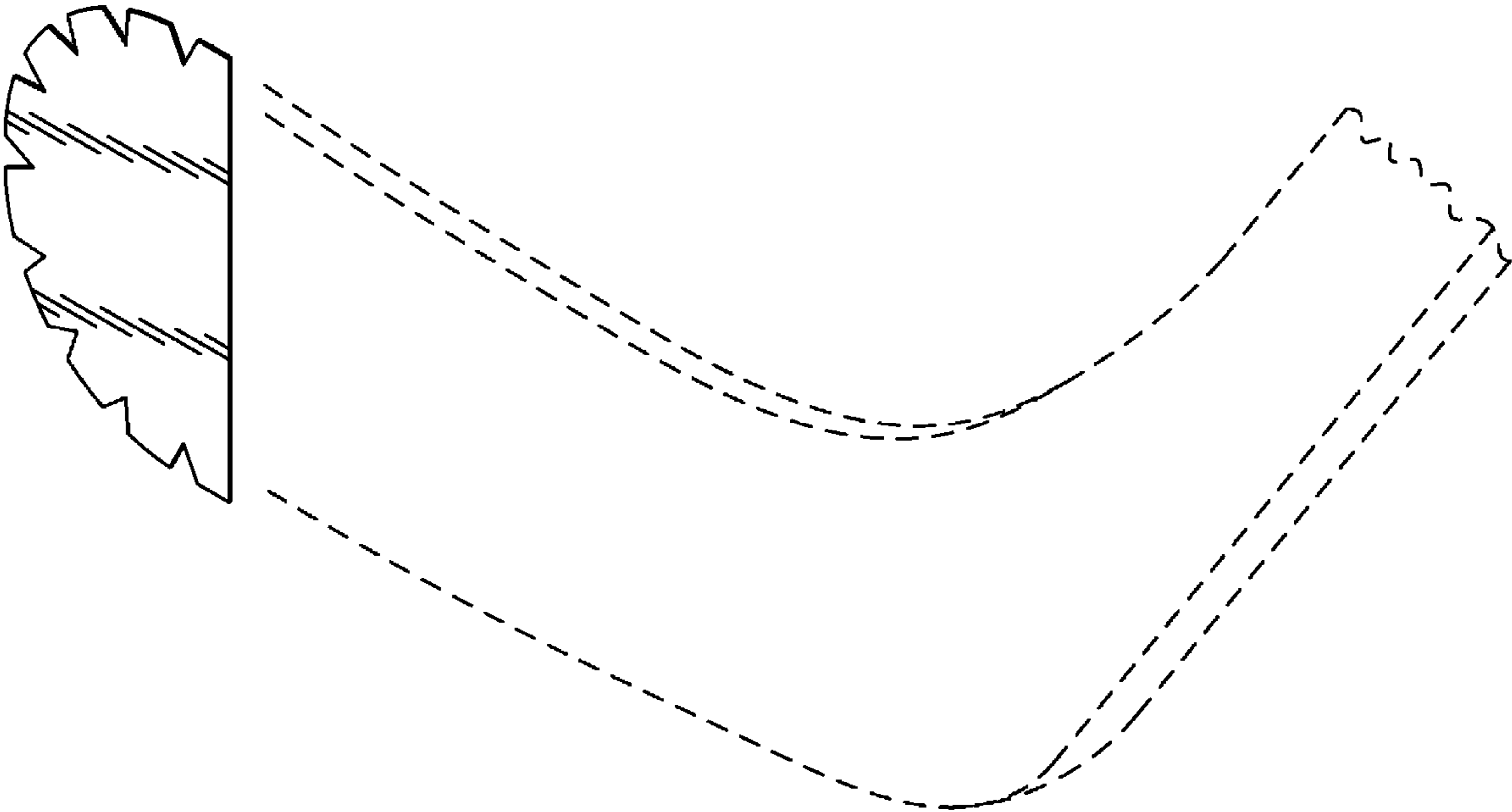

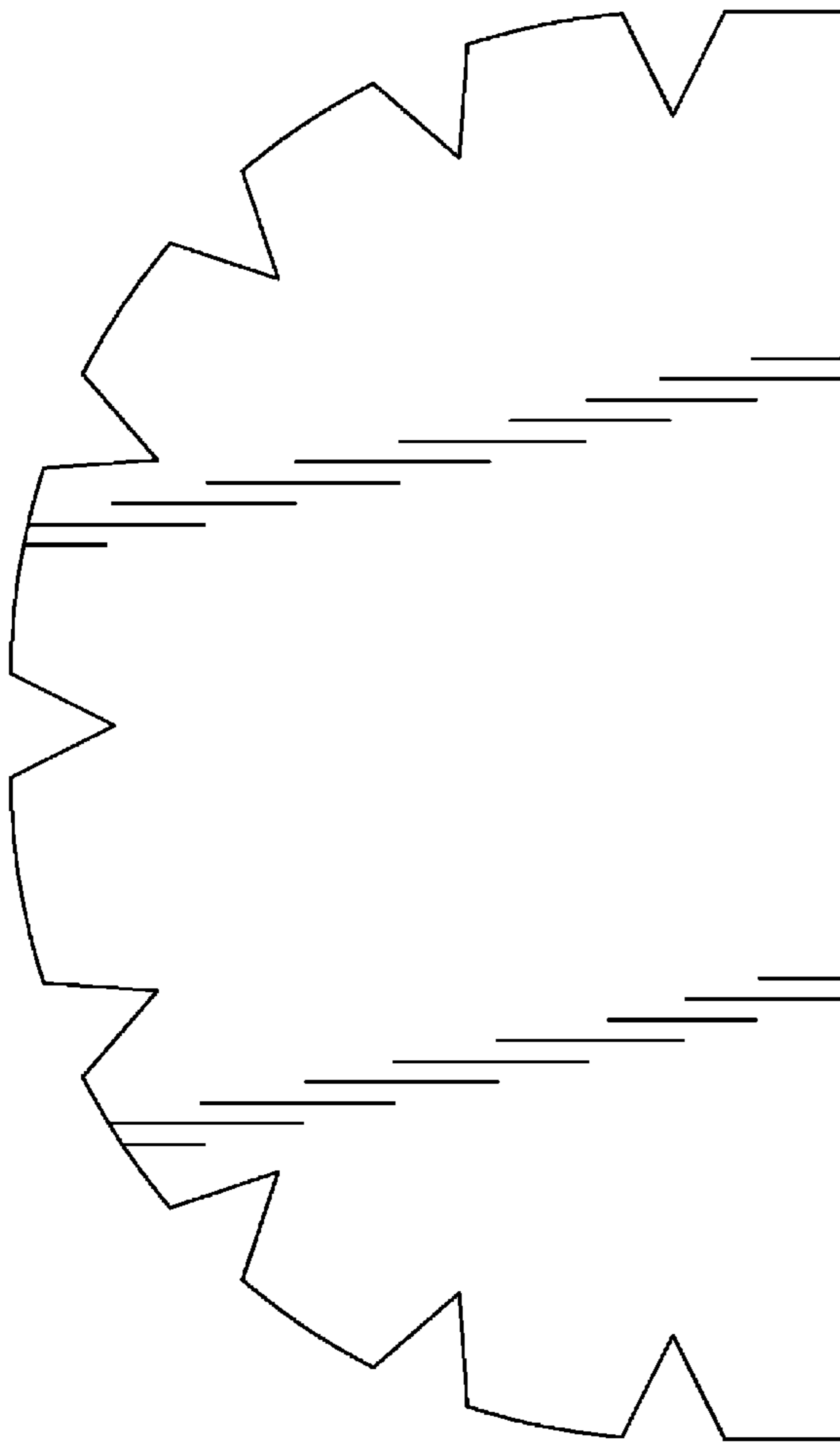
