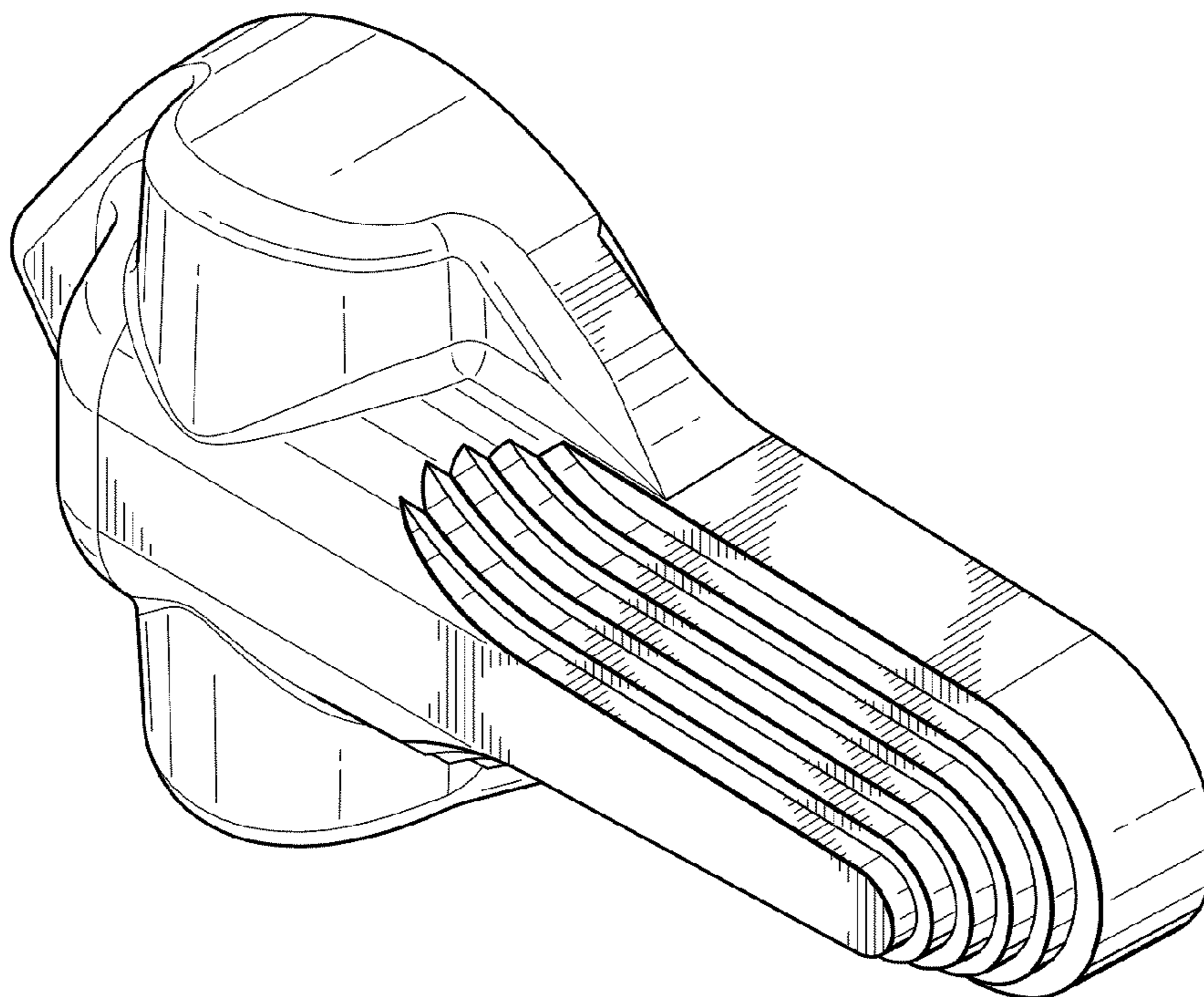
(57) **CLAIM**

The ornamental design for a control lever, as shown and described.

DESCRIPTION

FIG. 1 is a top left perspective view of a control lever showing my new design;
FIG. 2 is a front elevation view of the control lever of FIG. 1; and
FIG. 3 is a rear elevation view of the control lever of FIG. 1.
FIG. 4 is a top plan view of the control lever of FIG. 1.
FIG. 5 is a bottom plan view of the control lever of FIG. 1.
FIG. 6 is a left elevation view of the control lever of FIG. 1; and,
FIG. 7 is a right elevation view of the control lever of FIG. 1.

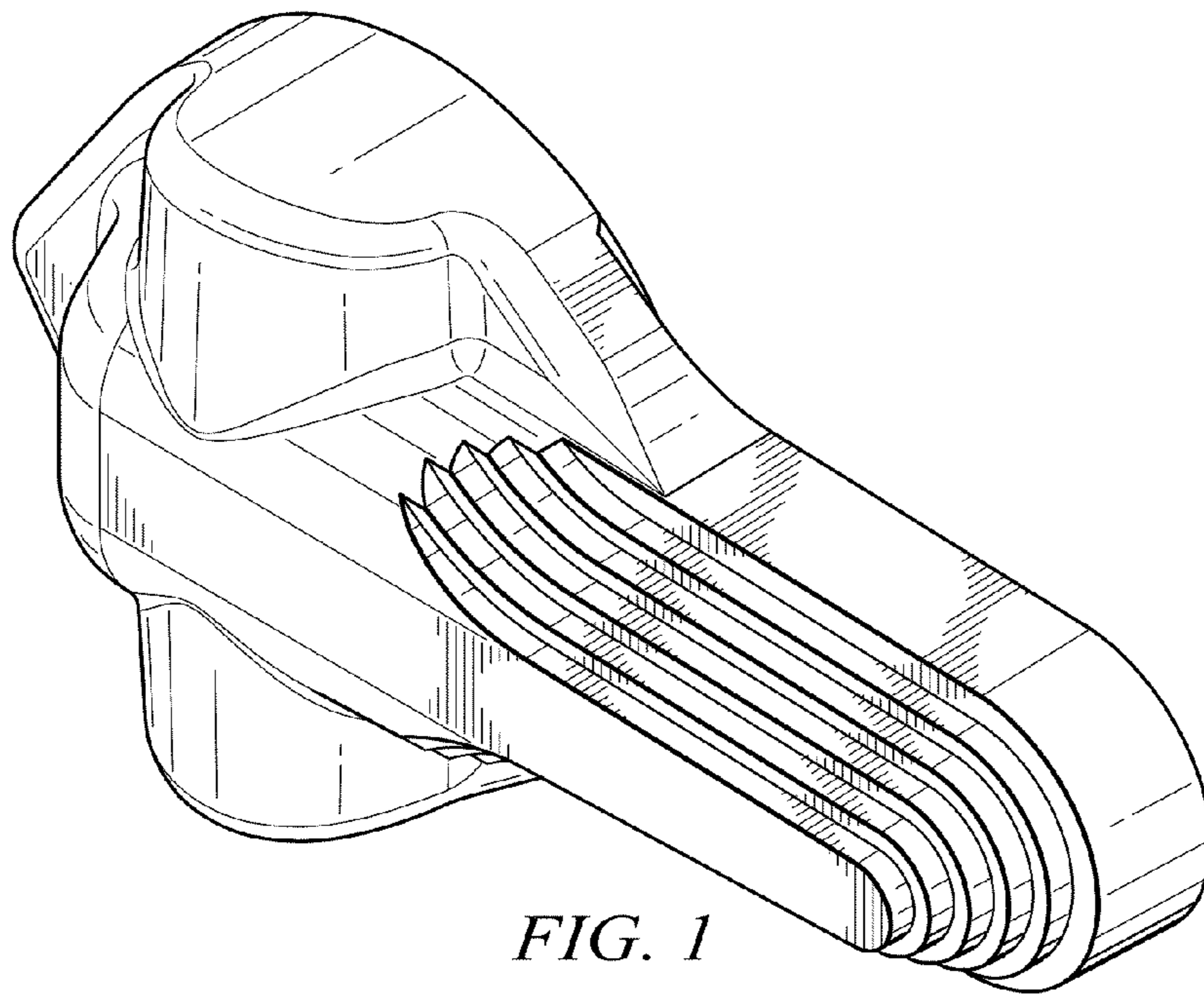

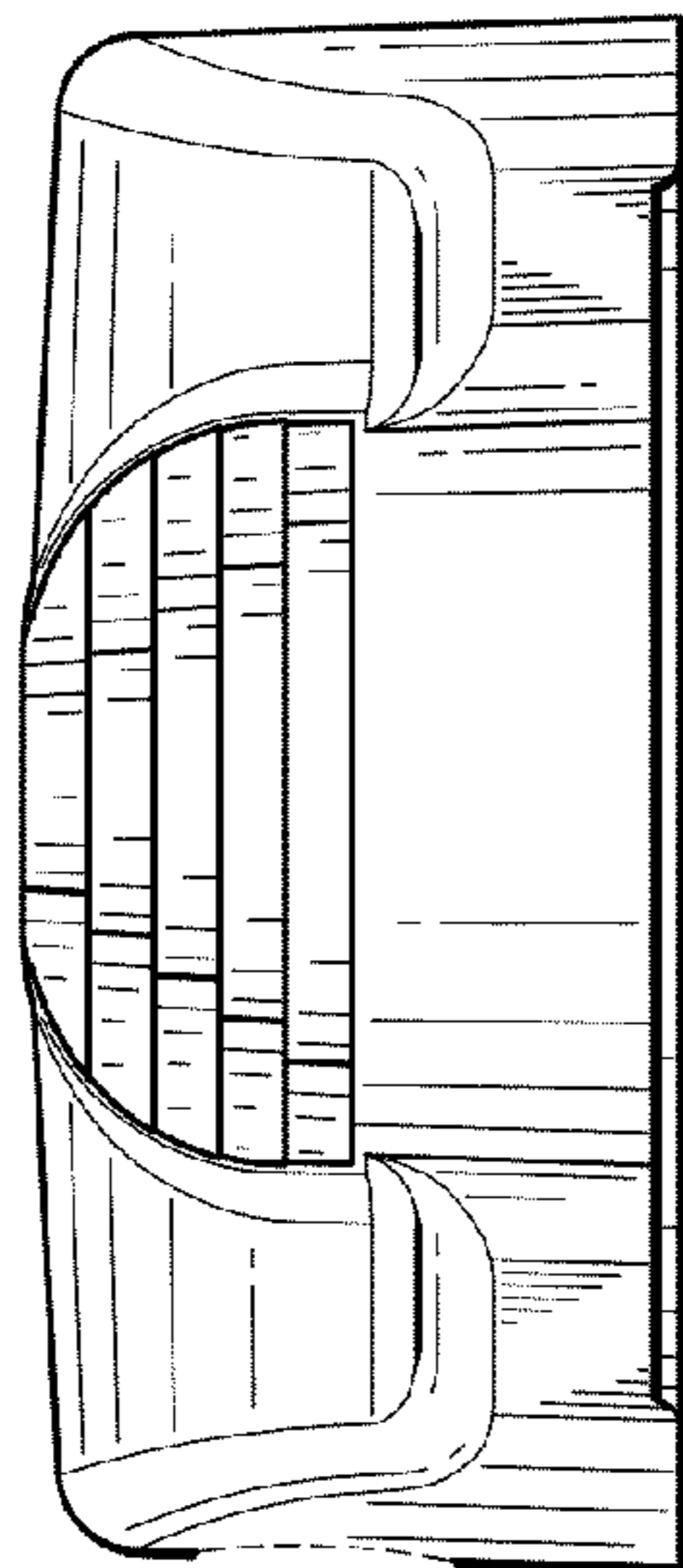

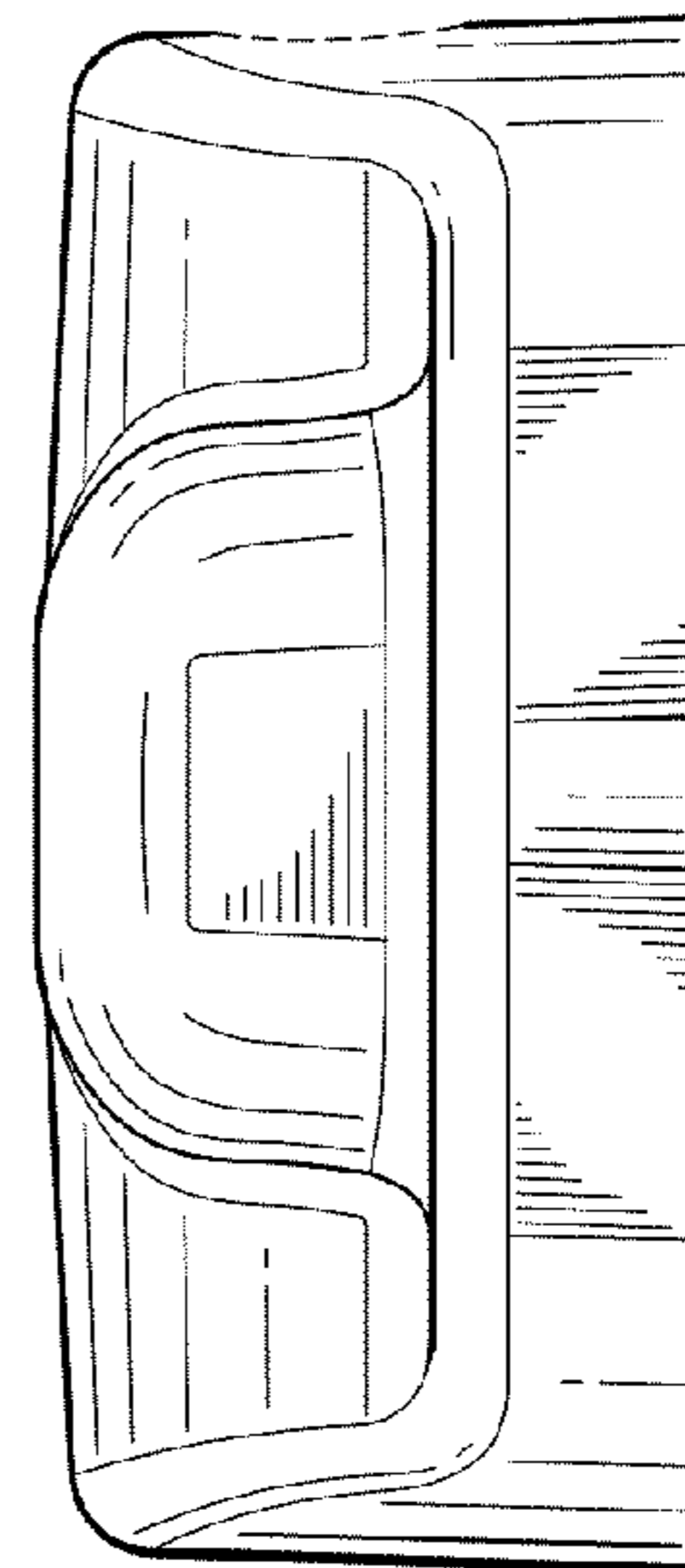

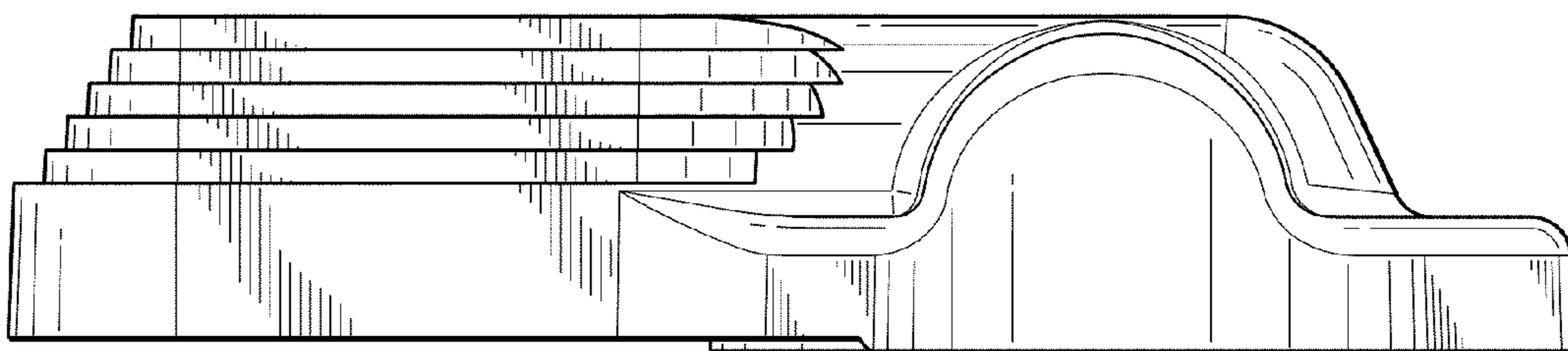

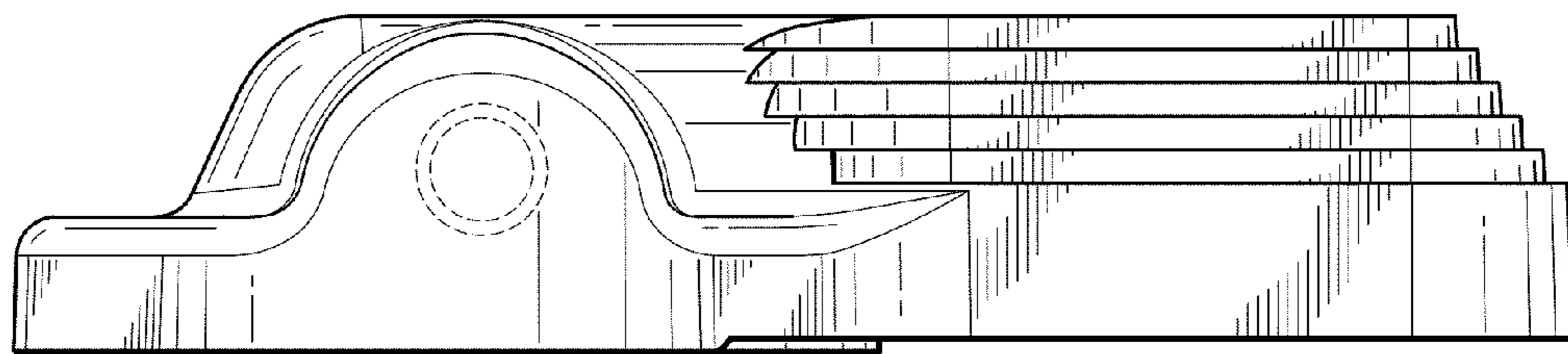

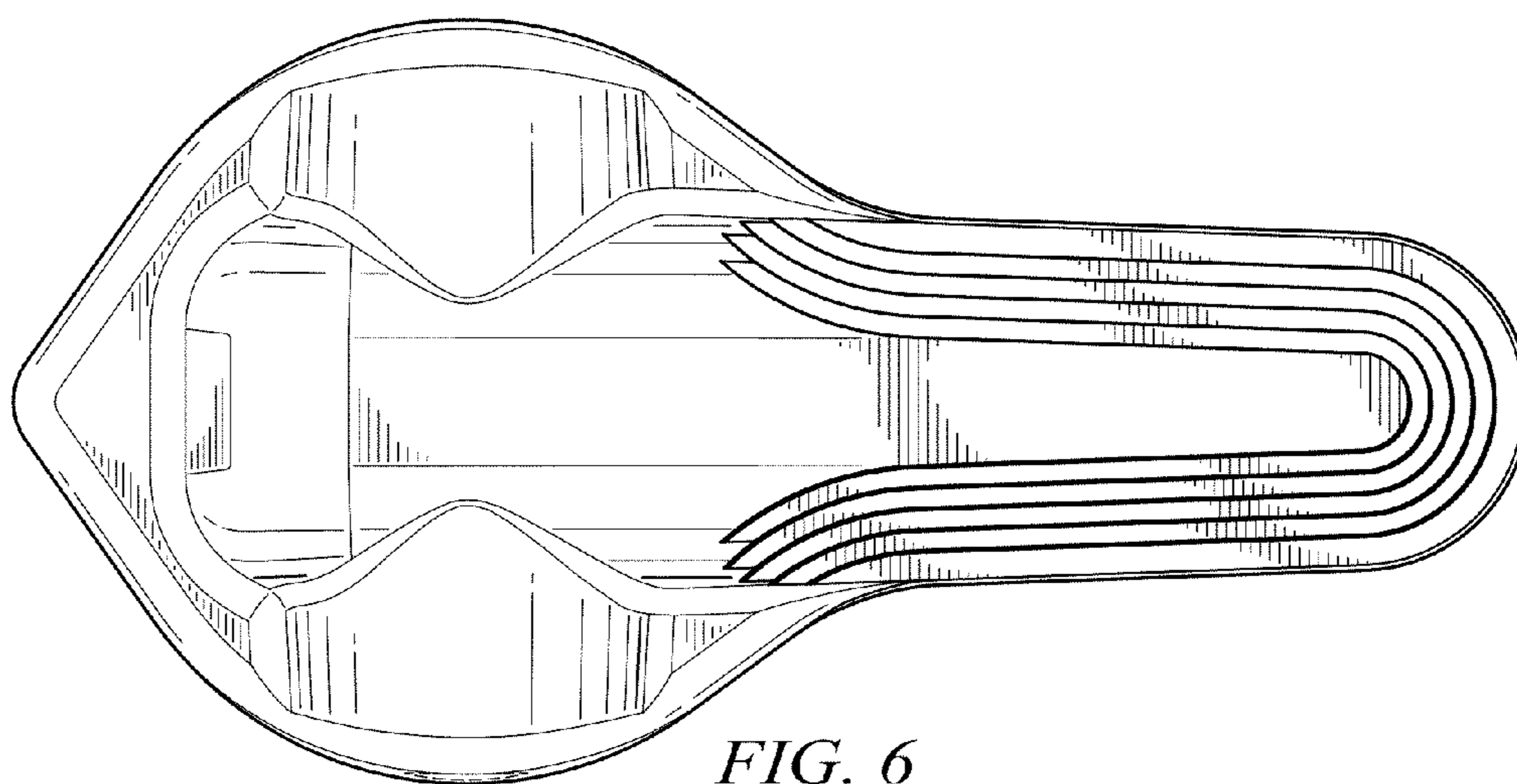

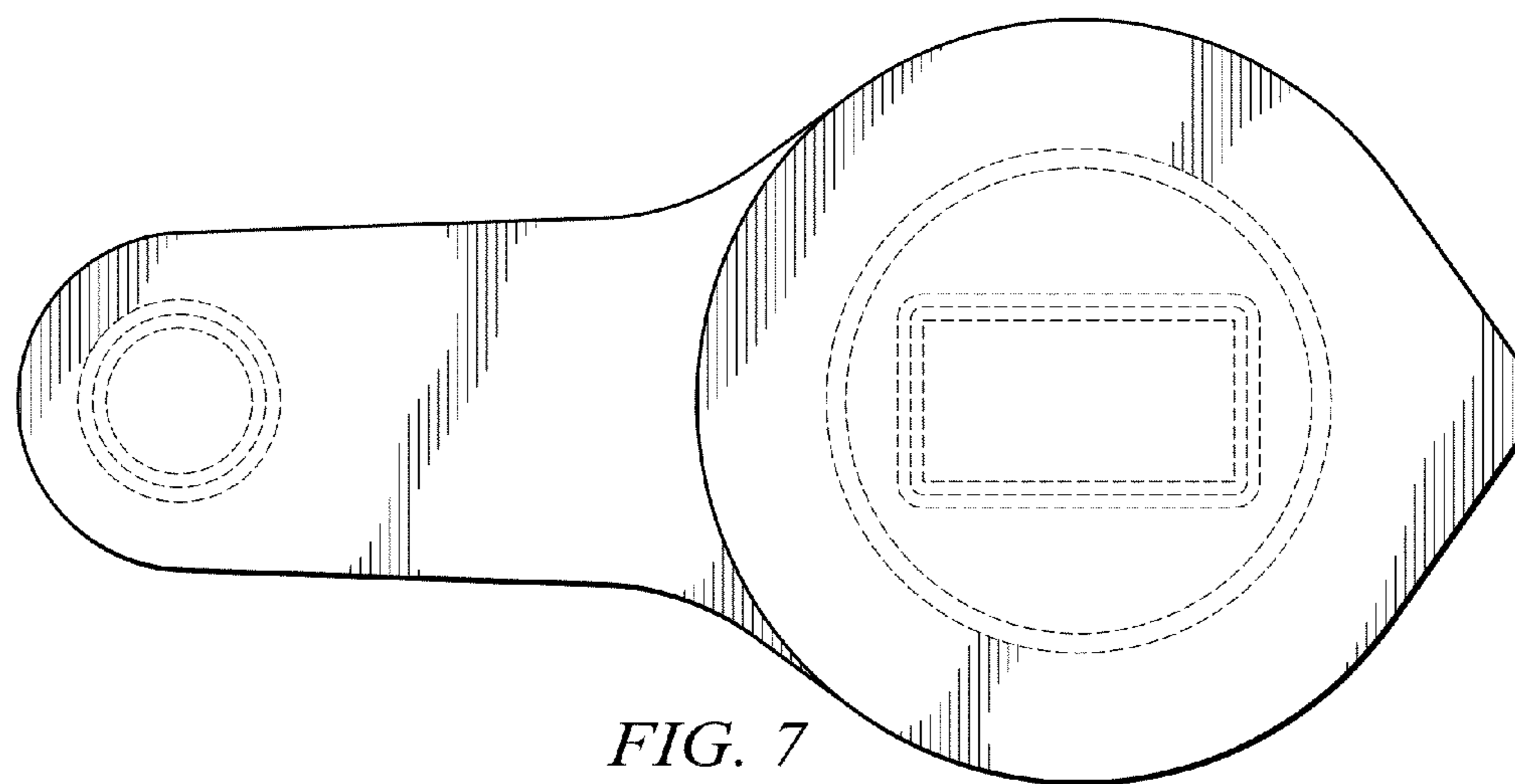
