The ornamental design for acupressure device, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the acupressure device of my design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a rear elevational view thereof;

FIG. 4 is a top plan view thereof;

FIG. 5 is a bottom plan view thereof;

FIG. 6 is a left side elevational view thereof;

FIG. 7 is a right side elevational view thereof;

FIG. 8 is a cross-sectional view thereof, taken along with line 8—8 of FIG. 4; and,

FIG. 9 is a perspective view showing a state of wearing the present design.

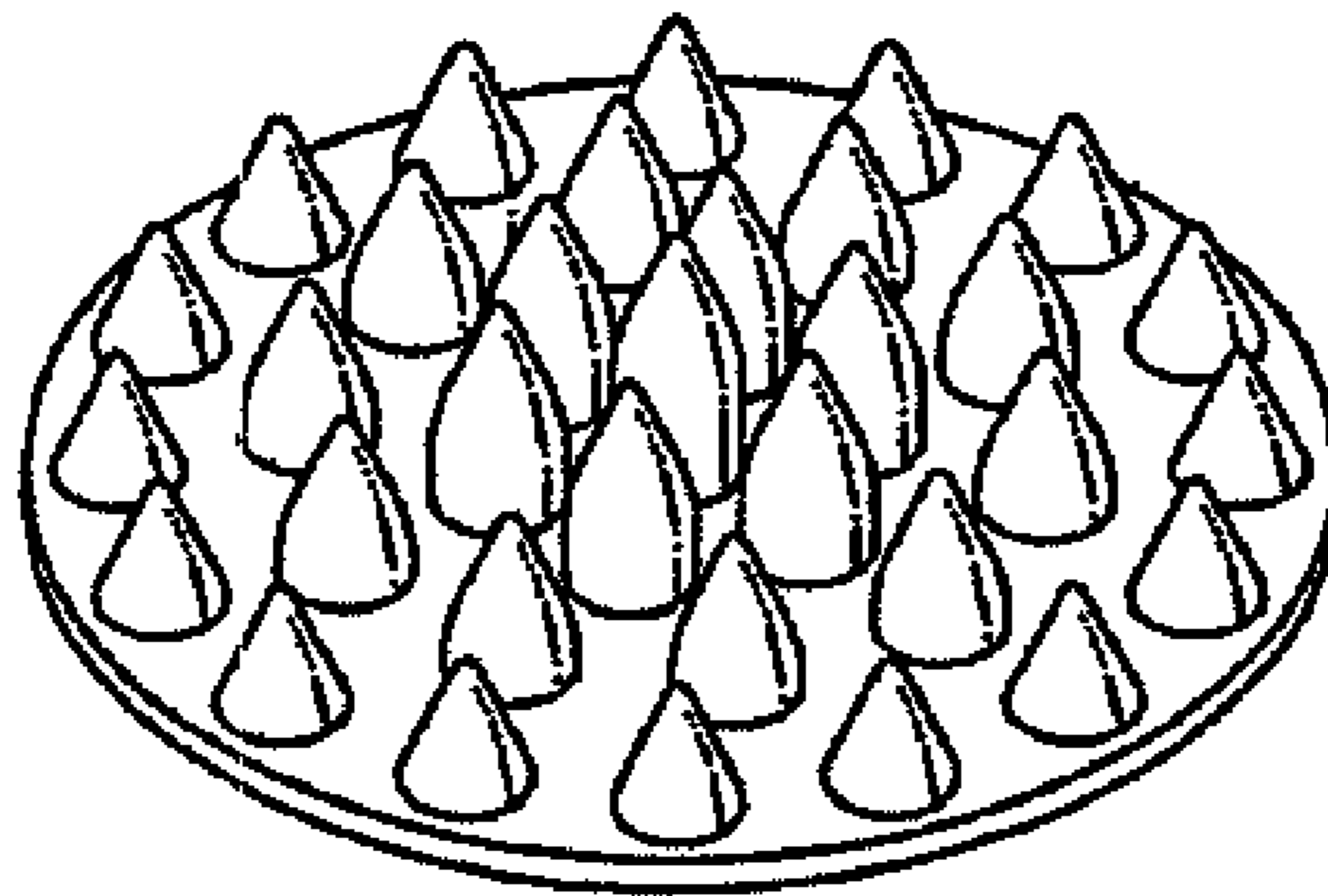

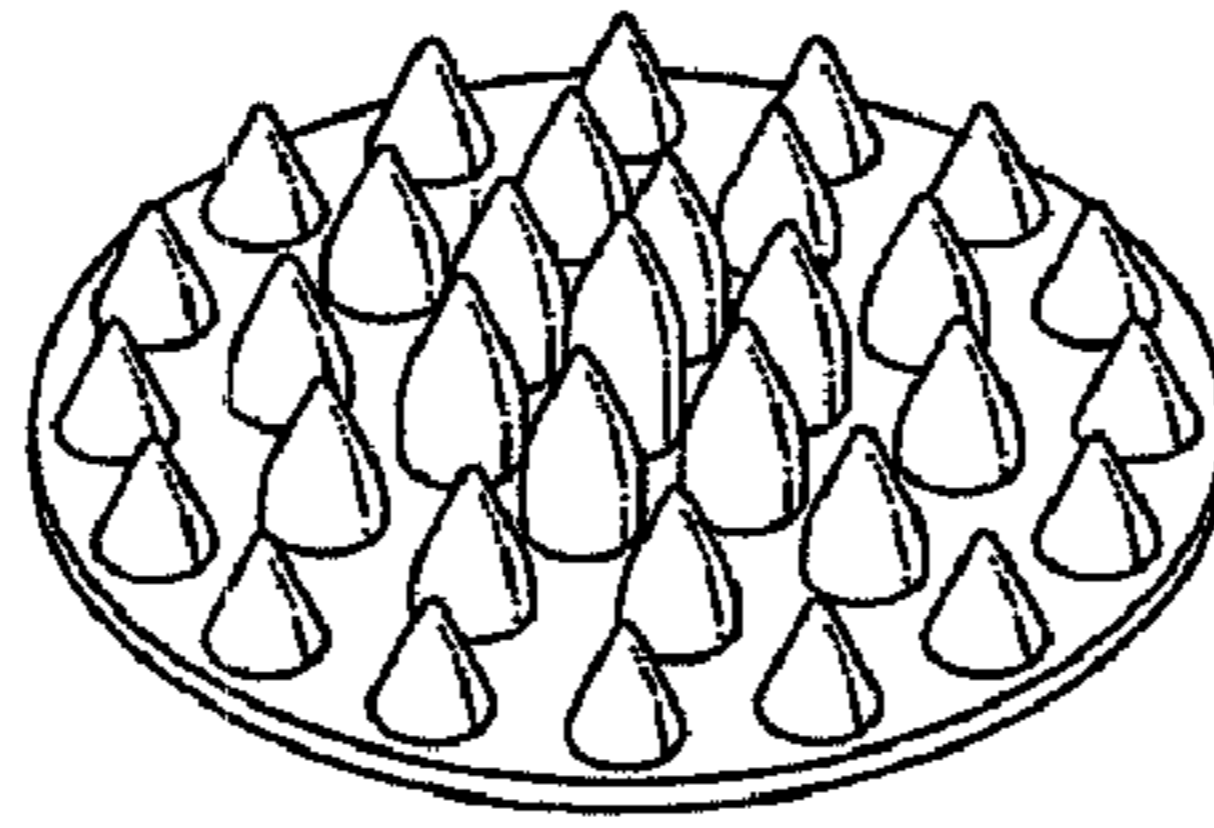

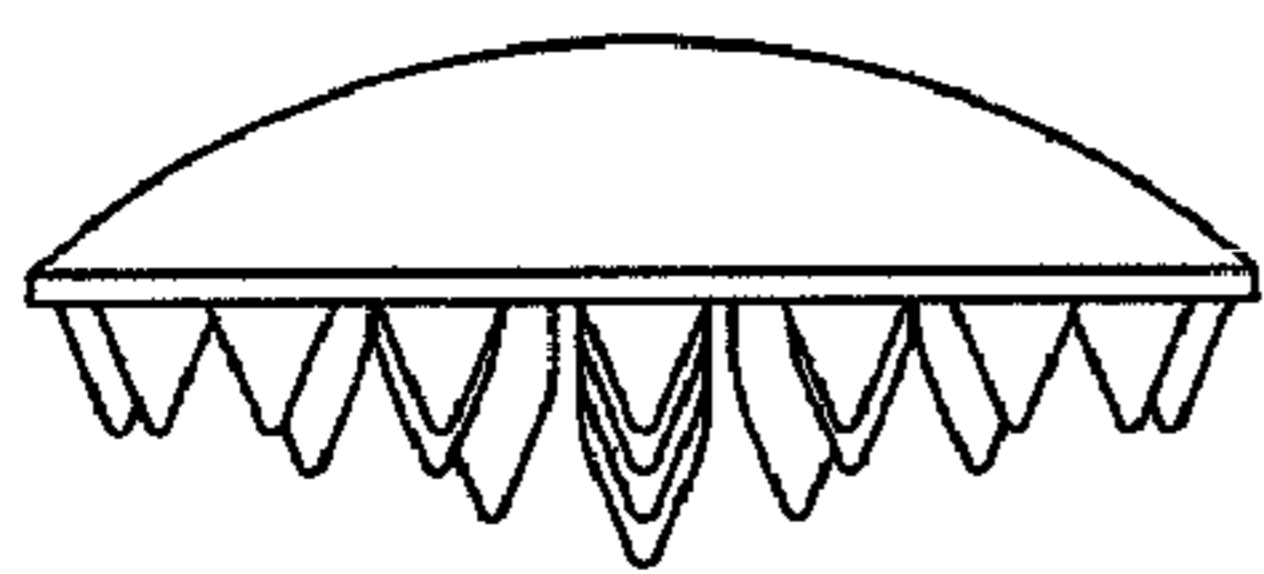

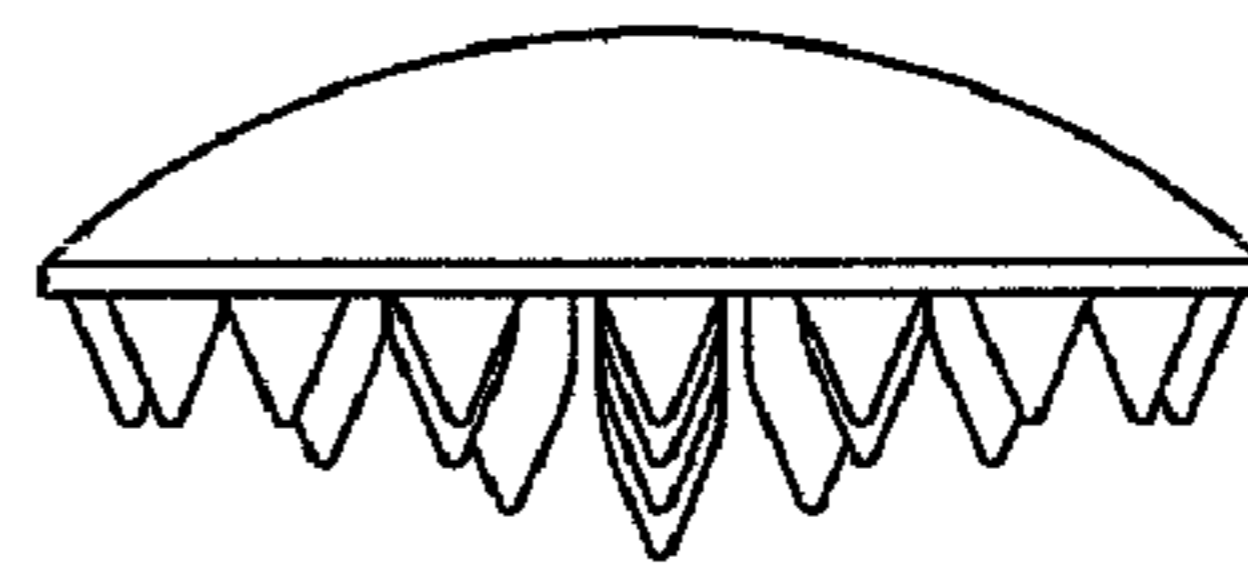

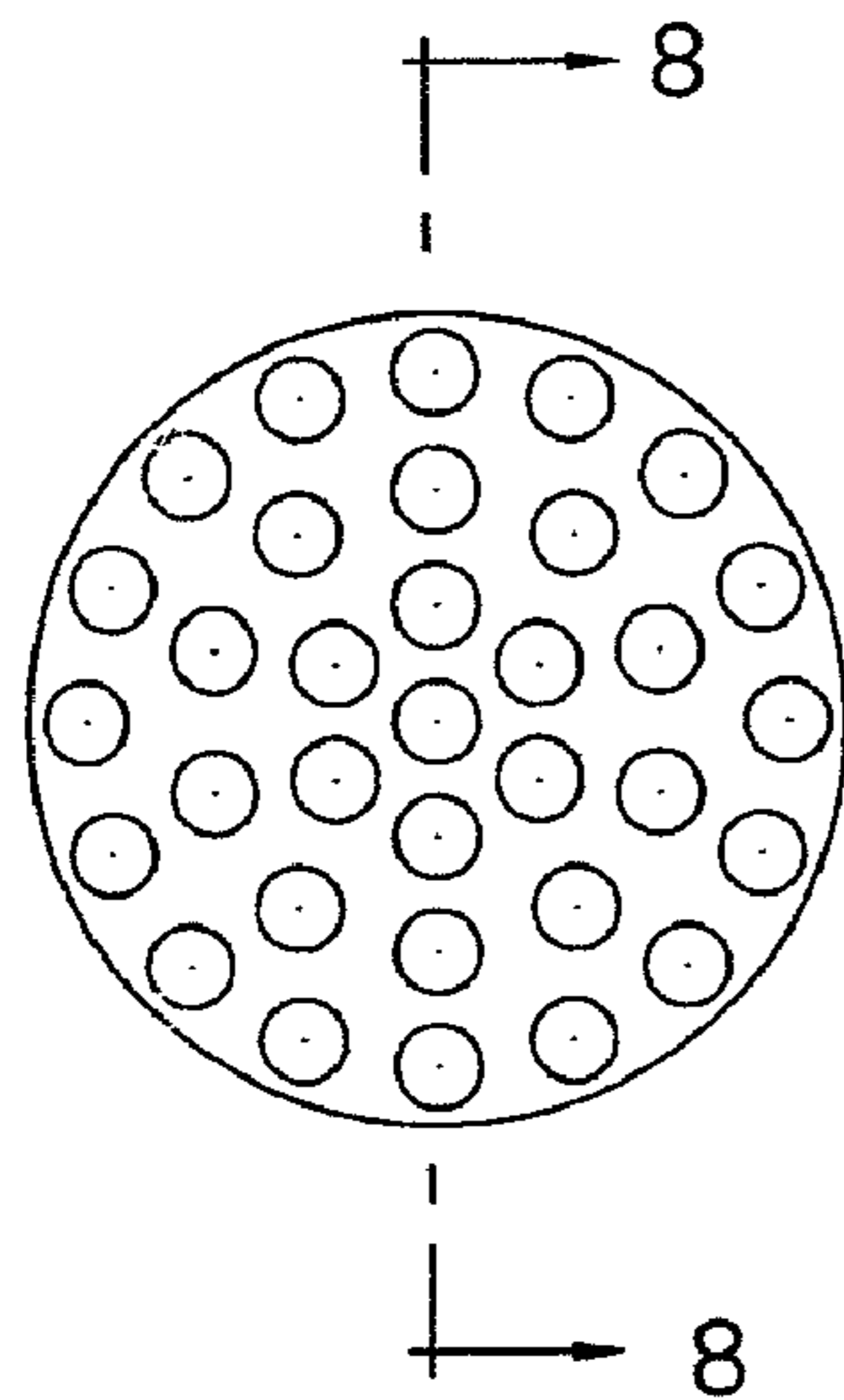

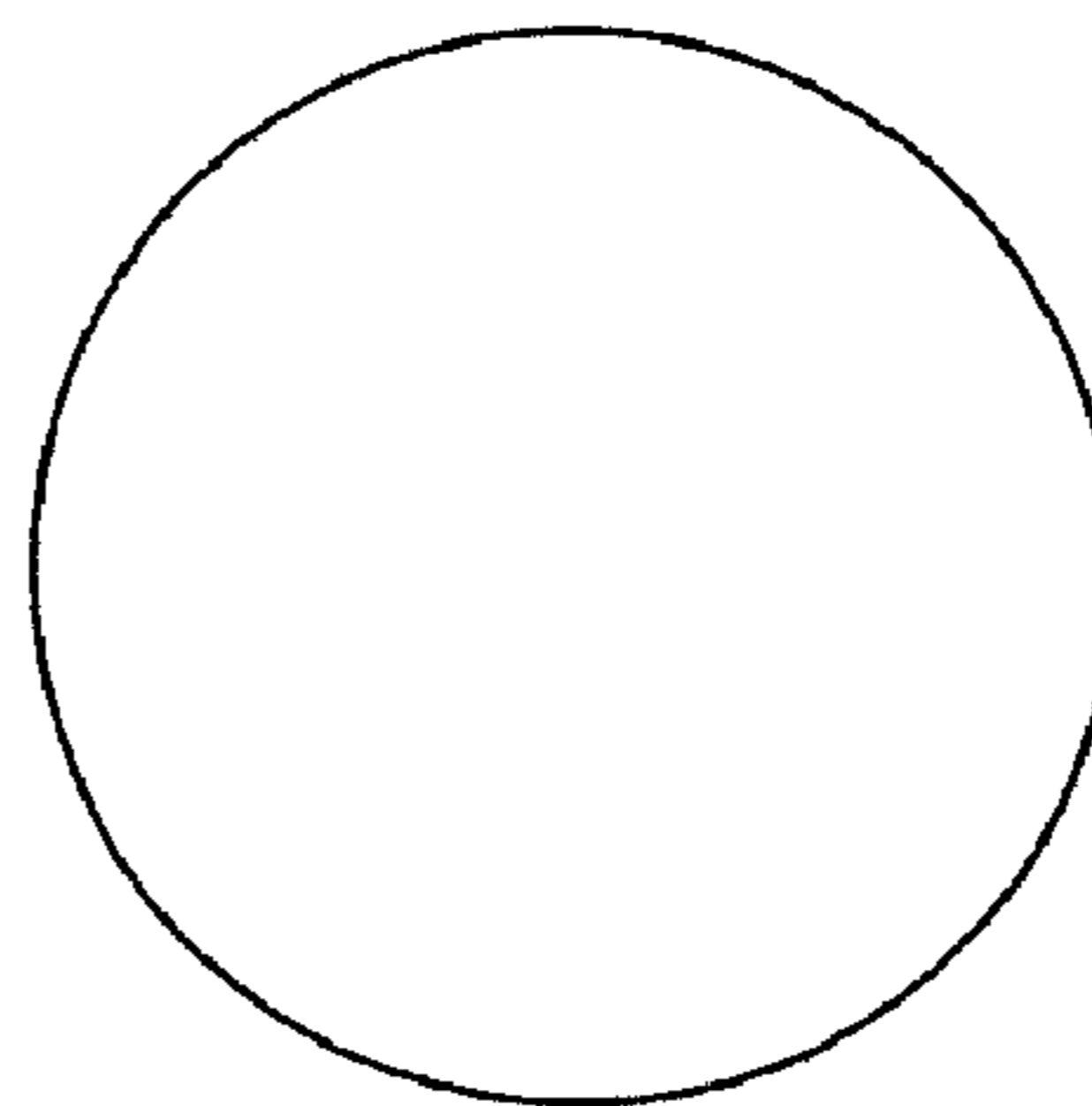

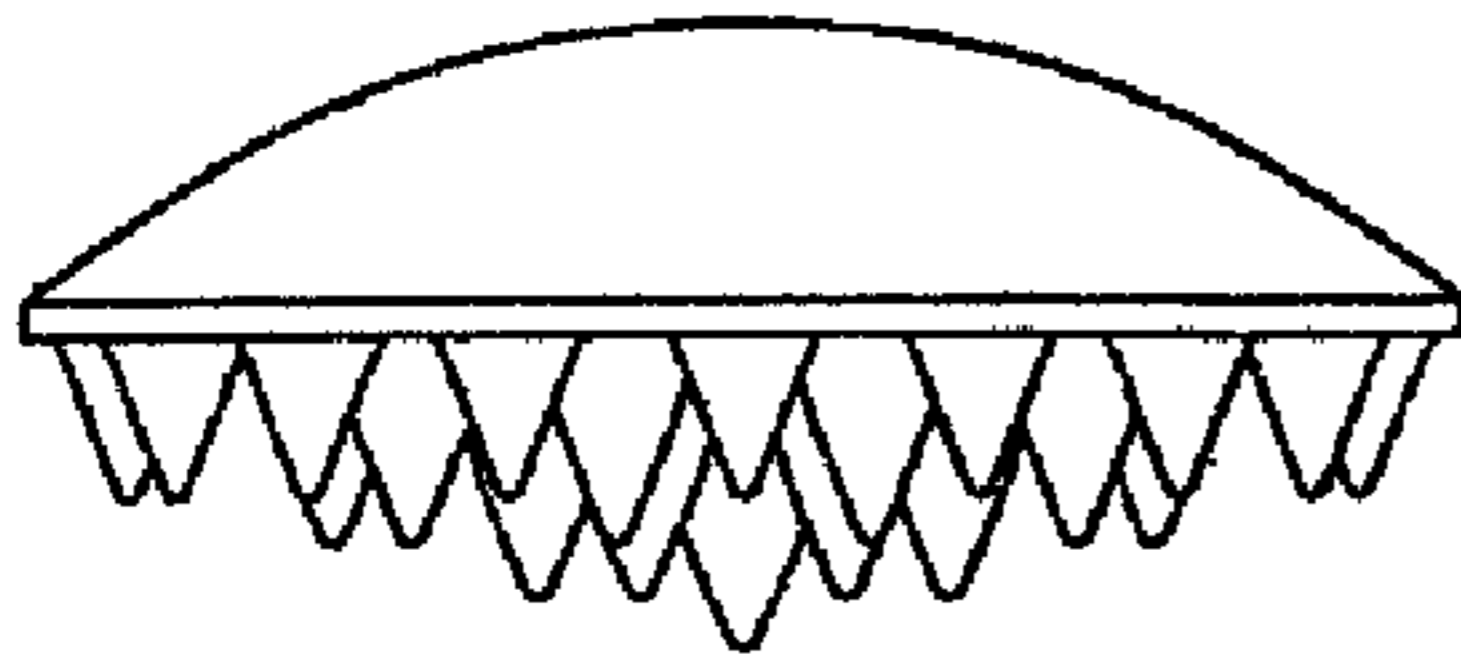

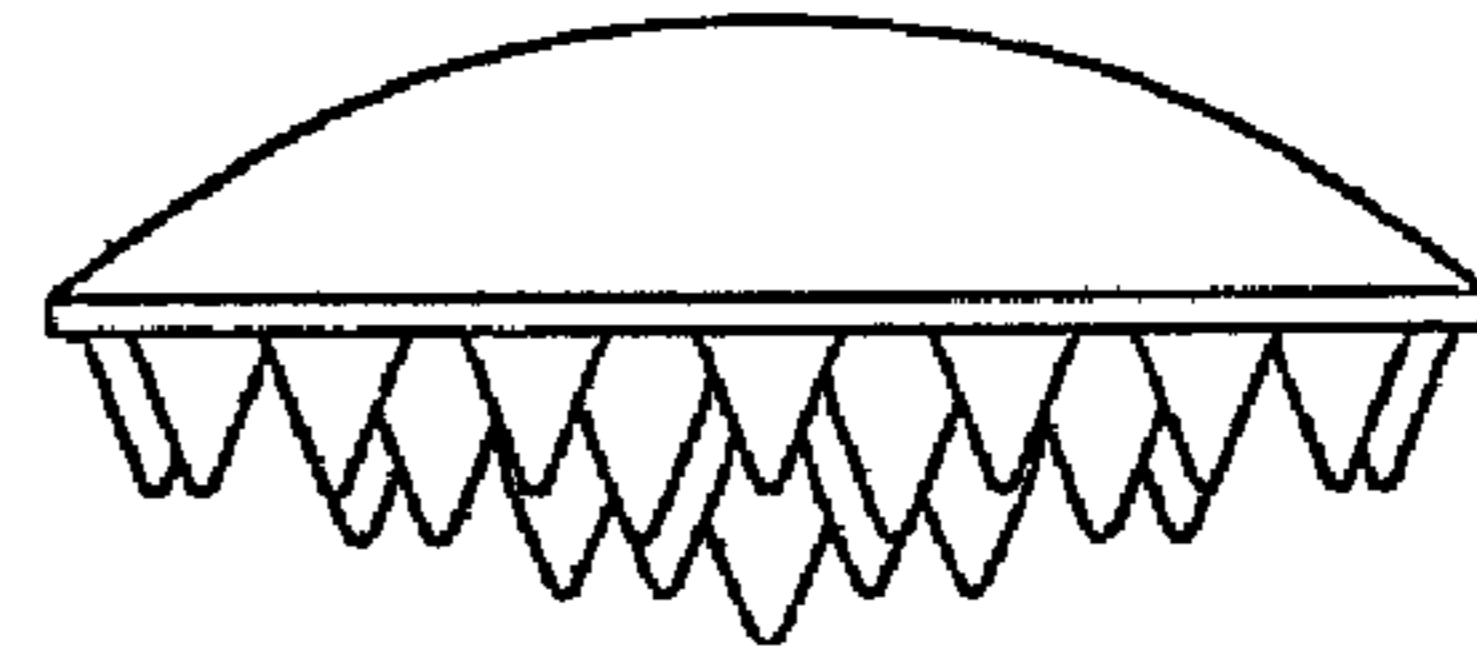

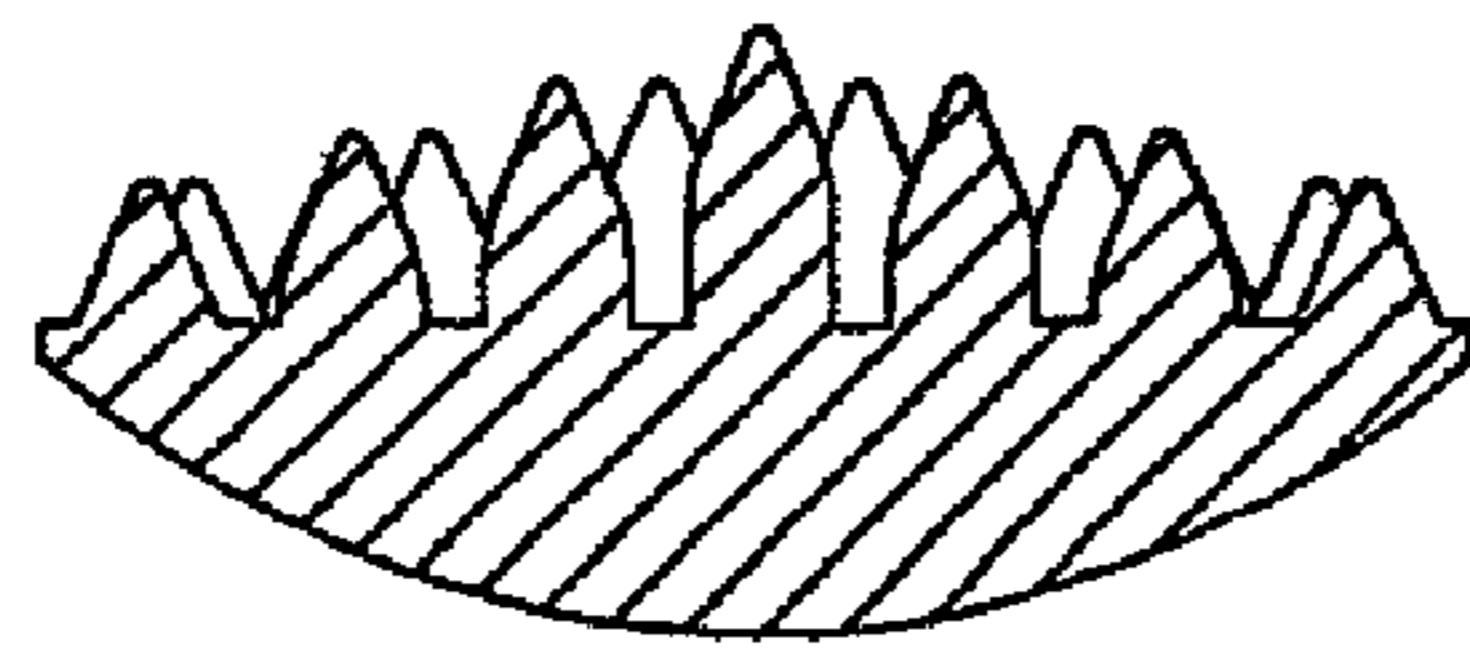
