(57) **CLAIM**

We claim the ornamental design for a store interior with a storefront, as shown and described.

FIG. 1 is a top plan view of the store interior with a storefront showing the store interior with the ceiling removed to reveal details of the design concerning the fixtures of the store.

FIG. 2 is a rear elevational view of showing a wall of the store interior of the store interior with a storefront.

FIG. 3 is a right side elevational view showing a wall of the store interior of the store interior with a storefront.

FIG. 4 is a left side view elevational view showing a wall of the store interior of the store interior with a storefront.

FIG. 5 is an exterior front elevational view of the store front leading to the store interior of the store interior with a storefront (The P Payless Shoesource and the logo forming part of the claimed design is a registered trademark of Payless Shoe-source Worldwide, Inc.).

FIG. 6 is a bottom view of the store interior showing the ceiling of the store of the interior with a storefront.

FIG. 7 is a left front perspective view of the store interior of the store interior with a storefront.

FIG. 8 is a right front perspective view of the store interior of the store interior with a storefront.

FIG. 9 is a left rear perspective view showing the store interior of the store interior with a storefront.

FIG. 10 is a right rear perspective view of the store interior of the store interior with a storefront; and,

FIG. 11 is a rear interior view of the front of the store of the store interior with a storefront.

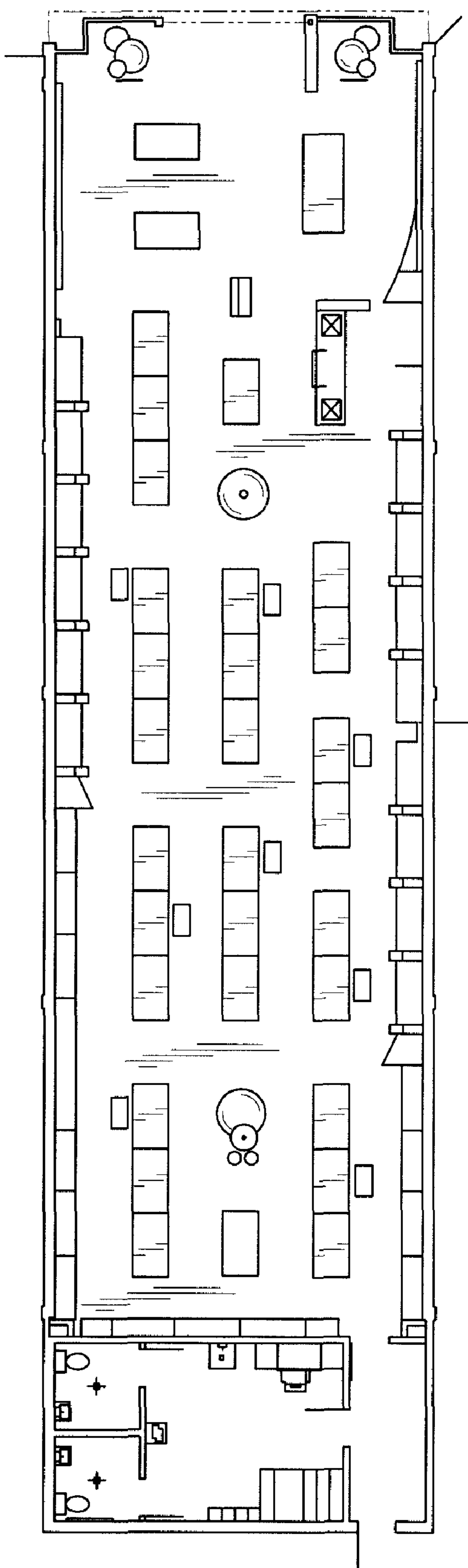

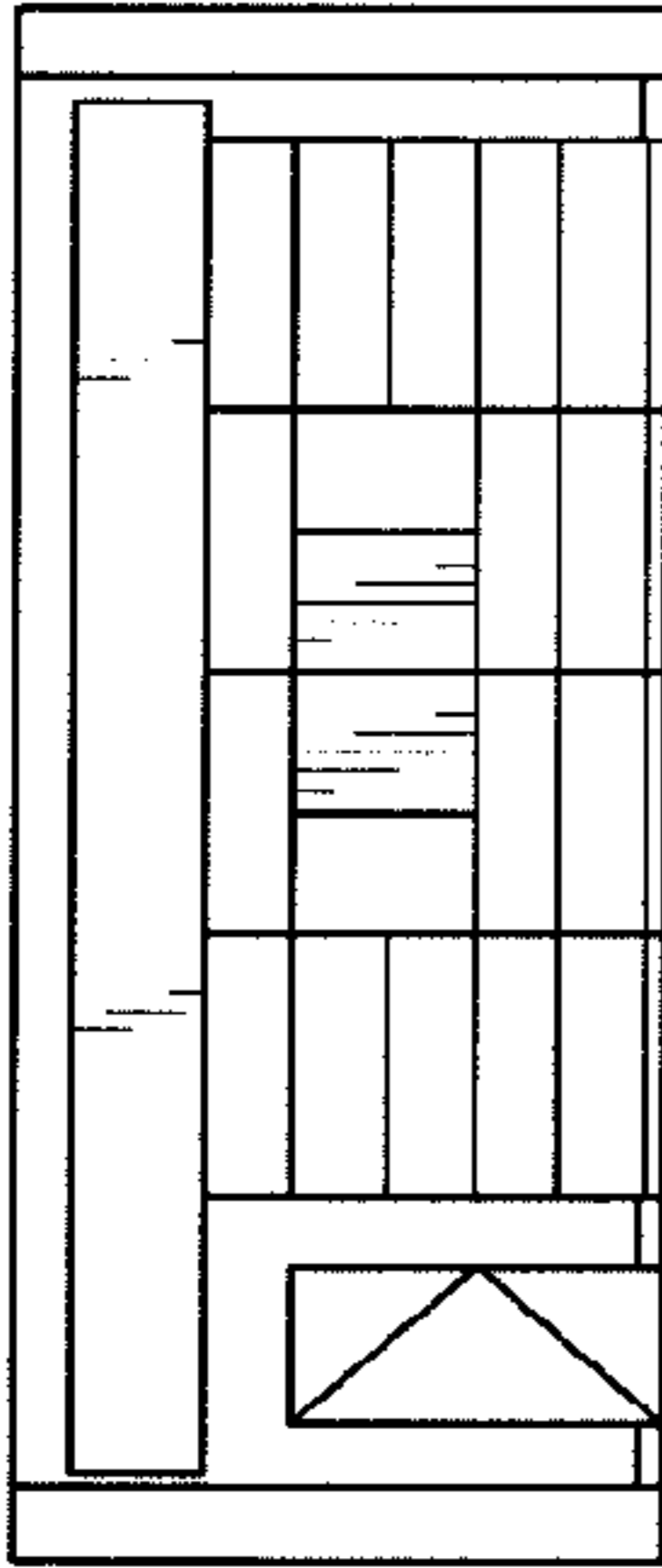

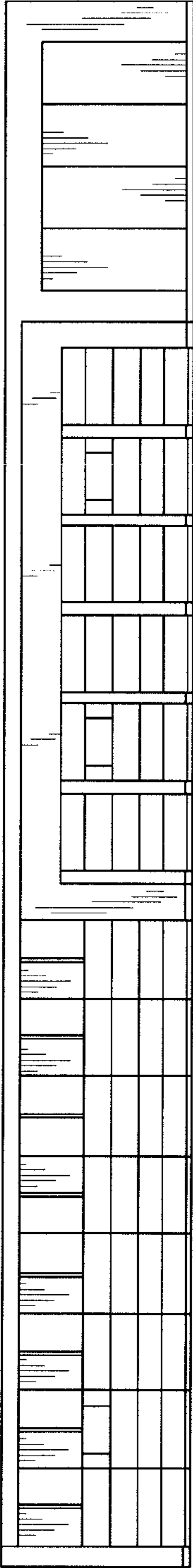
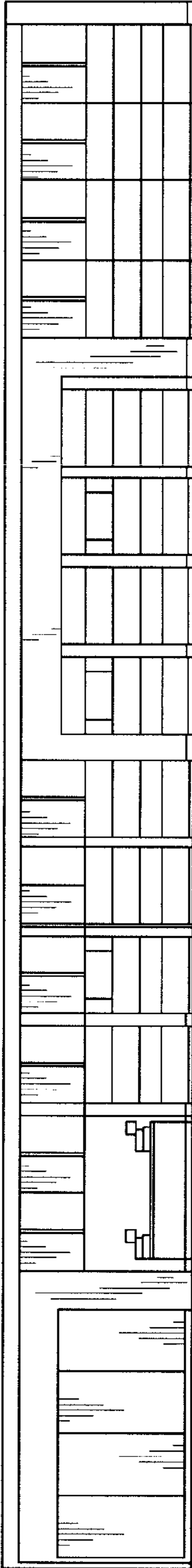

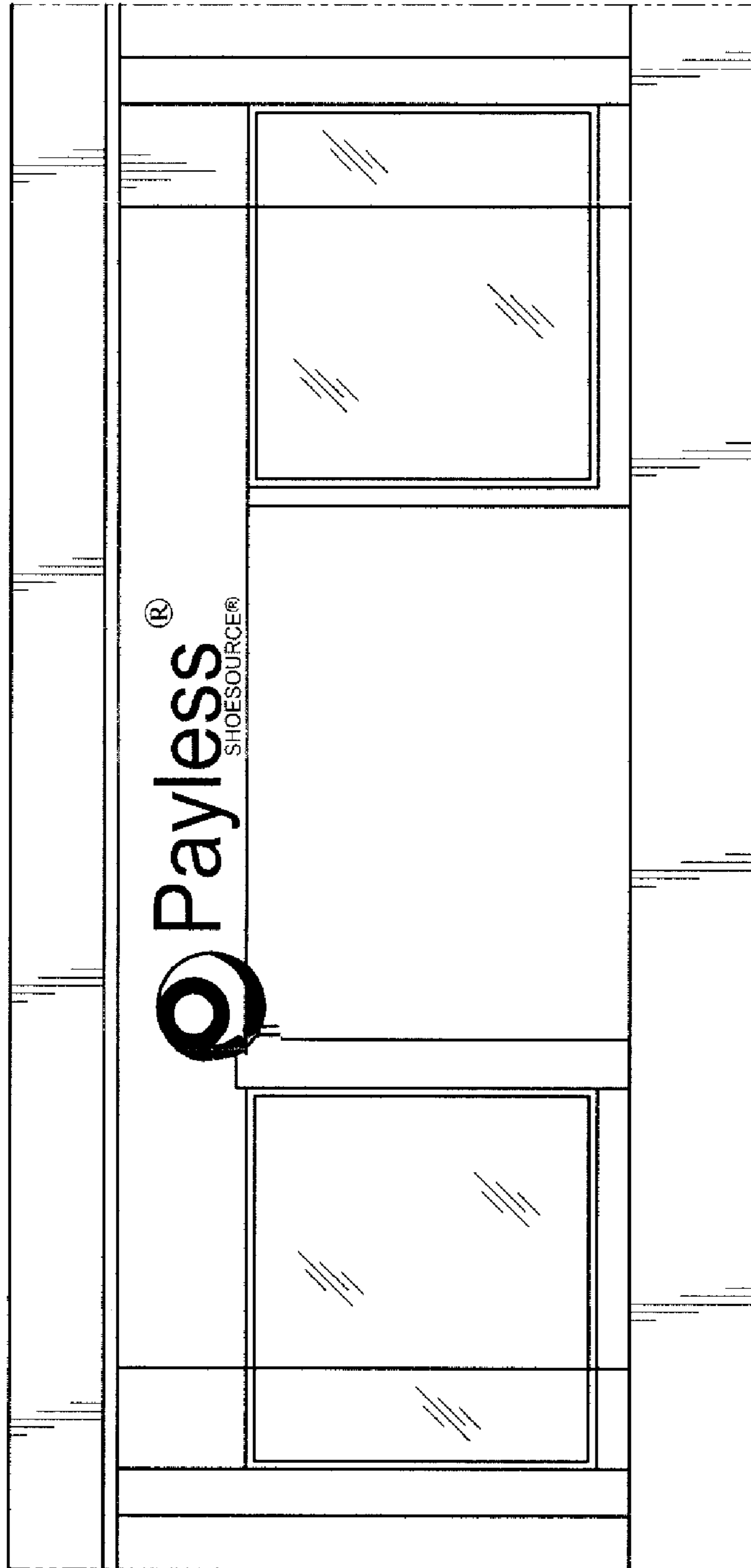

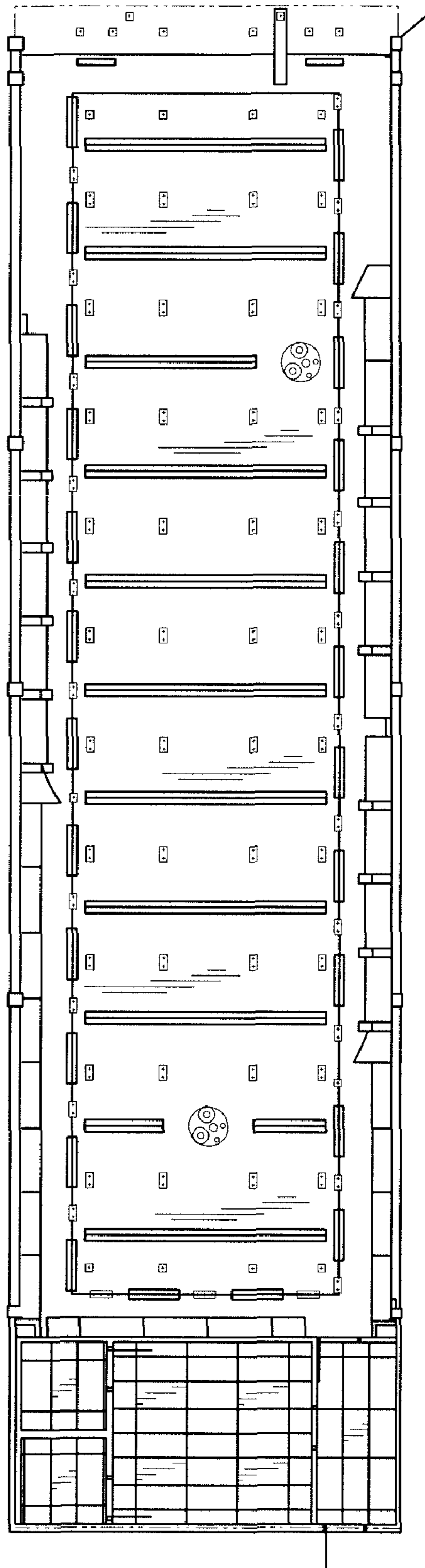

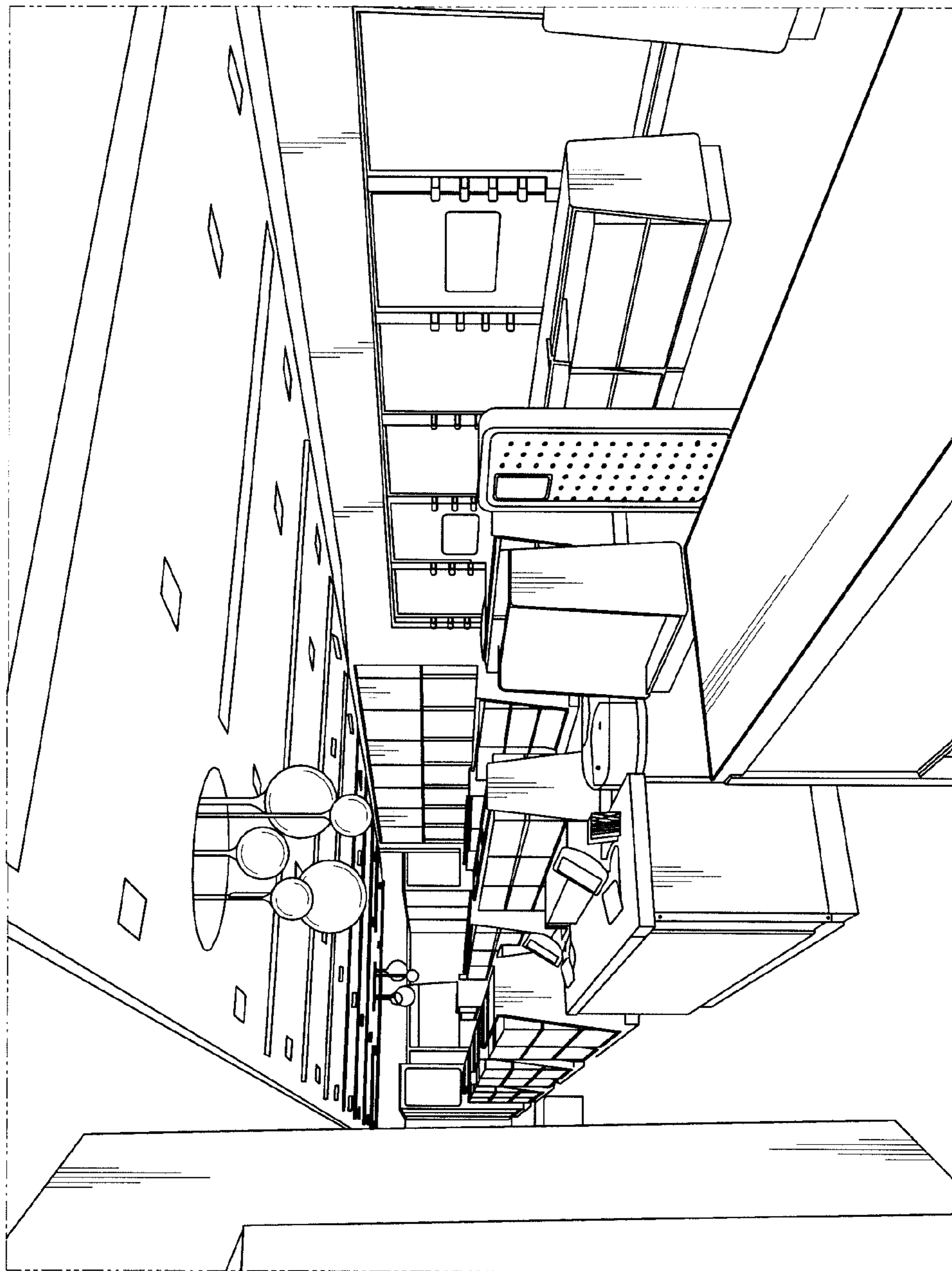

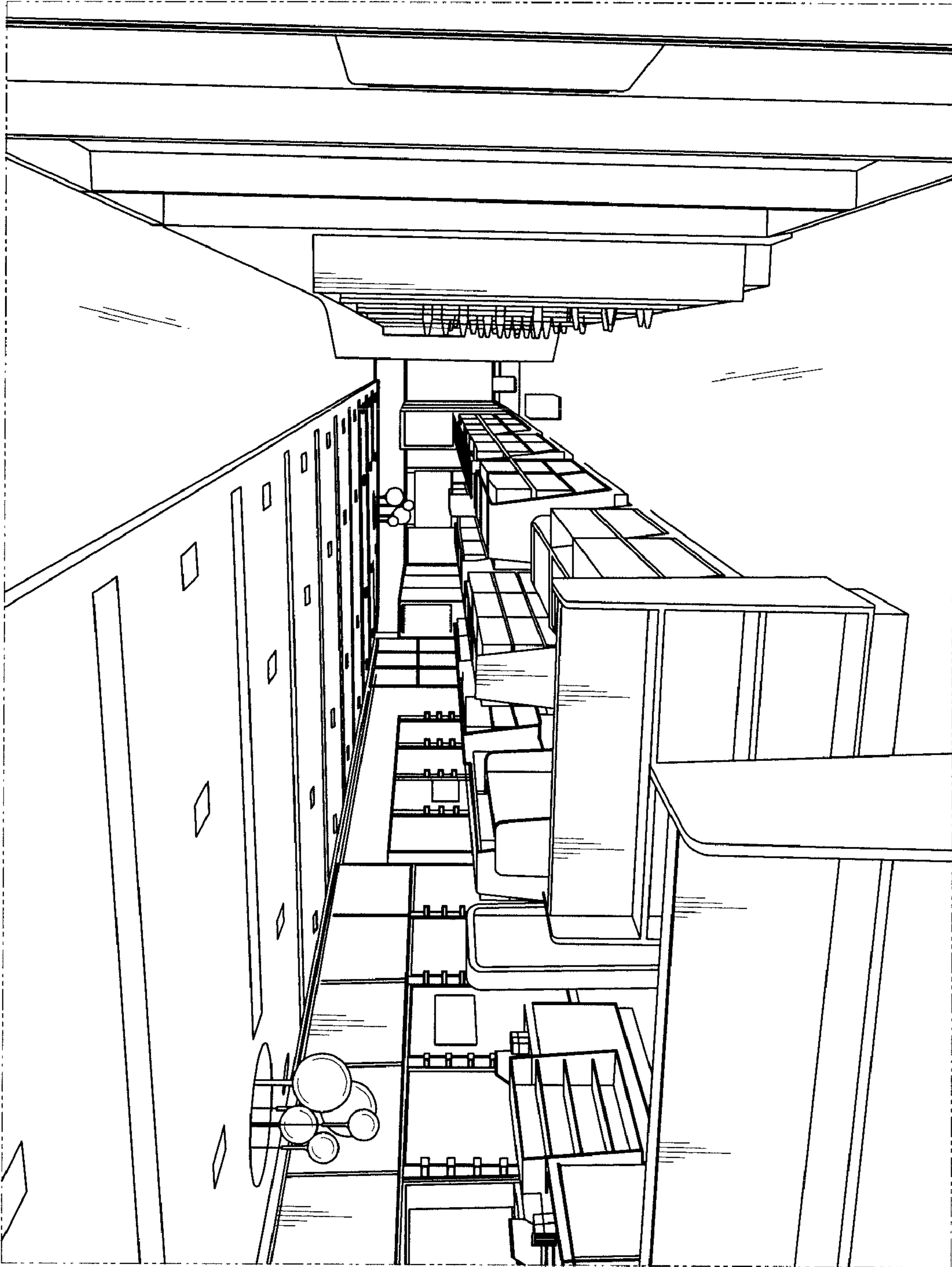

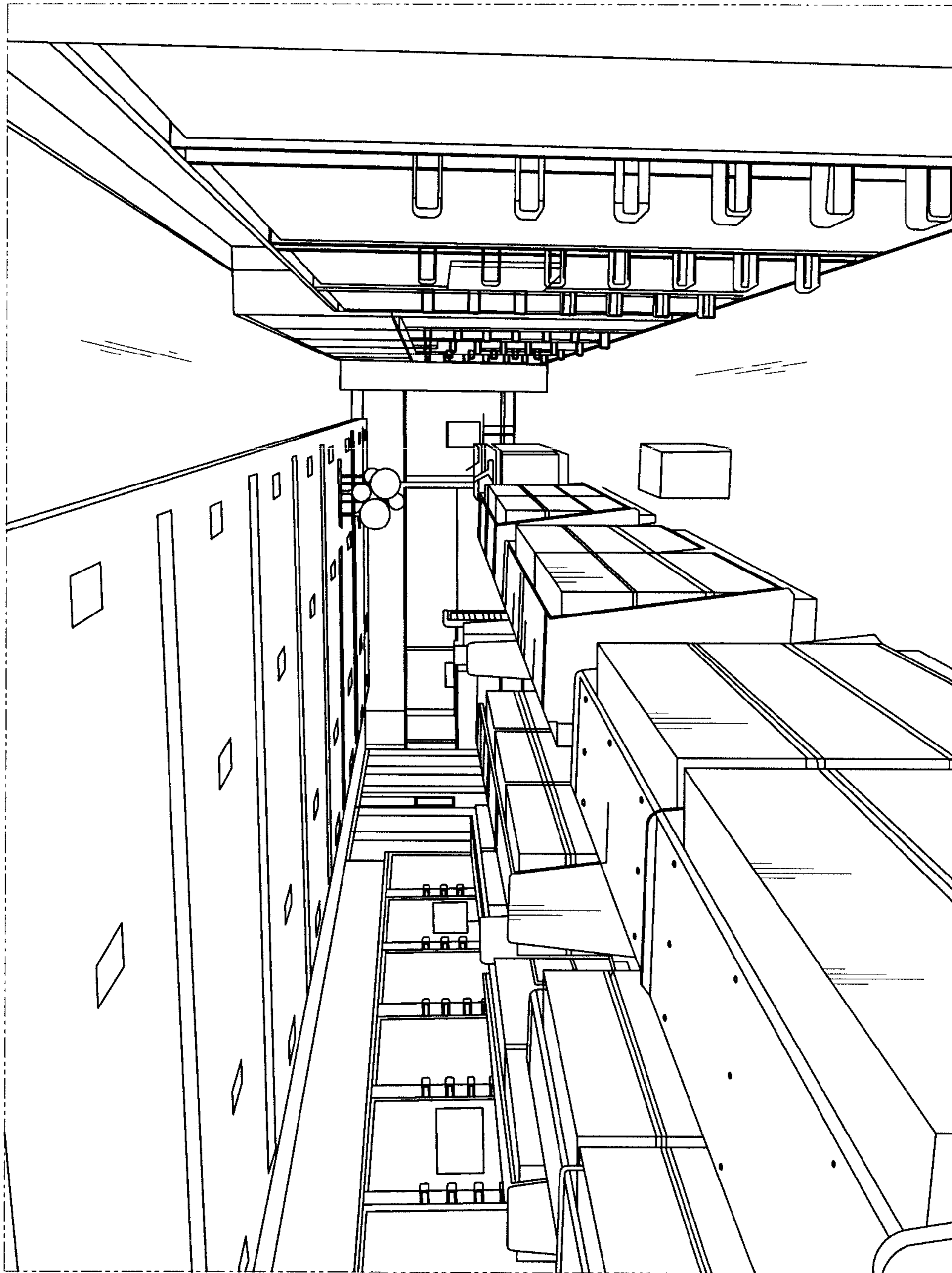

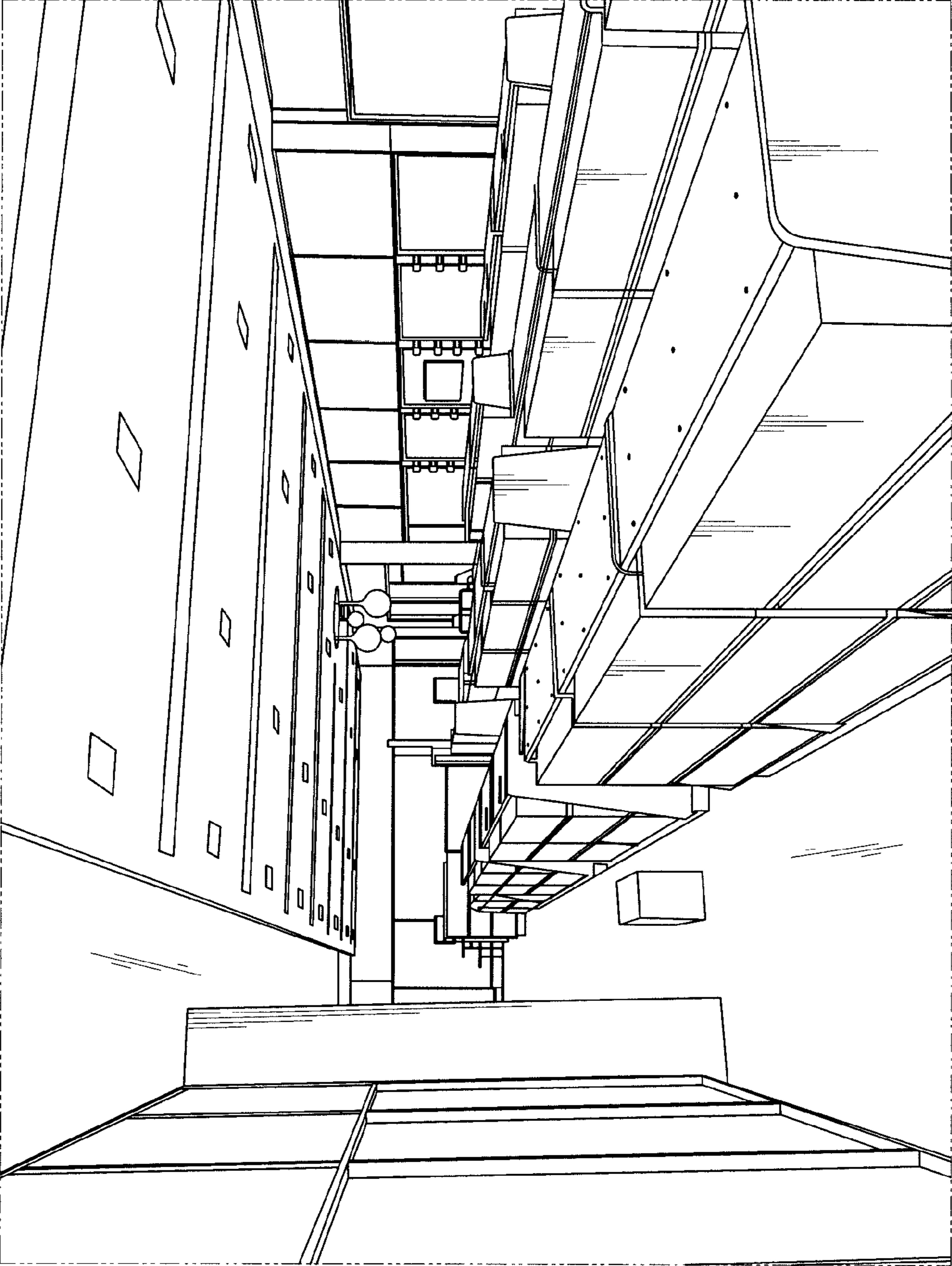

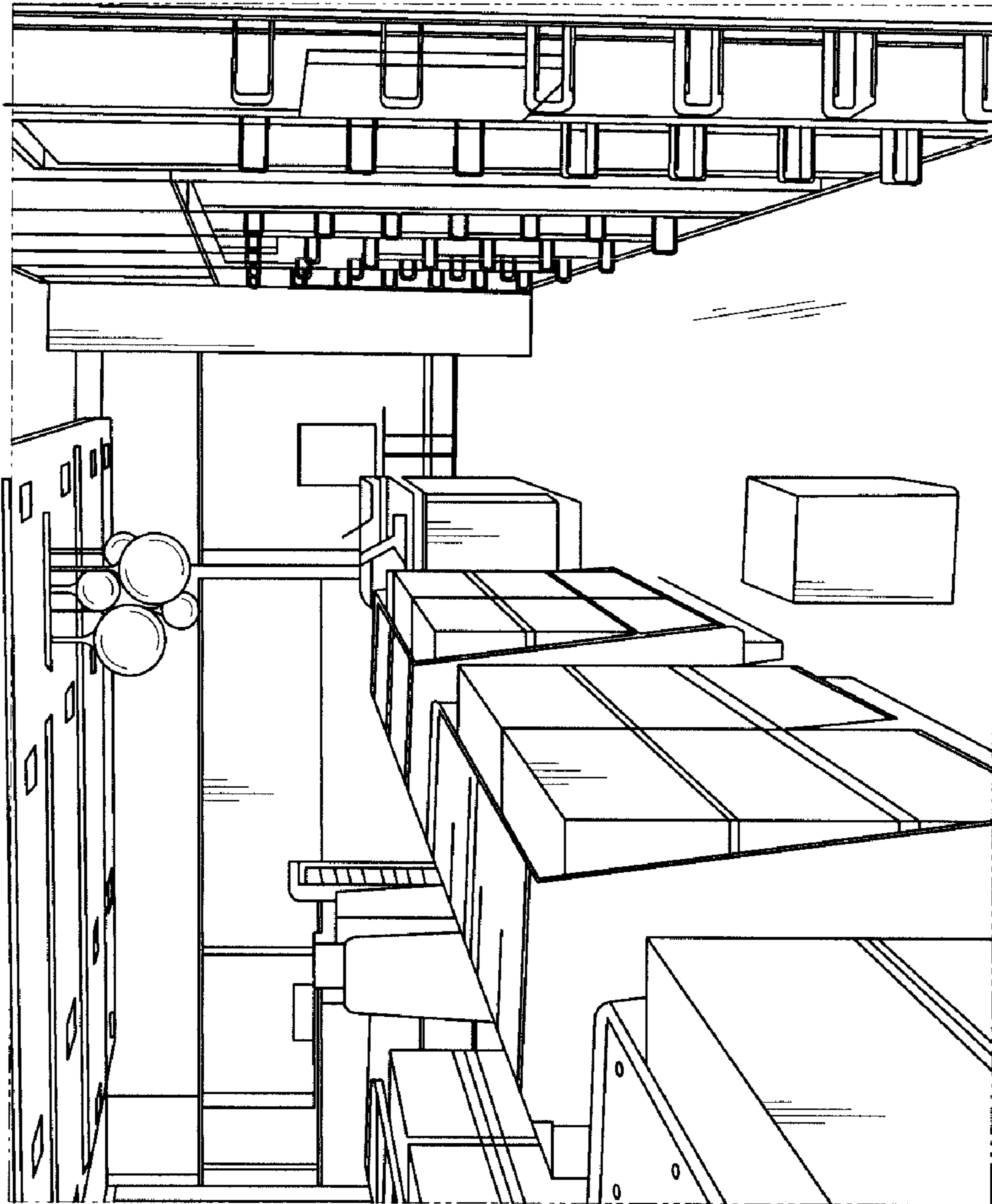
