The ornamental design for a portable lamp, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a portable lamp showing my new design;

FIG. 2 is a rear side view of the portable lamp shown in FIG. 1;

FIG. 3 is a top view of the portable lamp depicted in FIG. 1; FIG. 4 is a bottom view of a portable lamp depicted in FIG. 1; FIG. 5 is a left side elevational view of the portable lamp shown in FIG. 1;

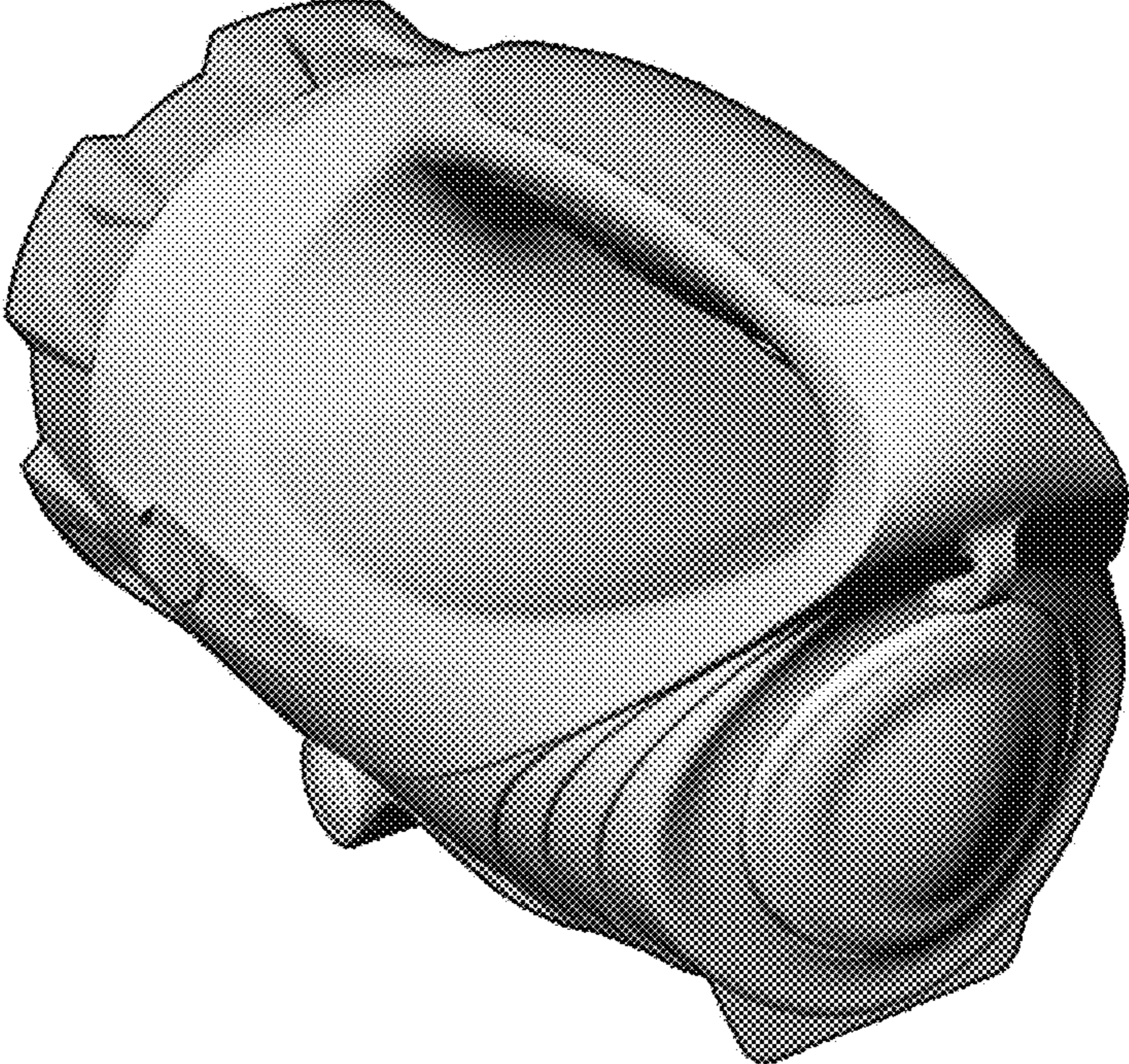

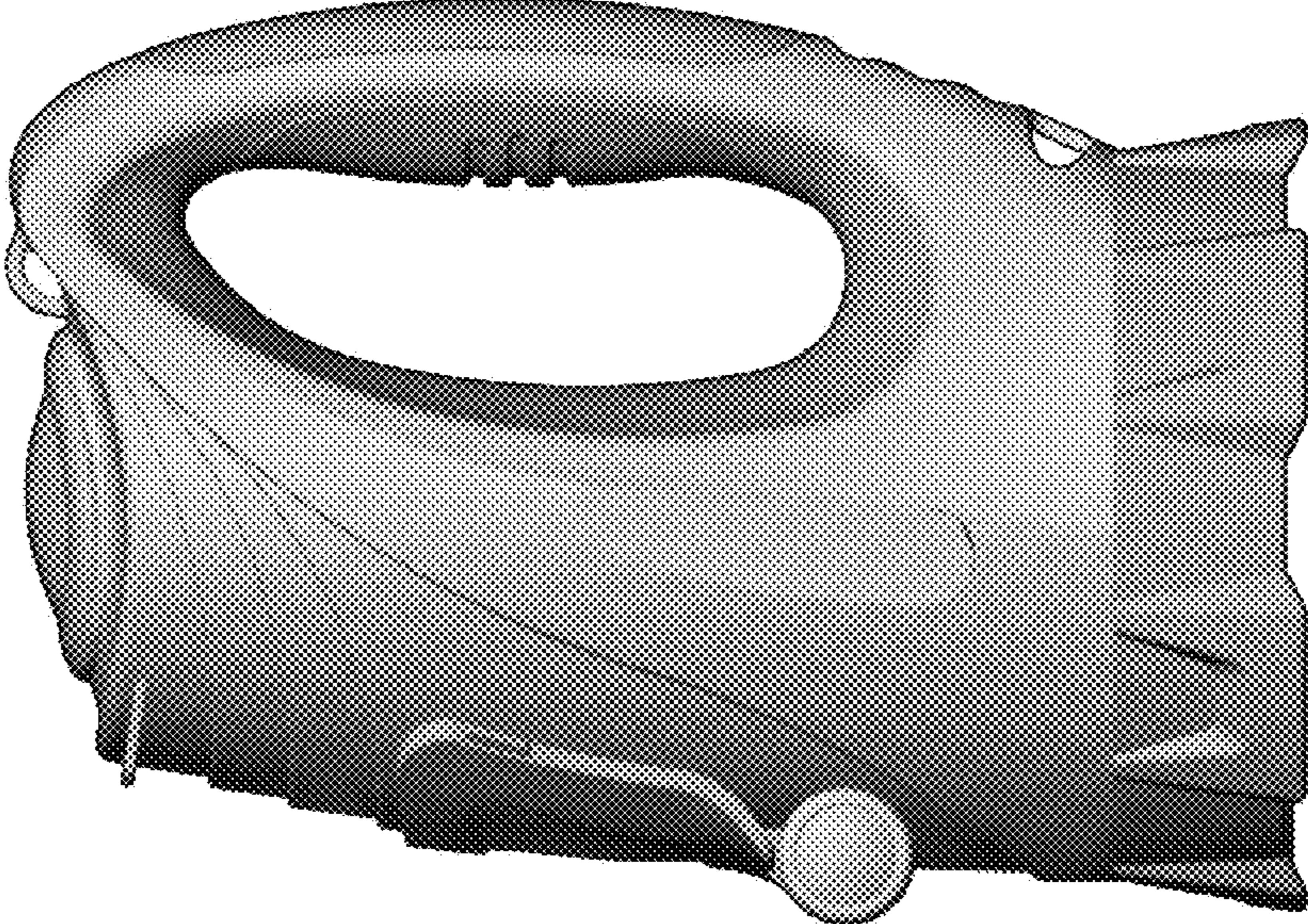

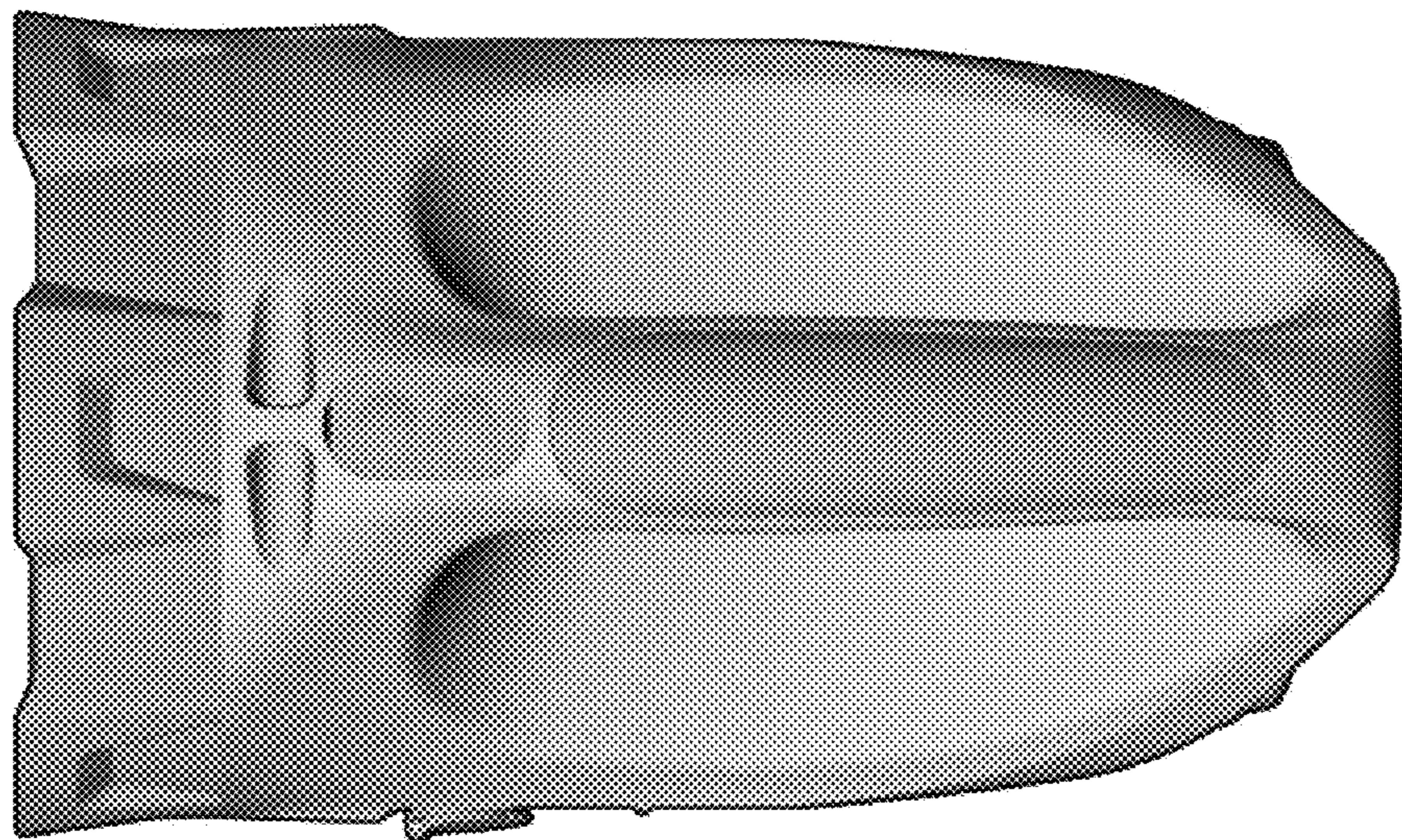

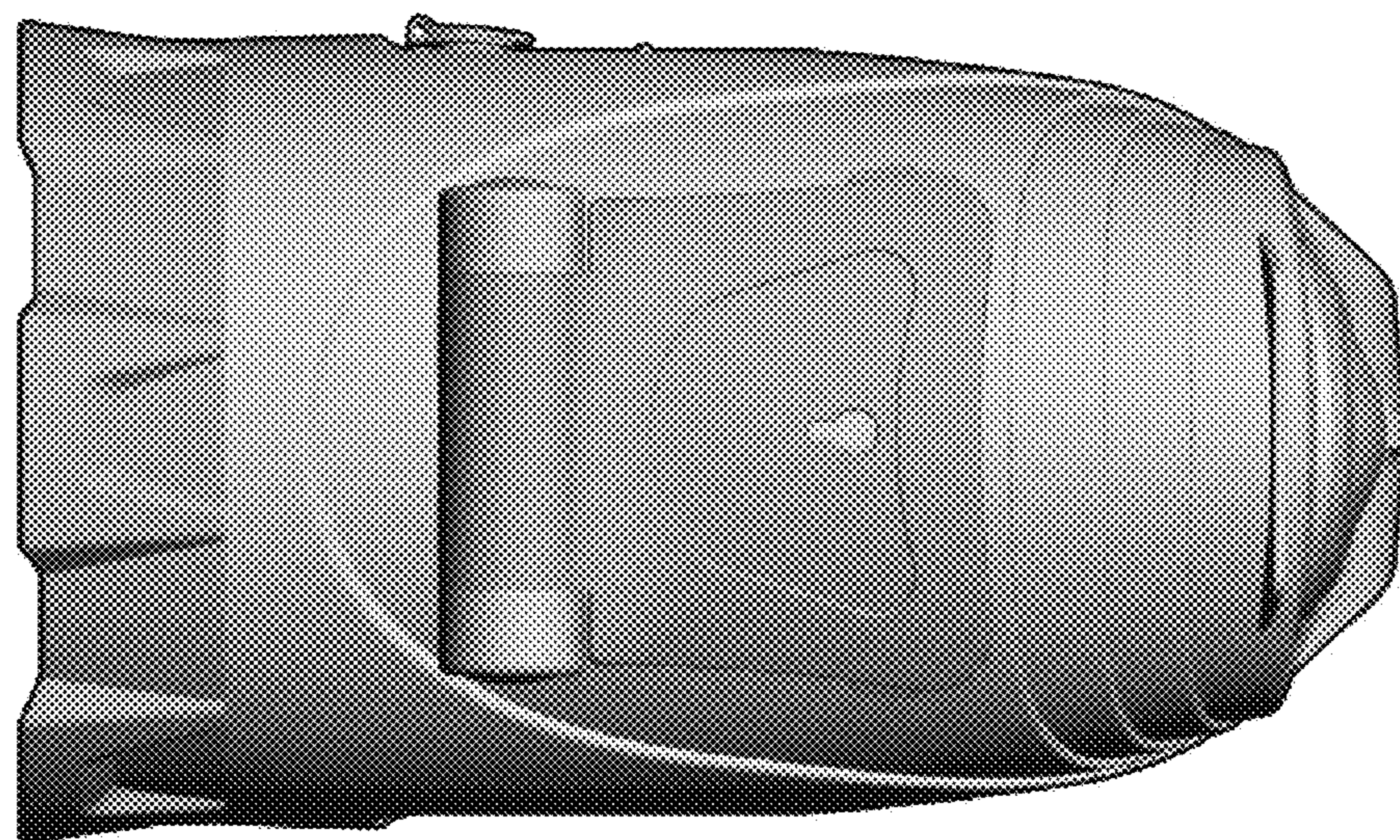

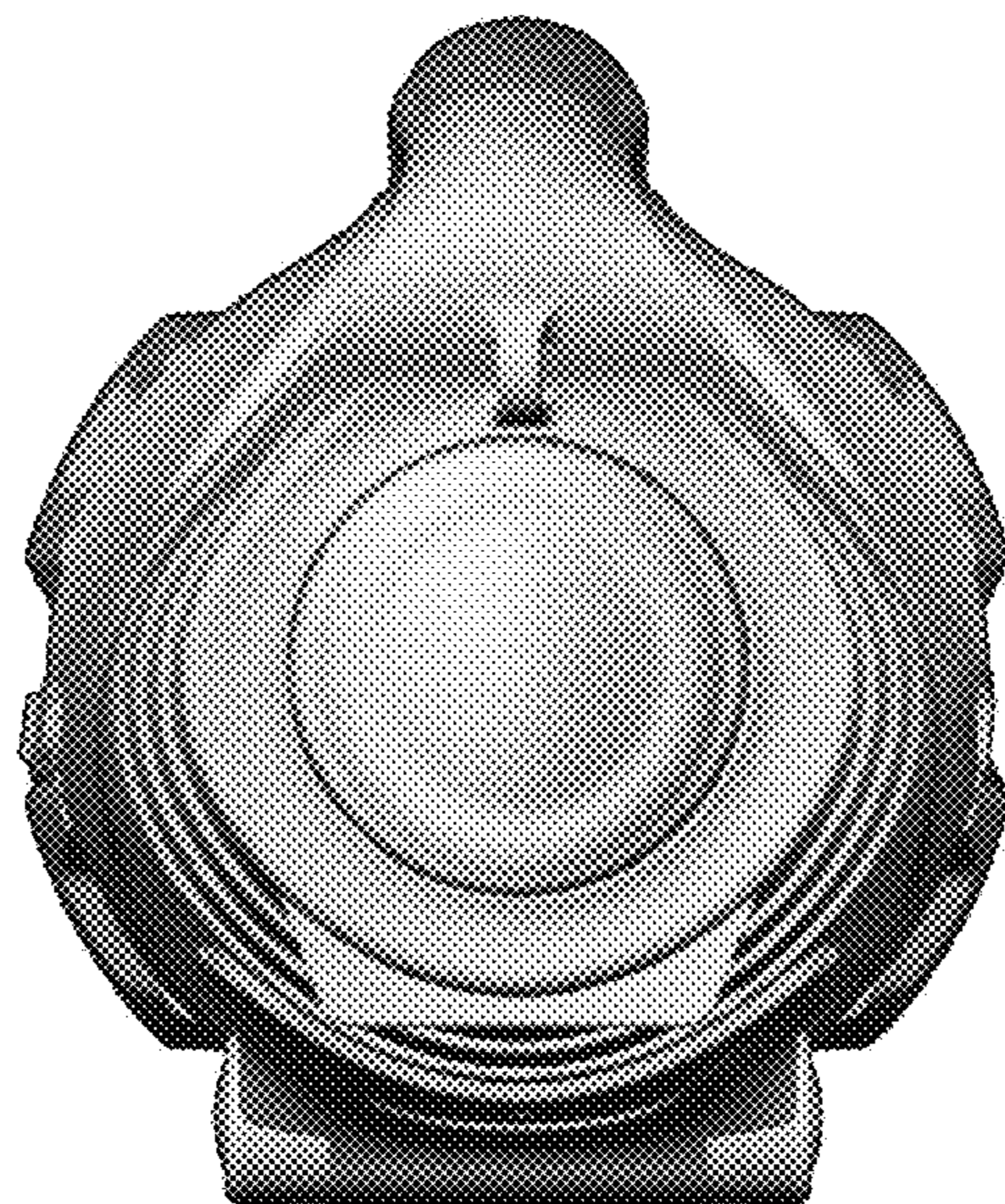

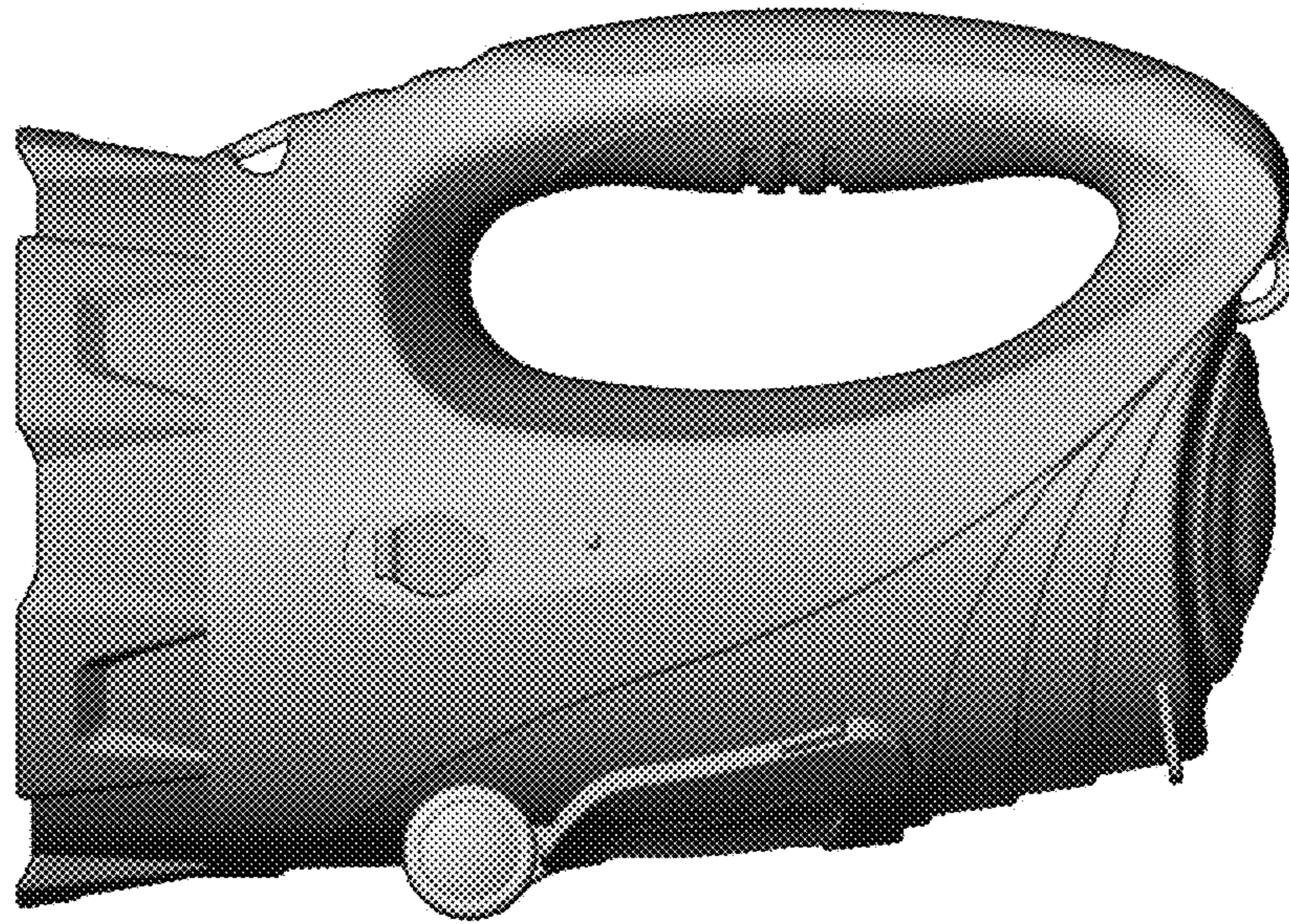

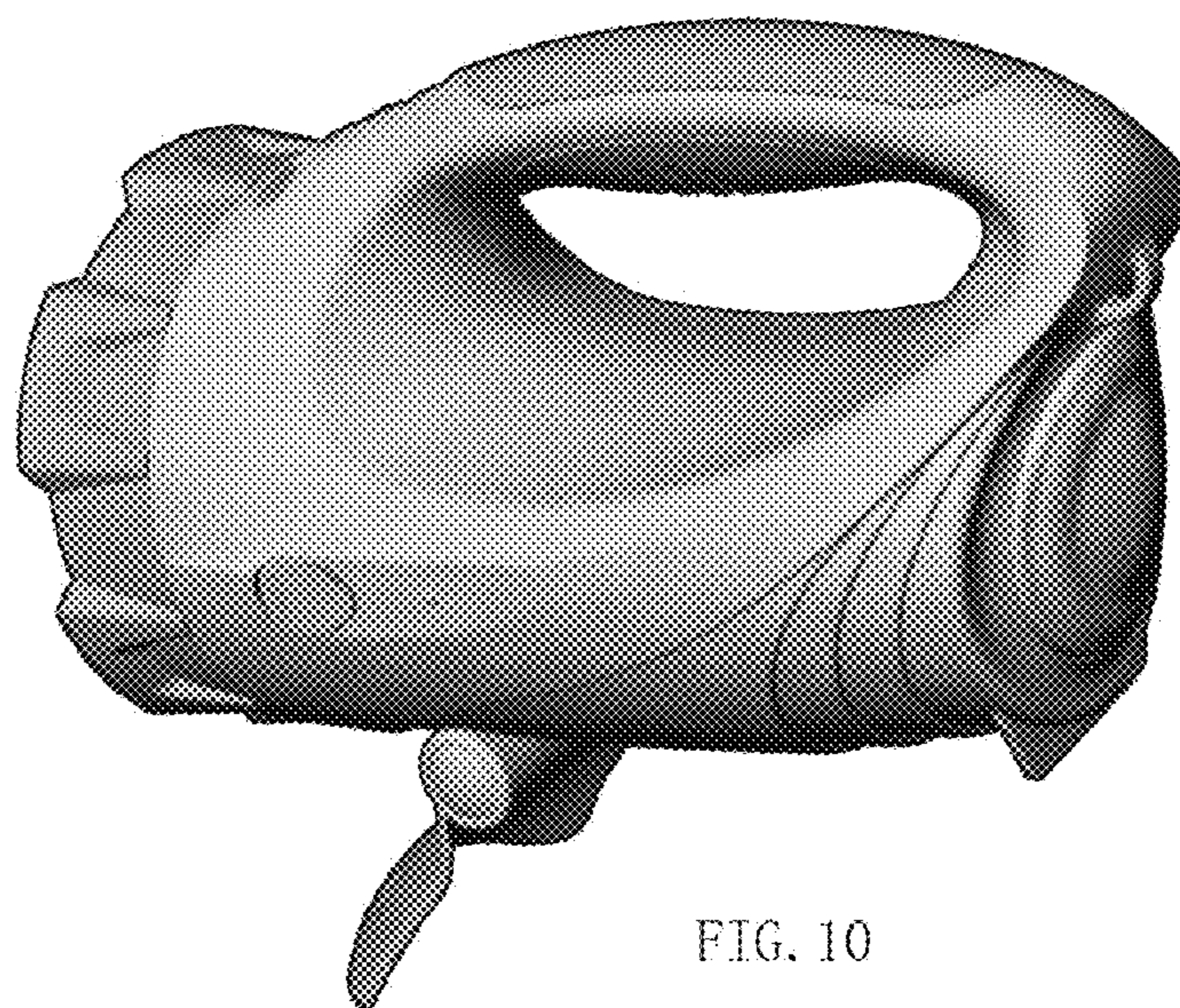
