FIG. 4 is a left side view of my design;

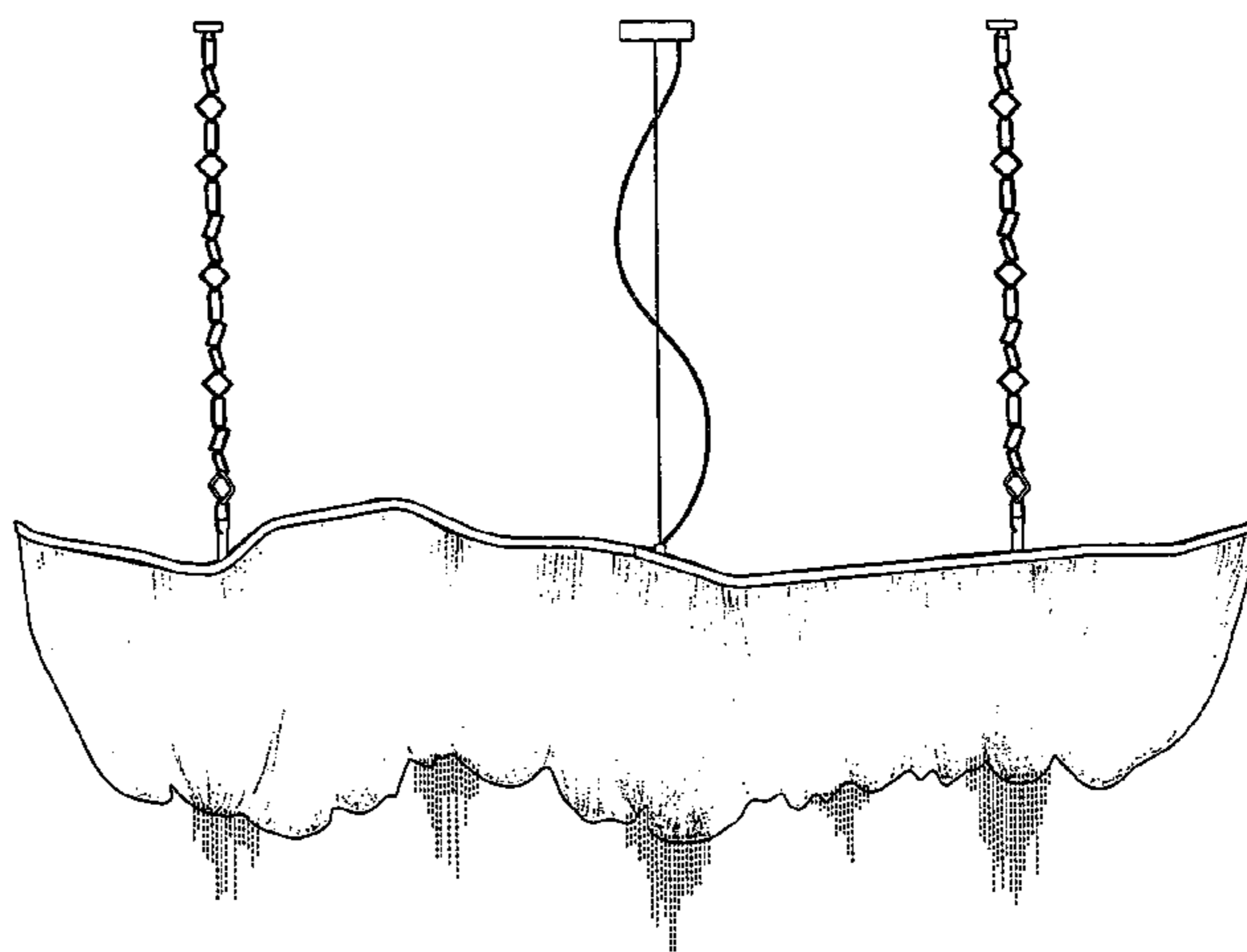
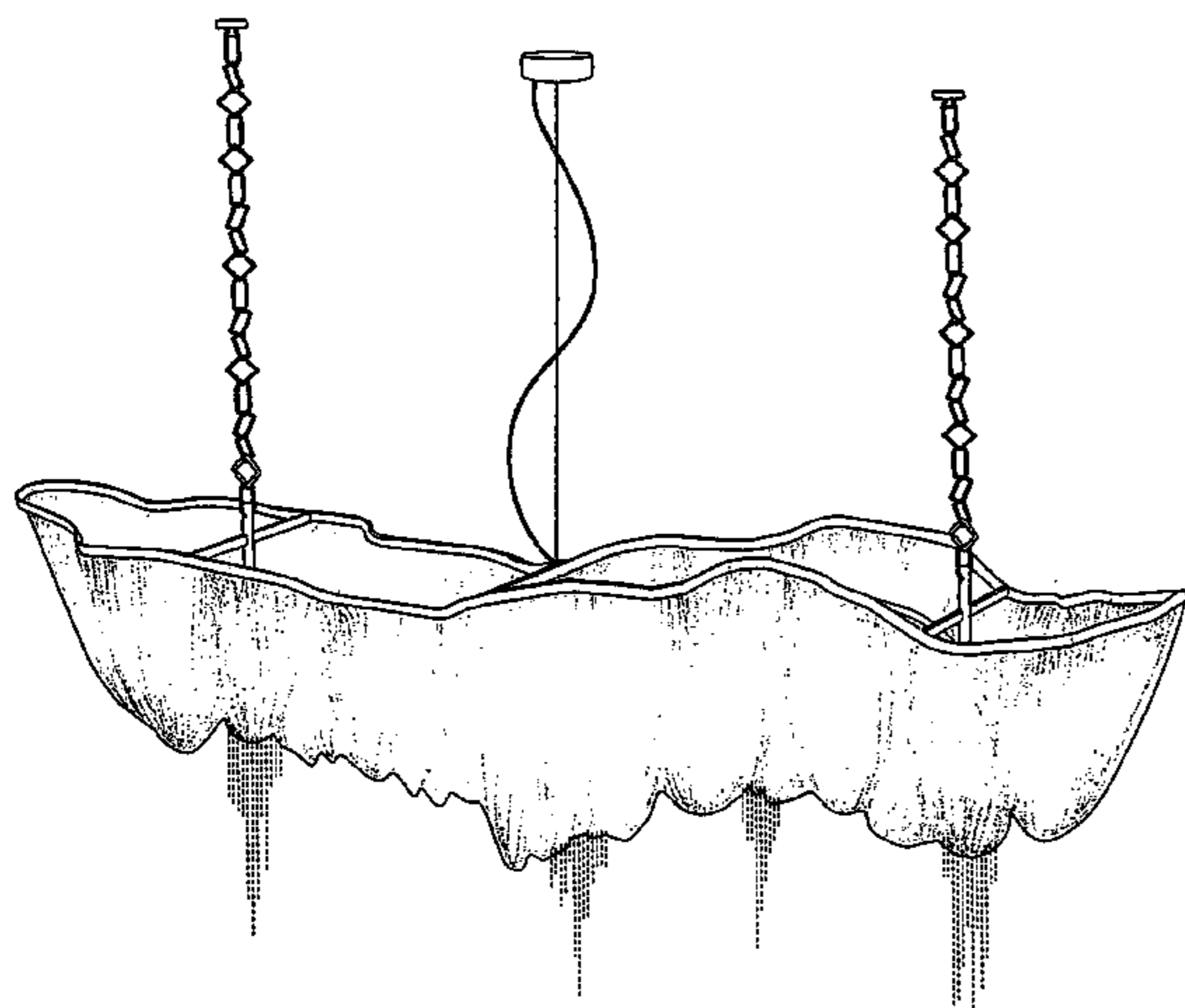
FIG. 5 is a right side view of my design;

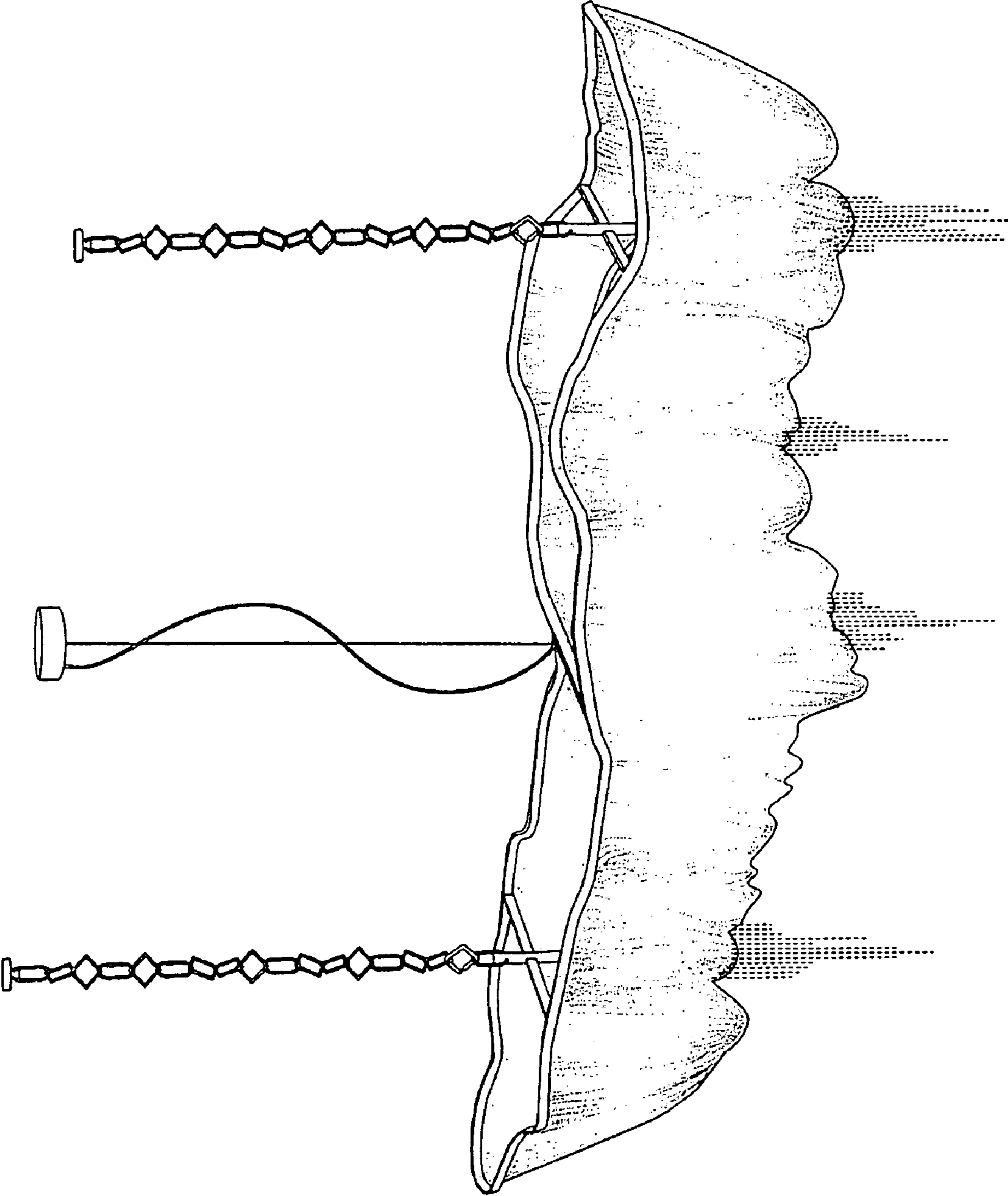

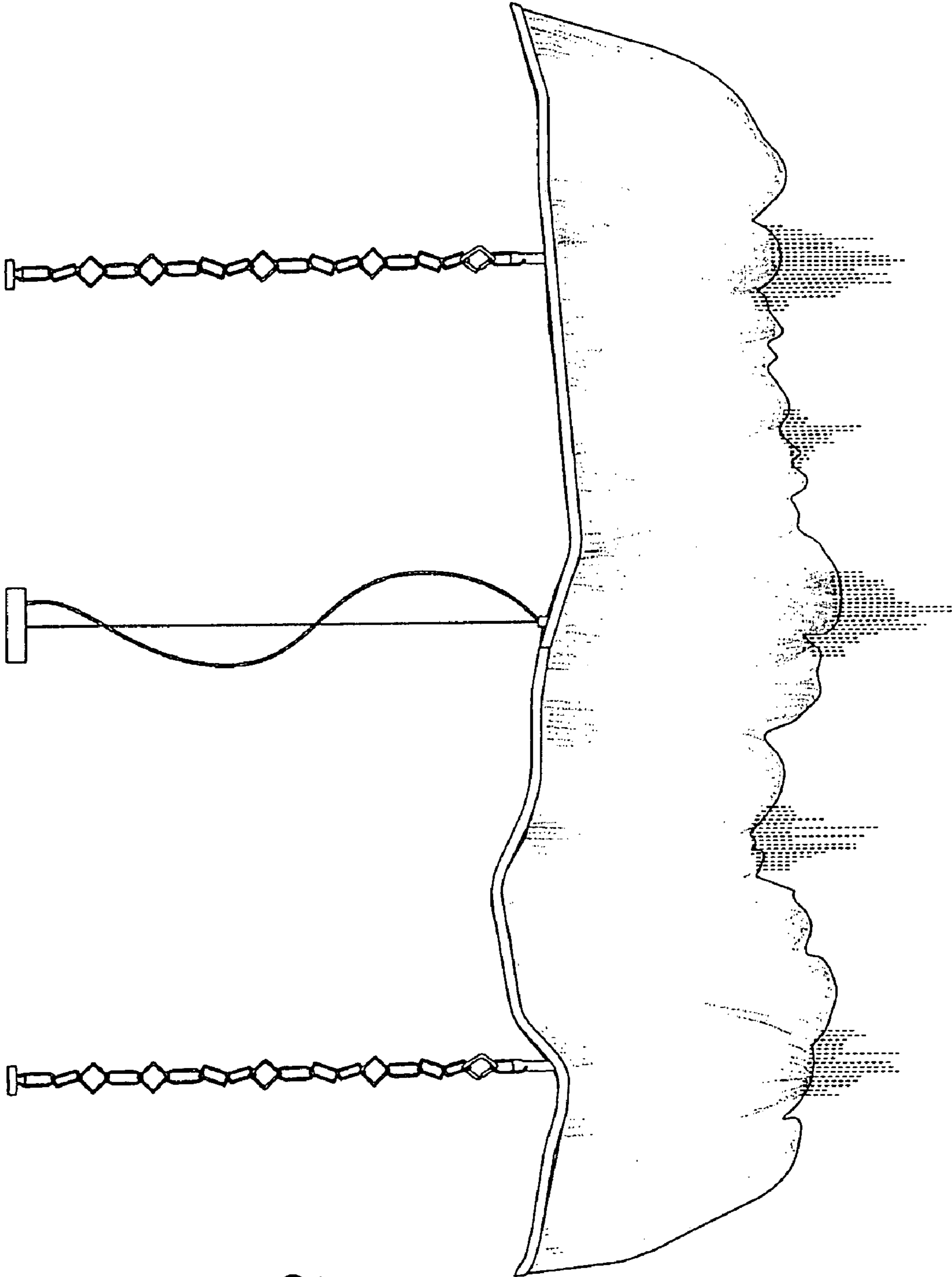

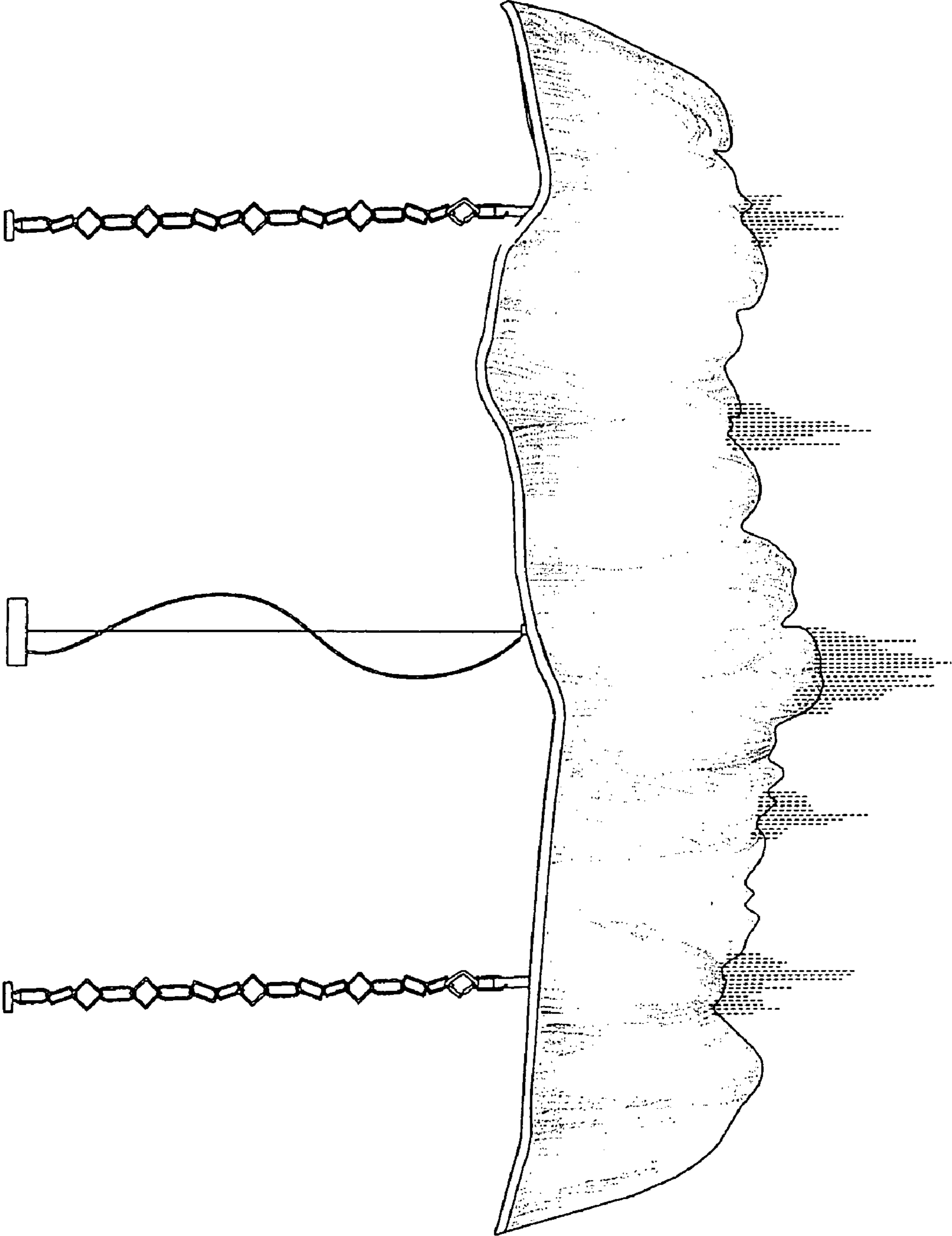

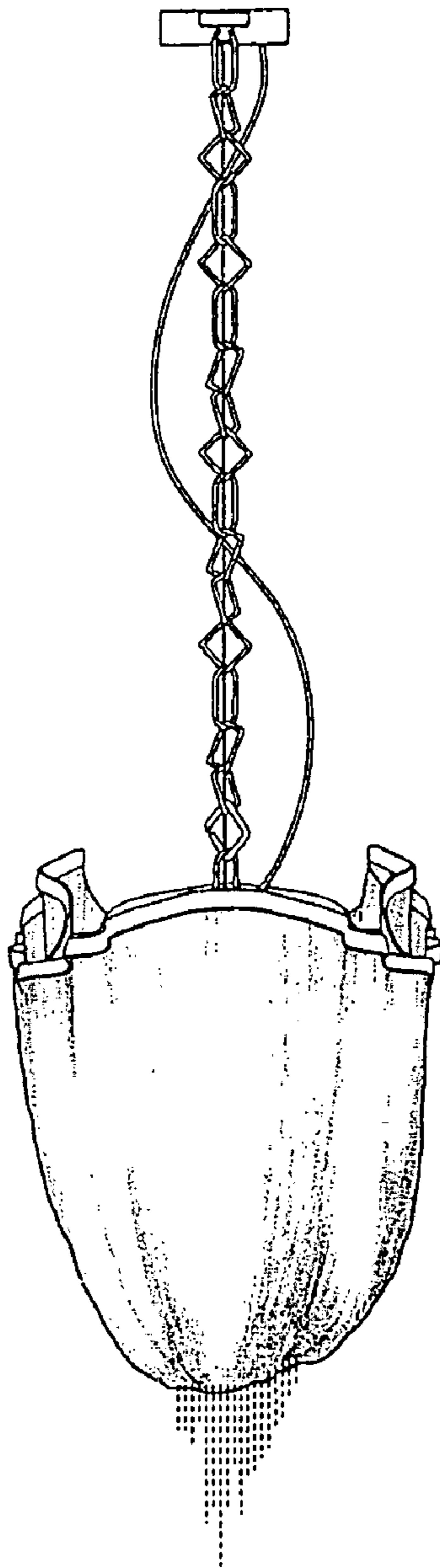
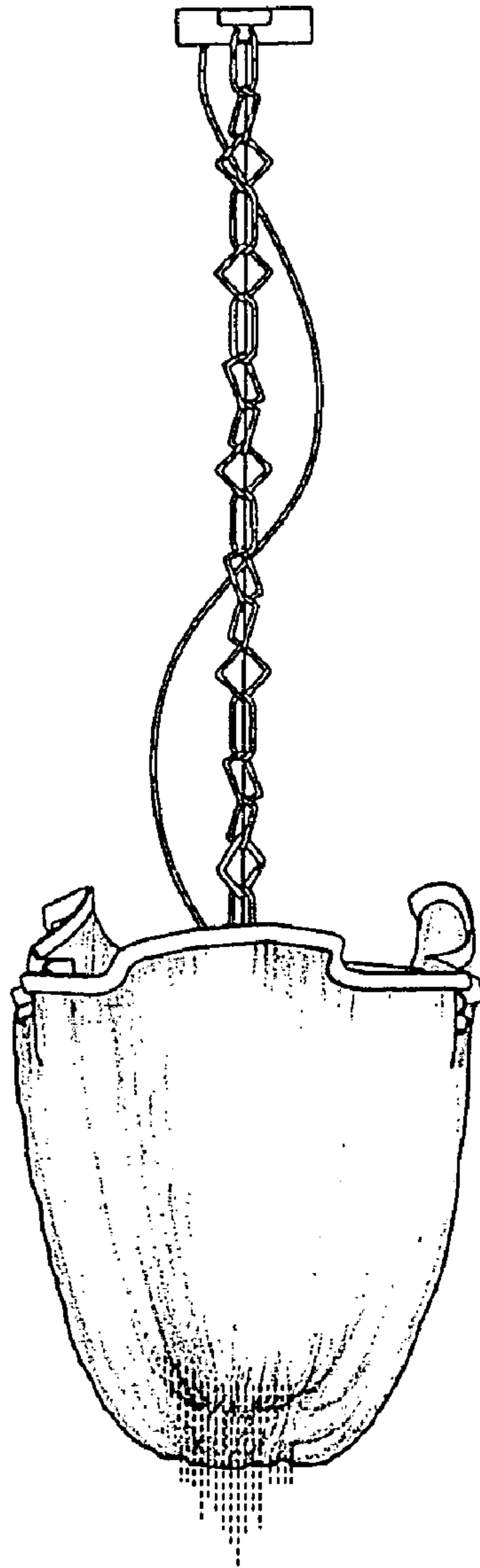

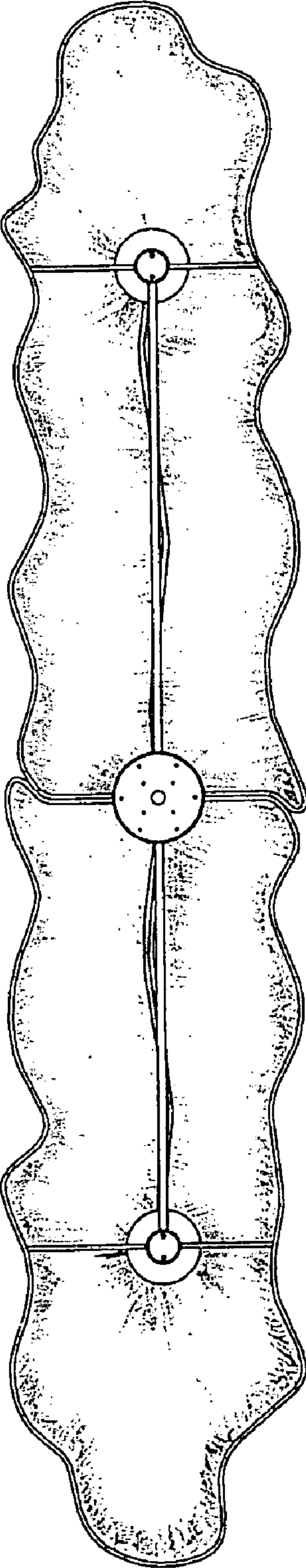

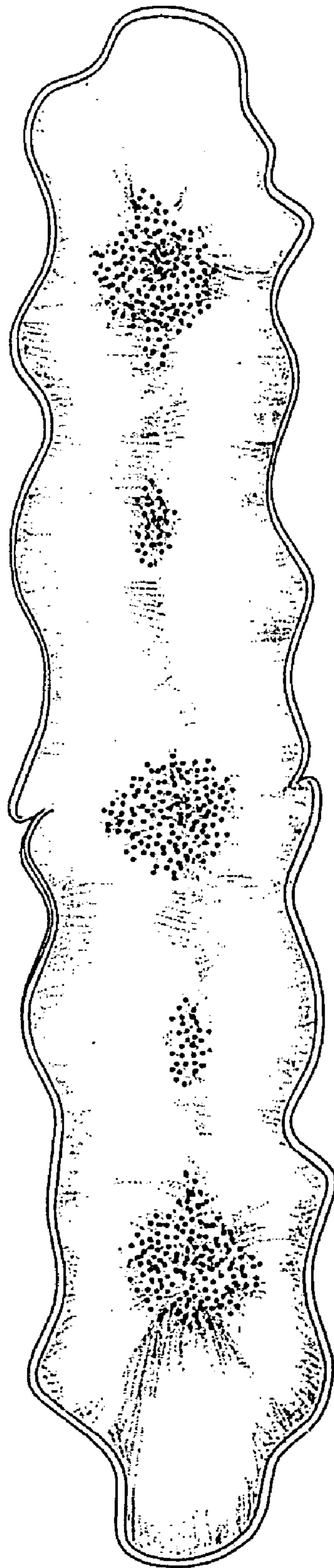
