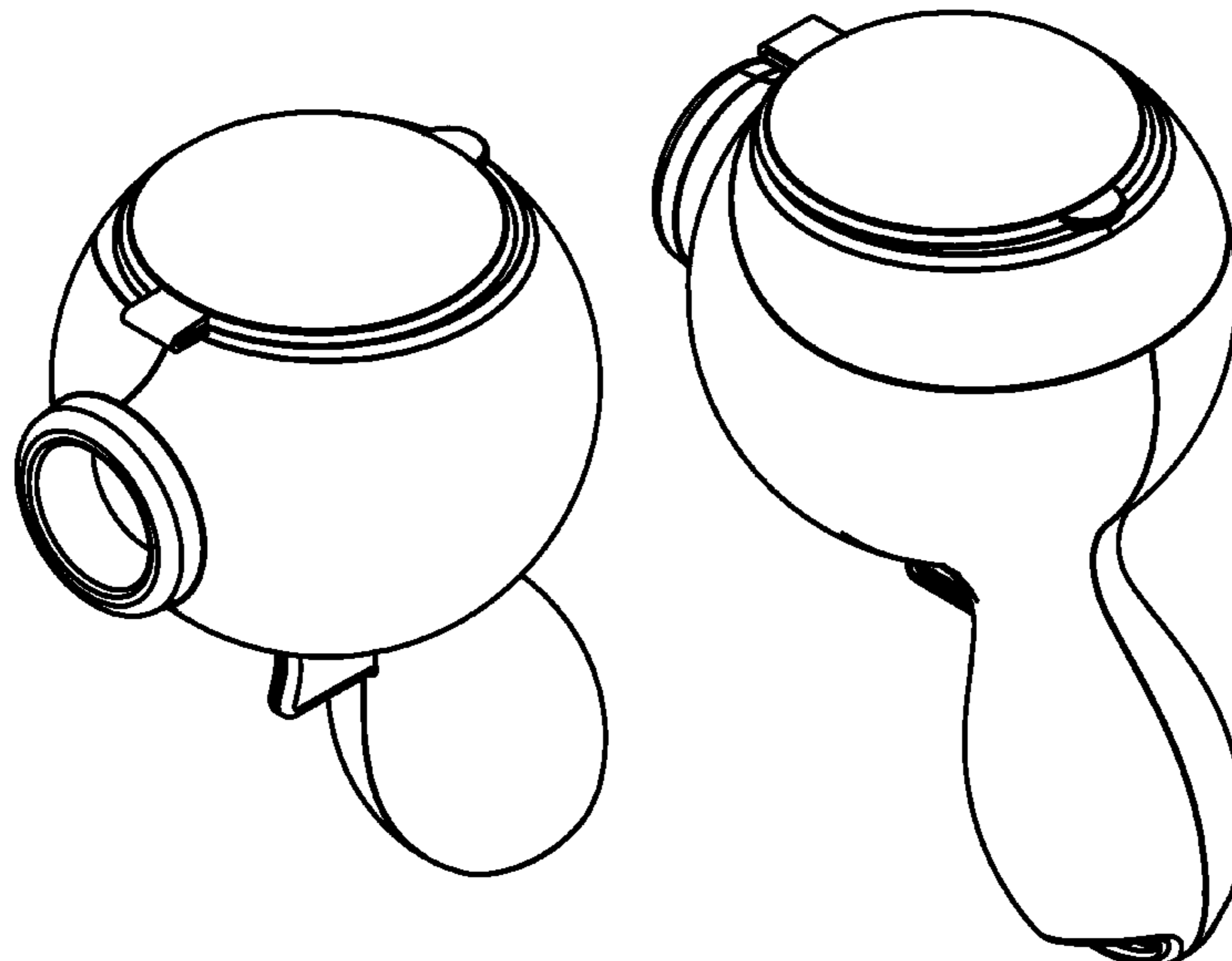
(57) **CLAIM**

The ornamental design for a pet treat dispensing device, as shown and described.

DESCRIPTION

FIG. 1 is a front isometric view from above the device; FIG. 2 is a rear isometric view from below the device; FIG. 3 is a left elevation view of the device; FIG. 4 is a right elevation view of the device; FIG. 5 is a front elevation view of the device; FIG. 6 is a rear elevation view of the device; FIG. 7 is a top view of the device; and, FIG. 8 is a bottom view of the device.

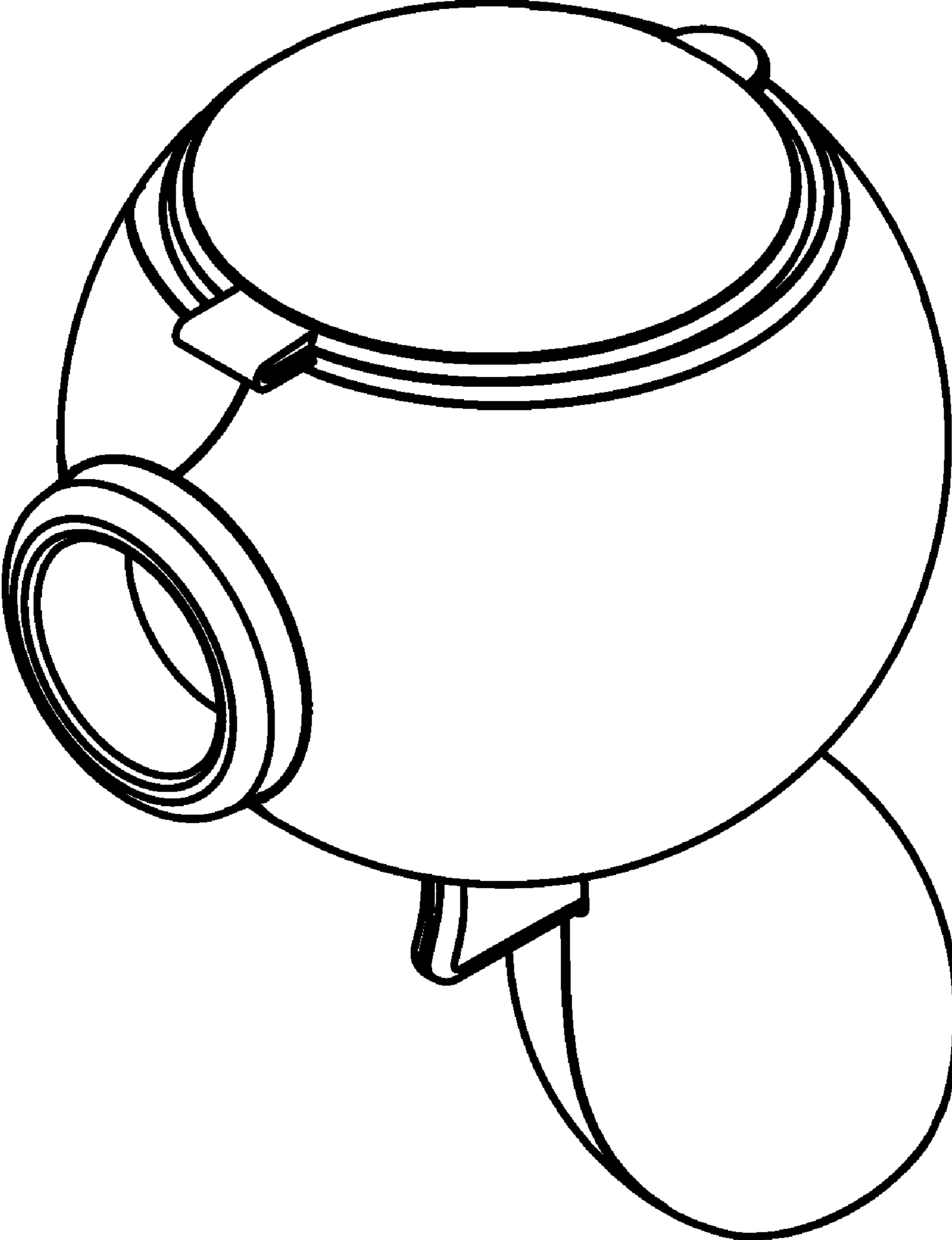

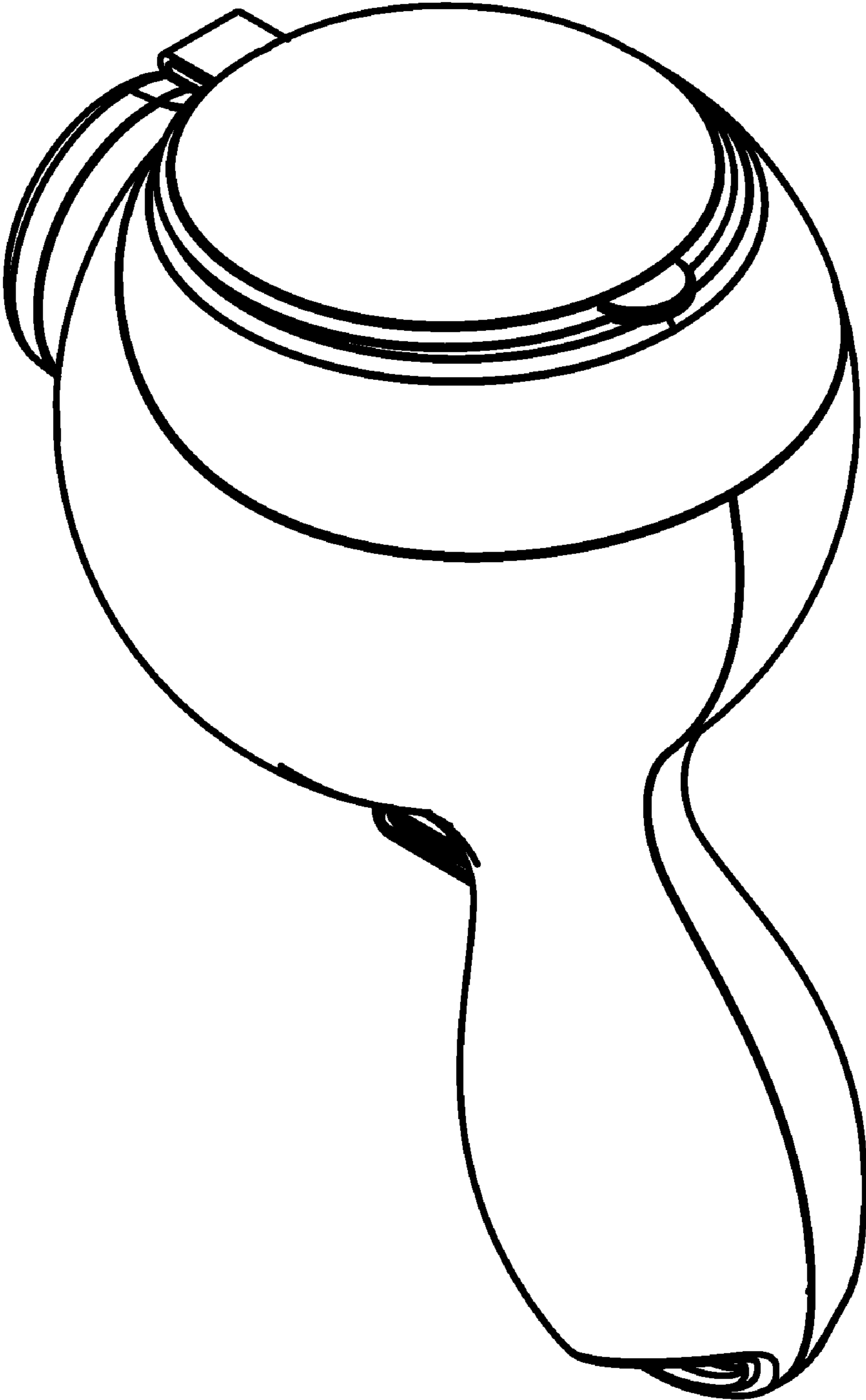

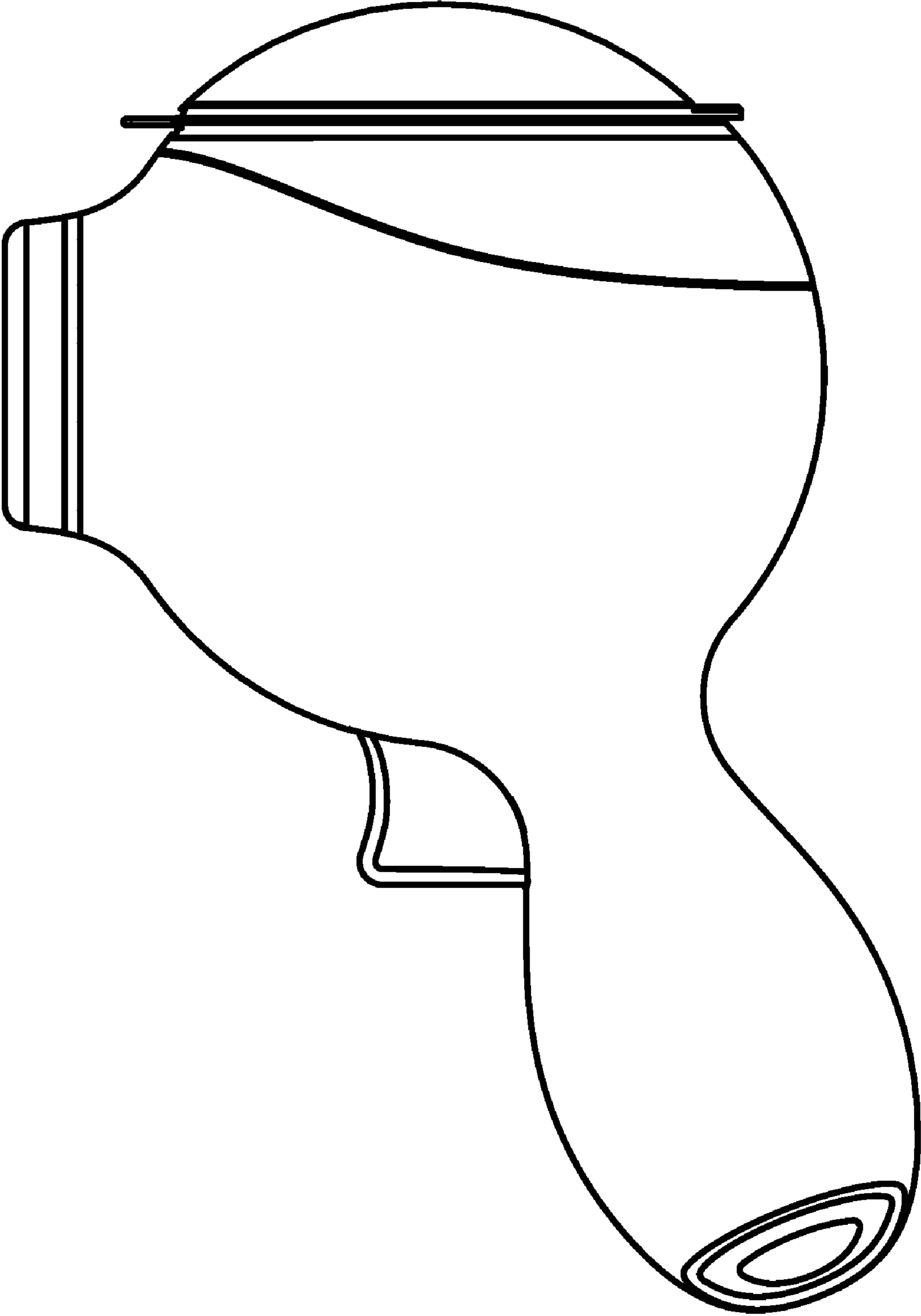

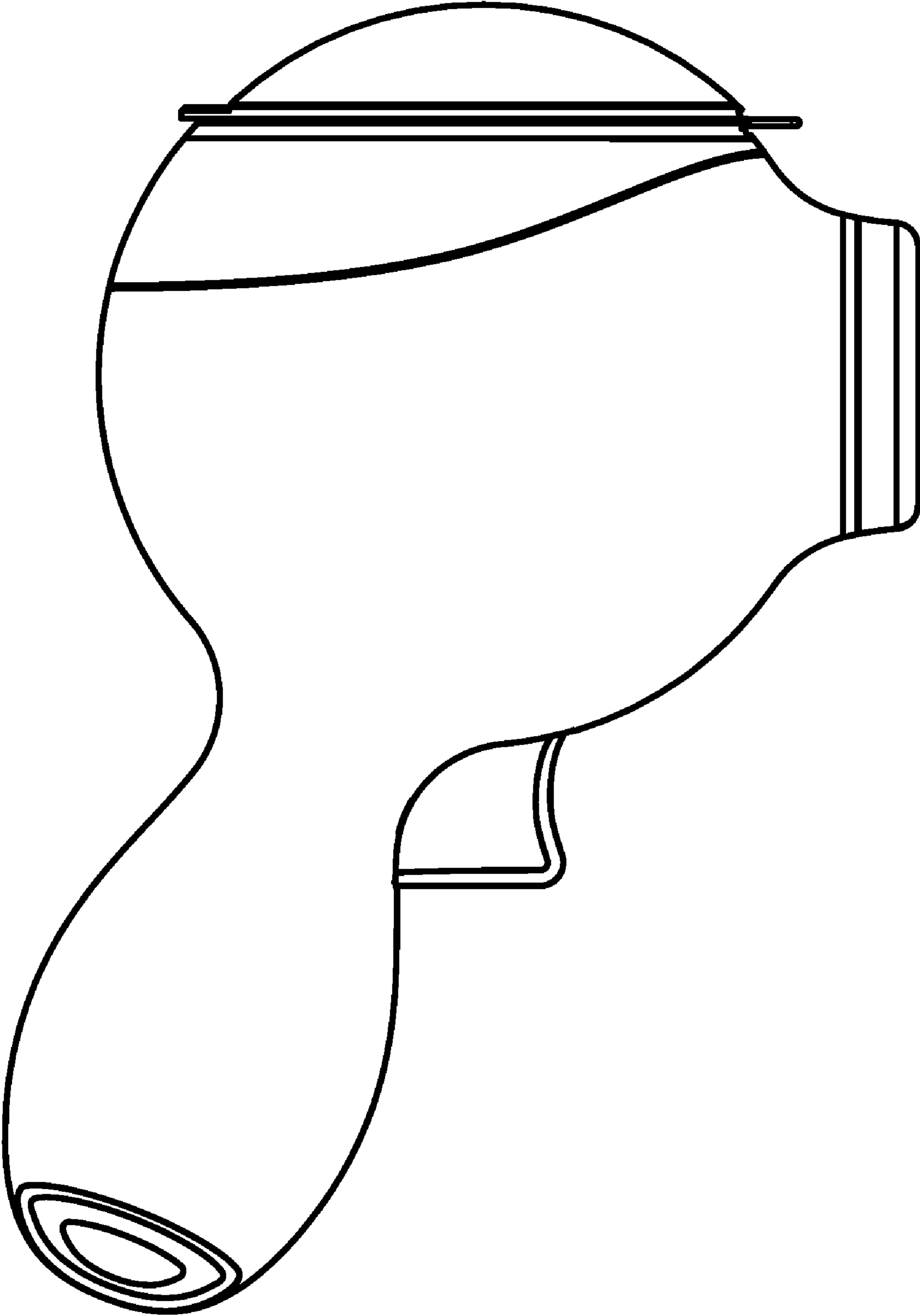

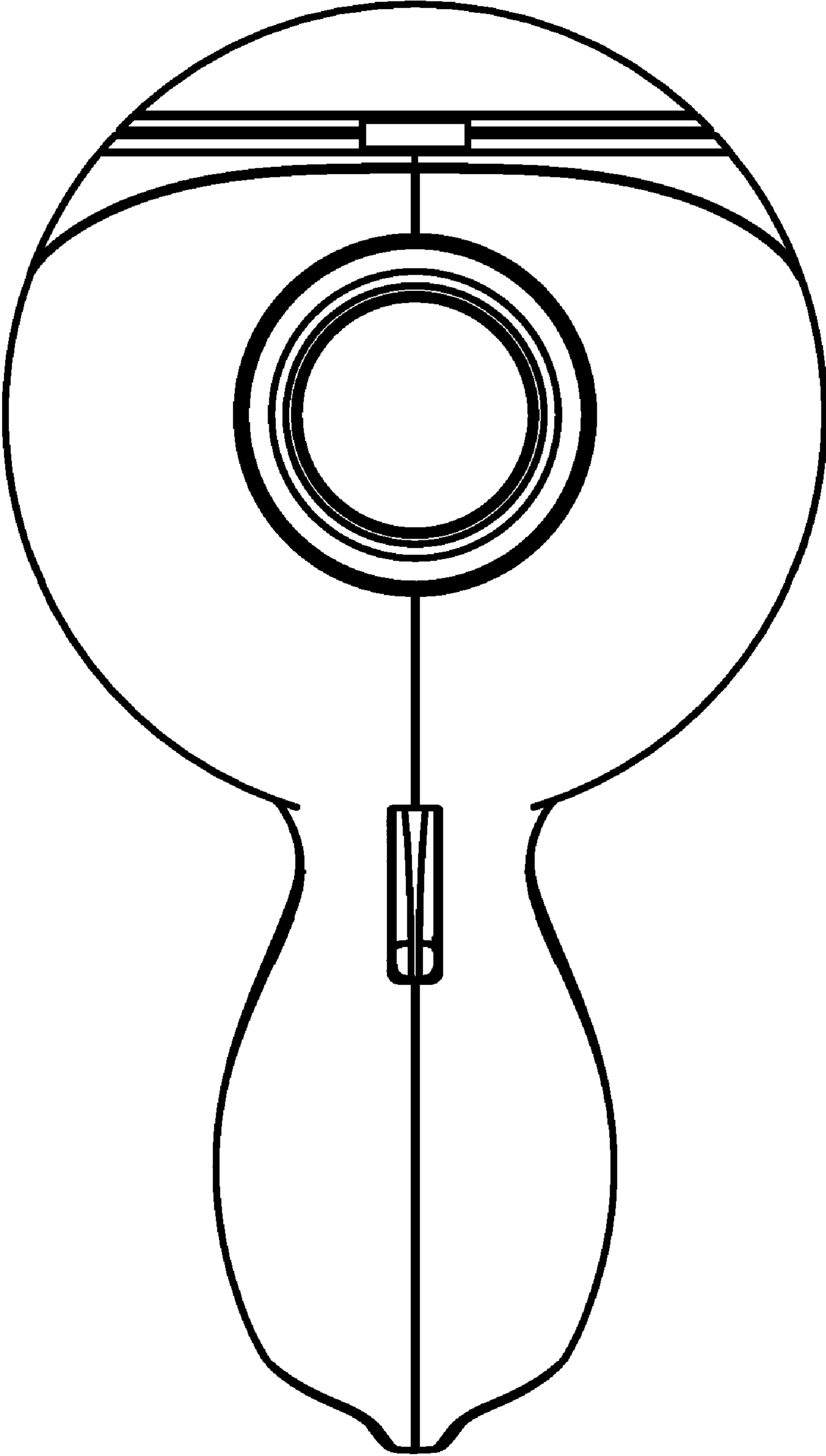

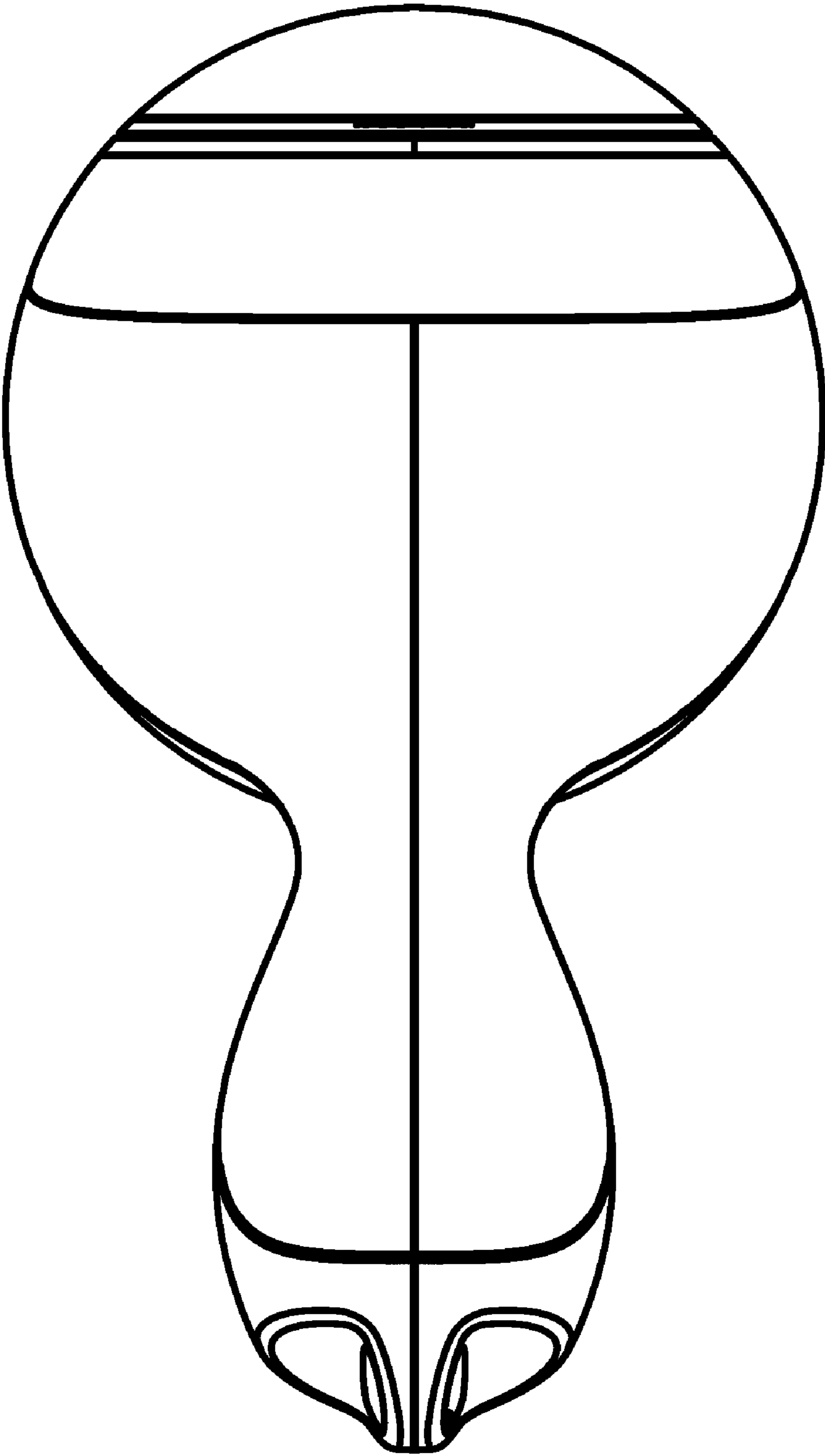

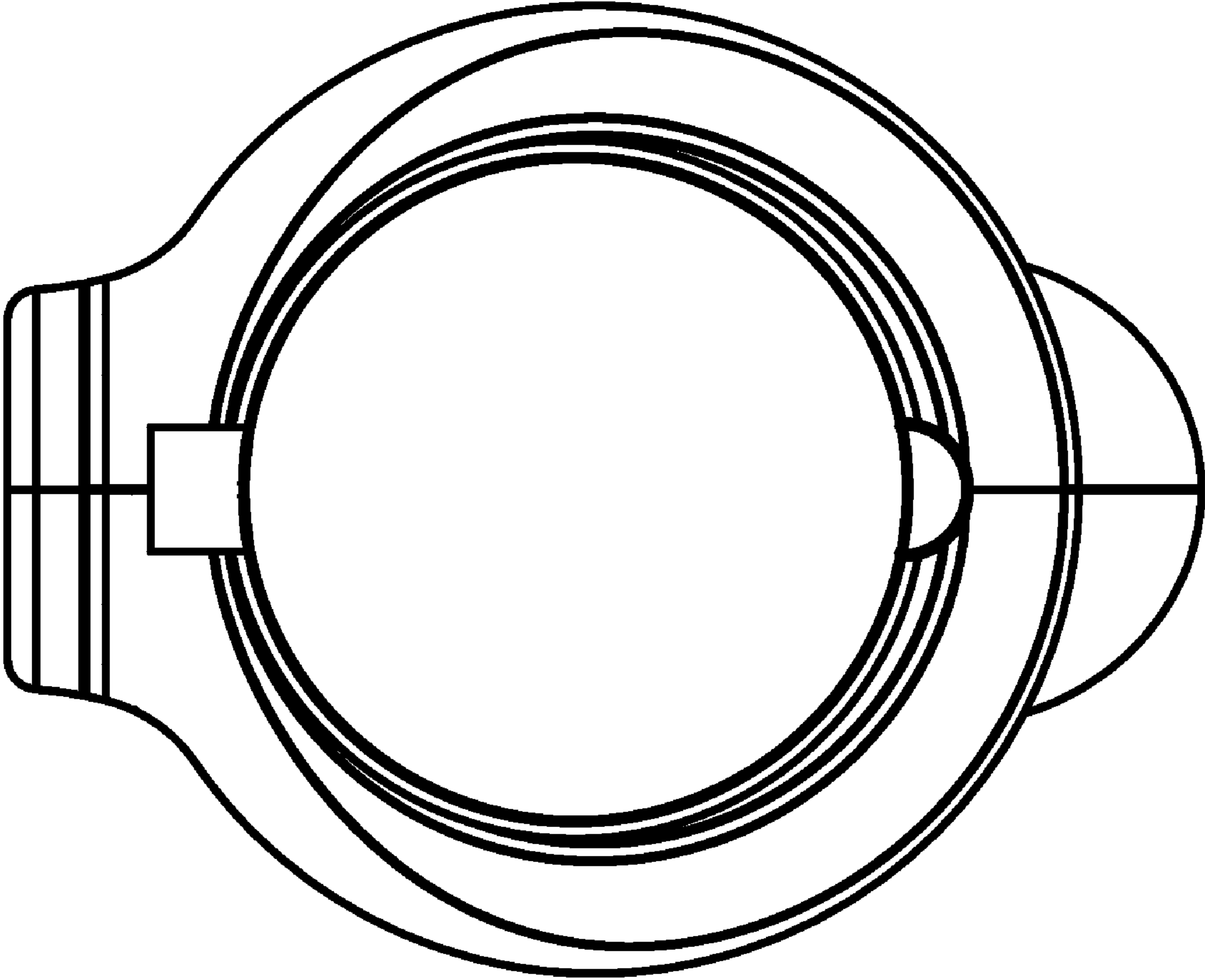

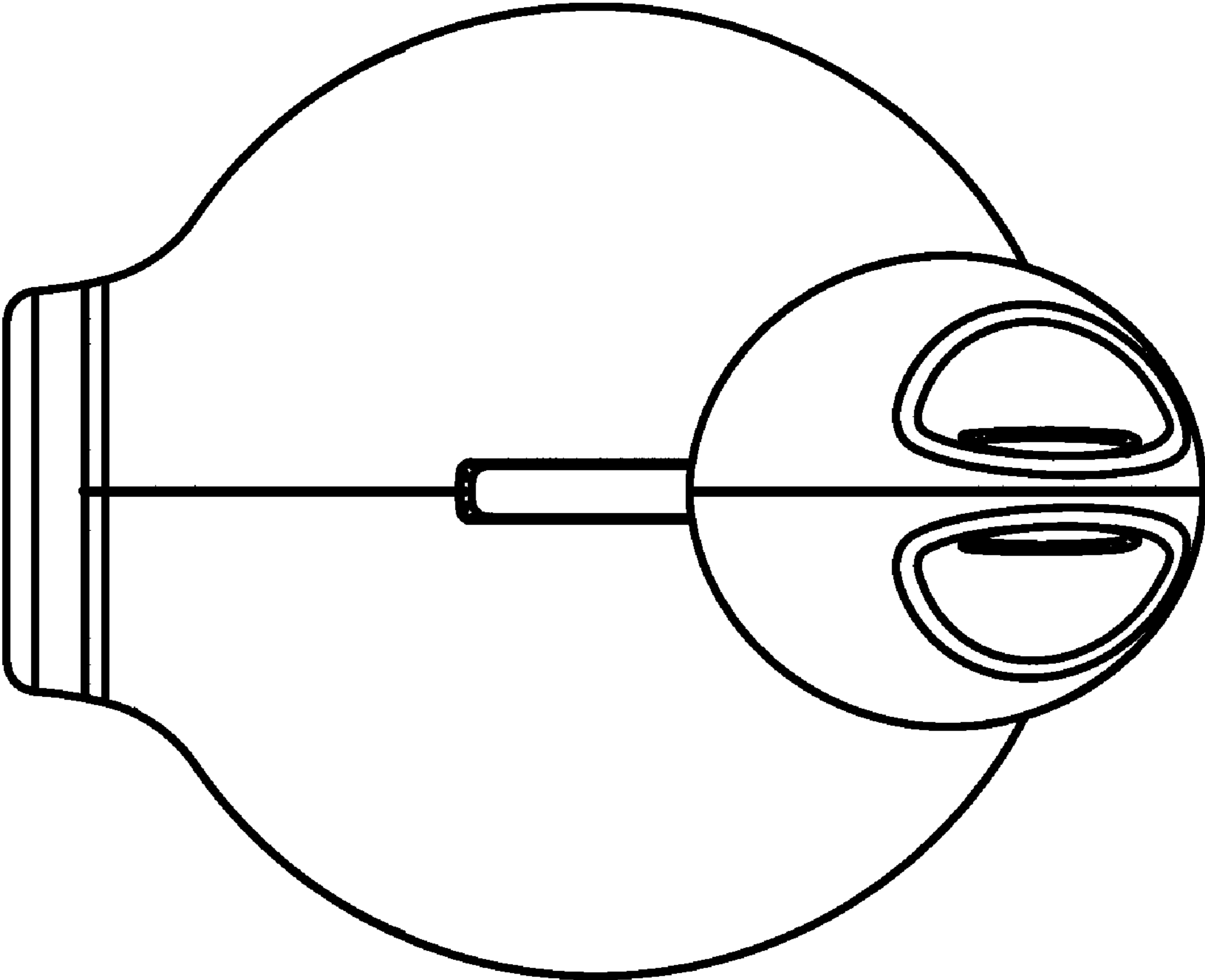
