FIG. 3 is a side elevational view of the bib shown in FIG. 2.

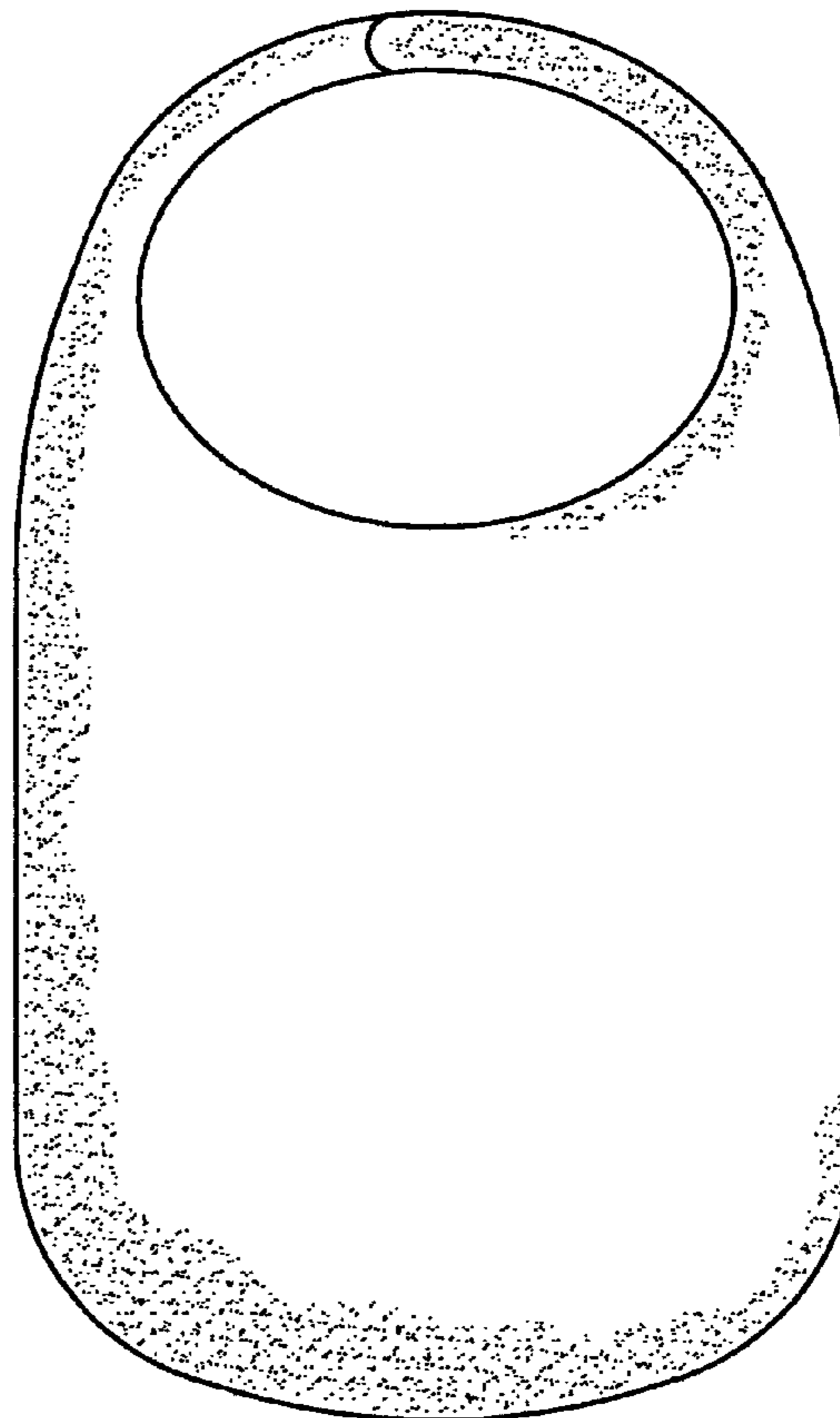
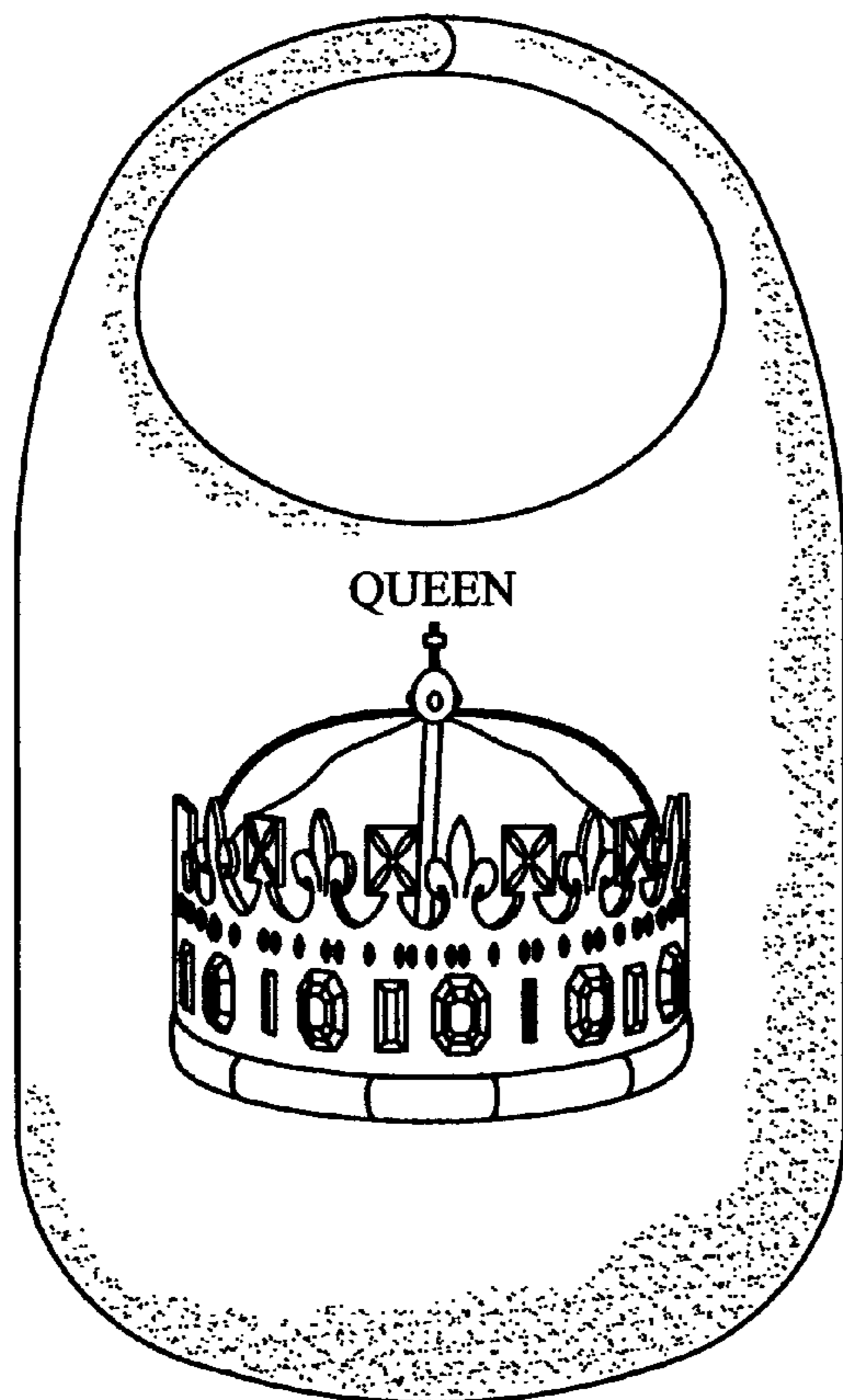
FIG. 4 is the opposite side elevational view of the bib shown in FIG. 2.

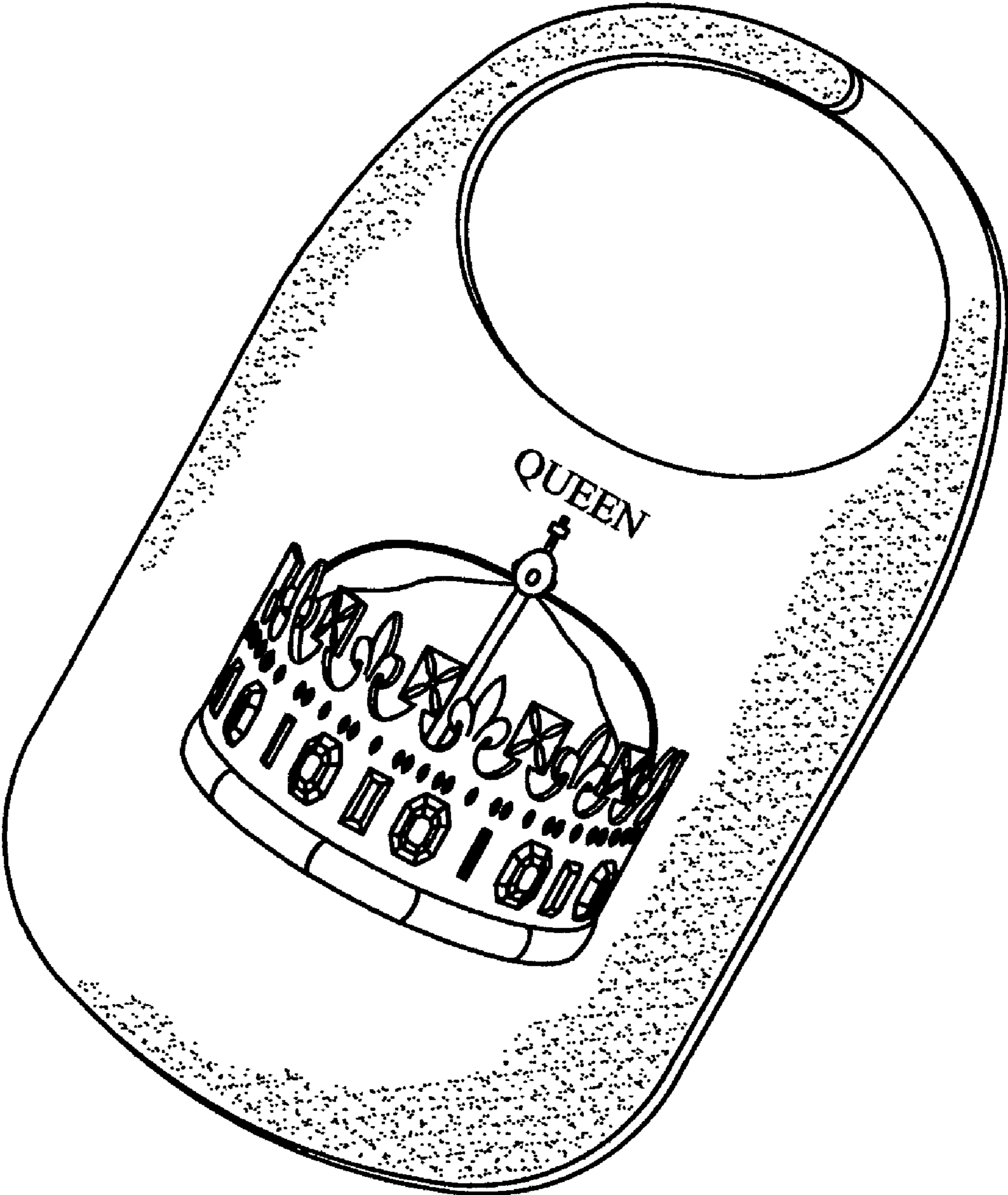

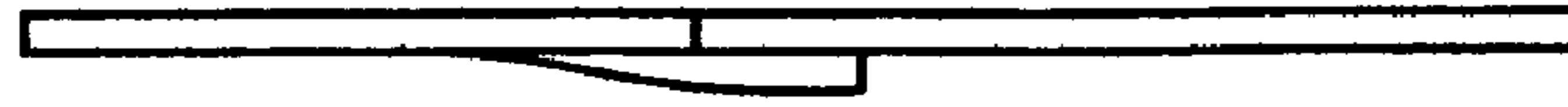

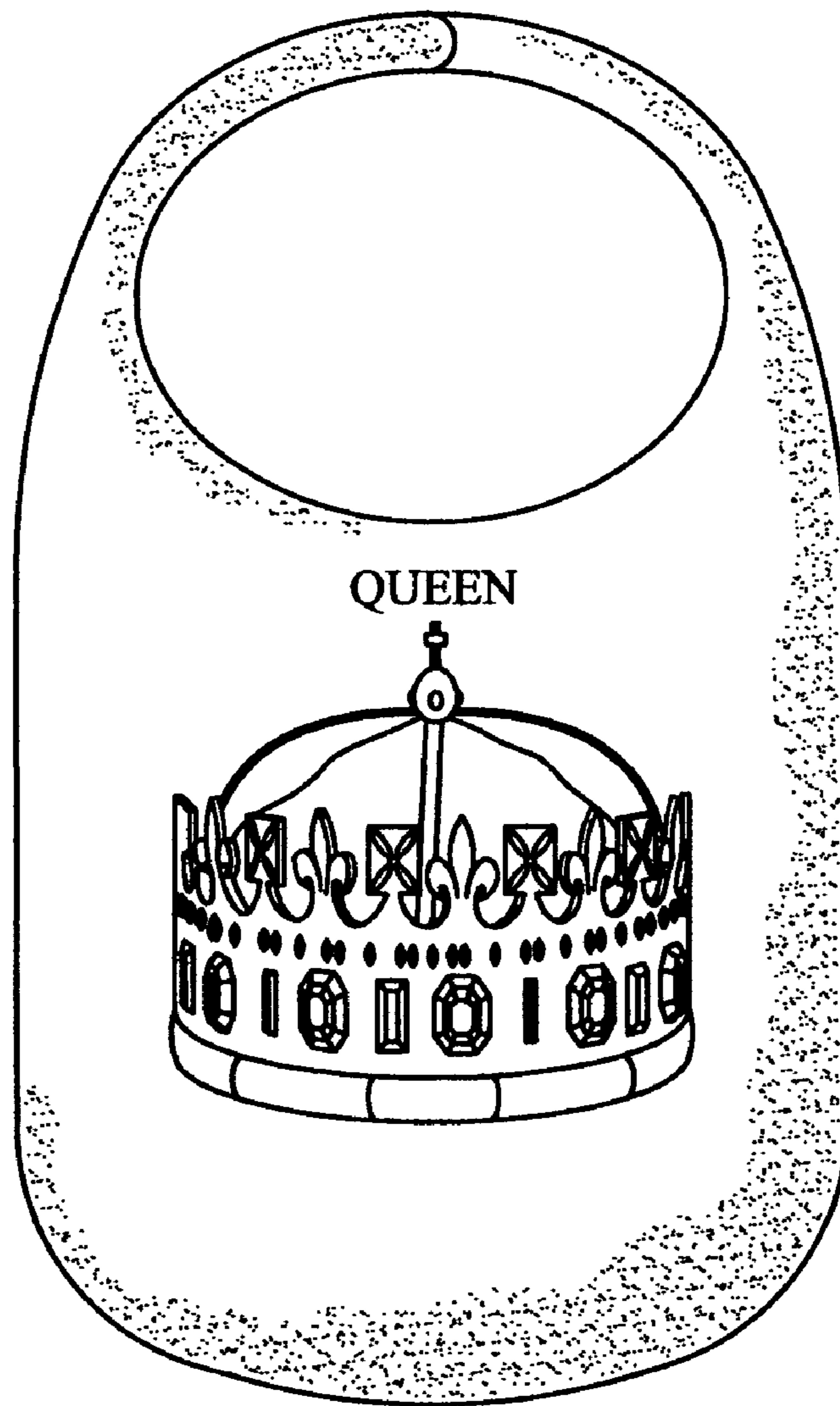
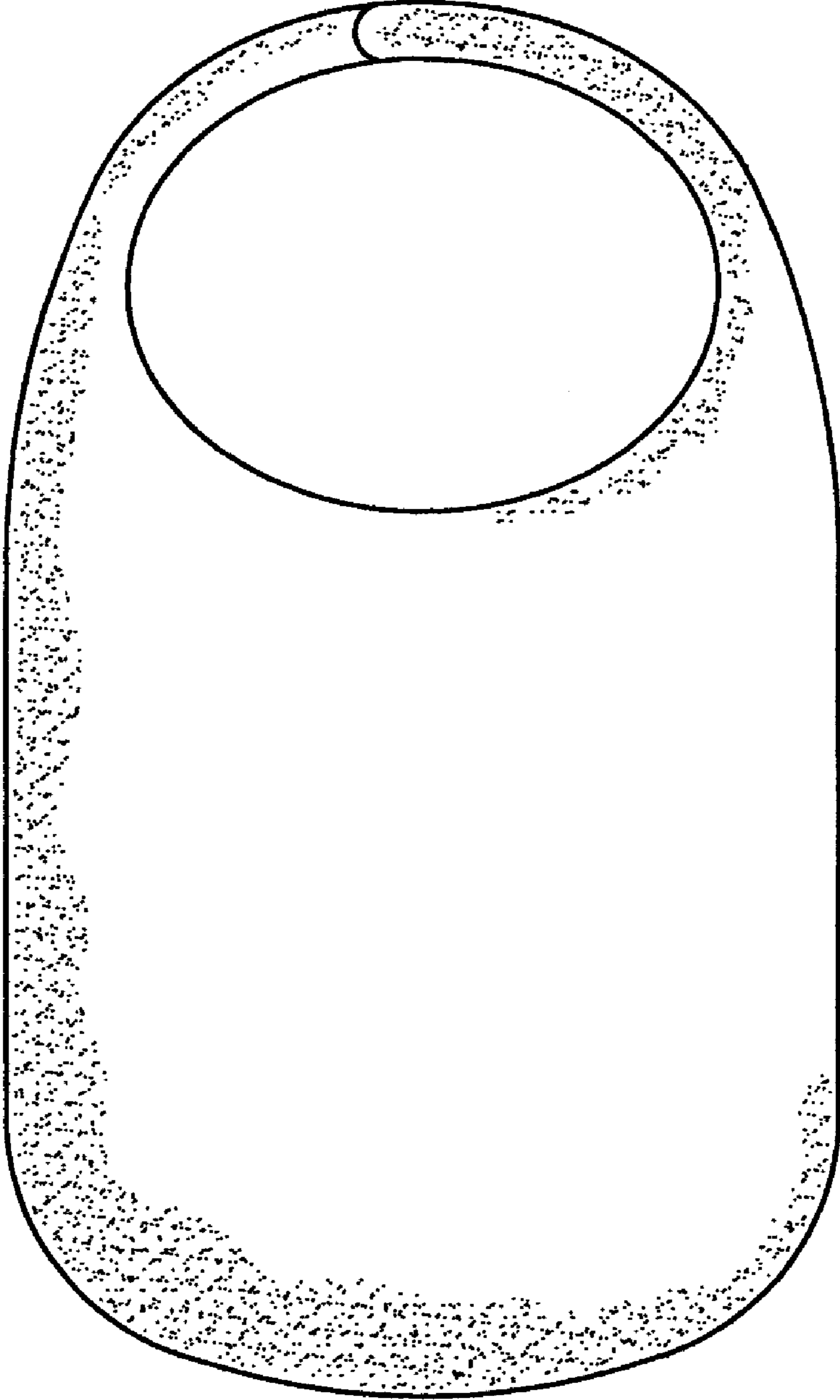
