DESCRIPTION

FIG. 1 is a top rear perspective view of the shoe tread of the instant invention;

FIG. 6 is a right side view thereof;

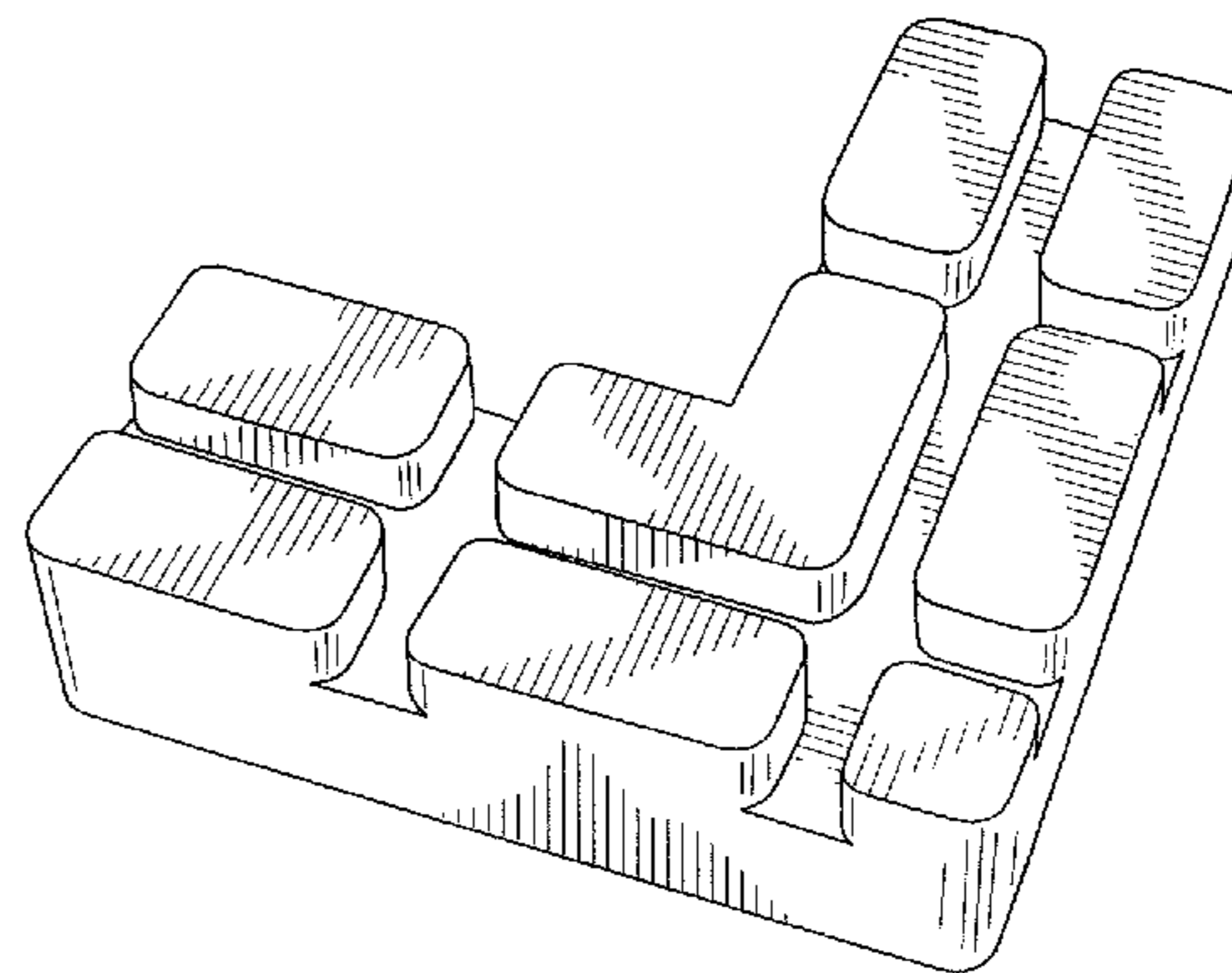
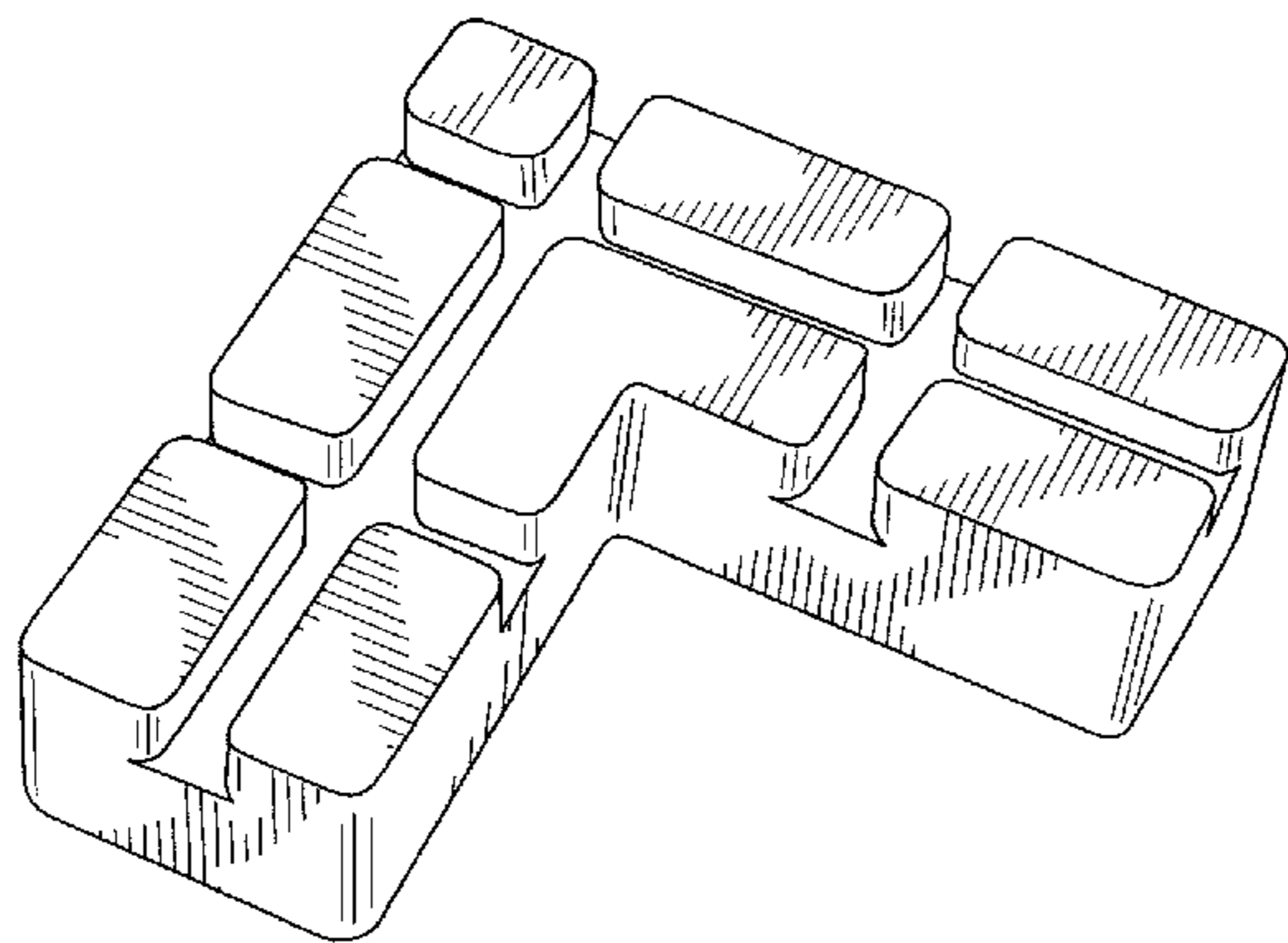
FIG. 7 is a left side view thereof;

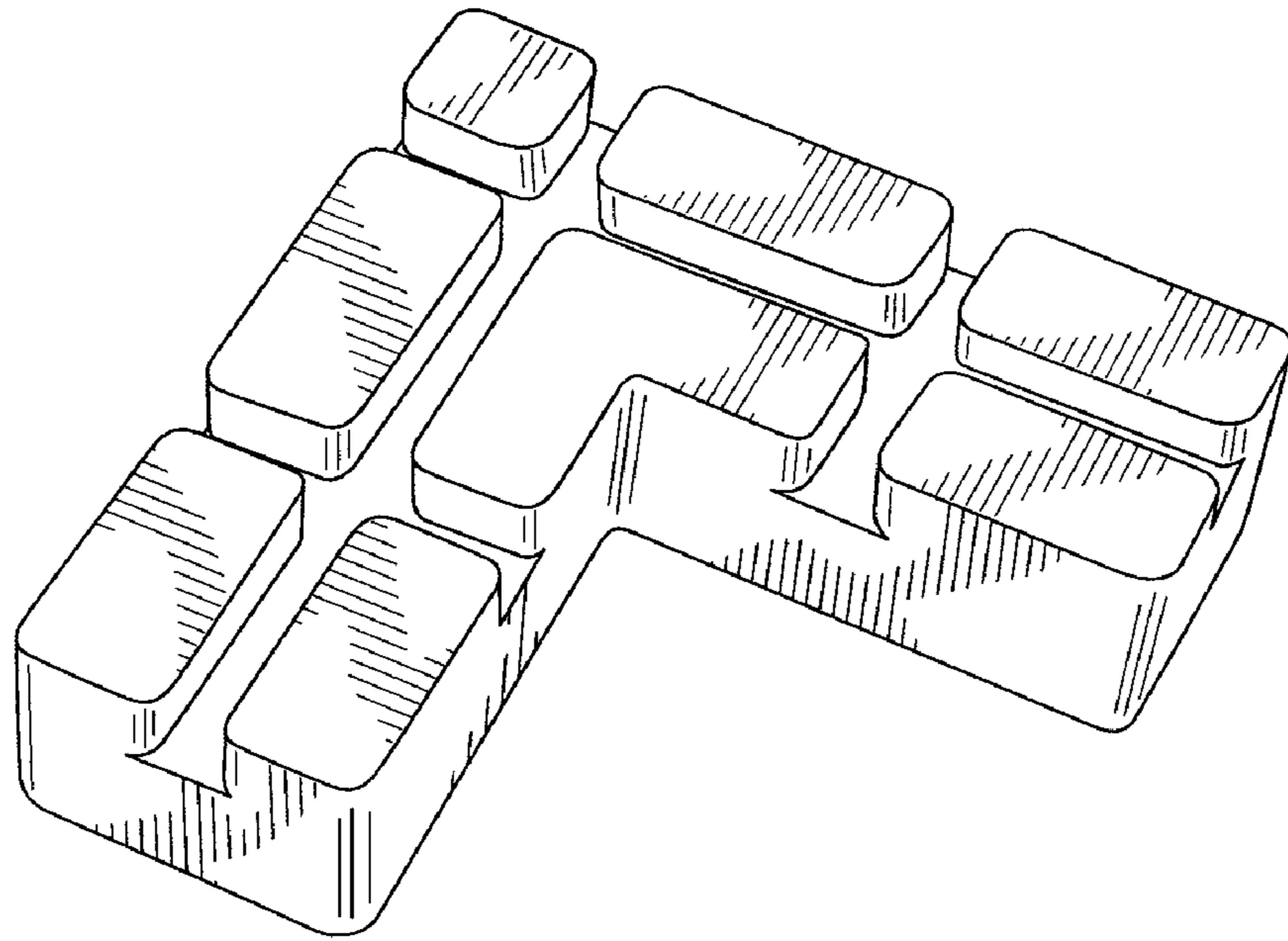

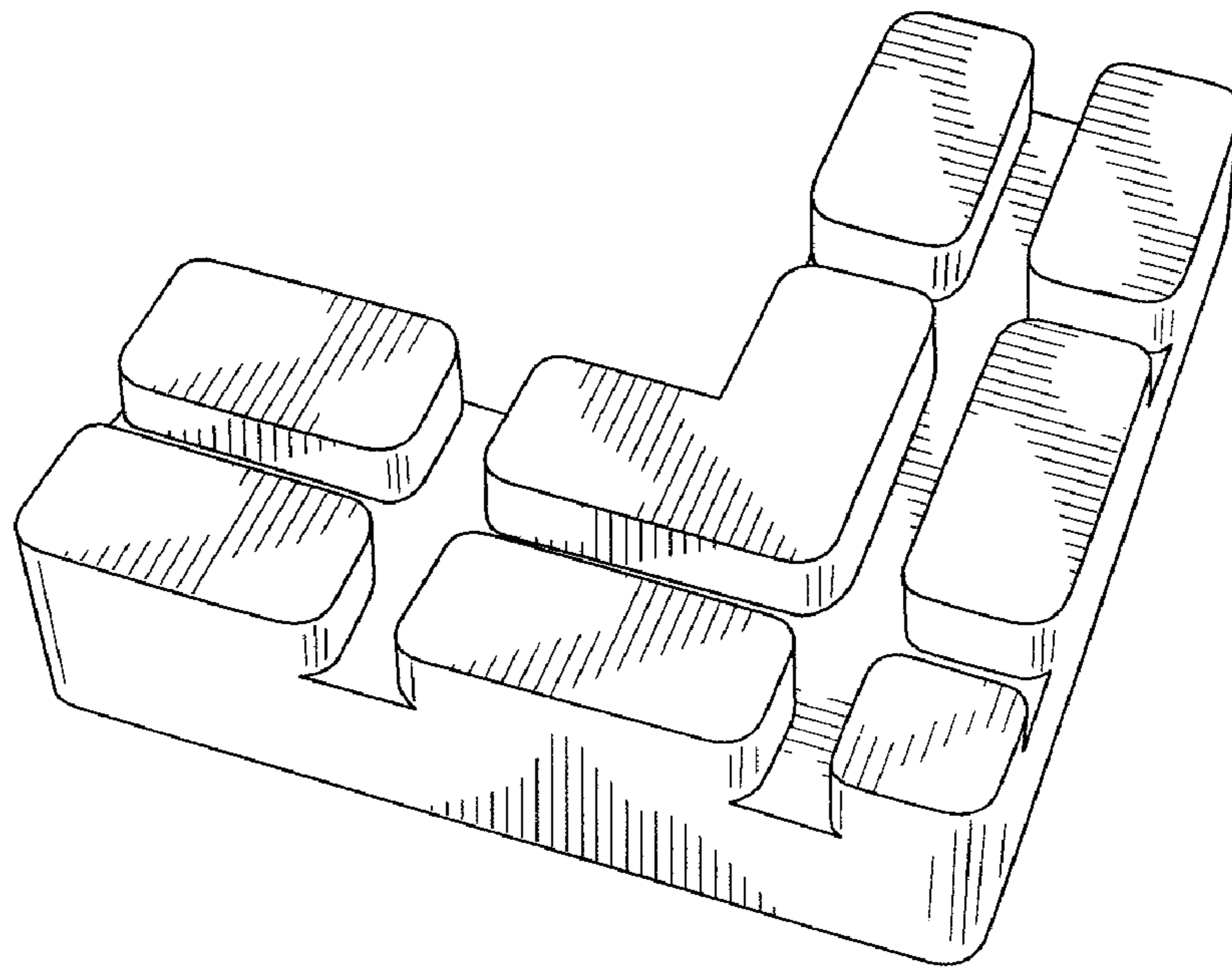

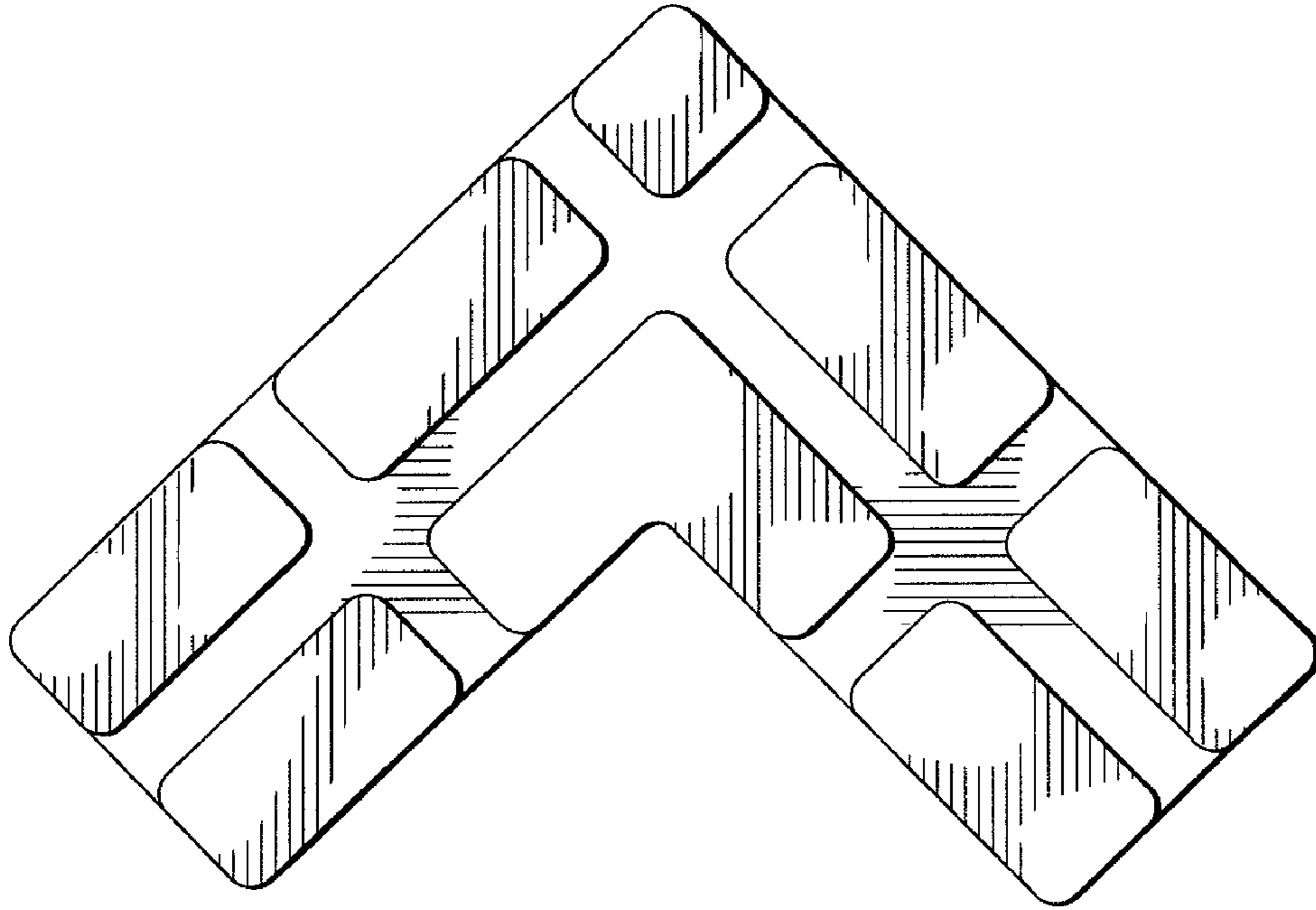

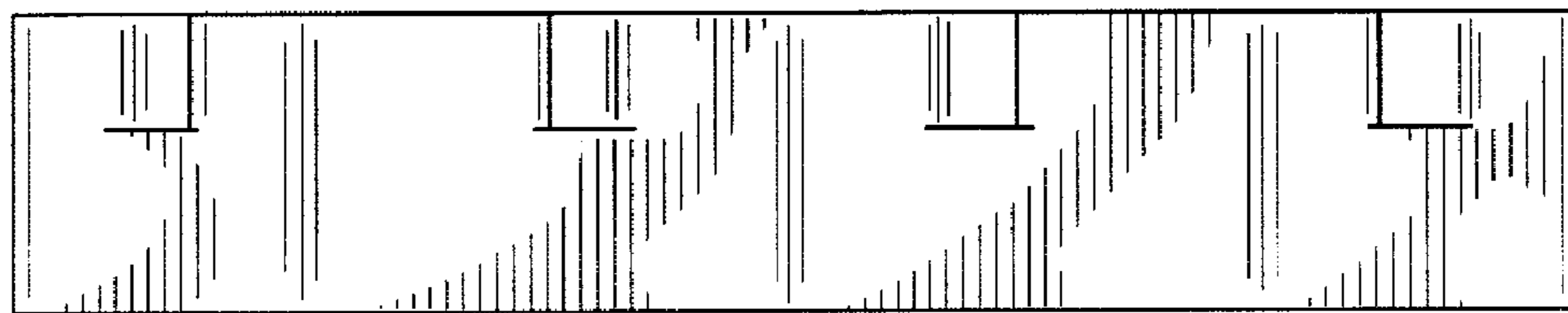

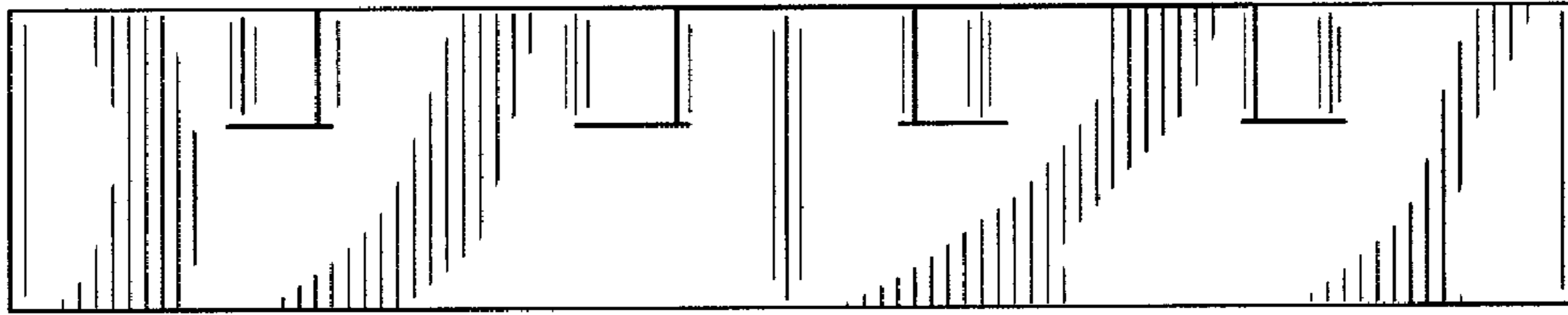

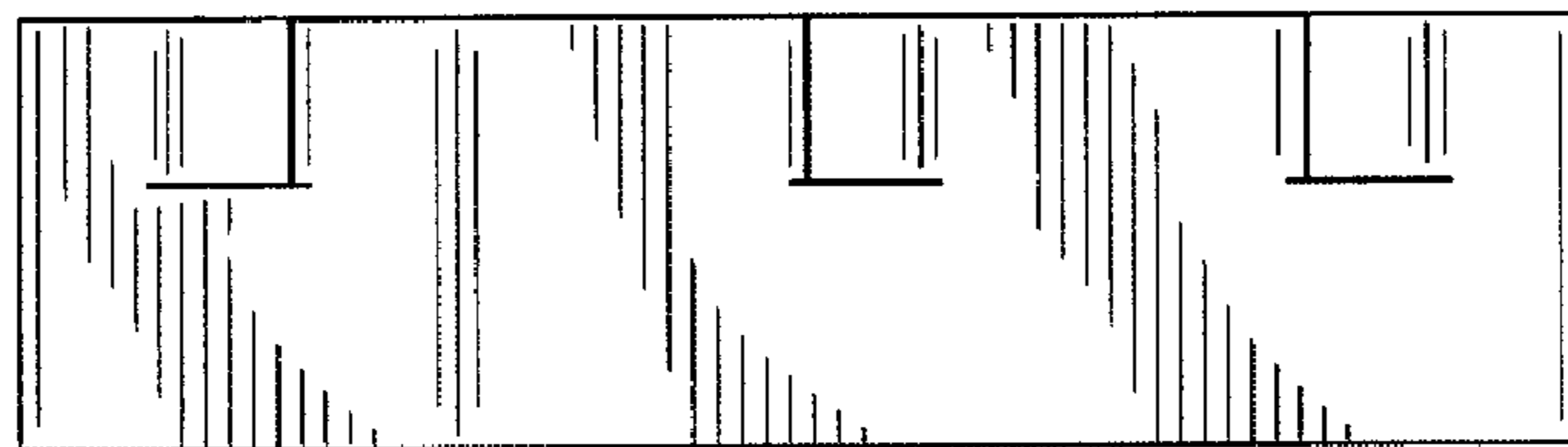

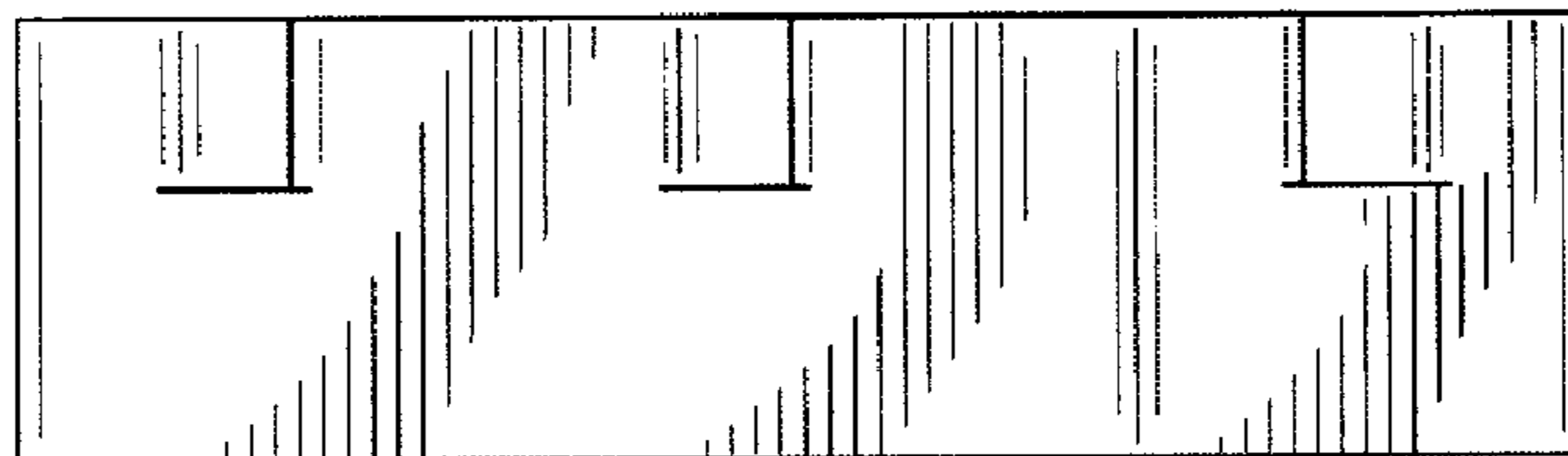

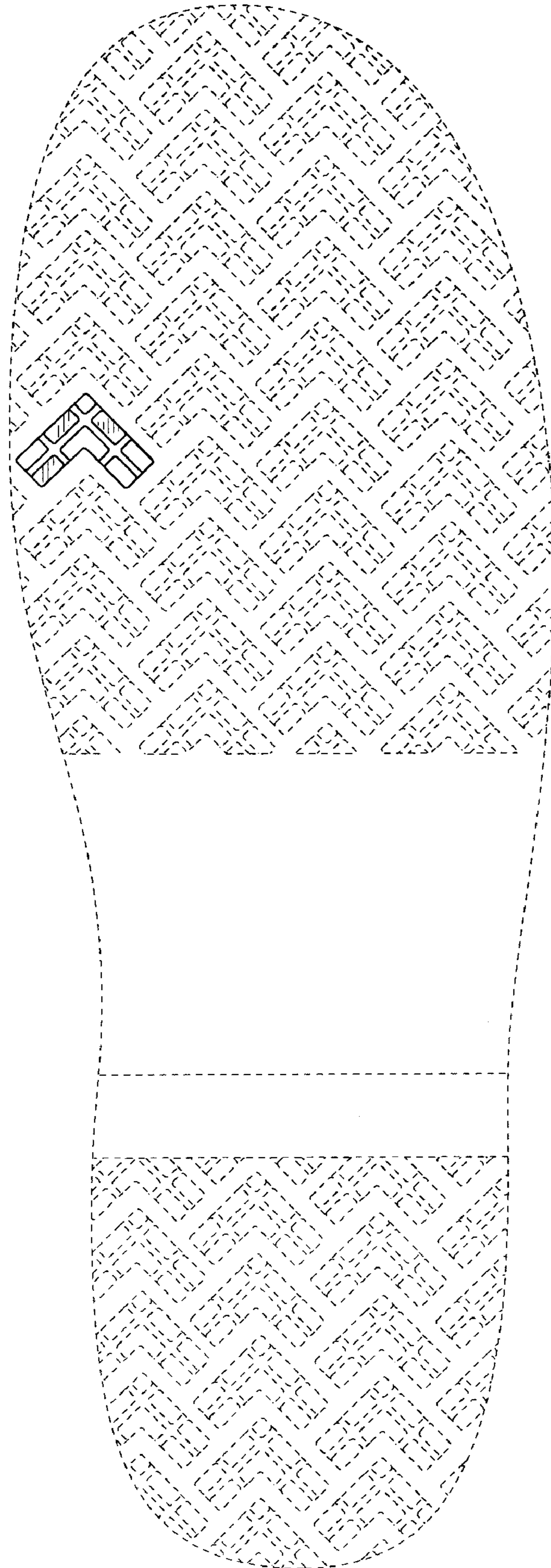

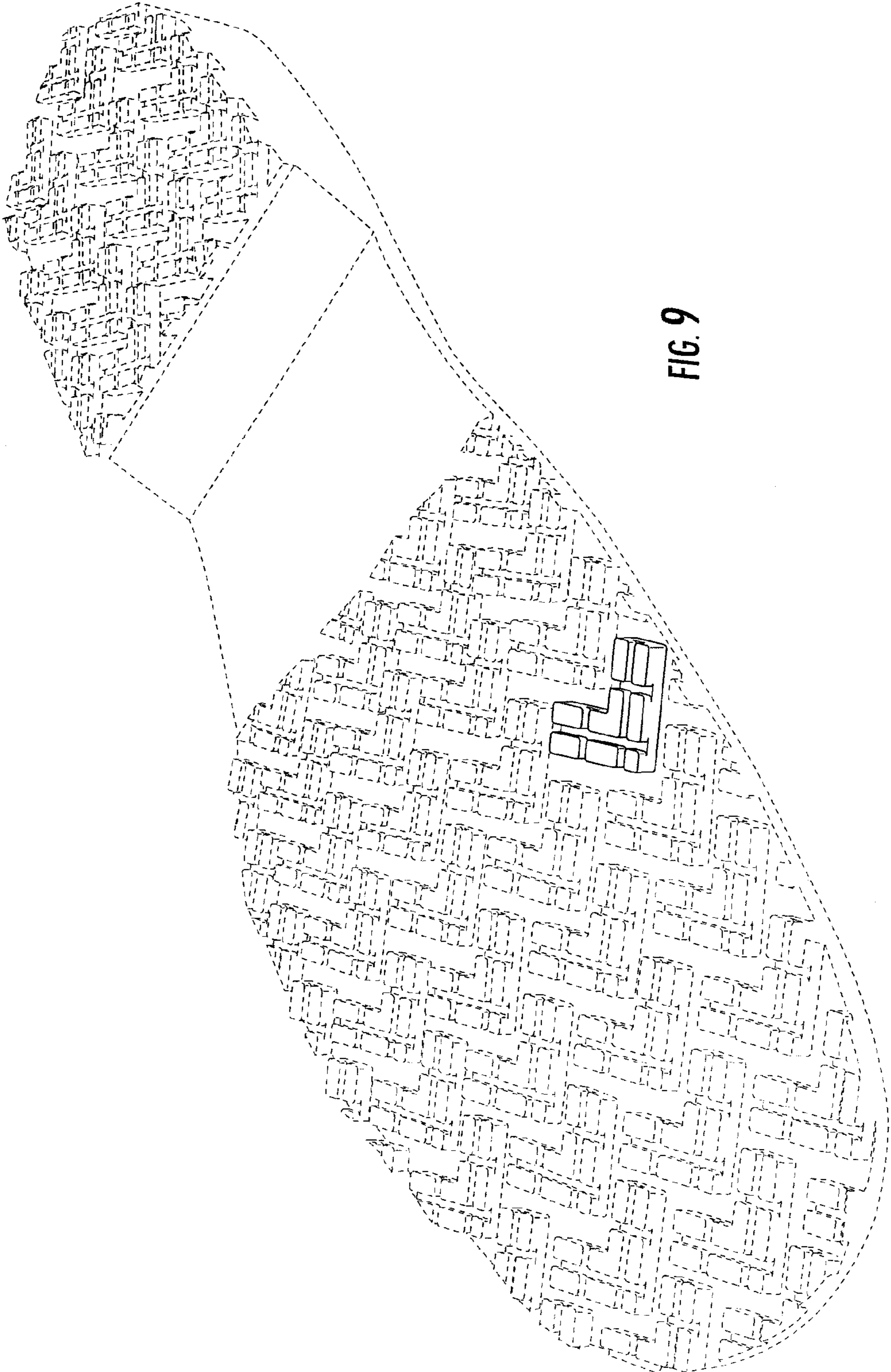
