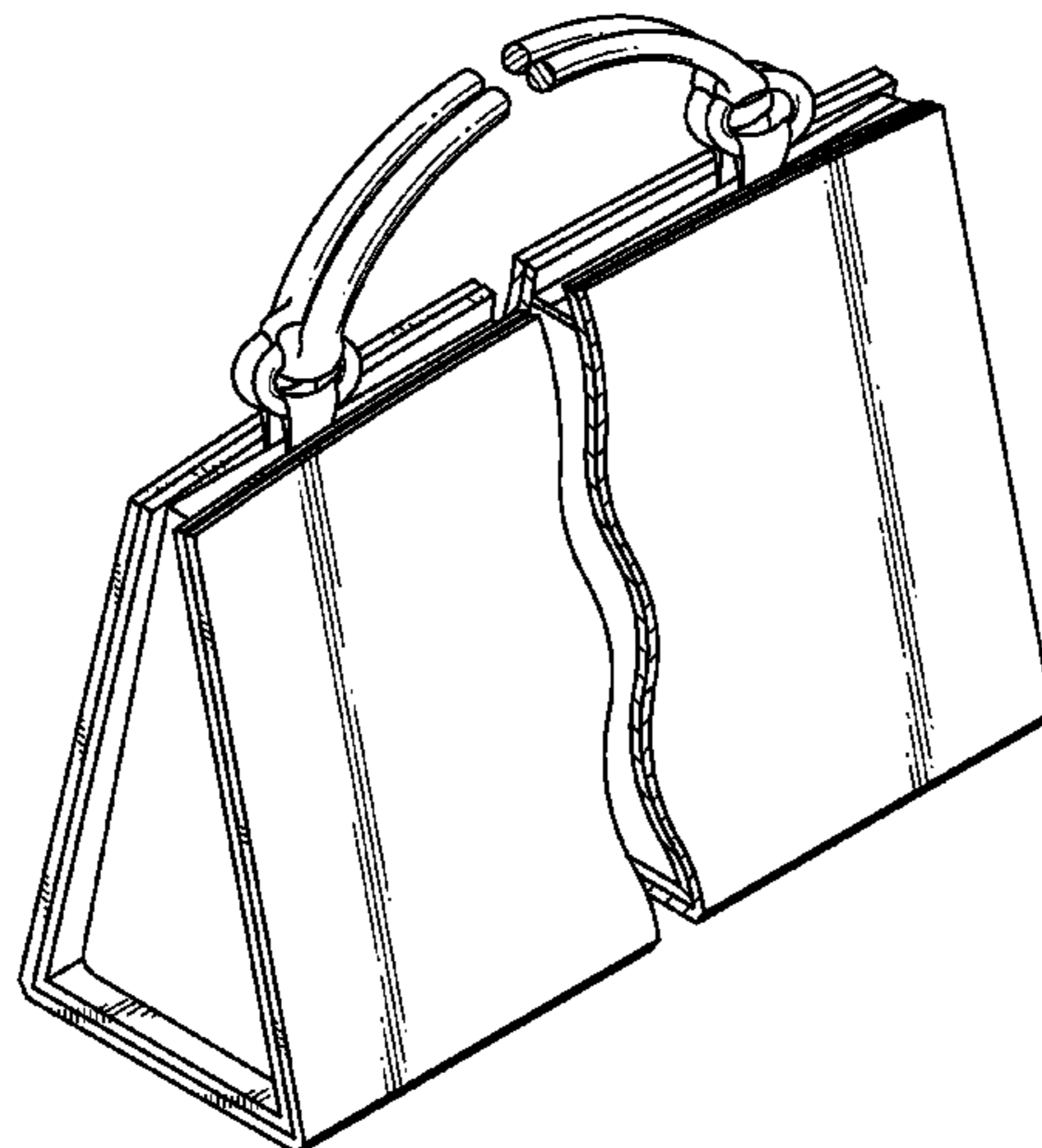
(57) **CLAIM**

The ornamental design for a handbag with interchangeable cover, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a handbag with interchangeable handbag cover, with the opposing rear view being a mirror image thereof;
FIG. 2 is a front perspective view thereof showing the handbag cover in a partially opened position with respect to the base handbag;
FIG. 3 is a front elevational view of the handbag cover shown in FIG. 1 with the opposing rear view being a mirror image thereof;
FIG. 4 is a top plan view thereof;
FIG. 5 is an elevated left view thereof, with the opposing right view being a mirror image thereof; and,
FIG. 6 is an elevated bottom view thereof.
The claimed design is shown broken away to indicate indeterminate length.

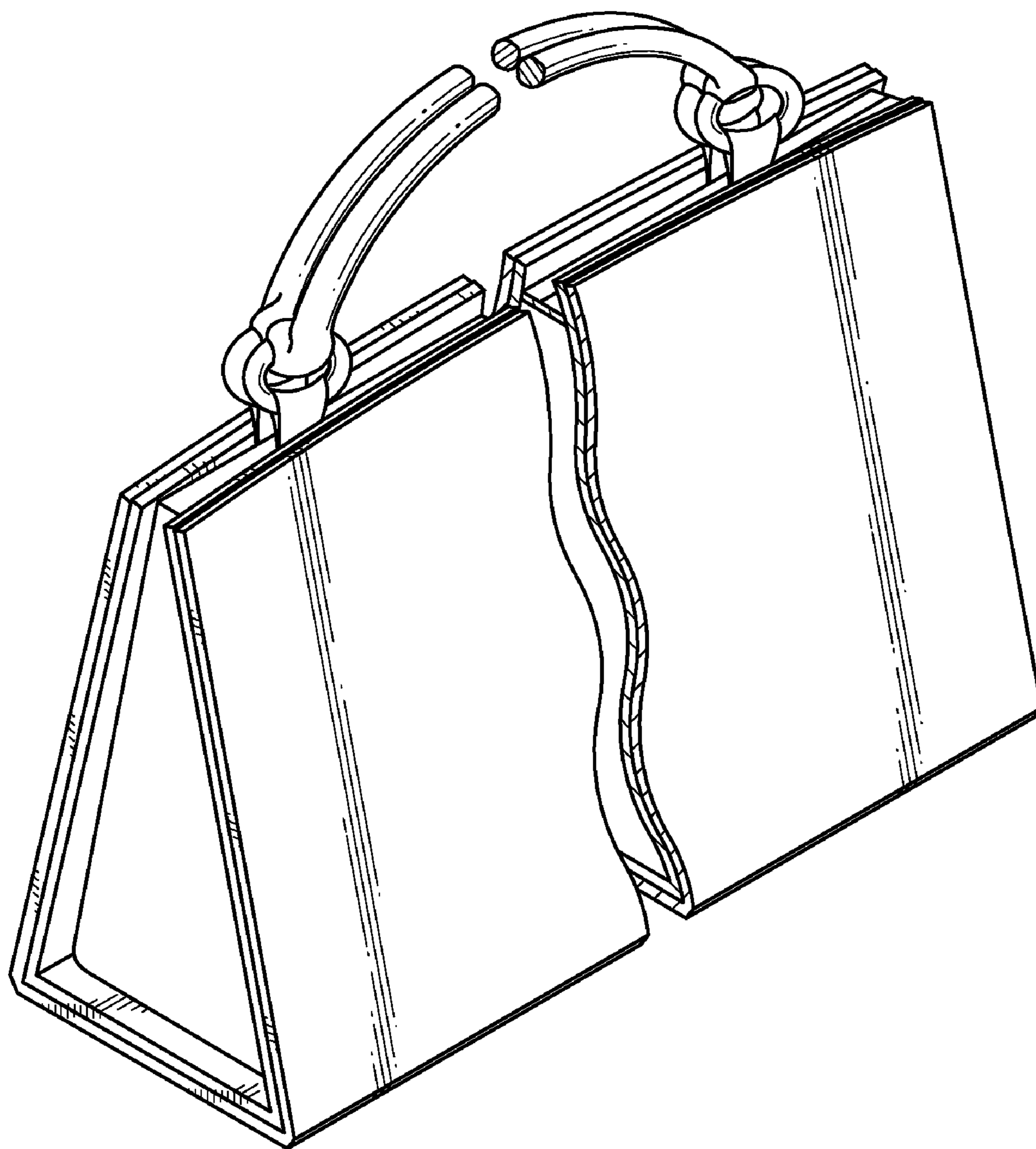

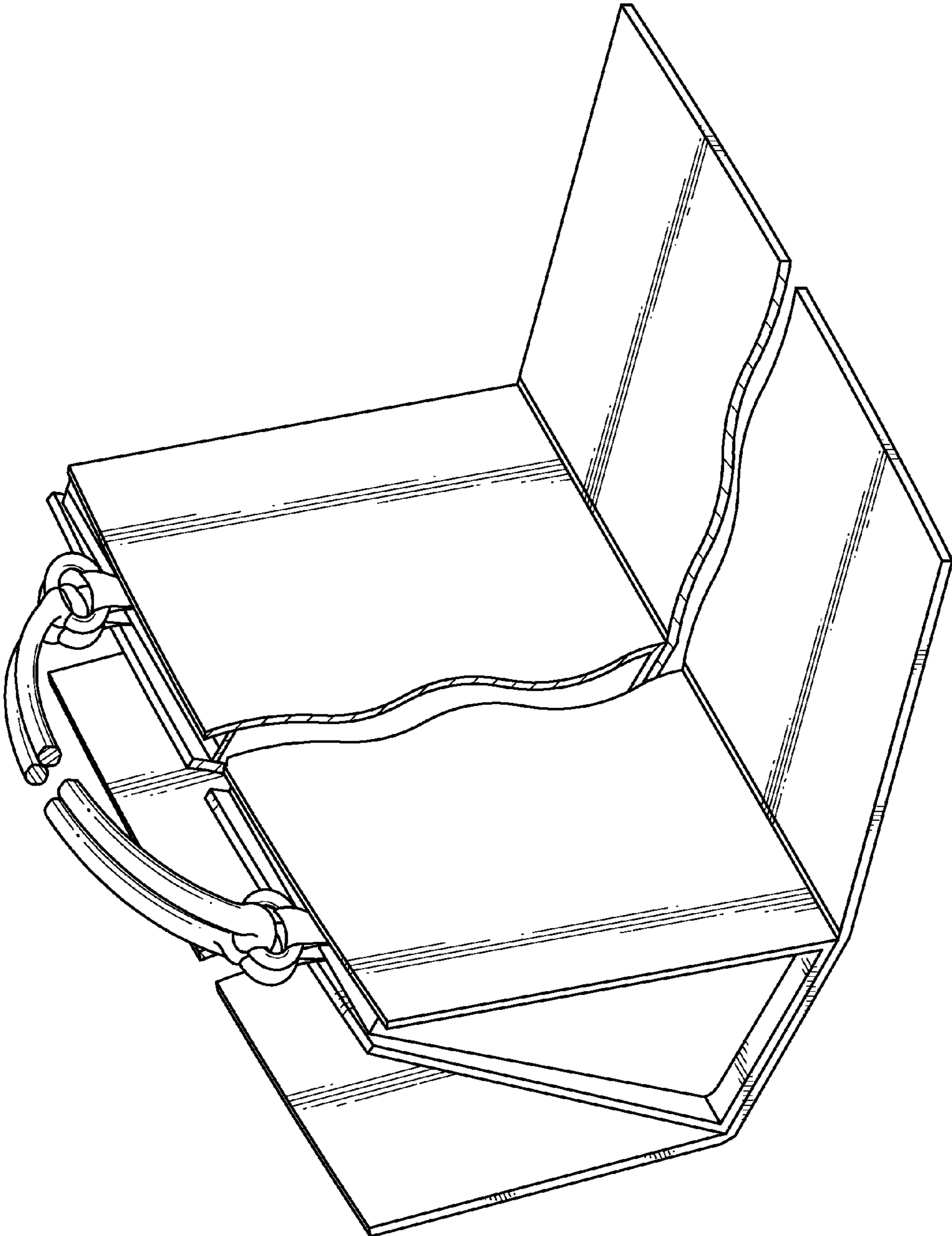

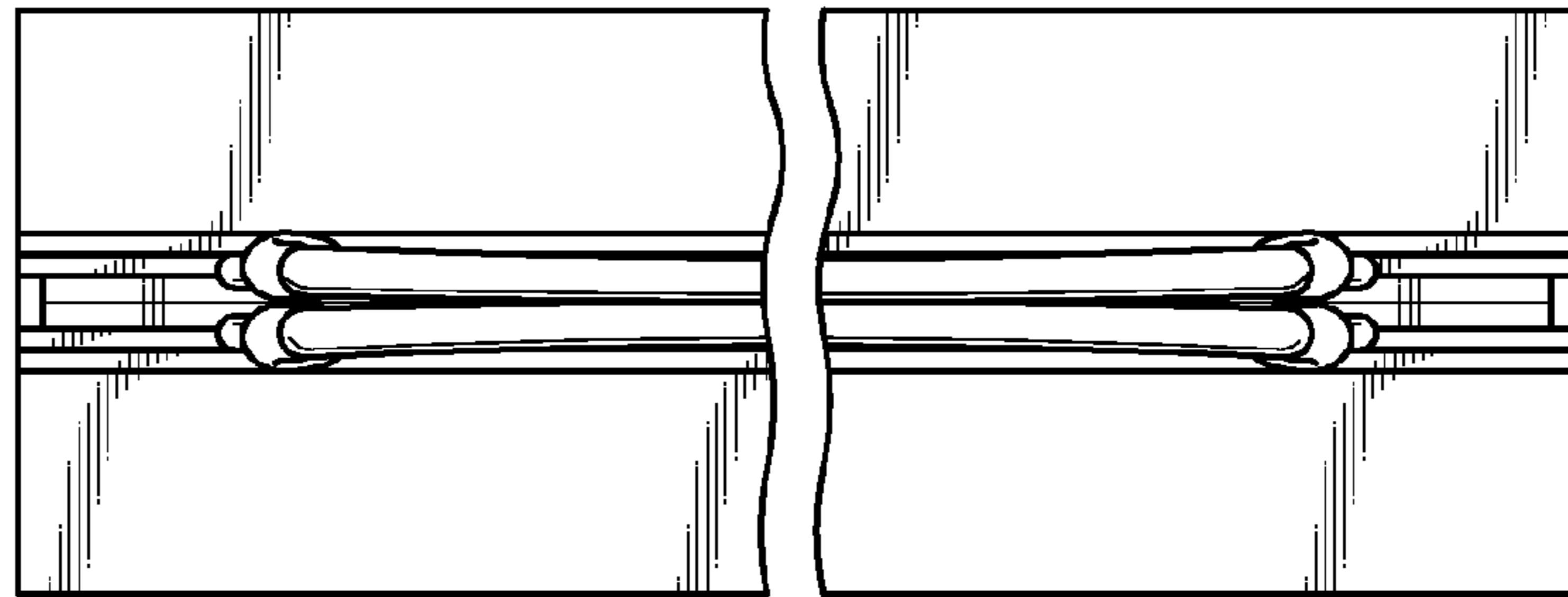

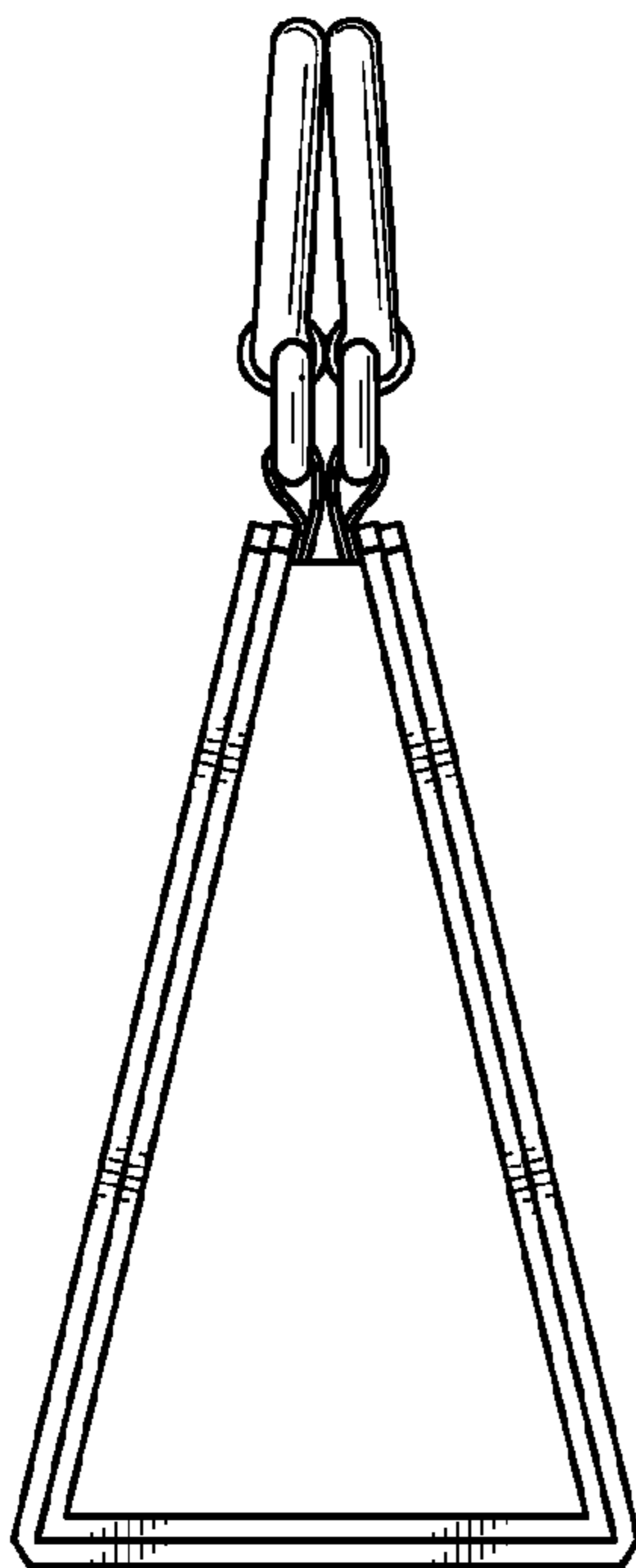

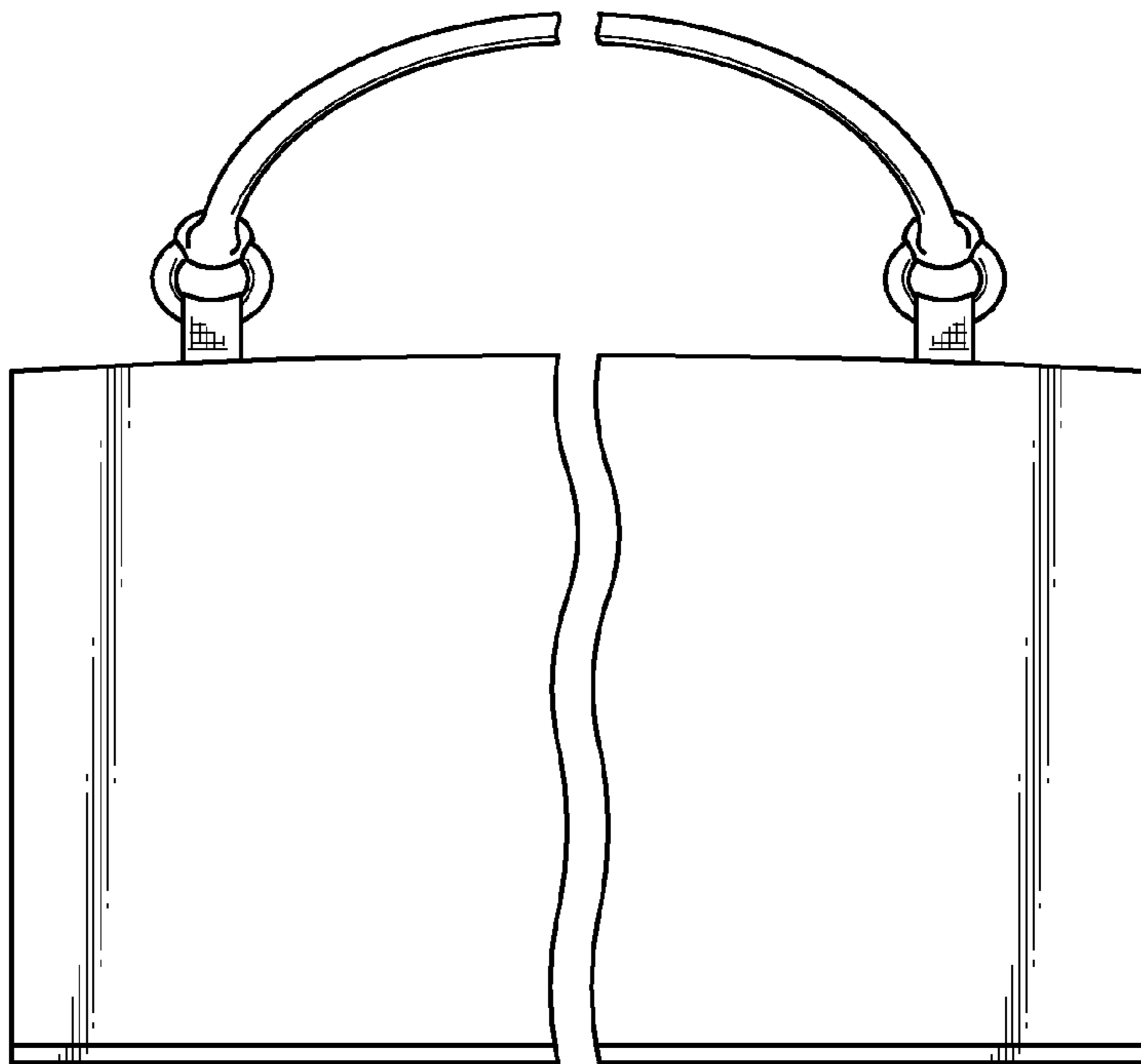

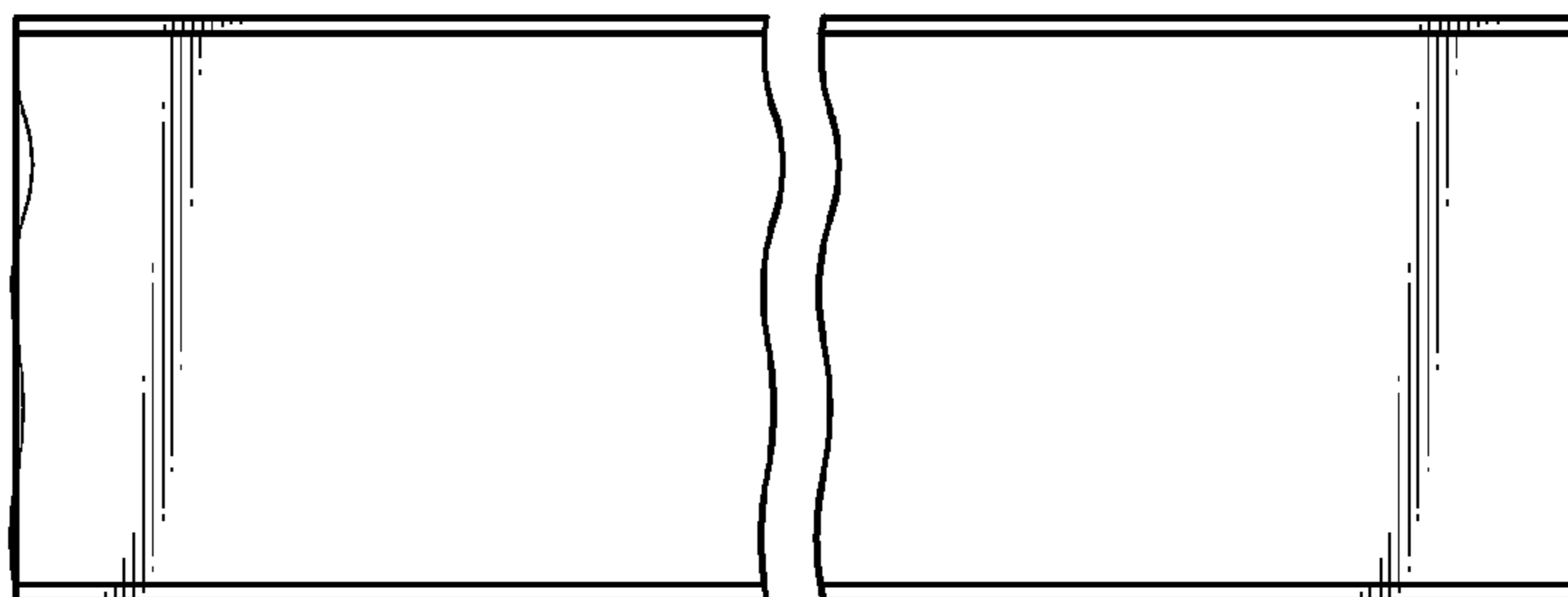
