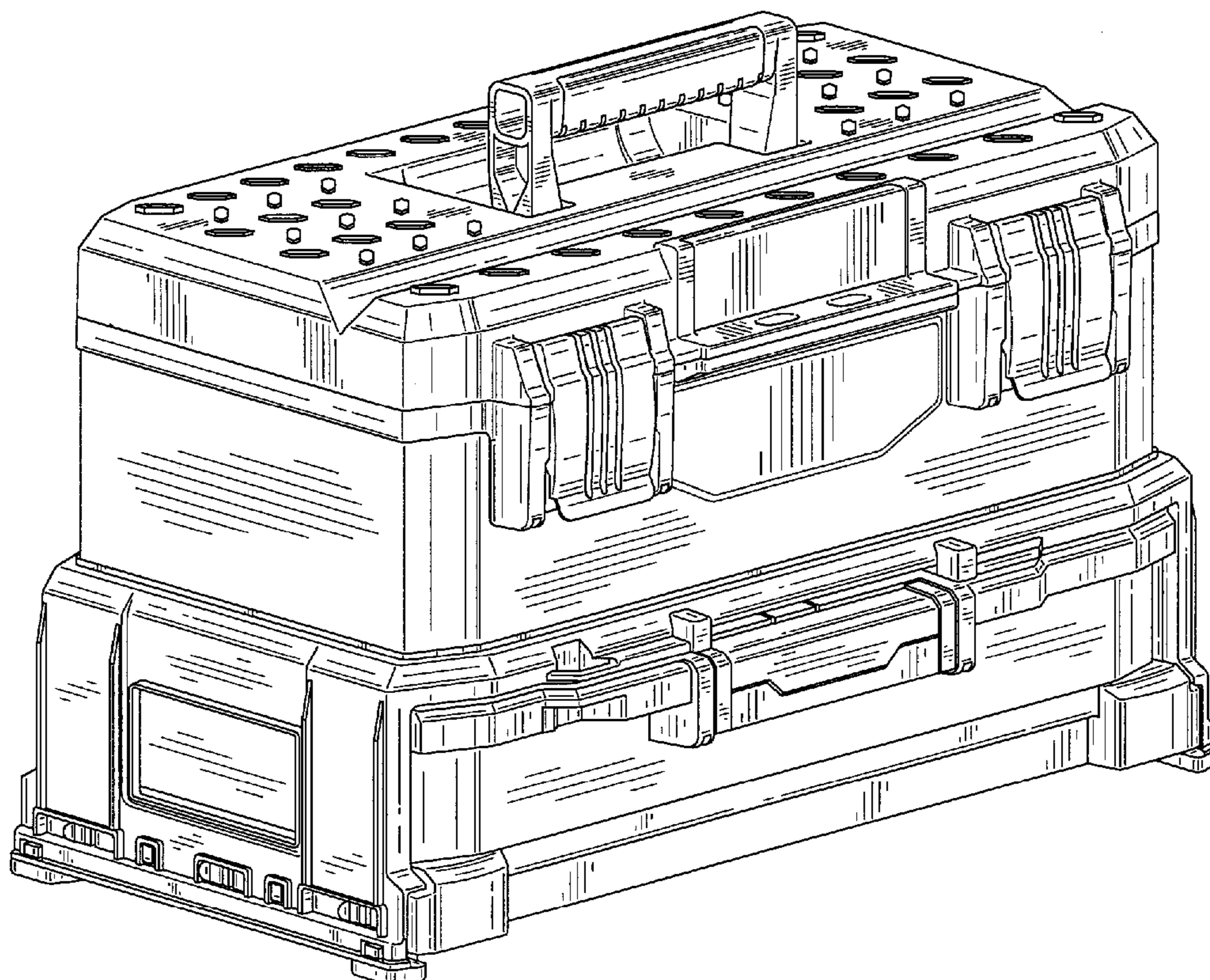
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is an isometric view according to our design; FIG. 2 is a front elevation view of the design of FIG. 1; FIG. 3 is a rear elevation view of the design of FIG. 1; FIG. 4 is a right side elevation view of the design of FIG. 1; FIG. 5 is a left side elevation view of the design of FIG. 1; FIG. 6 is a top plan view of the design of FIG. 1; and, FIG. 7 is a bottom plan view of the design of FIG. 1. The broken lines shown are included for the purpose of illustrating the environment of the design and form no part of the claimed design.

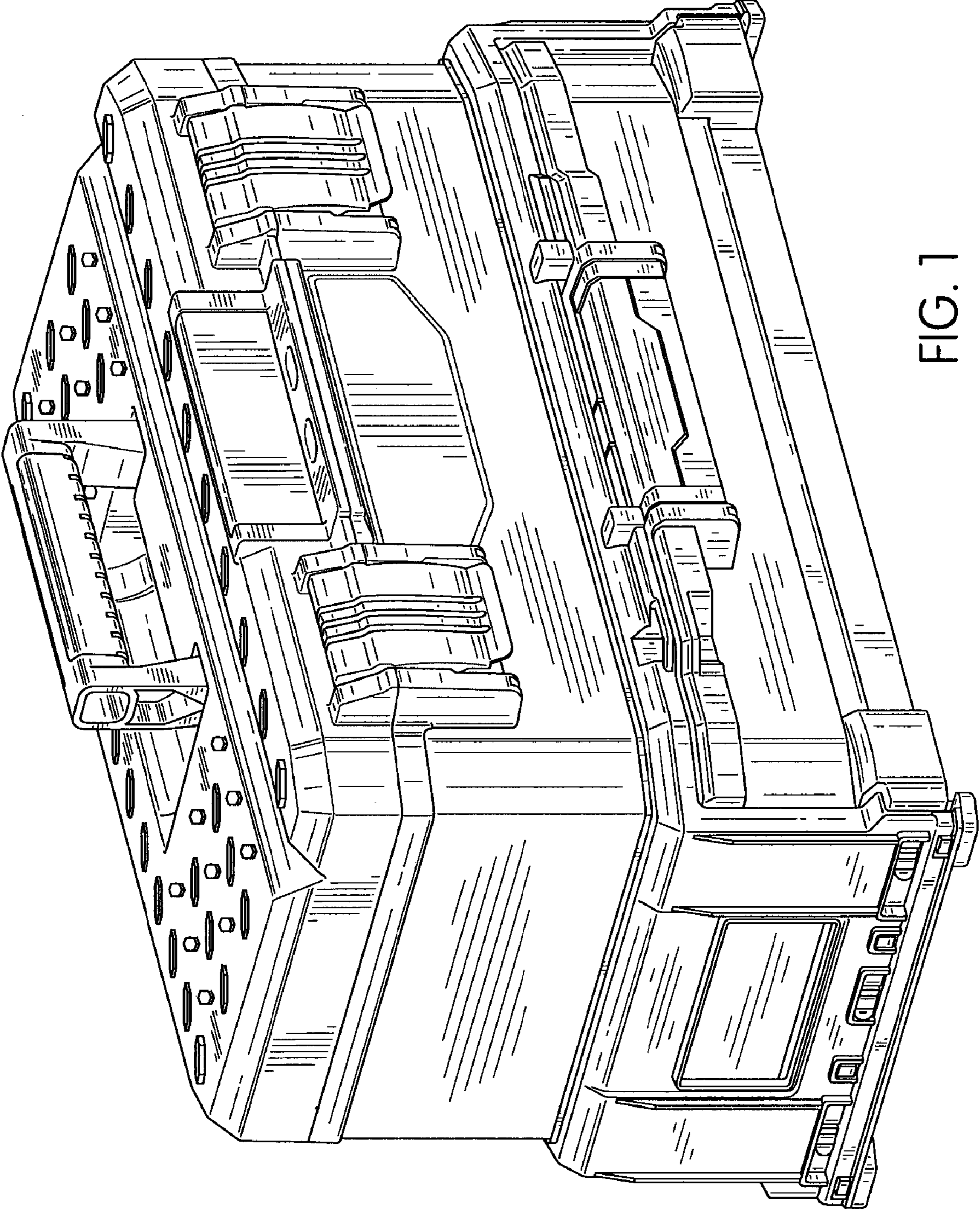

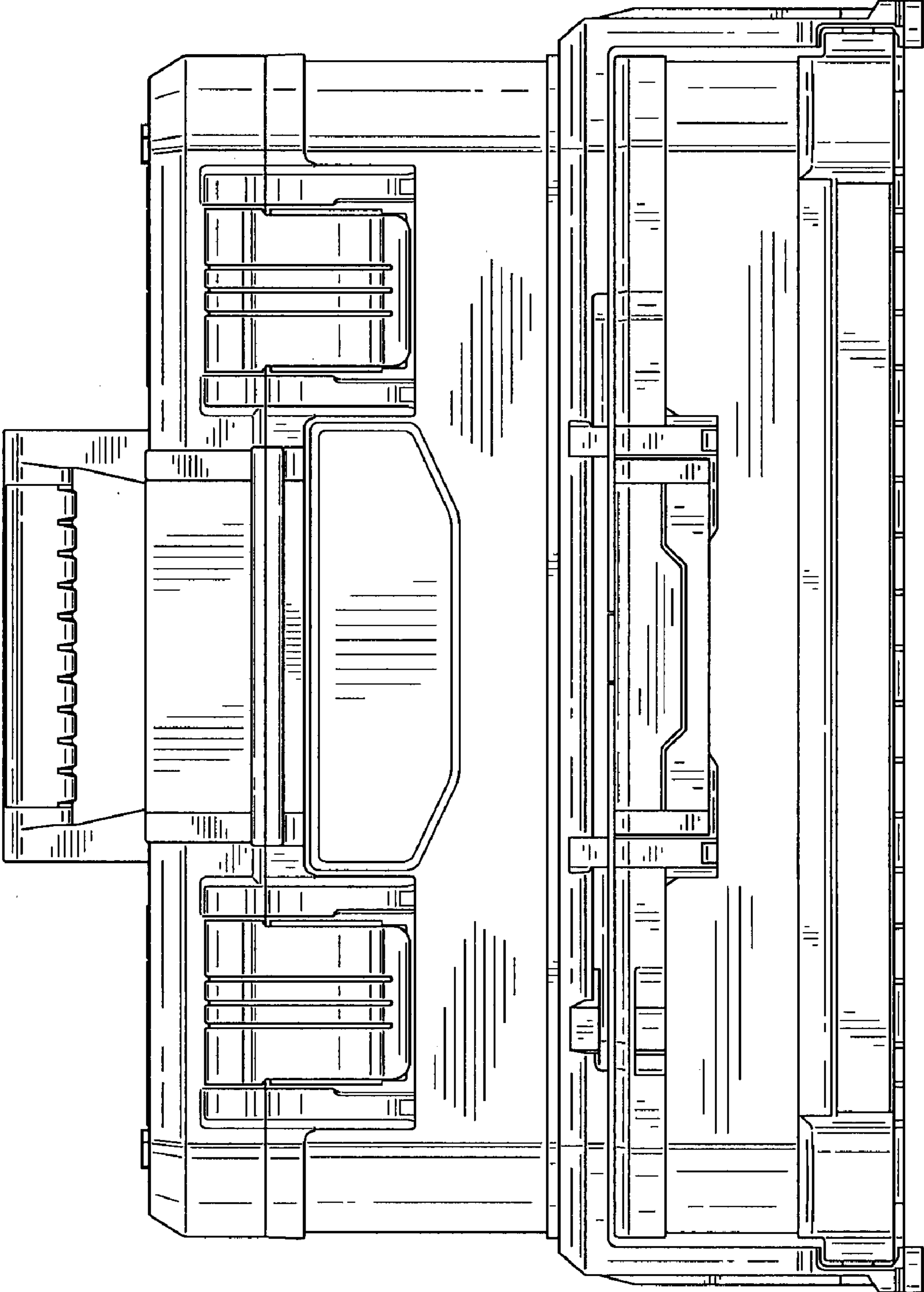

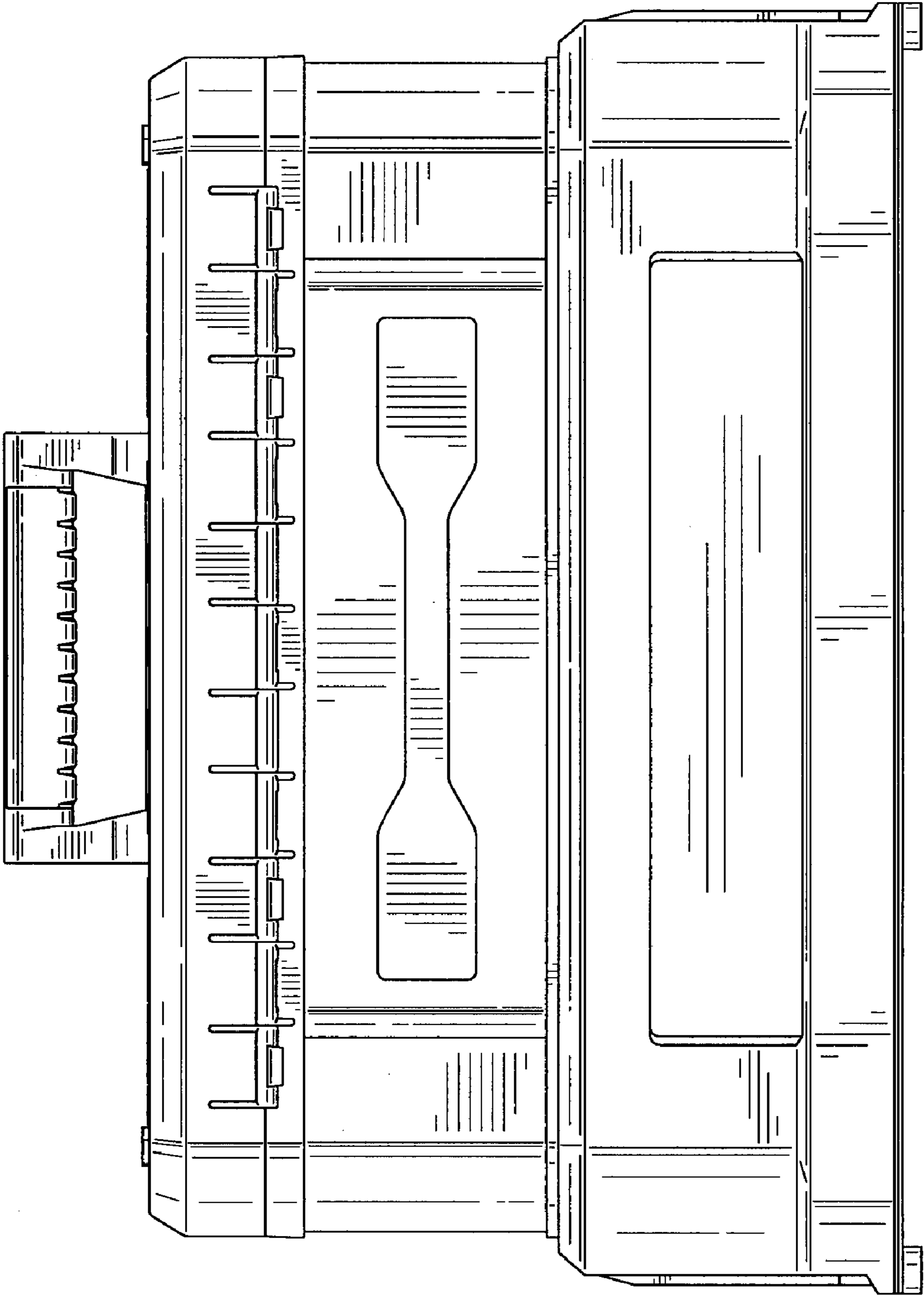

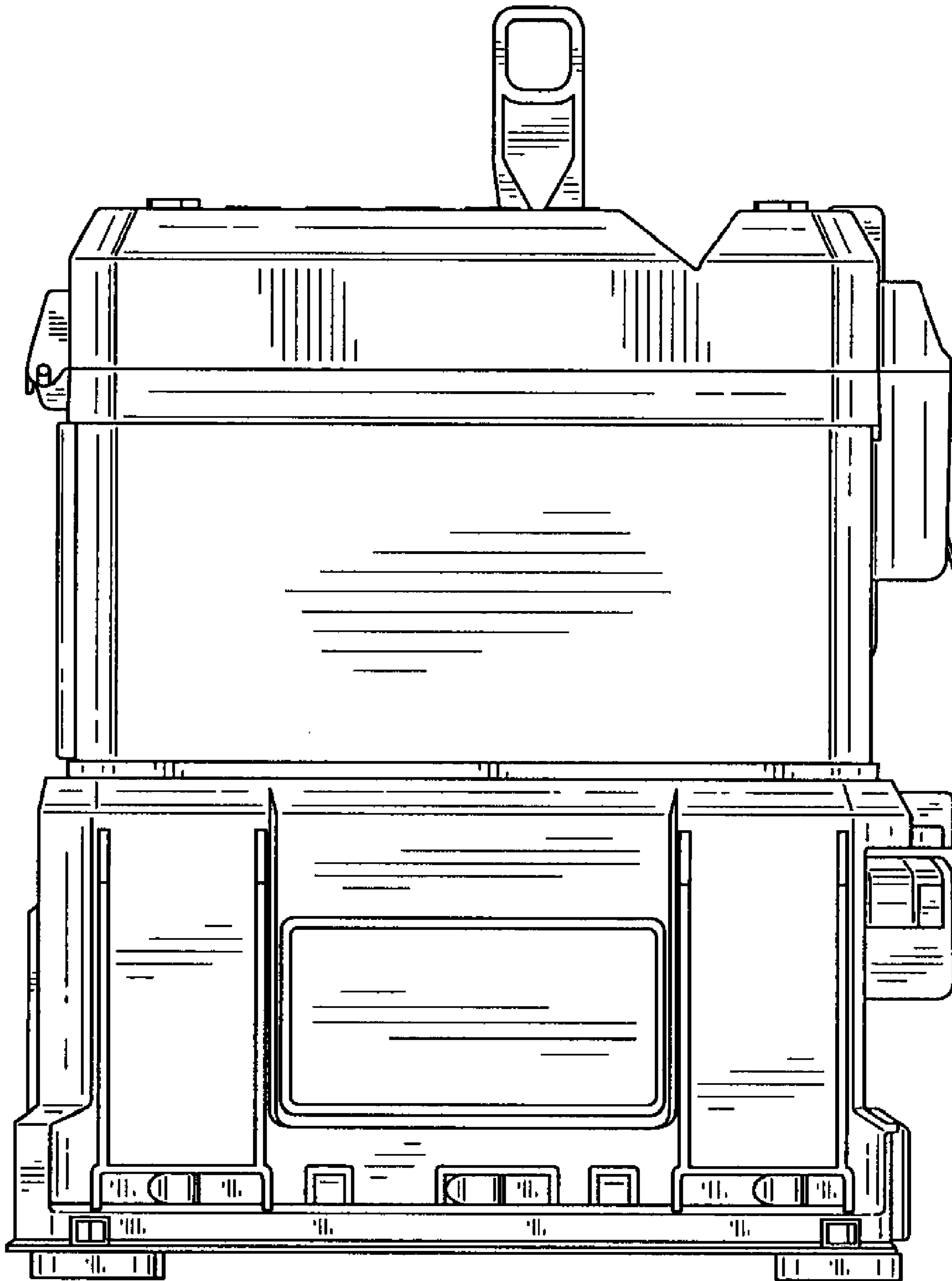

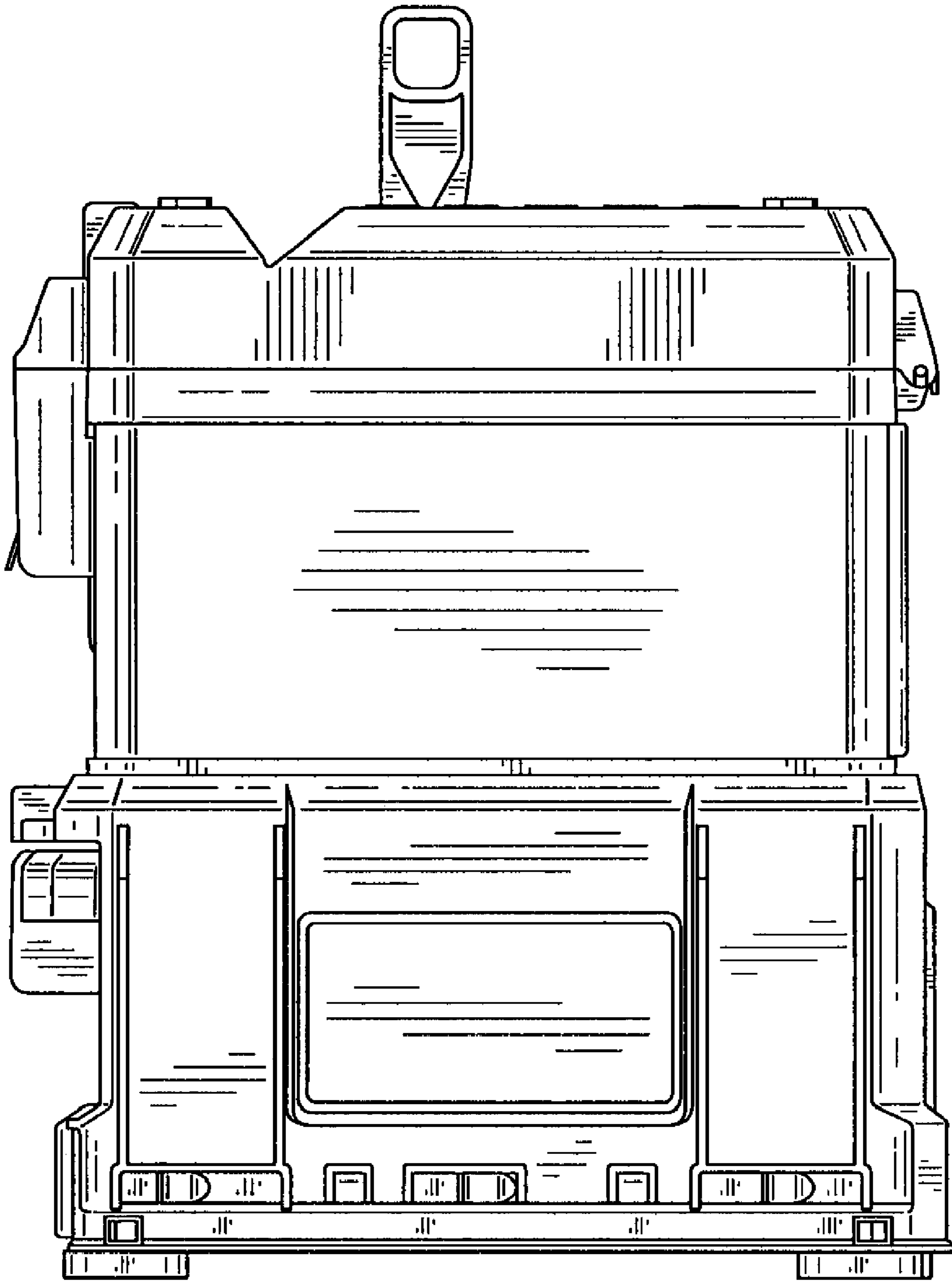

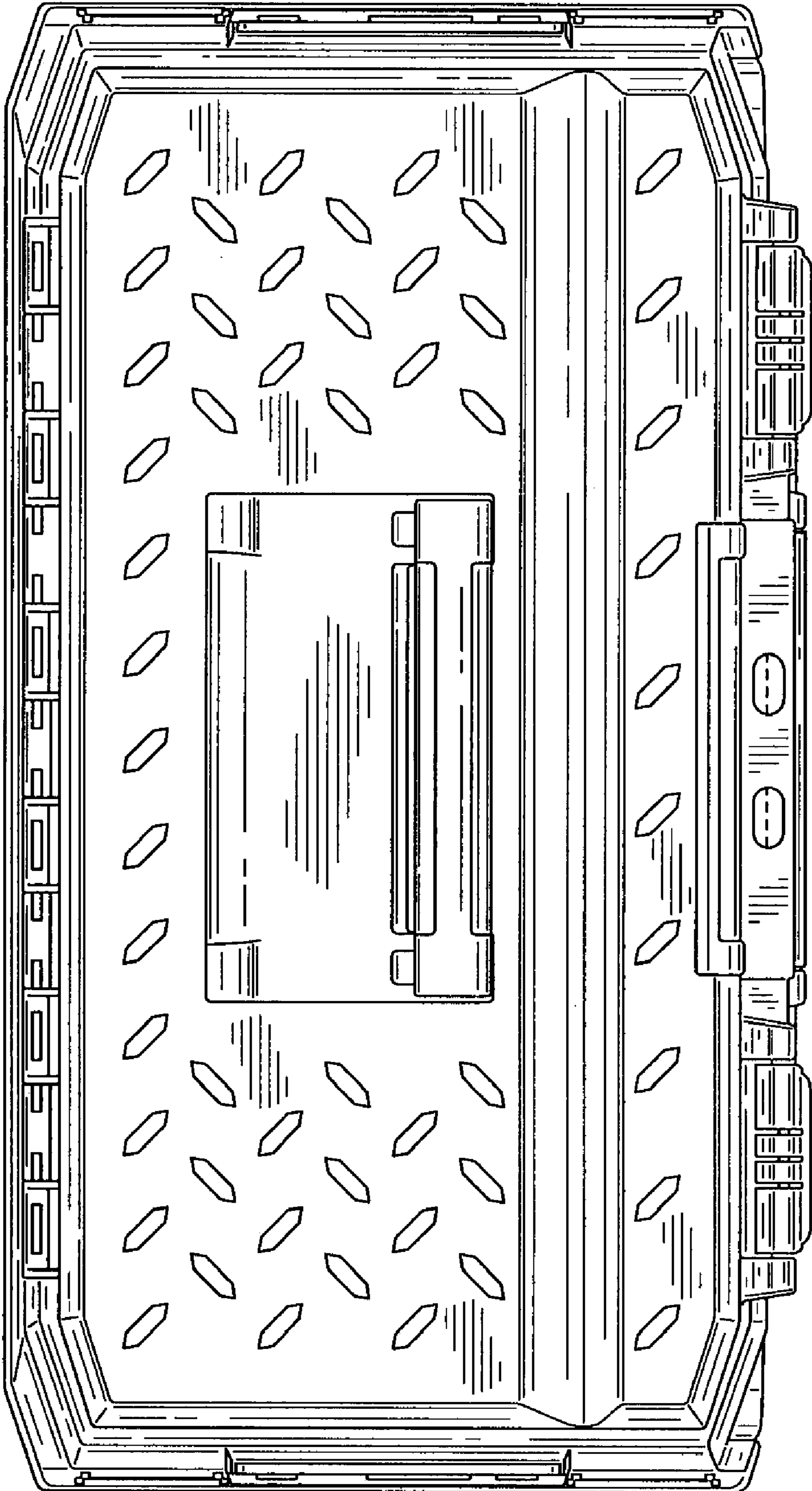

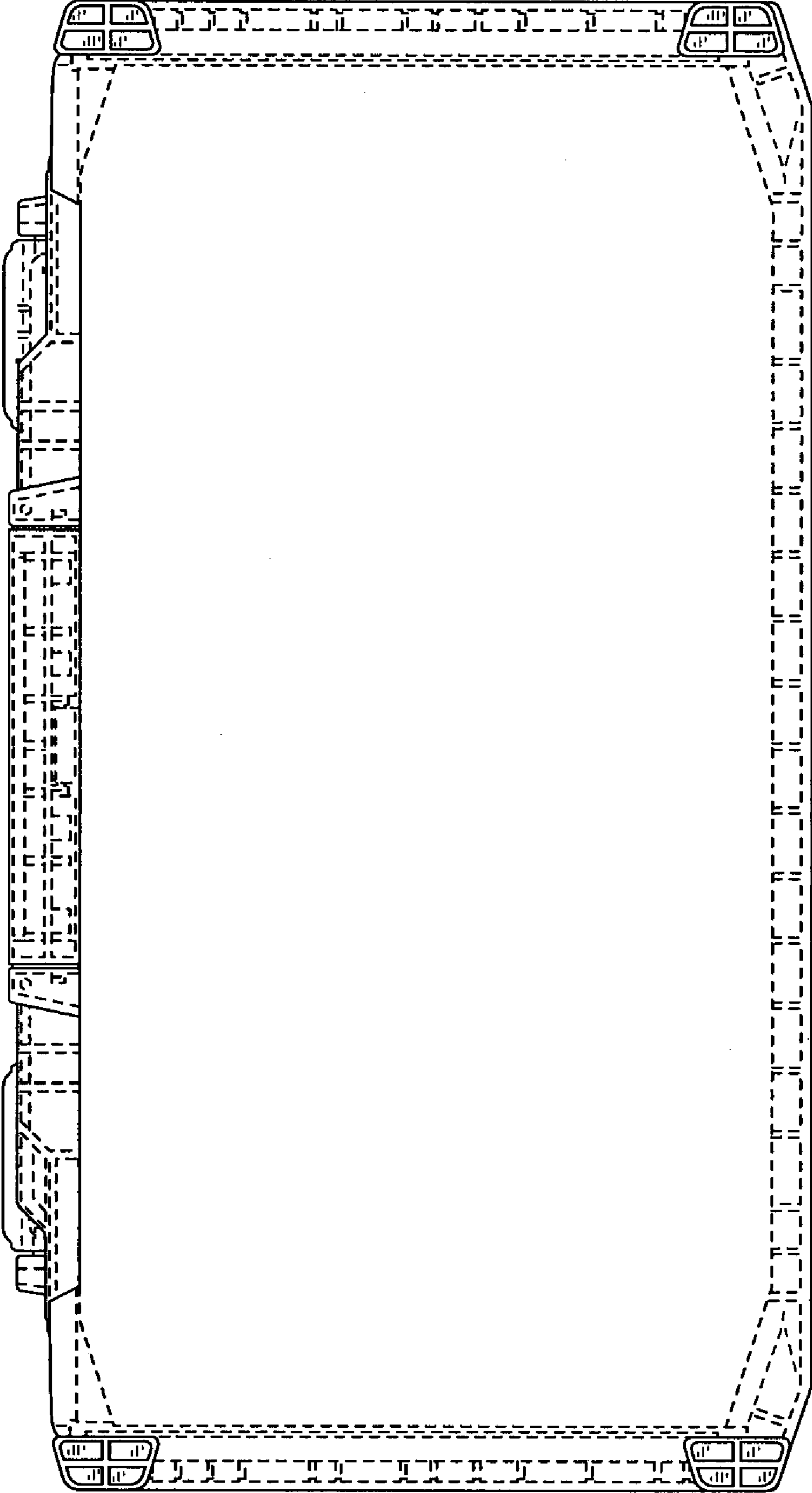
